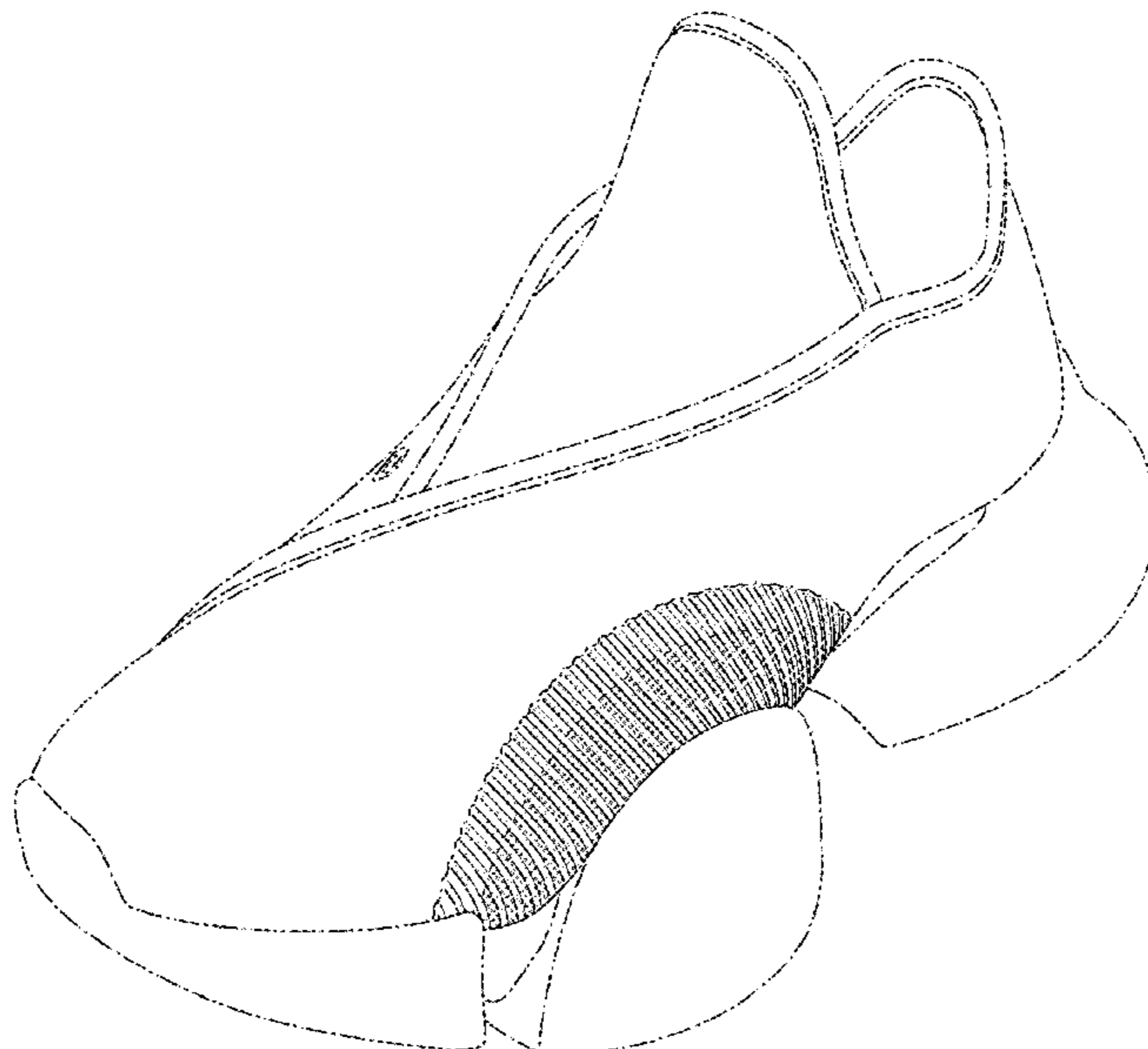
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing our new design;
FIG. 2 is a side view thereof; and,
FIG. 3 is a rear perspective view thereof.
The broken lines immediately adjacent to the top edges of the shaded and unshaded areas defines the bounds of the claimed design and forms no part thereof. The contrast in shading represents a contrast of appearance. The broken lines depicting the remainder of the shoe form no part of the claimed design.

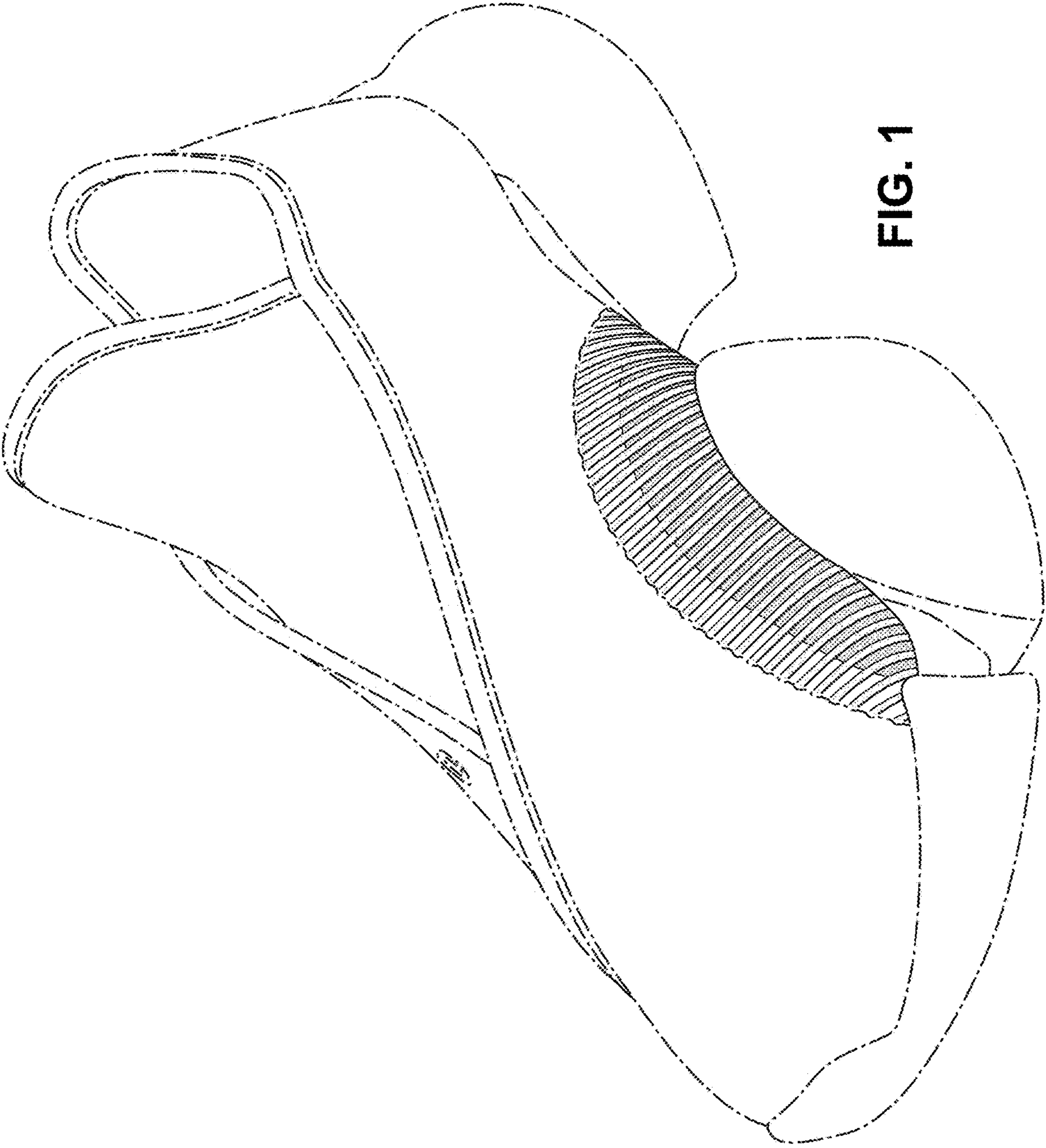

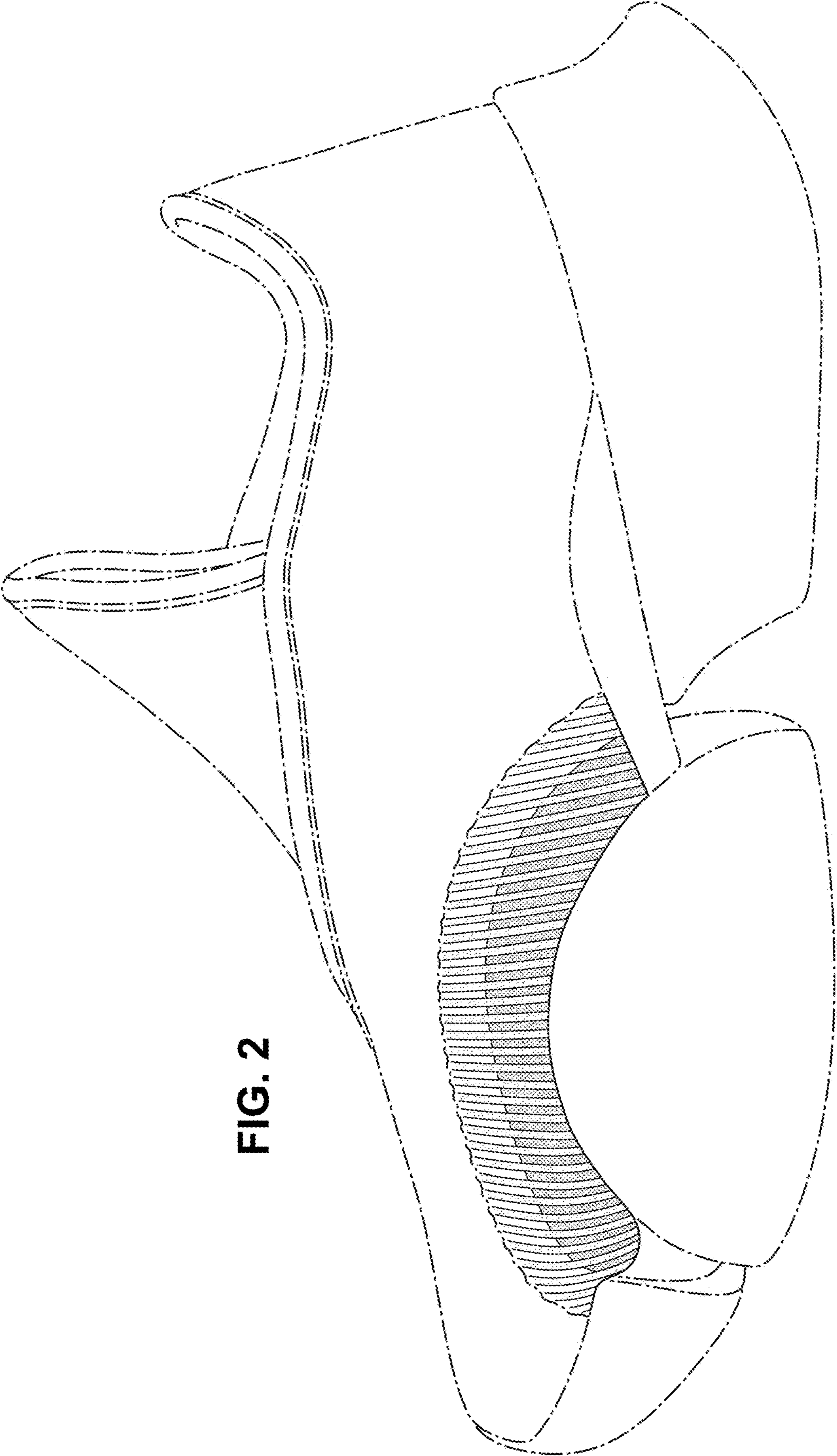

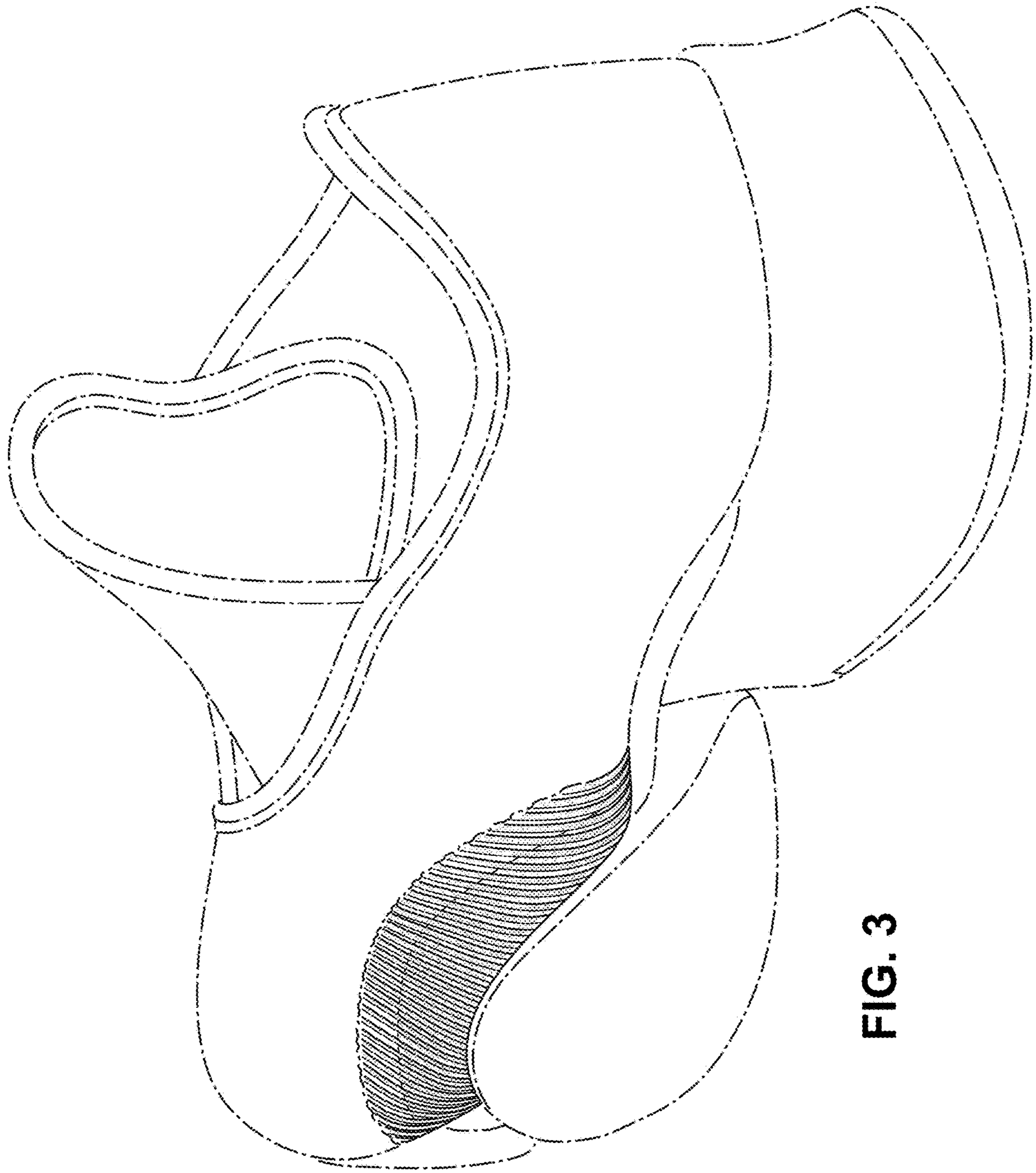
