DESCRIPTION

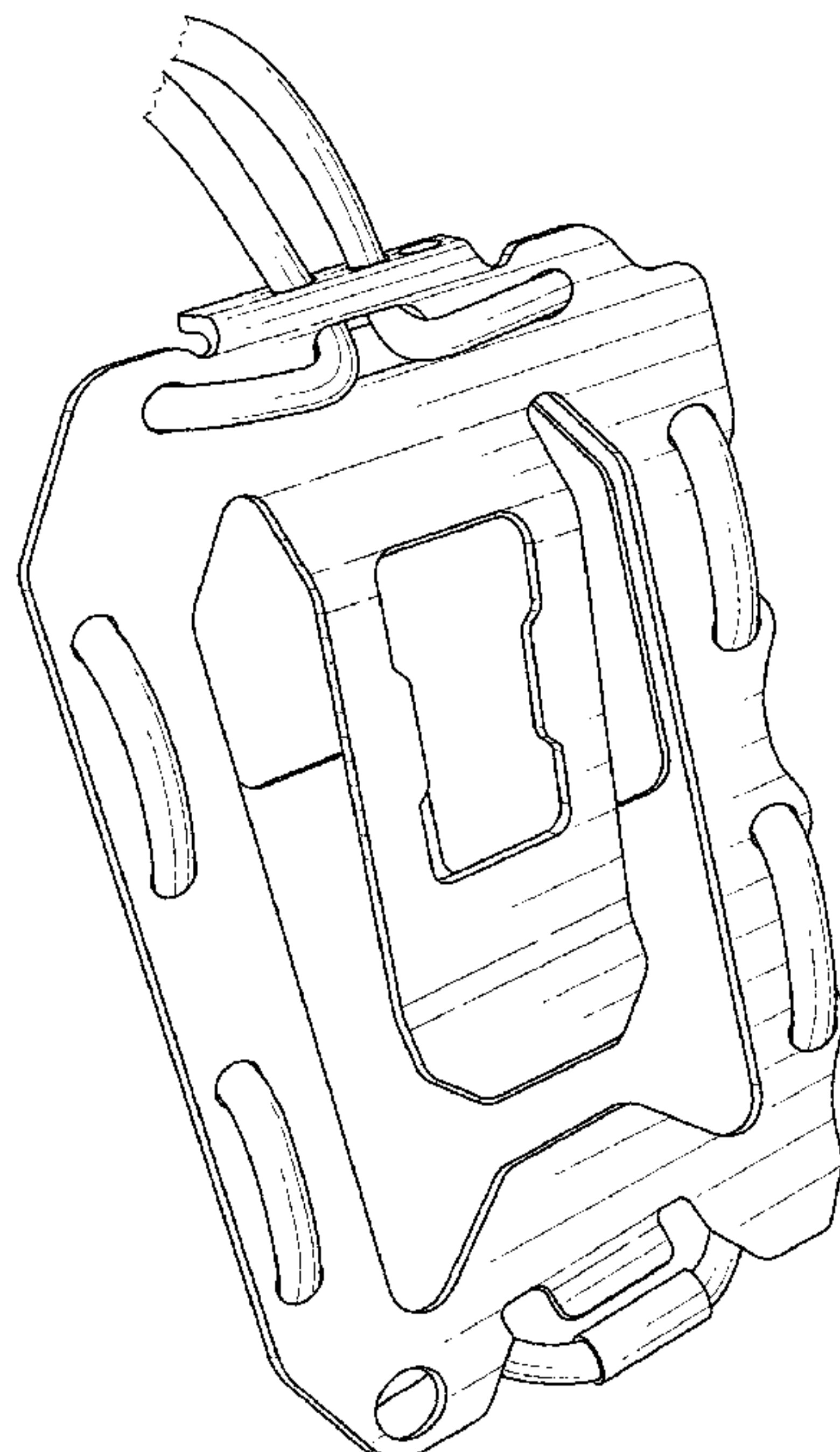
FIG. 1 is a front perspective view of a wallet, according to my design;

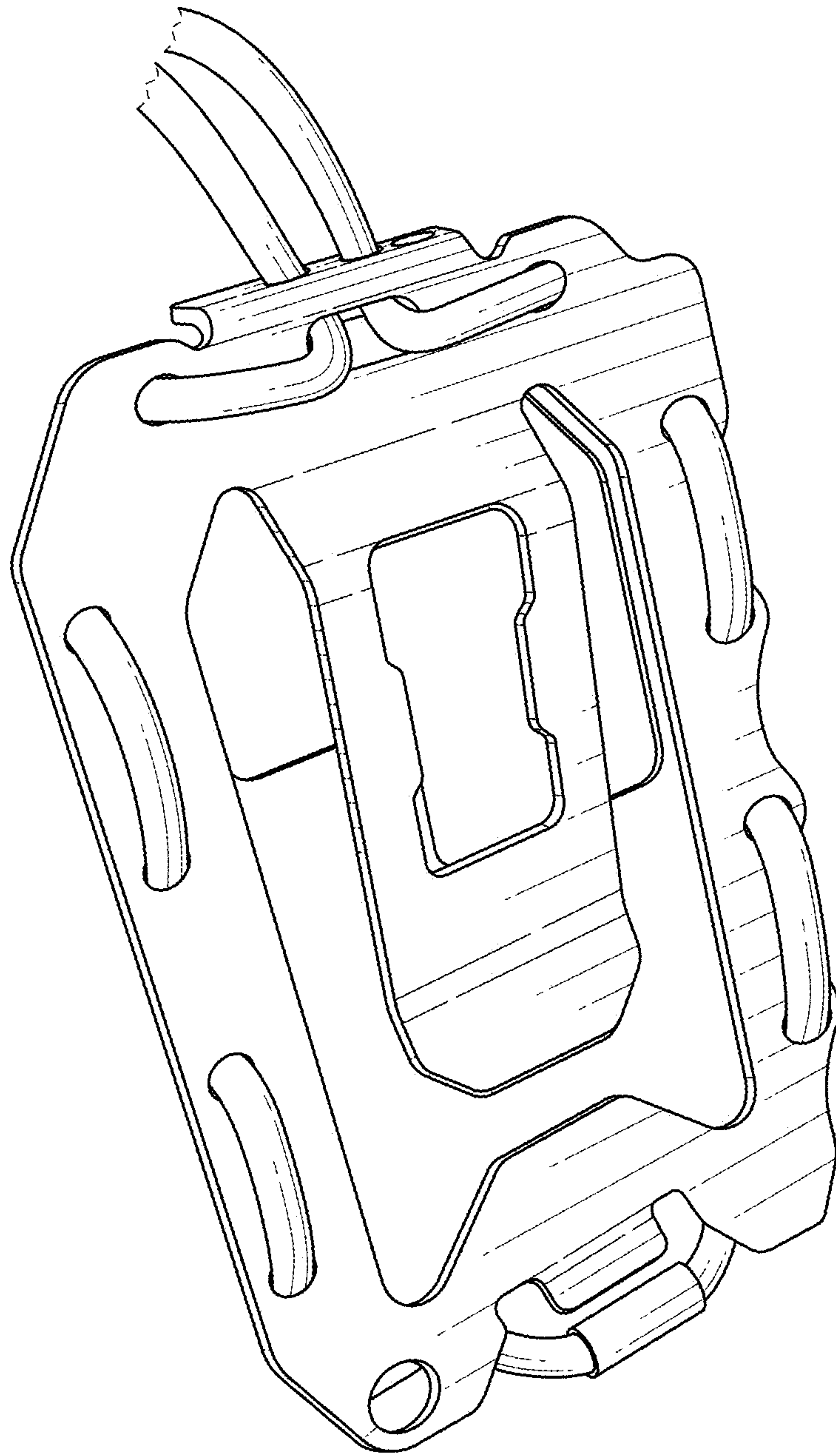

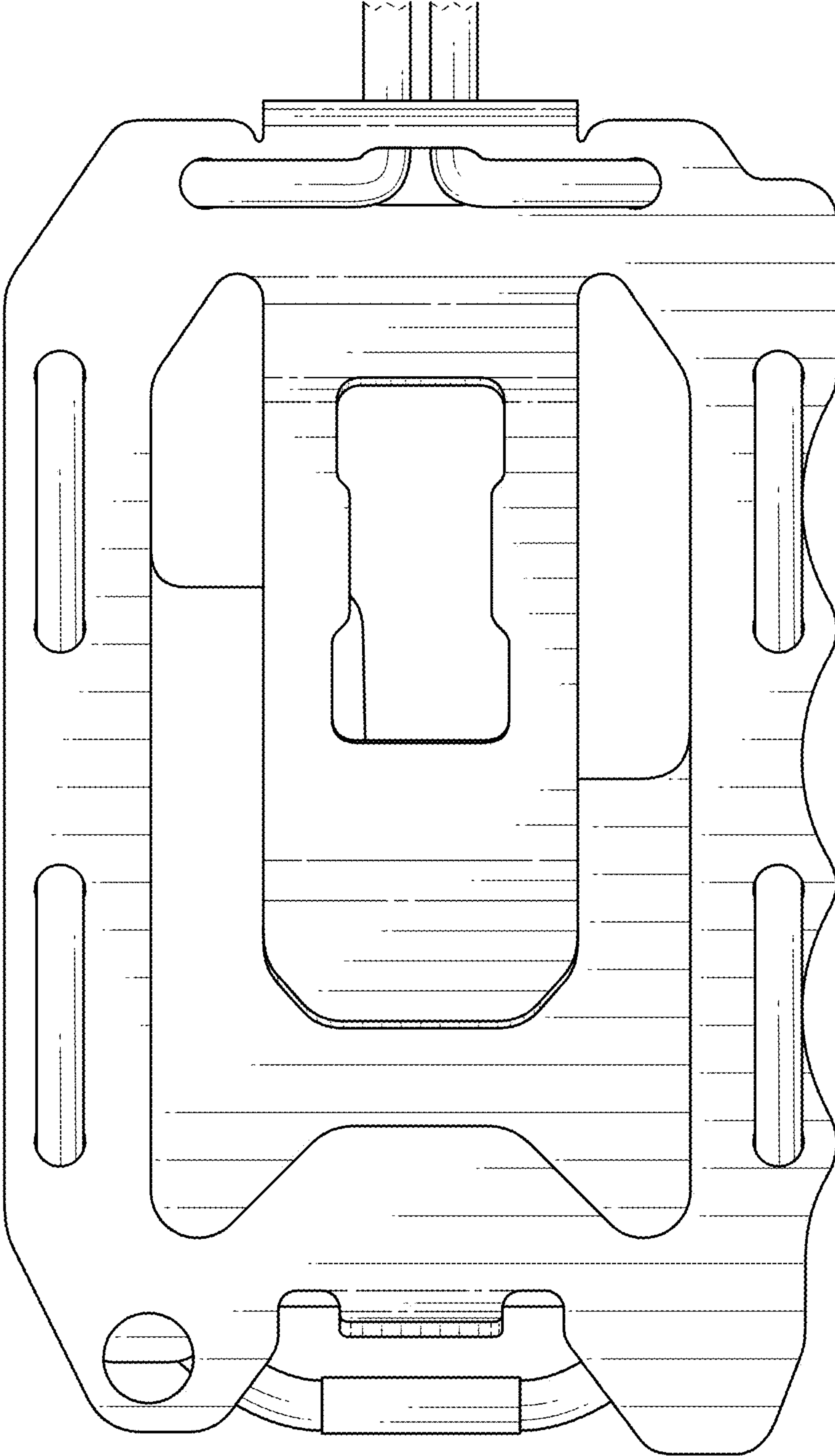

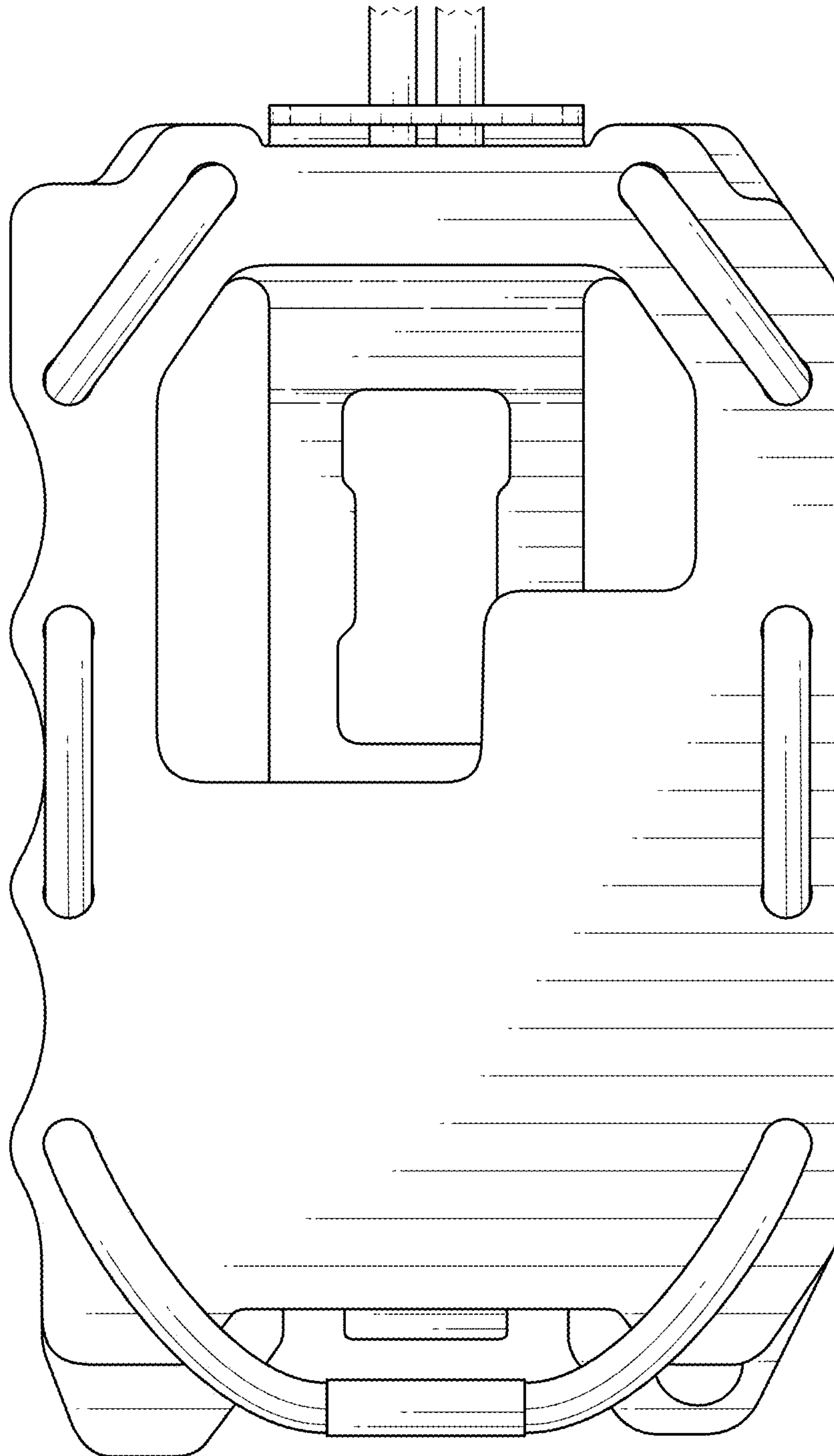

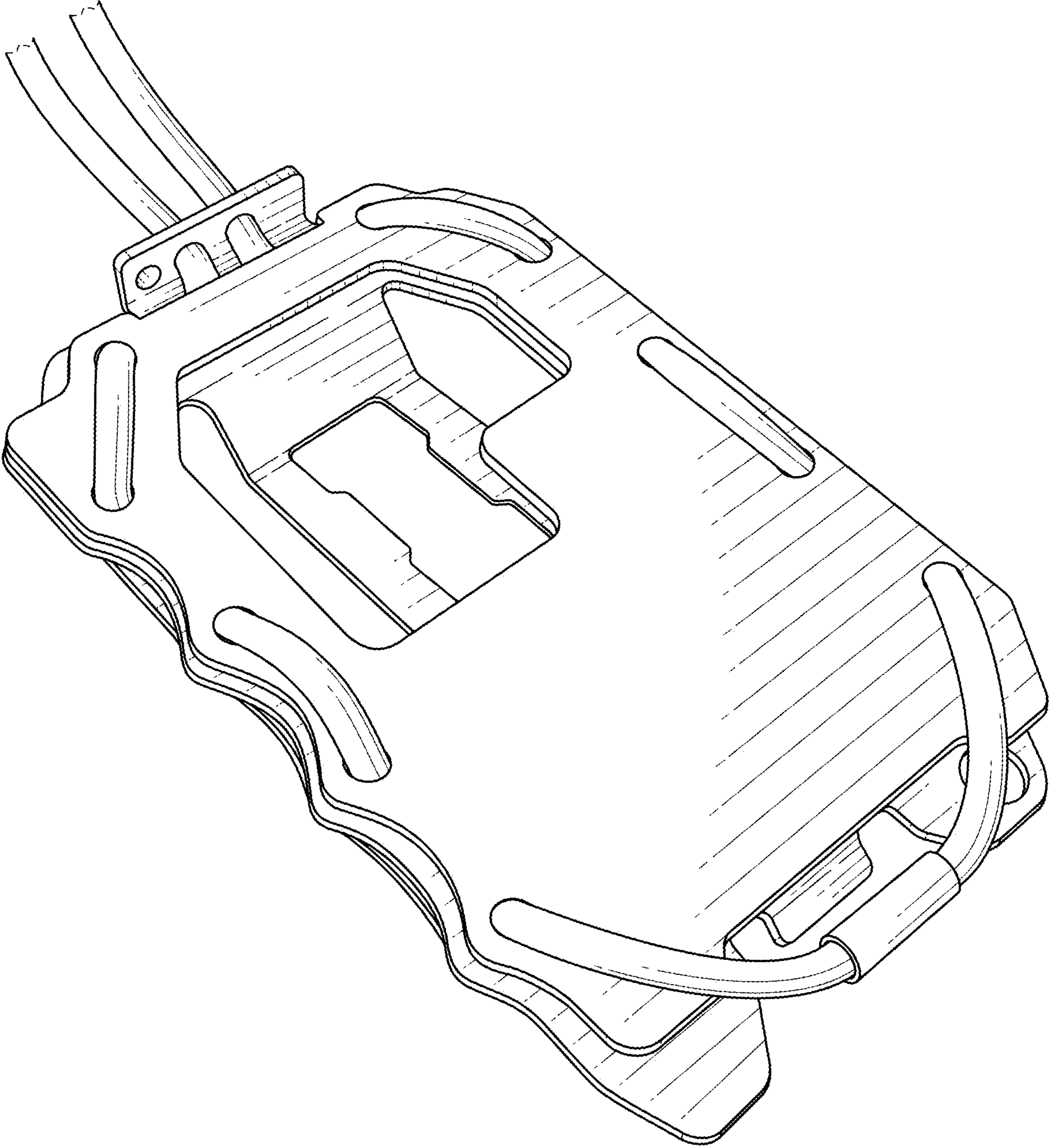

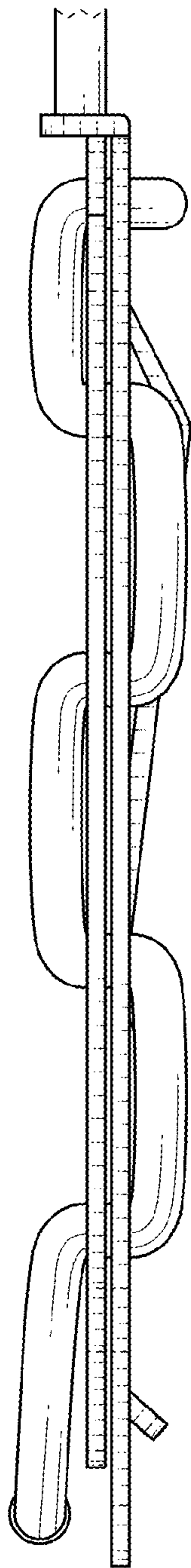

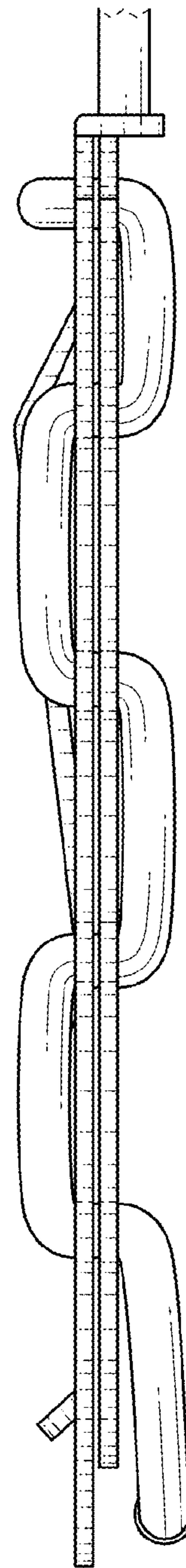

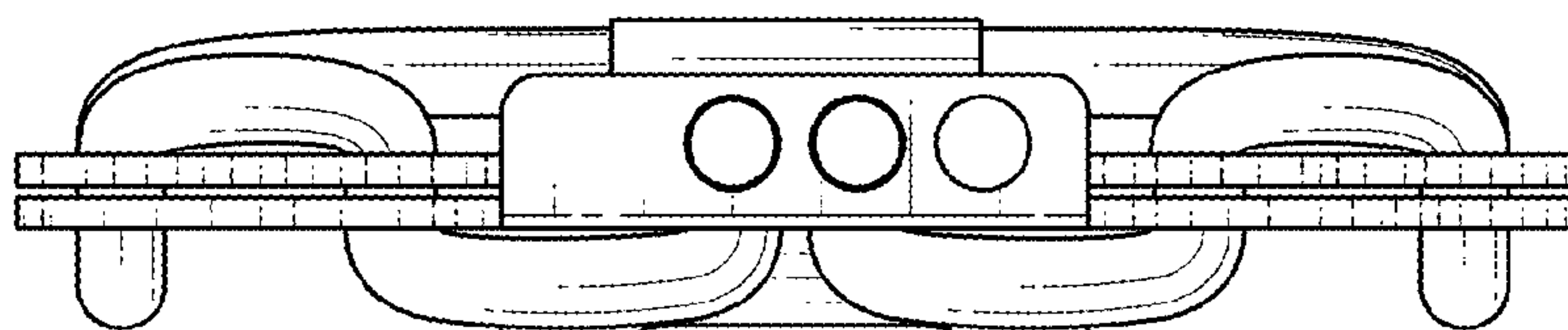

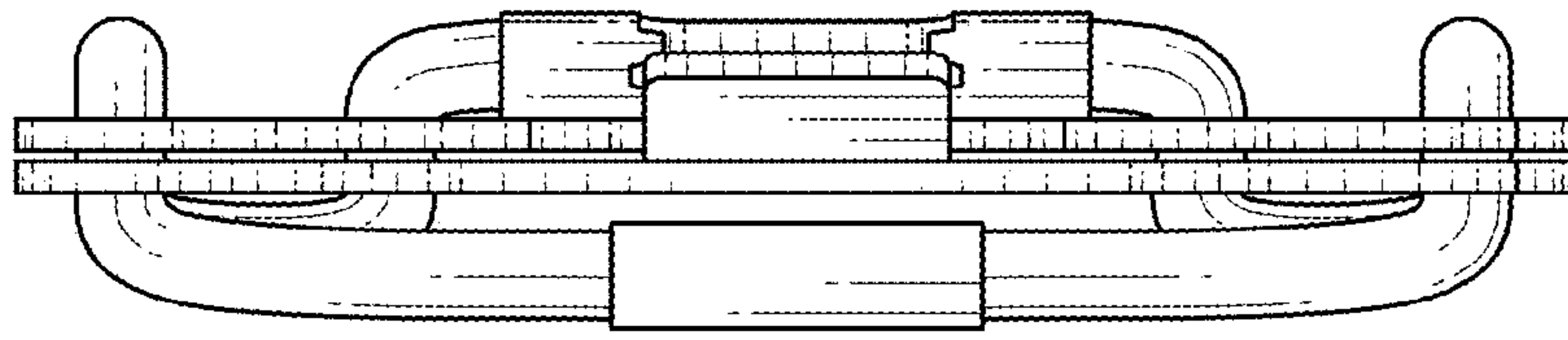

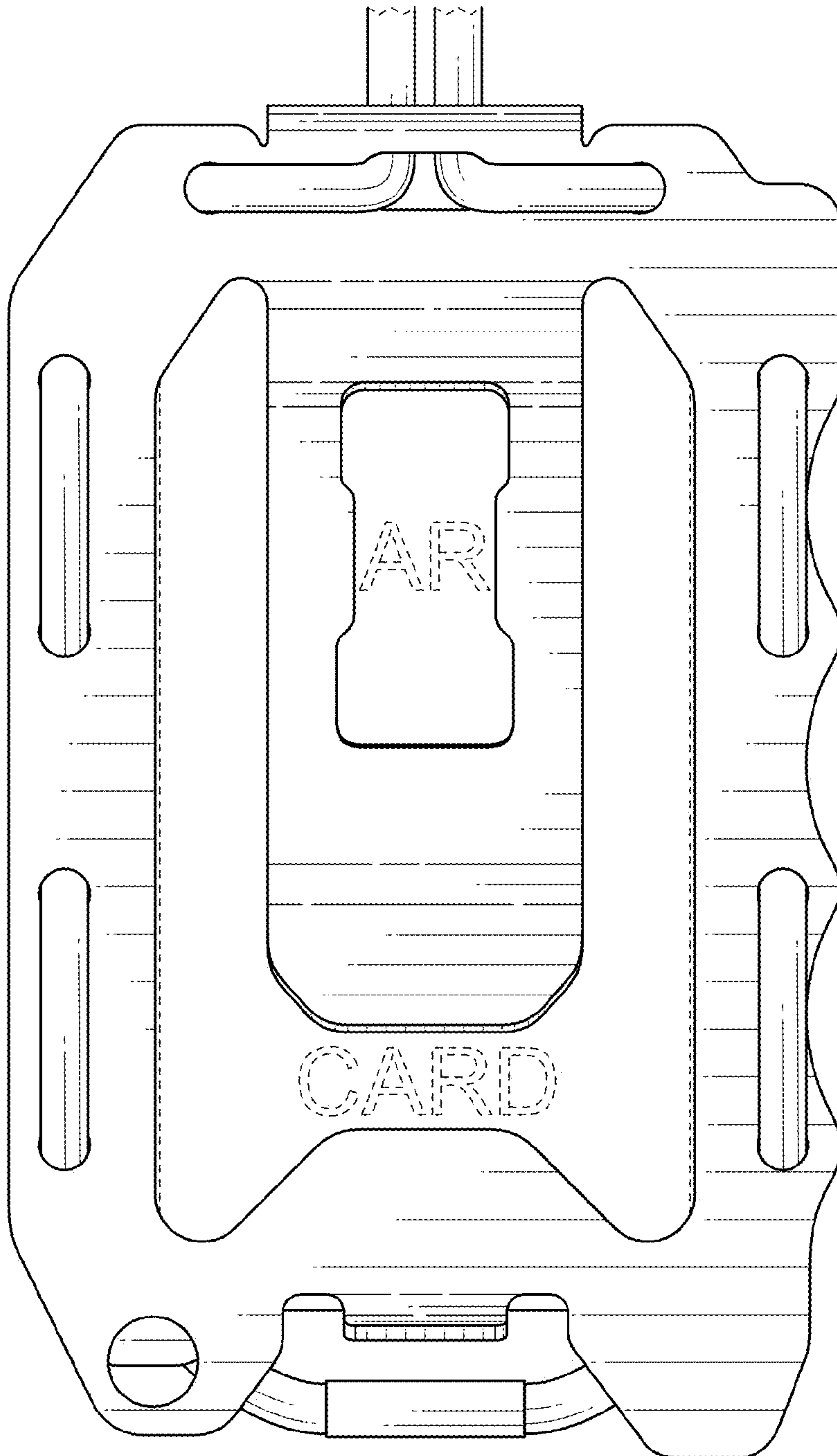

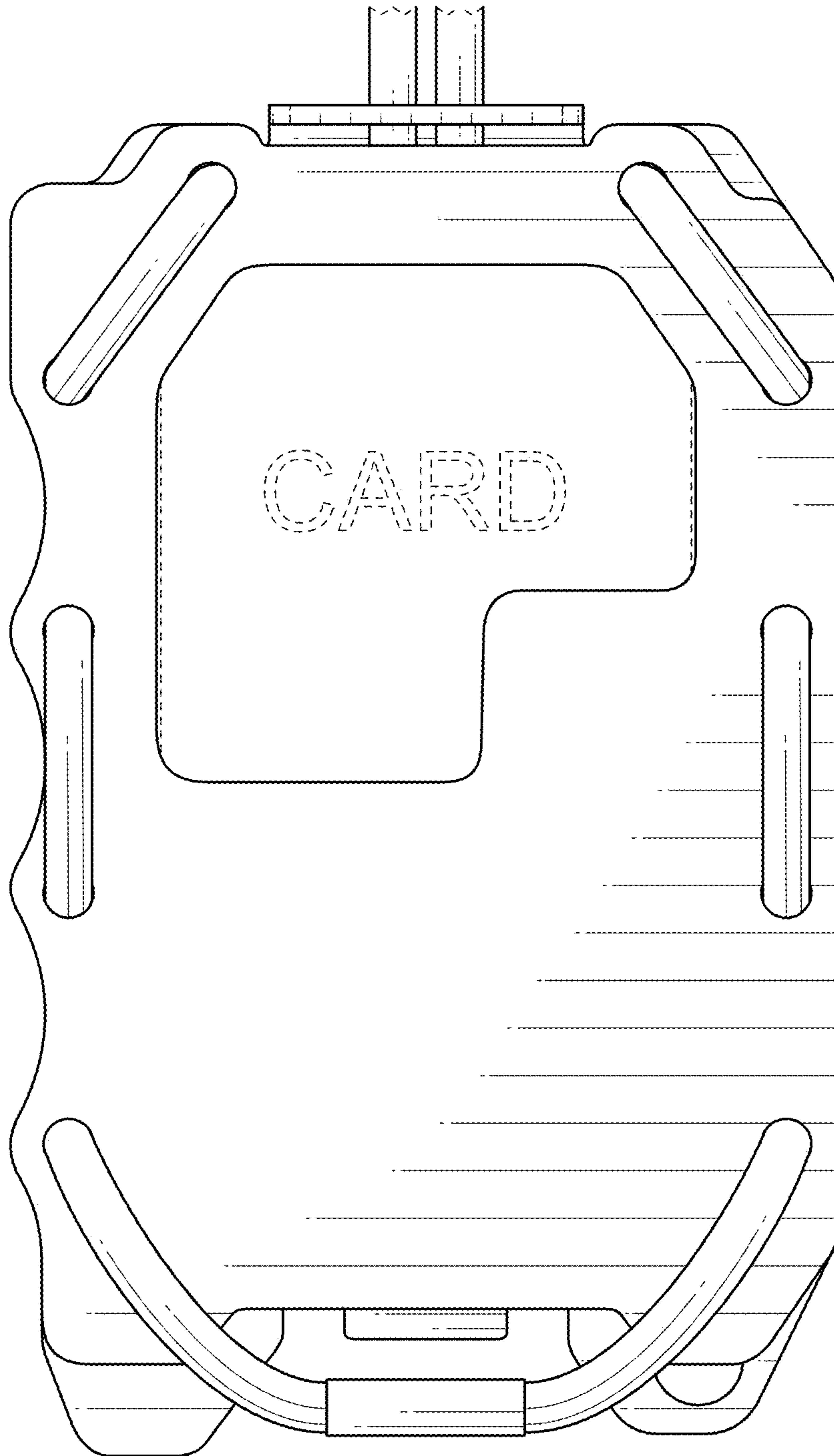
