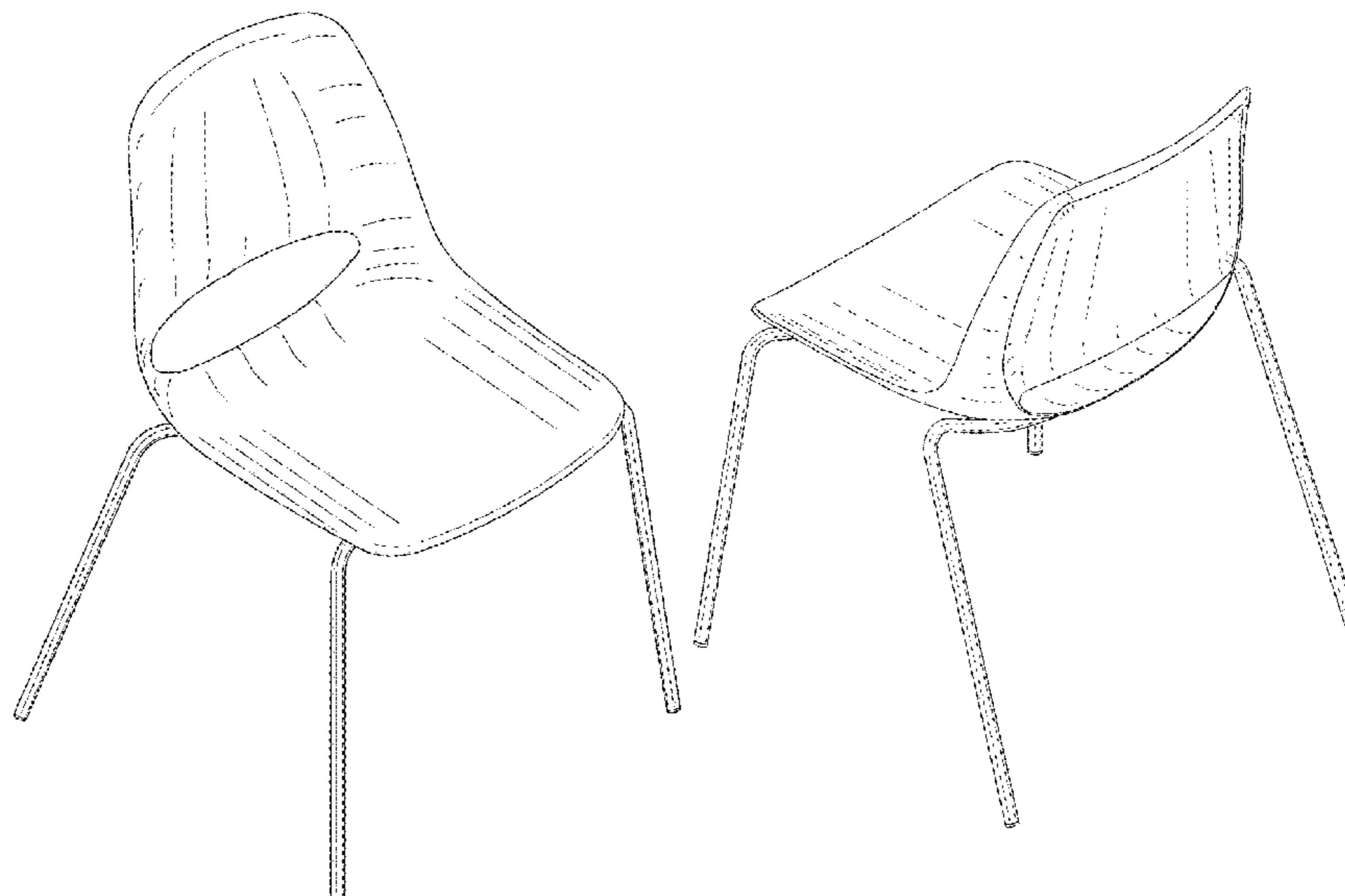
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, left-hand side perspective view of a chair embodying the principles of my new design;

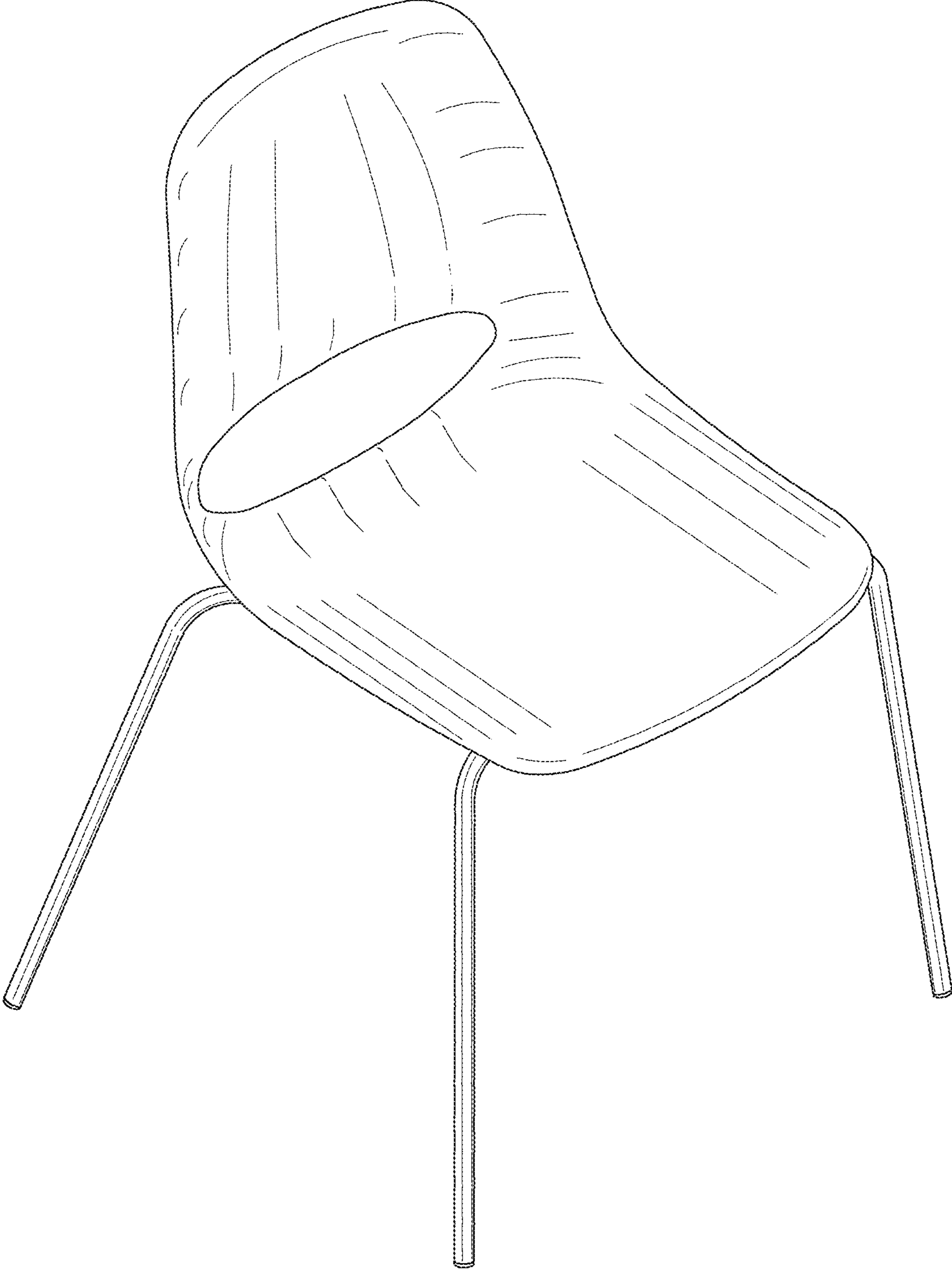

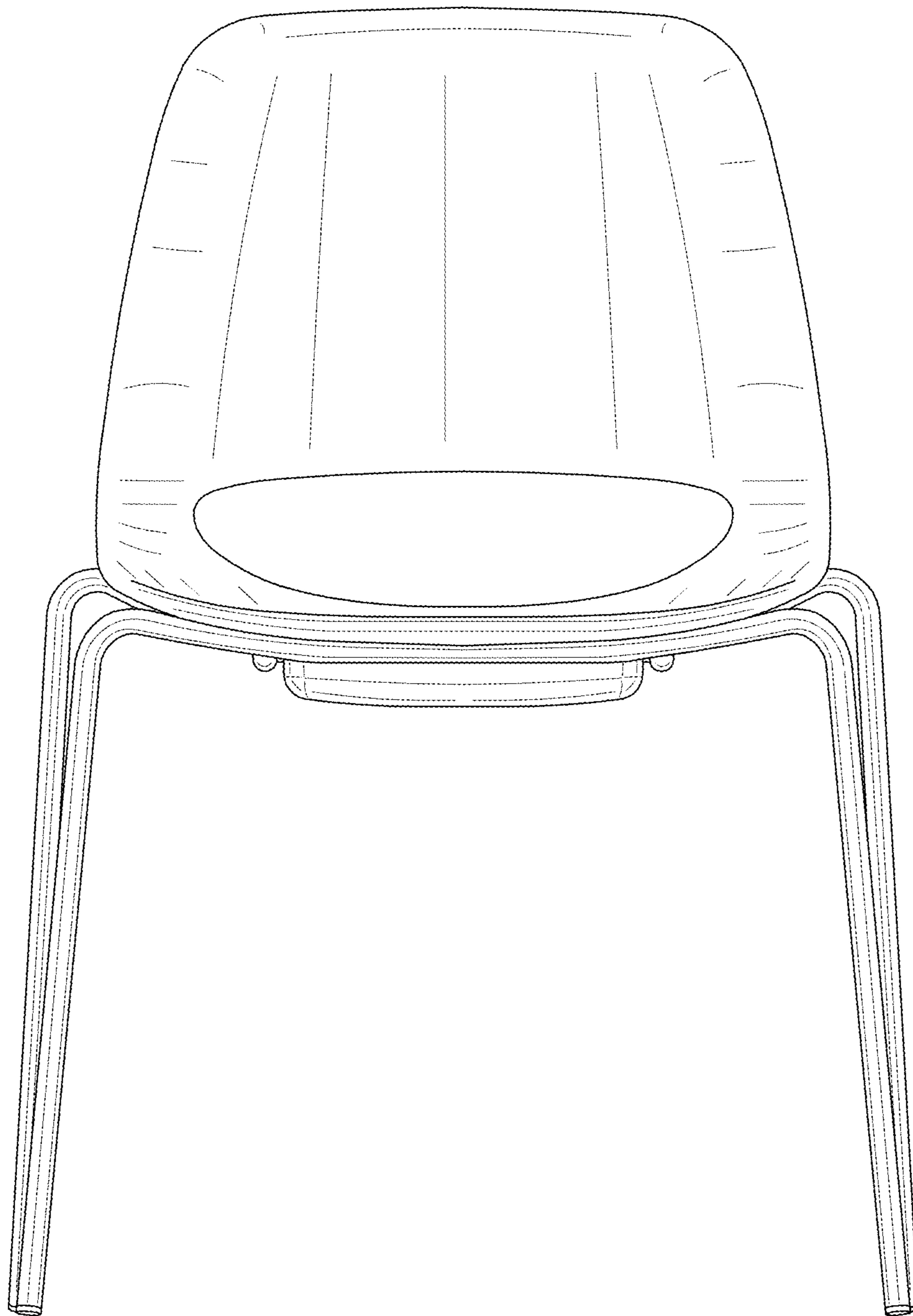

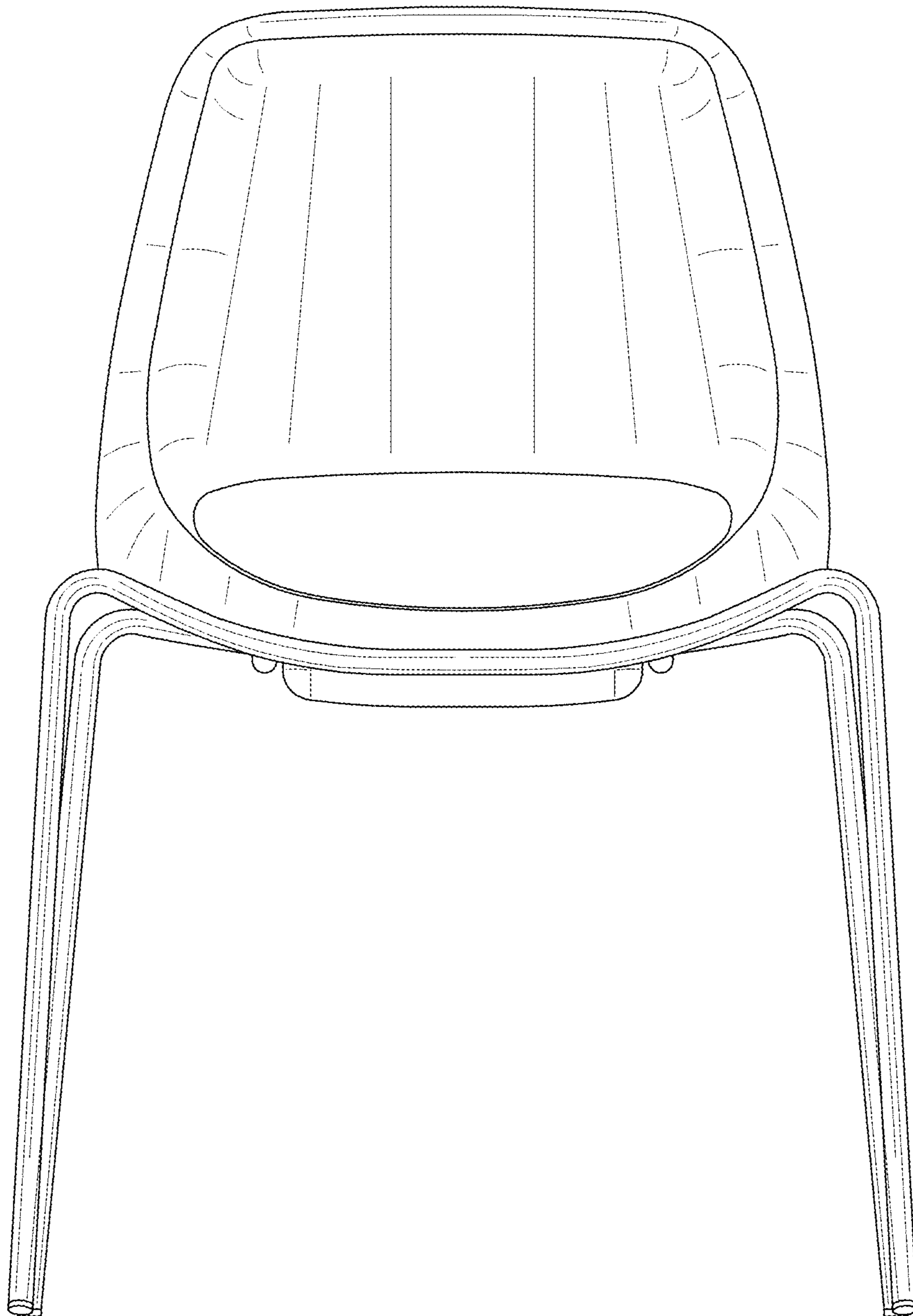

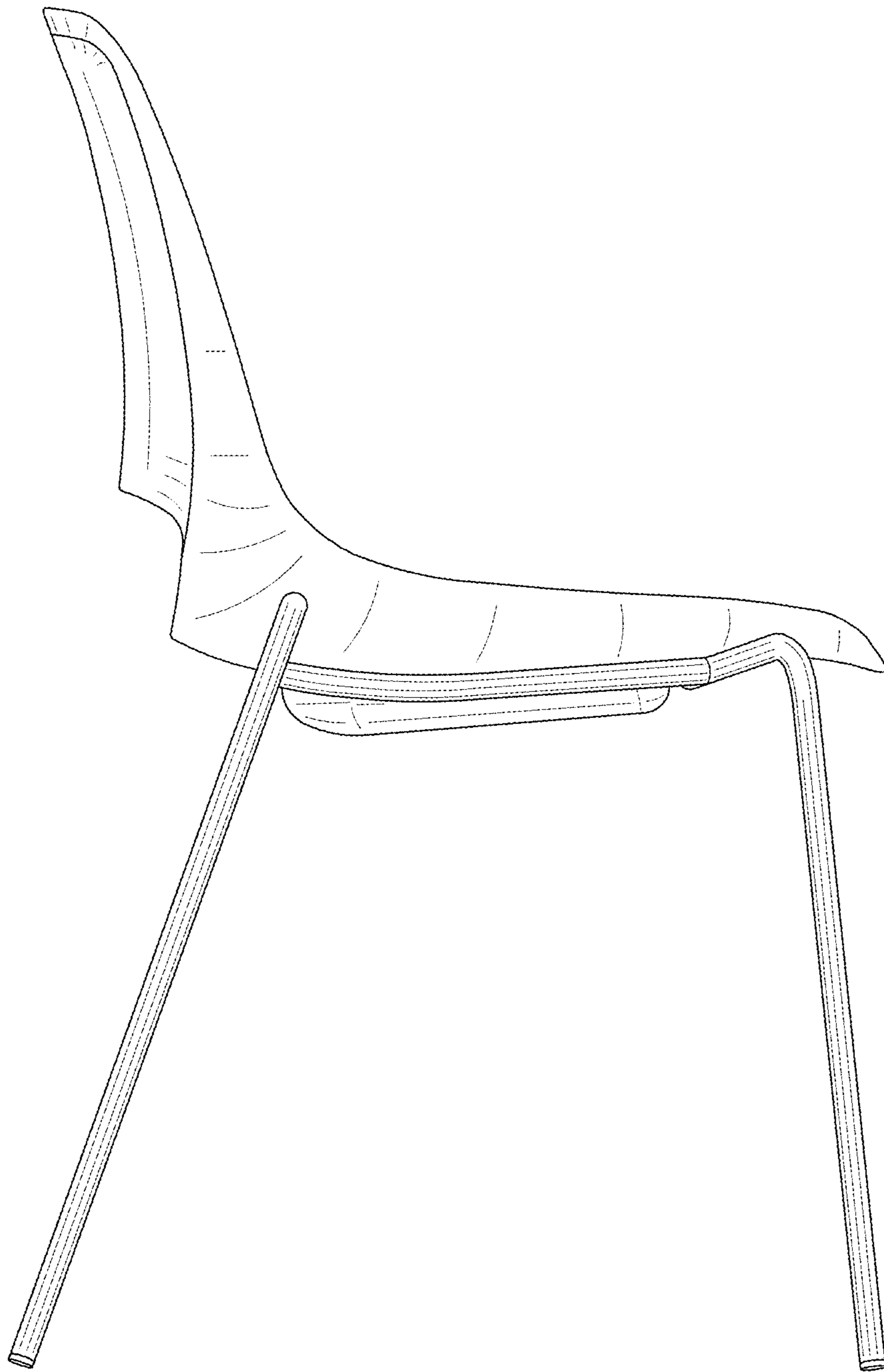

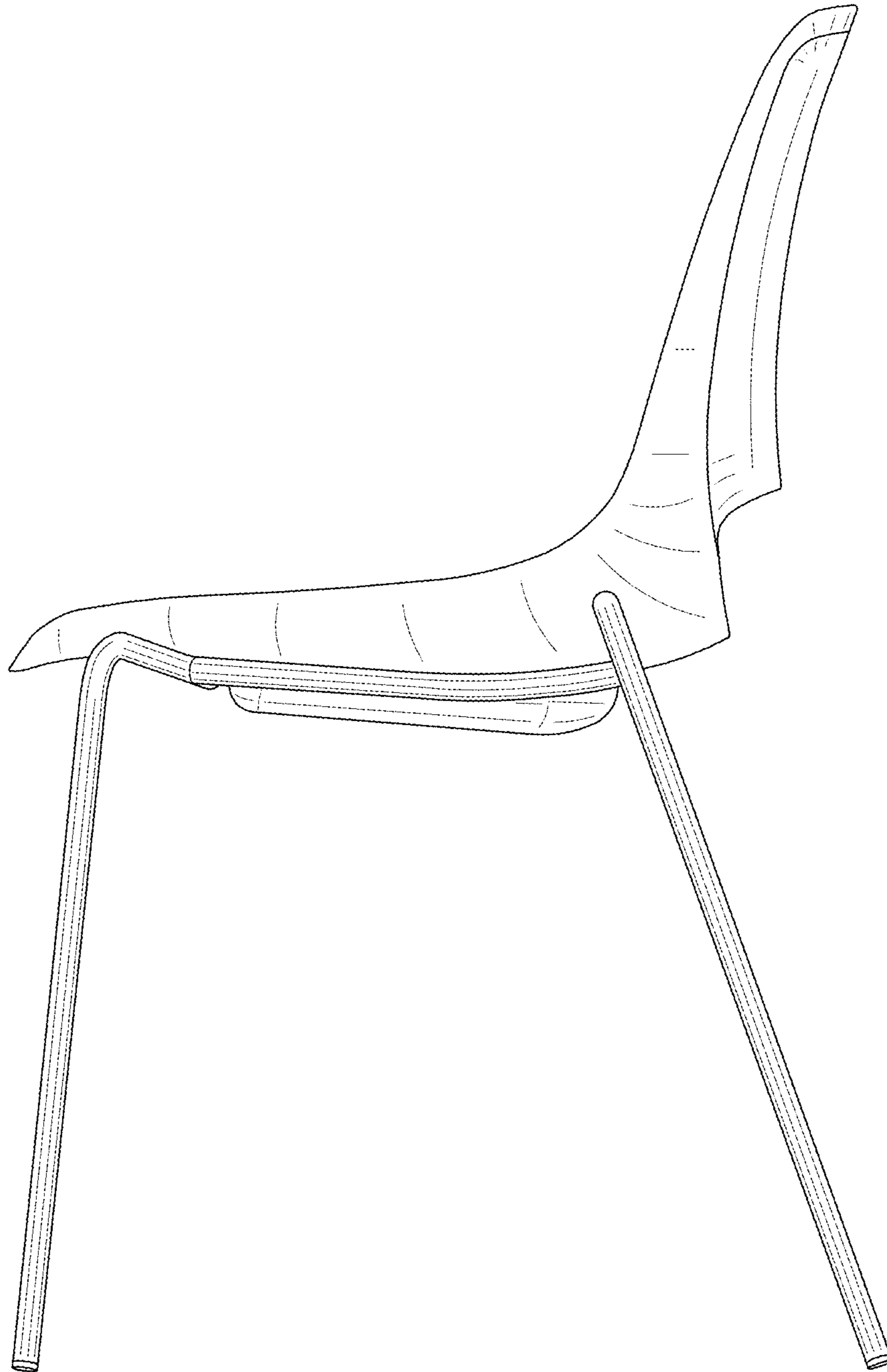

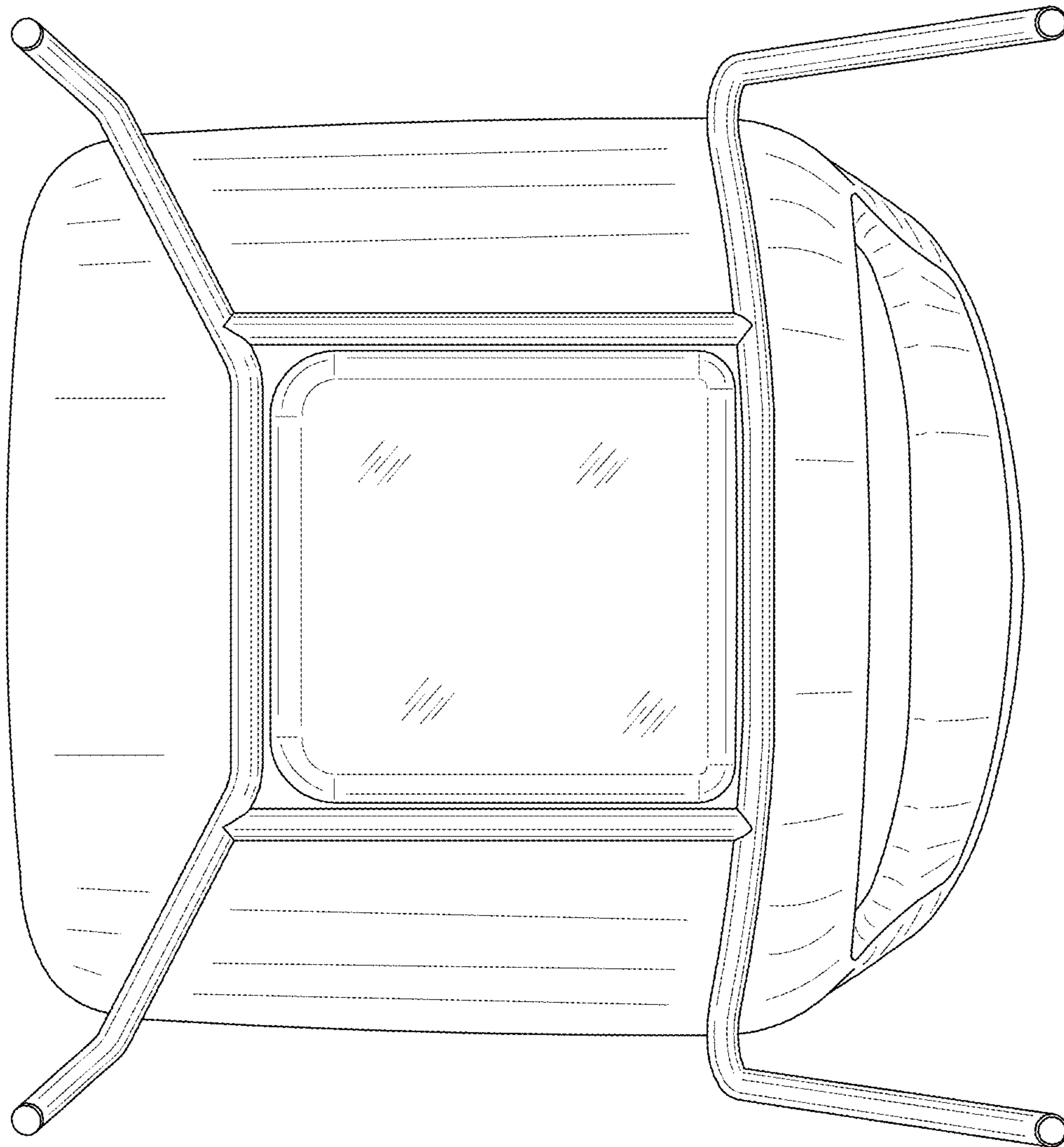

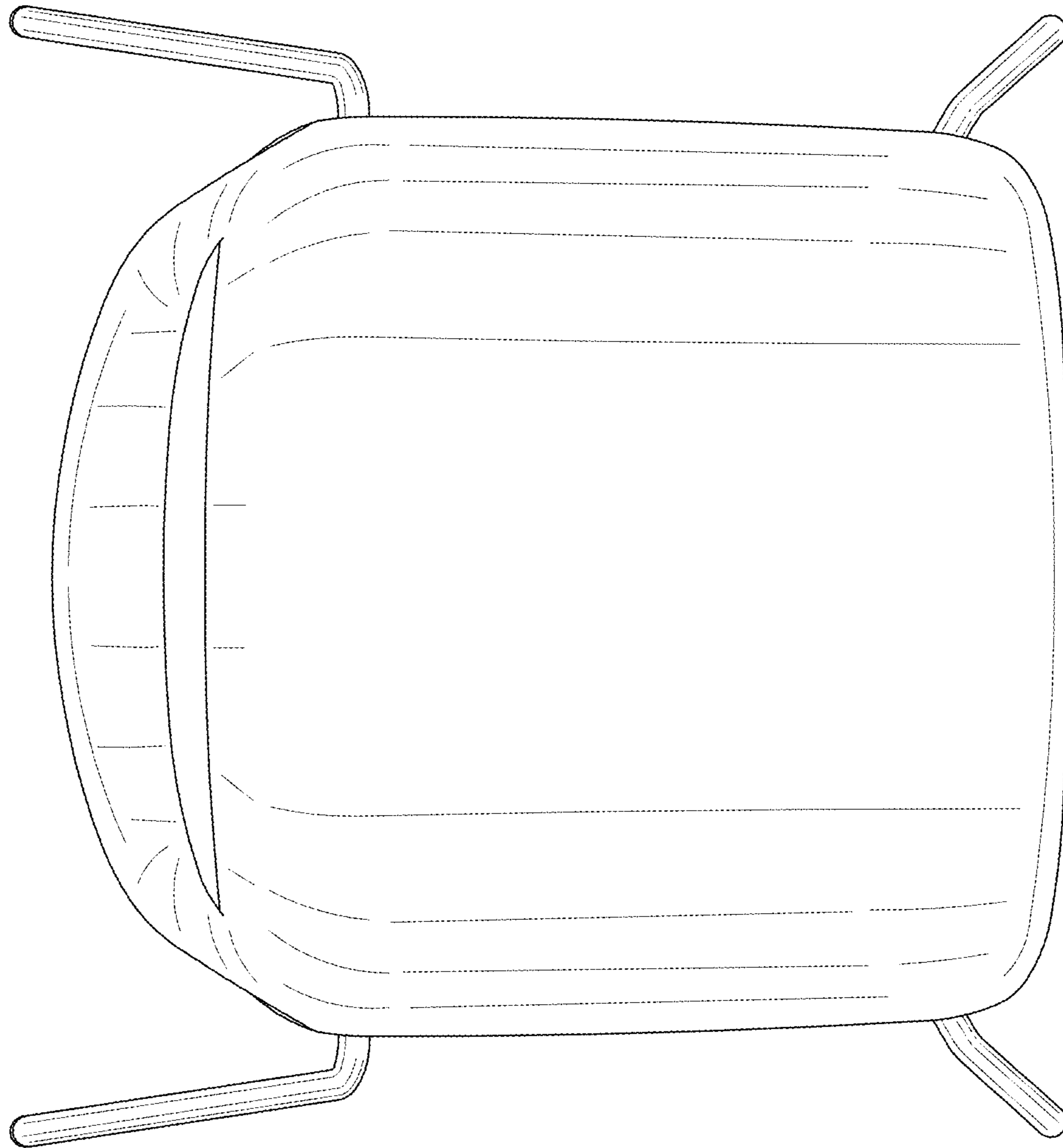
