FIG. 4 is a bottom plan view thereof.

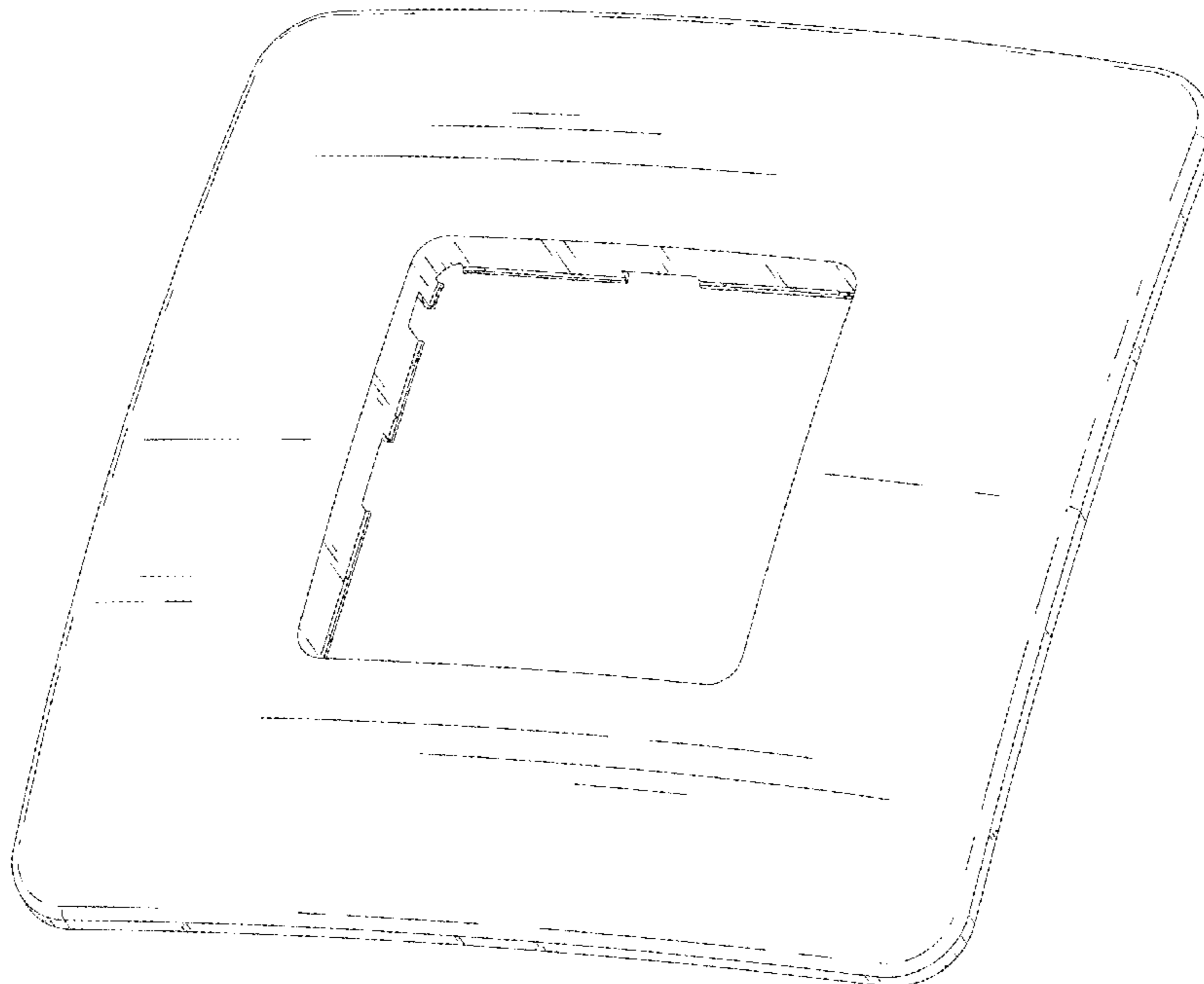
FIG. 5 is a right side elevational view thereof.

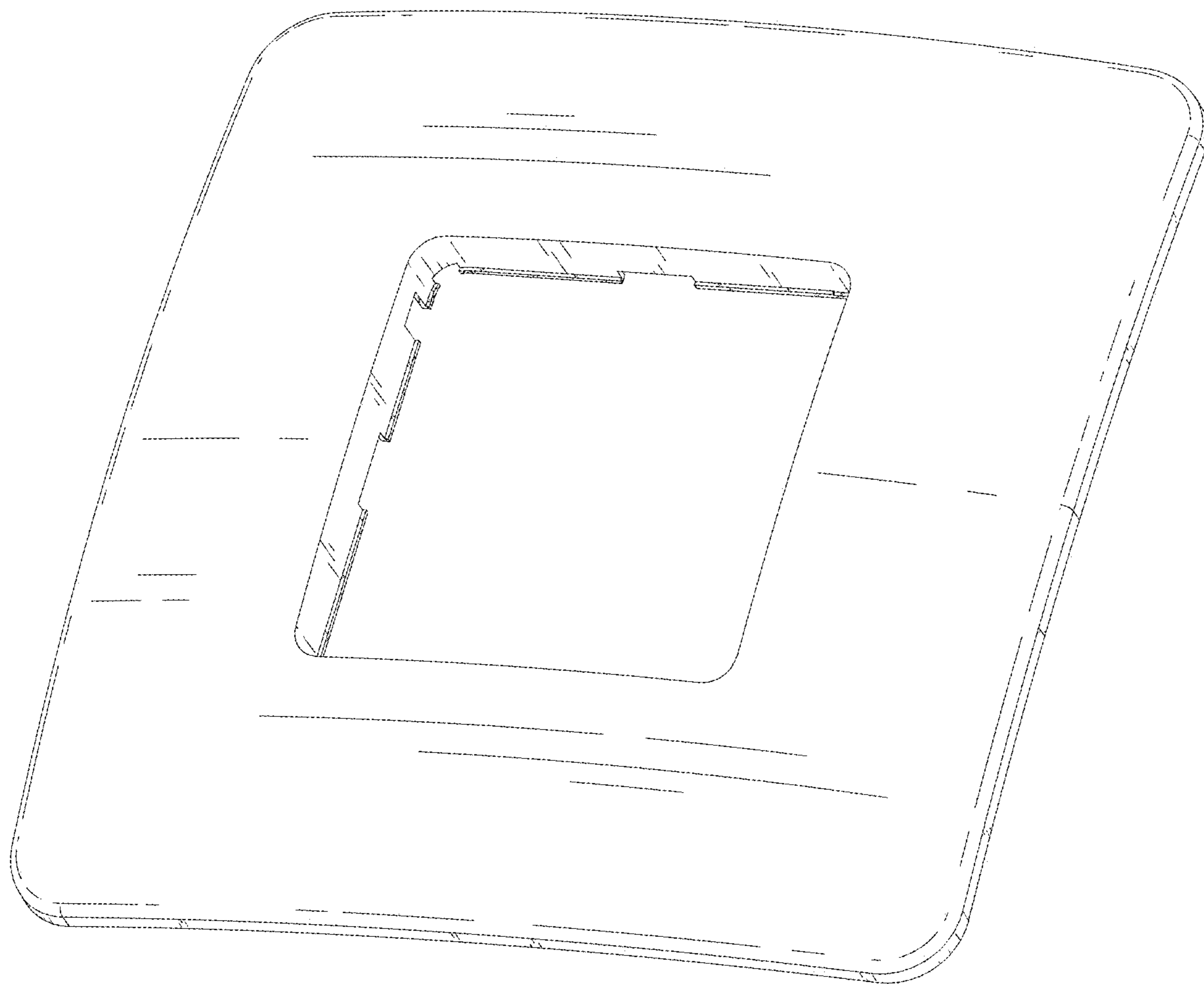

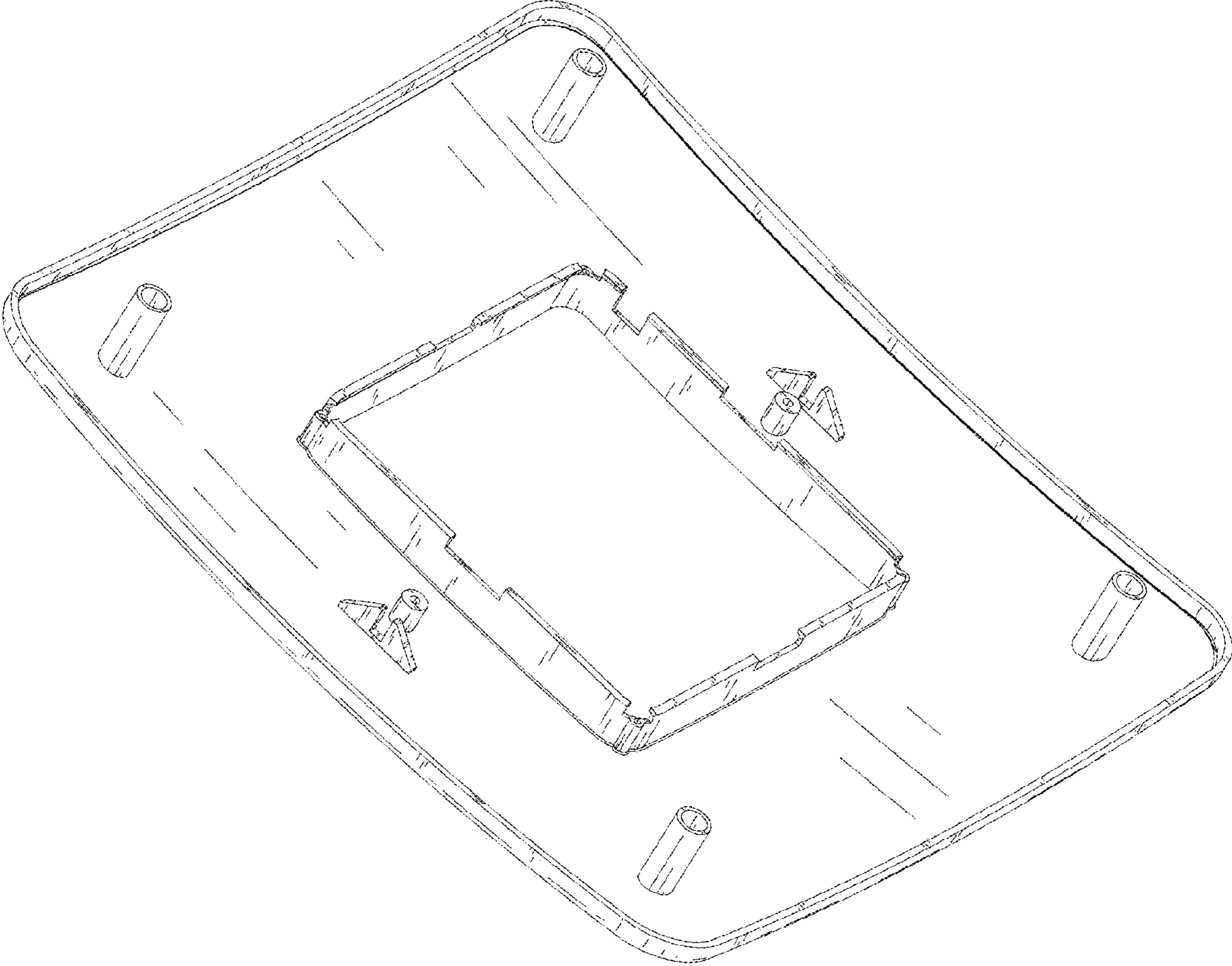

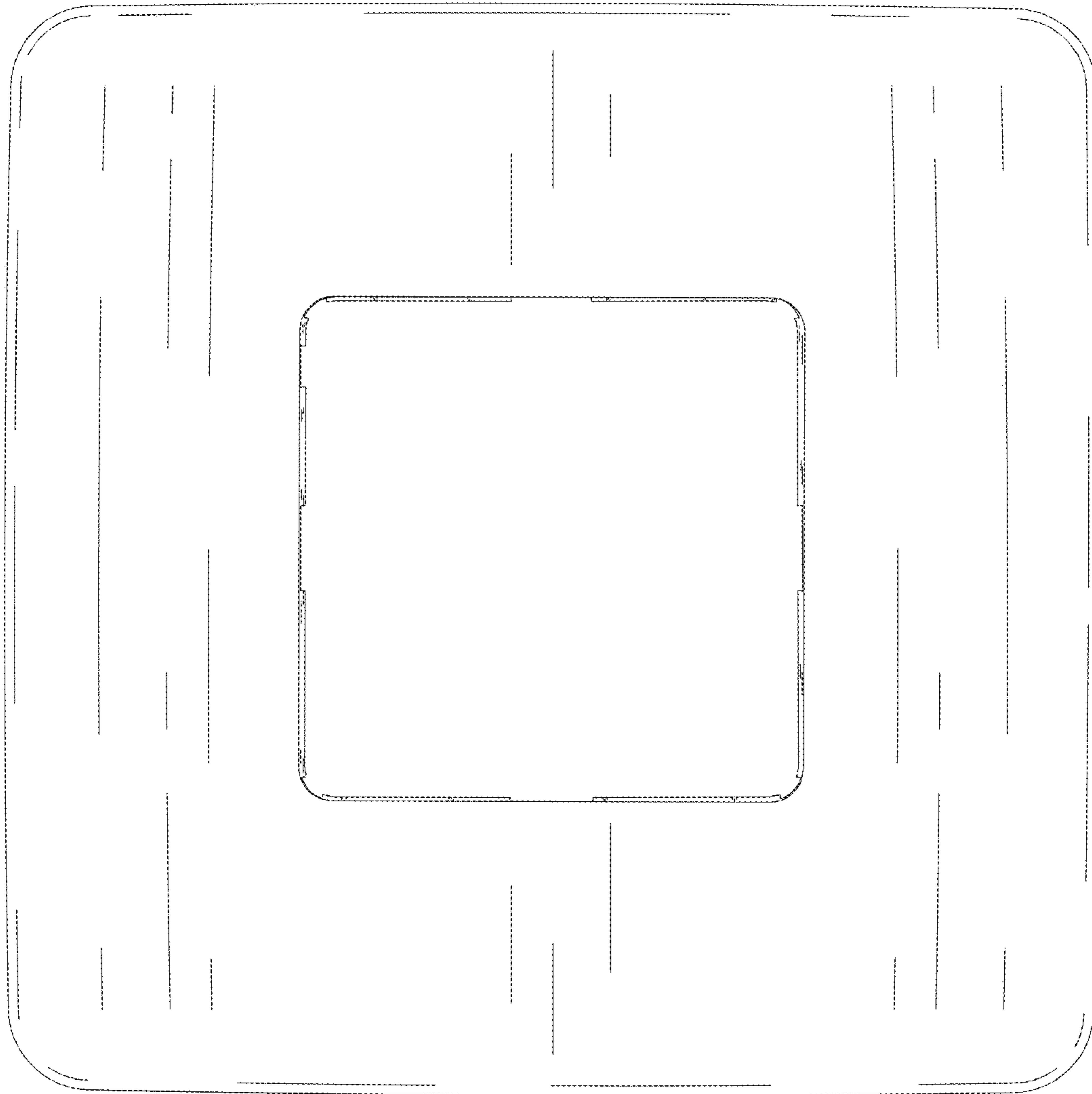

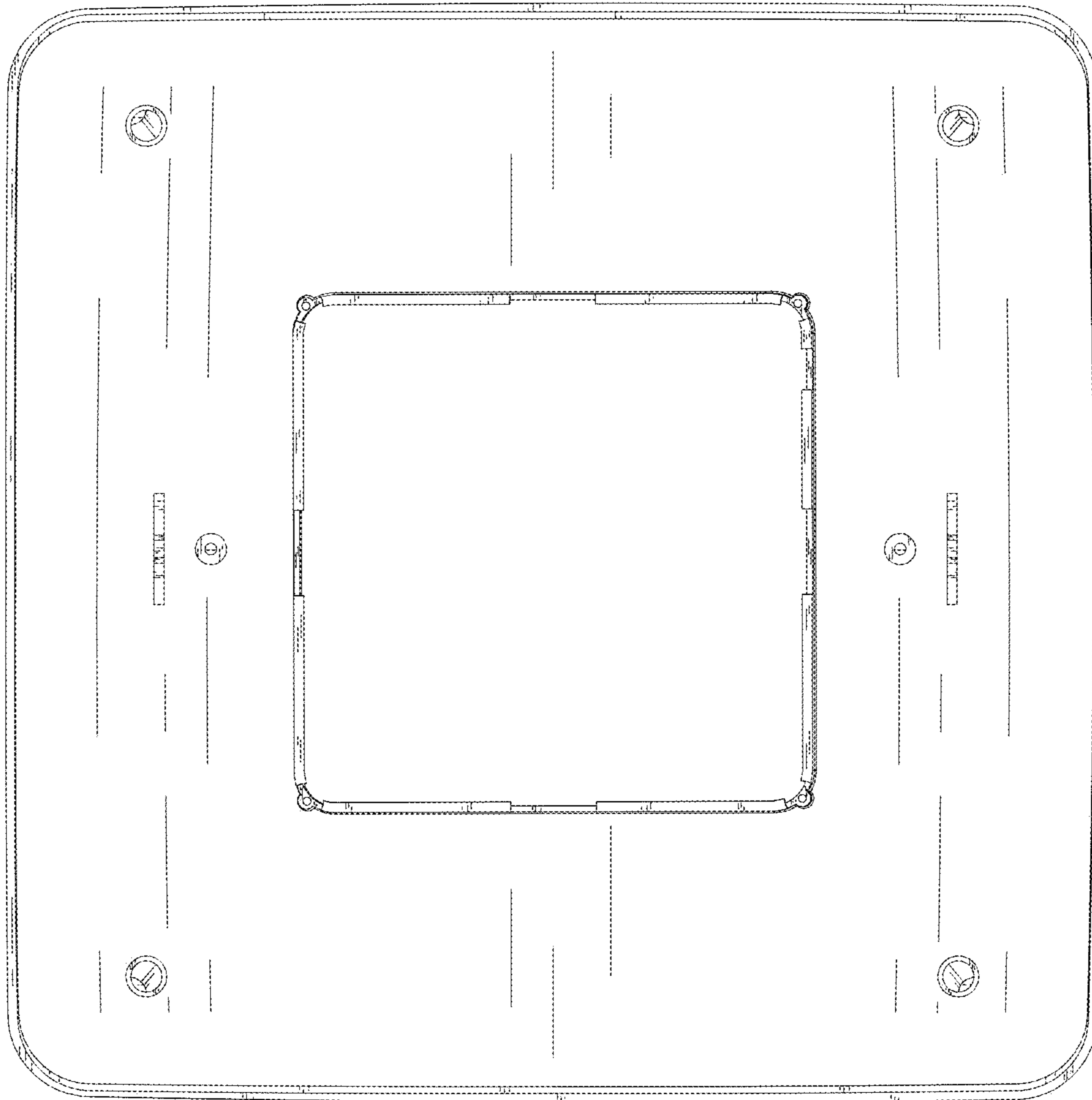

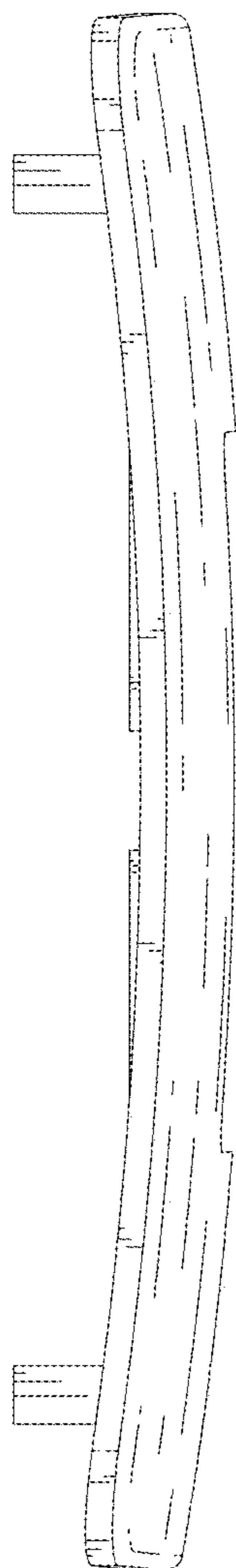

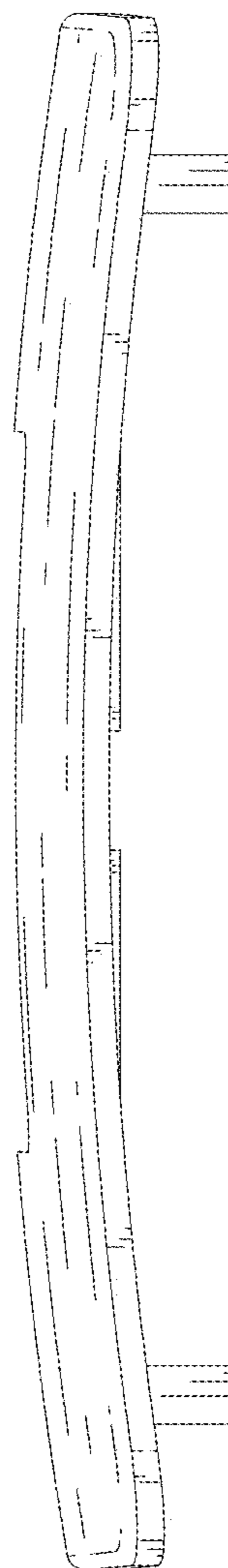

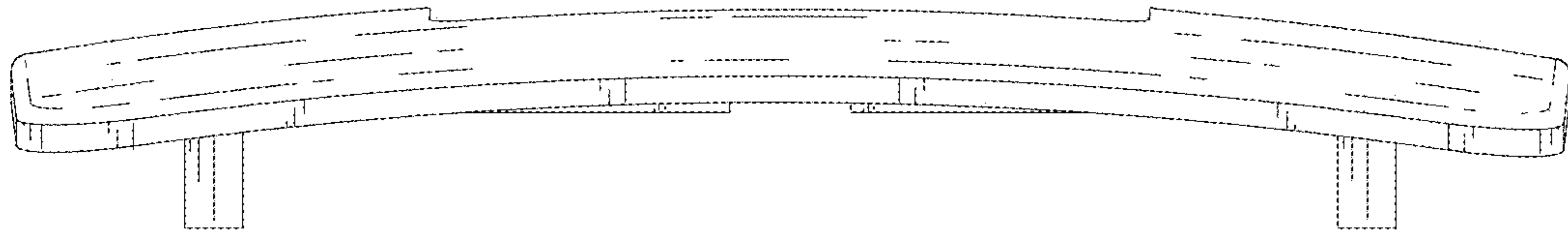

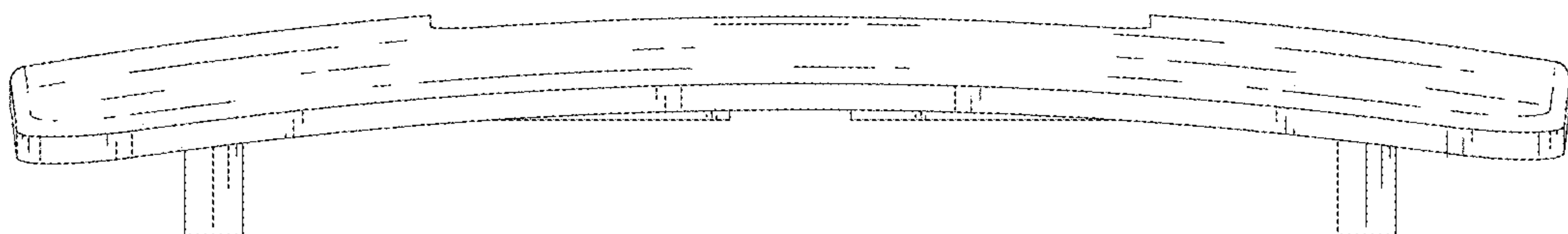
