(57) **CLAIM**

The ornamental design for a vented pouch, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a vented pouch in a closed configuration;

FIG. 2 is a top plan view of the first embodiment thereof in a partially open configuration;

FIG. 3 is a top plan view of the first embodiment thereof in an open configuration;

FIG. 4 is a bottom plan view of the first embodiment thereof; FIG. 5 is a front elevation view of the first embodiment thereof;

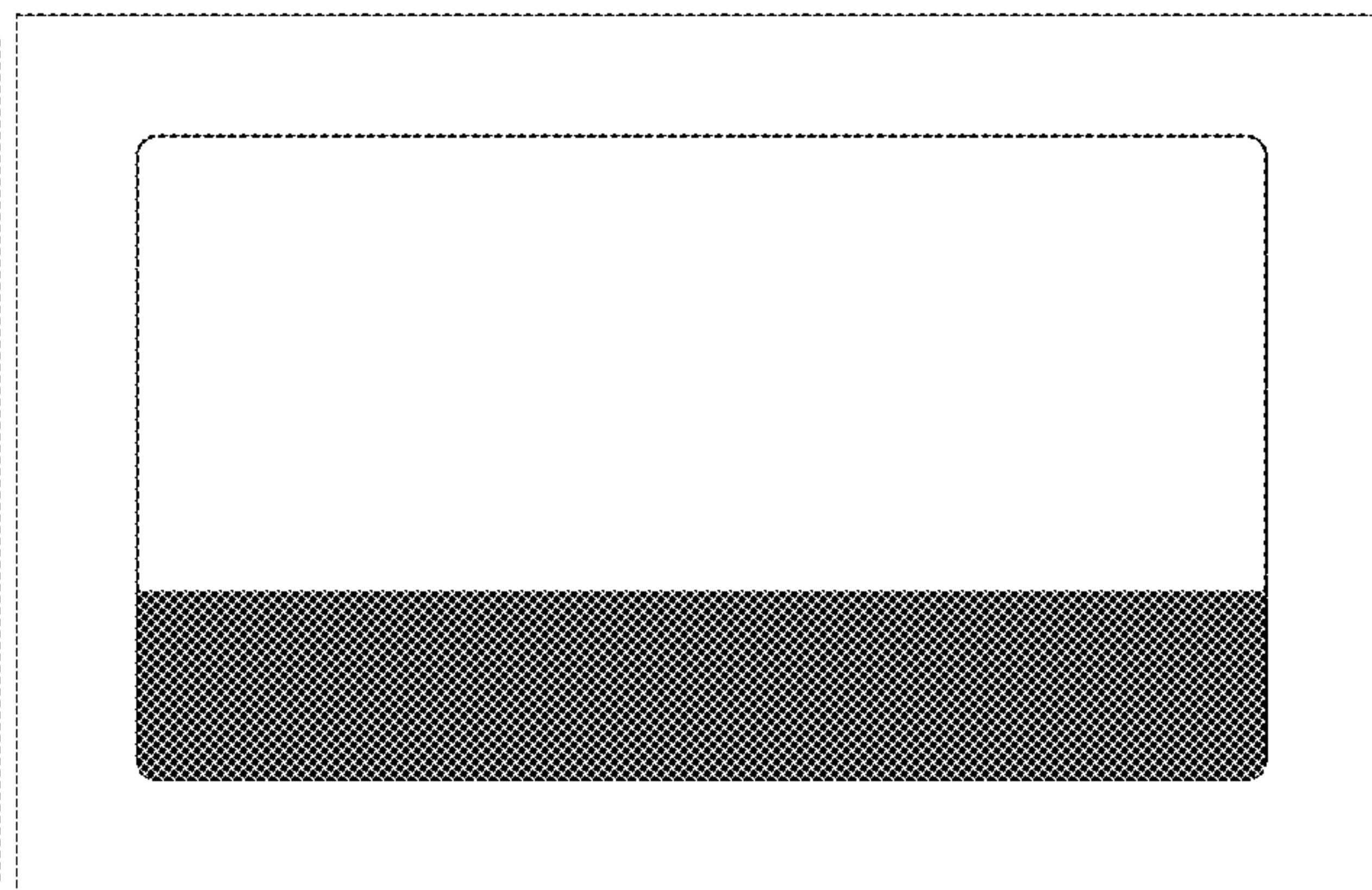
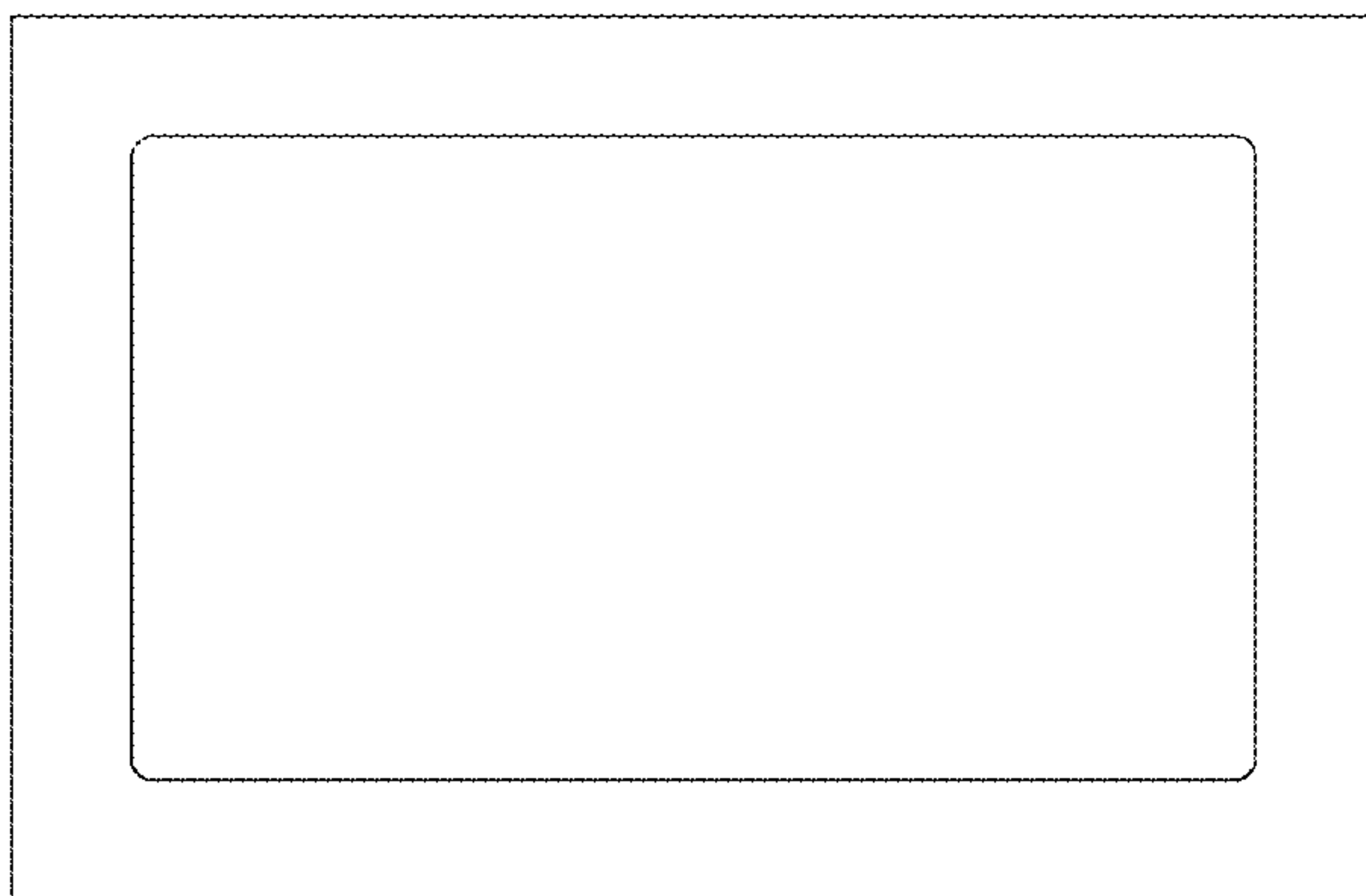
FIG. 6 is a back elevation view of the first embodiment thereof;

FIG. 7 is a right elevation view of the first embodiment thereof;

FIG. 8 is a left elevation view of the first embodiment thereof;

FIG. 9 is a top plan view of a second embodiment of a vented pouch in a closed configuration, wherein the bottom, front, back, right and left views are substantially identical to those of the first embodiment thereof detailed above; and, FIG. 10 is a top plan view of a third embodiment of a vented pouch in a closed configuration, wherein the bottom, front, back, right and left views are substantially identical to those of the first embodiment thereof detailed above.

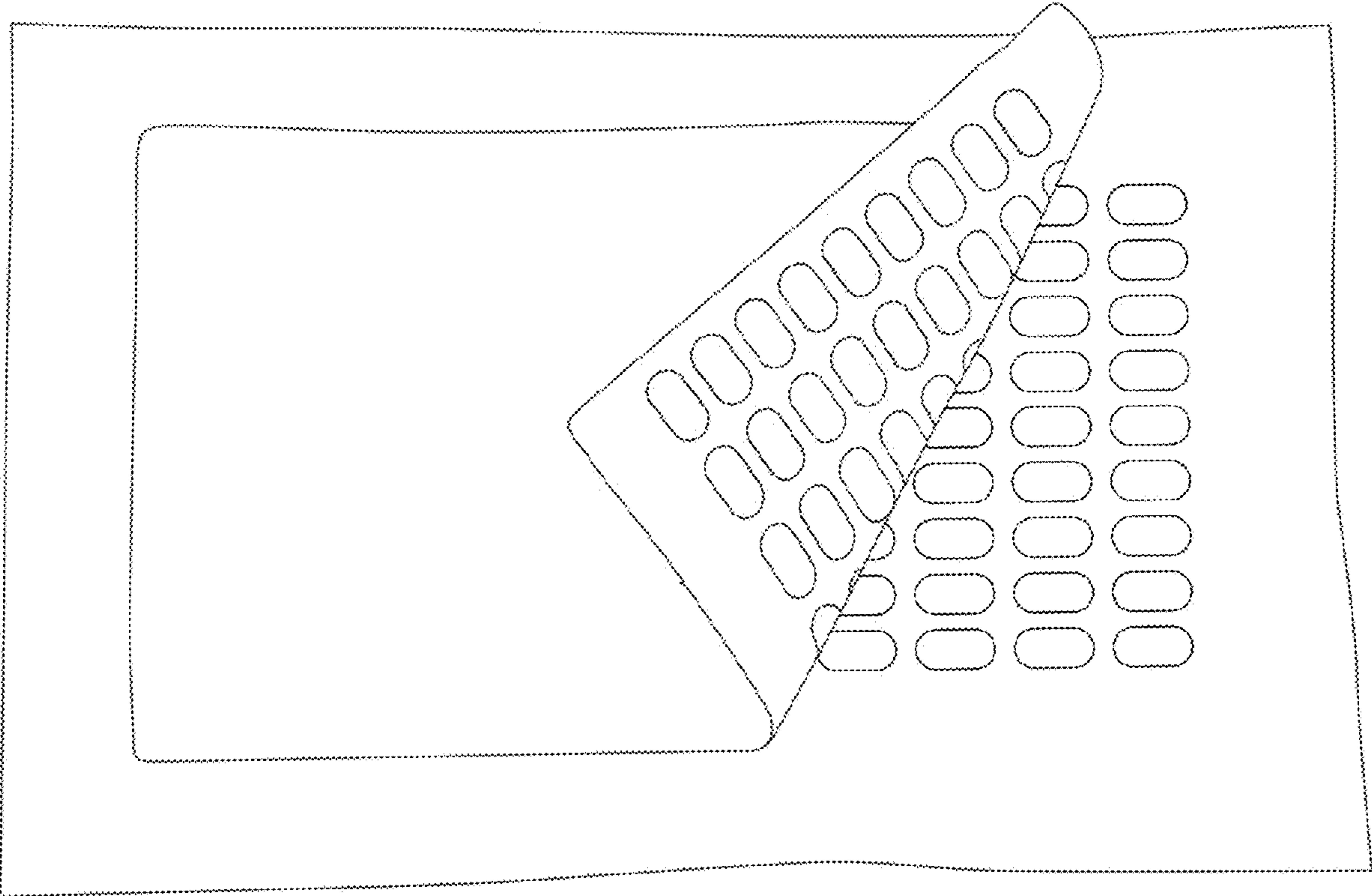

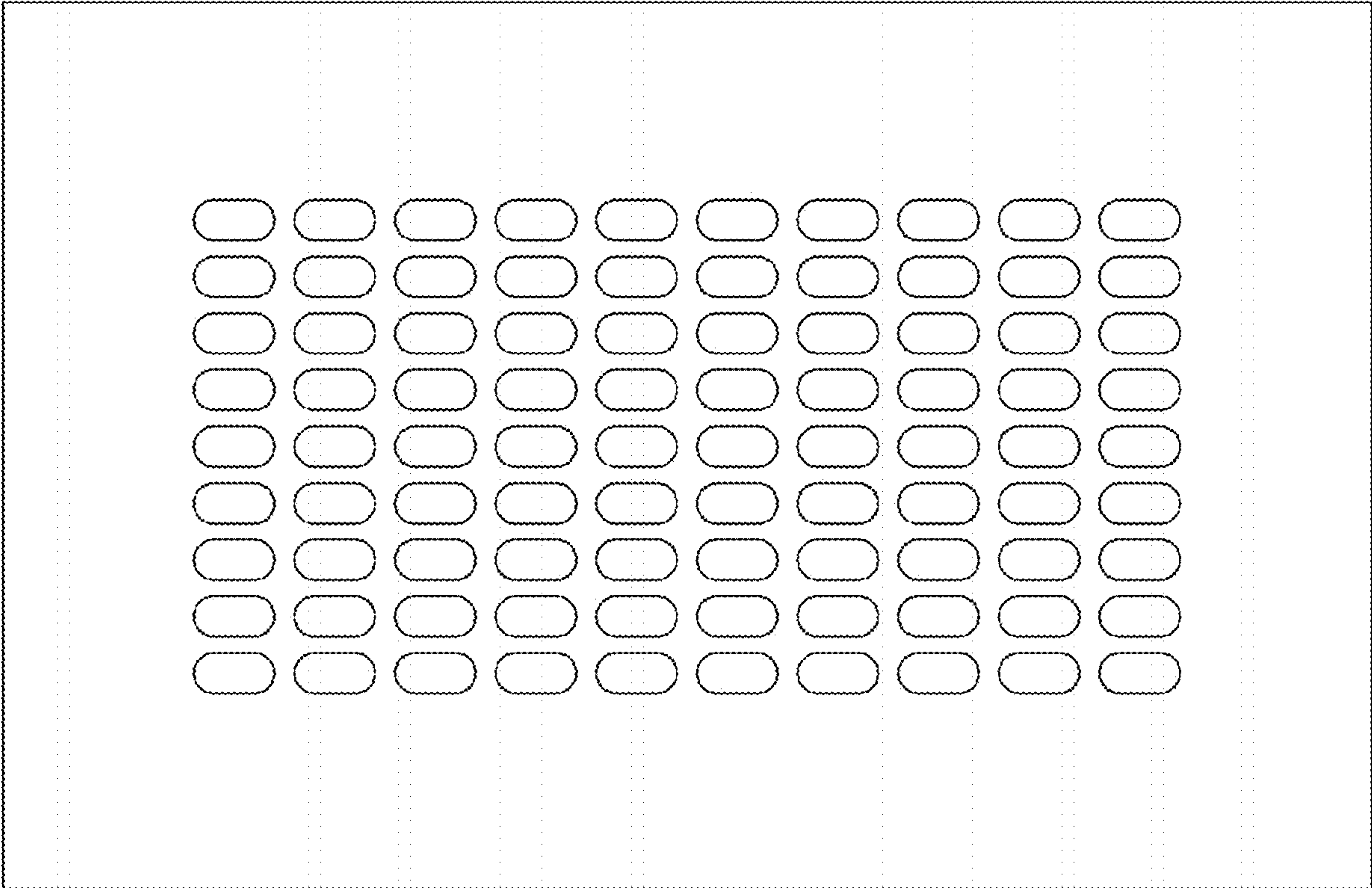

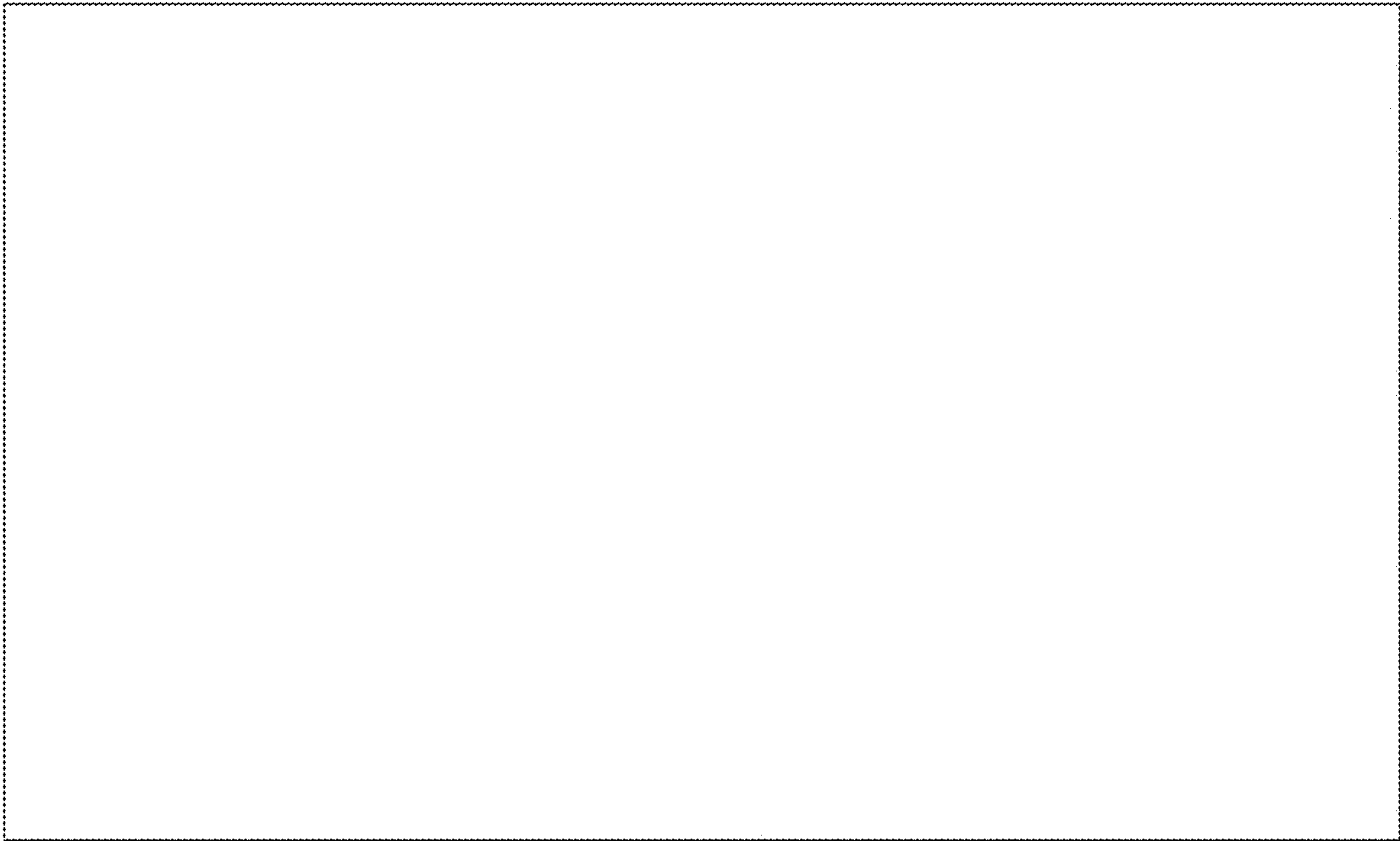

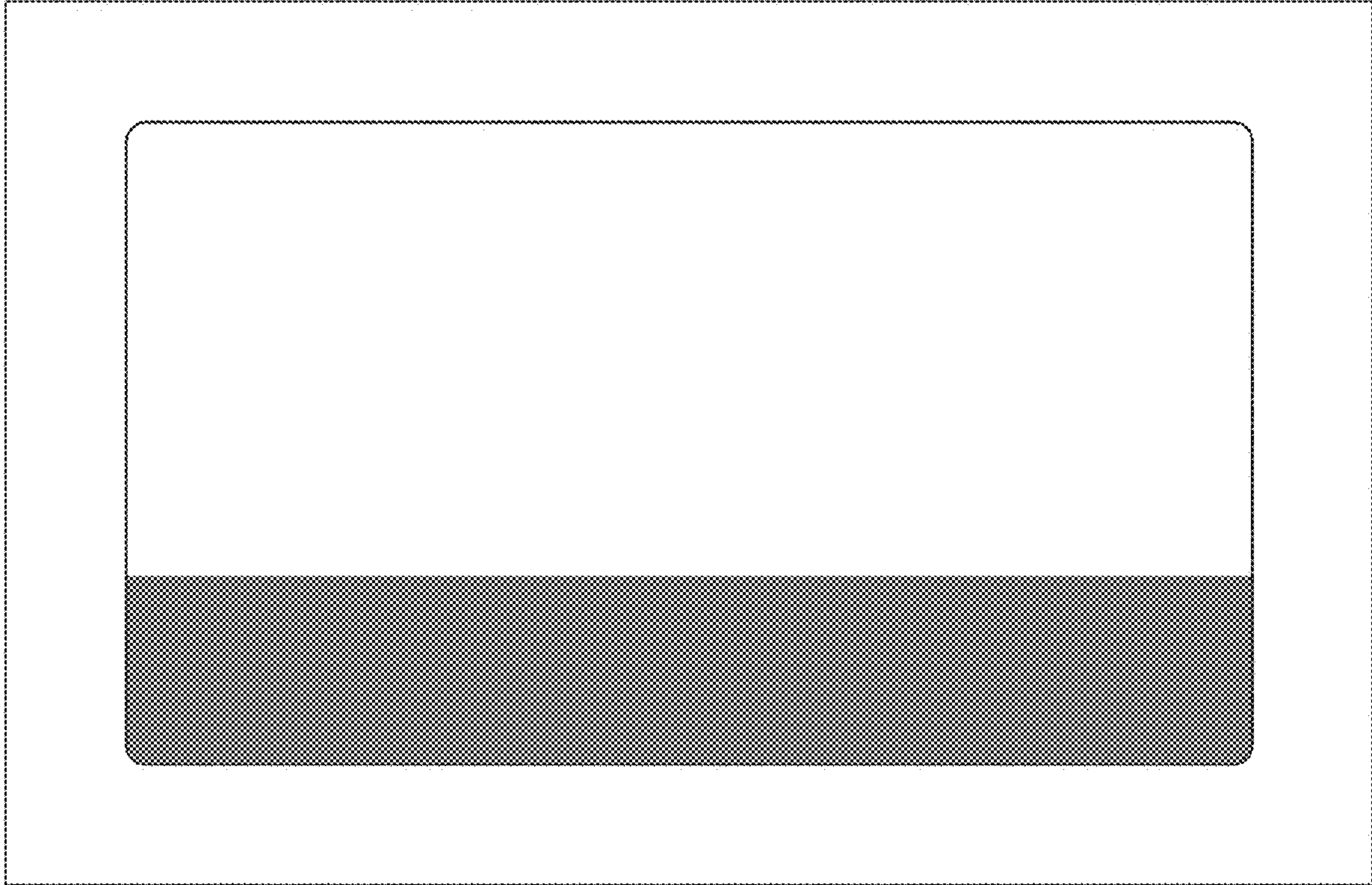

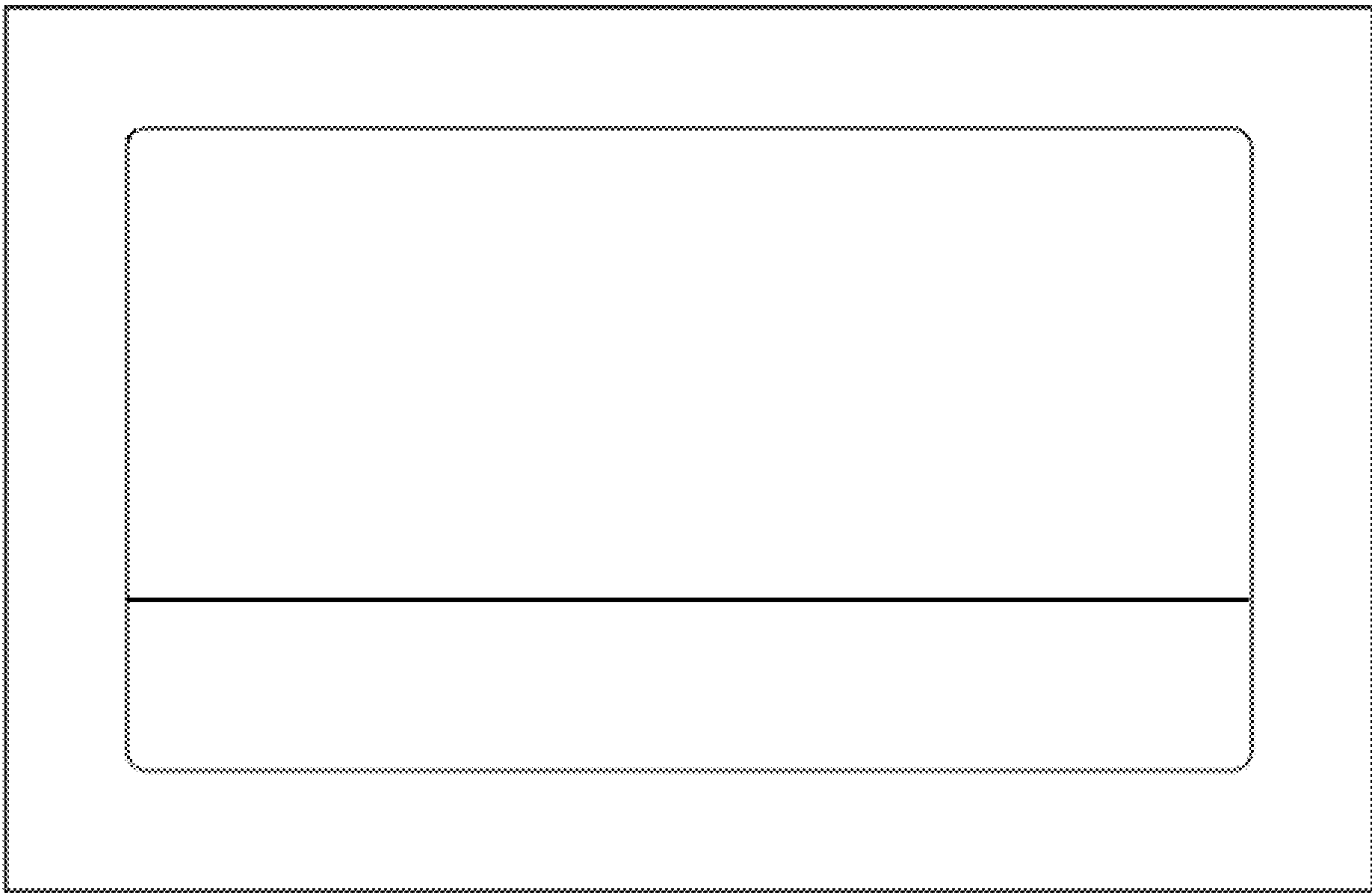
