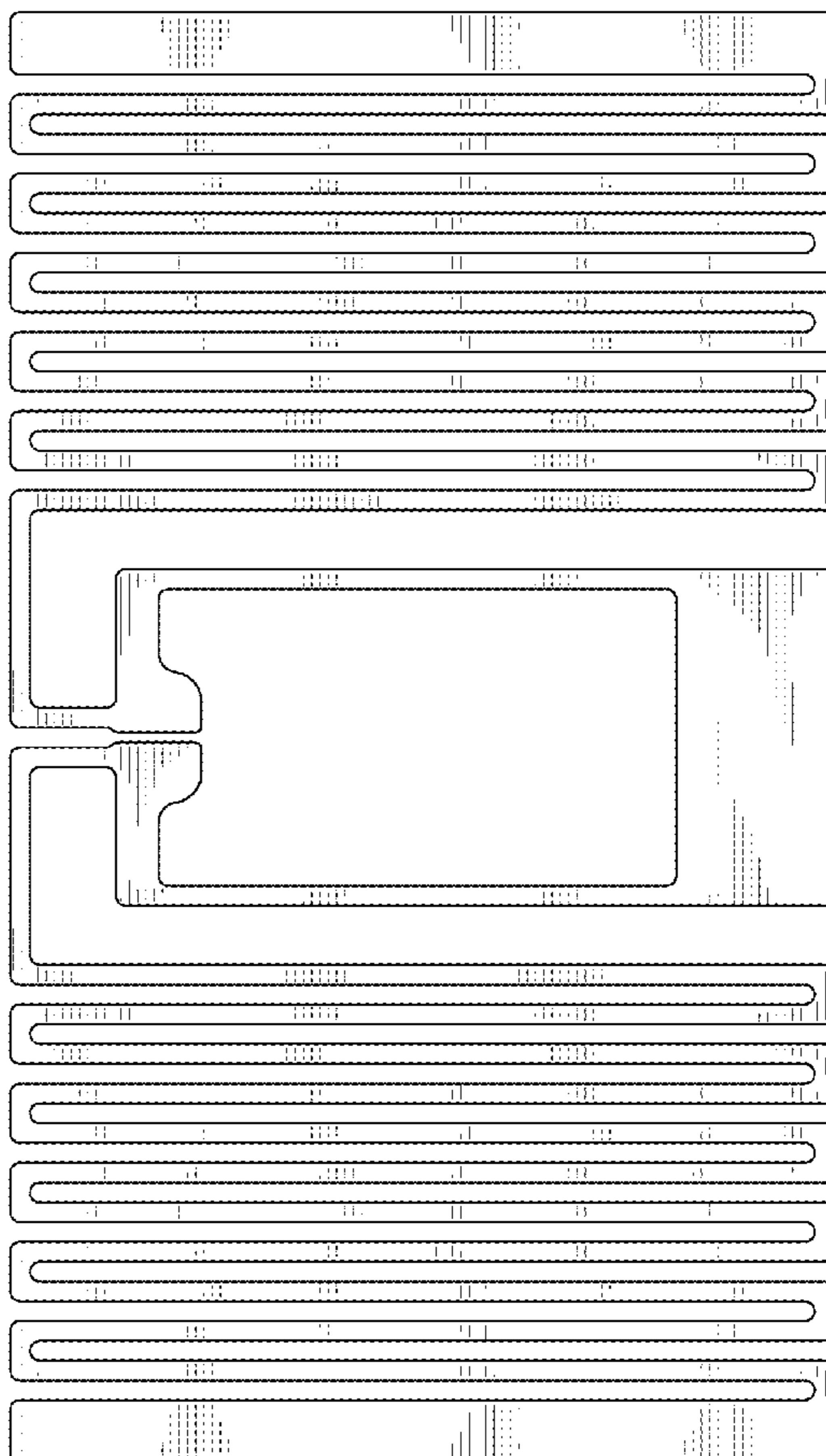
**DESCRIPTION**

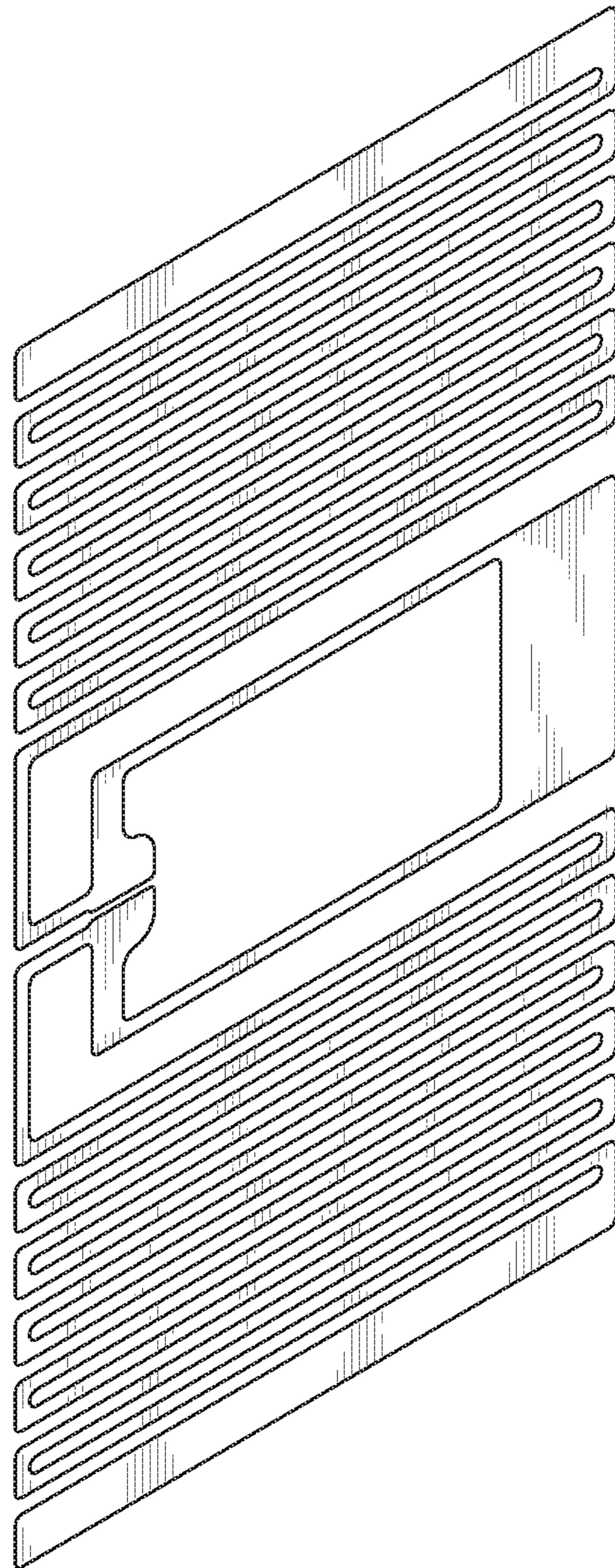

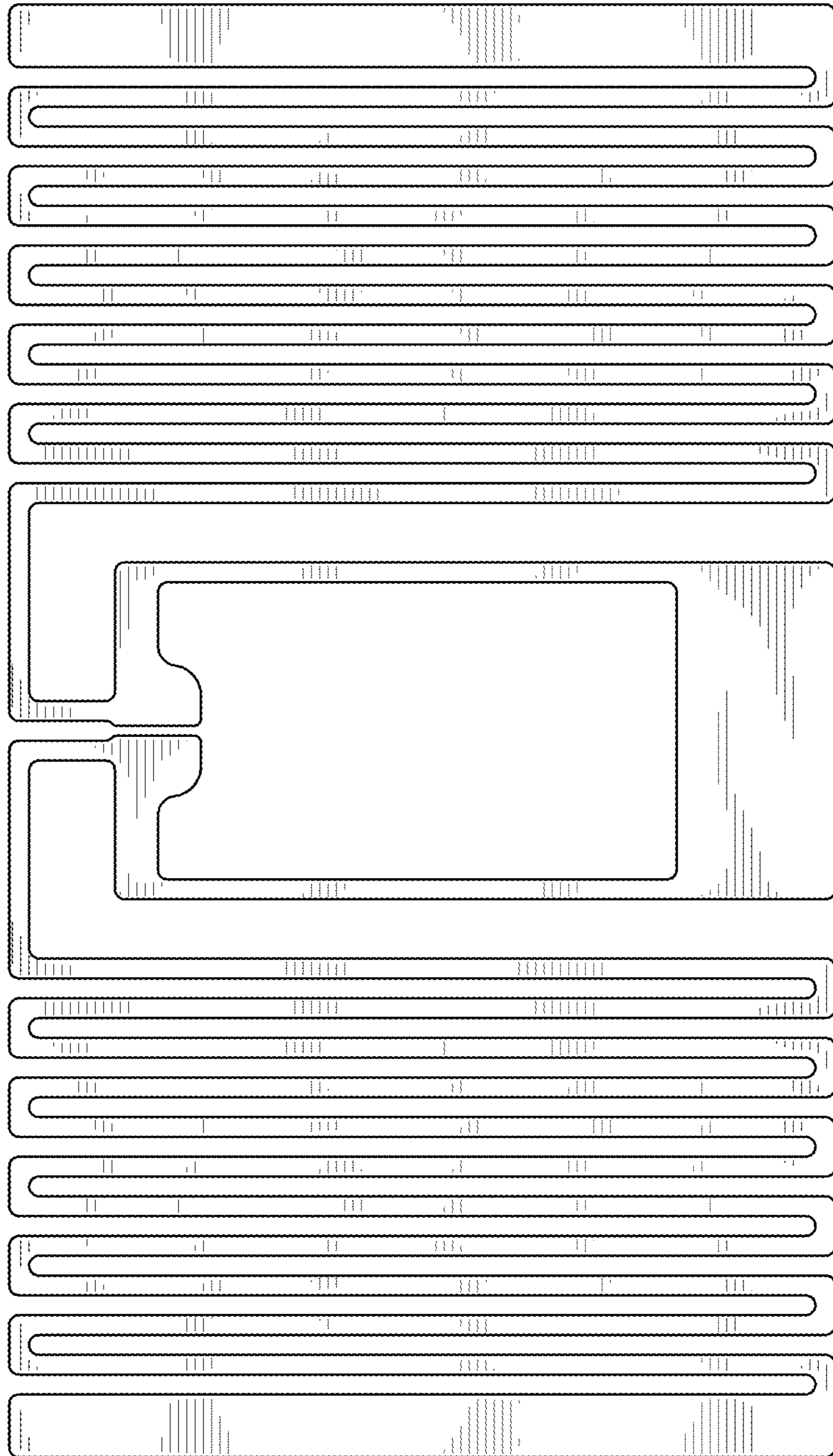
