(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with graphical user interface showing our new design; and,

FIG. 2 is a front view of a second embodiment thereof, shown enlarged and without the display screen for clarity of illustration.

The outer perimeter shown in evenly-spaced broken lines in FIG. 1 illustrates a display screen or portion thereof and forms no part of the claimed design. The remaining evenly-spaced broken lines in FIG. 1 illustrate portions of the graphical user interface that form no part of the claimed design. The dot-dash broken lines in FIG. 1 define boundaries of the claimed design and form no part thereof.

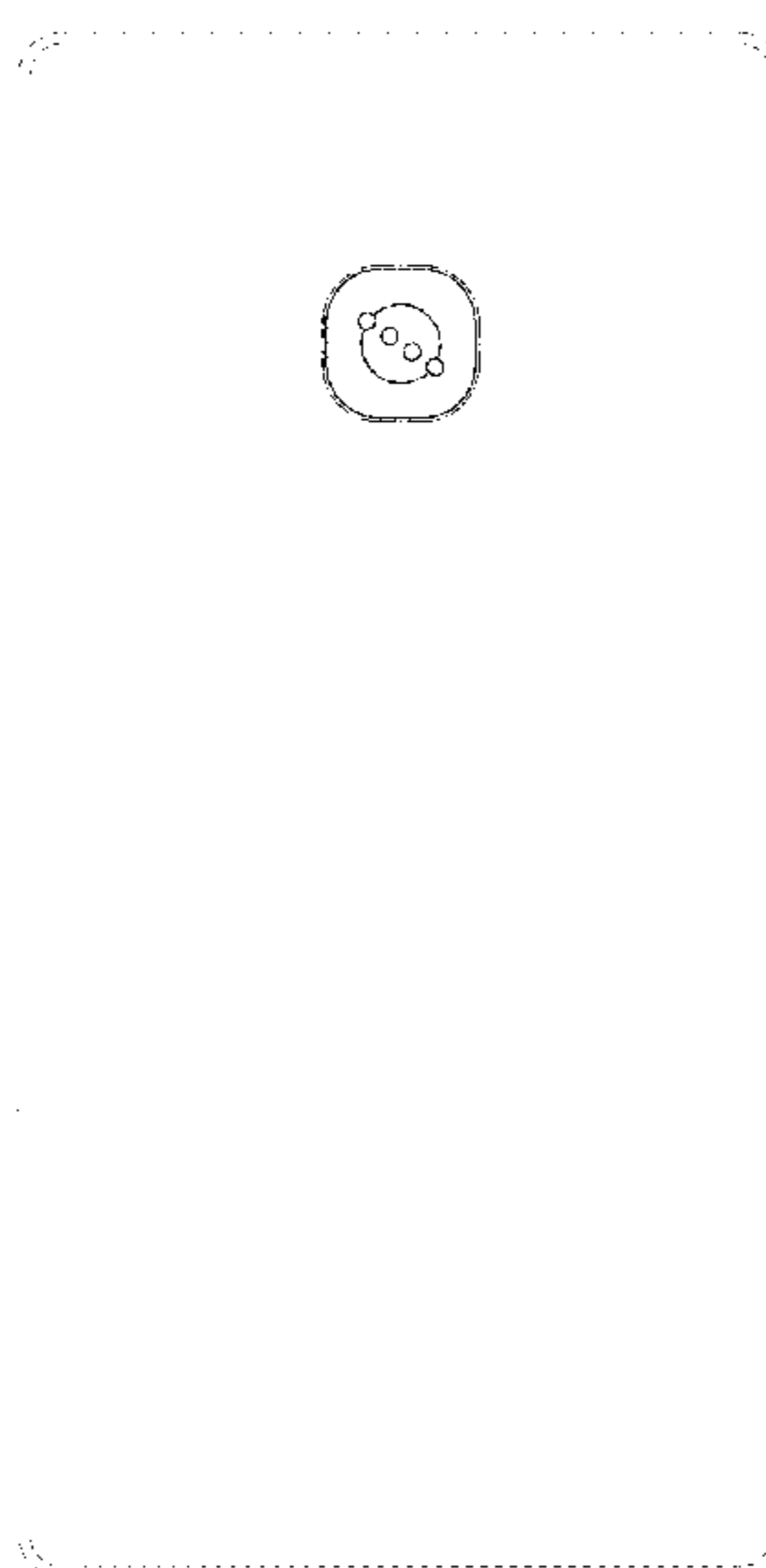

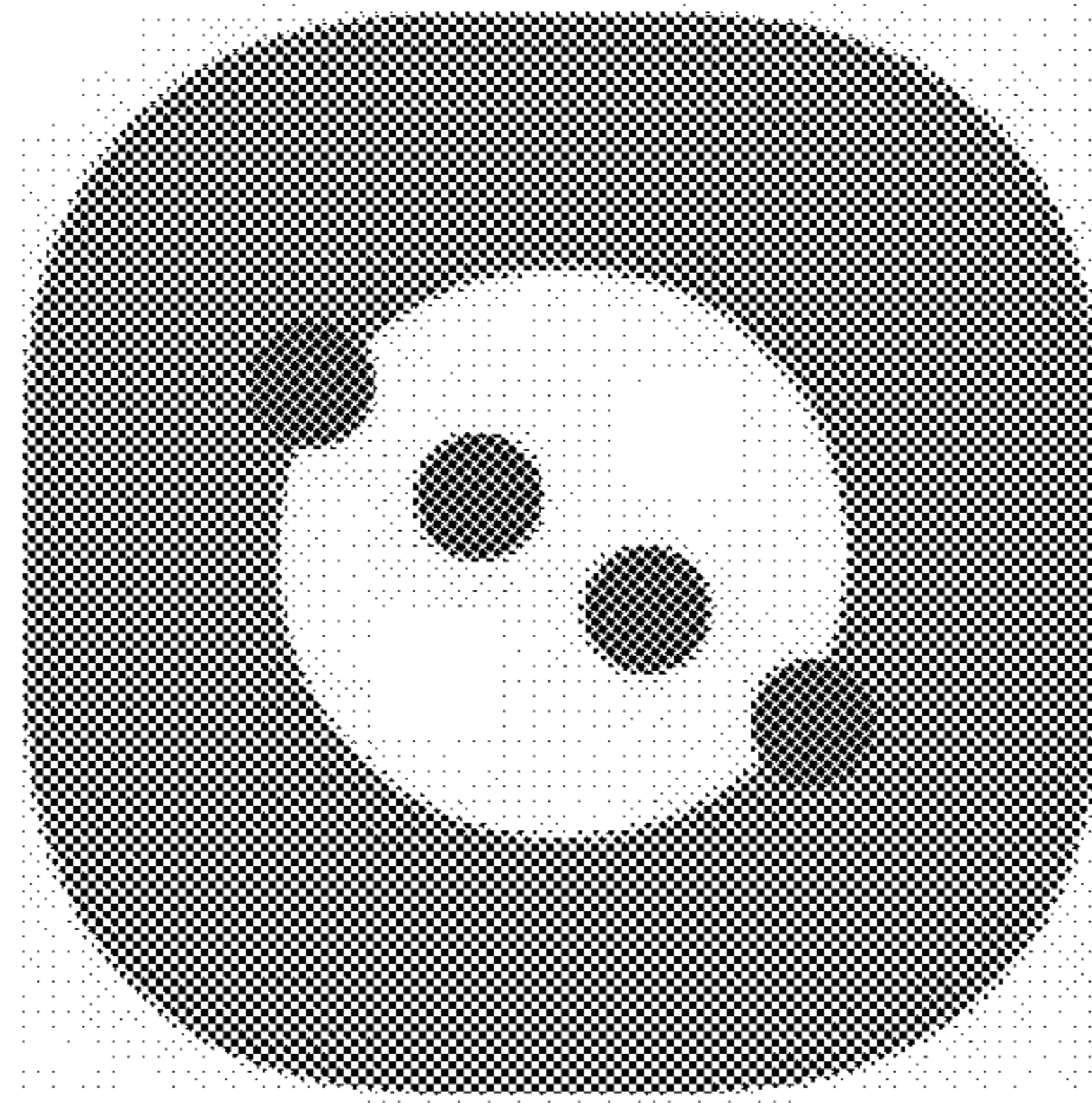
