(57) **CLAIM**

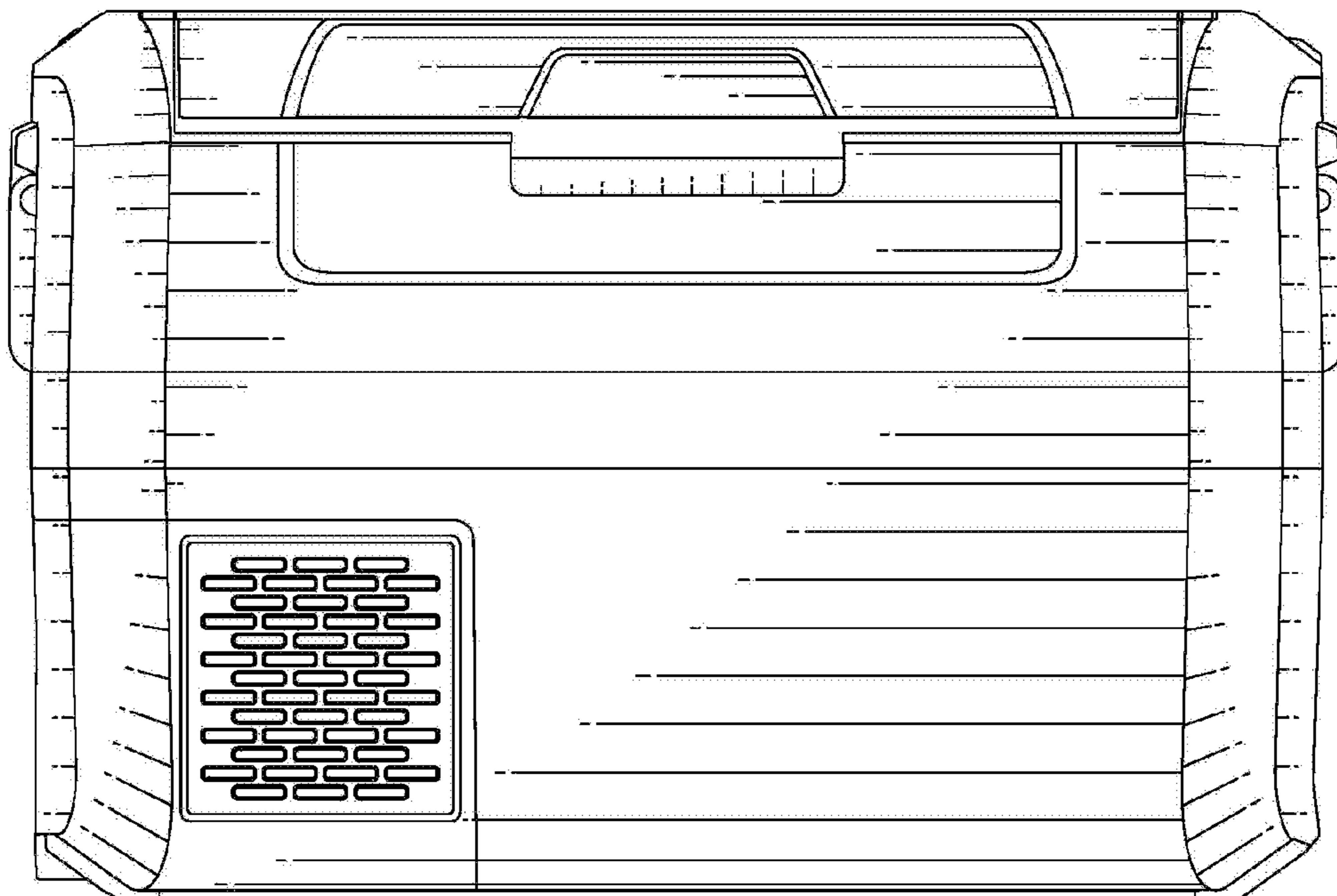
The ornamental design for a portable refrigerator, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a portable refrigerator; FIG. 2 is an opposite elevation view of the portable refrigerator; FIG. 3 is a top plan view of the portable refrigerator; FIG. 4 is a bottom plan view of the portable refrigerator; FIG. 5 is a side elevation view of the portable refrigerator; FIG. 6 is an opposite side elevation view of the portable refrigerator; FIG. 7 is a perspective view of the portable refrigerator; and, FIG. 8 is an environmental view of the portable refrigerator in a vehicle.

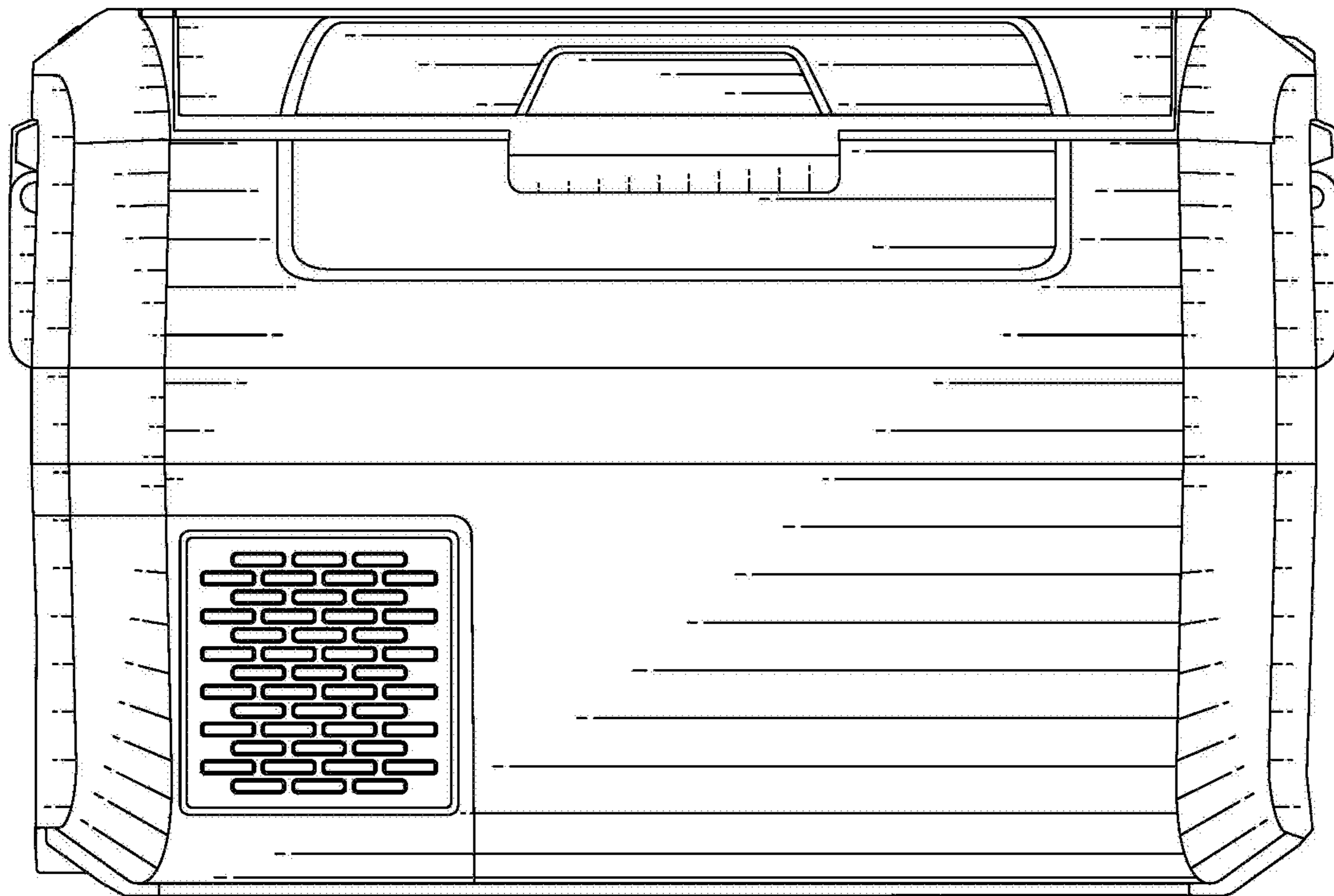

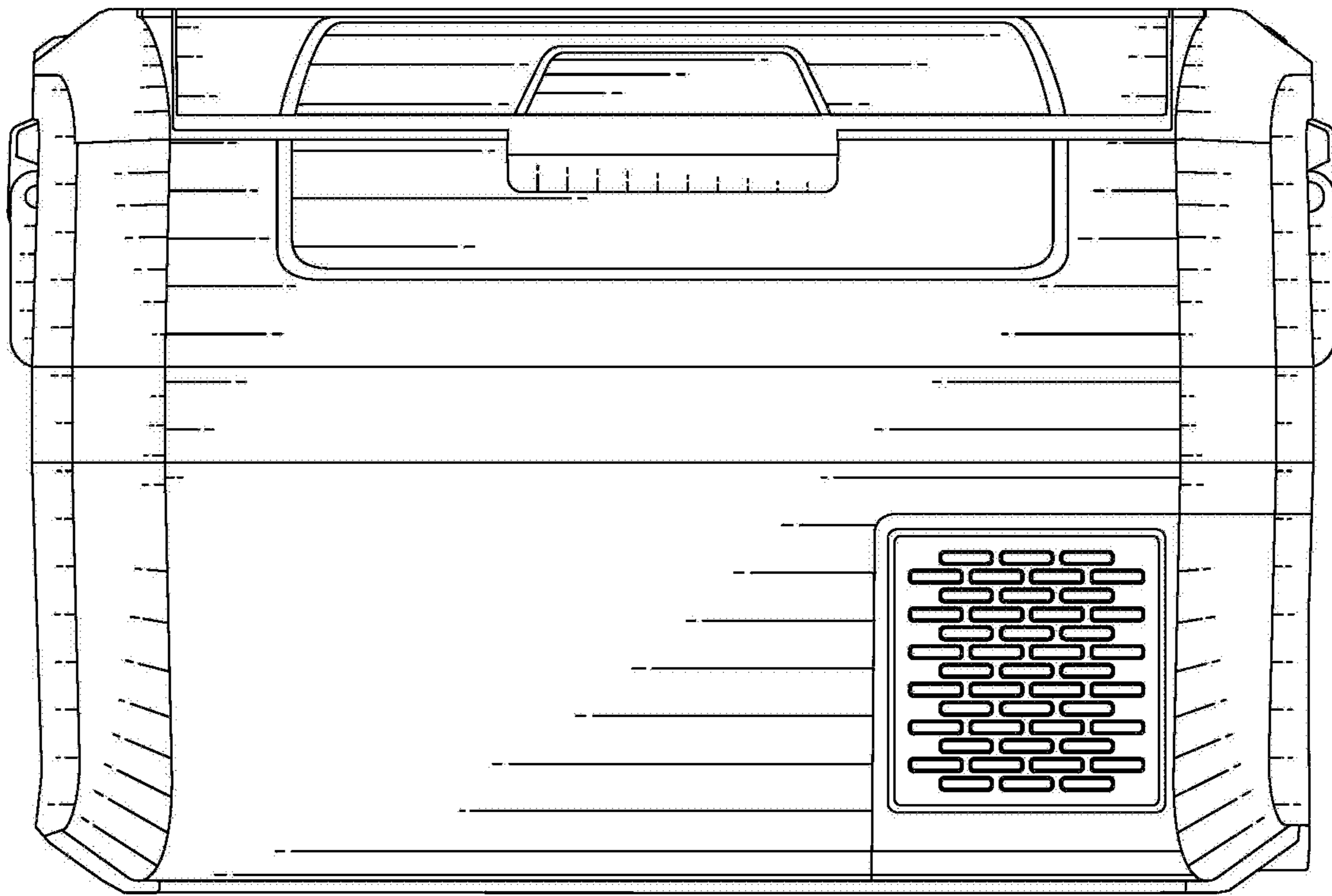

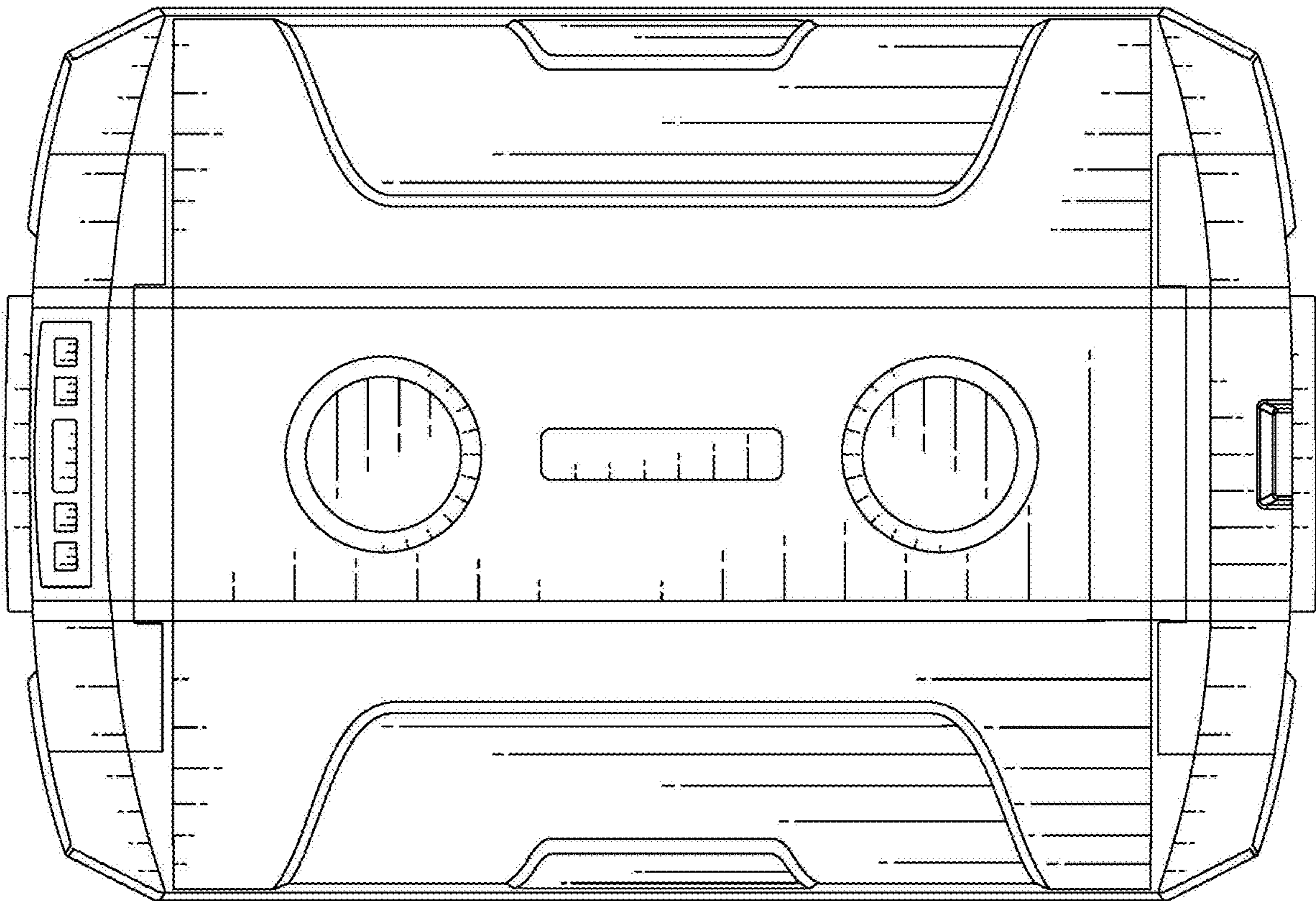

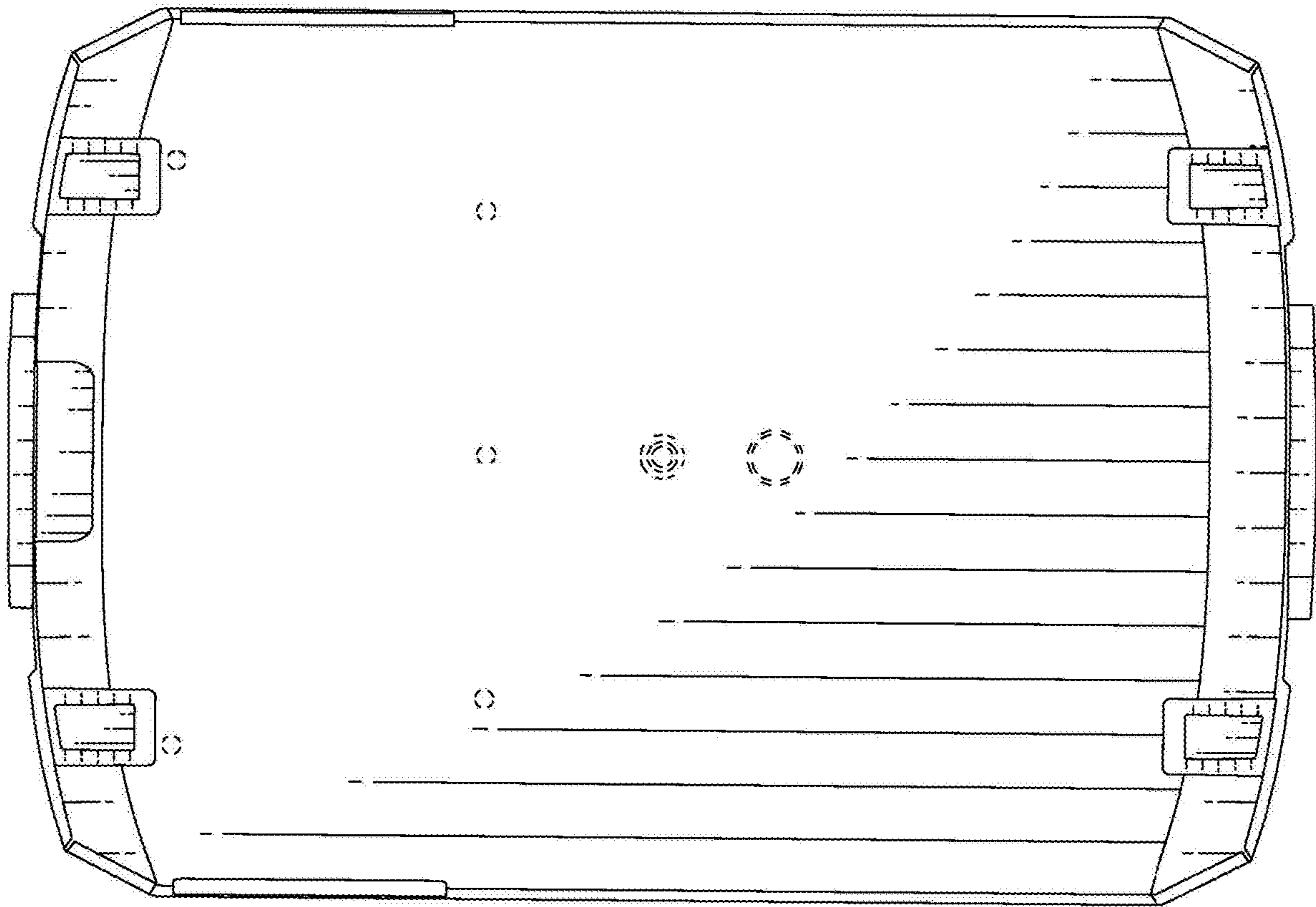

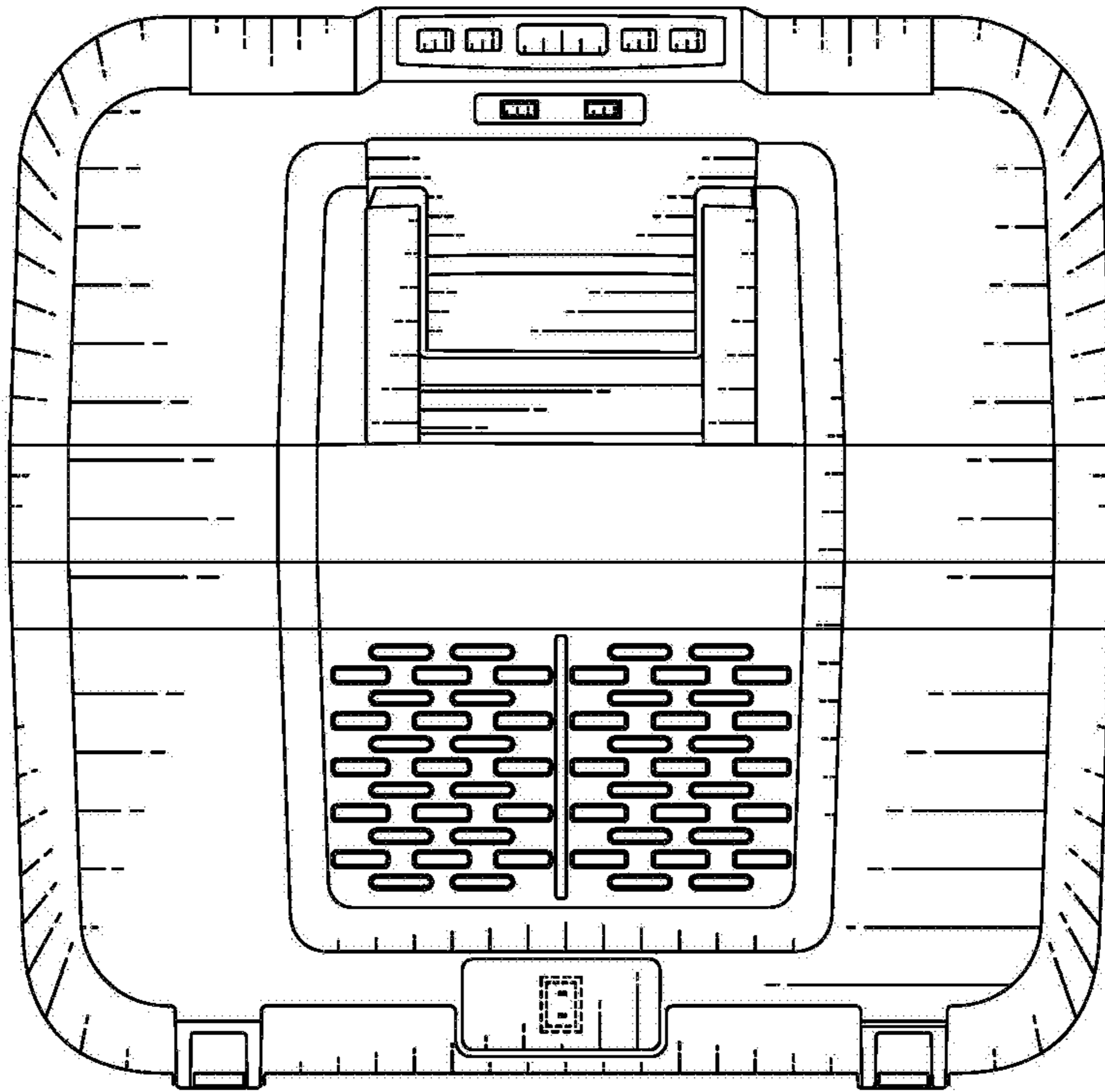

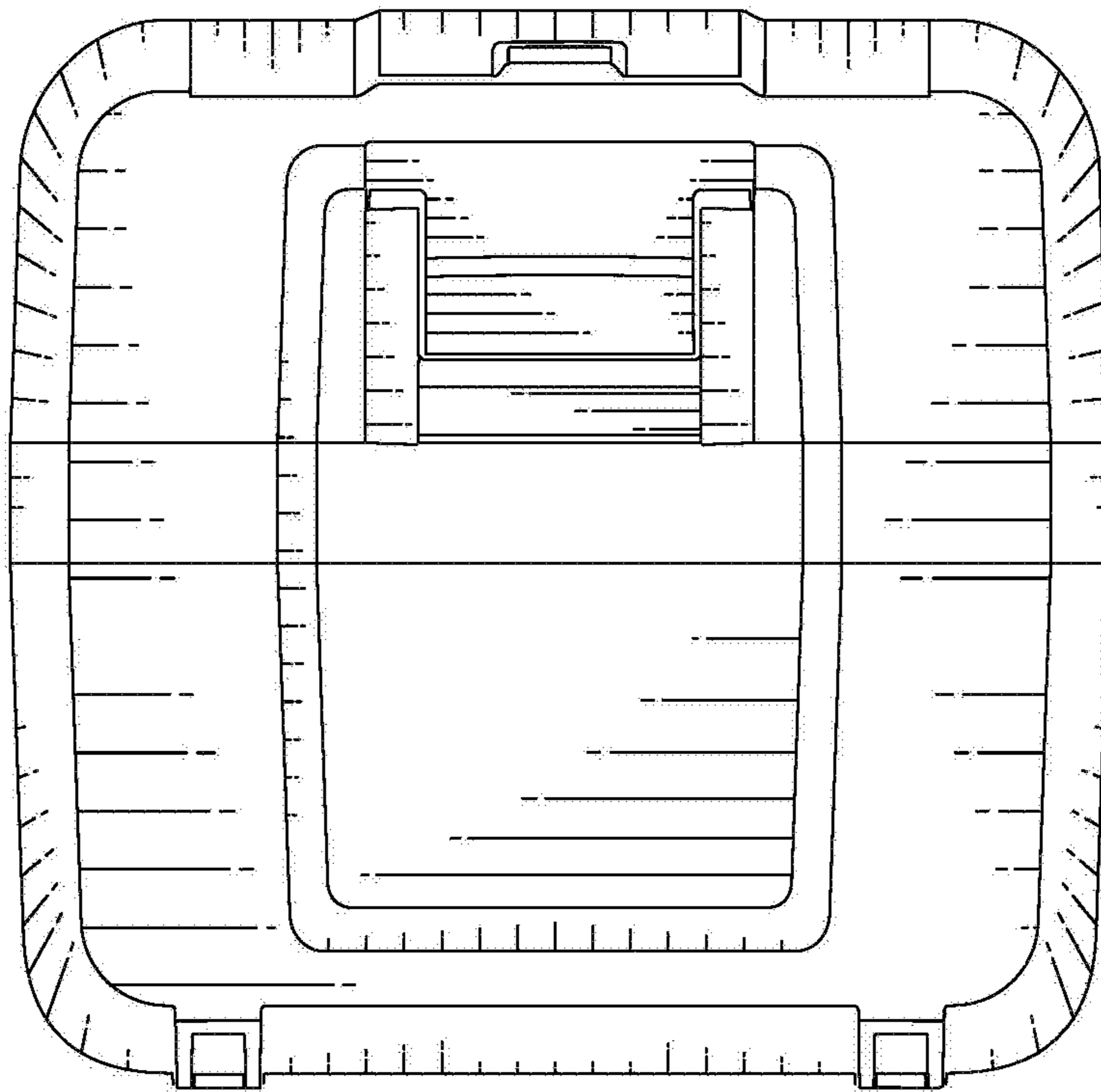

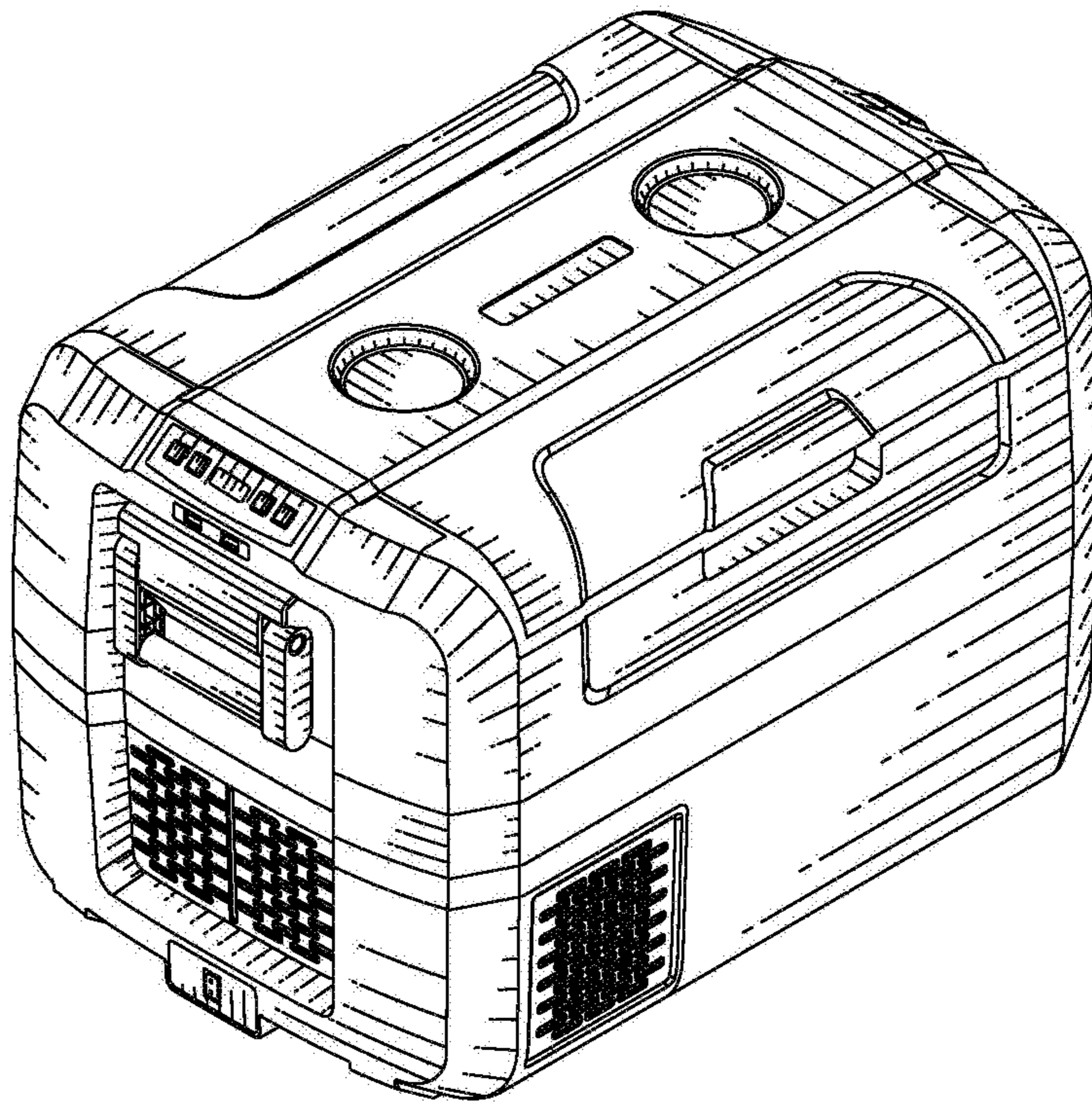

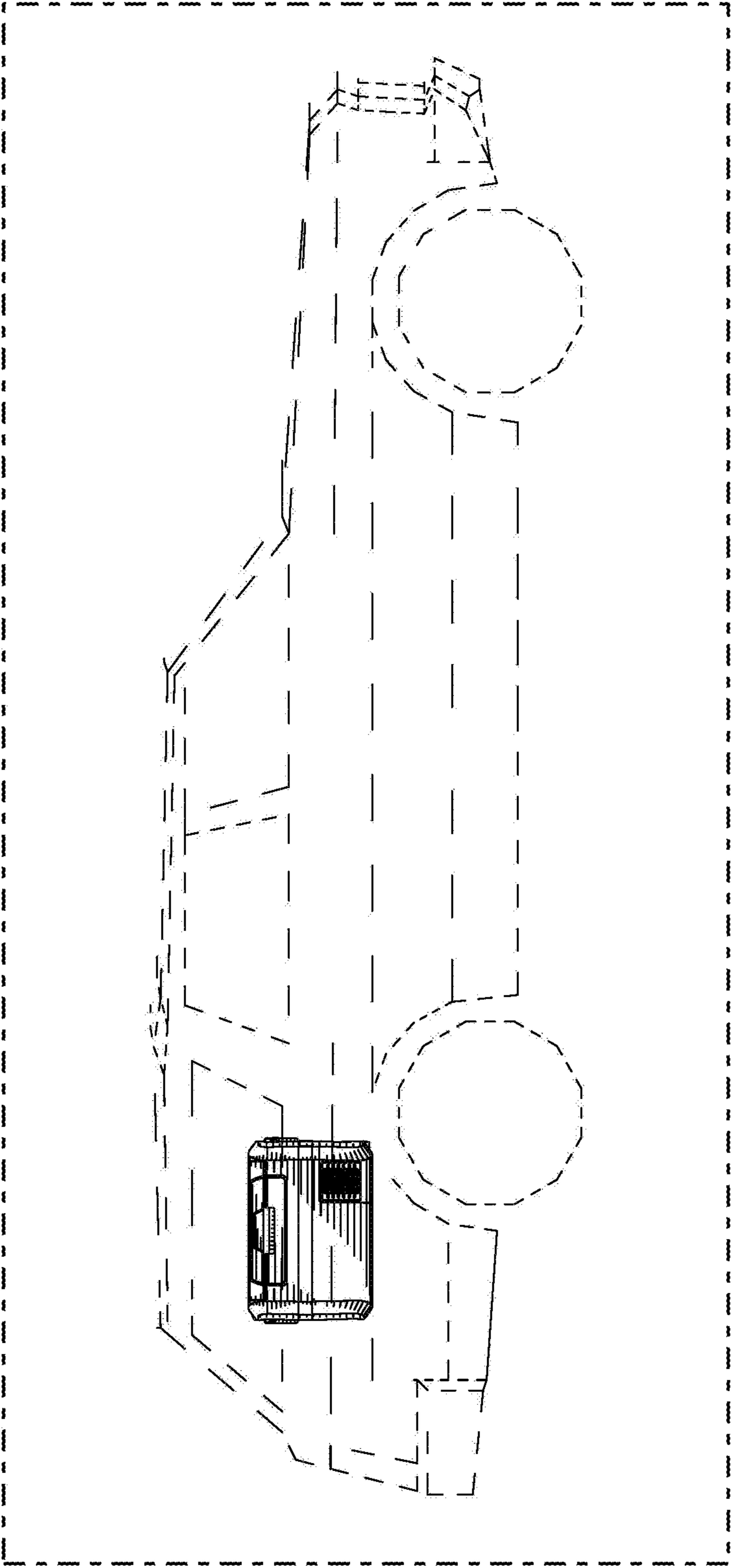
