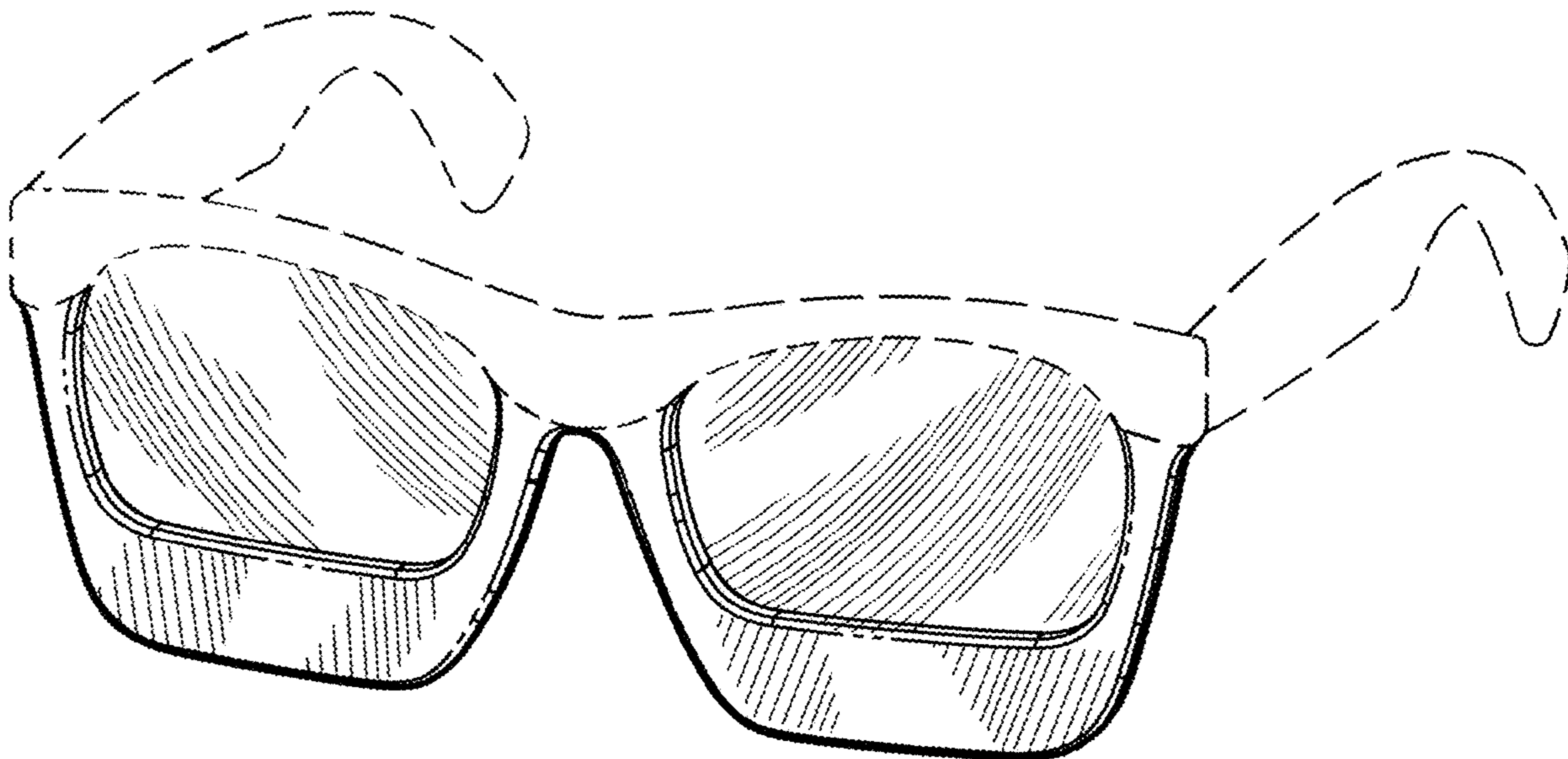
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of an ornamental design of eyeglasses showing our new design. FIG. 2 is a front elevational view thereof. FIG. 3 is a rear elevational view thereof. FIG. 4 is a left side elevational view thereof. FIG. 5 is a right side elevational view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines in the figures illustrate the portions of the design that form no part of the claimed design.

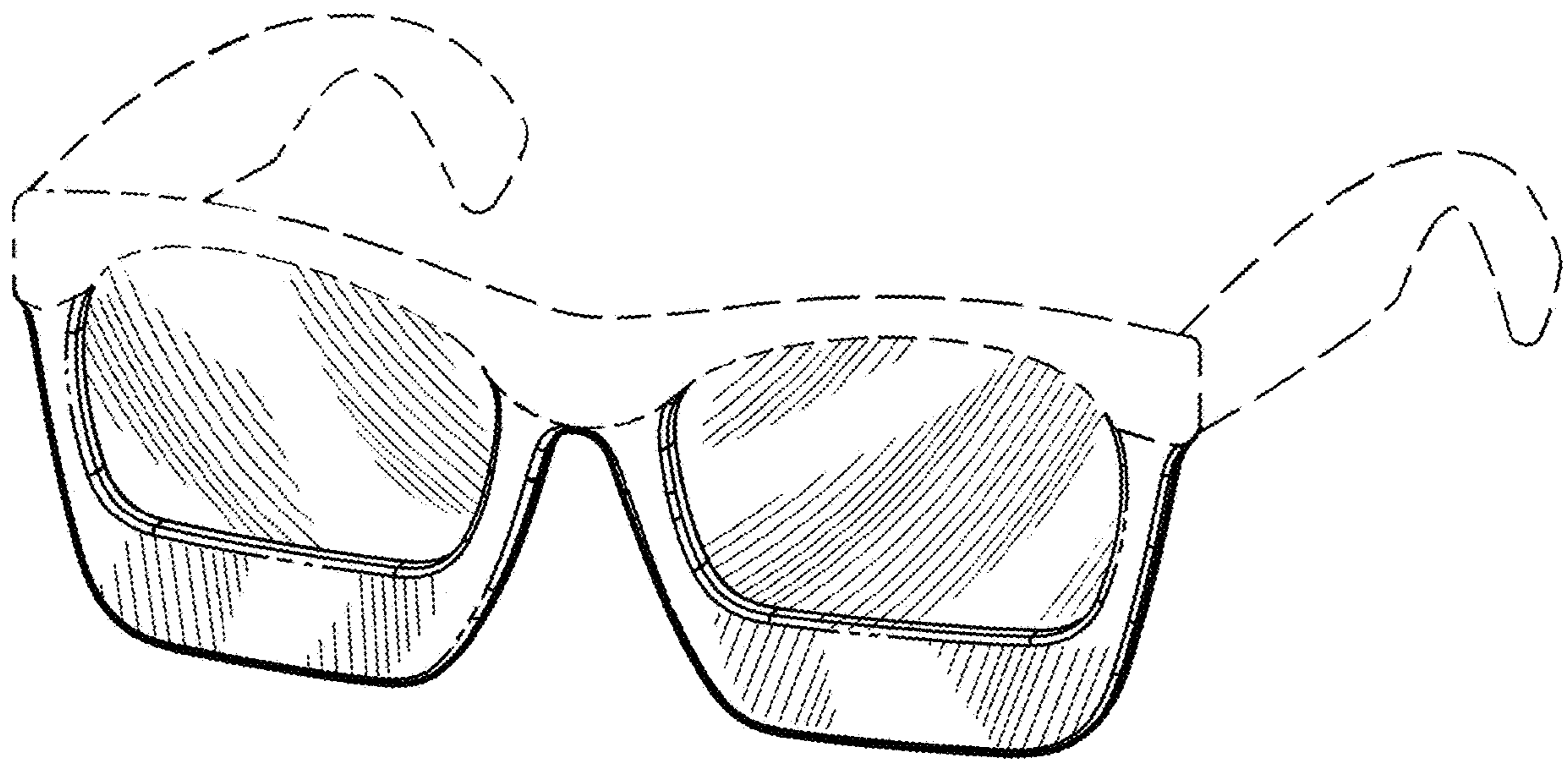

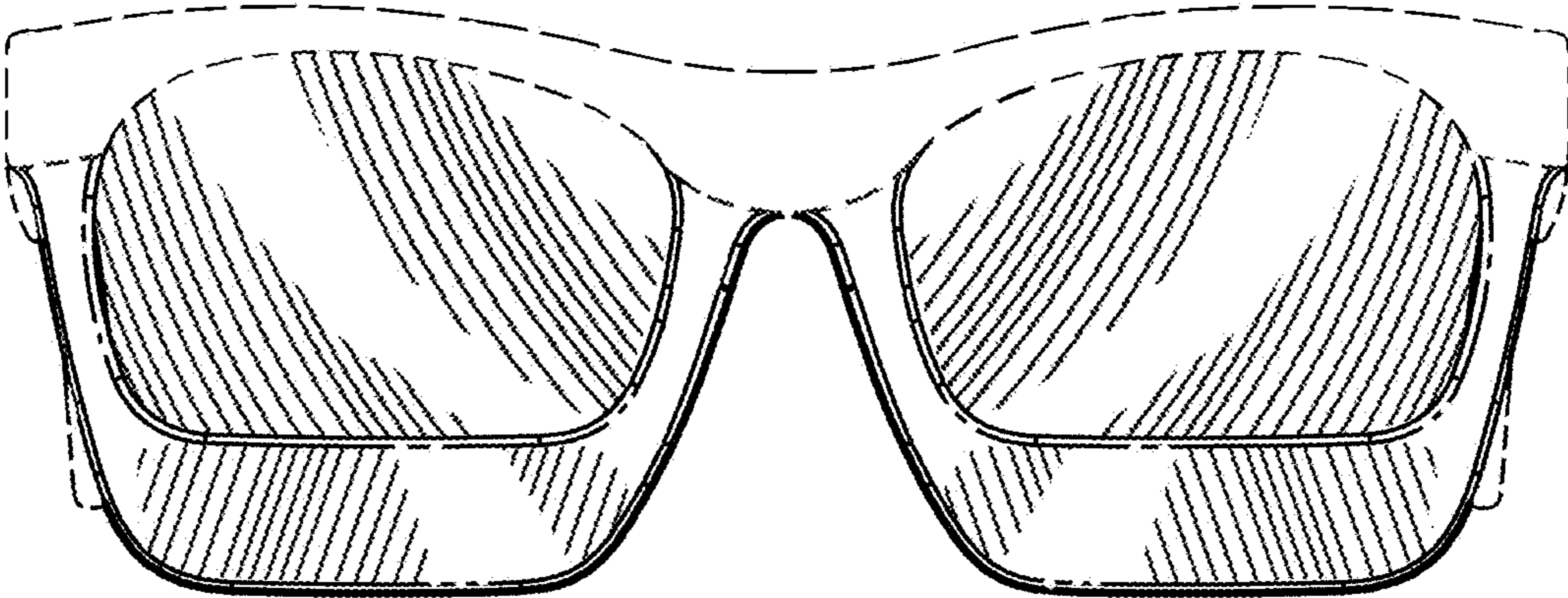

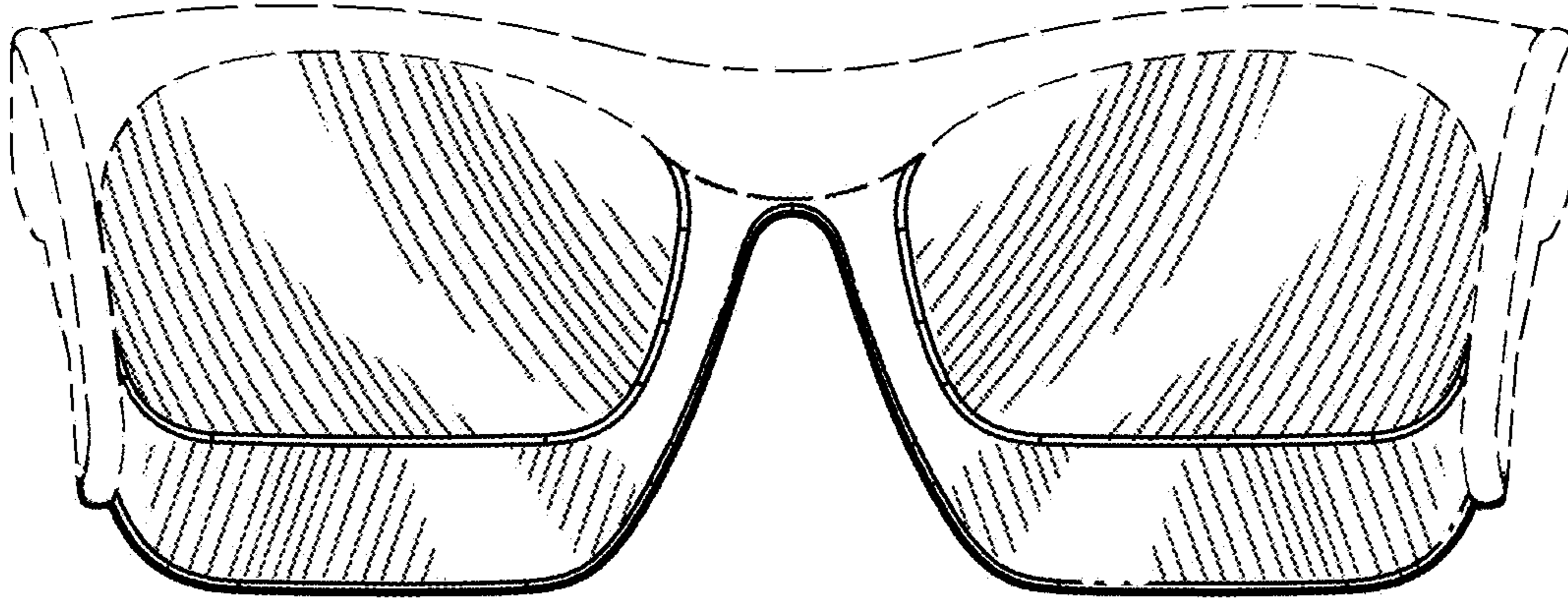

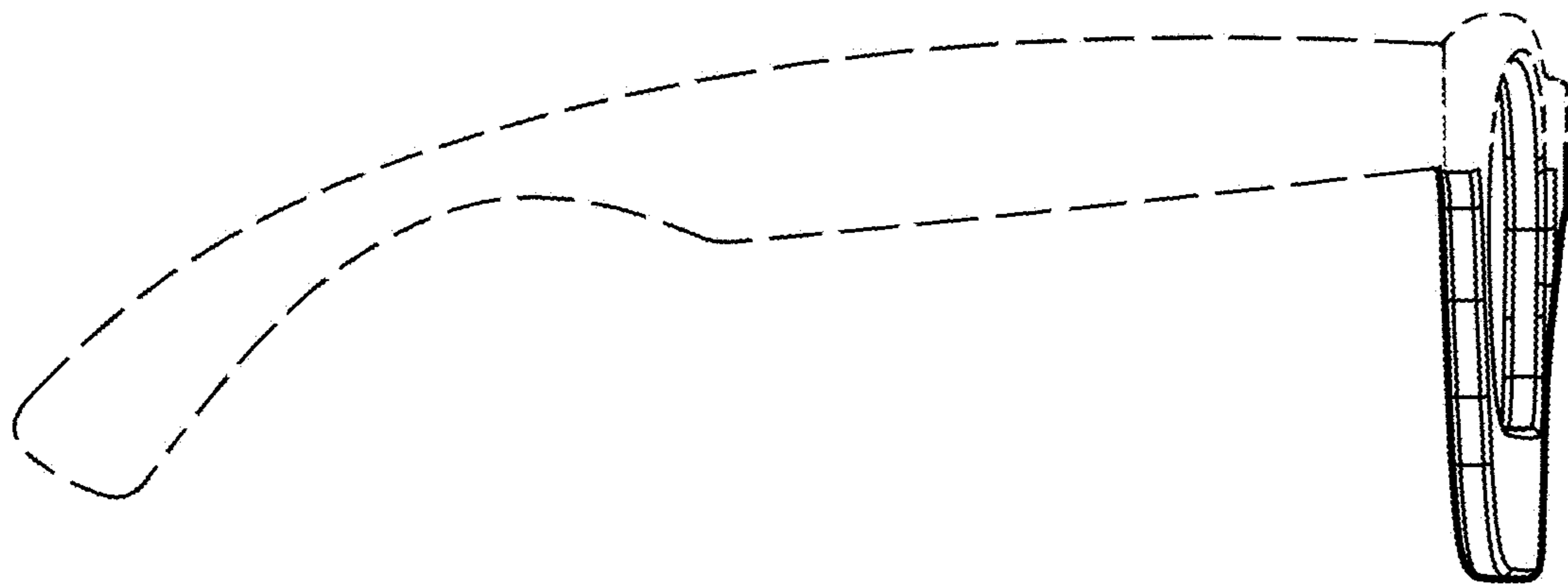

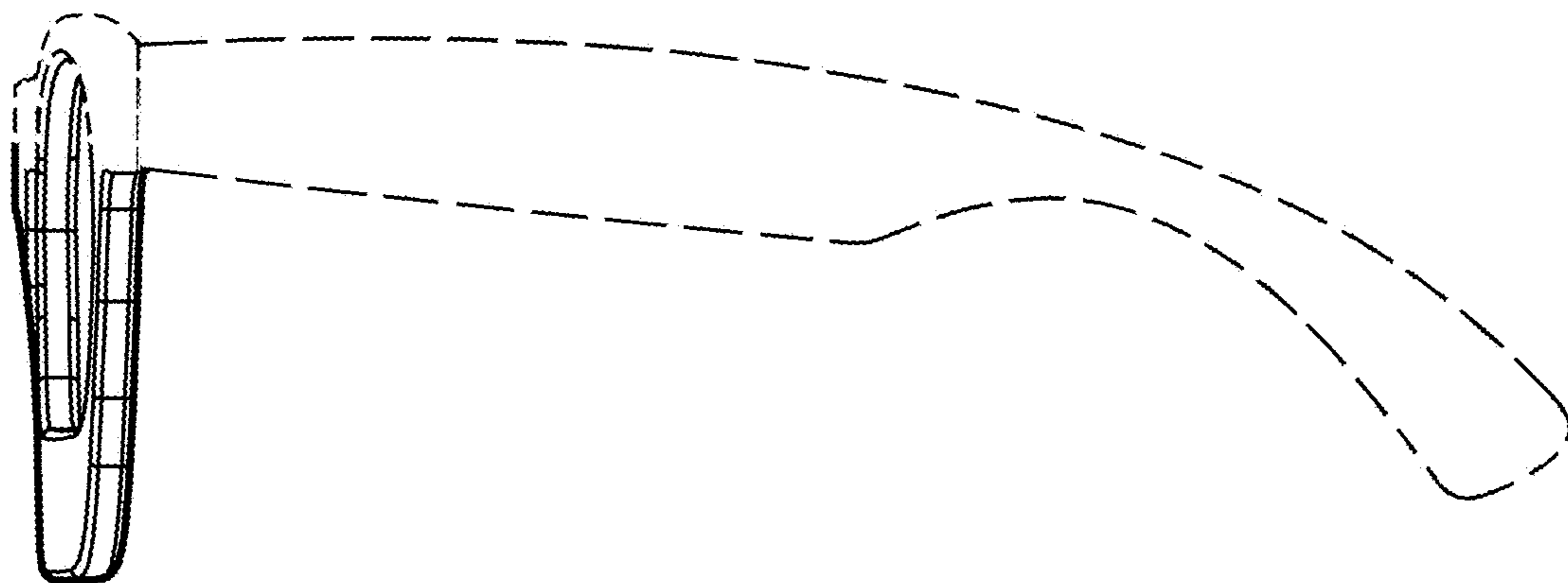

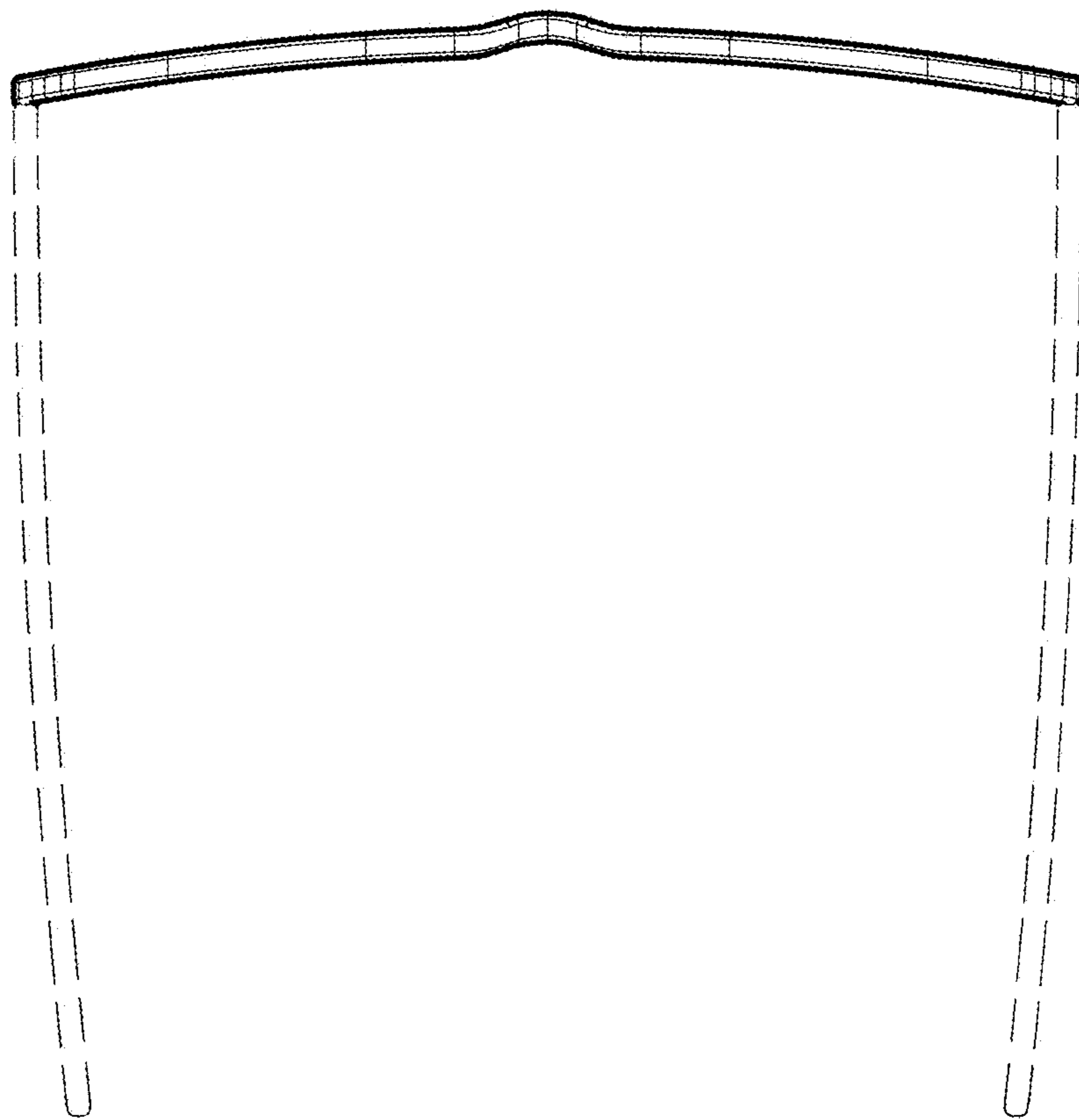
