FIG. 11 is a right side view of the gaming machine shown in FIG. 8;

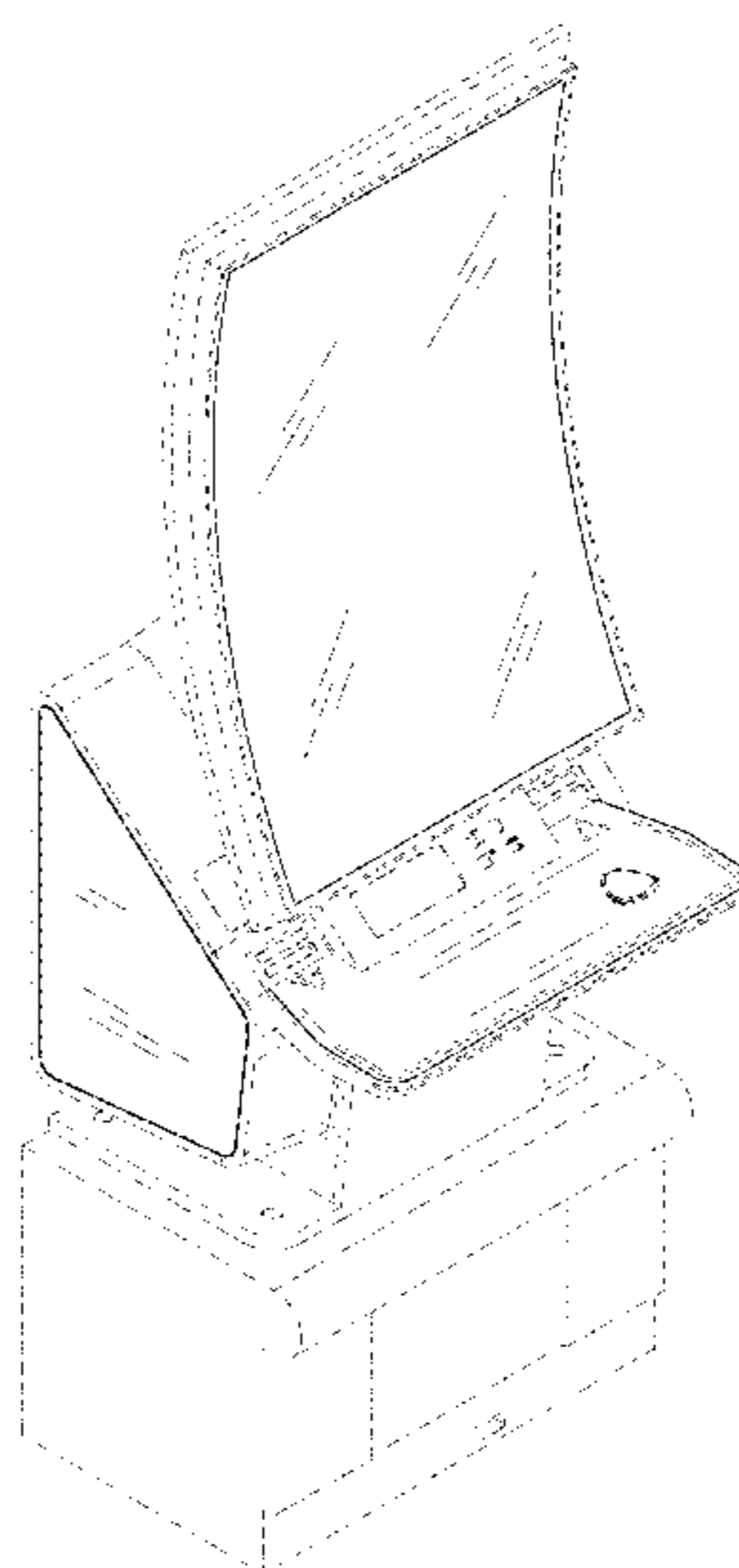
FIG. 12 is a left side view of the gaming machine shown in FIG. 8;

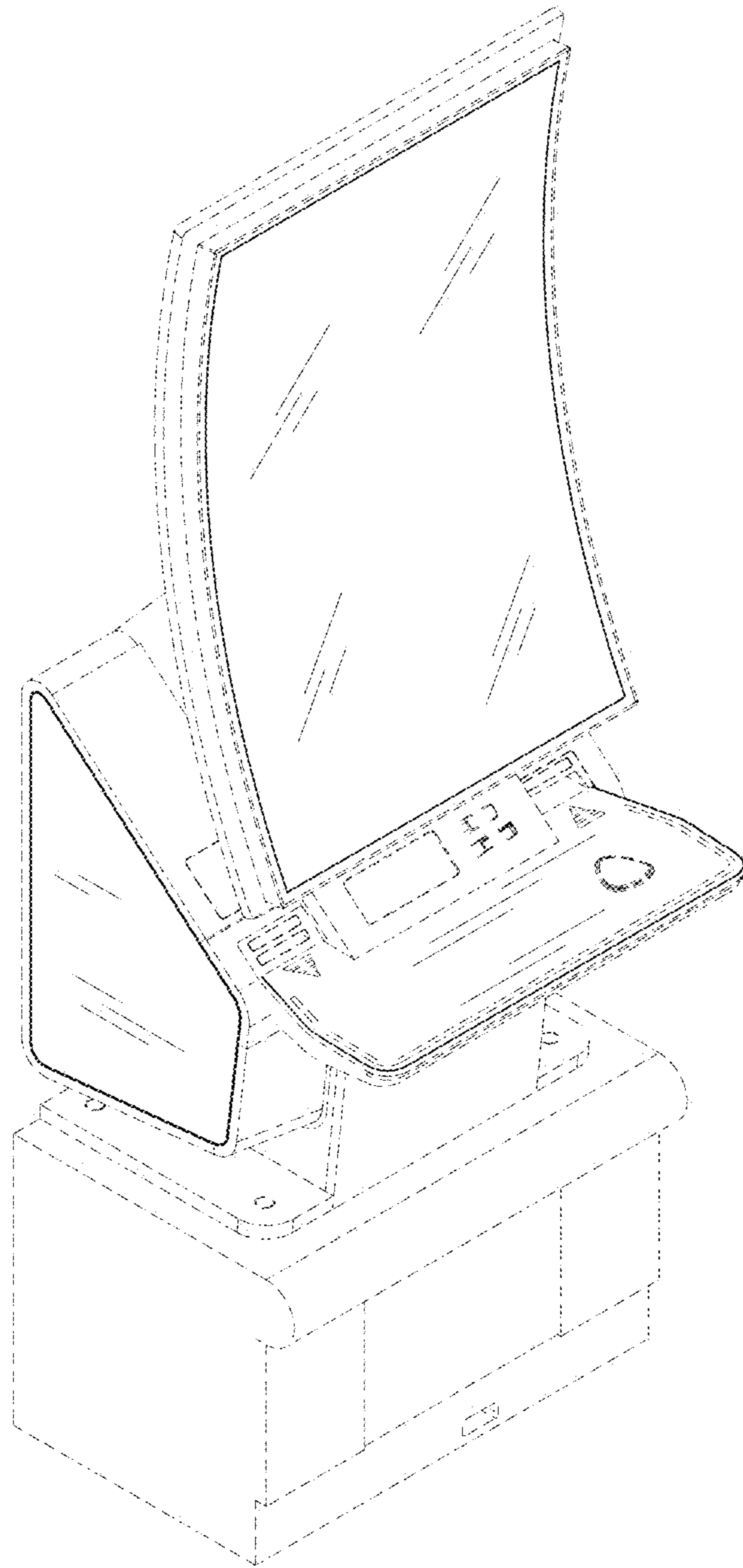

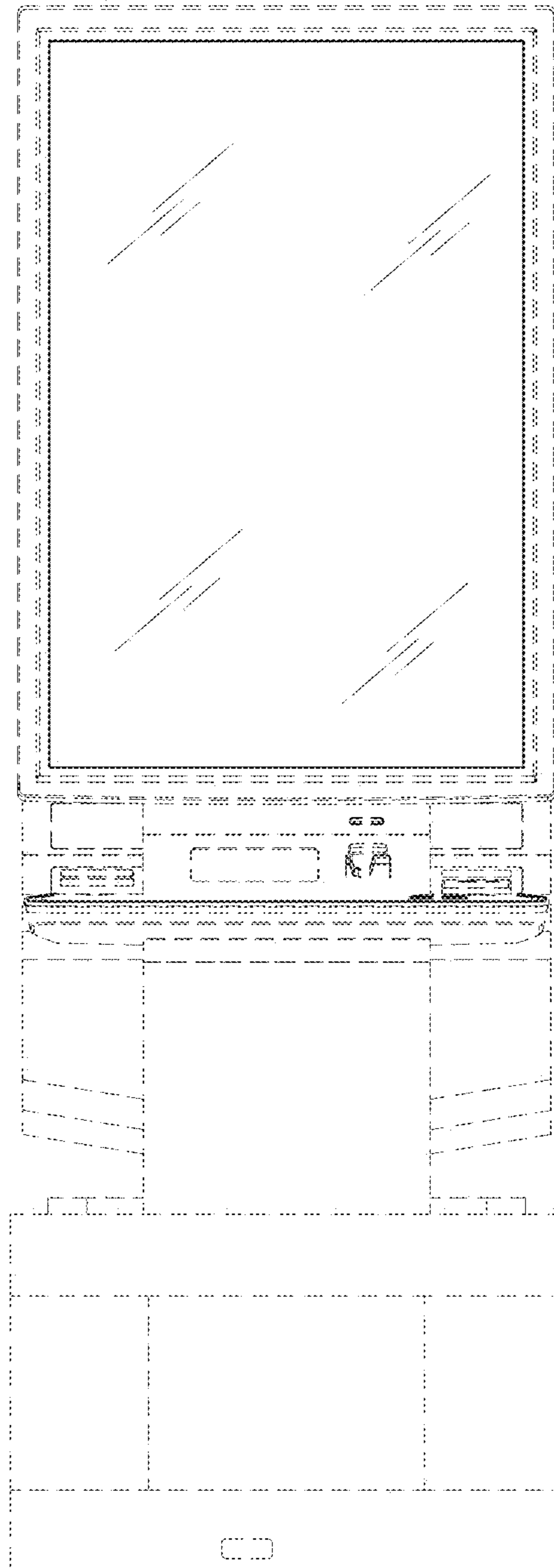

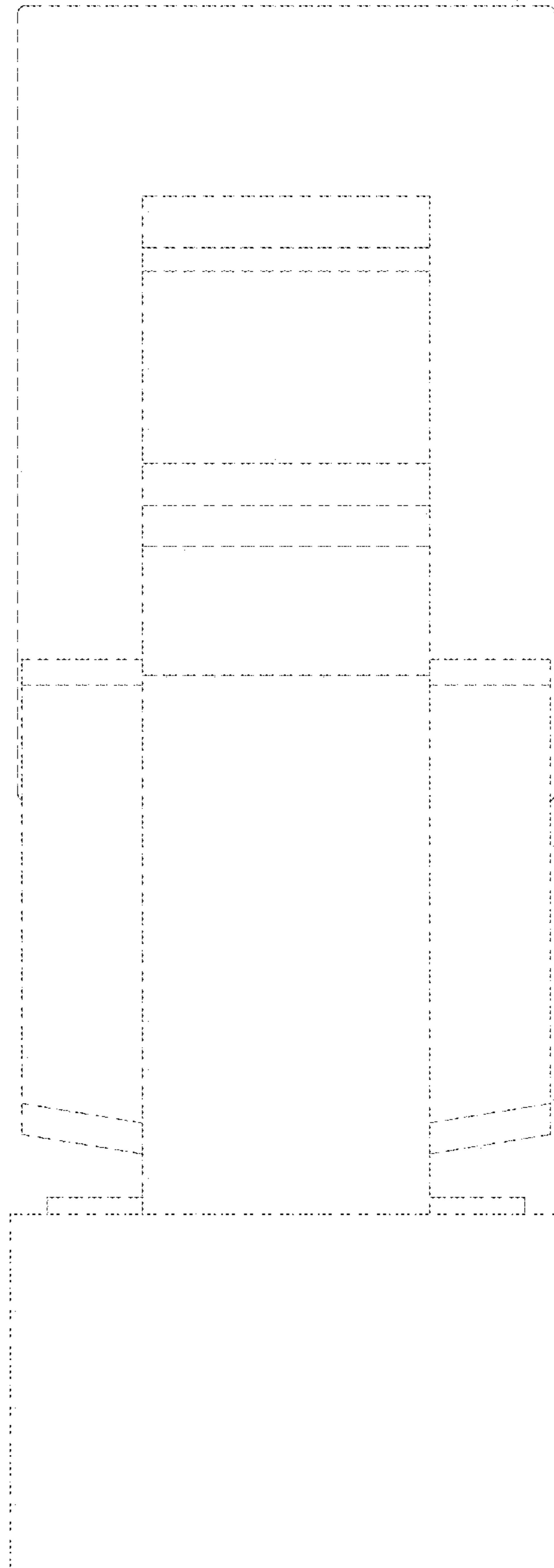

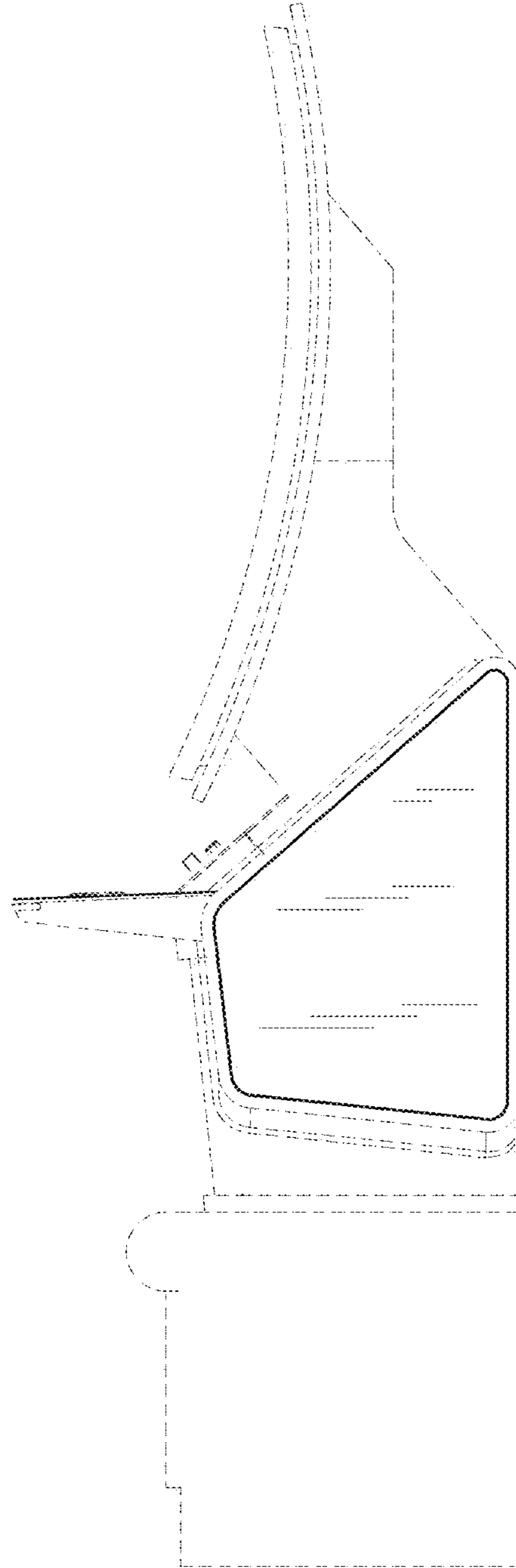

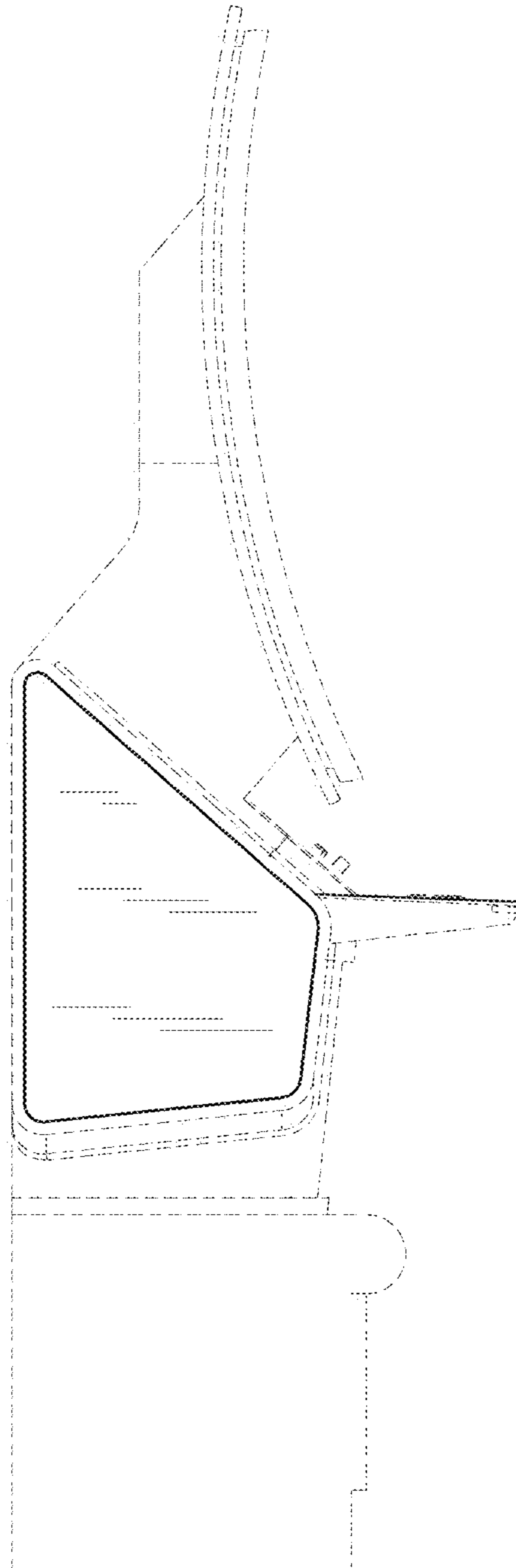

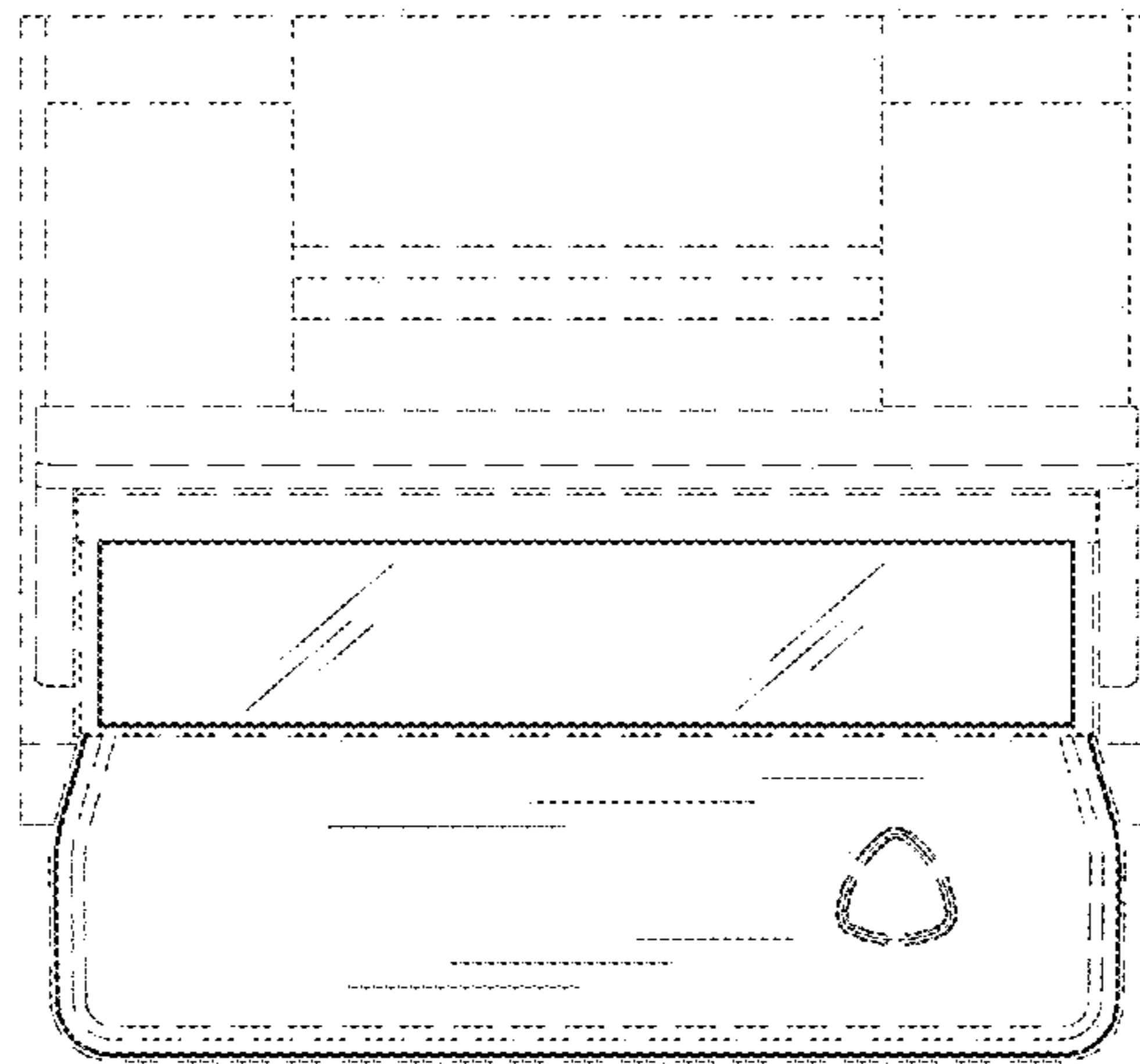

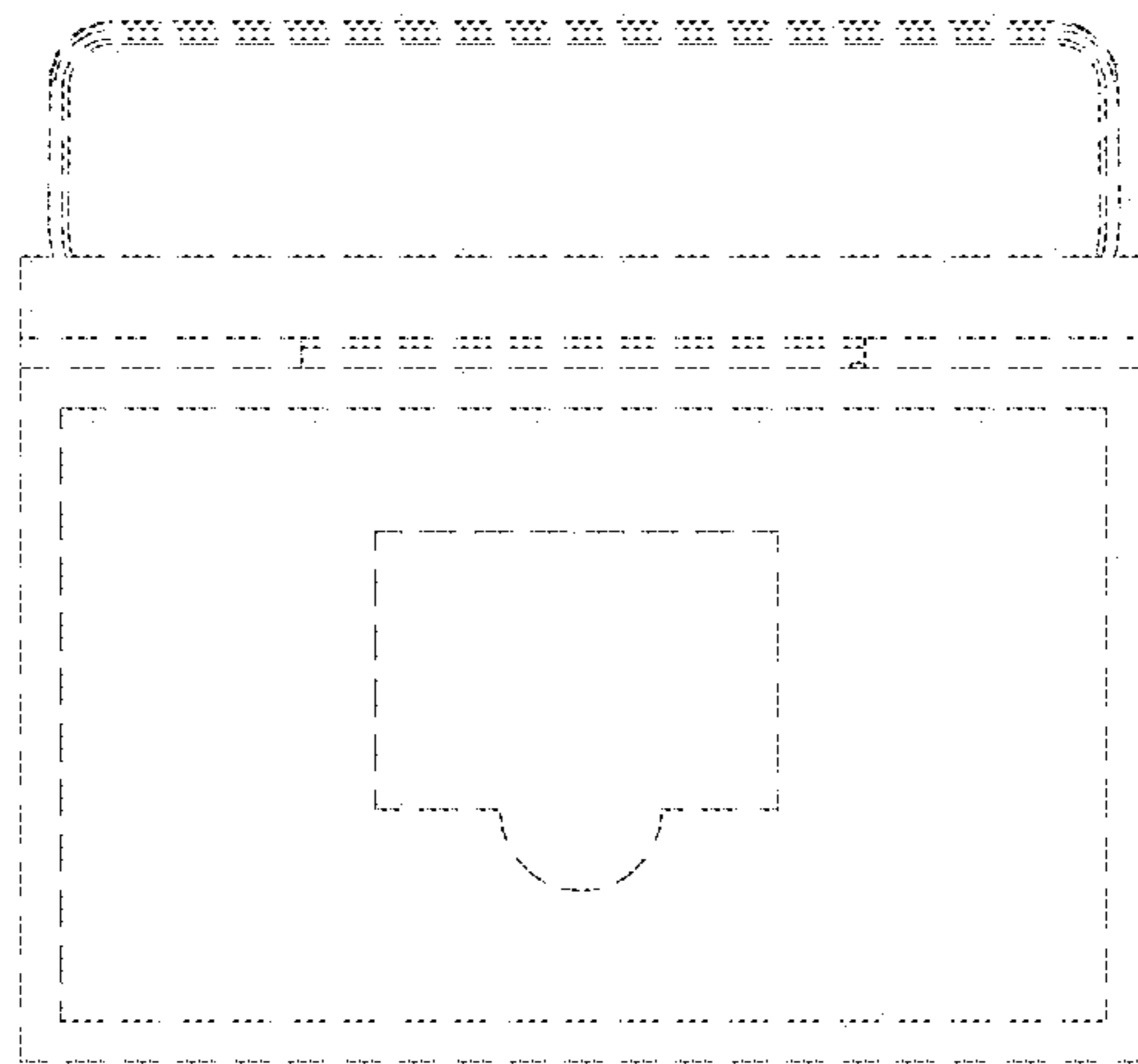

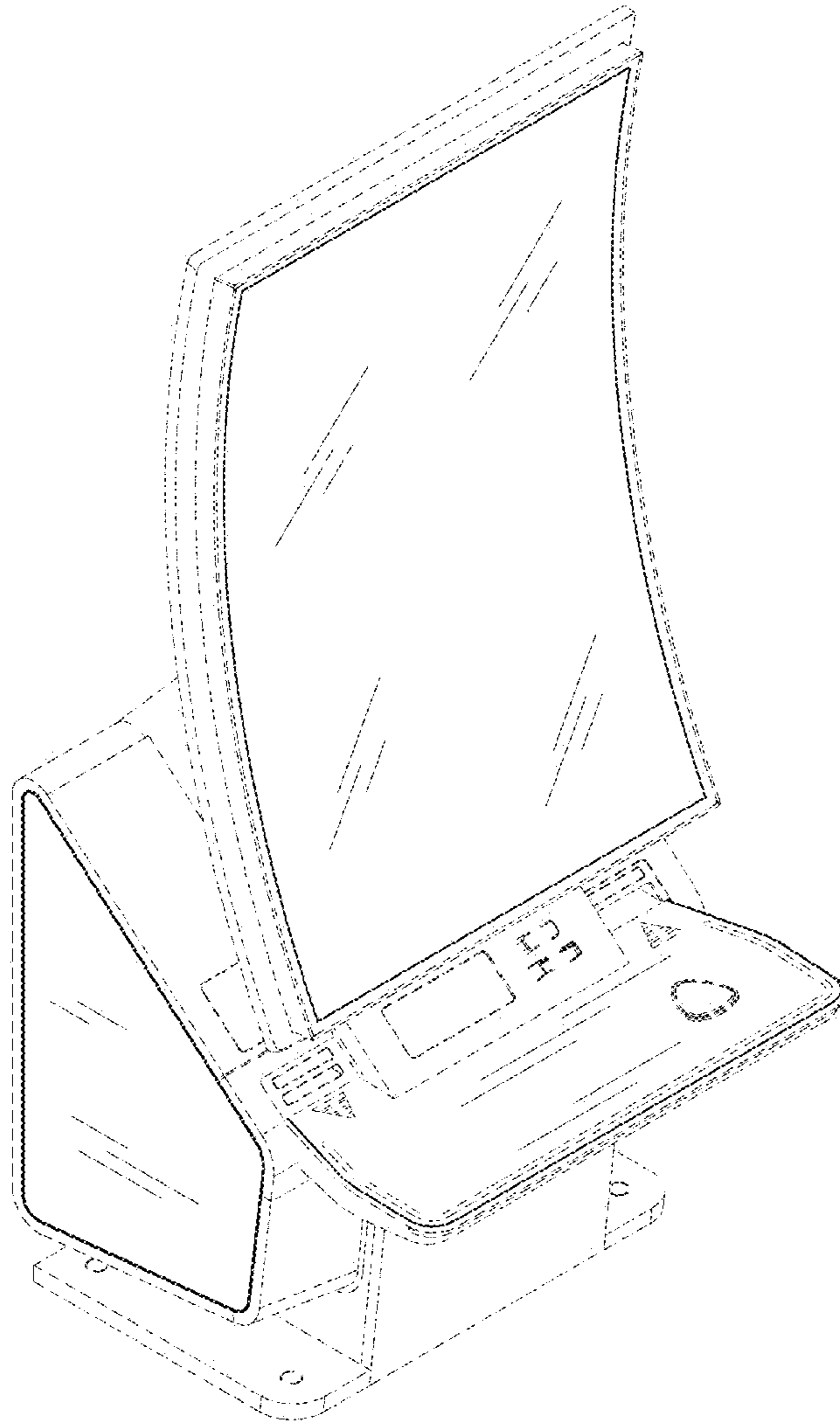

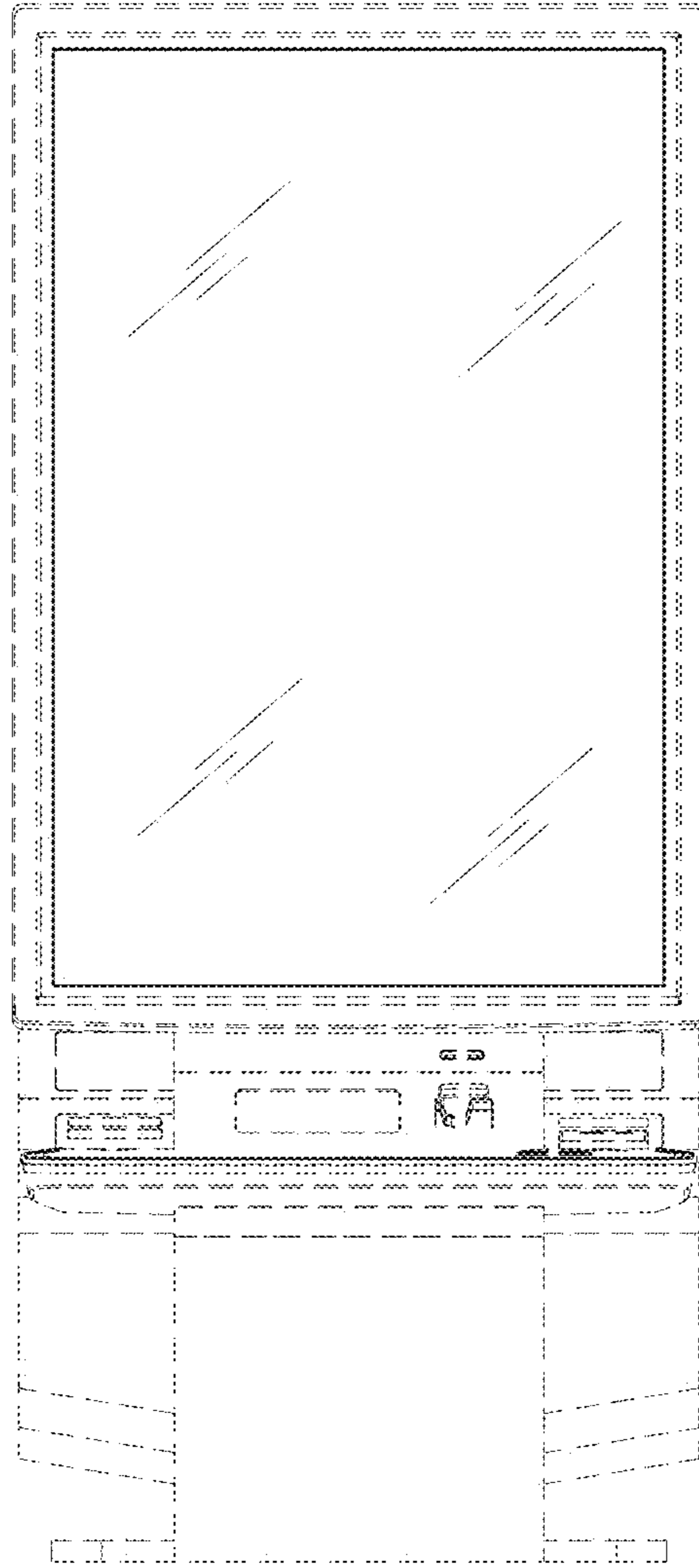

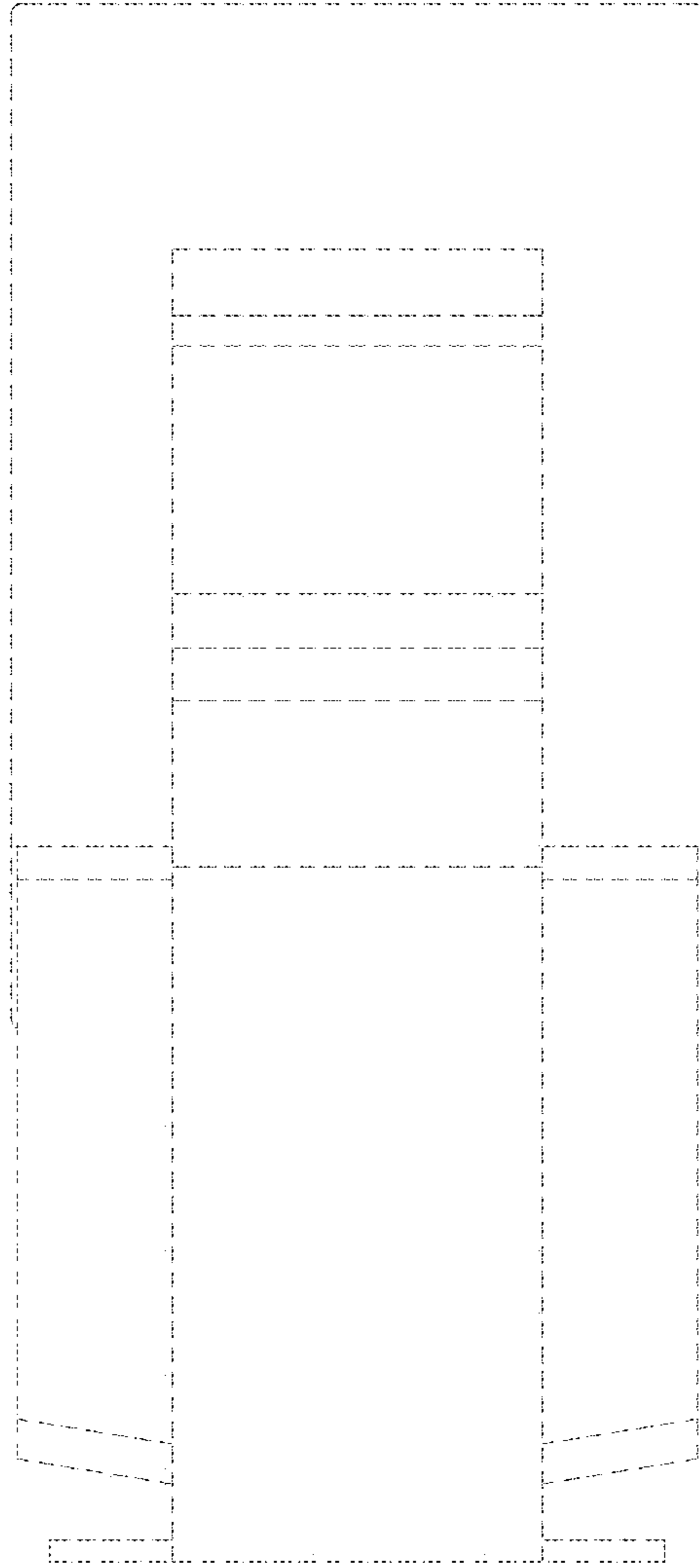

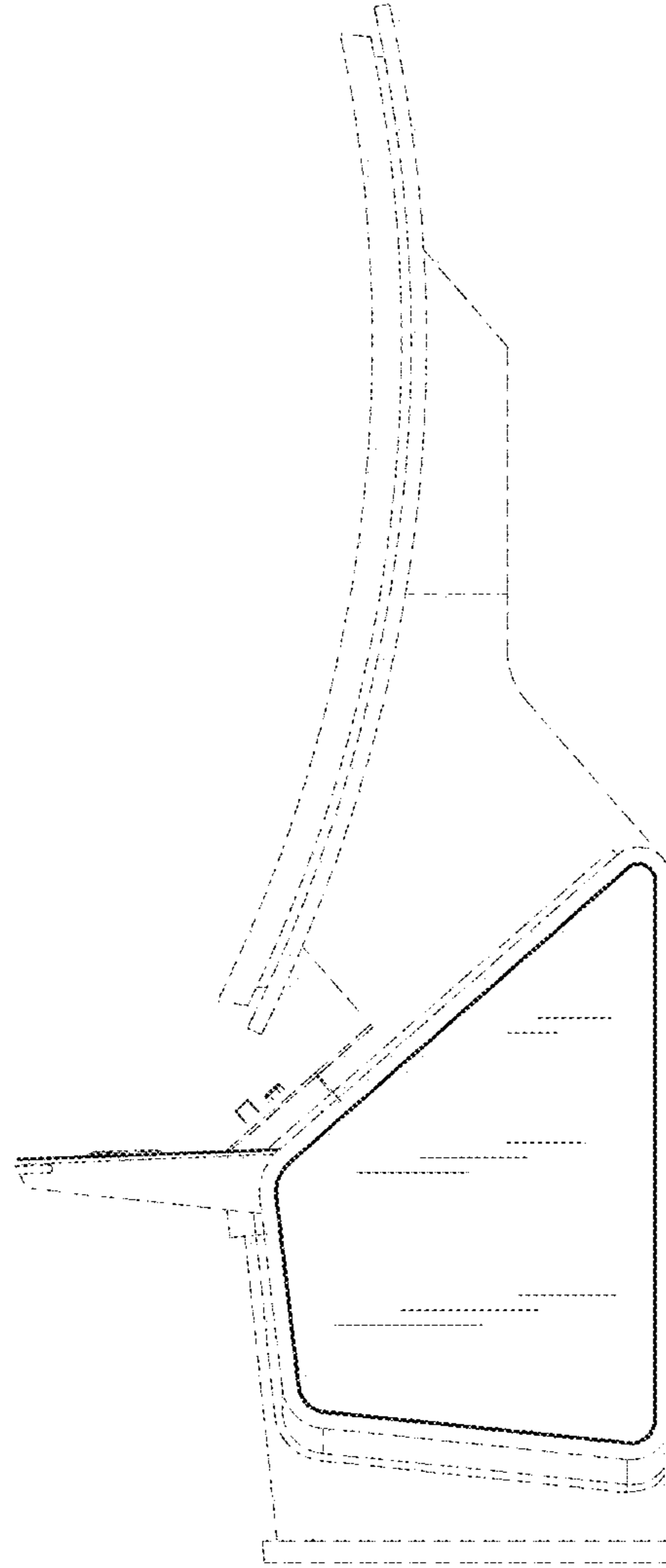

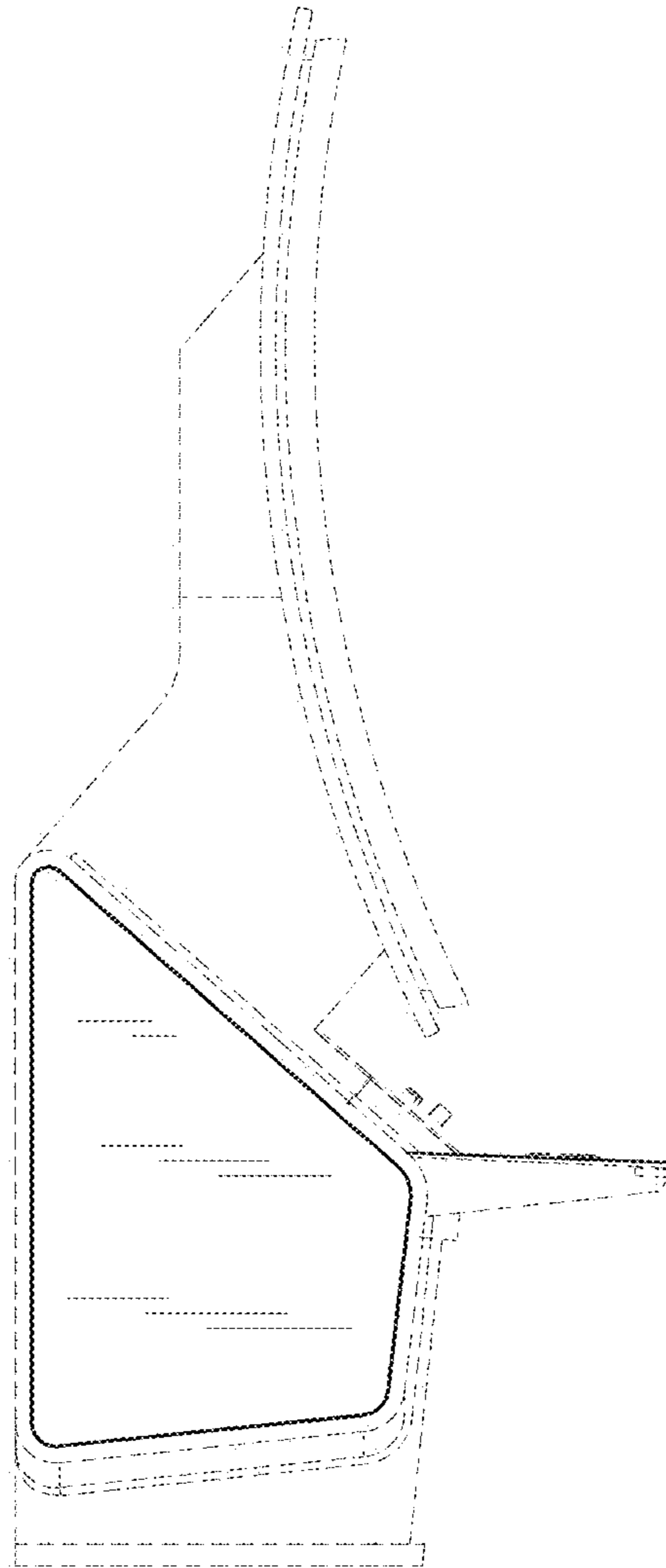

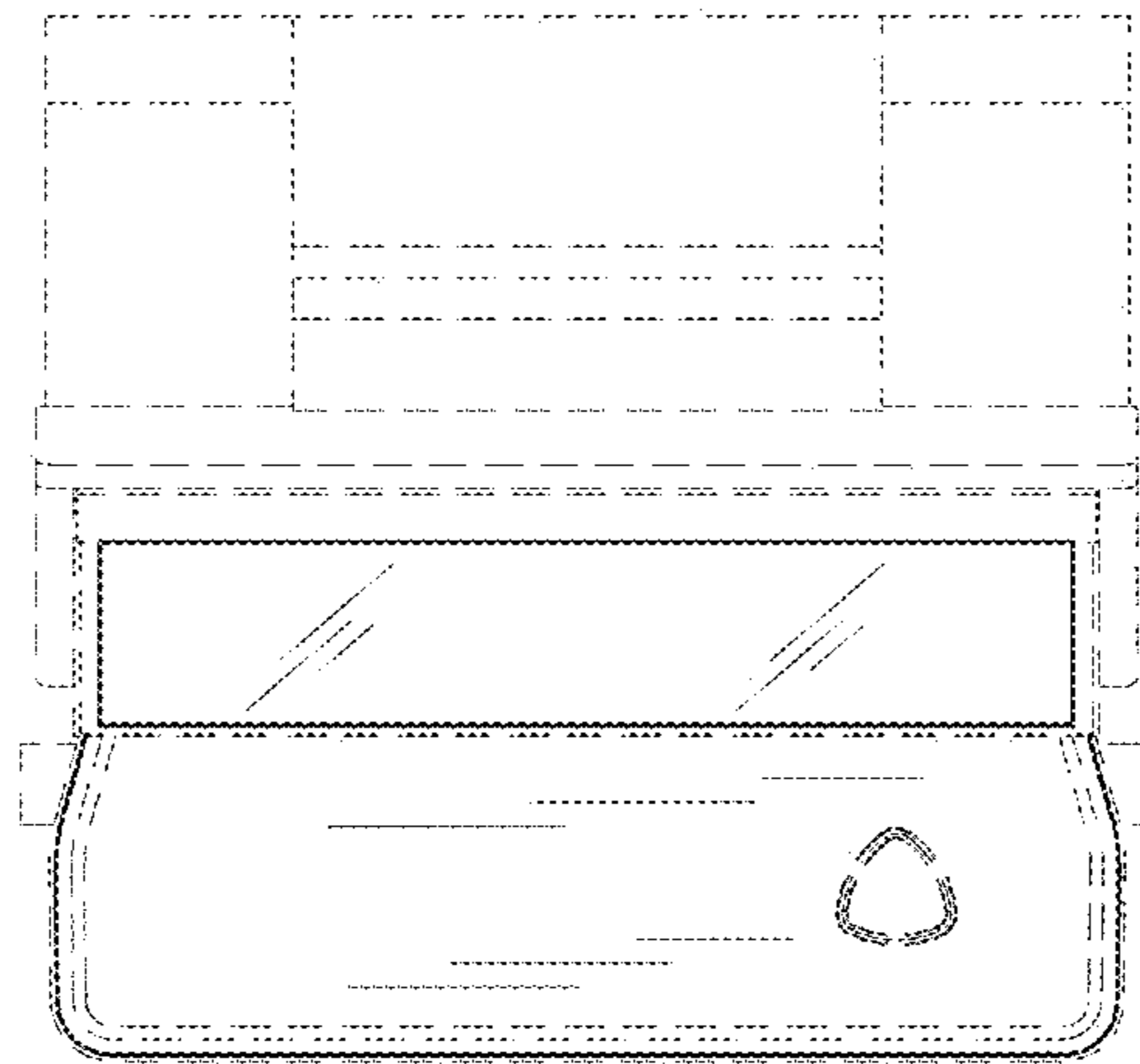

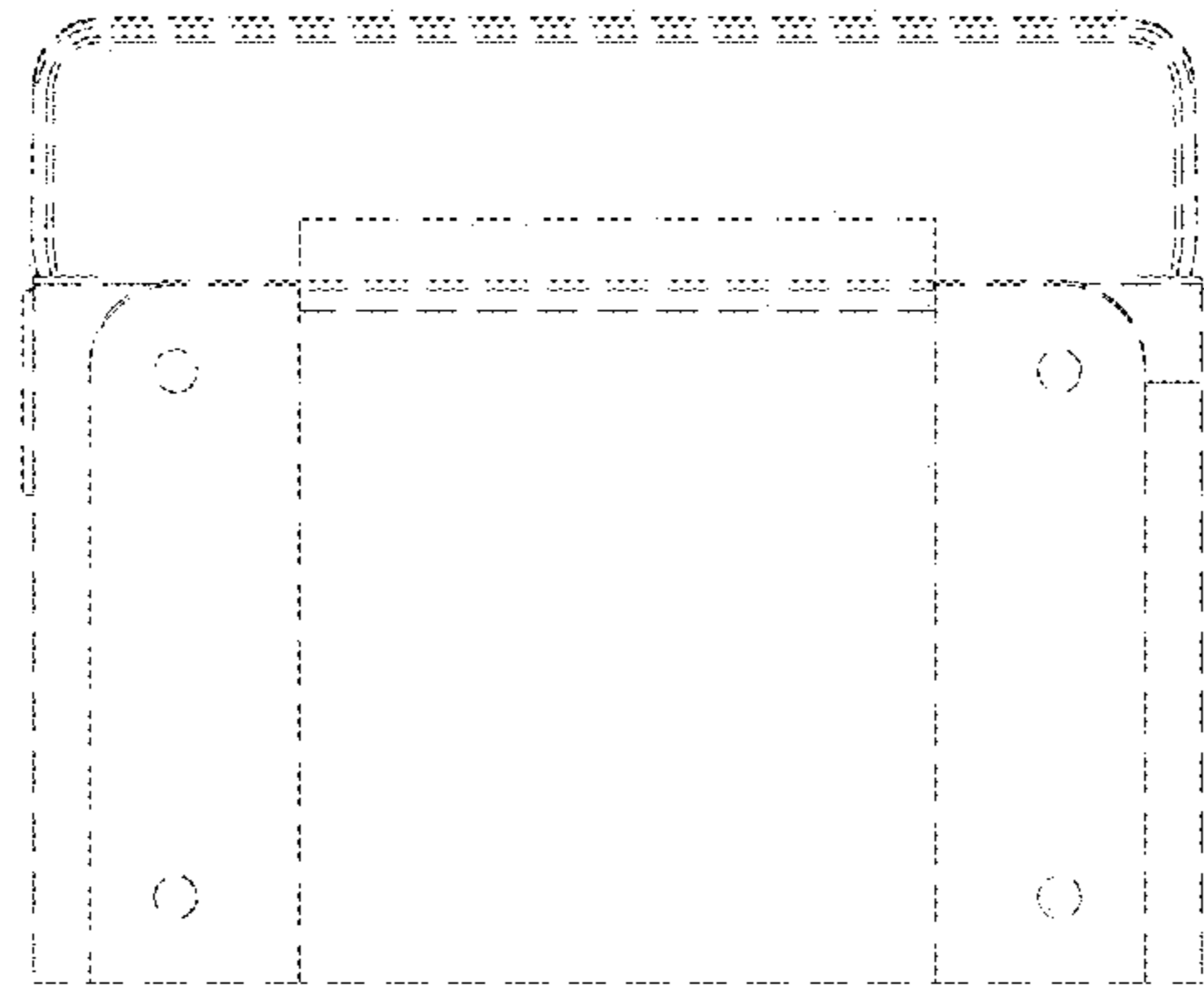
