FIG. 7 is a right side view thereof.

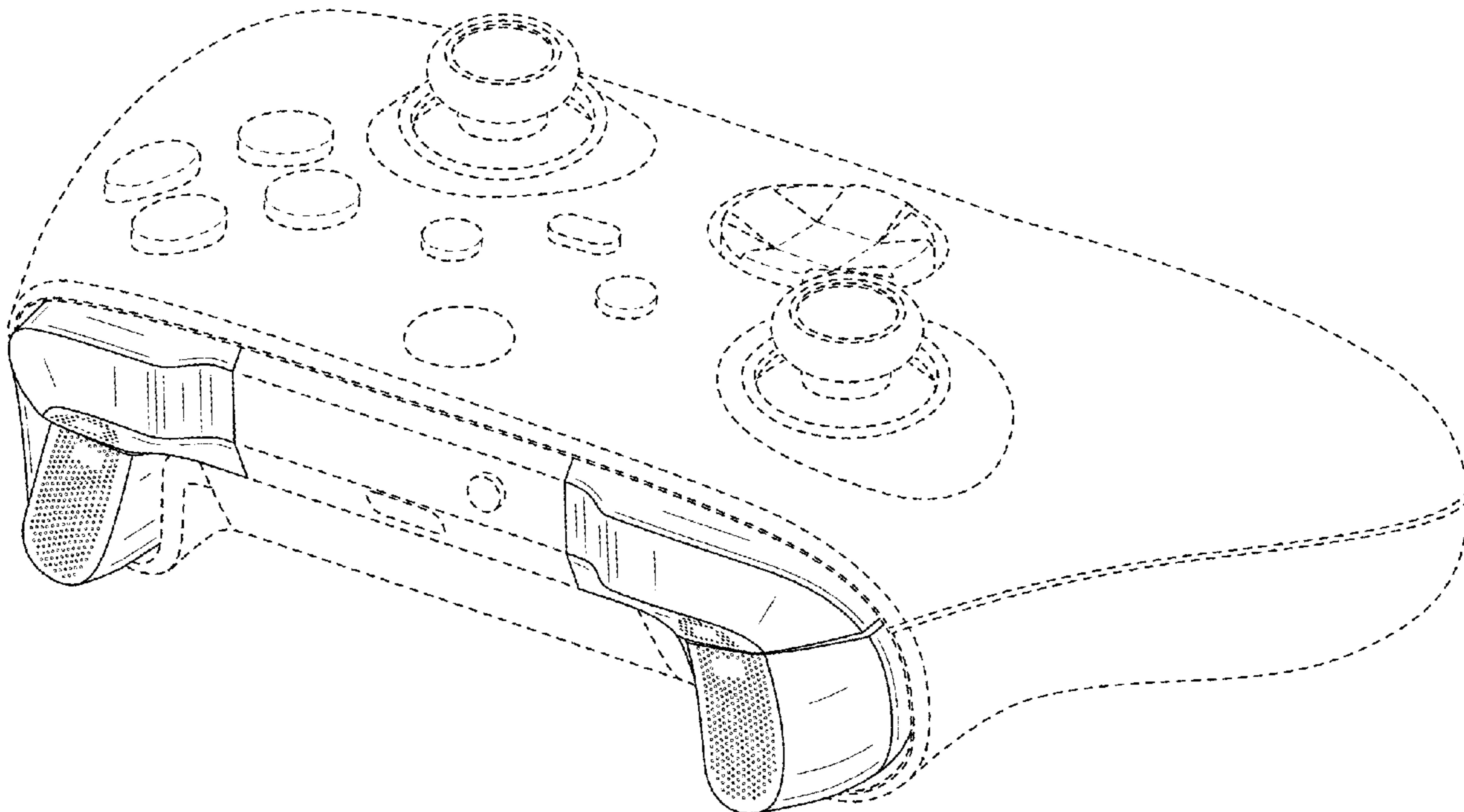
The broken lines depicting the remainder of the controller in FIGS. 1-7 show features that form no part of the claimed design.

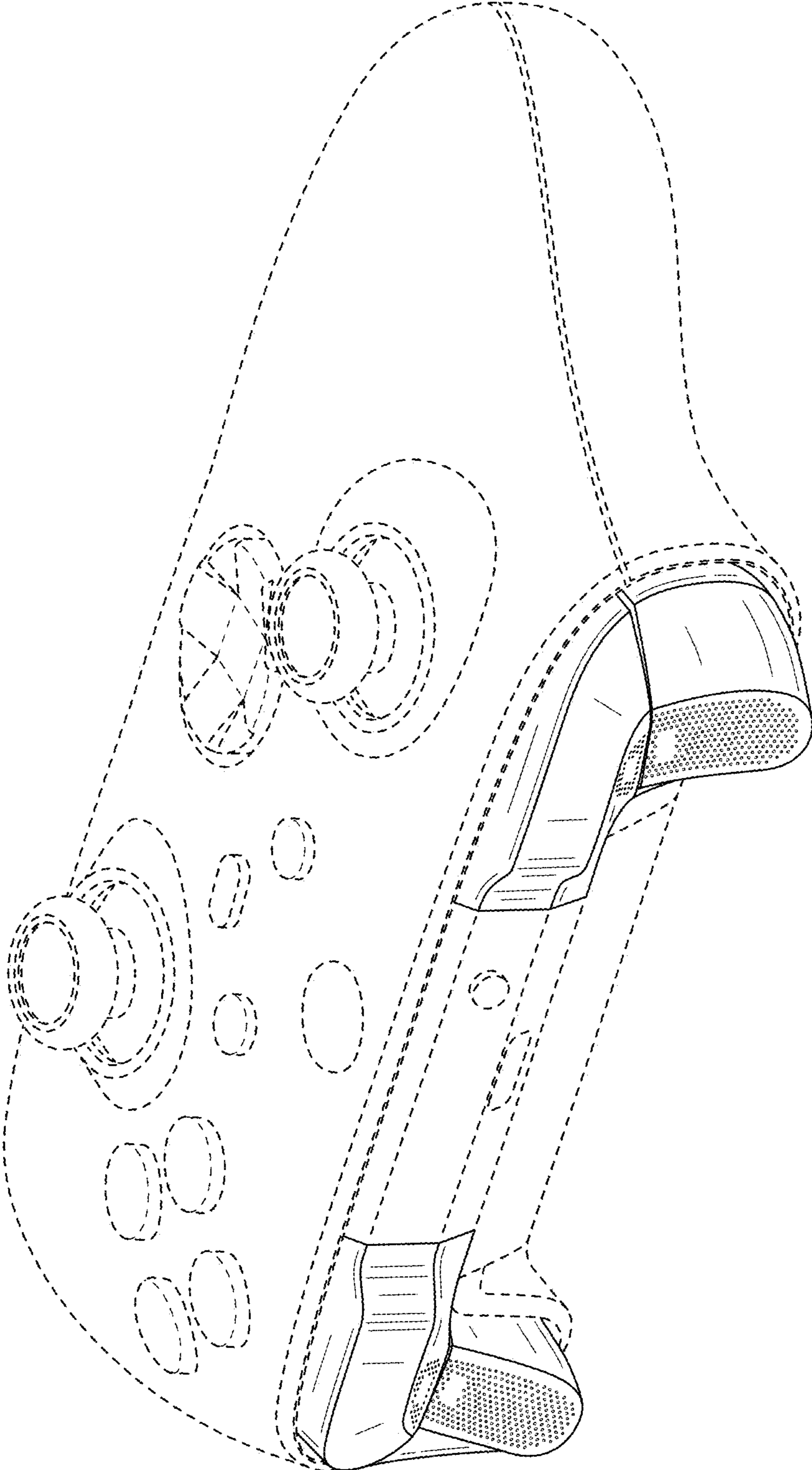

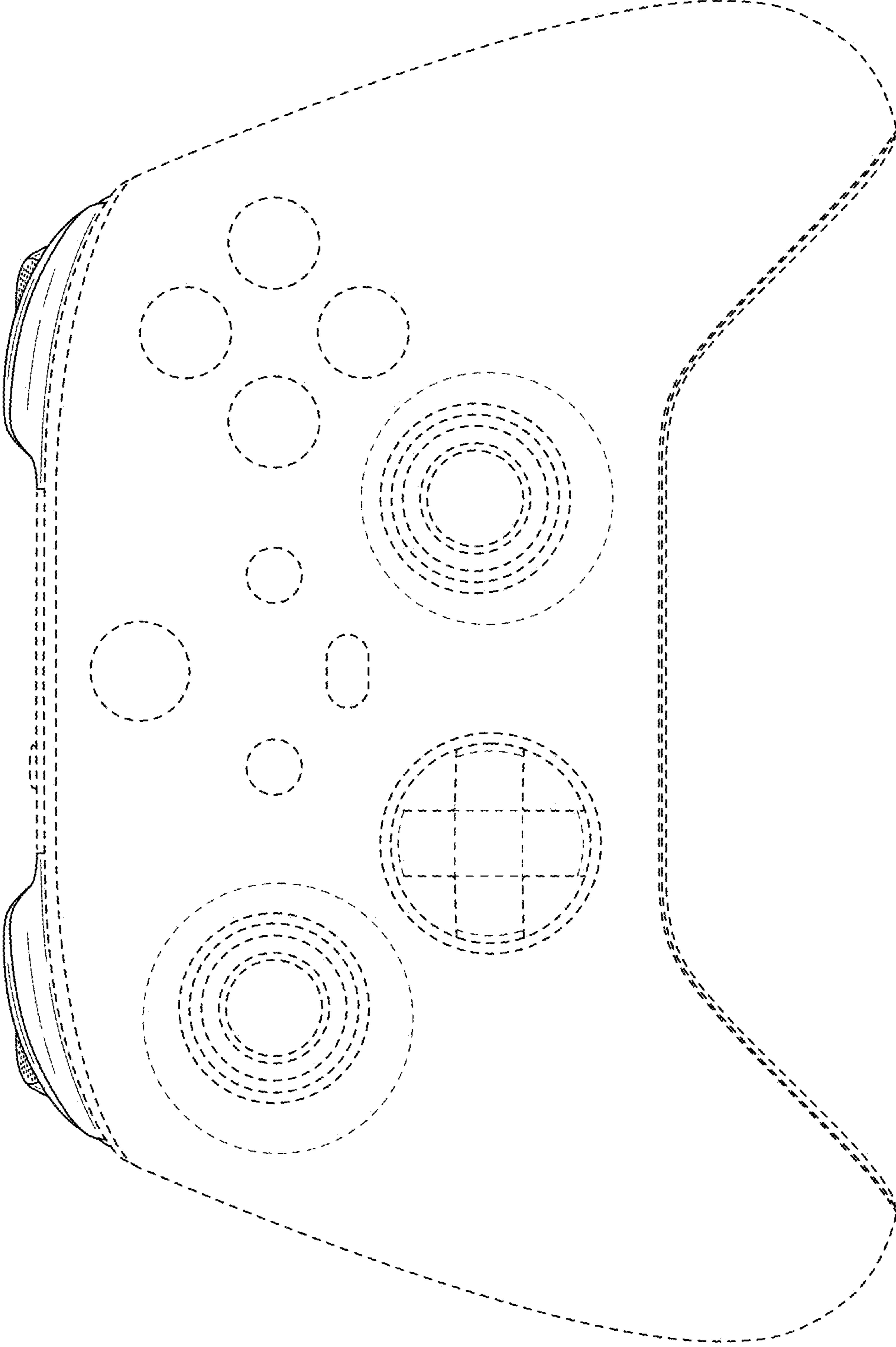

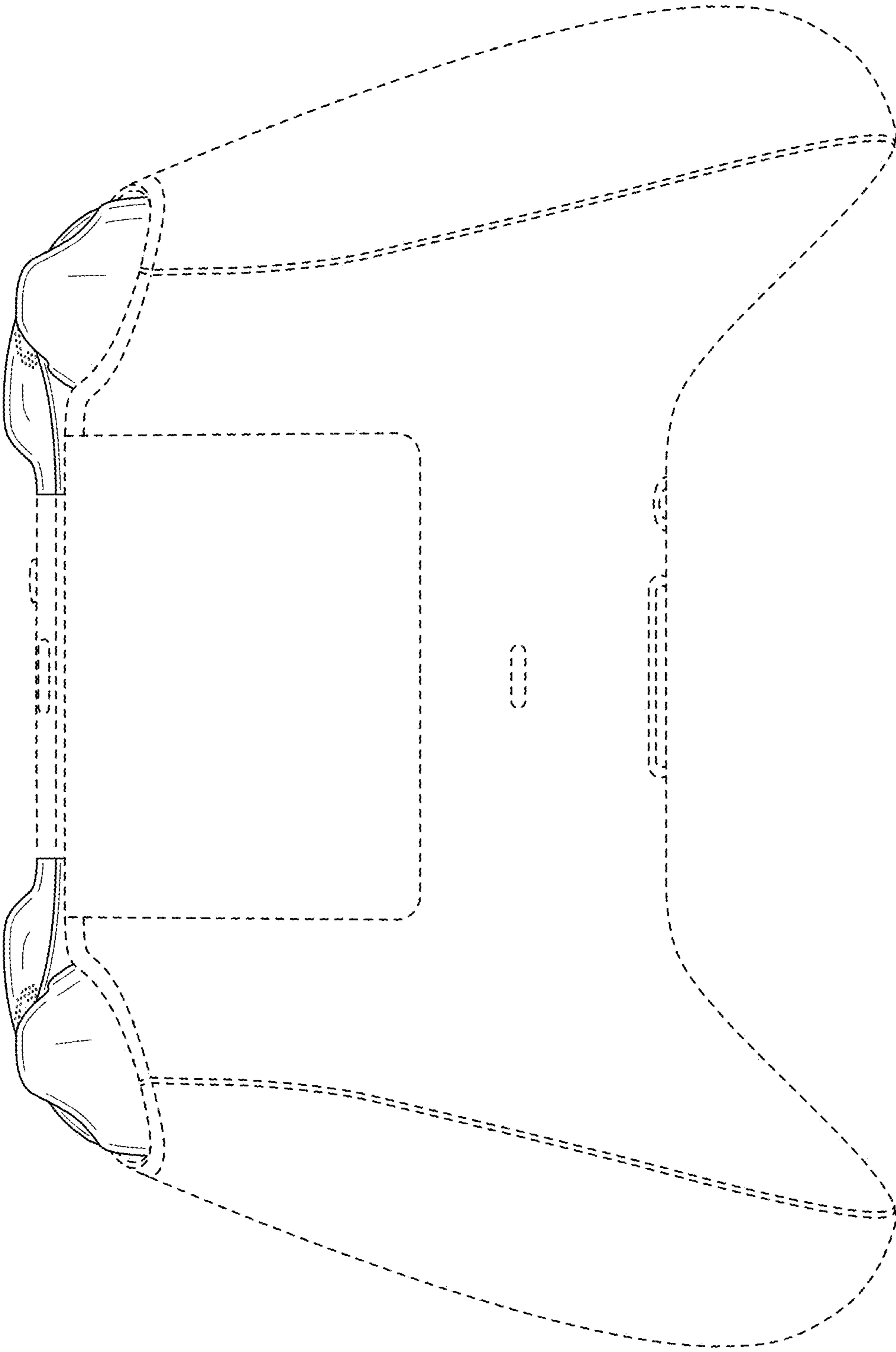

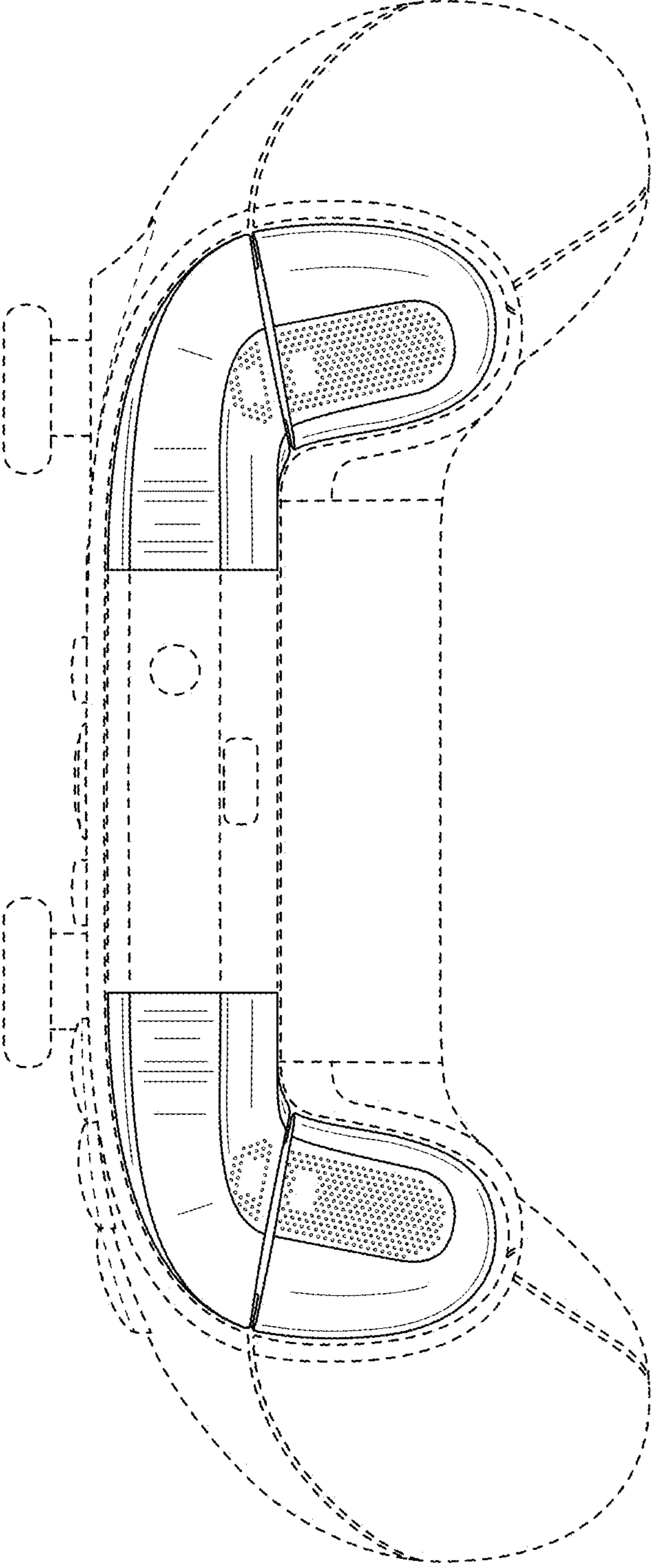

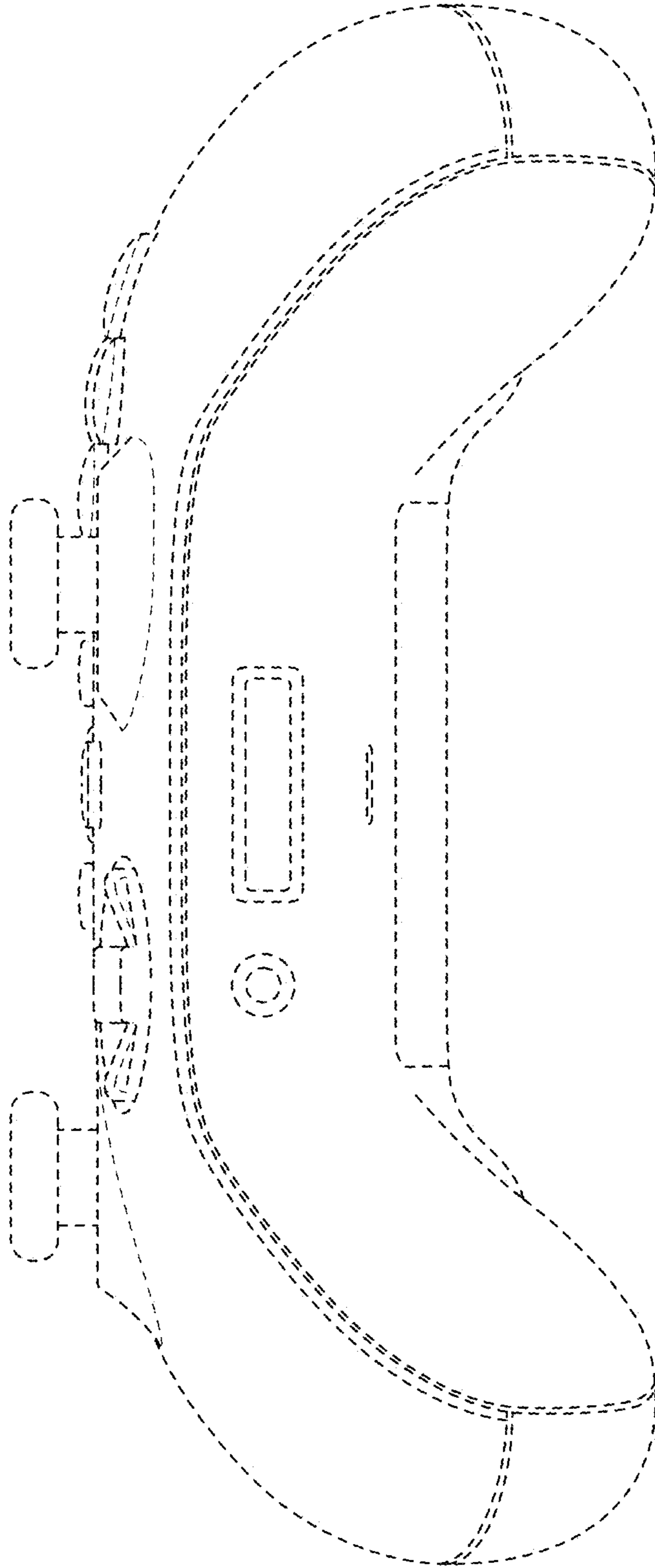

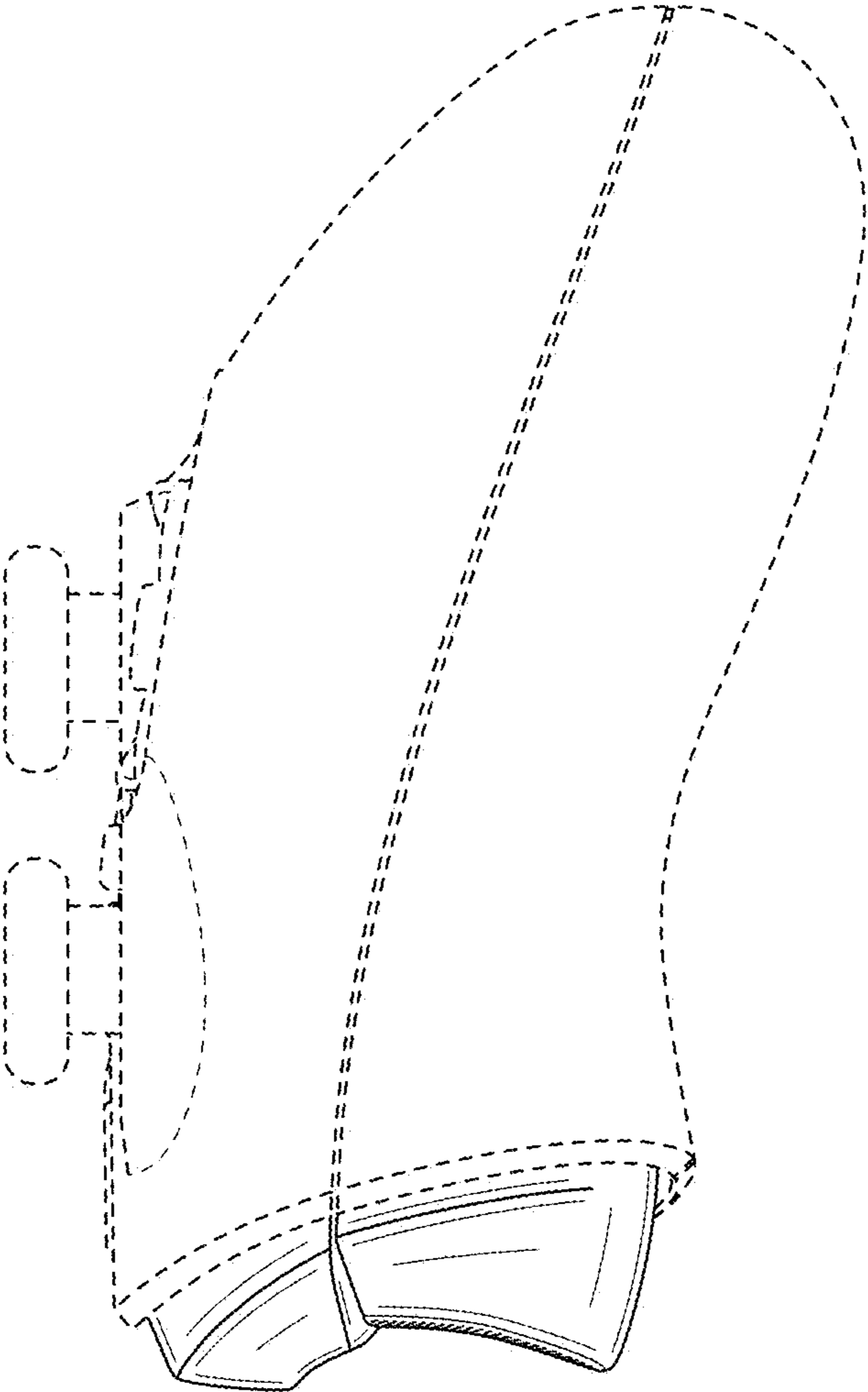

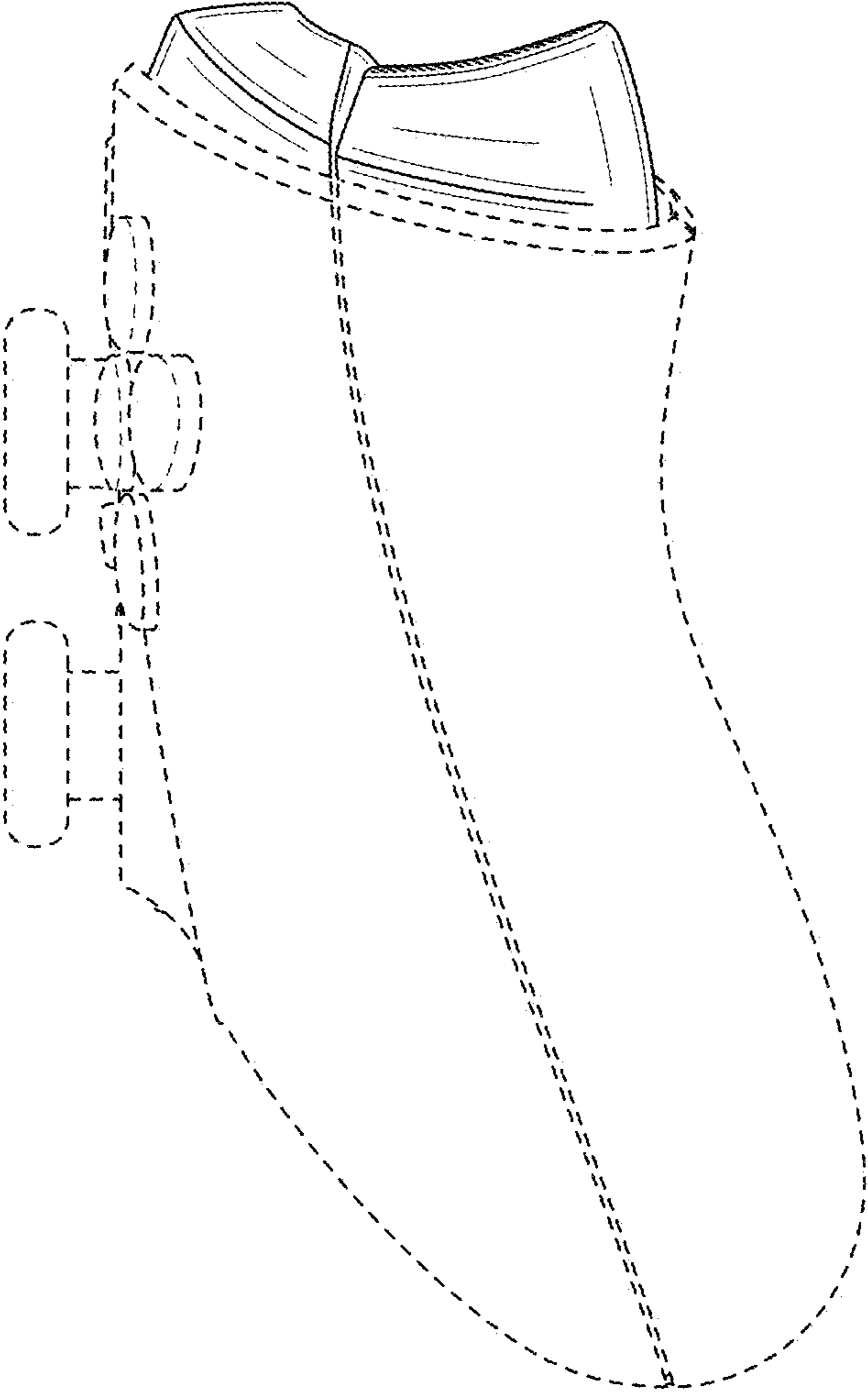
