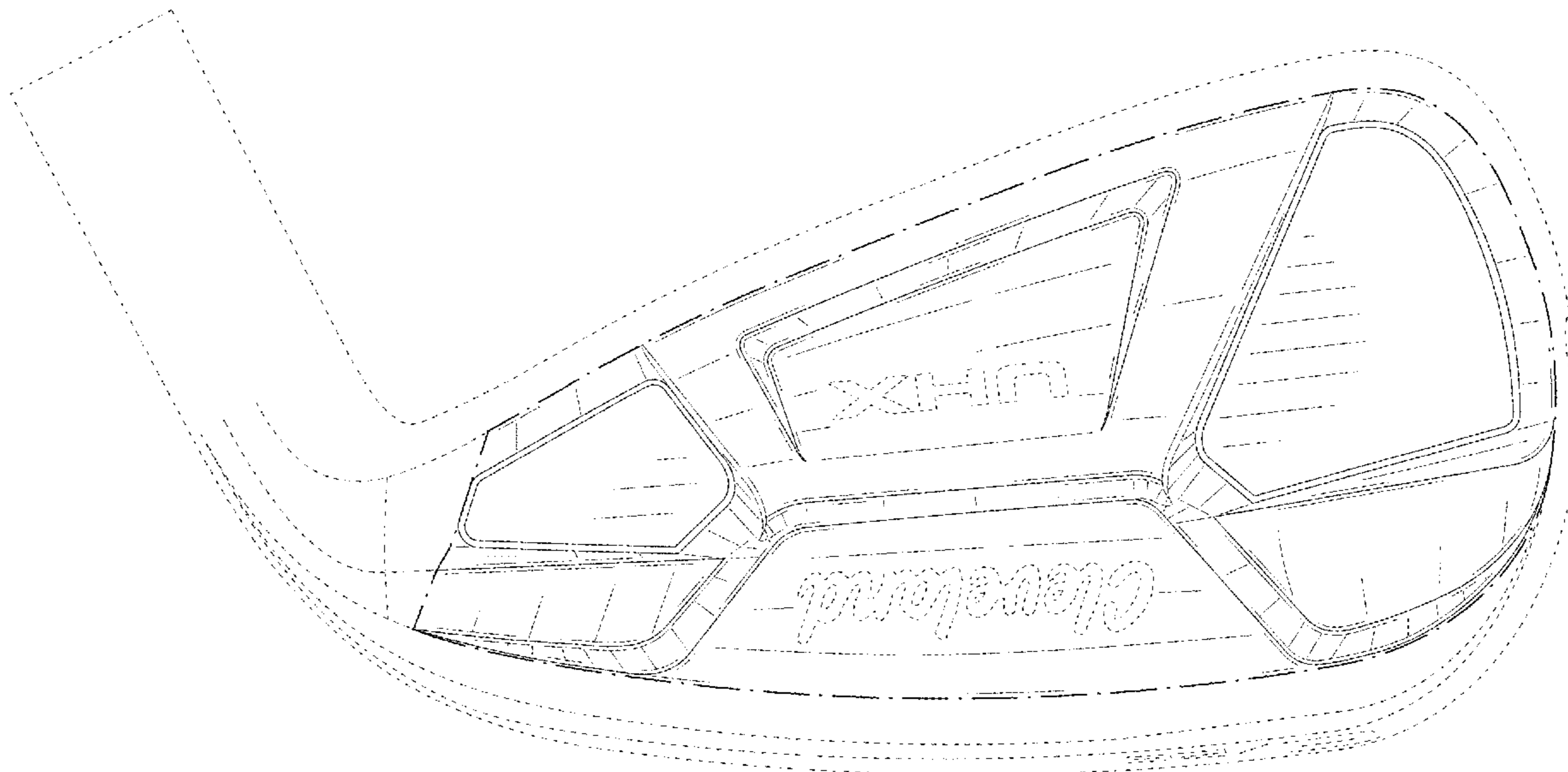
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, heel-side, rear perspective view of the golf club head;  
 FIG. 2 is a rear elevational view thereof  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a heel-side elevational view thereof;  
 FIG. 5 is a toe-side elevational view thereof;  
 FIG. 6 is a front elevational view thereof; and,  
 FIG. 7 is a bottom plan view thereof.  
 The broken lines depict parts of the golf club head that form no part of the claimed design. The dot-dash chain lines depict boundaries of the claimed subject matter and form no part of the claimed design.

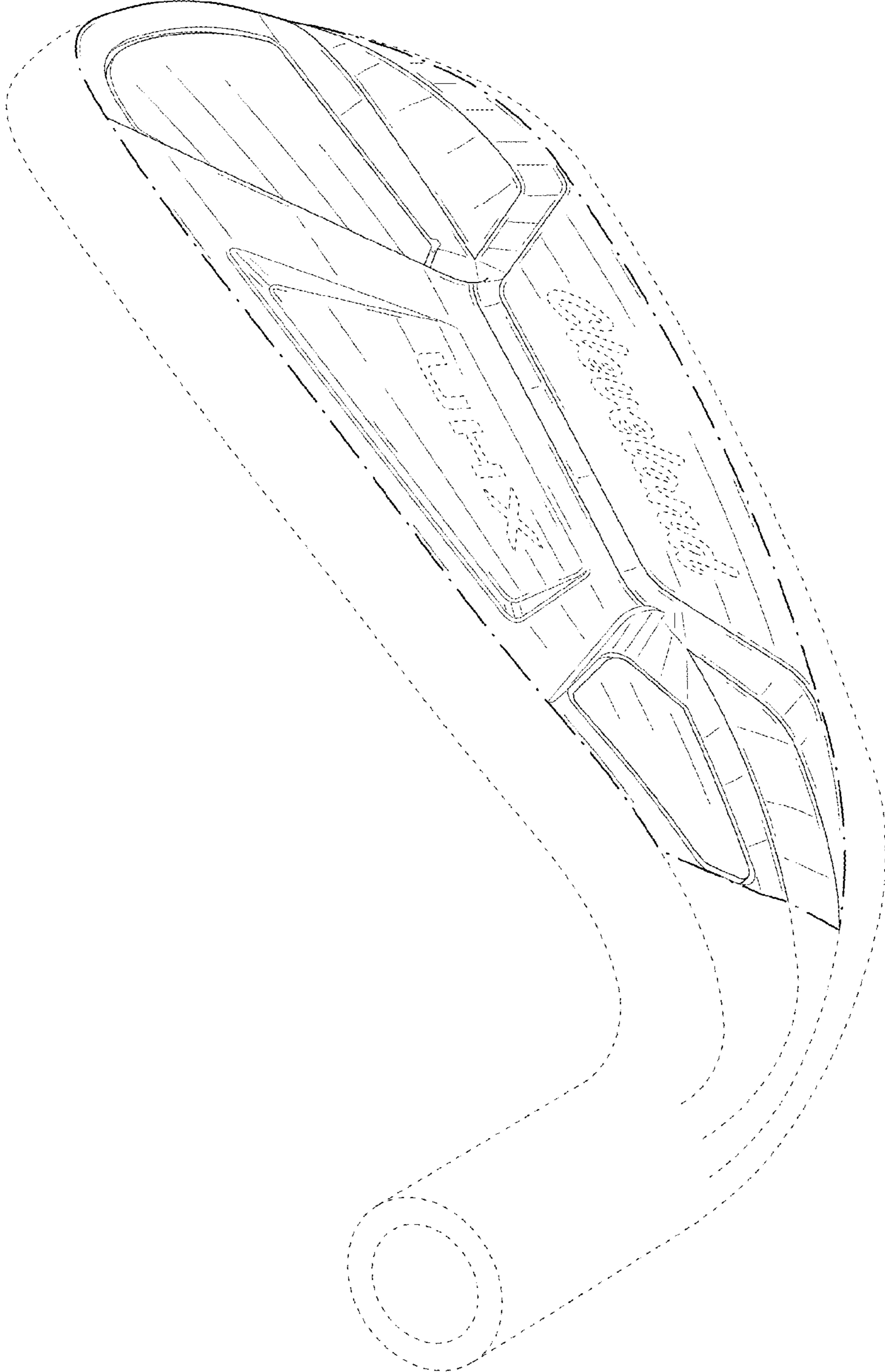

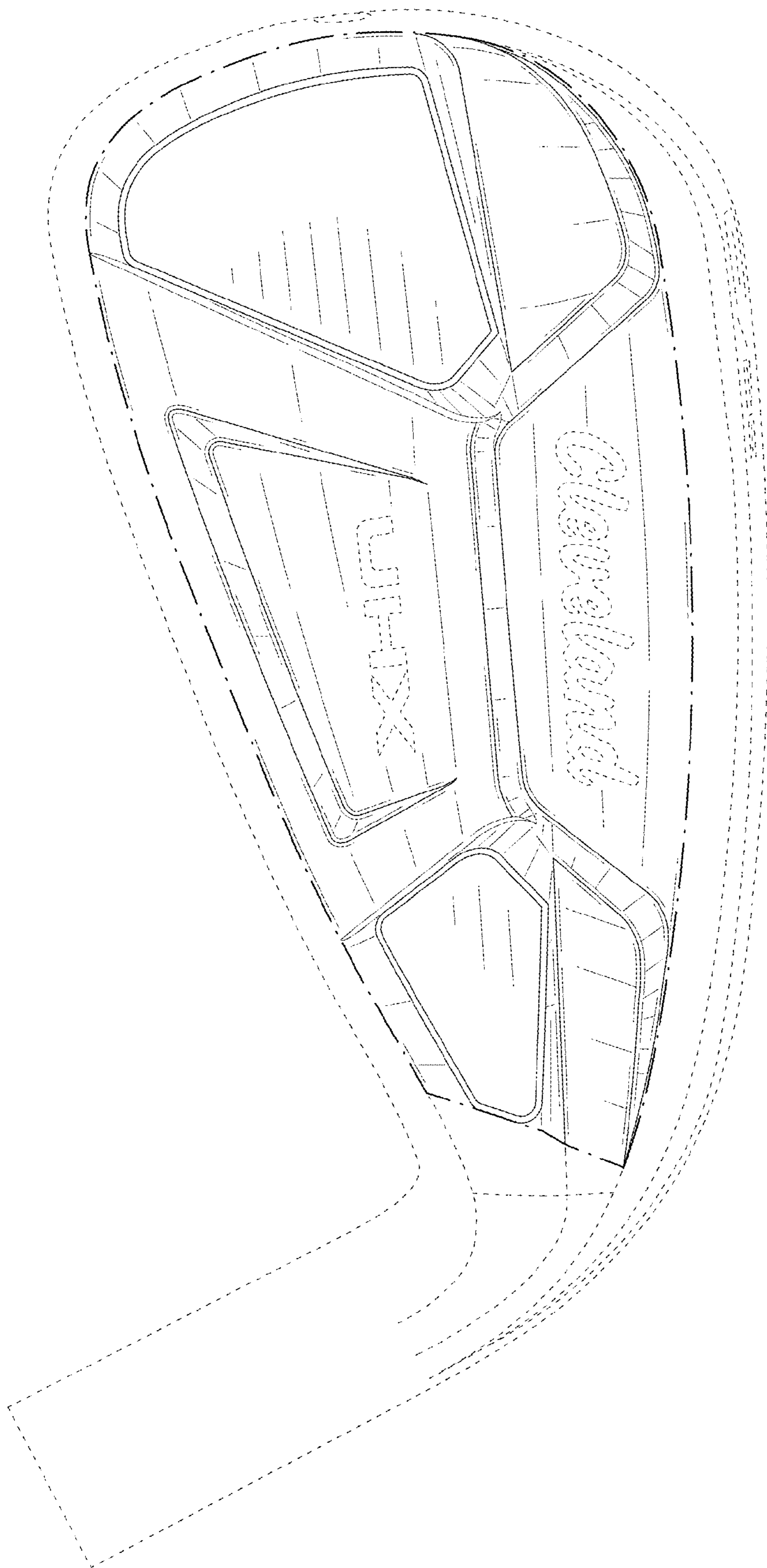

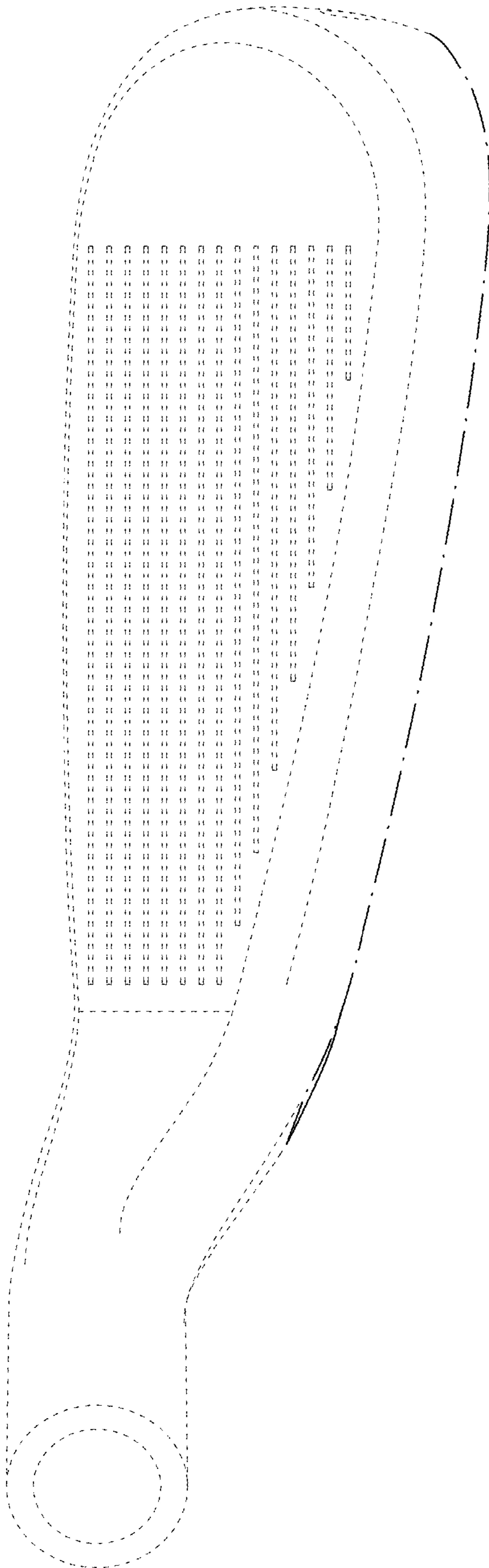

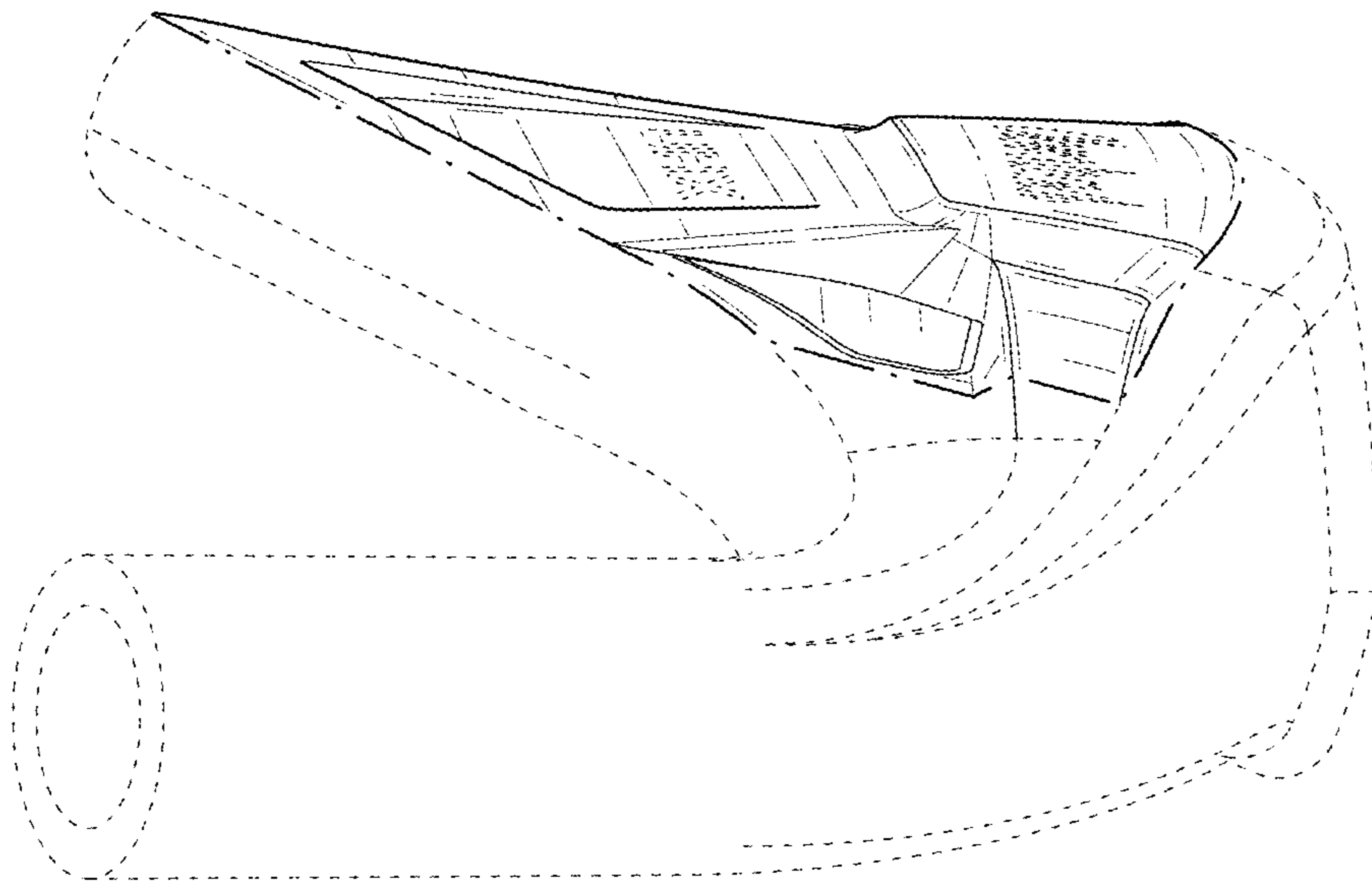

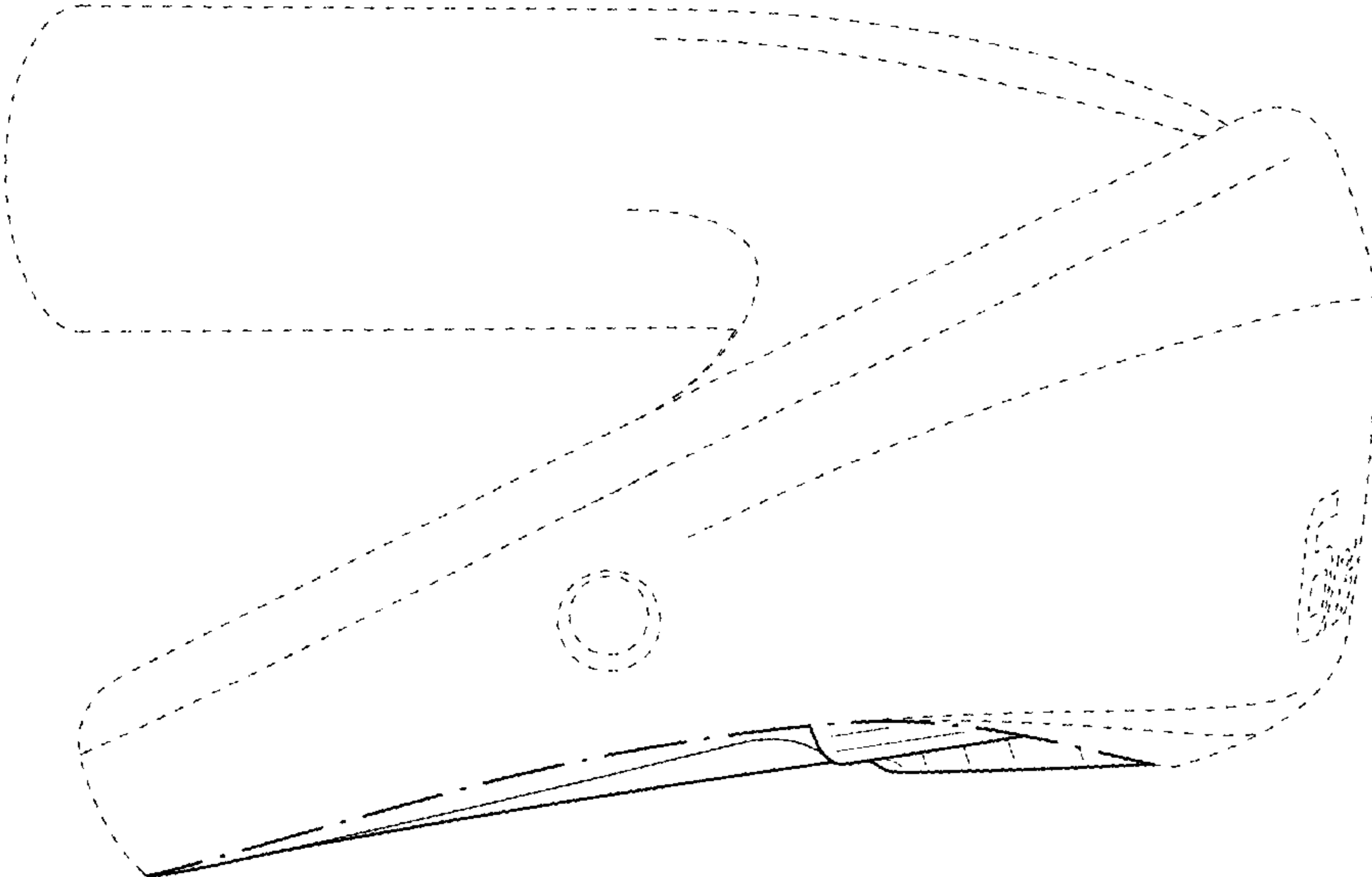

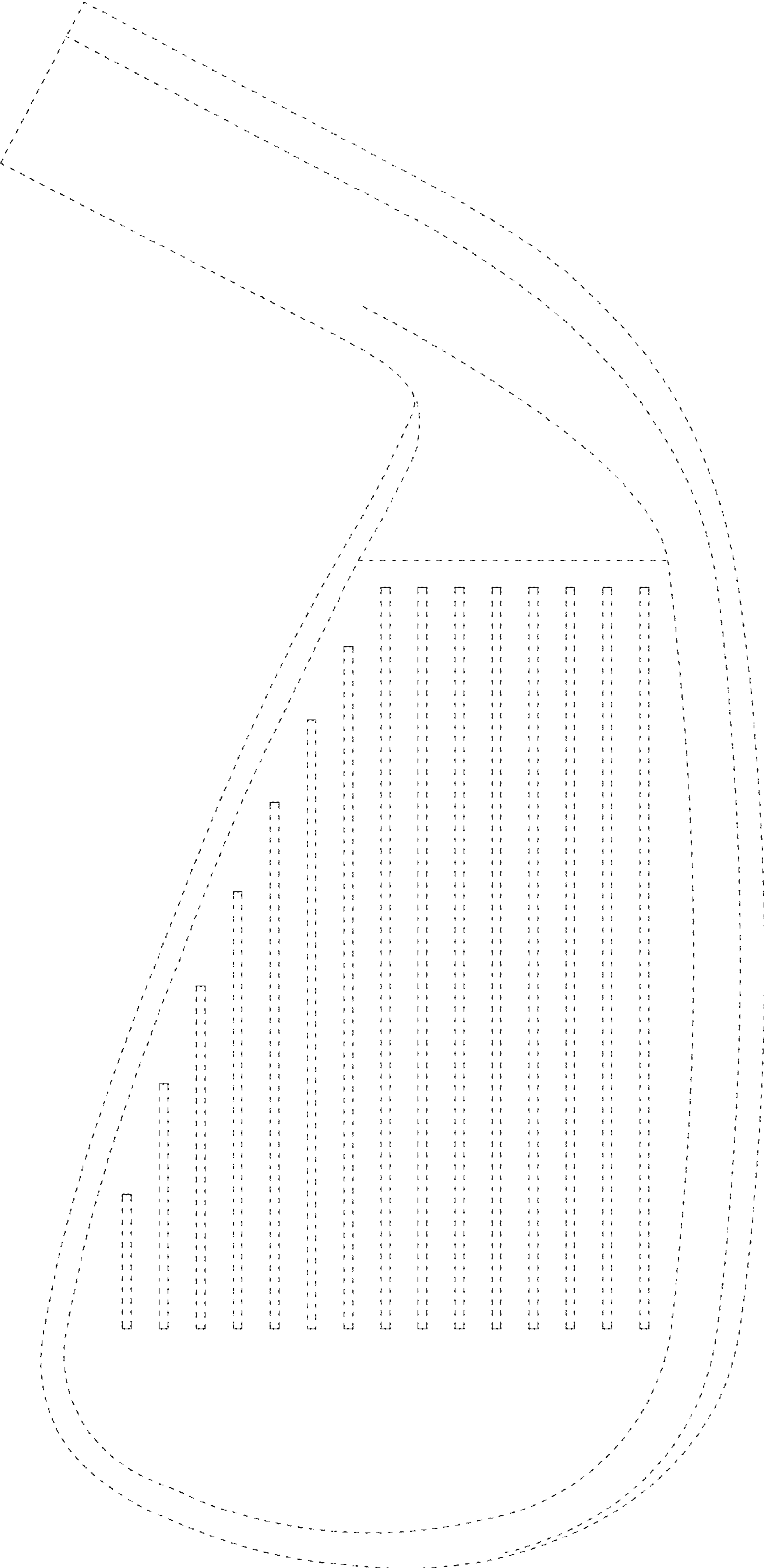

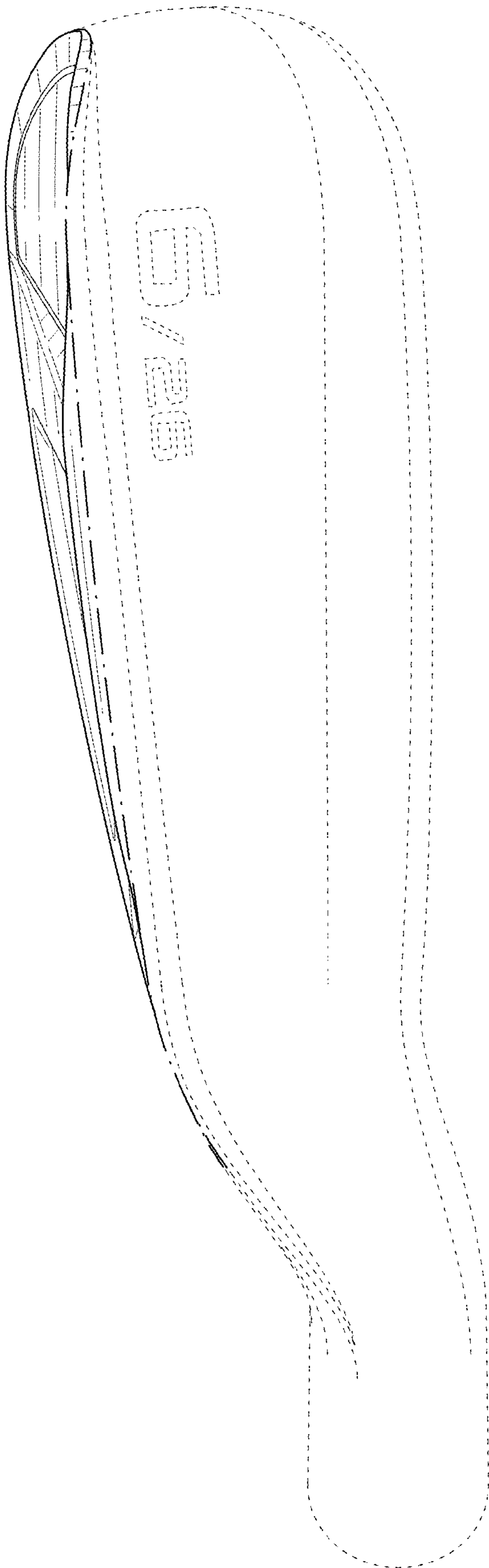
