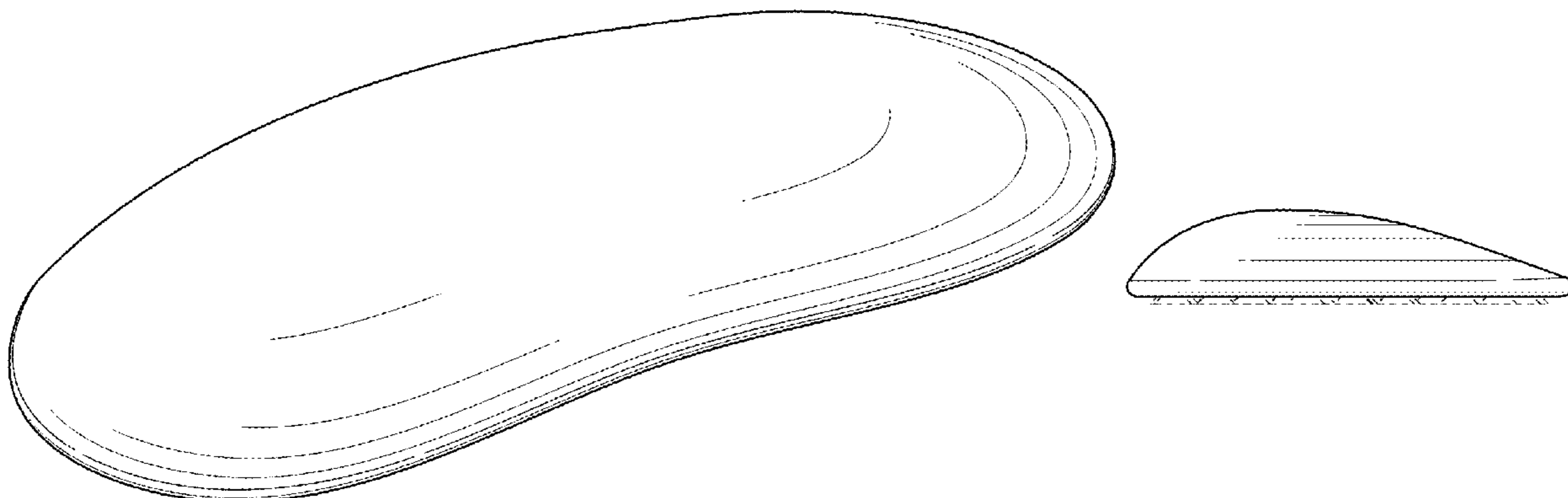
(57) **CLAIM**

I claim the ornamental design for a submersible body support, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a submersible body support showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 left side elevation thereof;
FIG. 5 is a right side elevation thereof;
FIG. 6 is a front elevation thereof; and,
FIG. 7 is a rear elevation thereof.
The broken line showing of the submersible body support is for the purpose of illustrating portions of the article and forms no part of the claimed design.

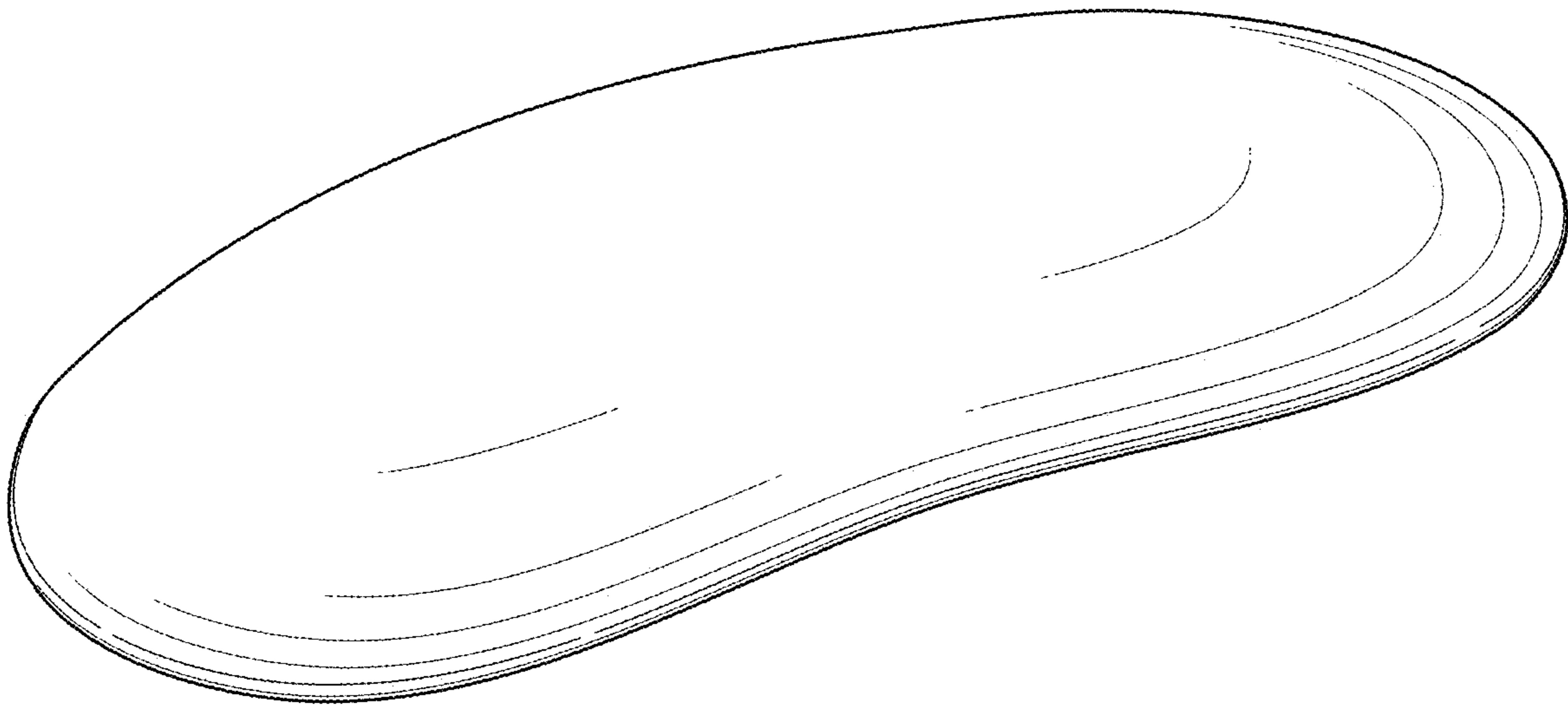

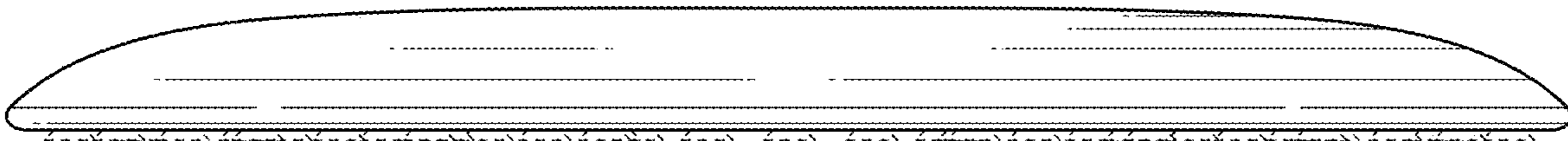

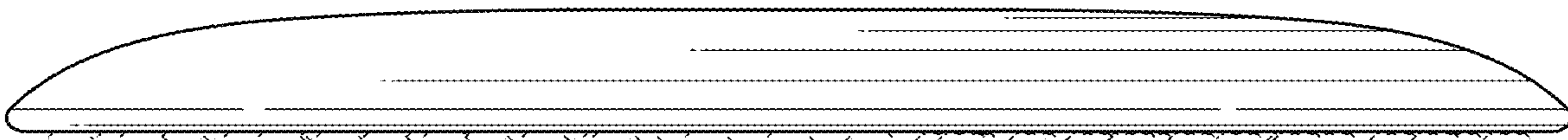

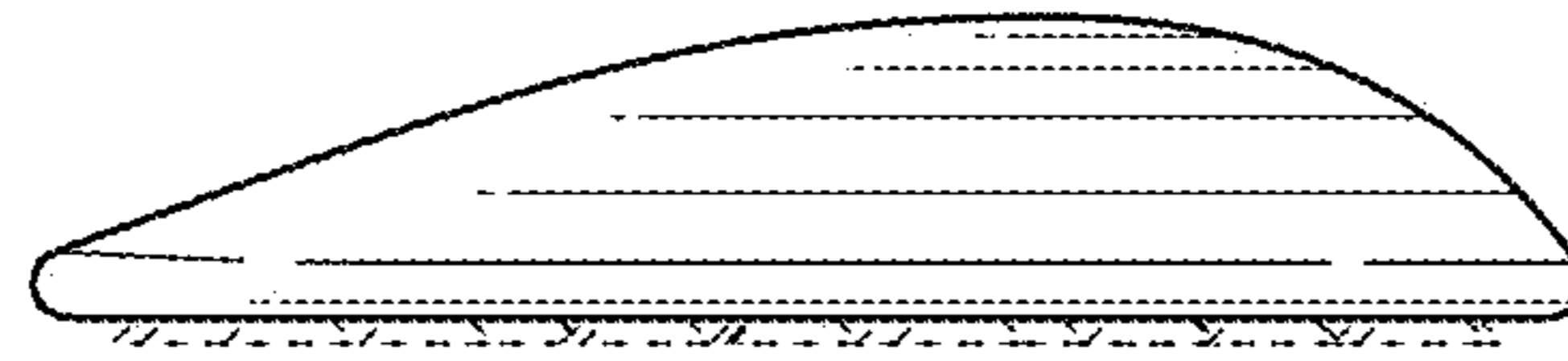

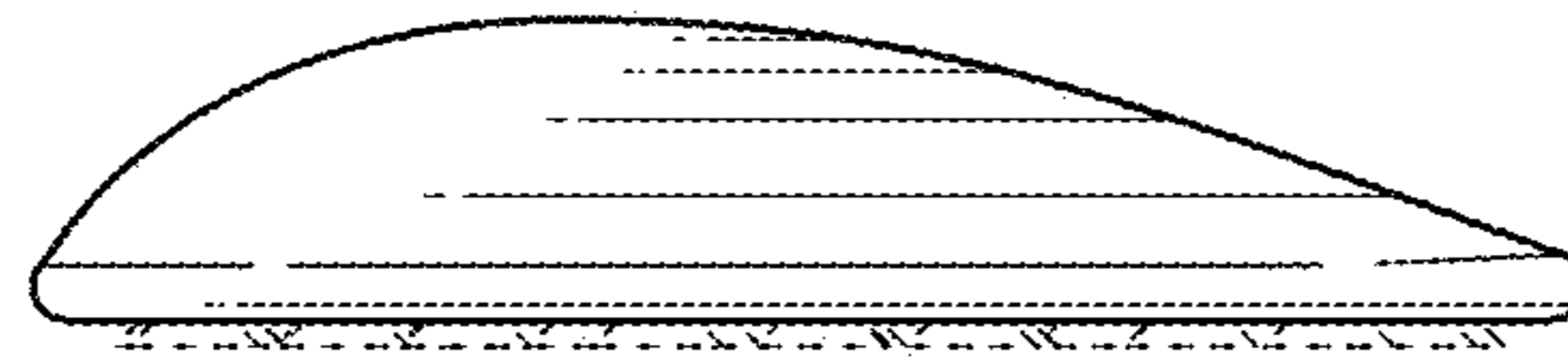

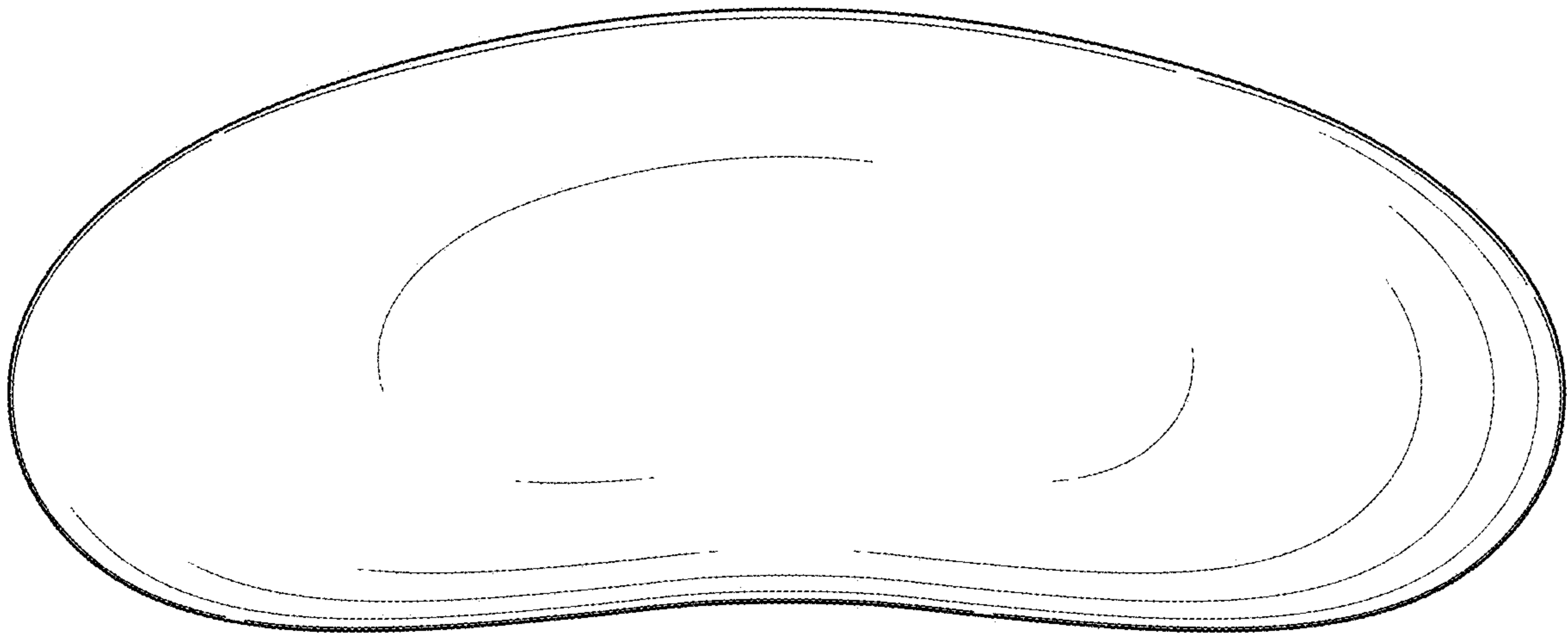

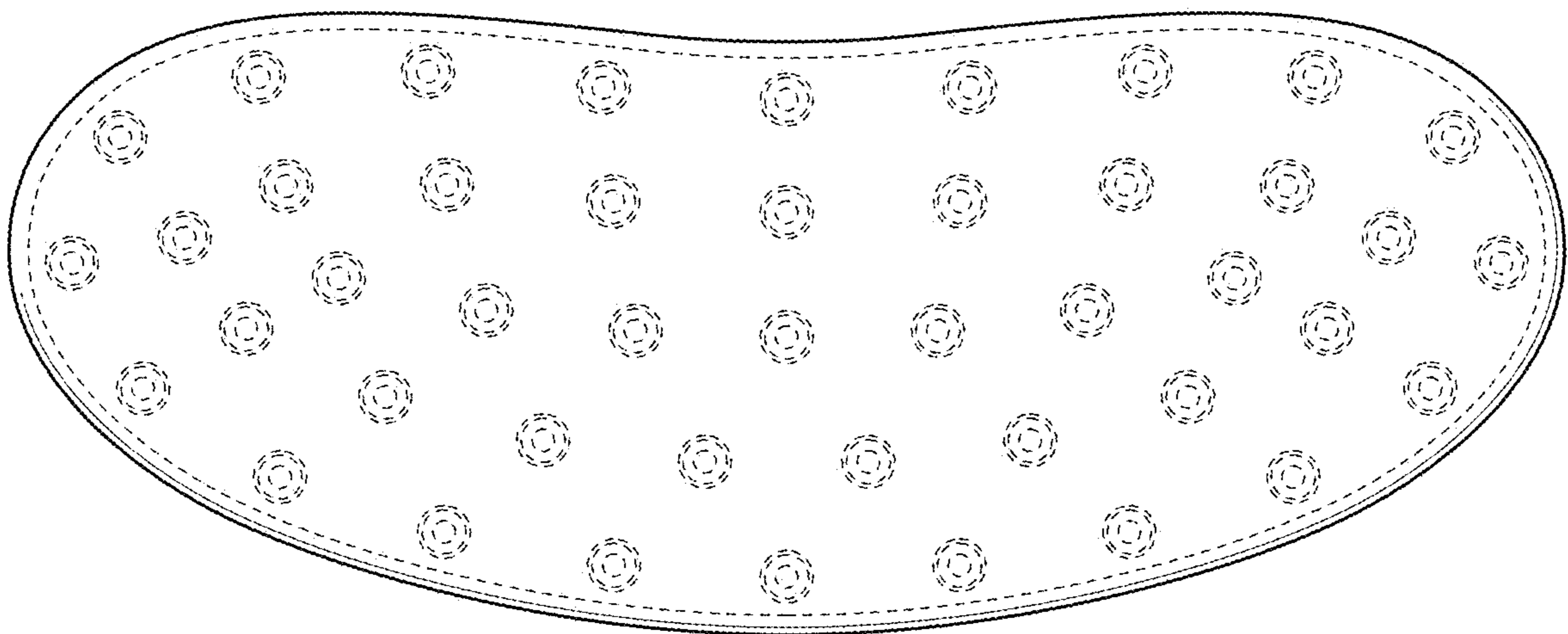
