The ornamental design for a mosaic tile, as shown and described.

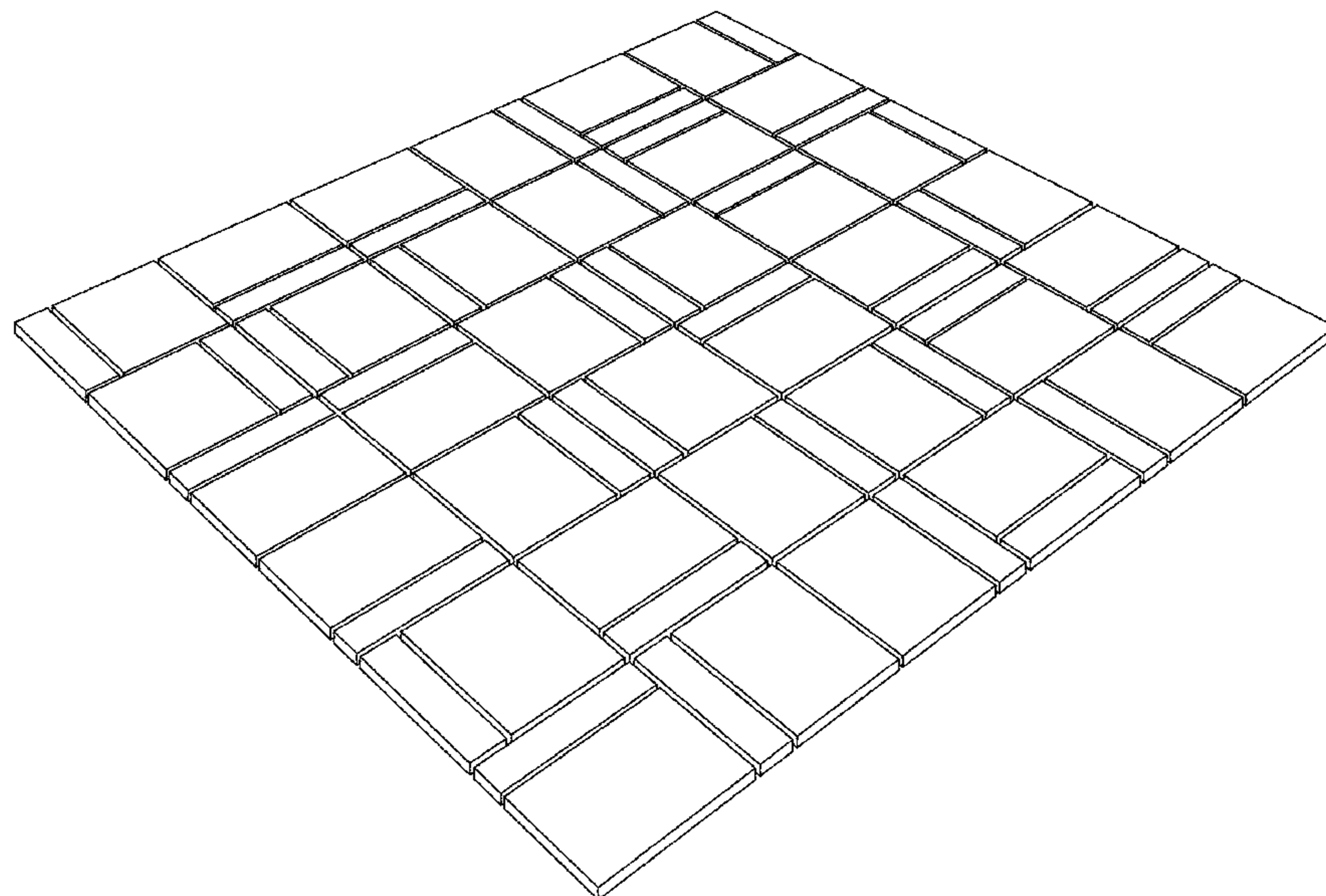
DESCRIPTION

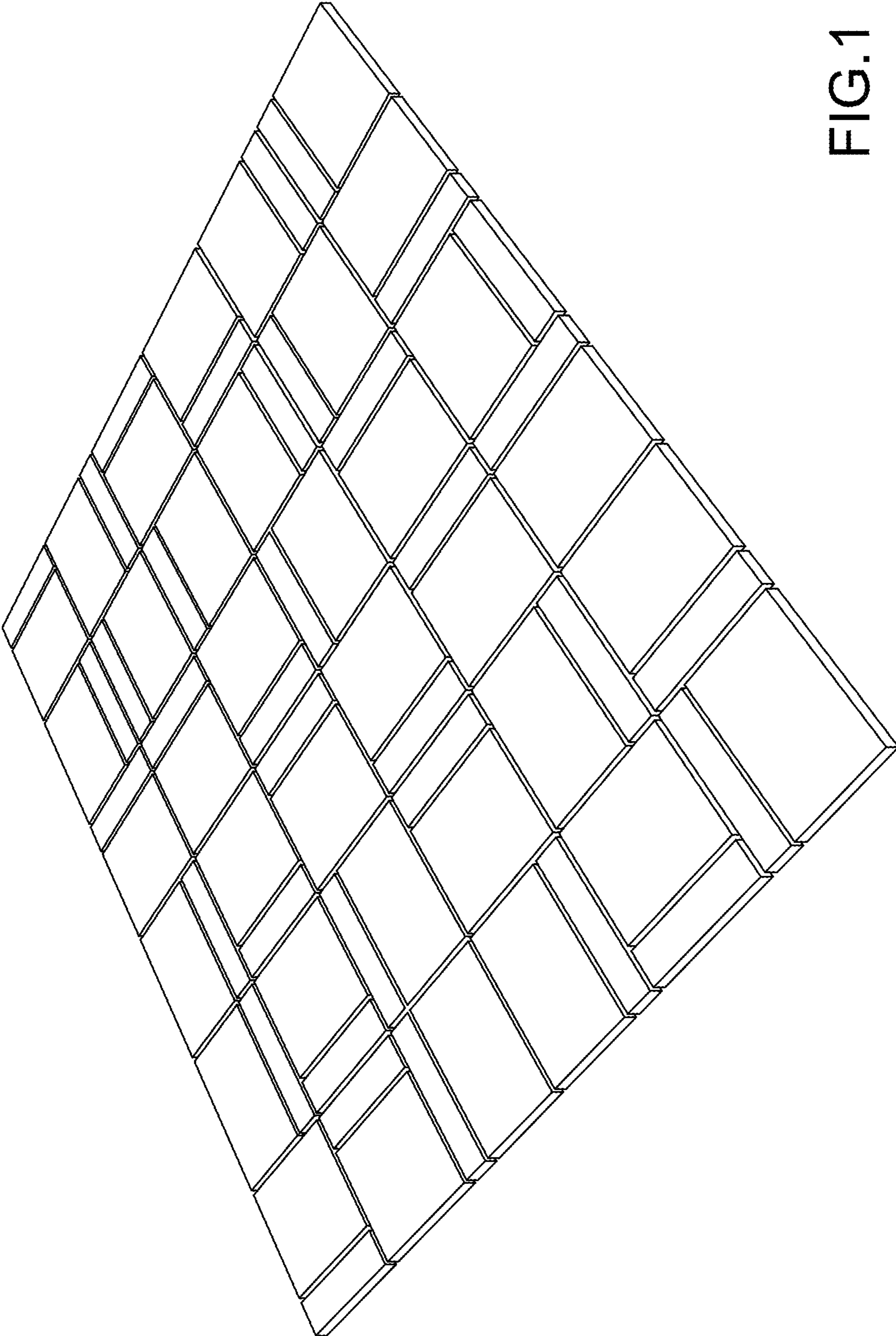

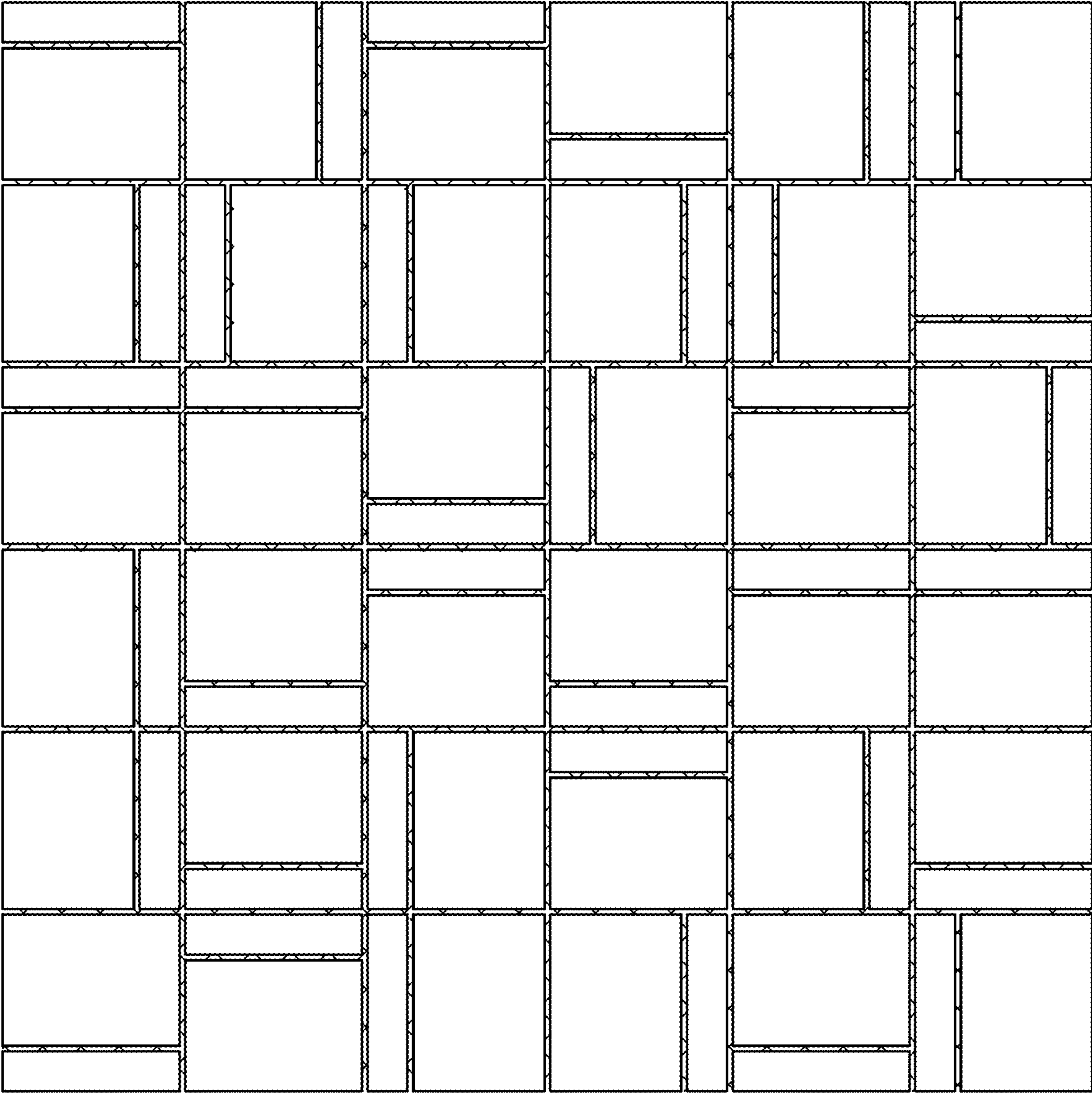

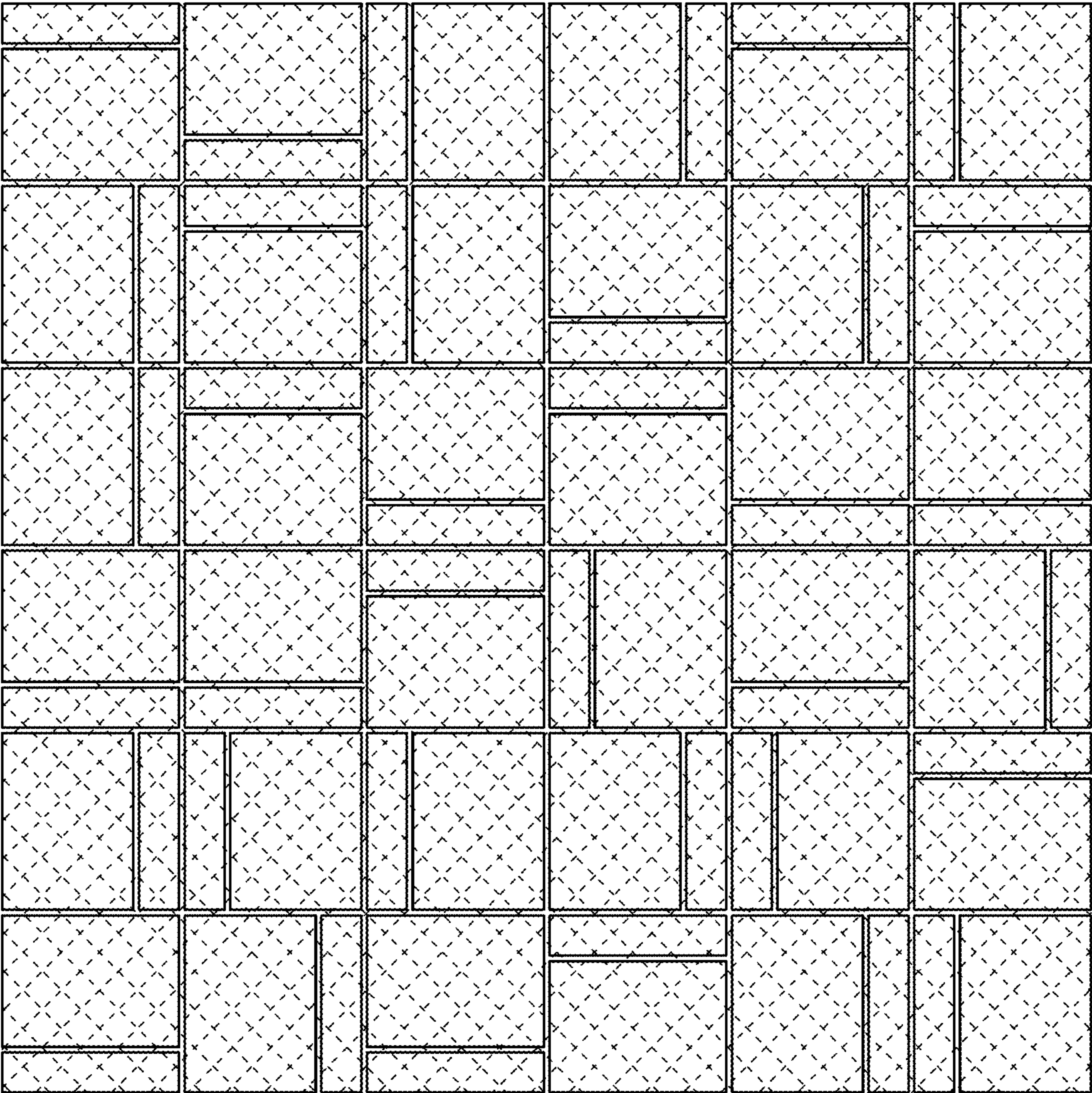




FIG. 4 FIG. 5
