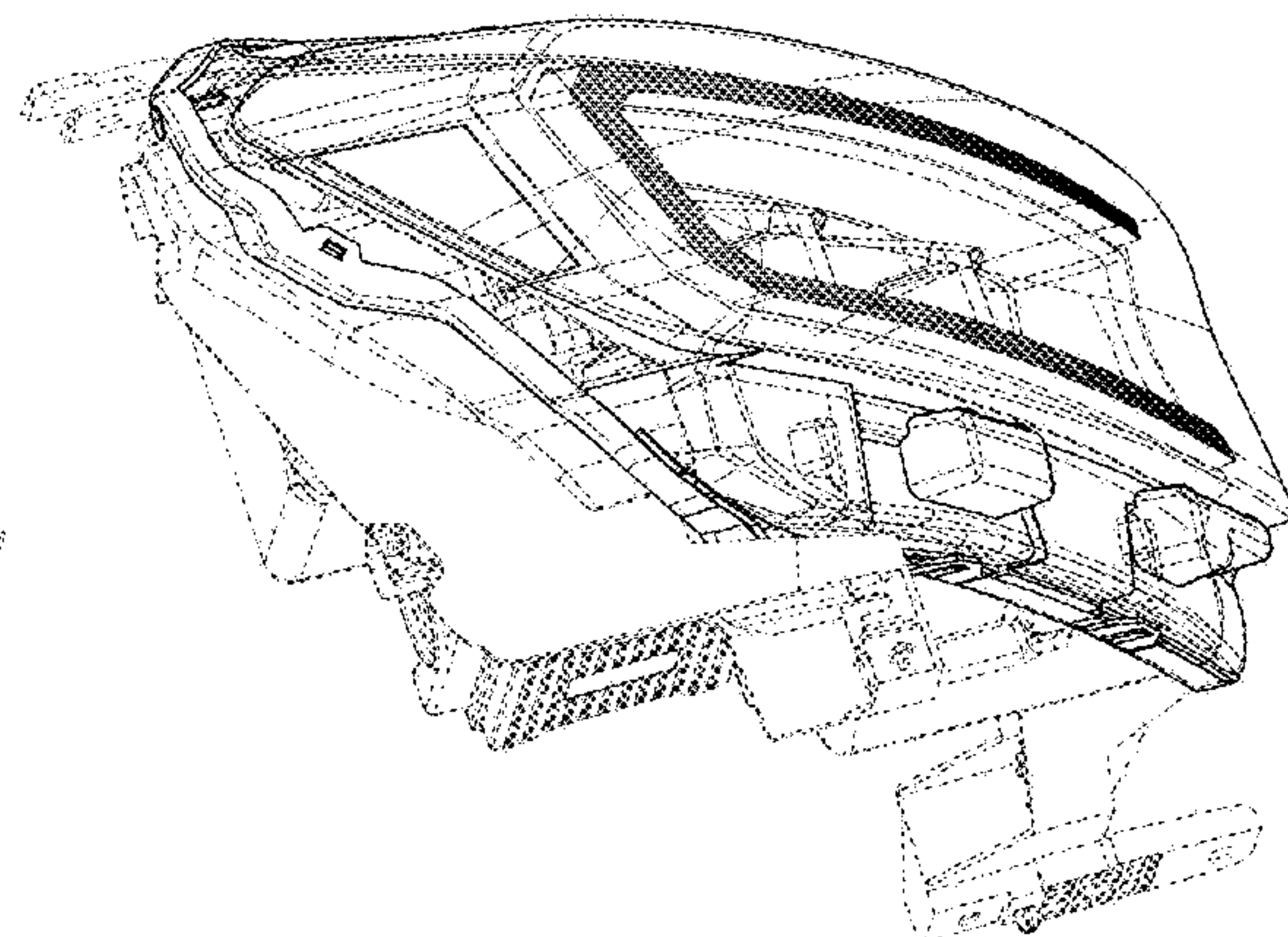
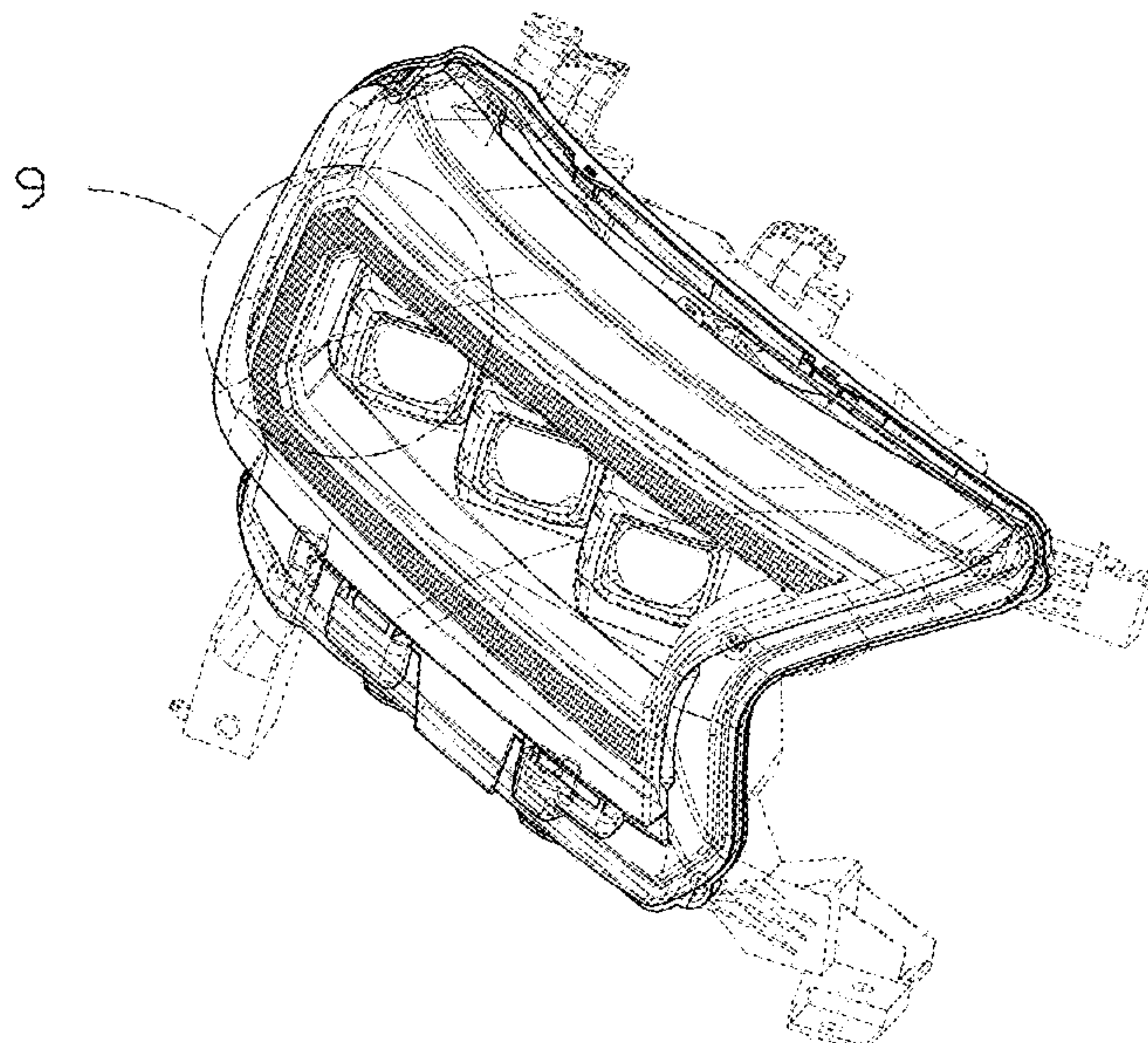

The dash dot dash lines in FIGS. 1, 9, 10 and 18 are for the purpose of depicting the cut line of the enlarged view and form no part of the claim.

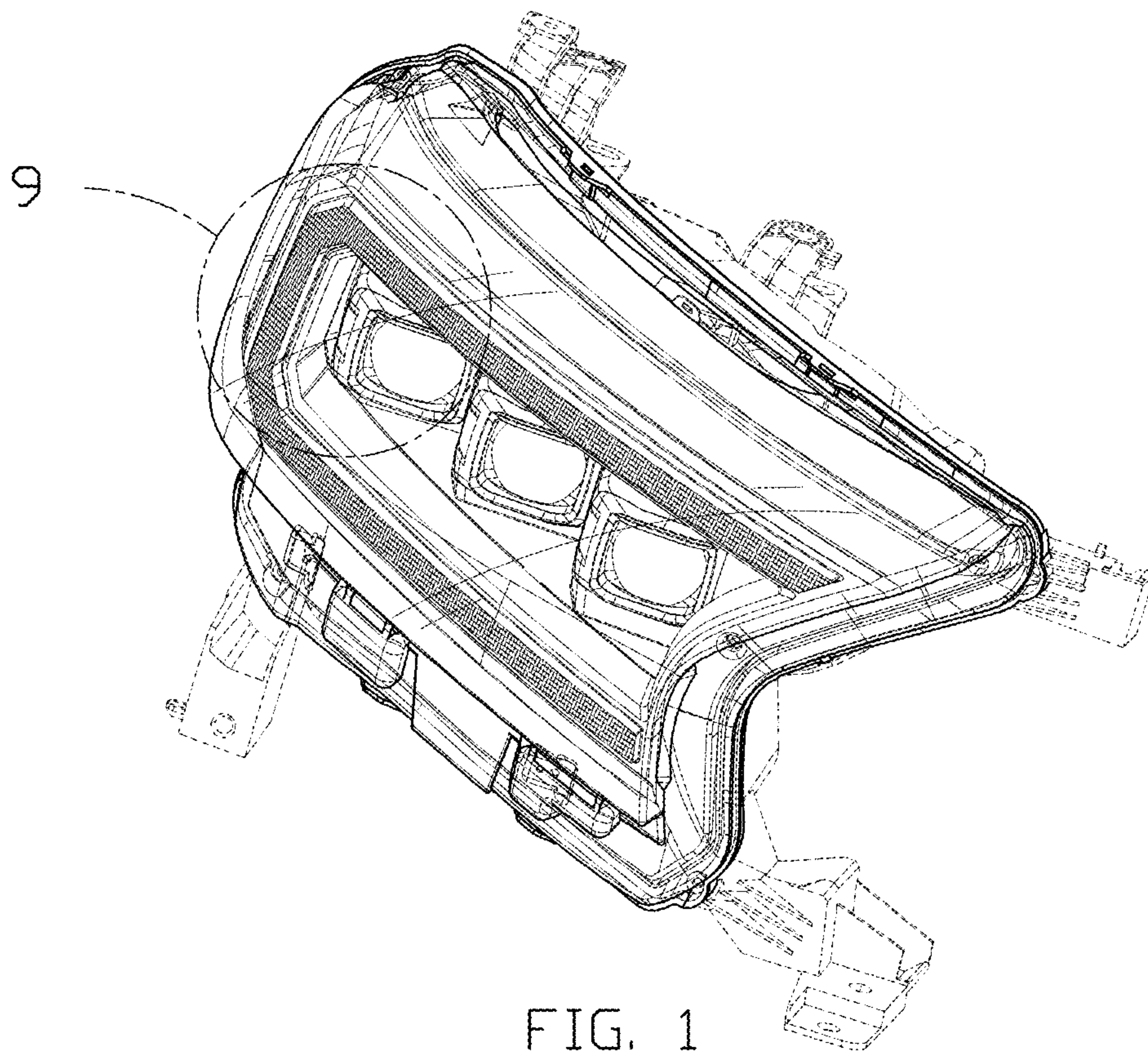

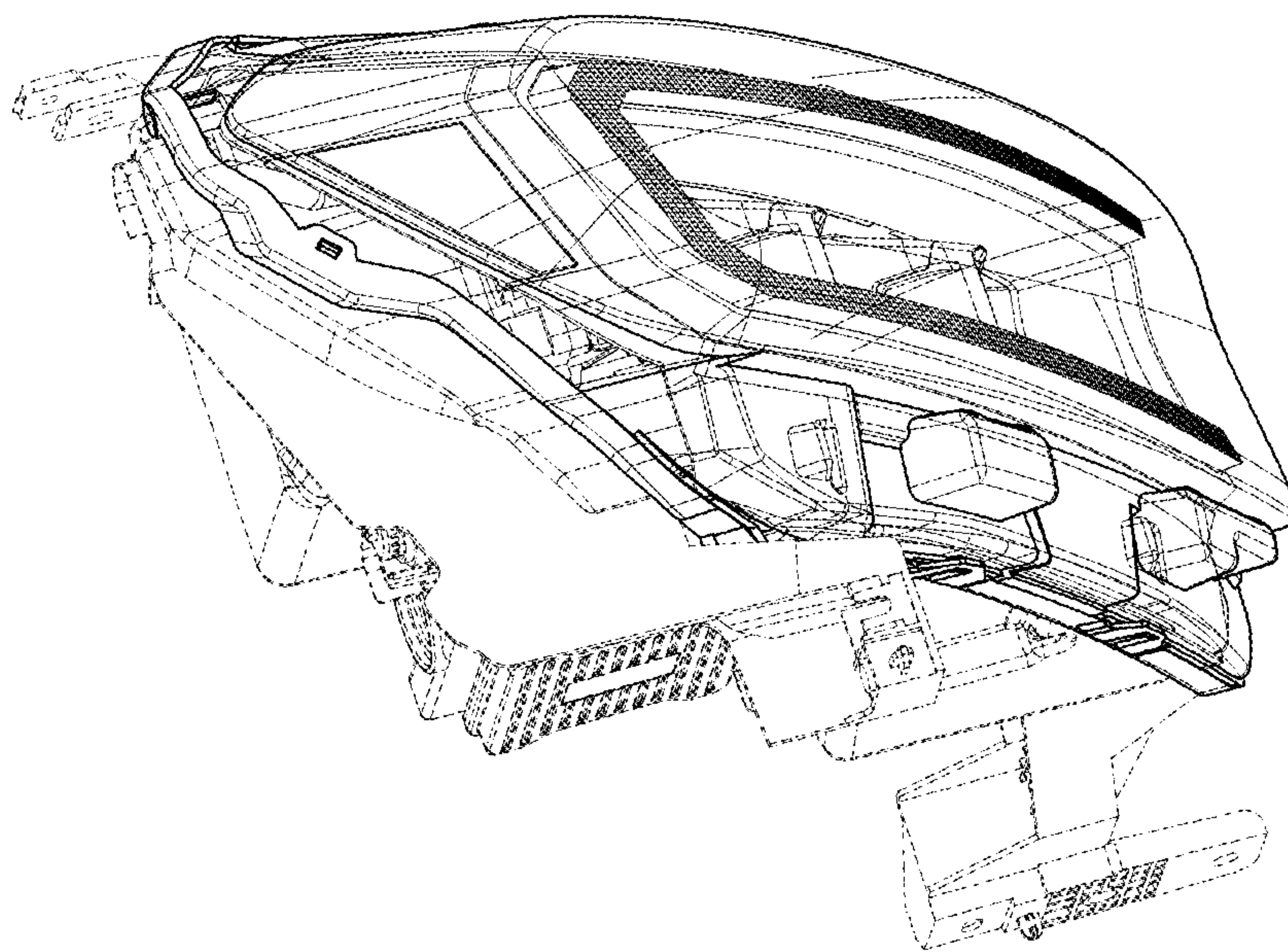

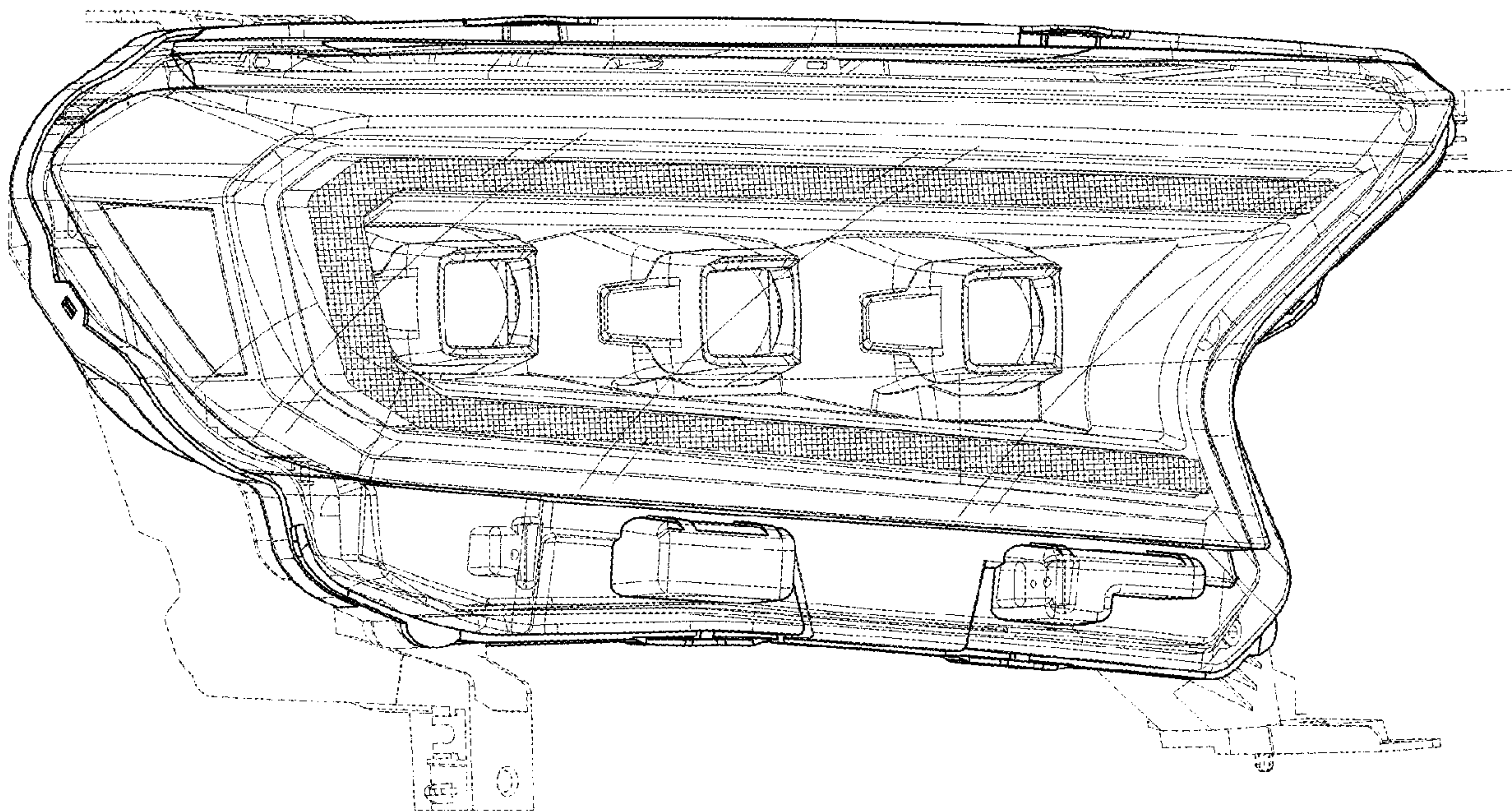

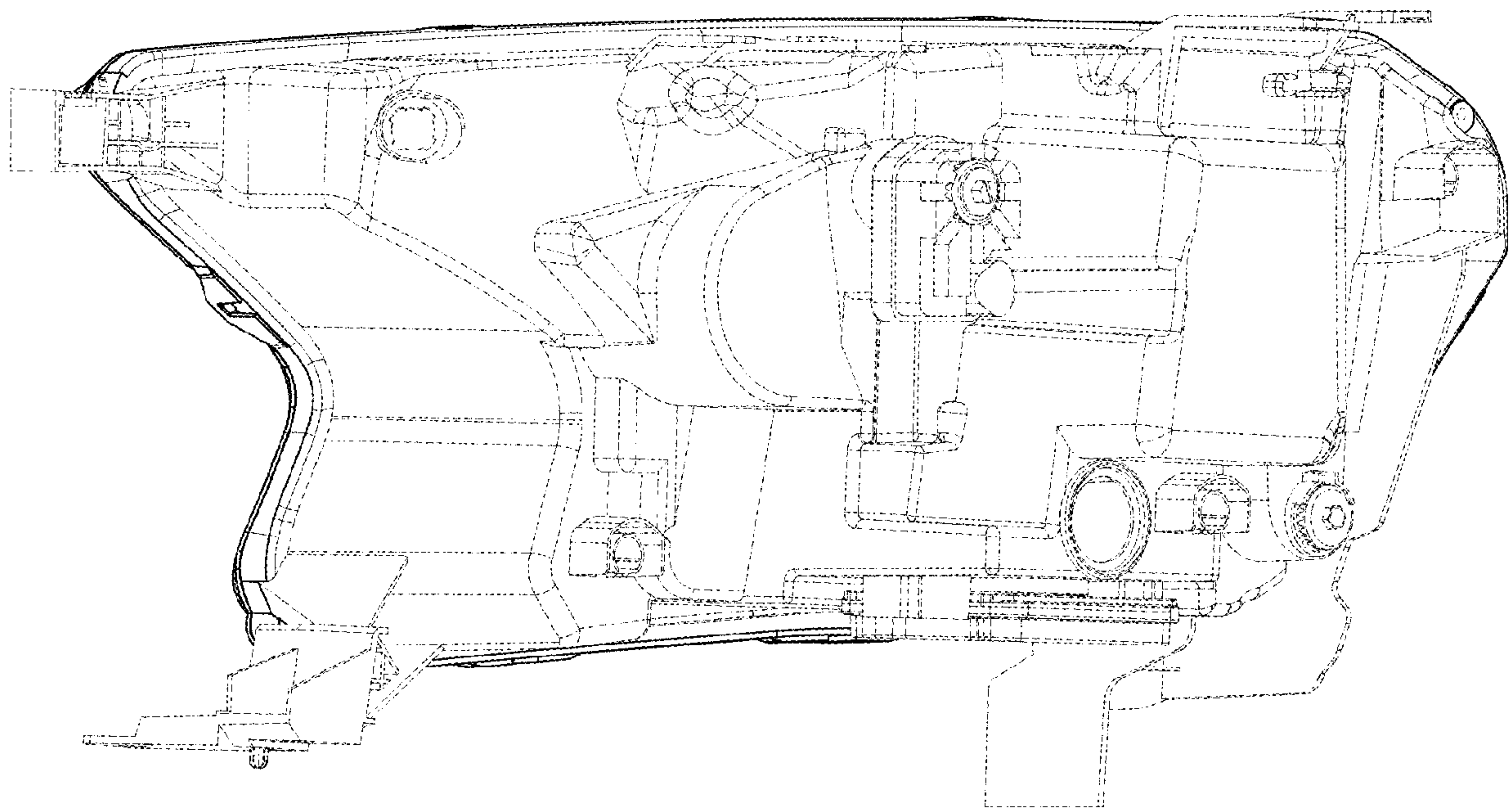

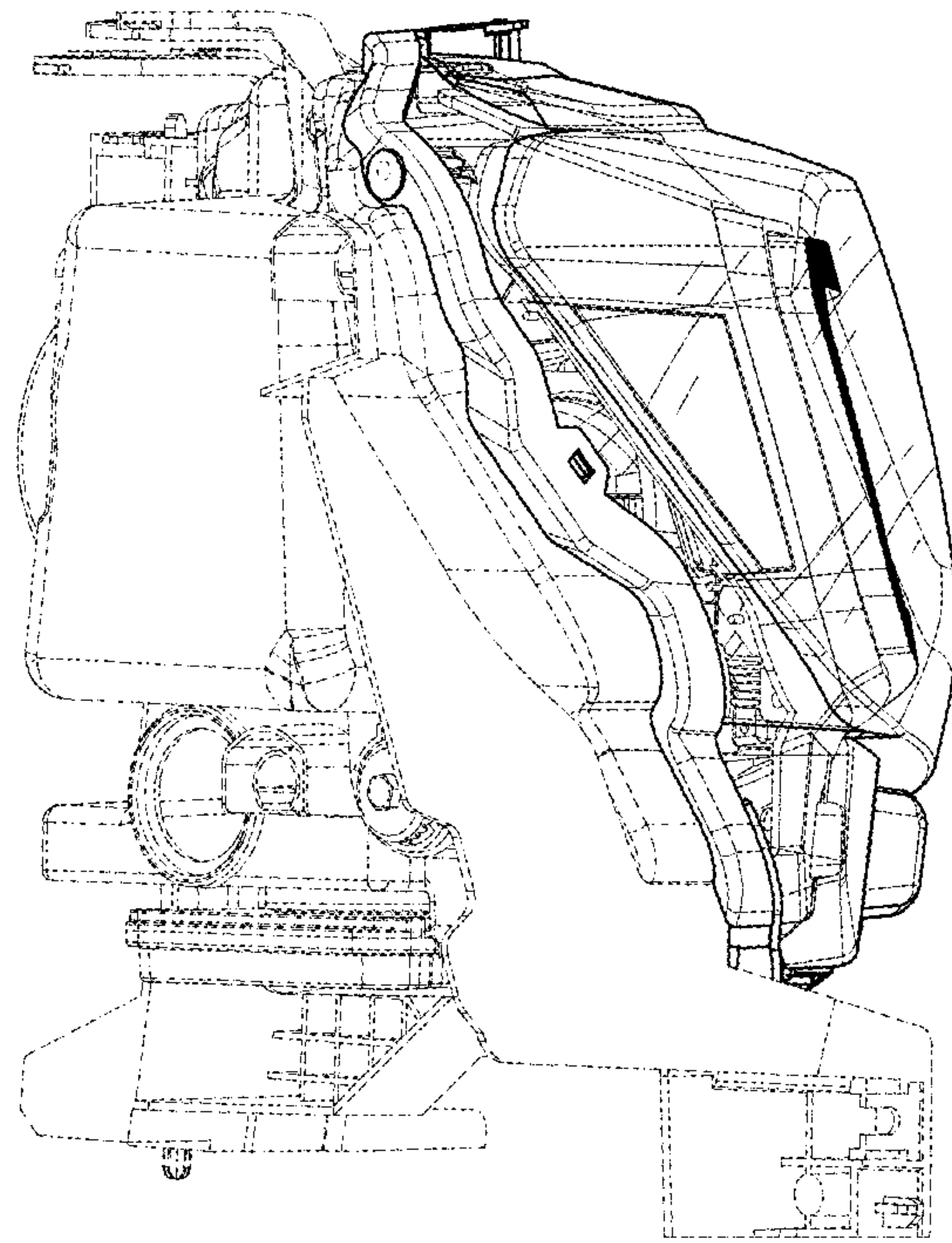

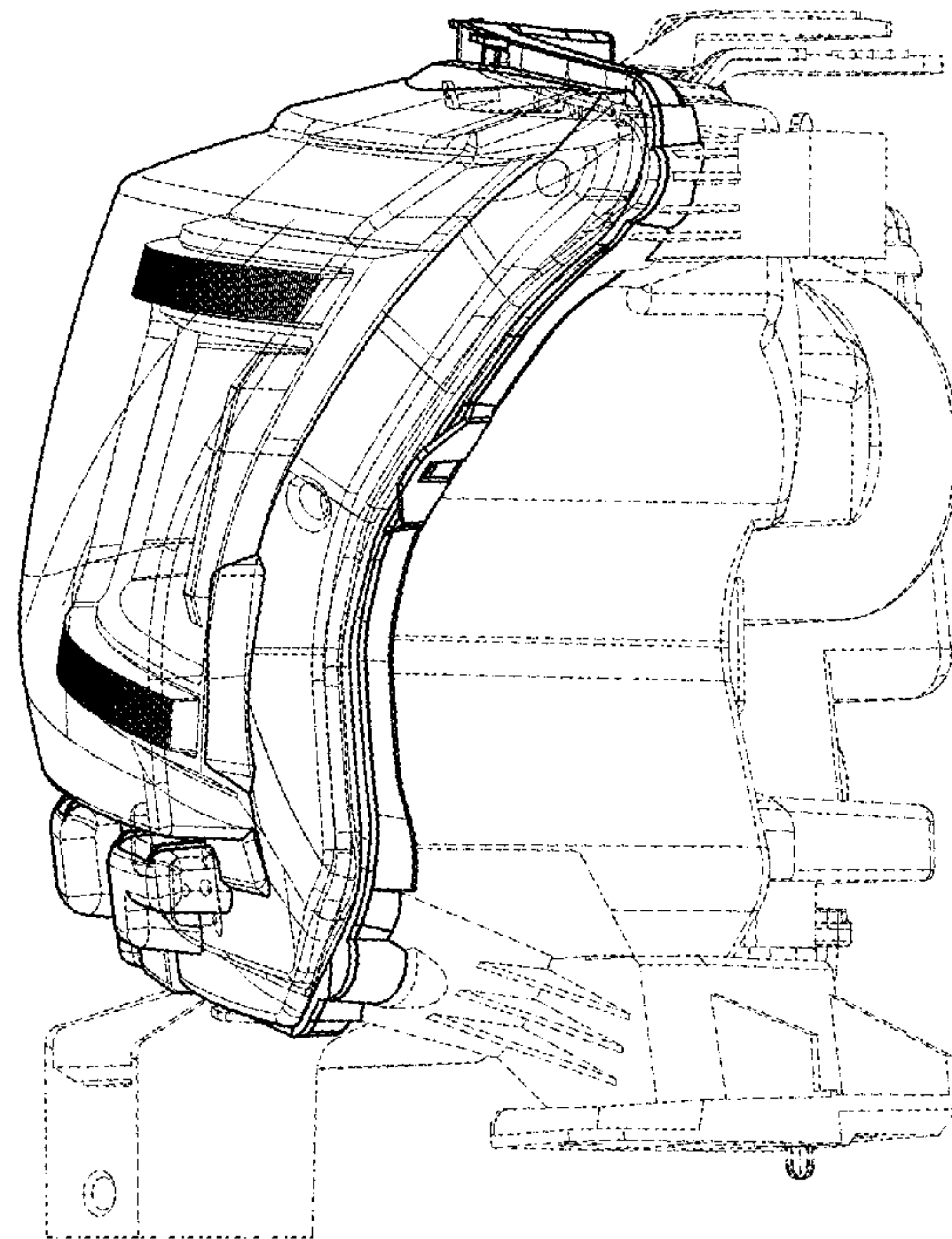

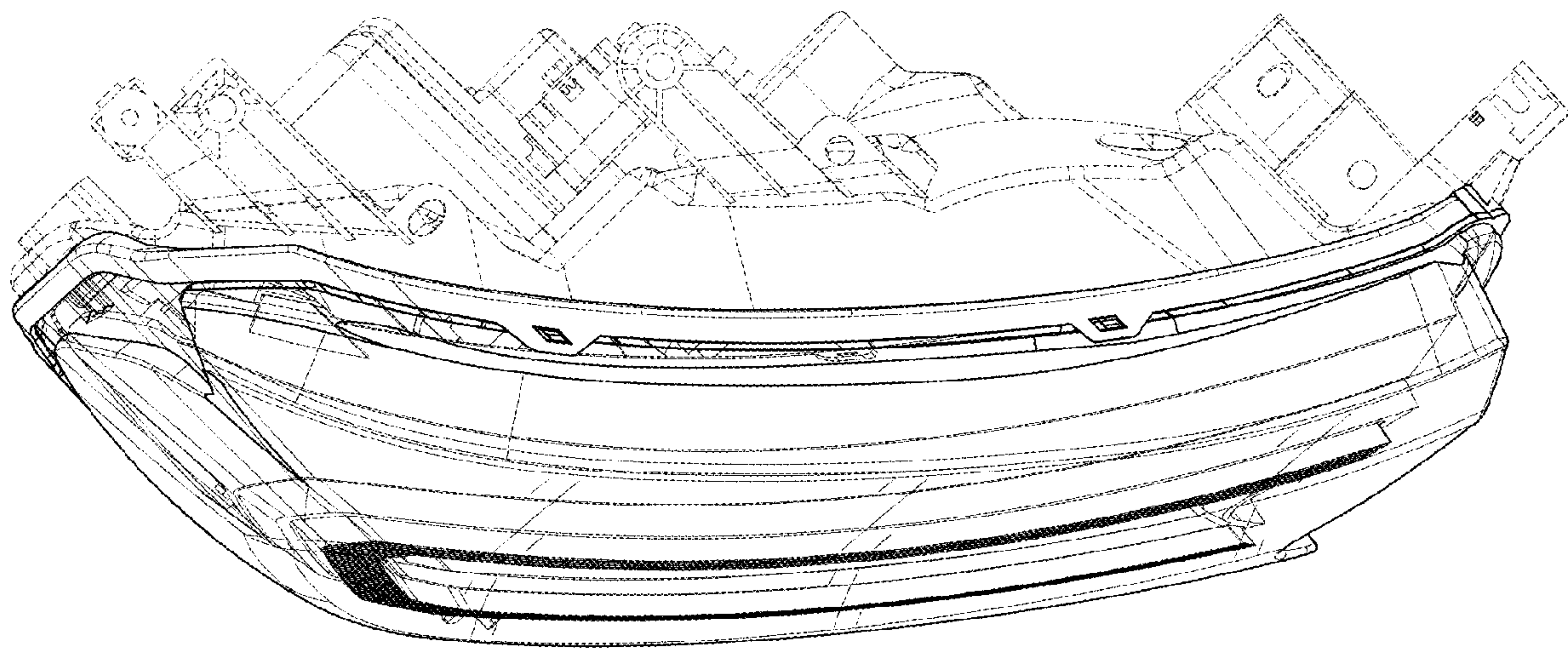

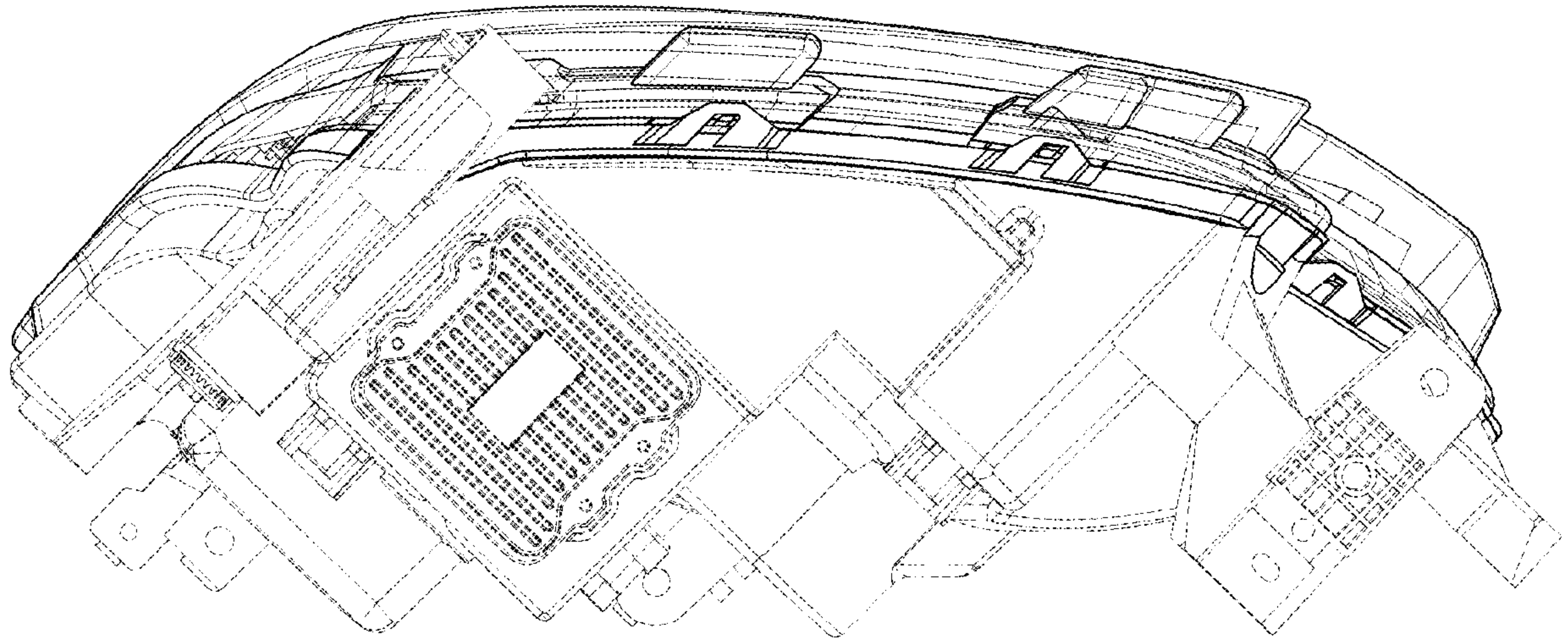

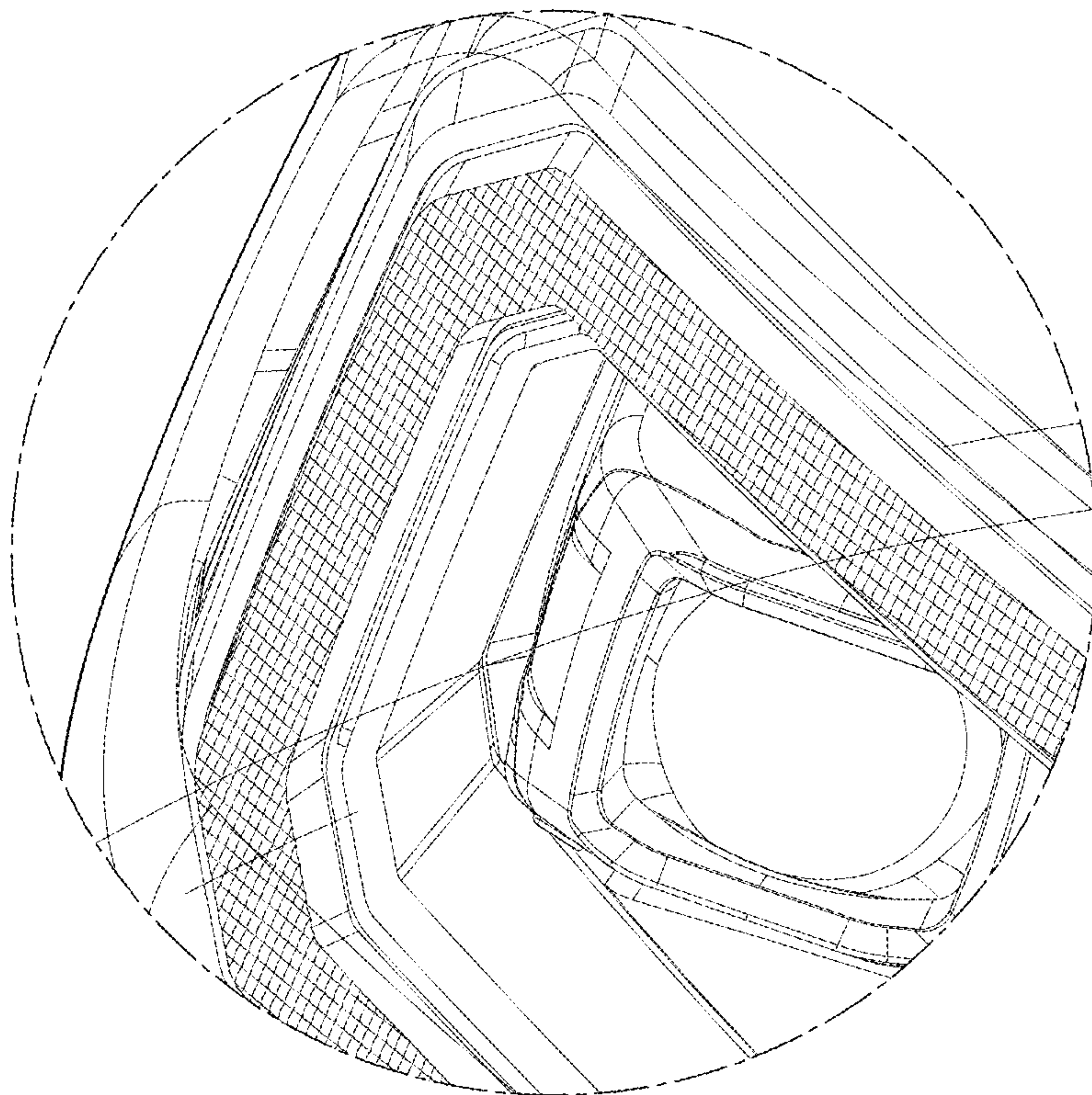
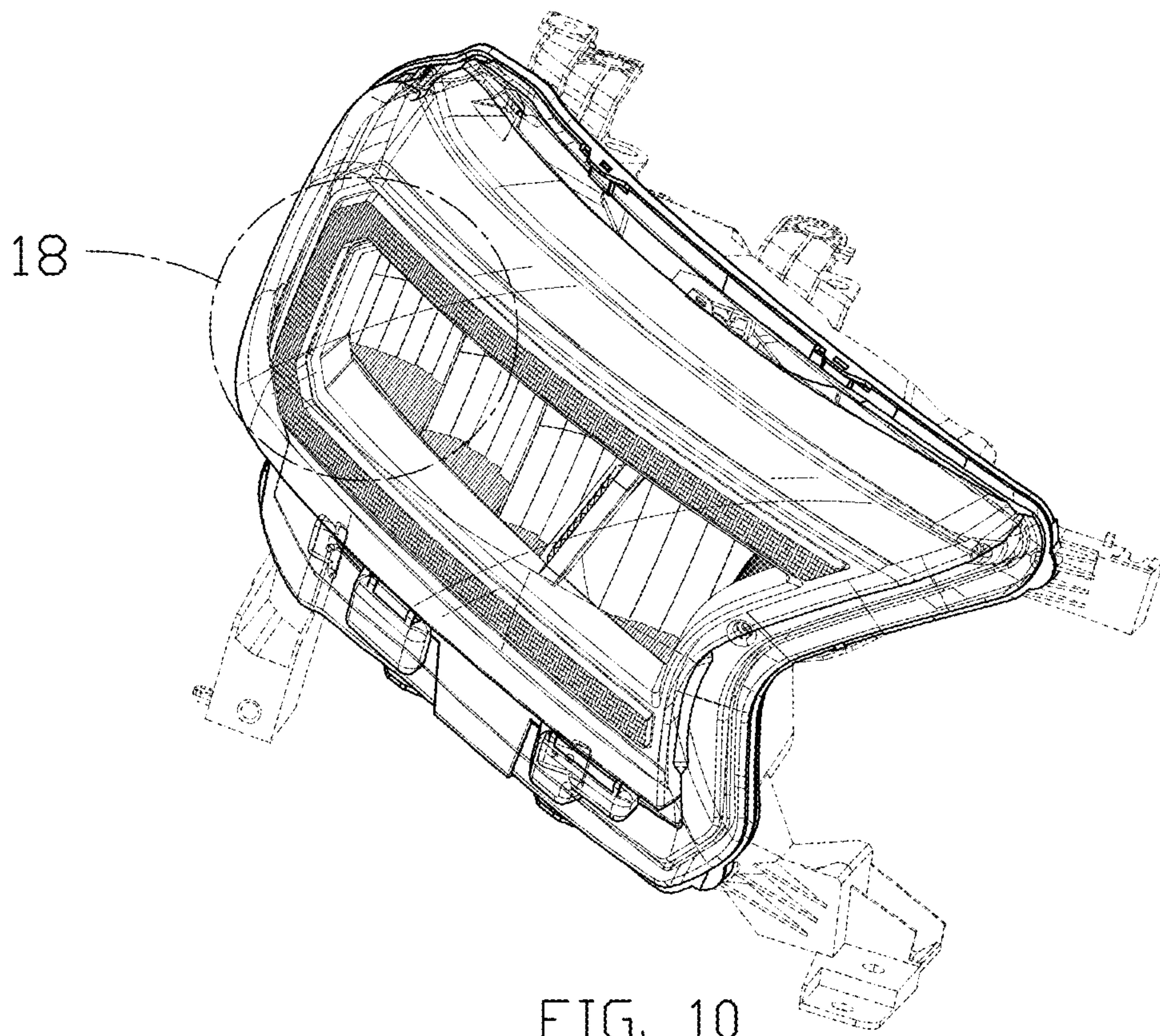

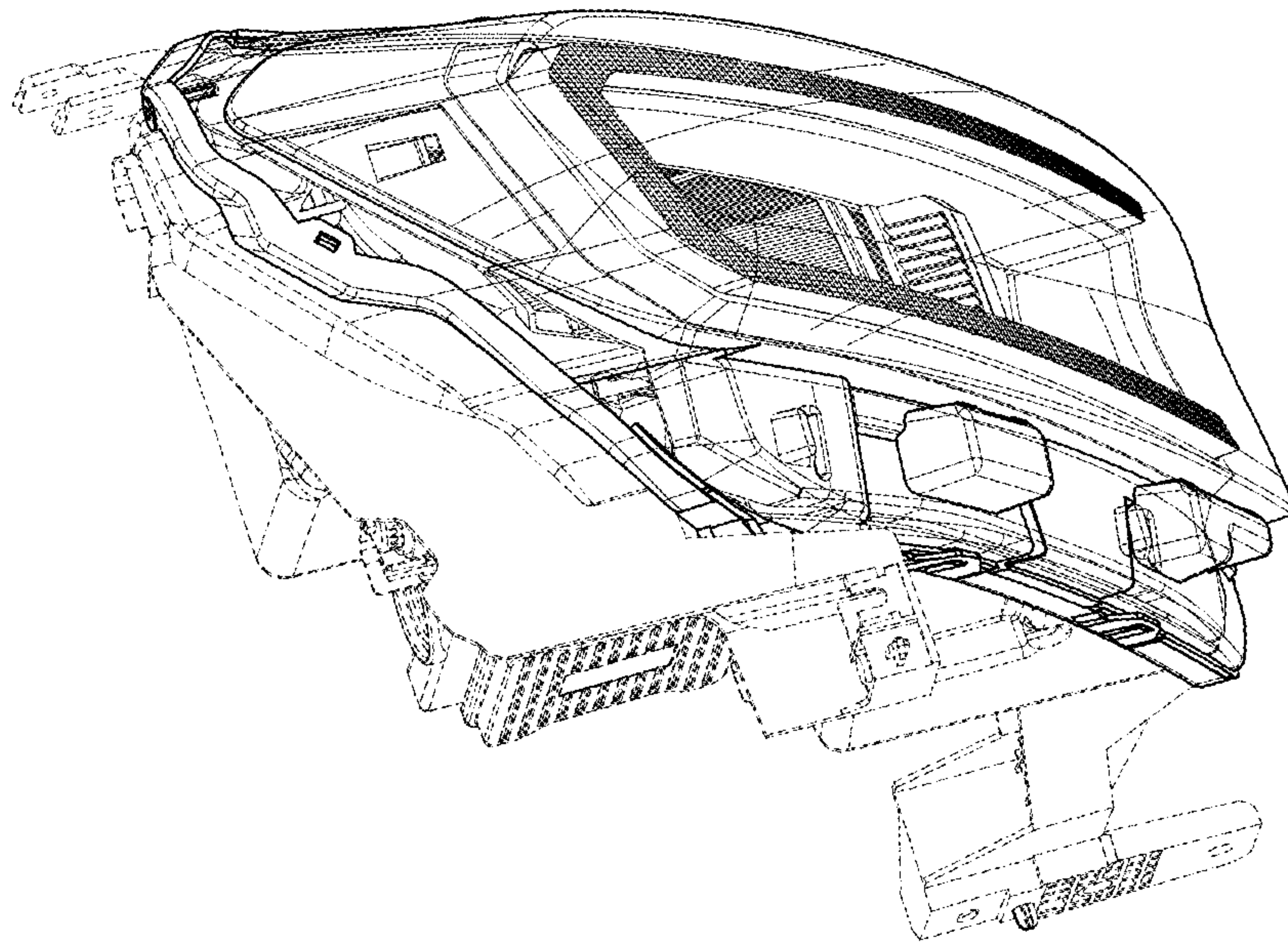

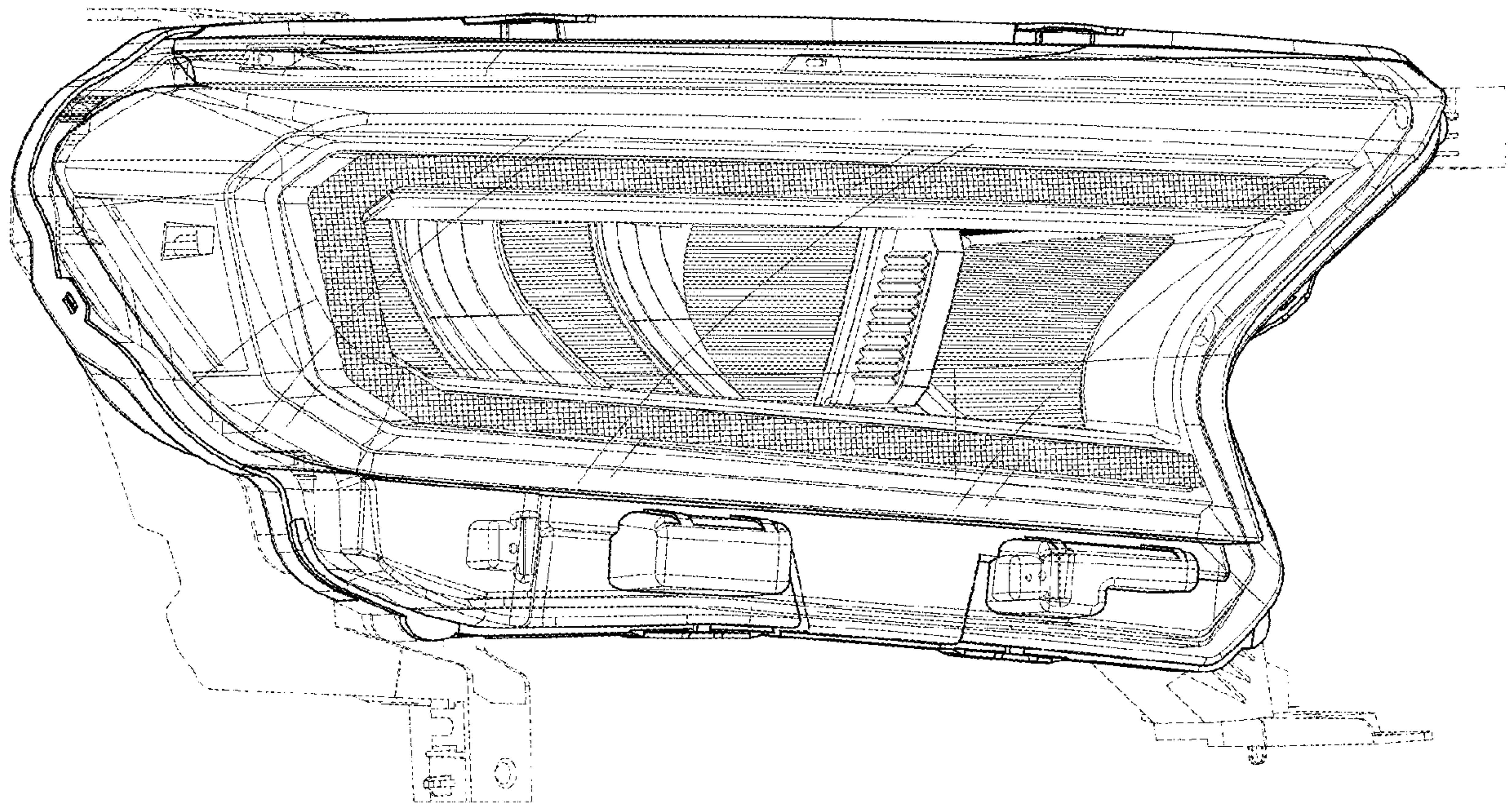

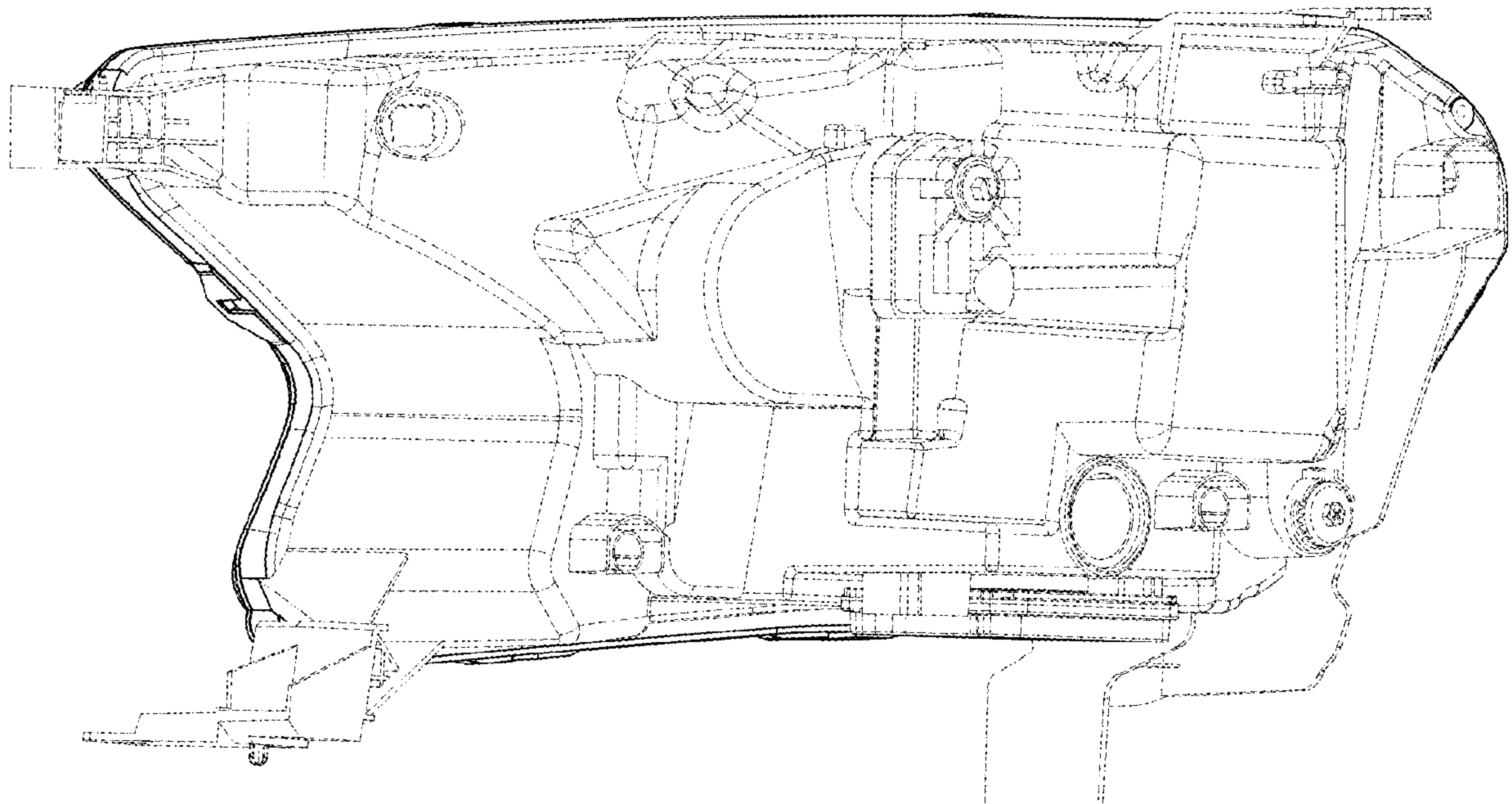

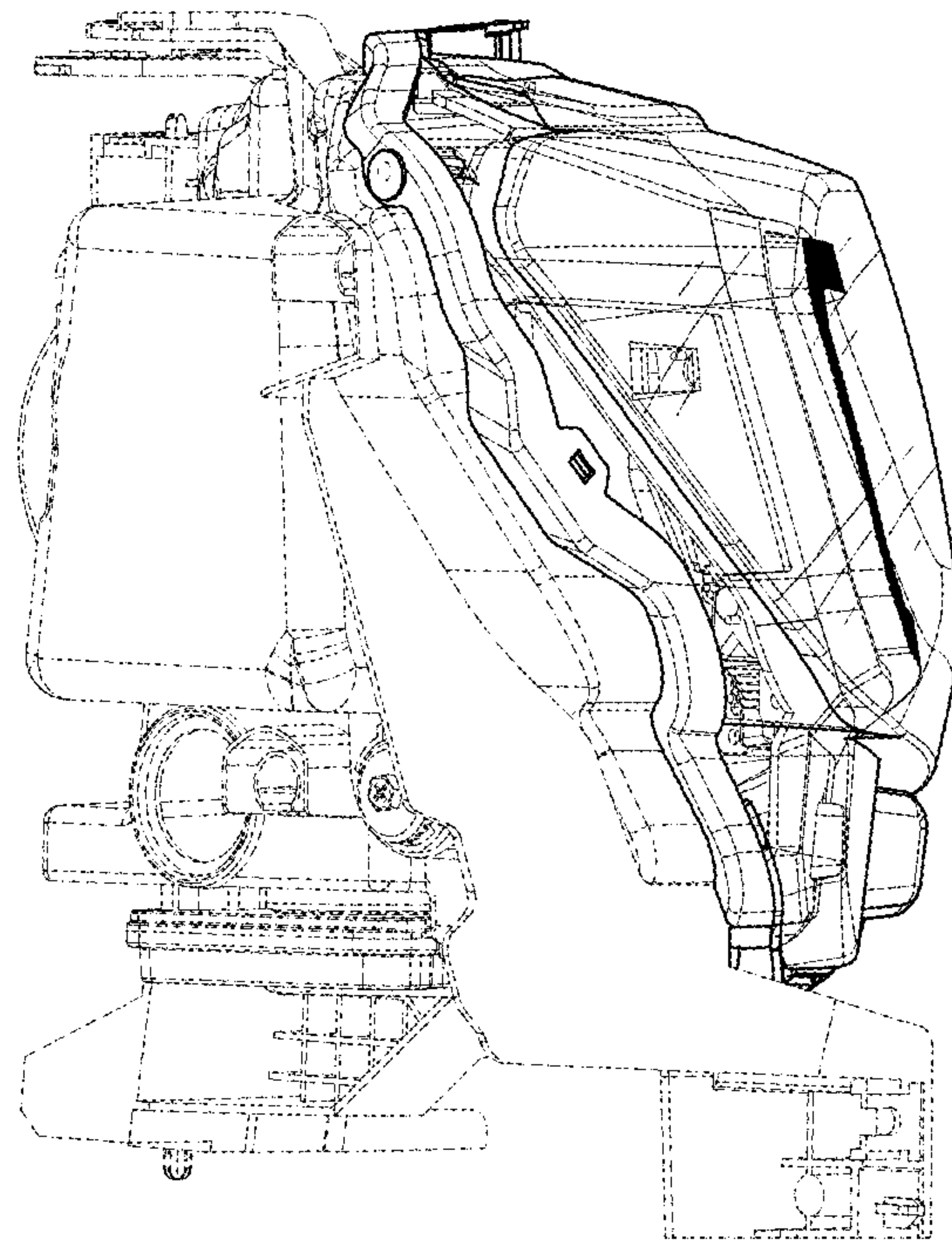

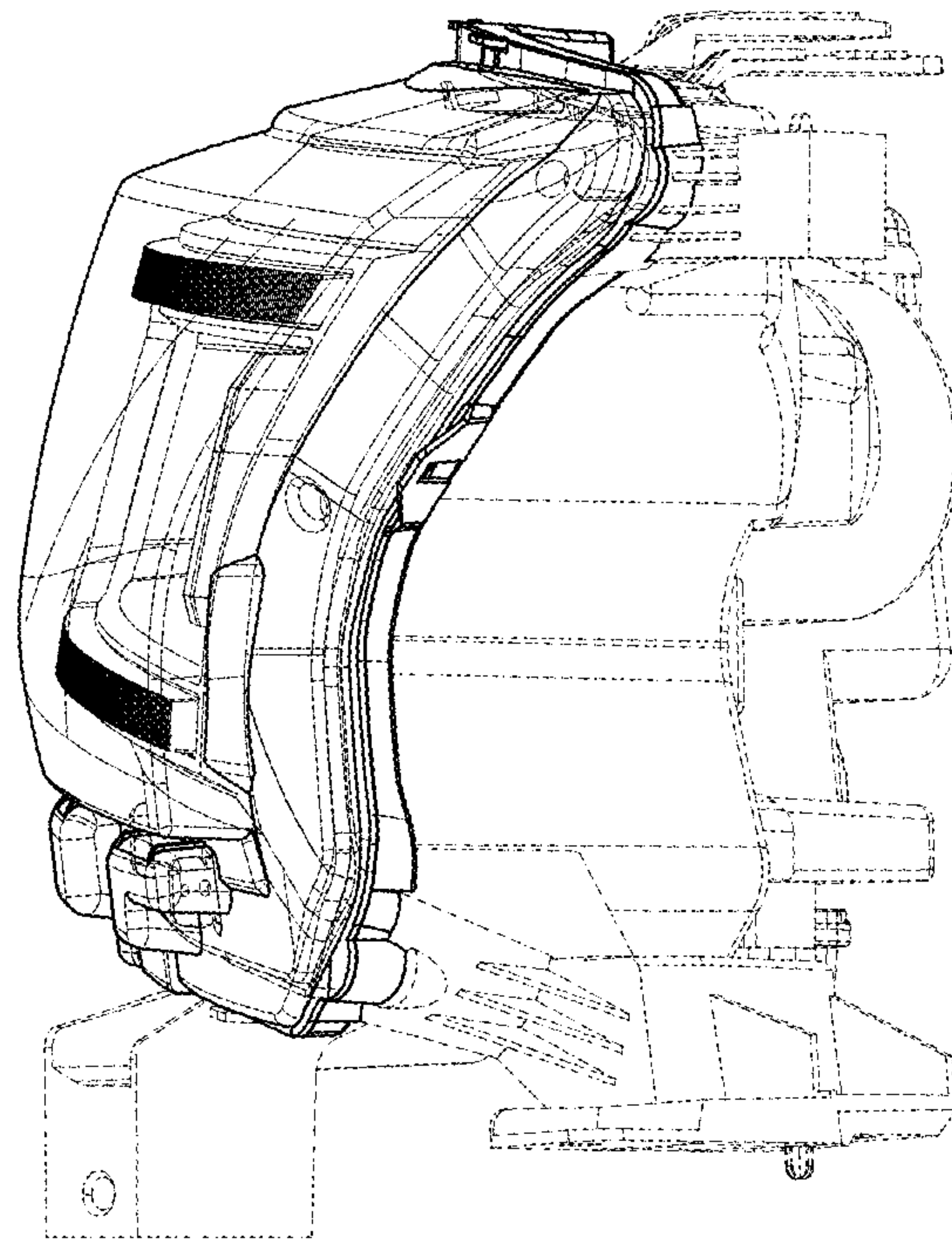

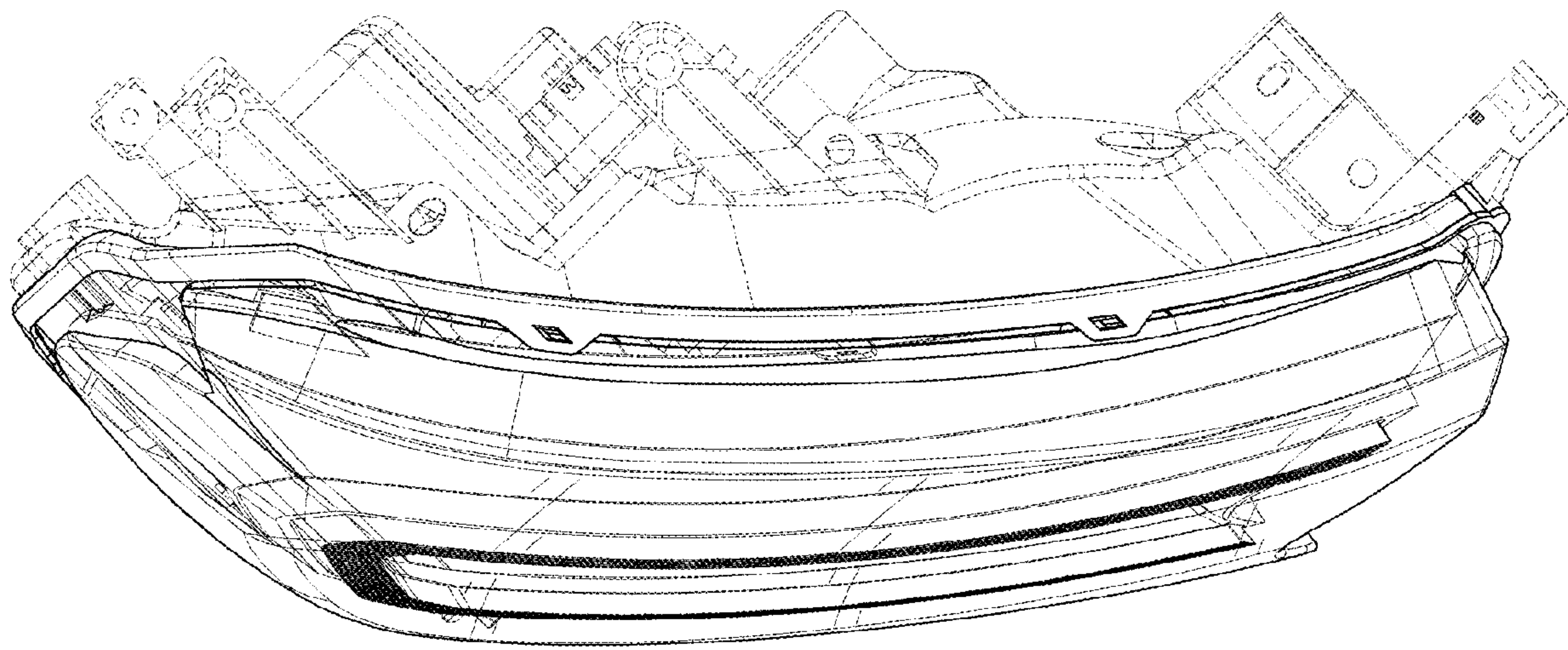

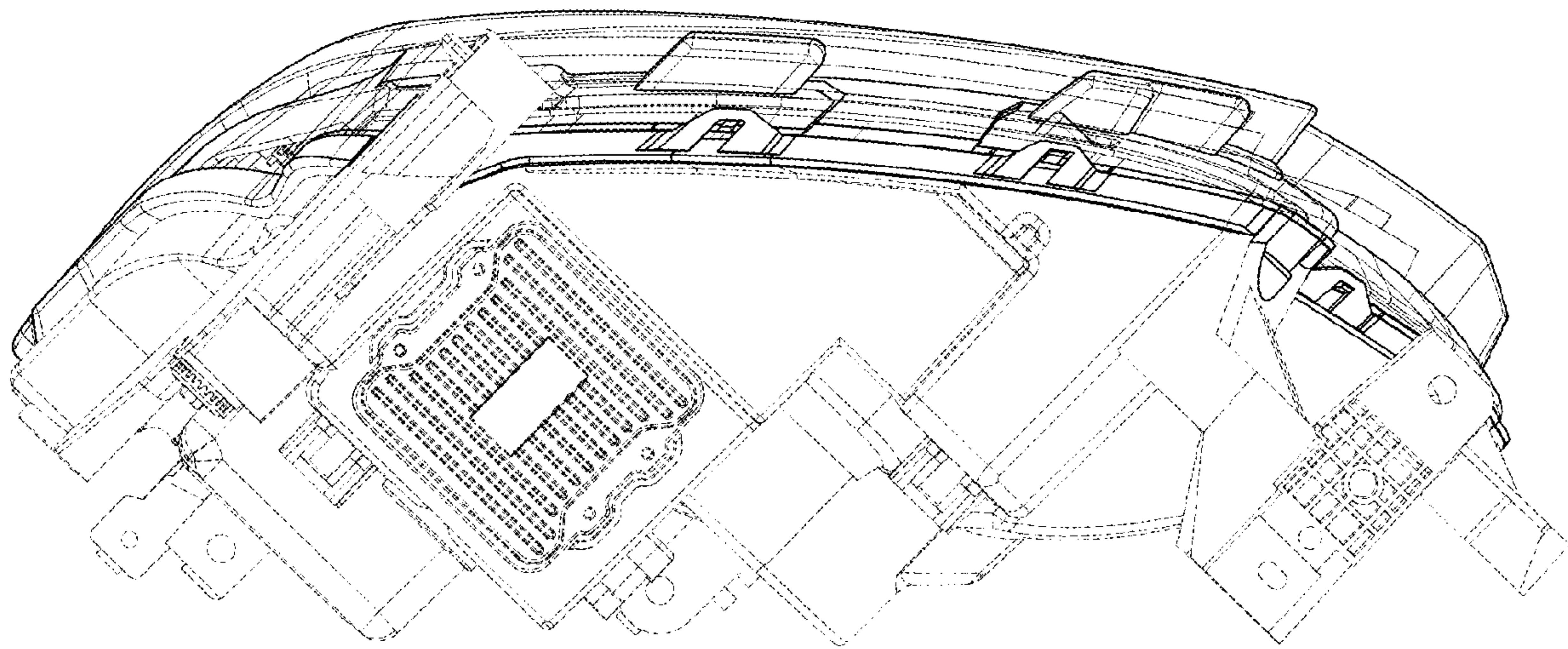

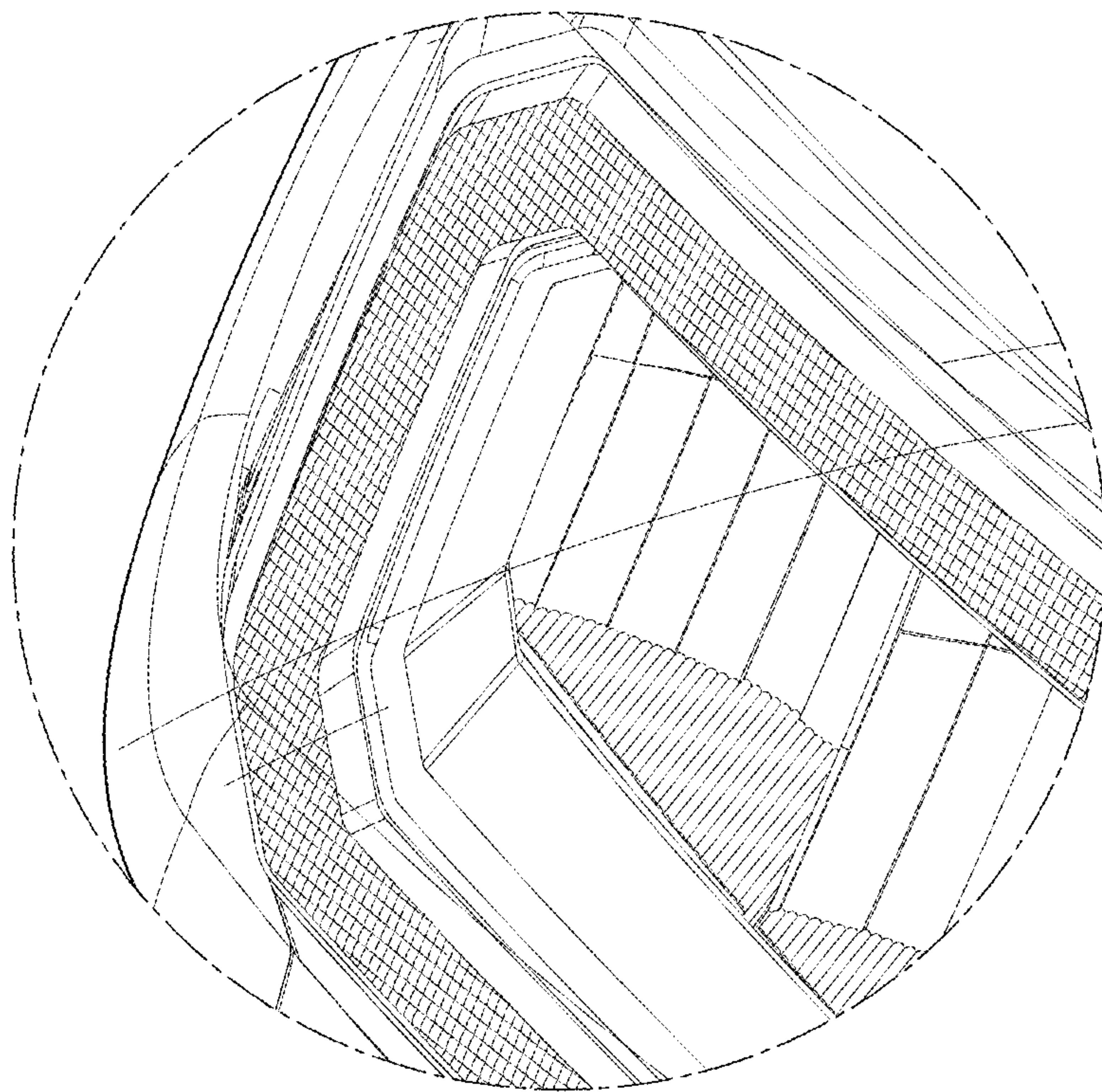
