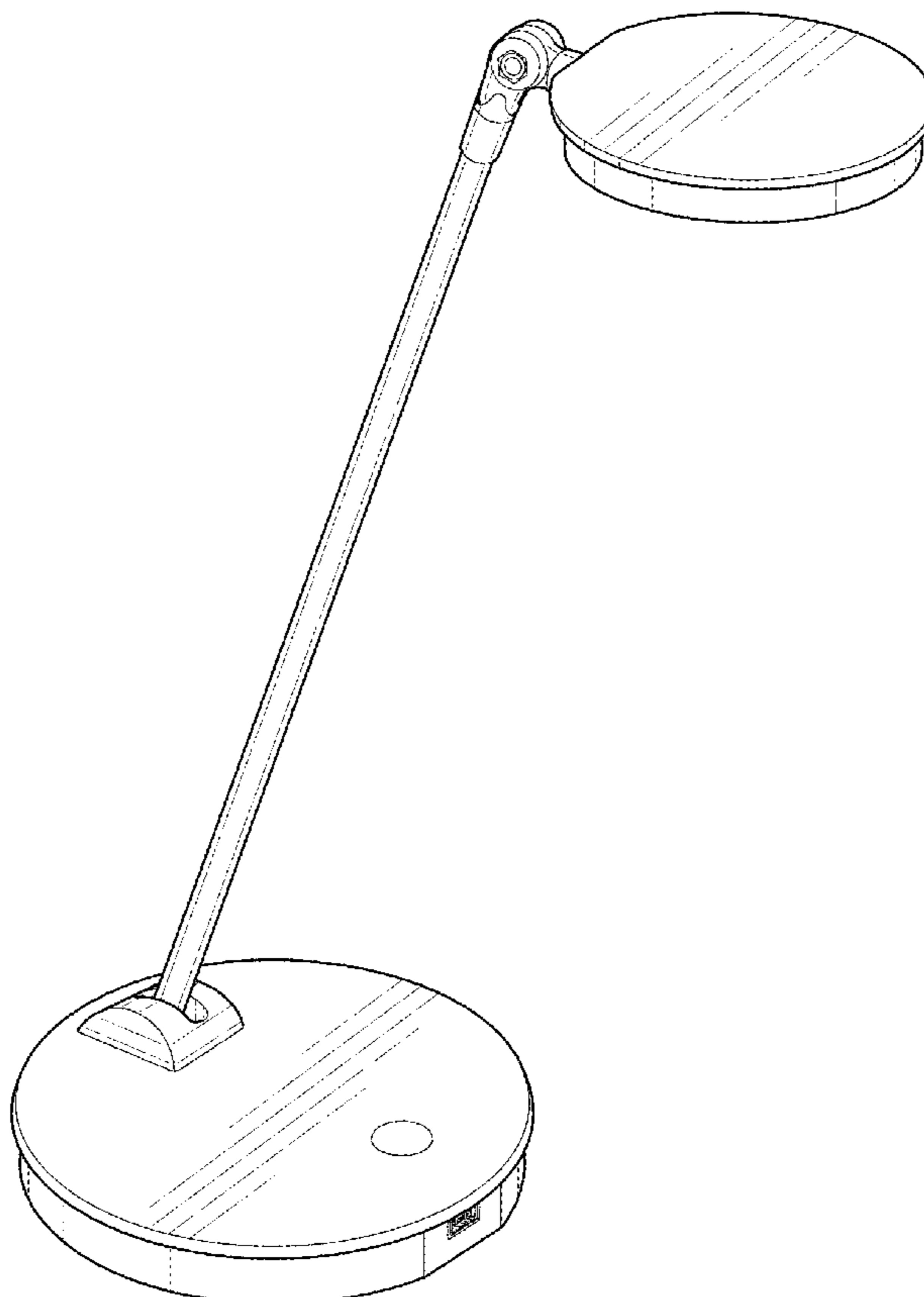
The new and ornamental design for a task light, as shown.

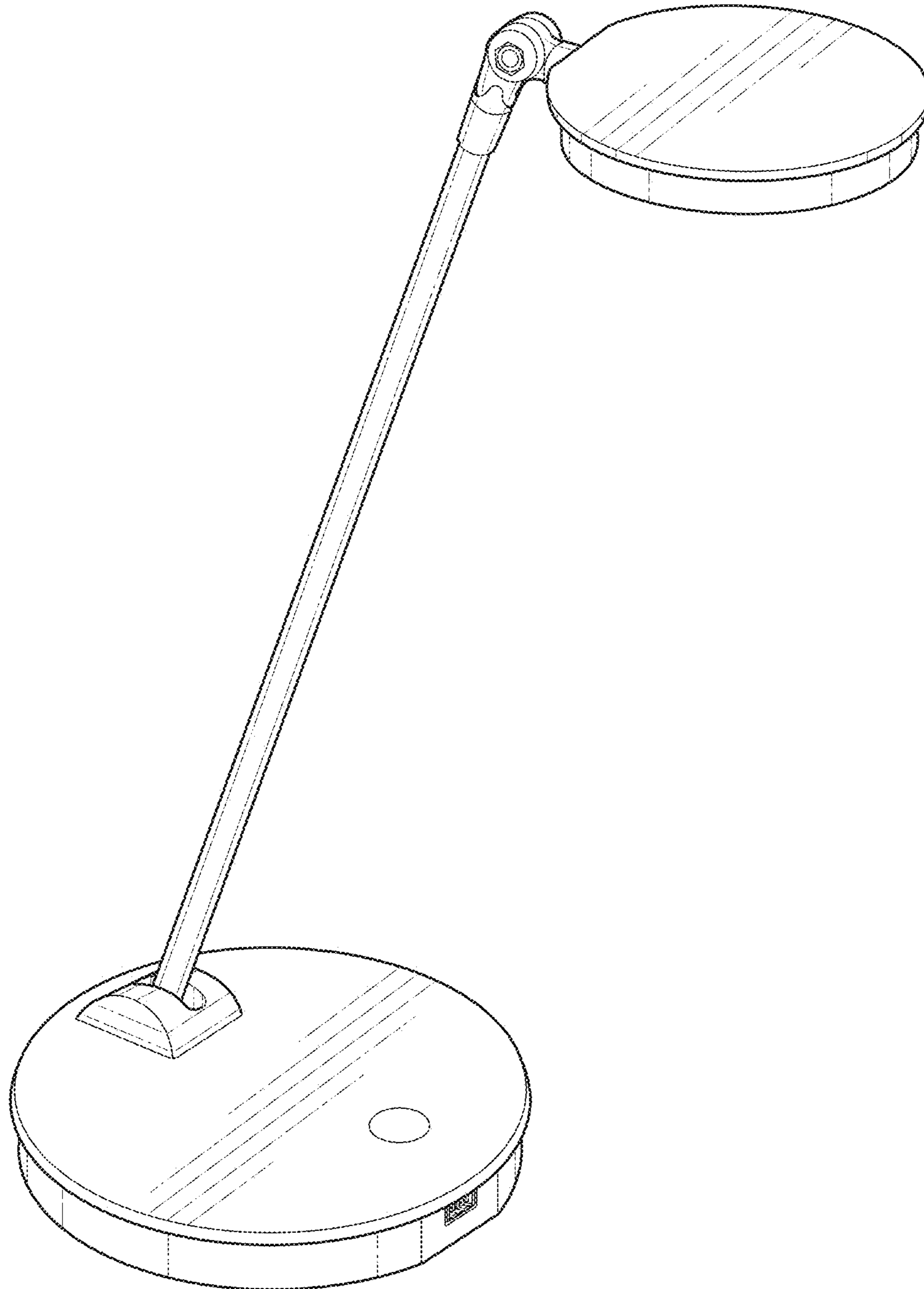

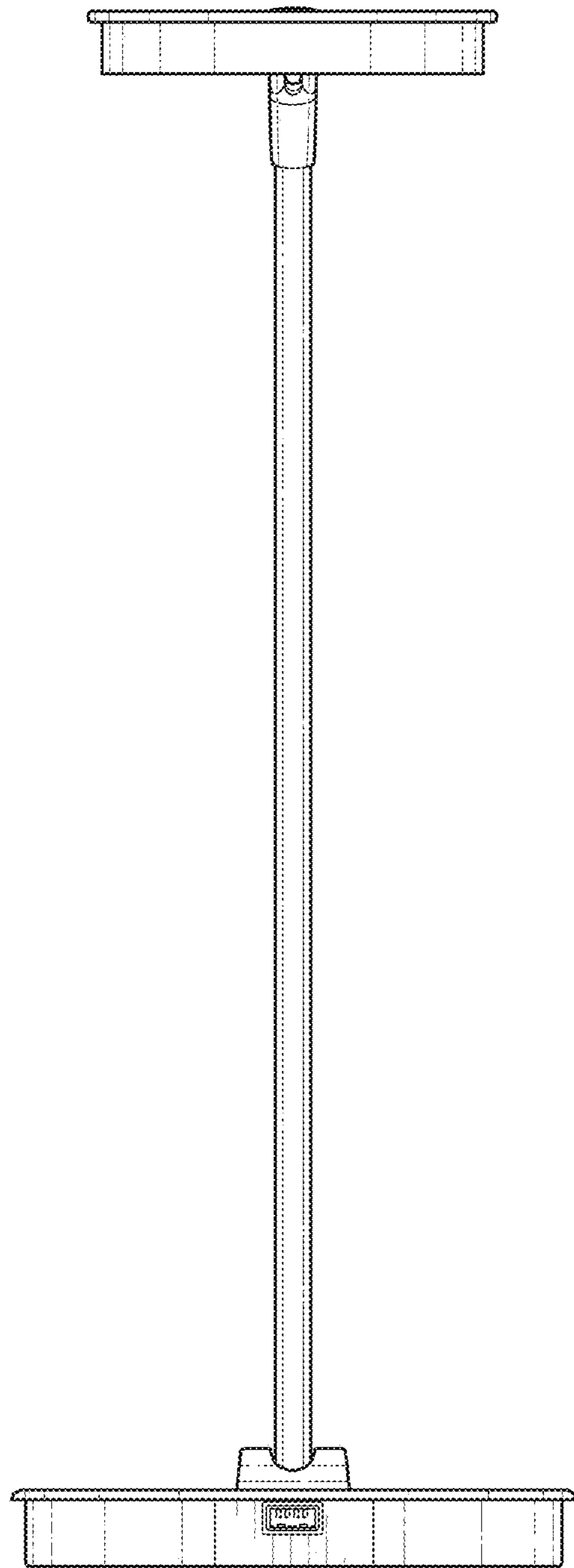

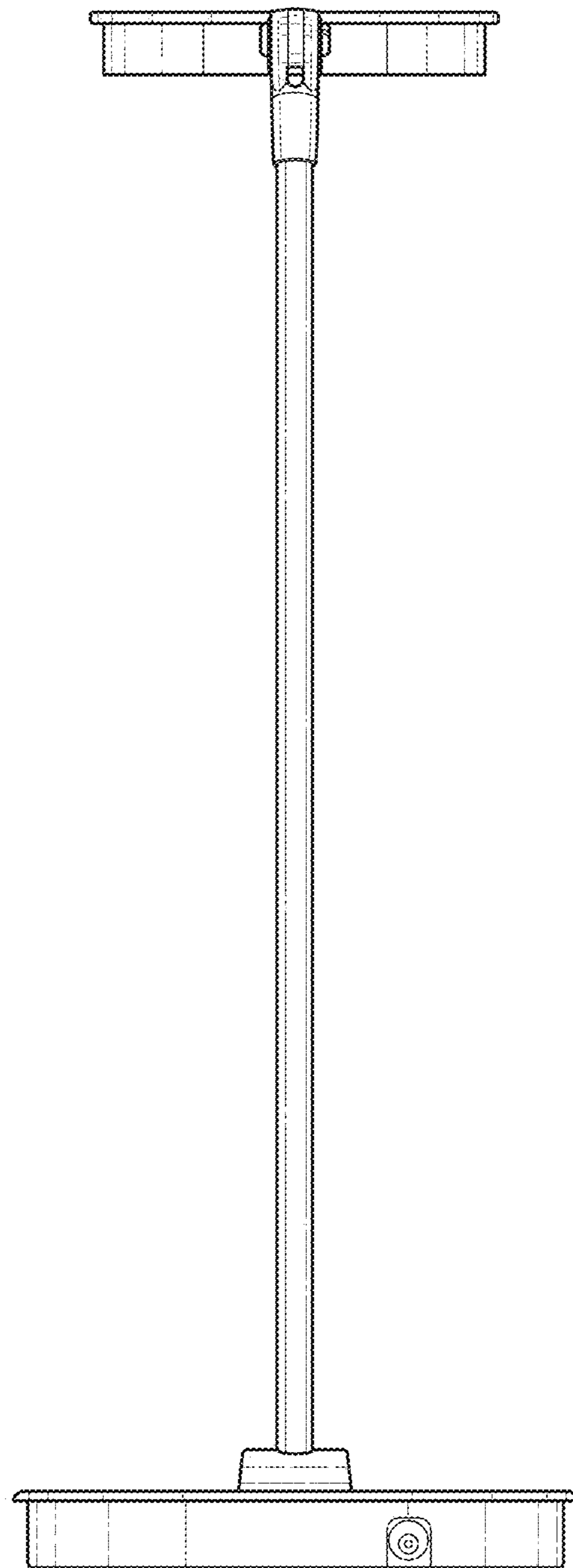

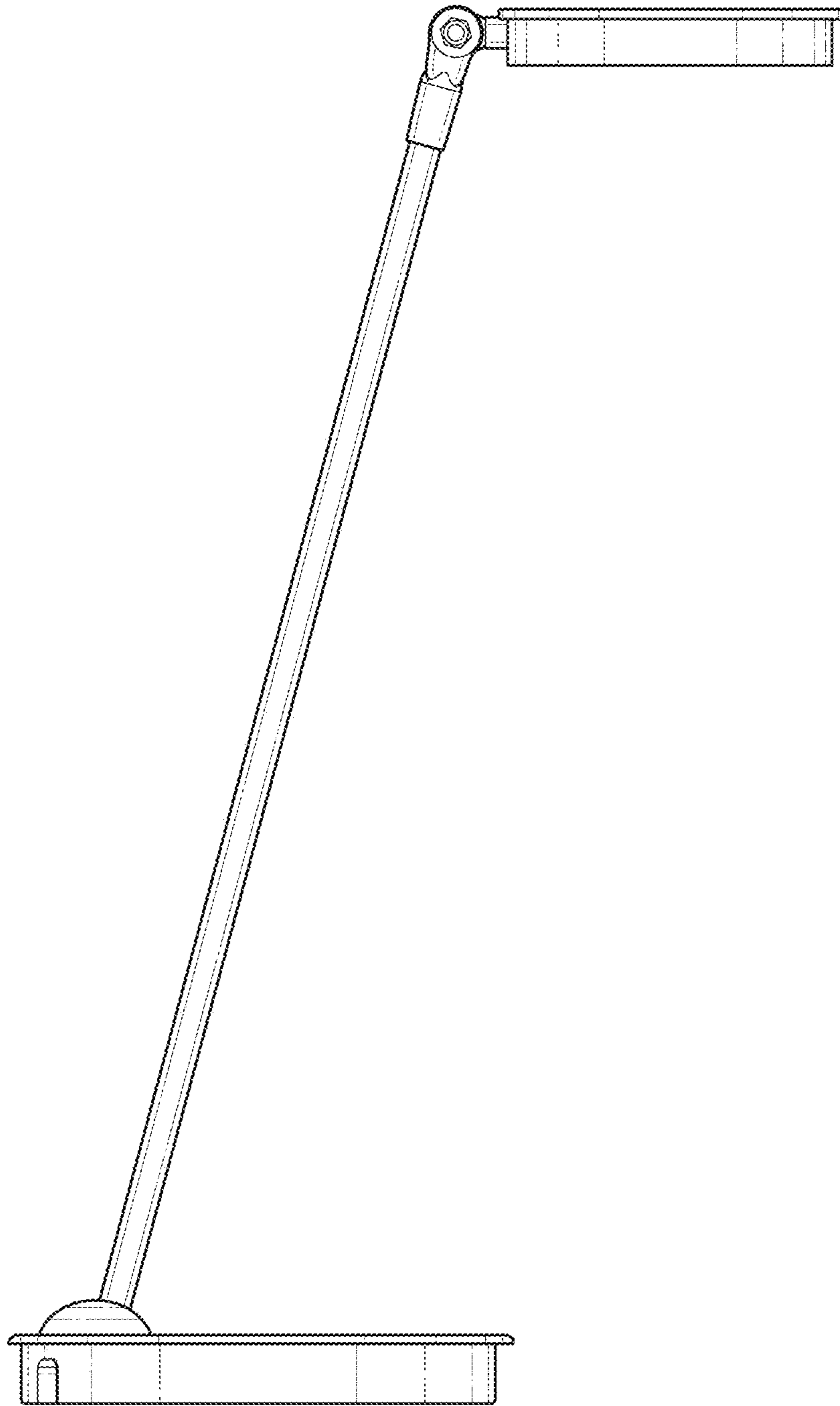

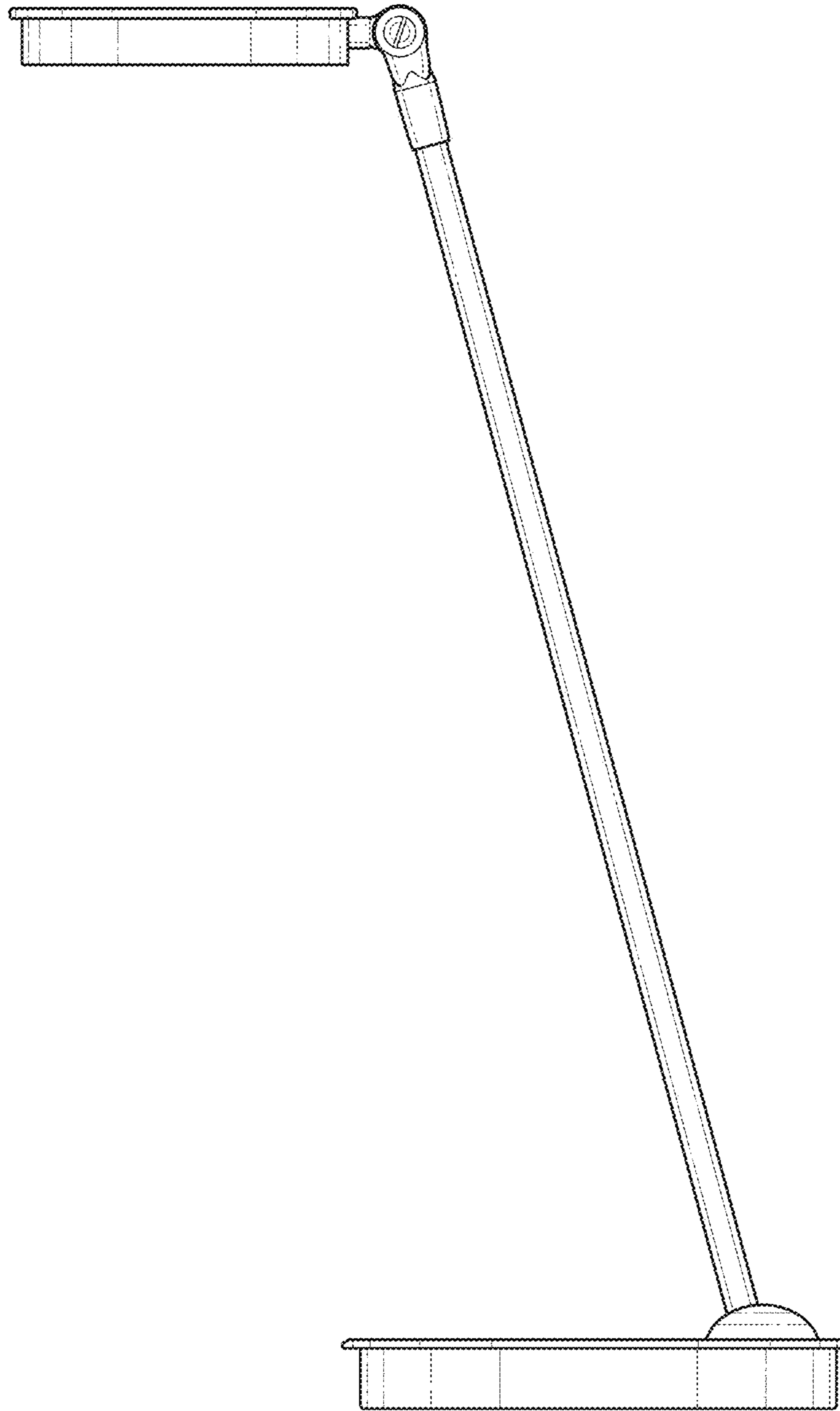

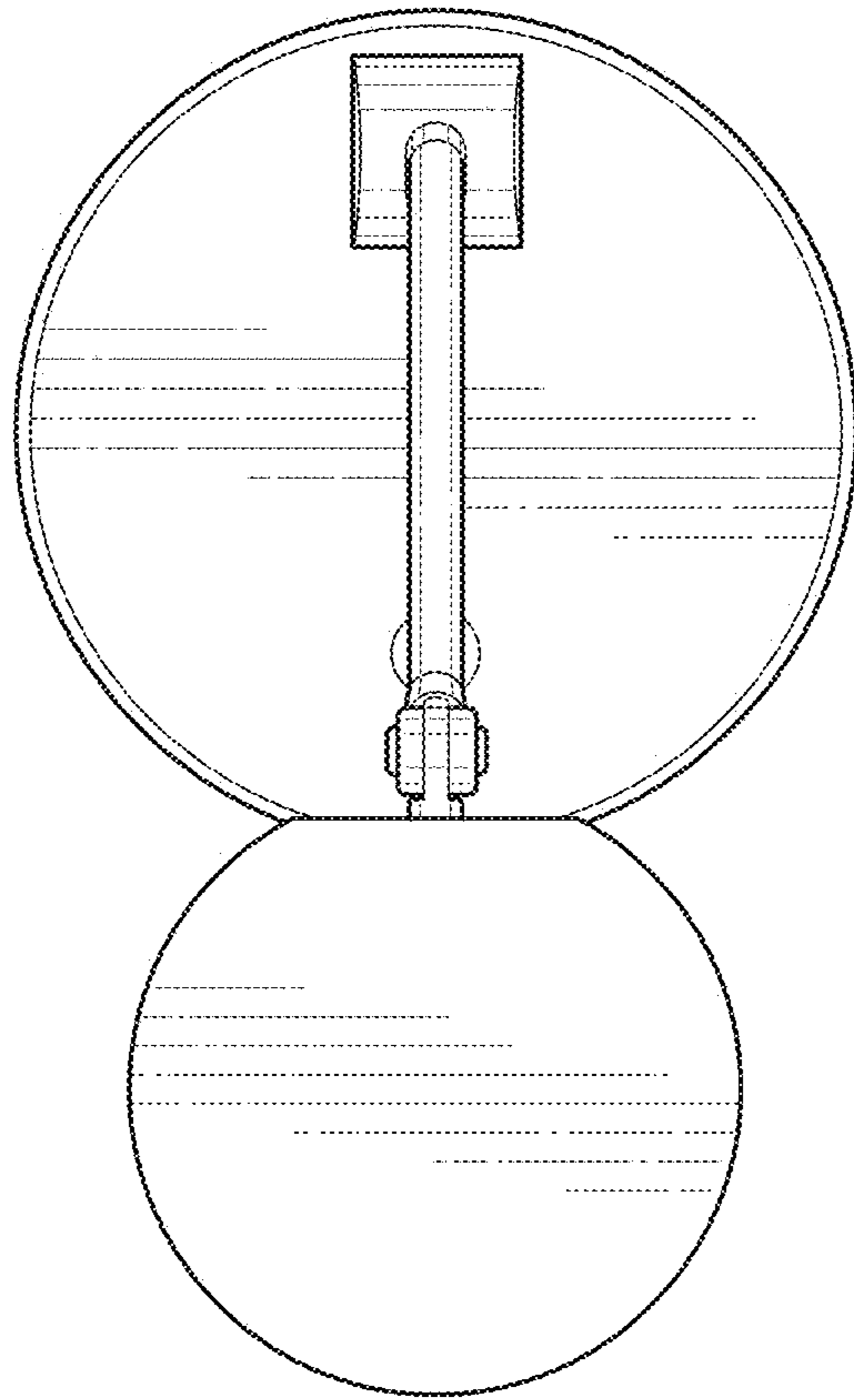

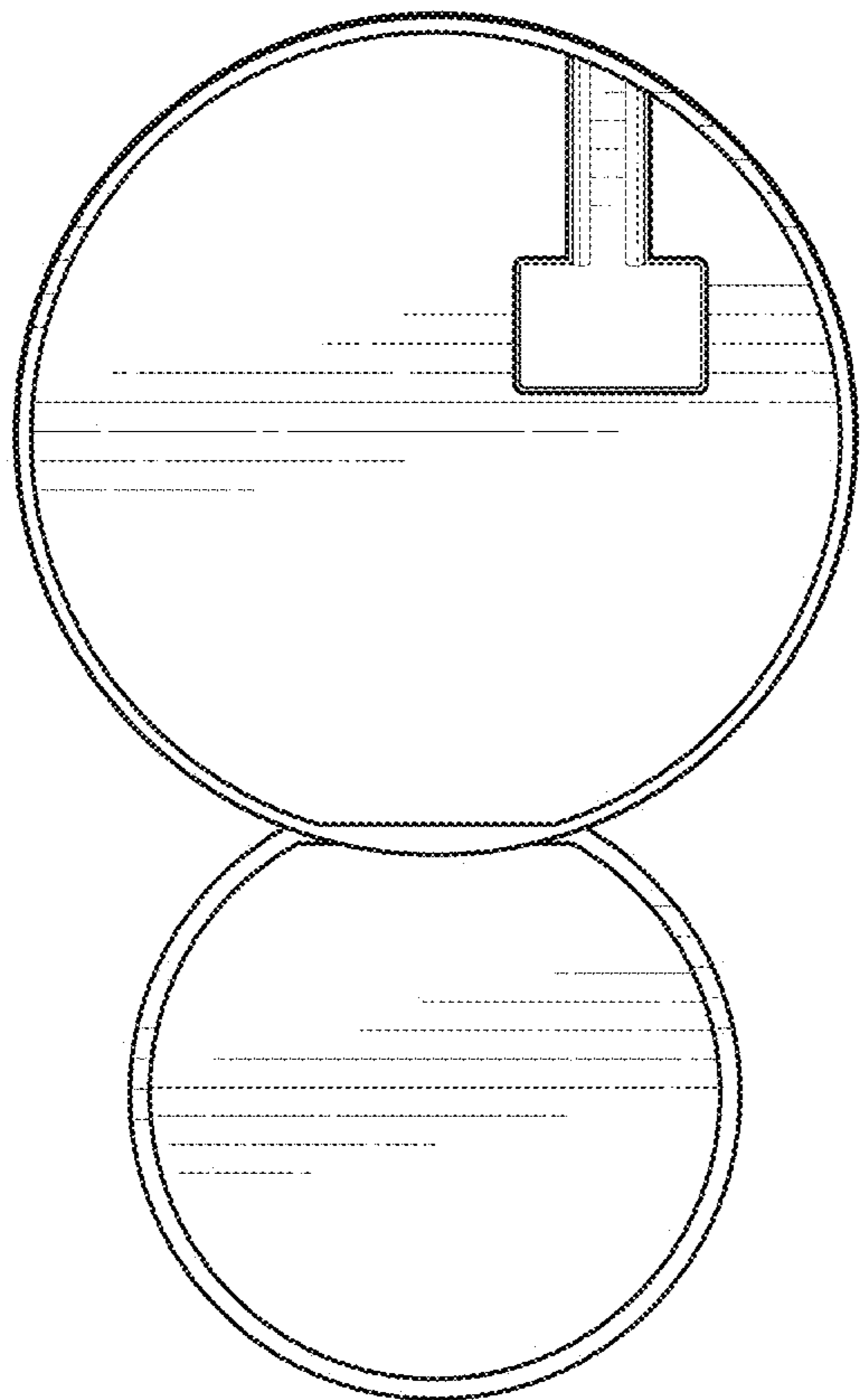
