and described.

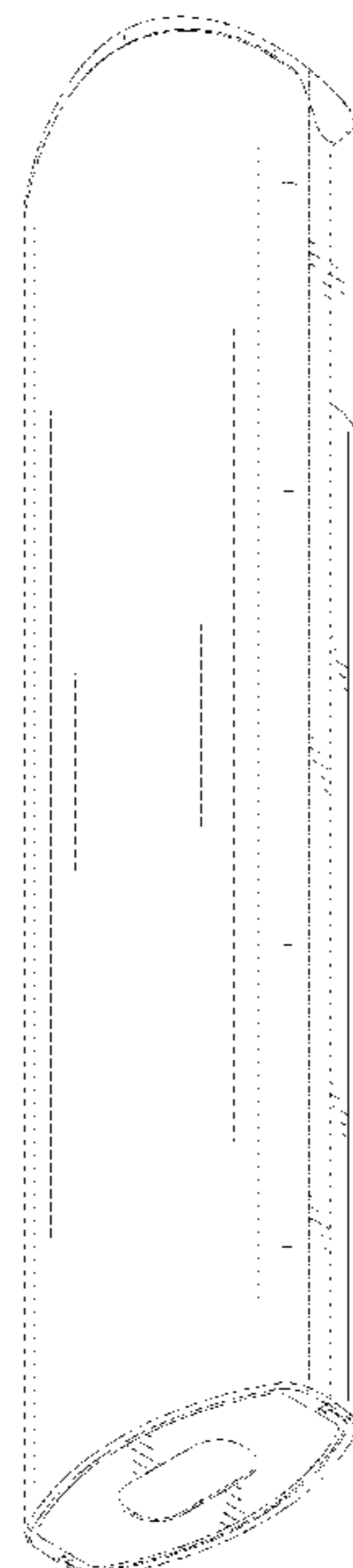
DESCRIPTION

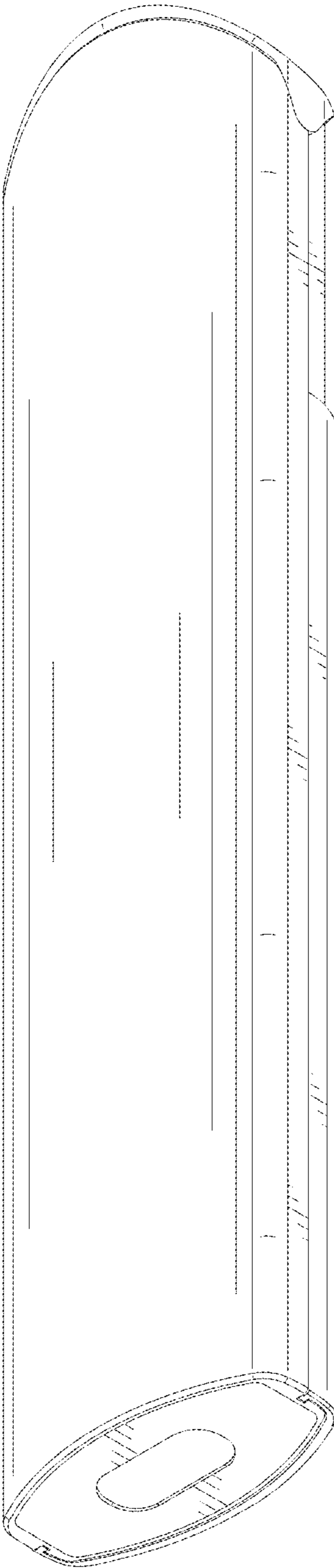

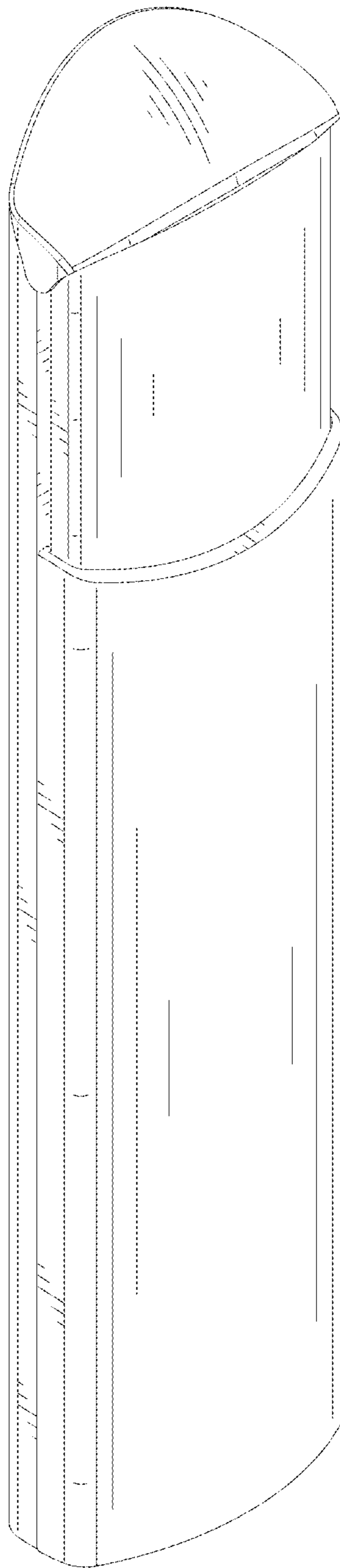

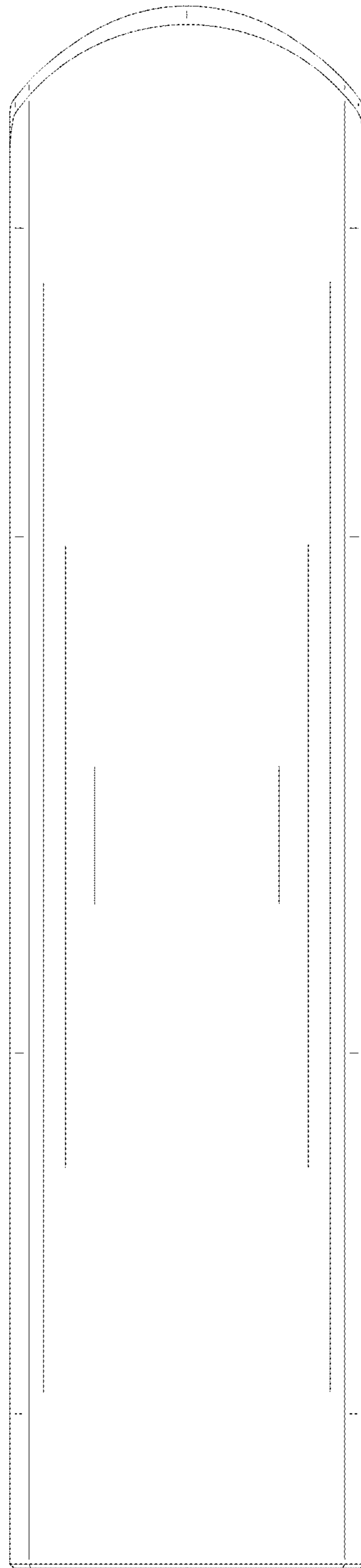

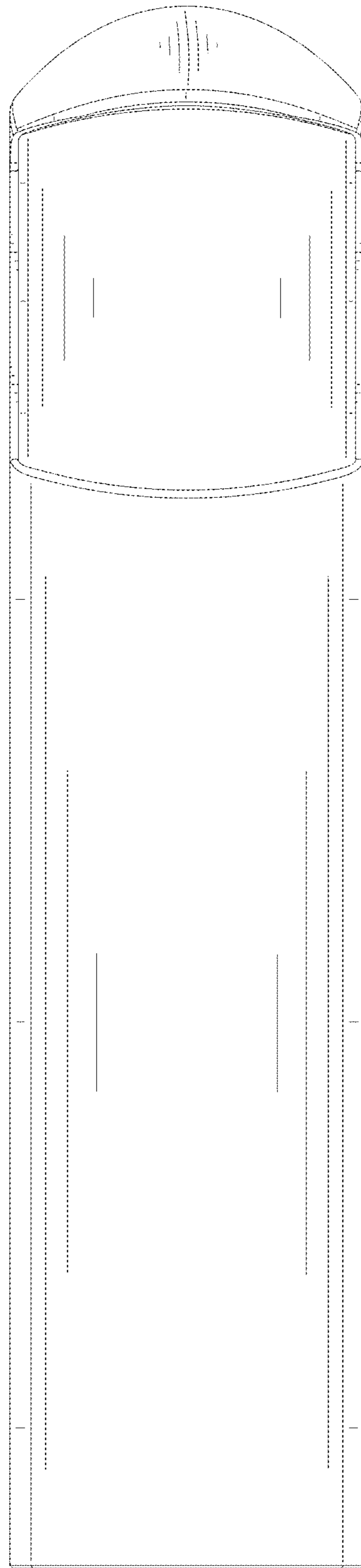

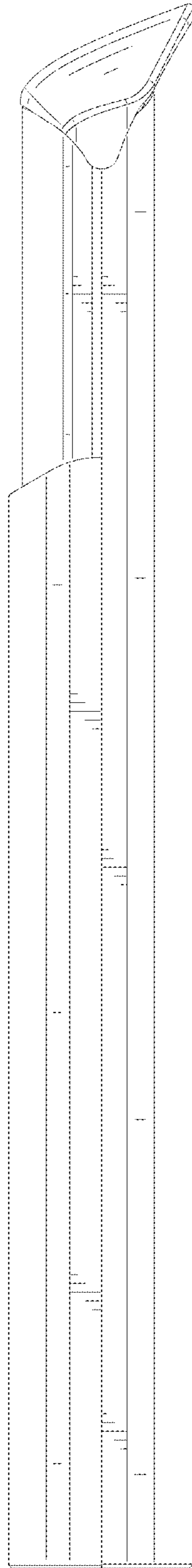

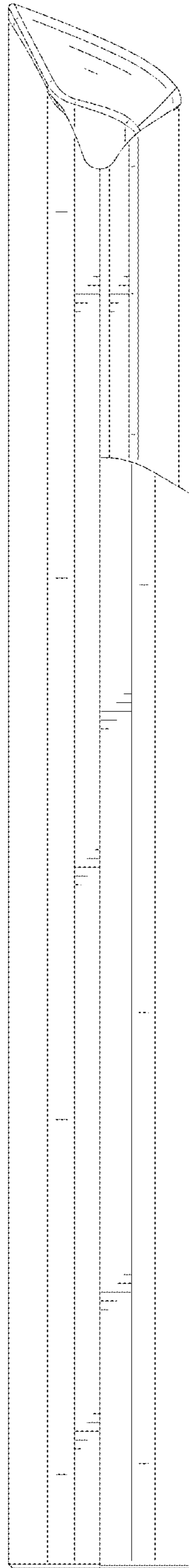

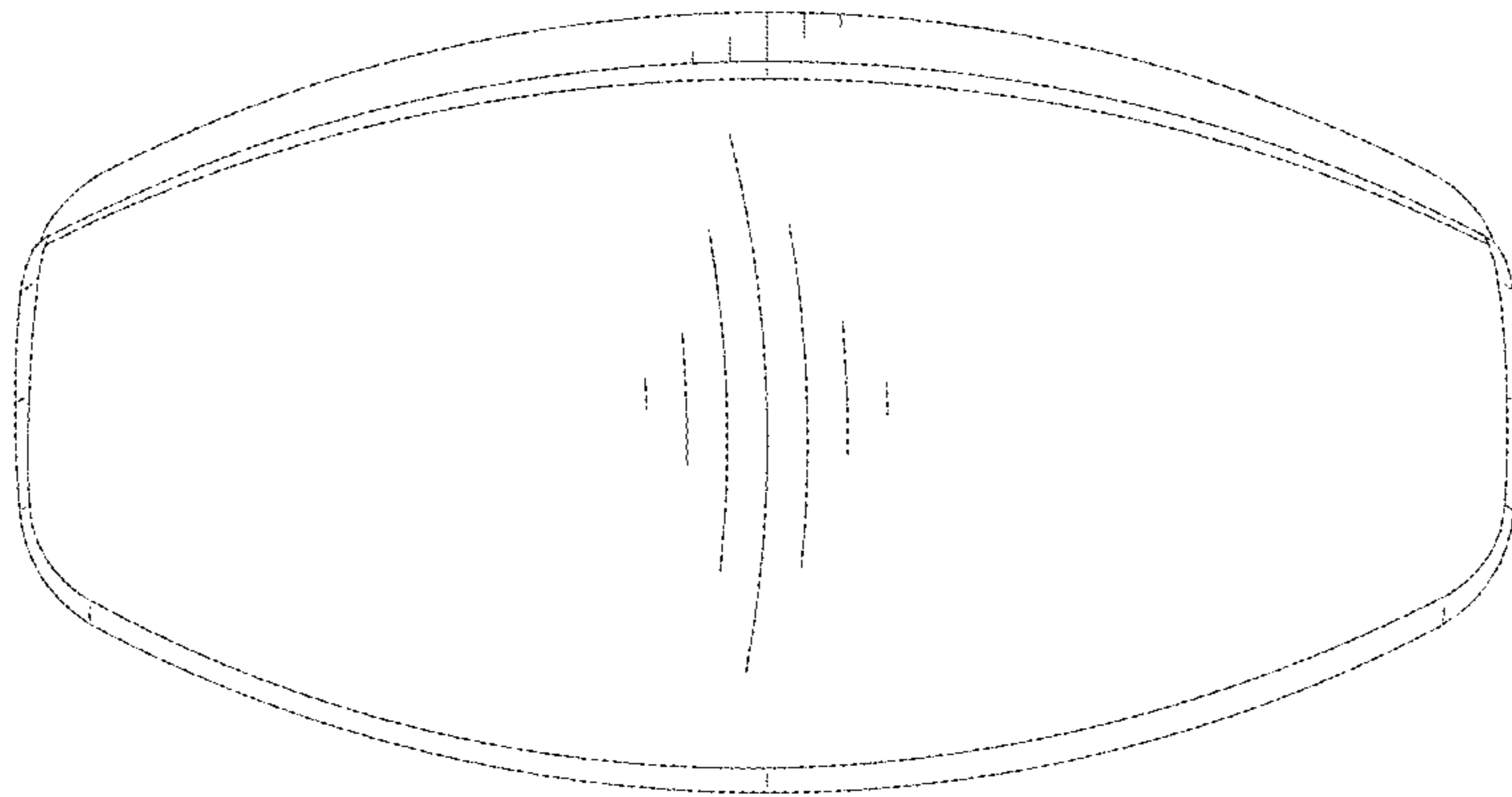

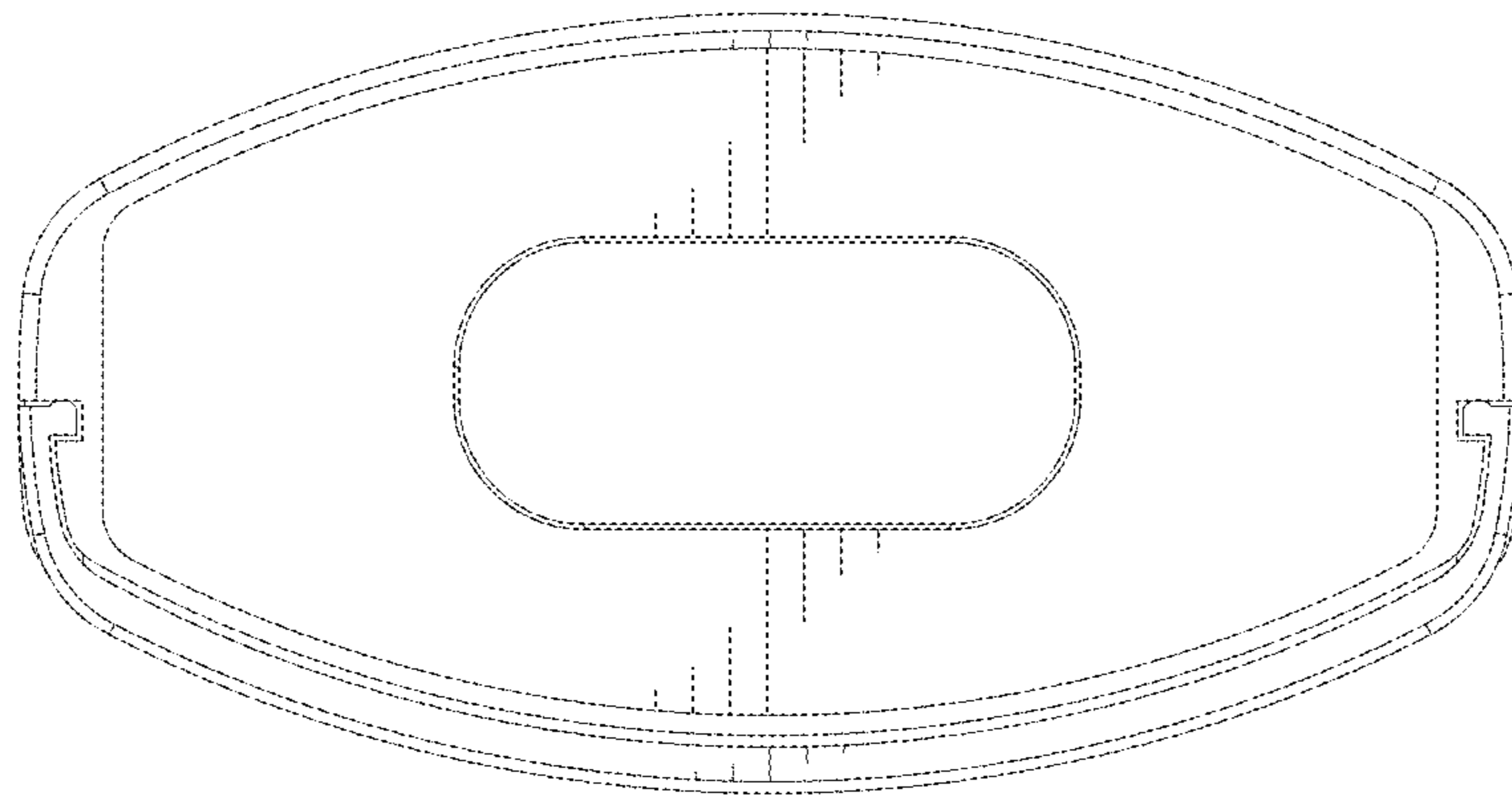

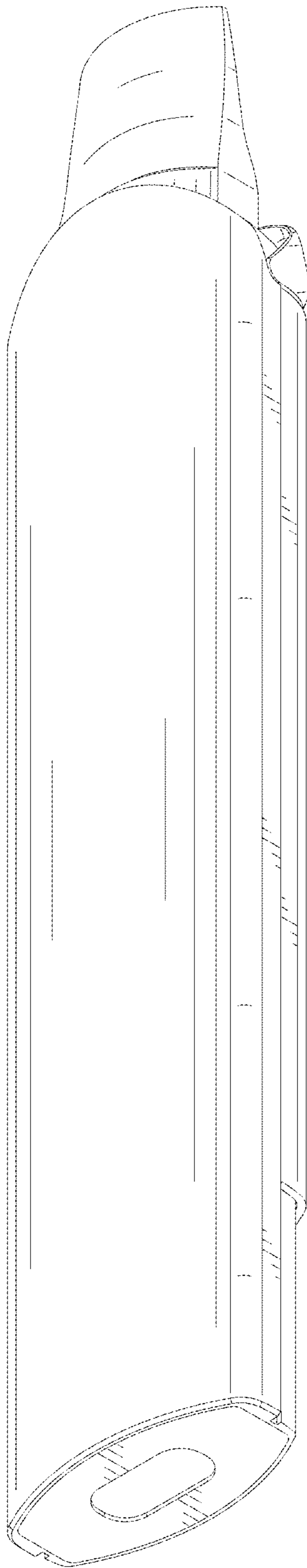

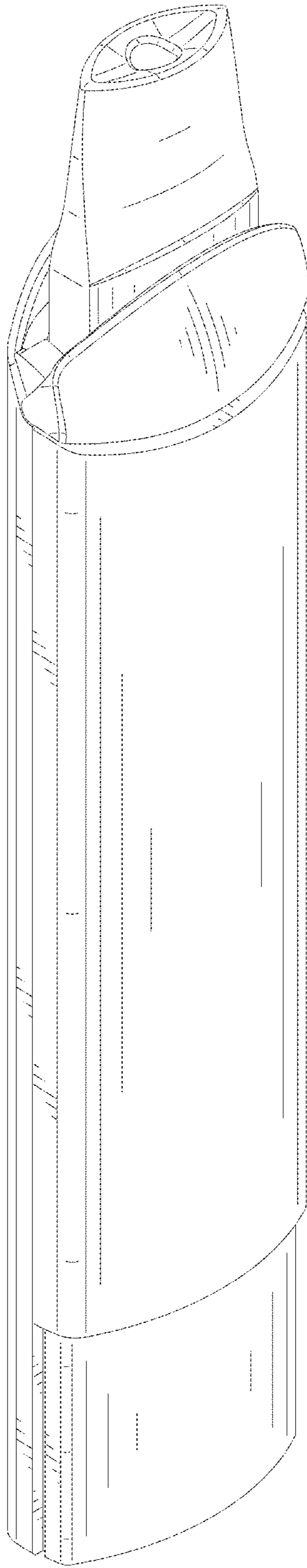

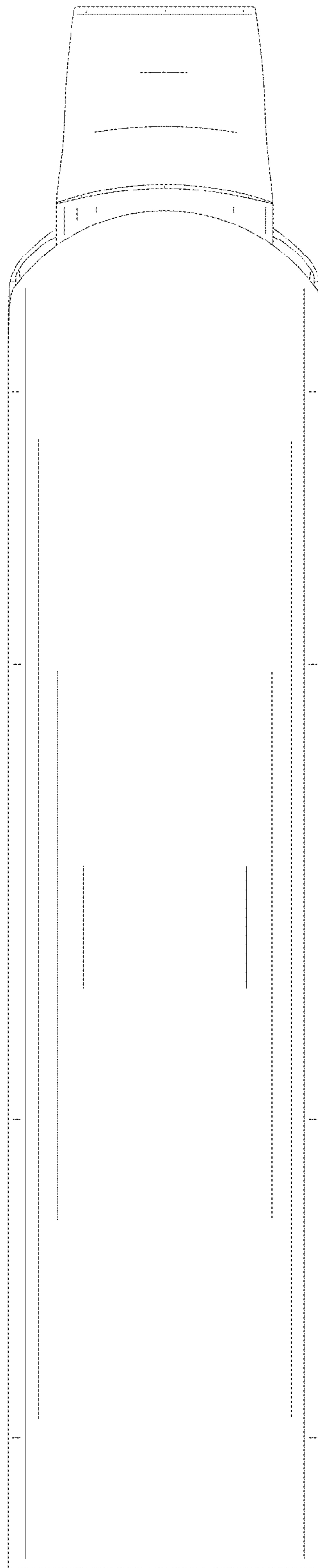

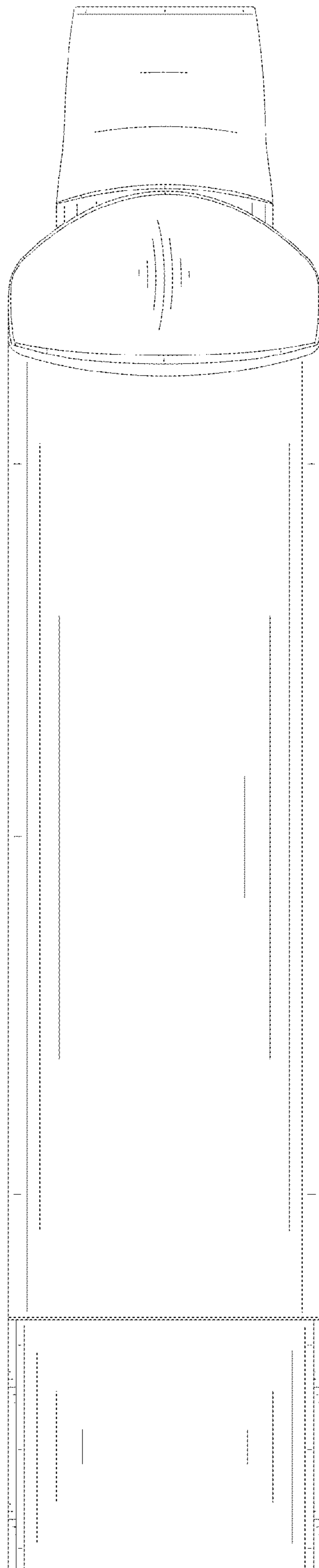

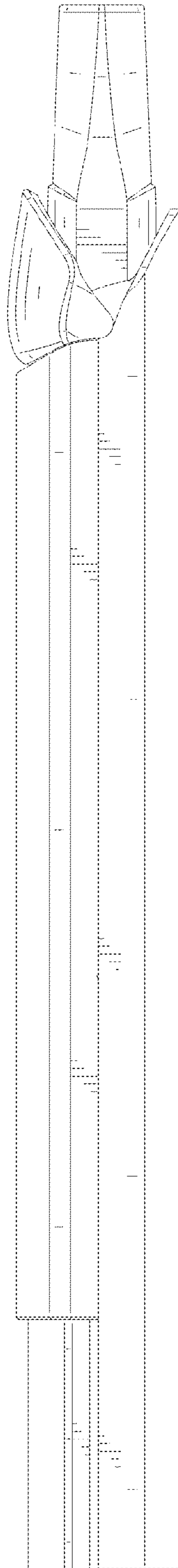

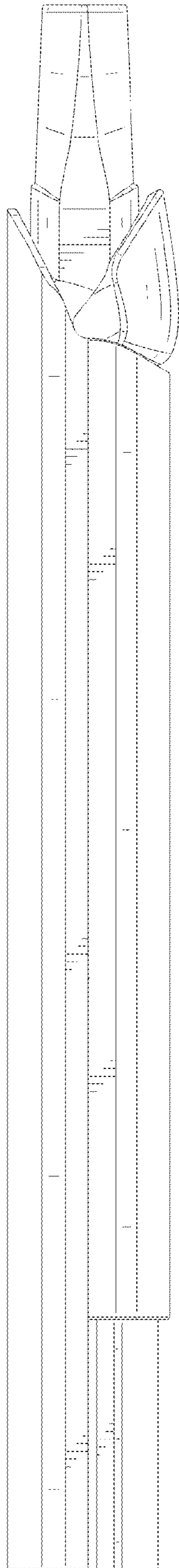

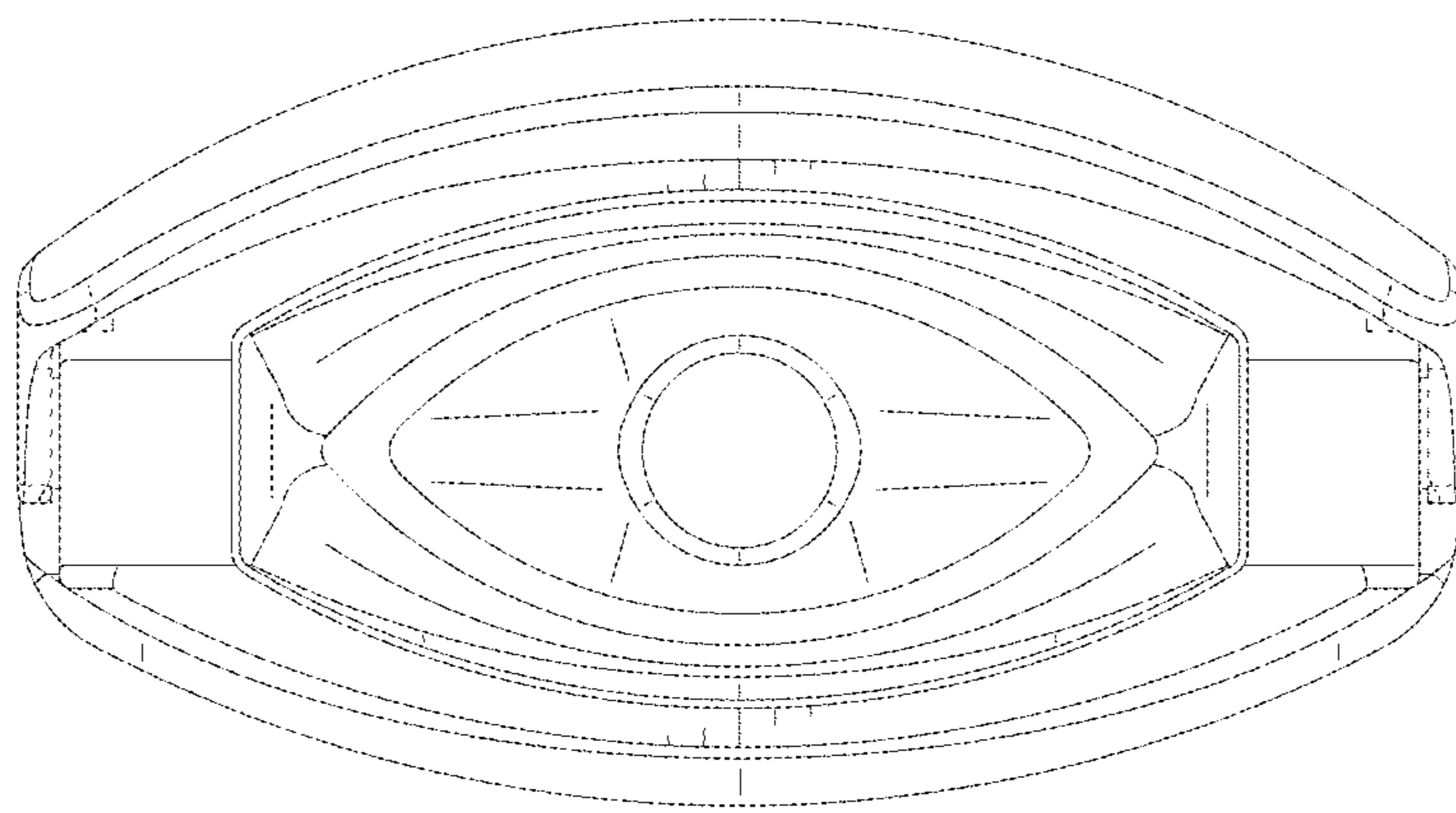

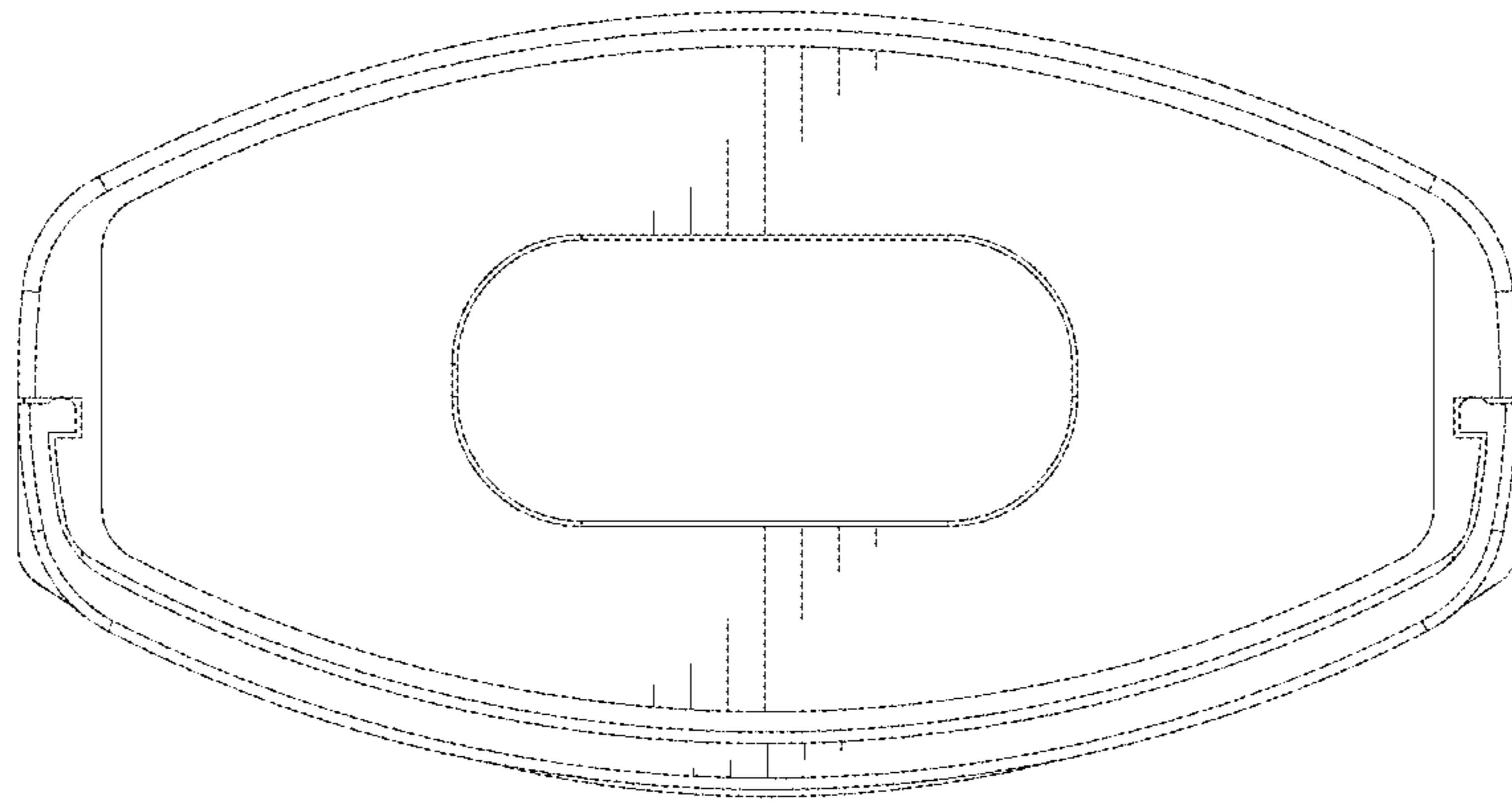
