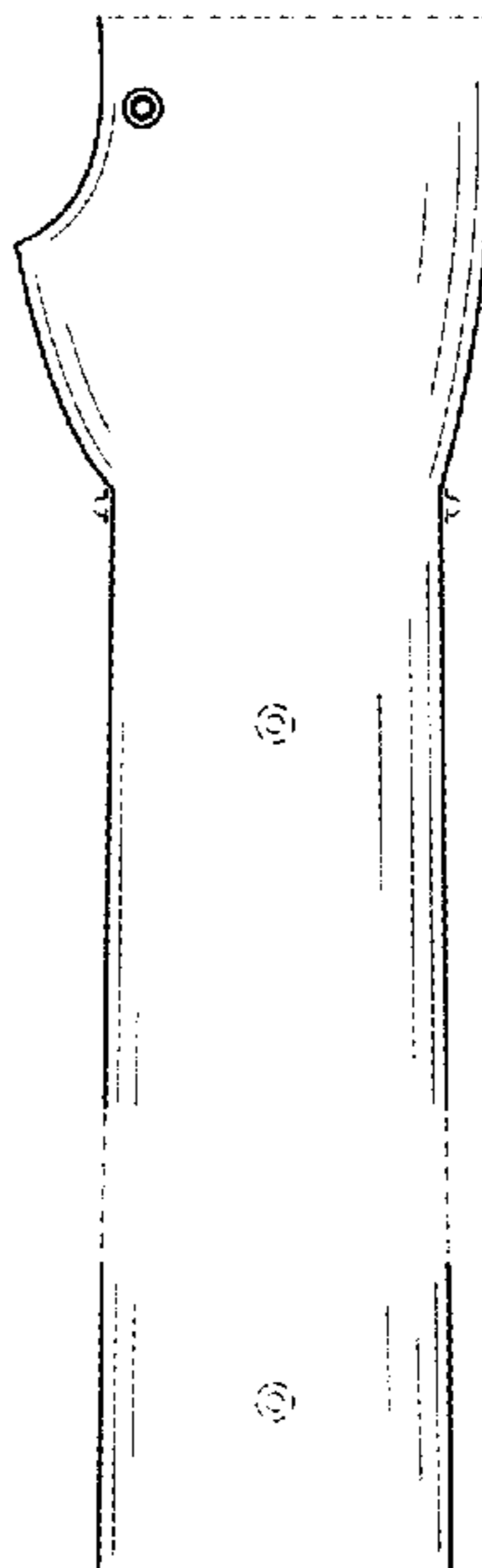
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom view of a utility glove, according to the present design;

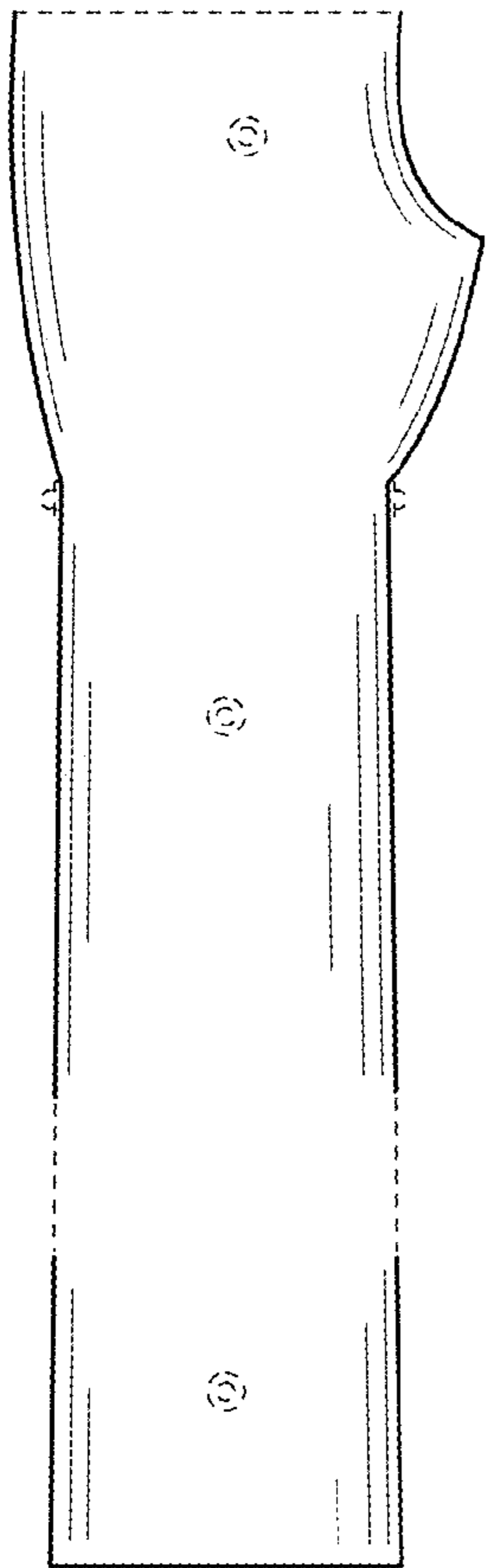

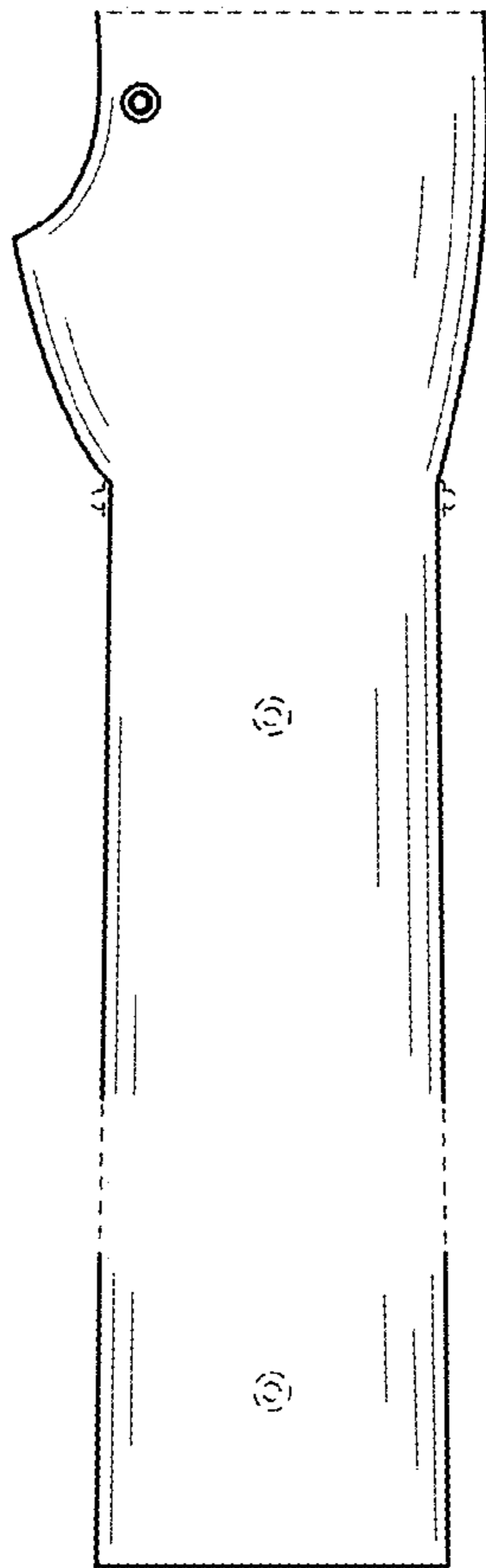

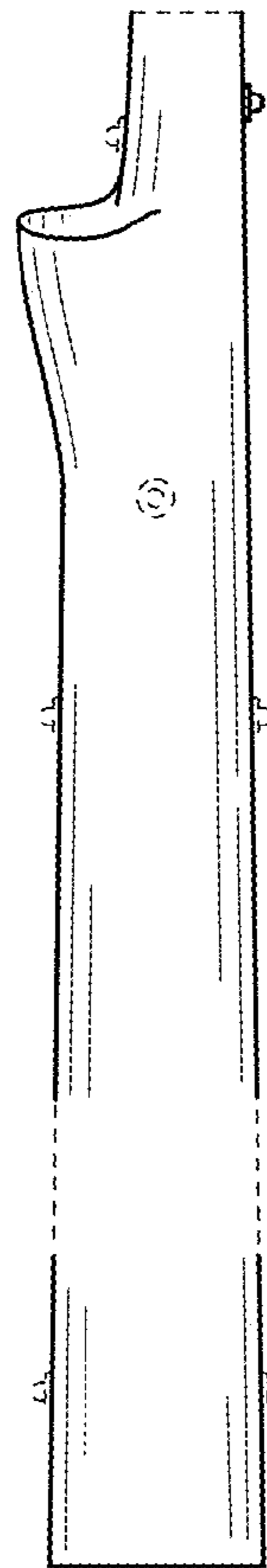

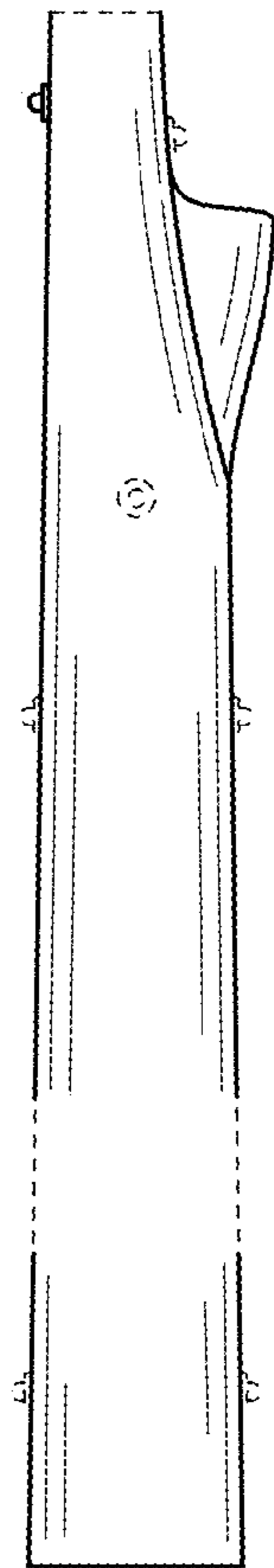
