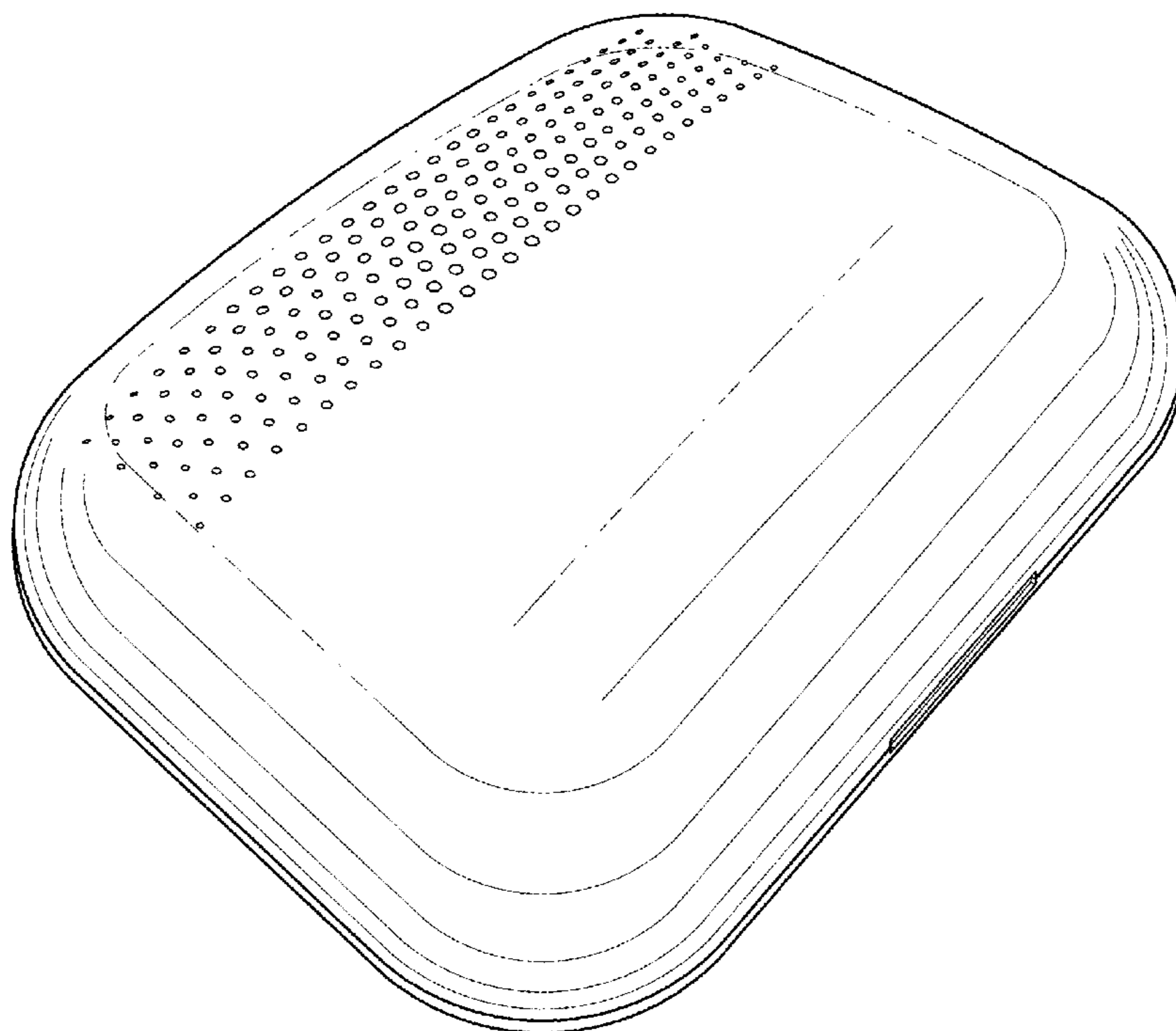
(57) **CLAIM**

I claim the ornamental design for a facial brush case, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a facial brush case. FIG. 2 is a top view of the facial brush case of FIG. 1. FIG. 3 is a bottom view of the facial brush case of FIG. 1. FIG. 4 is a front view of the facial brush case of FIG. 1. FIG. 5 is a rear view of the facial brush case of FIG. 1. FIG. 6 is a side view of the right side of the facial brush case of FIG. 1. FIG. 7 is a side view of the left side of the facial brush case of FIG. 1. FIG. 8 is an exploded rear perspective view of the facial brush case of FIG. 1. FIG. 9 is a top view of the lower portion of the facial brush case of FIG. 1. FIG. 10 is a rear view of the view lower portion of the facial brush case of FIG. 1. FIG. 11 is a front view of the lower portion of the facial brush case of FIG. 1. FIG. 12 is a side view of the right side of the lower portion of the facial brush case of FIG. 1; and, FIG. 13 is a side view of the left side of the lower portion of the facial brush case of FIG. 1. In the drawings, the broken lines depict portions of the facial brush case that form no part of the claimed design.

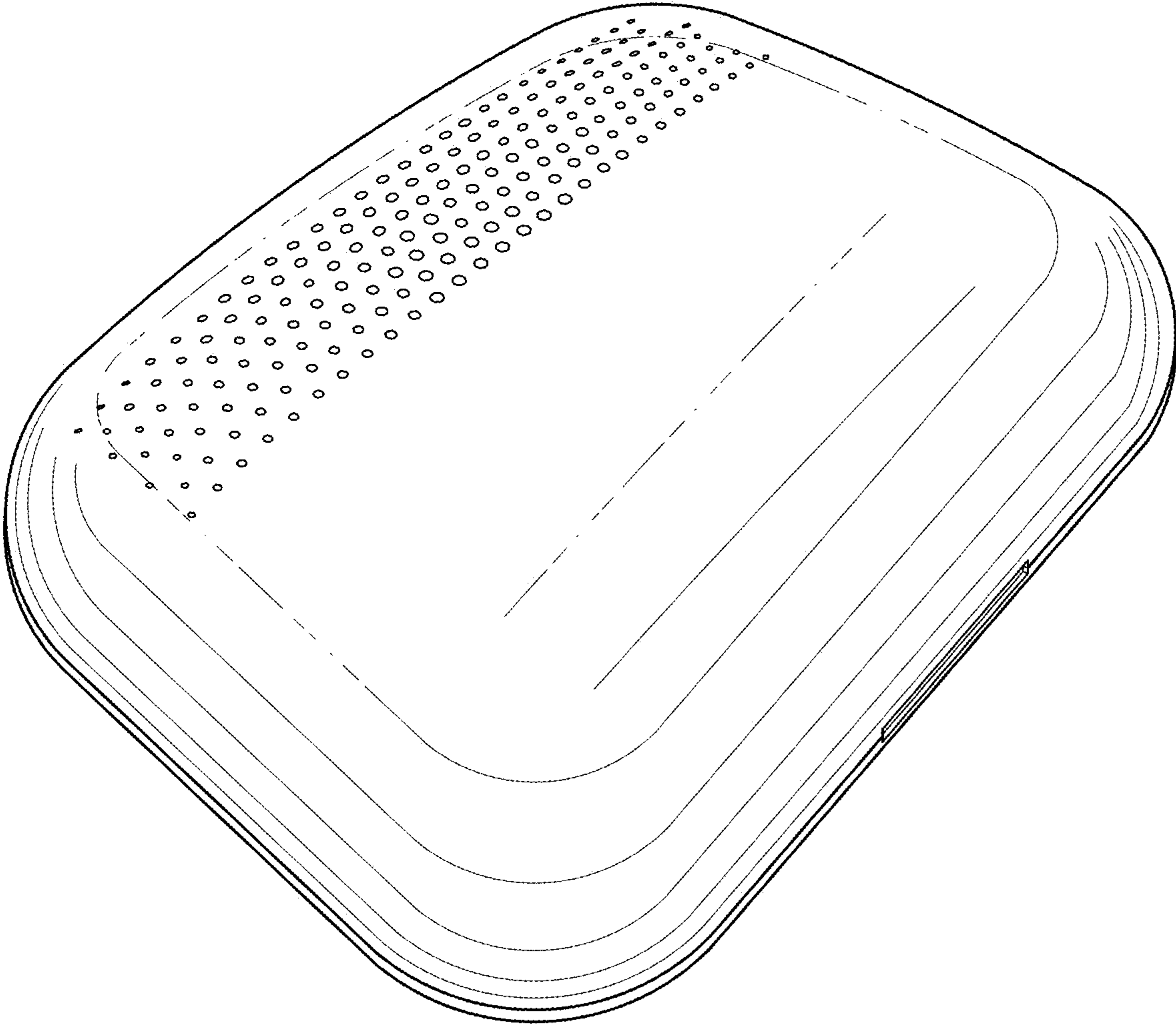

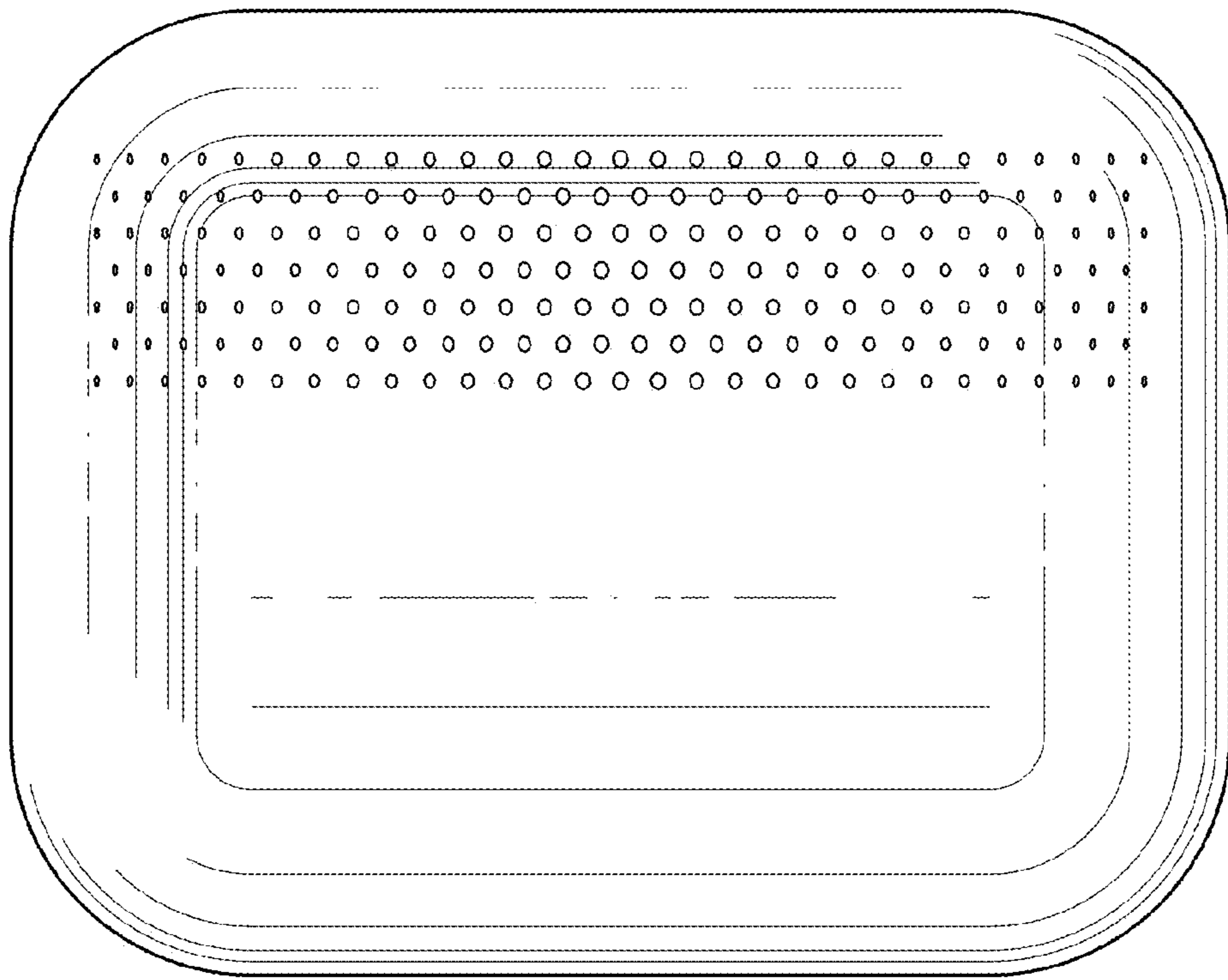

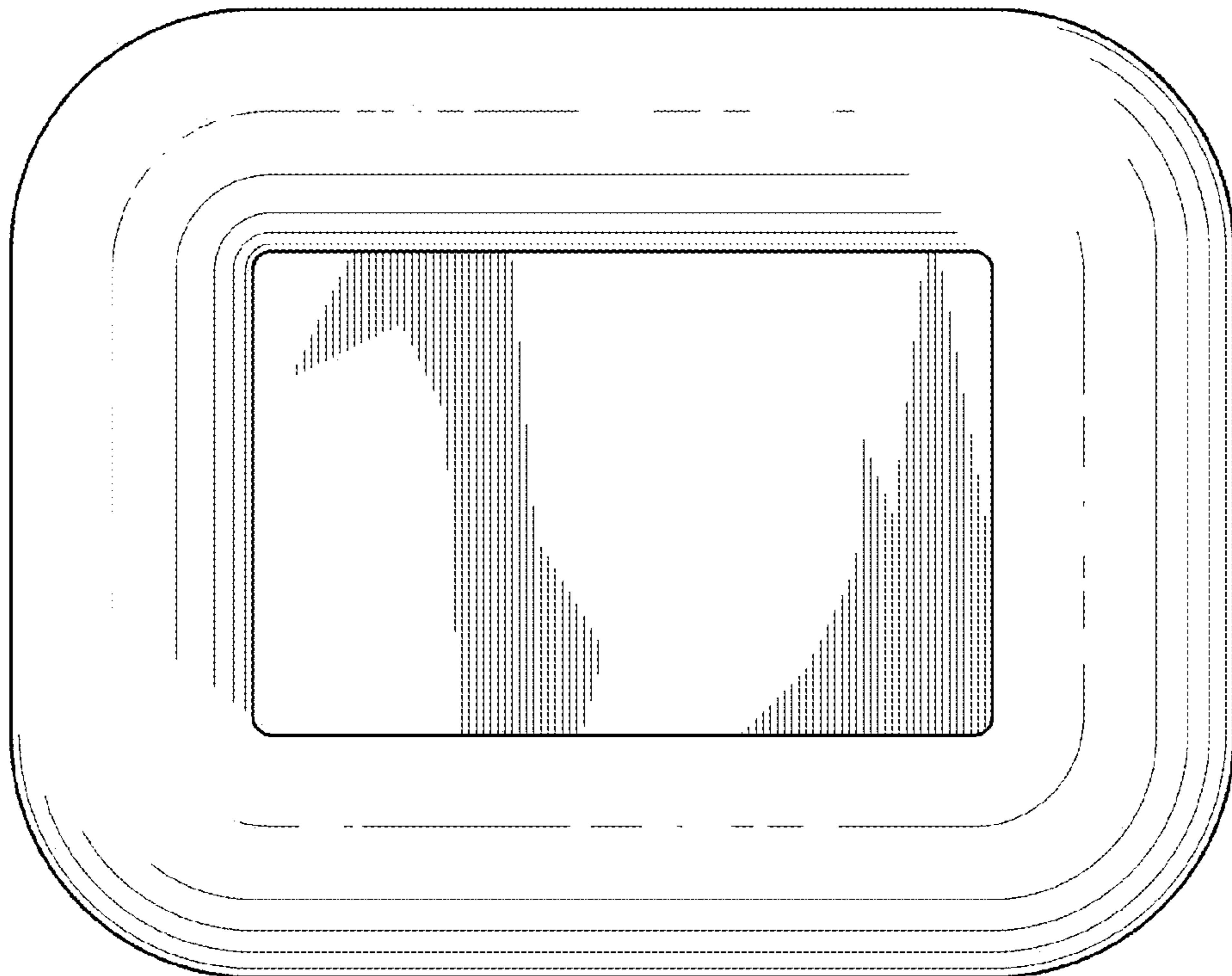

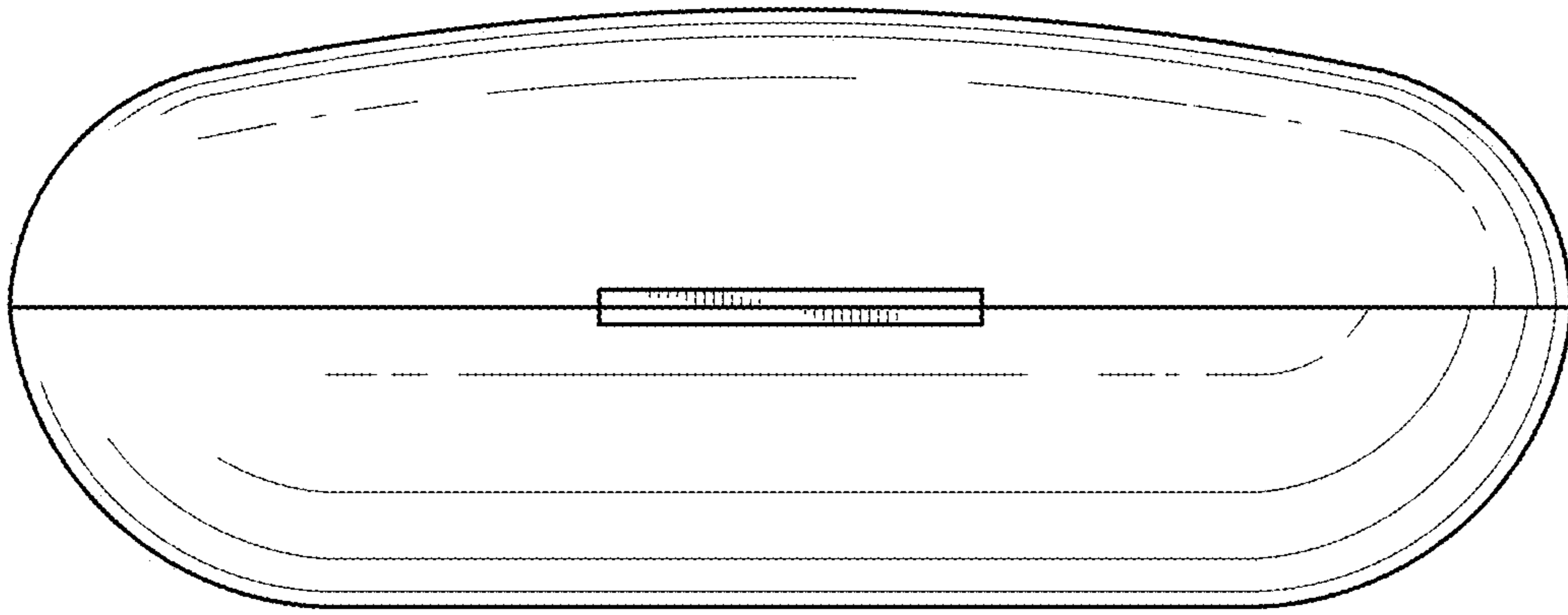

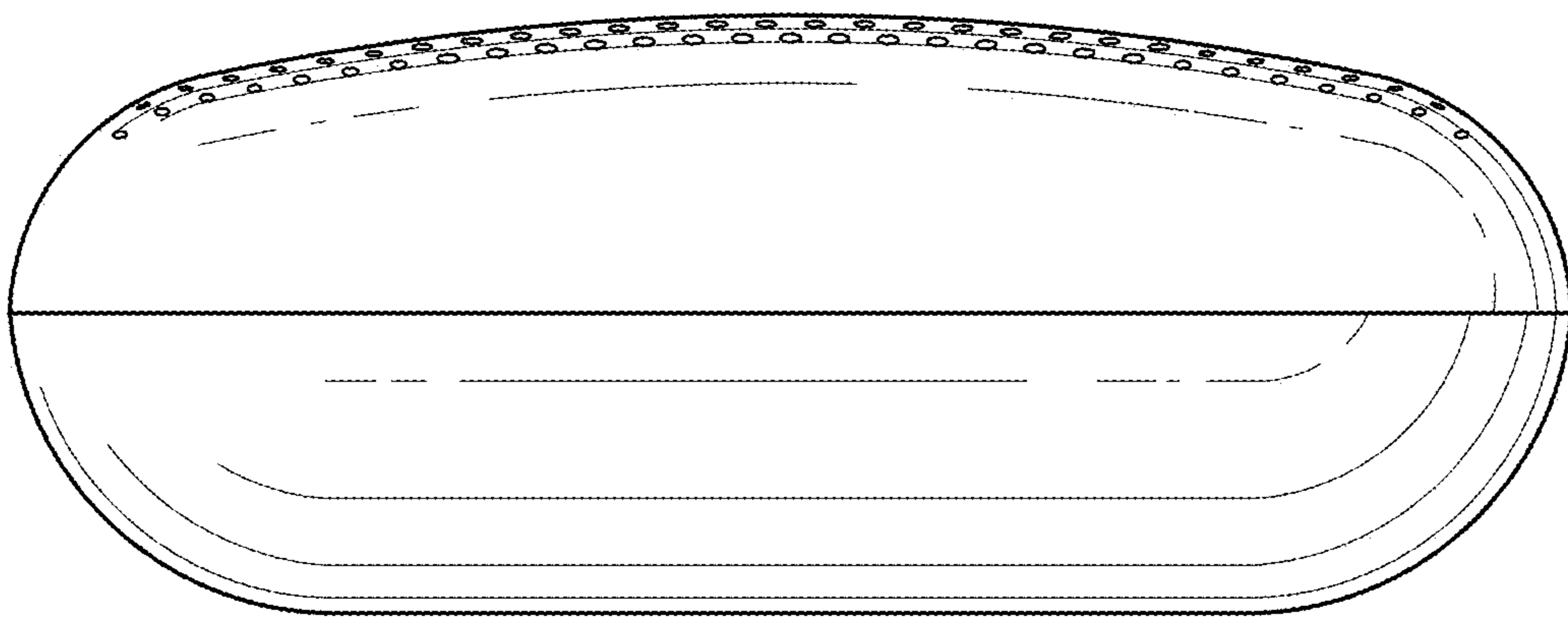

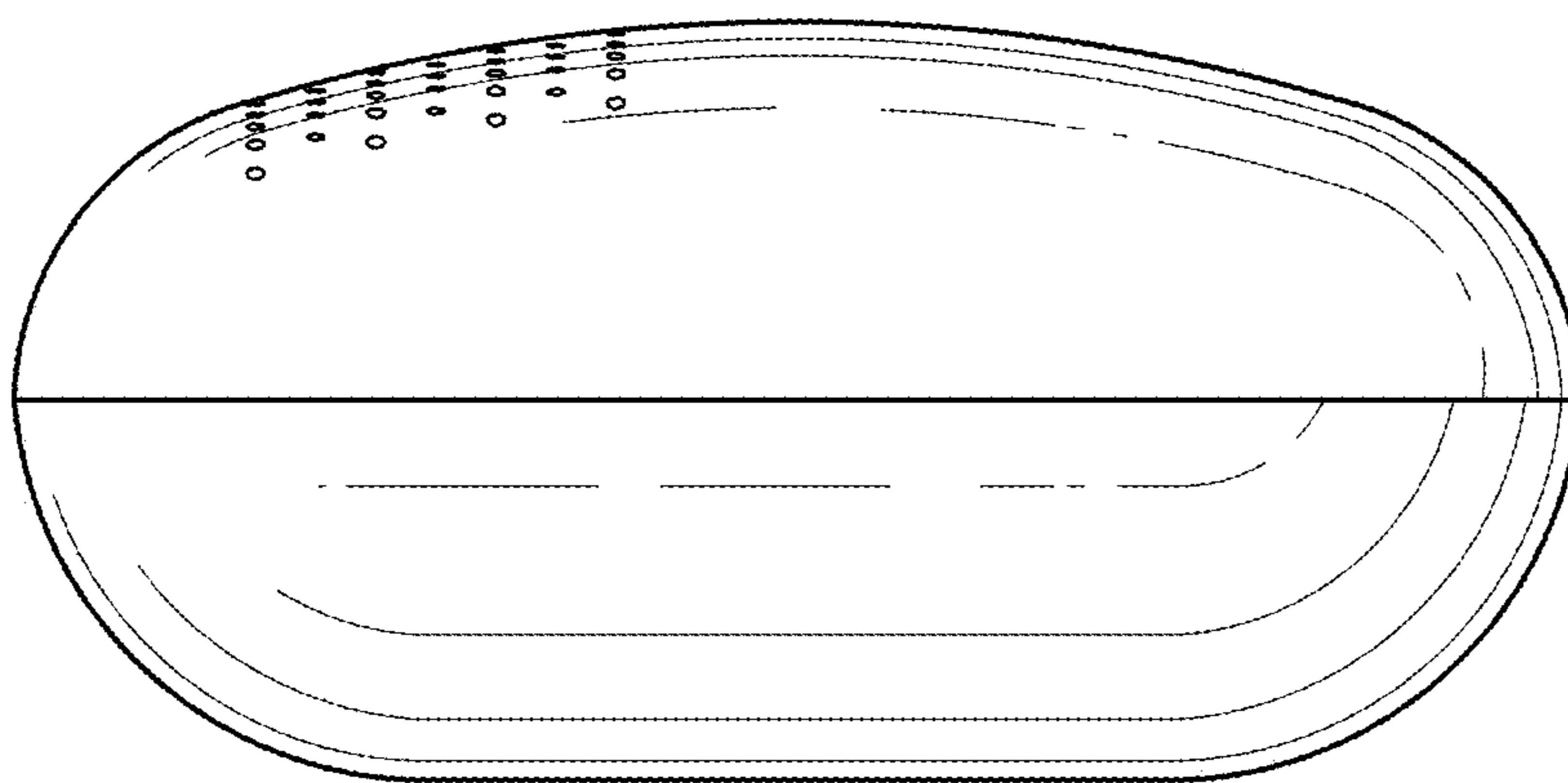

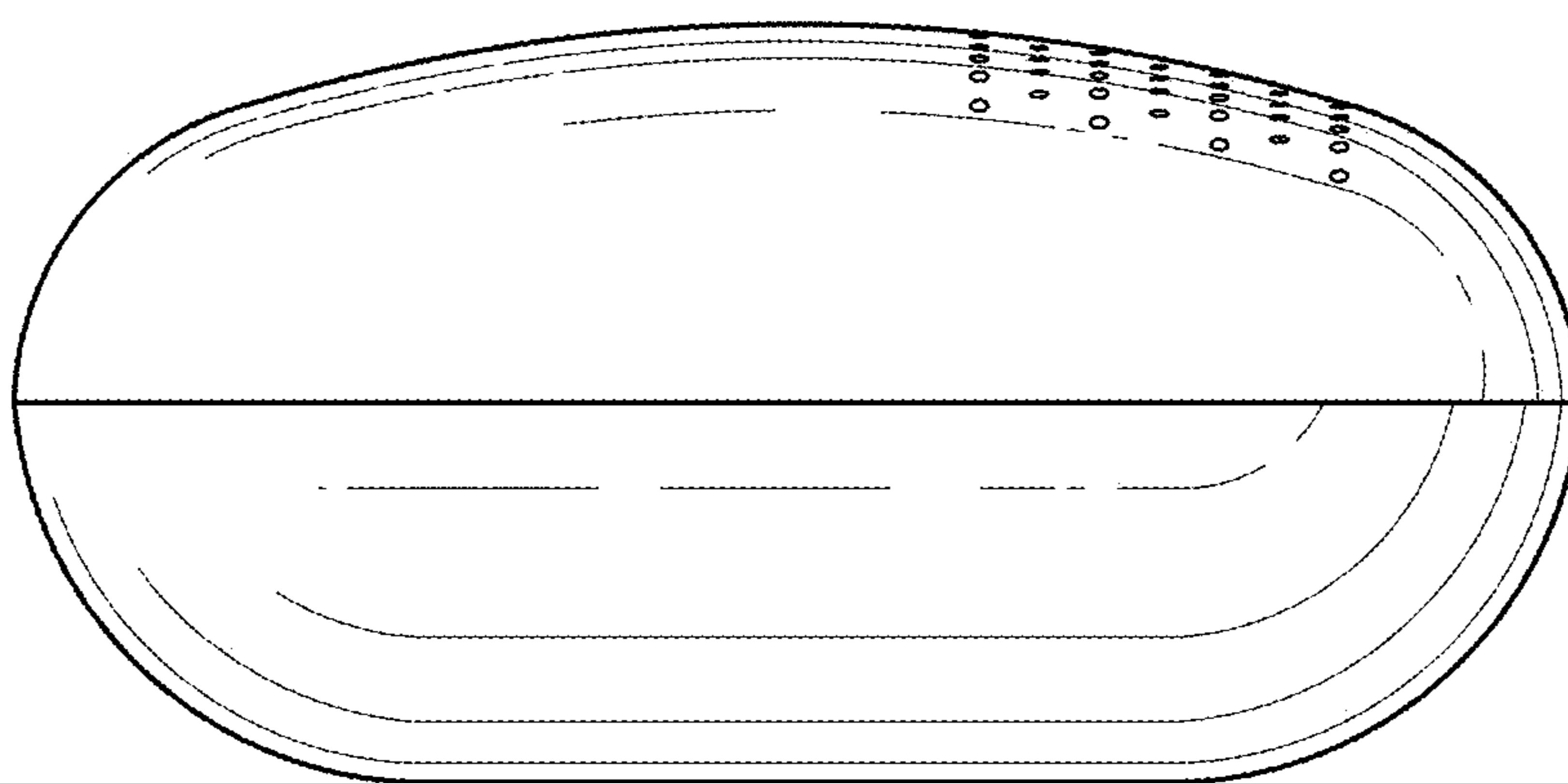
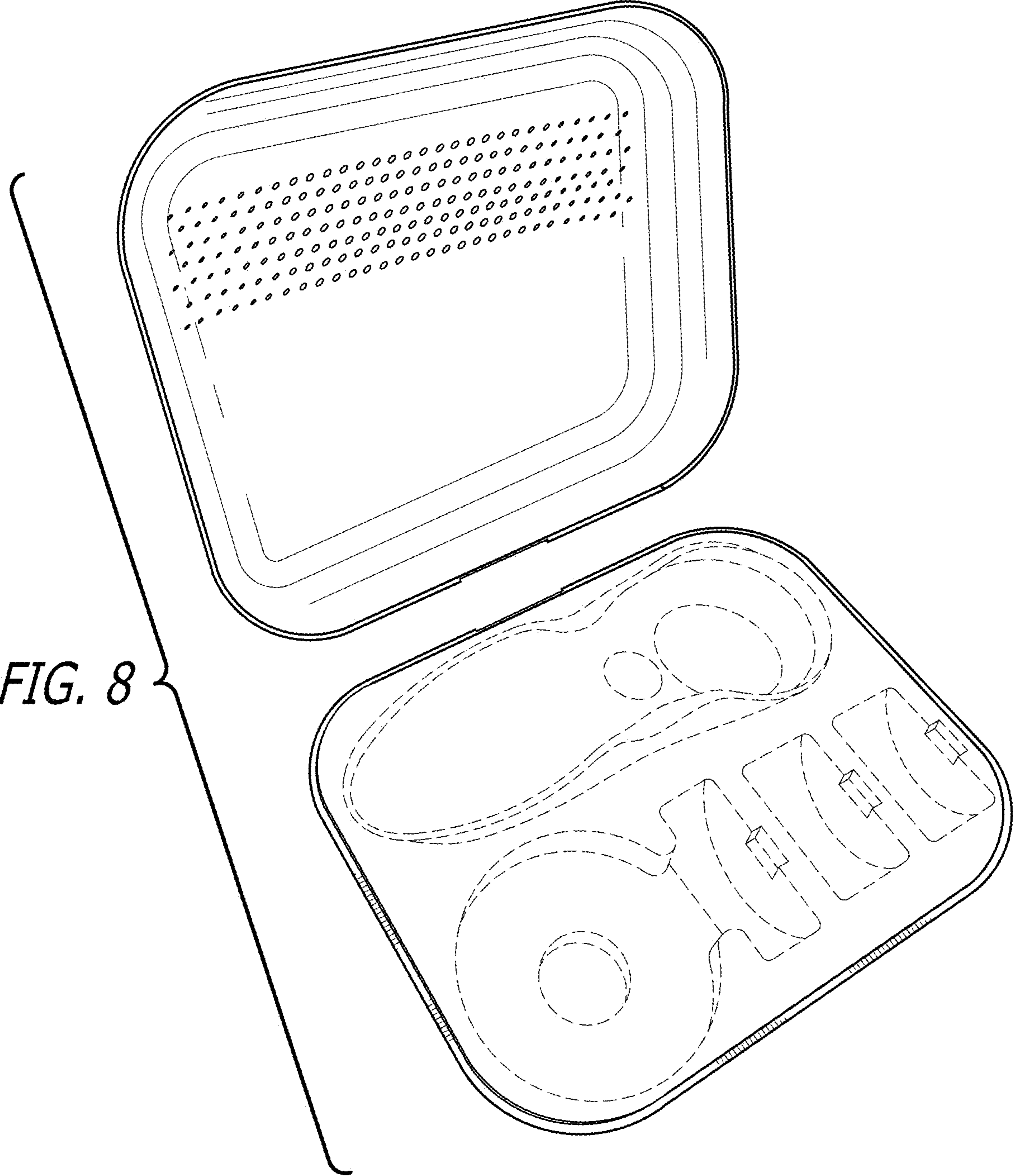

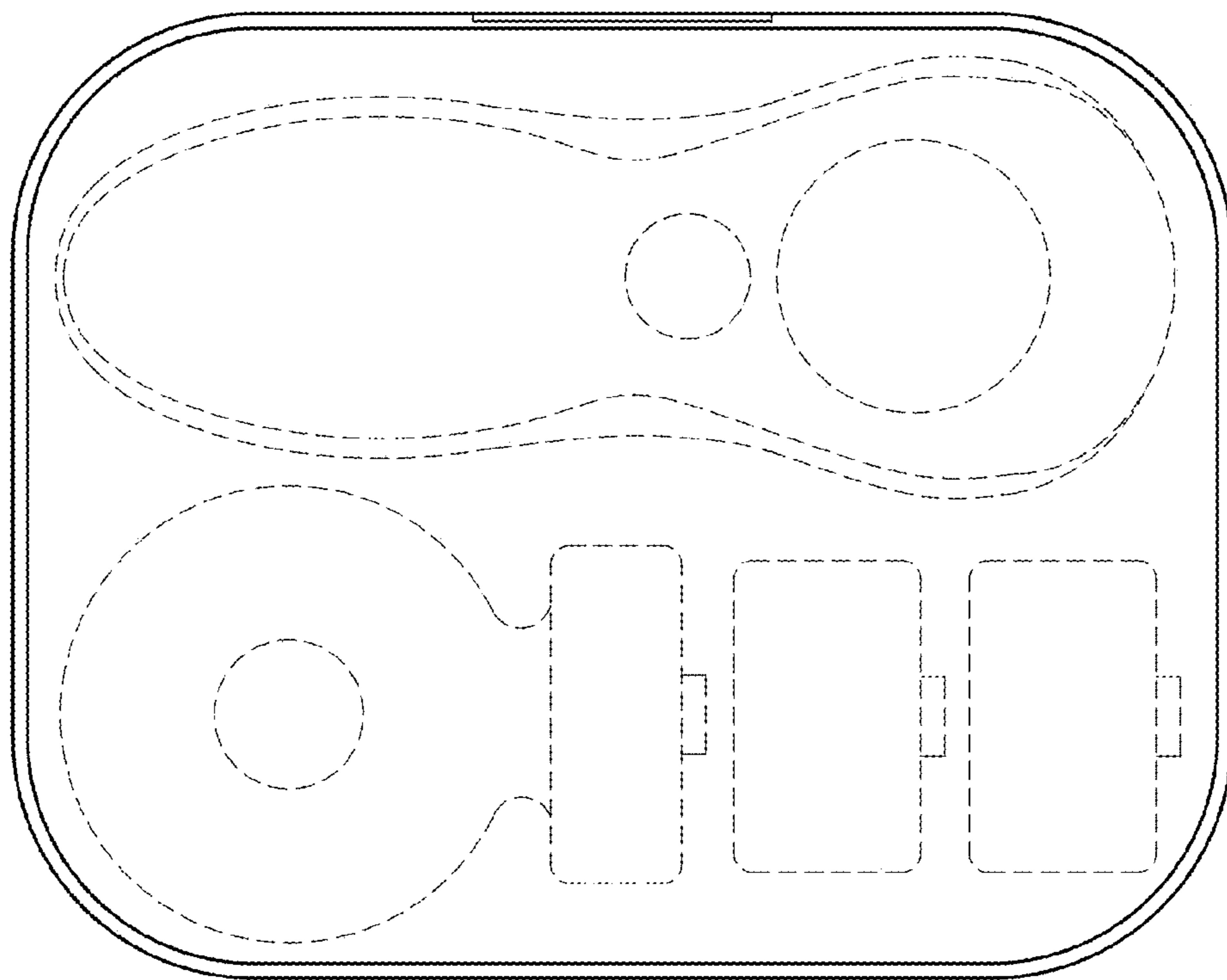

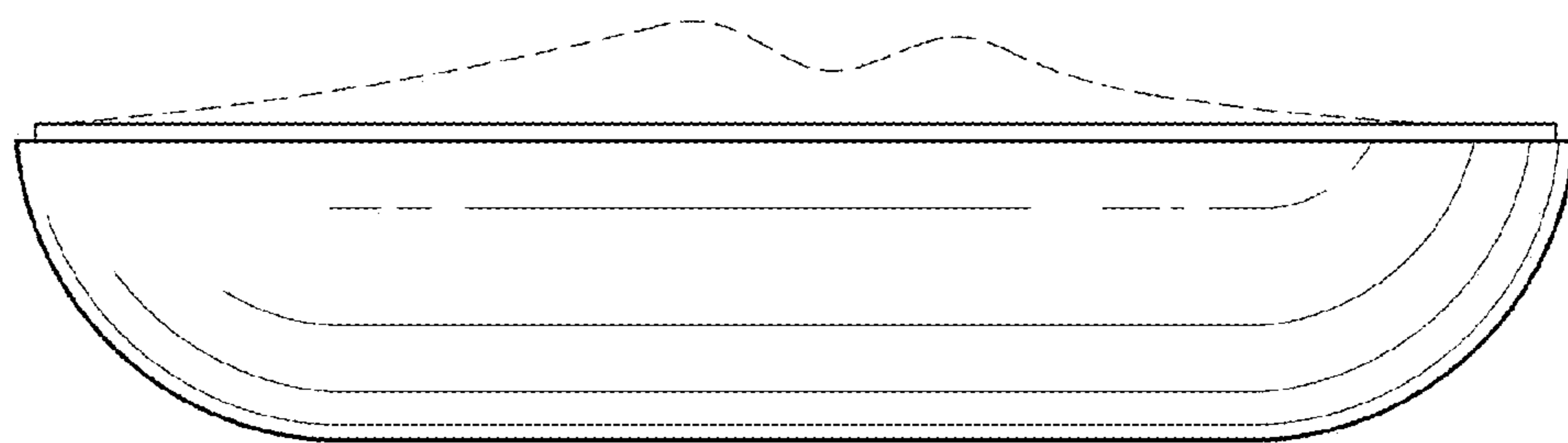

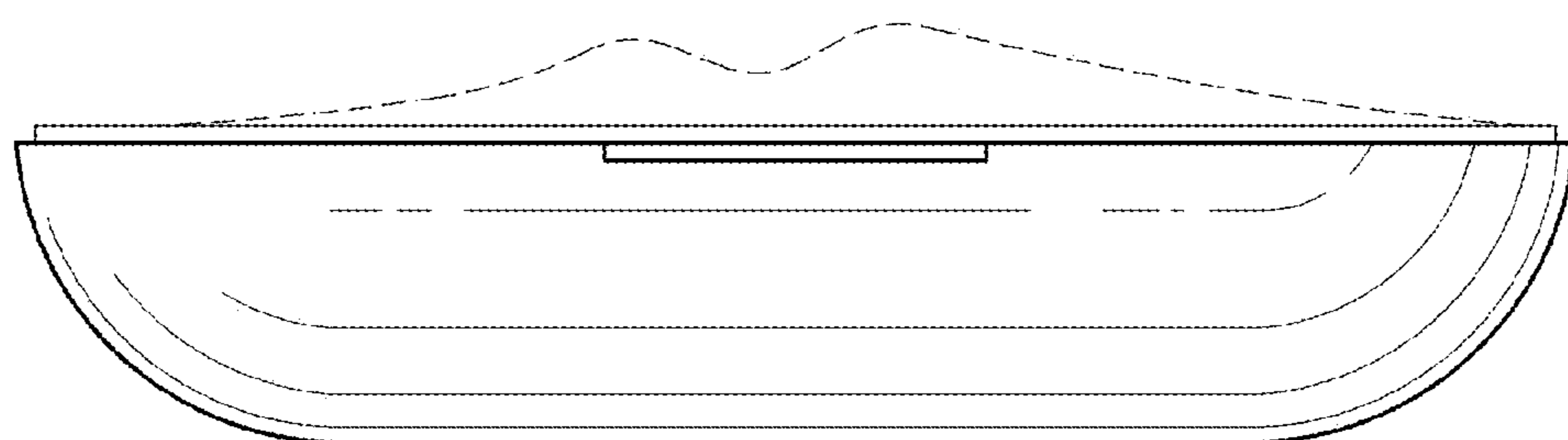

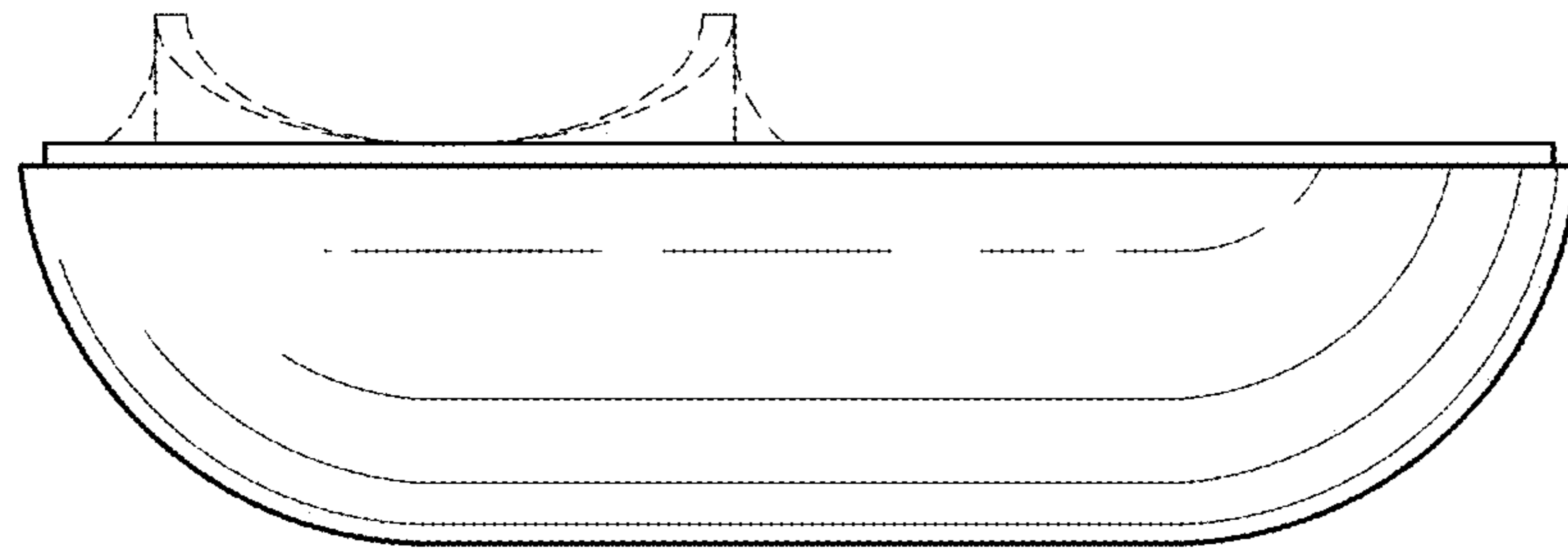

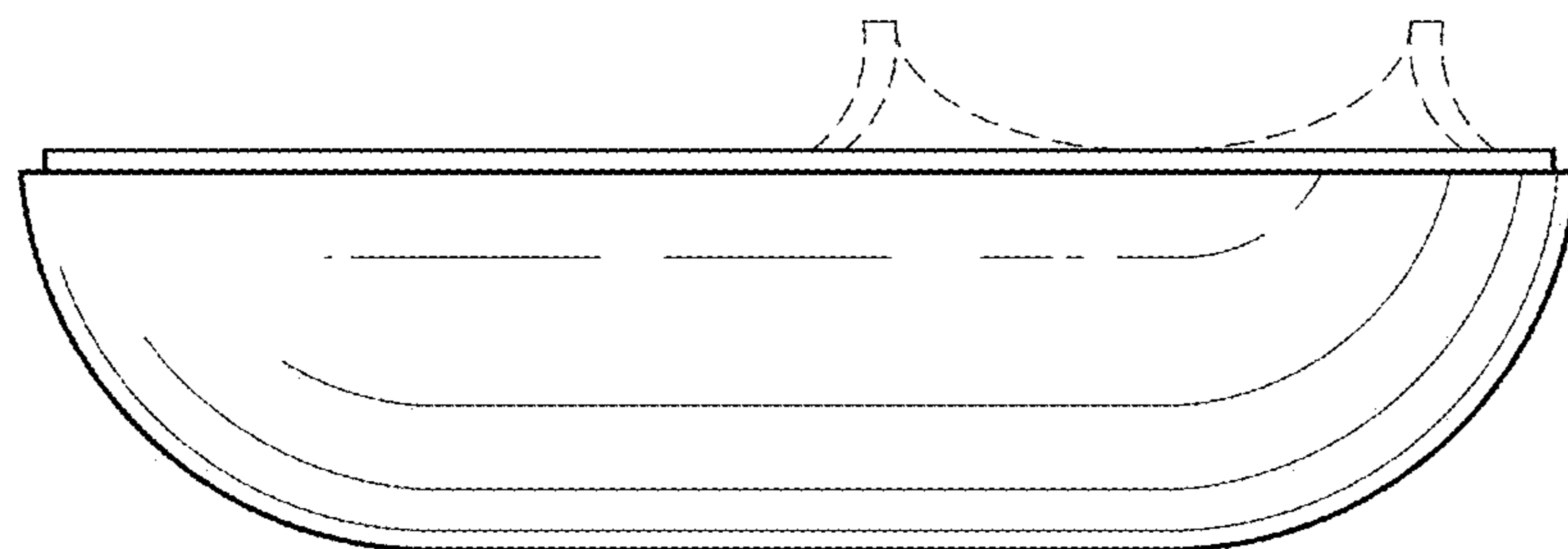
