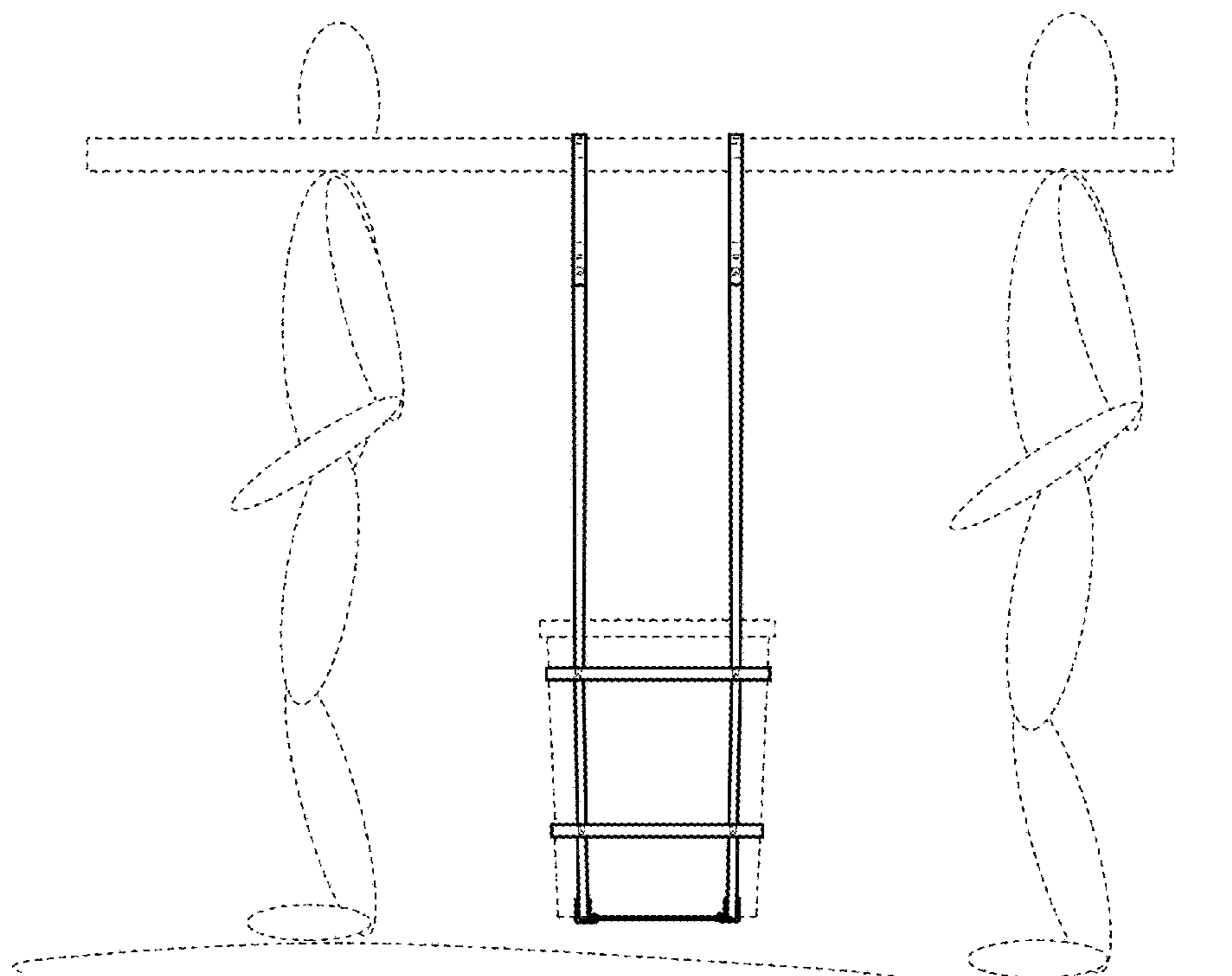
(57) **CLAIM**

The ornamental design for a strap rigging for a bucket, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation view of a strap rigging for a bucket, showing my new design in its environment;

 FIG. 4 is a right side elevation view thereof;

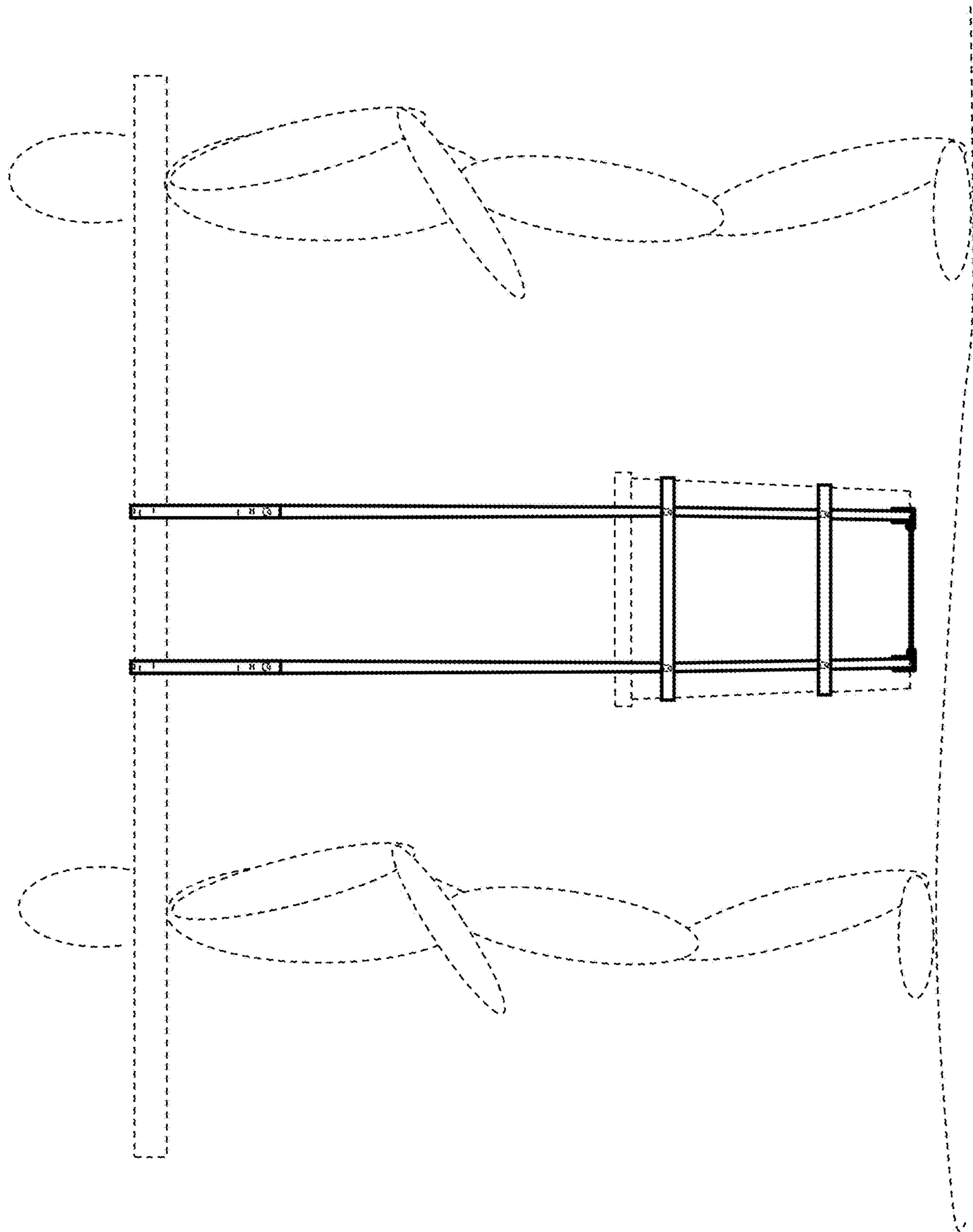

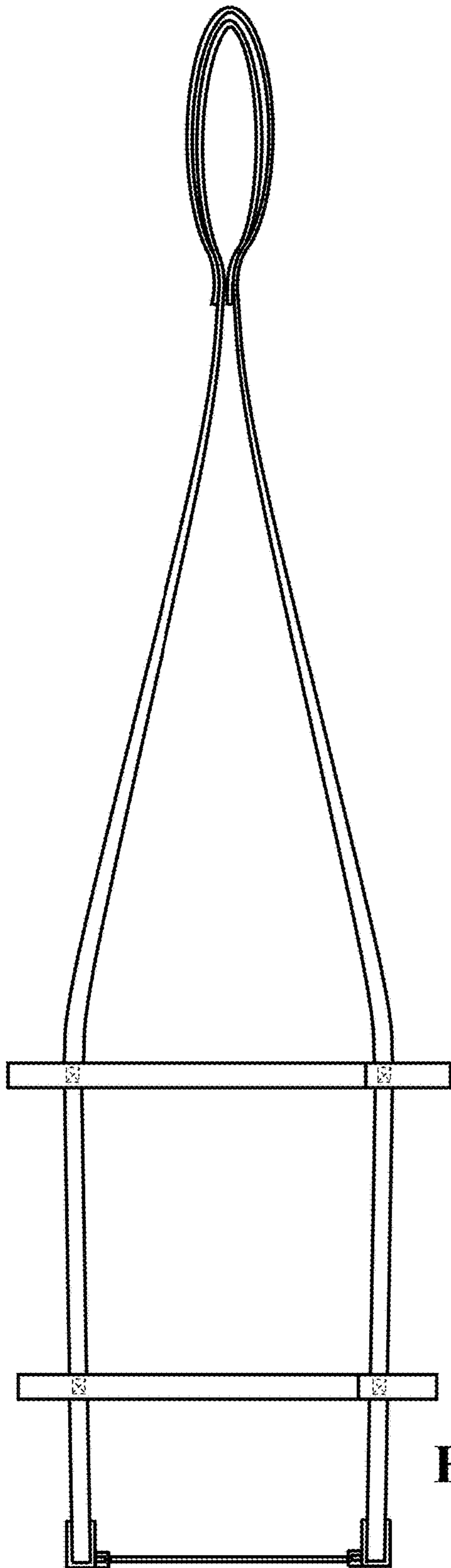

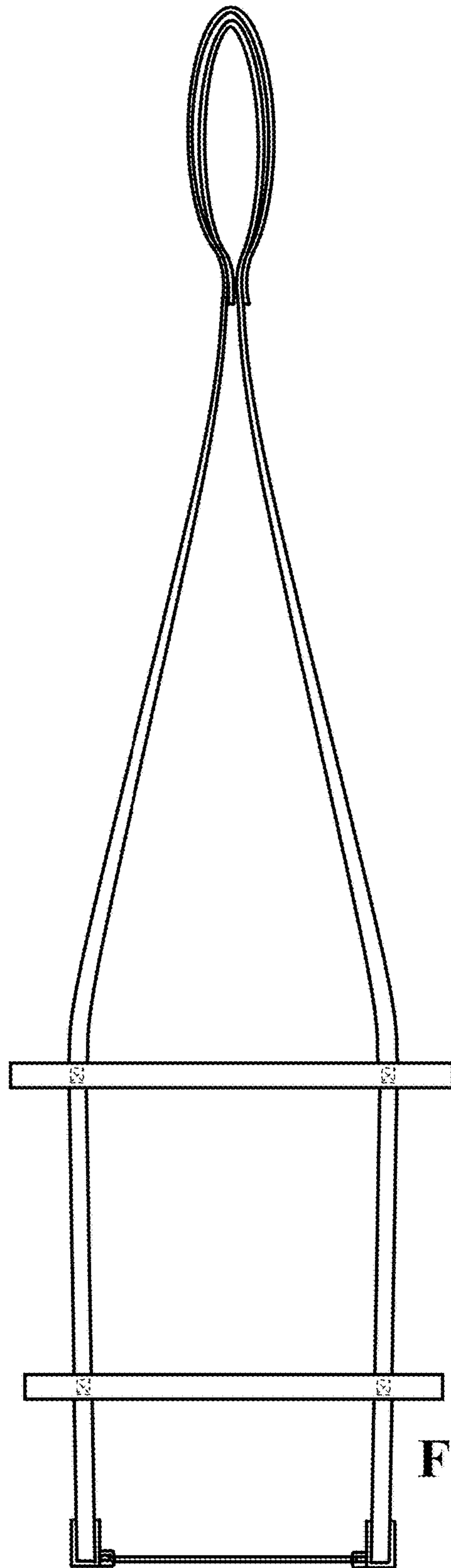

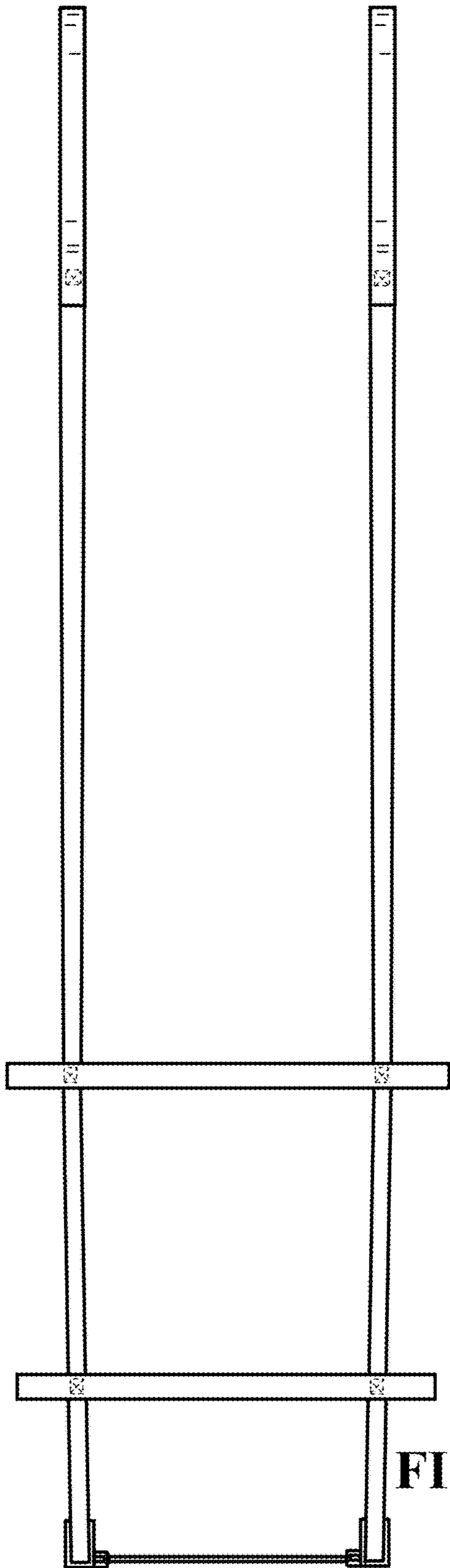

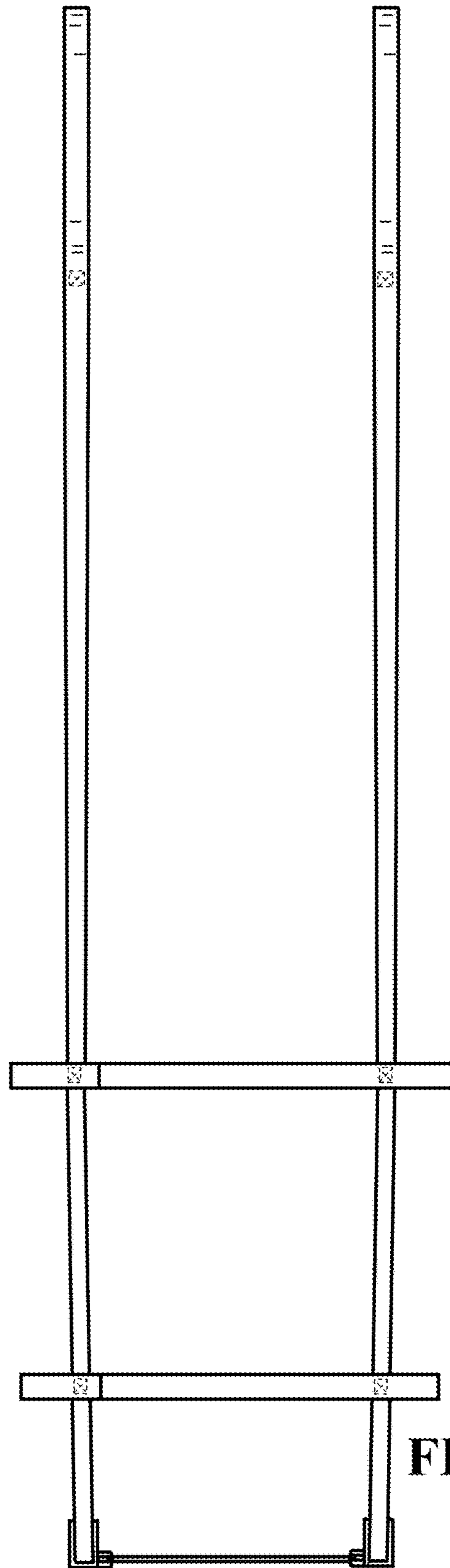

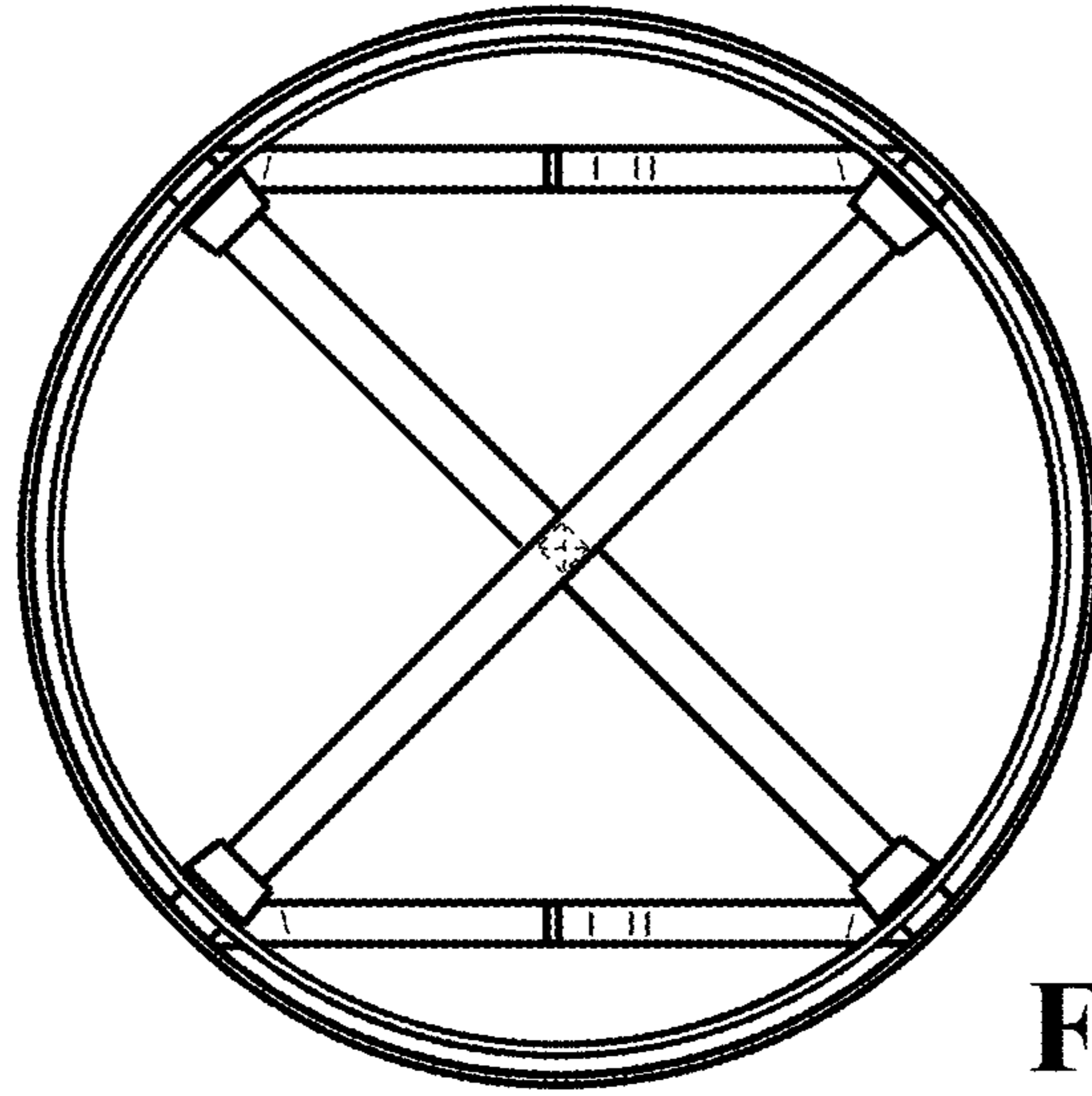

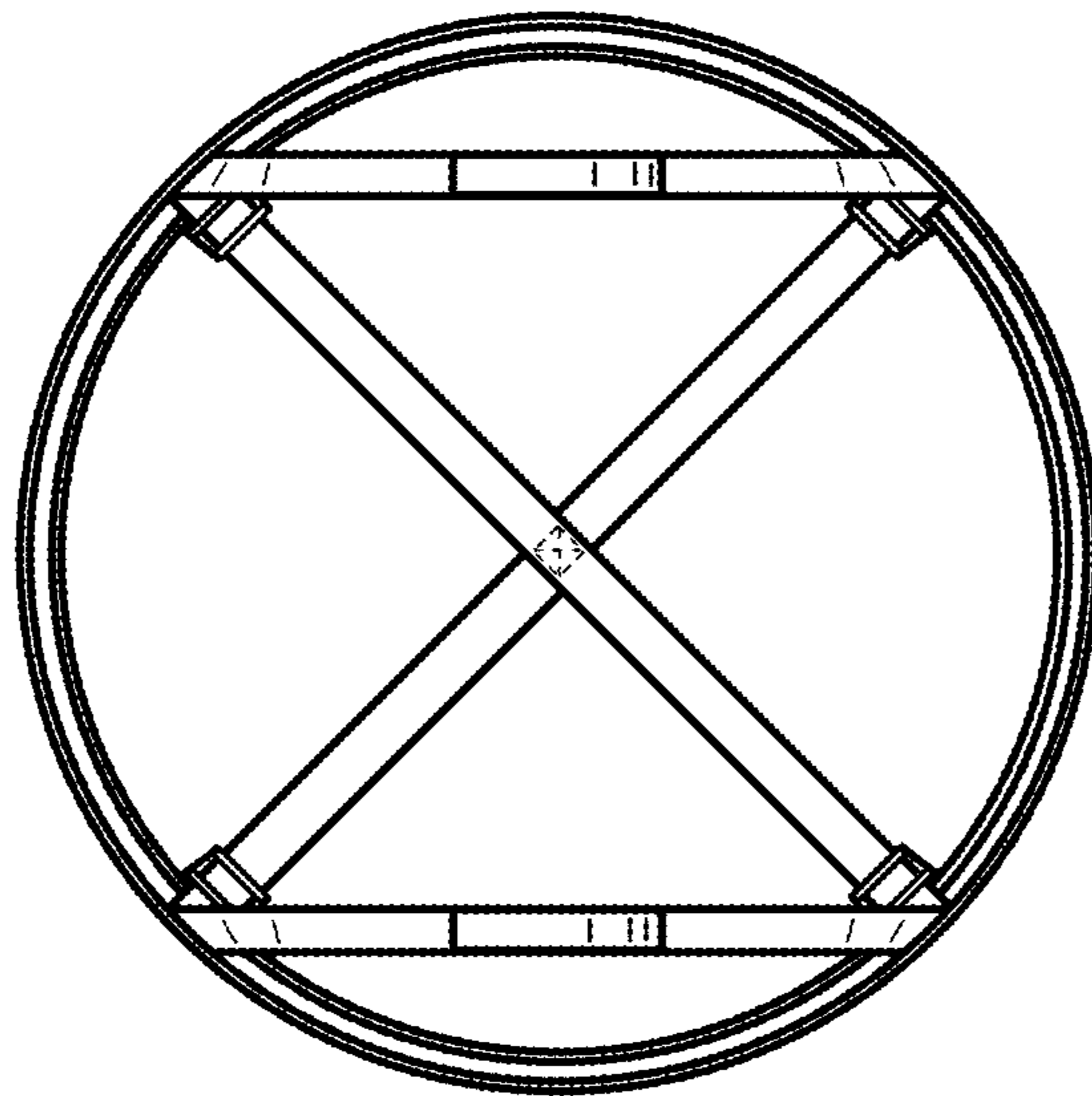

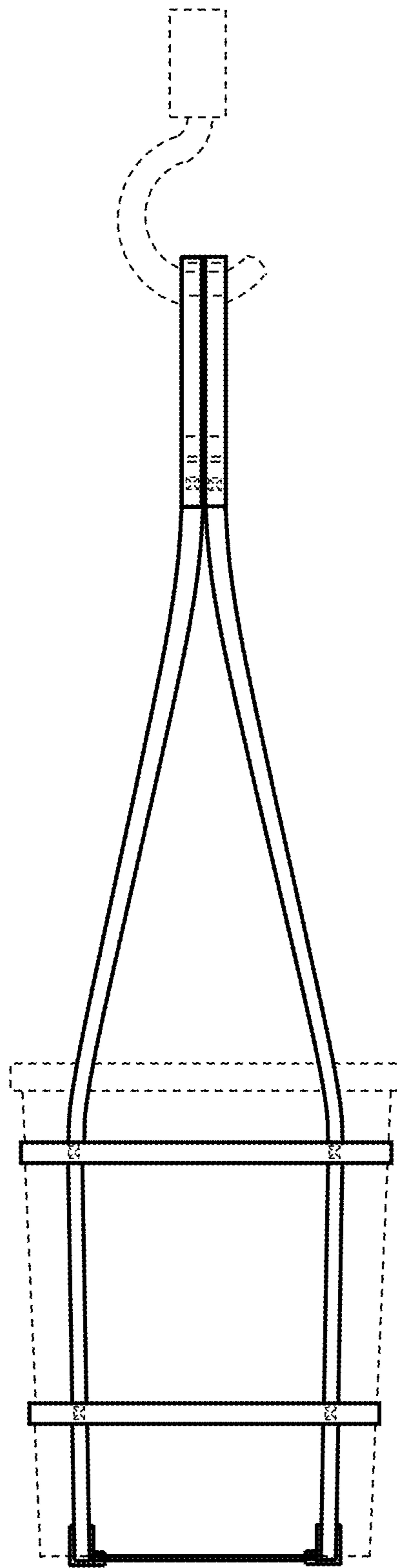
