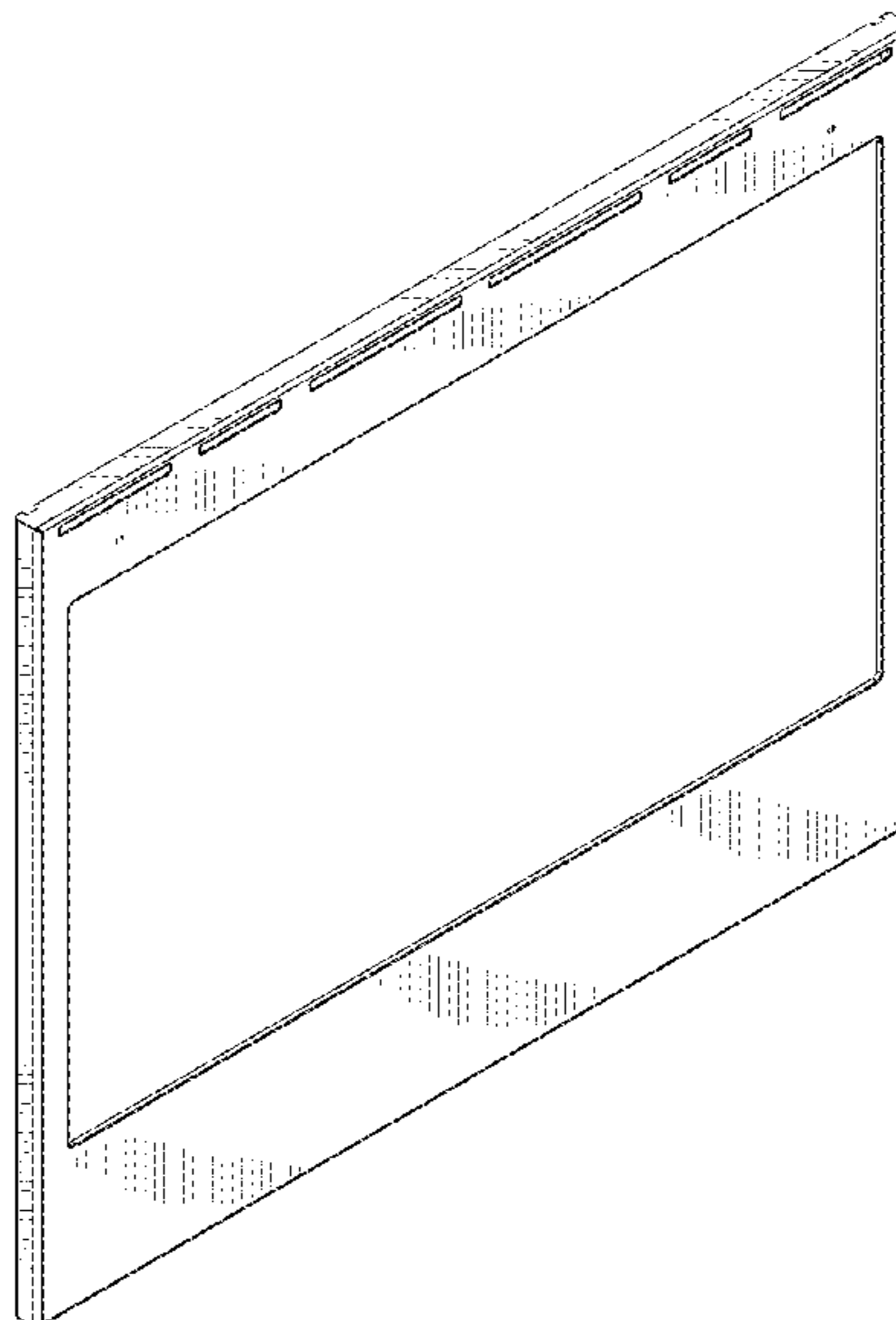
(57) **CLAIM**

I claim the ornamental design for a panel for an oven, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a panel for an oven of the present disclosure;
FIG. 2 is a front elevational view of the panel for an oven of FIG. 1;
FIG. 3 is a rear elevational view of the panel for an oven of FIG. 1;
FIG. 4 is a first side elevational view of the panel for an oven of FIG. 1;
FIG. 5 is a second side elevational view of the panel for an oven of FIG. 1;
FIG. 6 is a top plan view of the panel for an oven of FIG. 1; and,
FIG. 7 is a bottom plan view of the panel for an oven of FIG. 1.

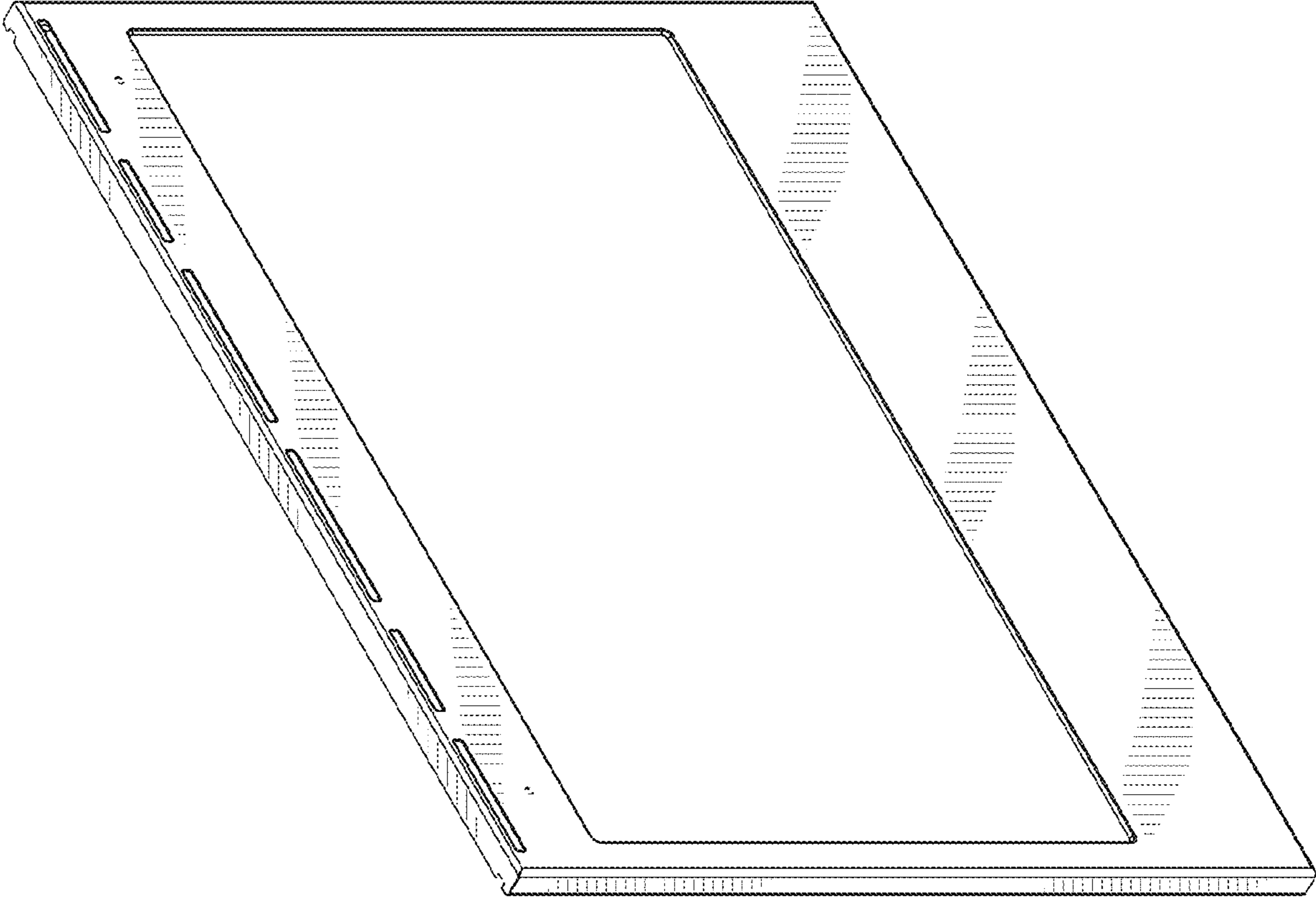

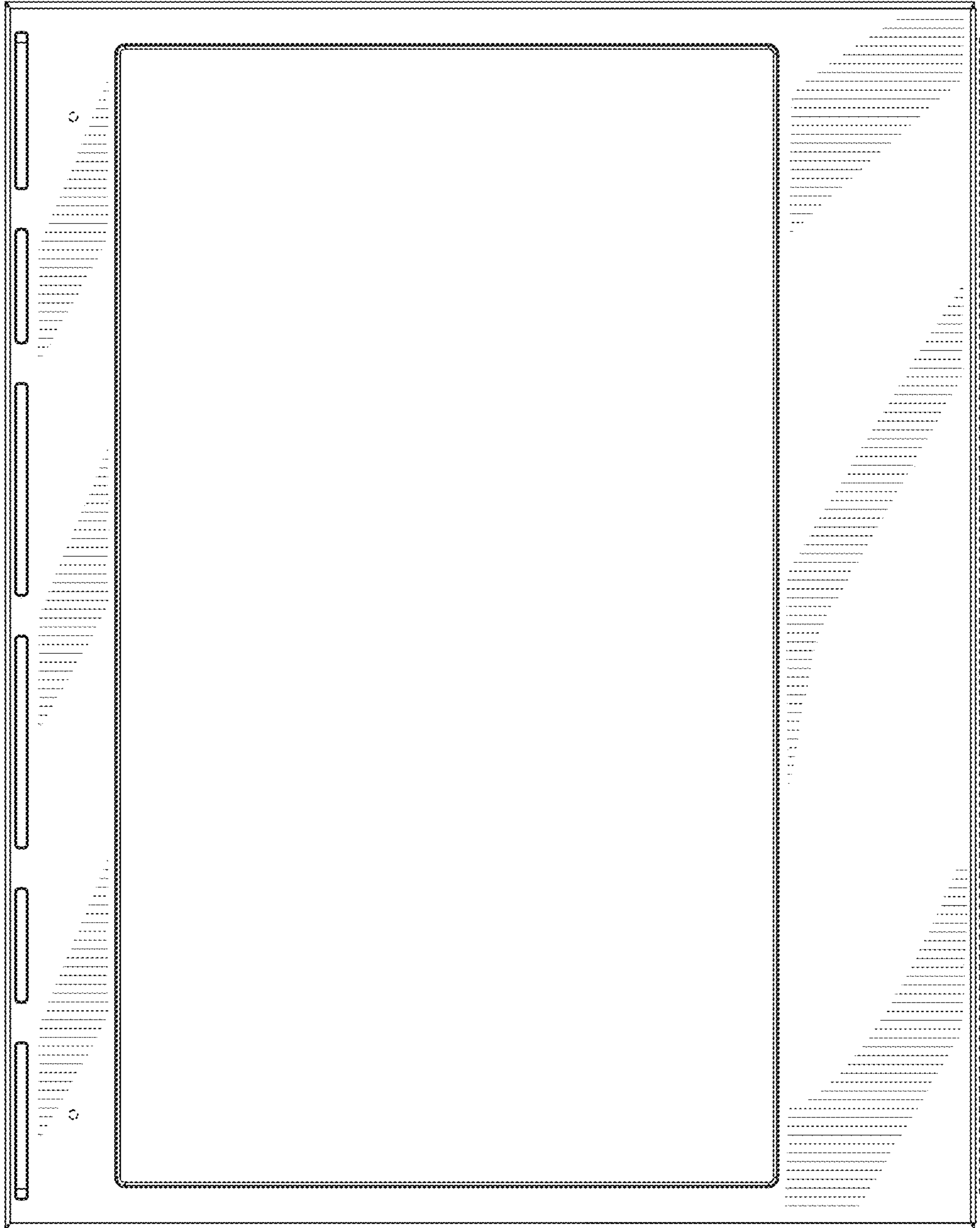

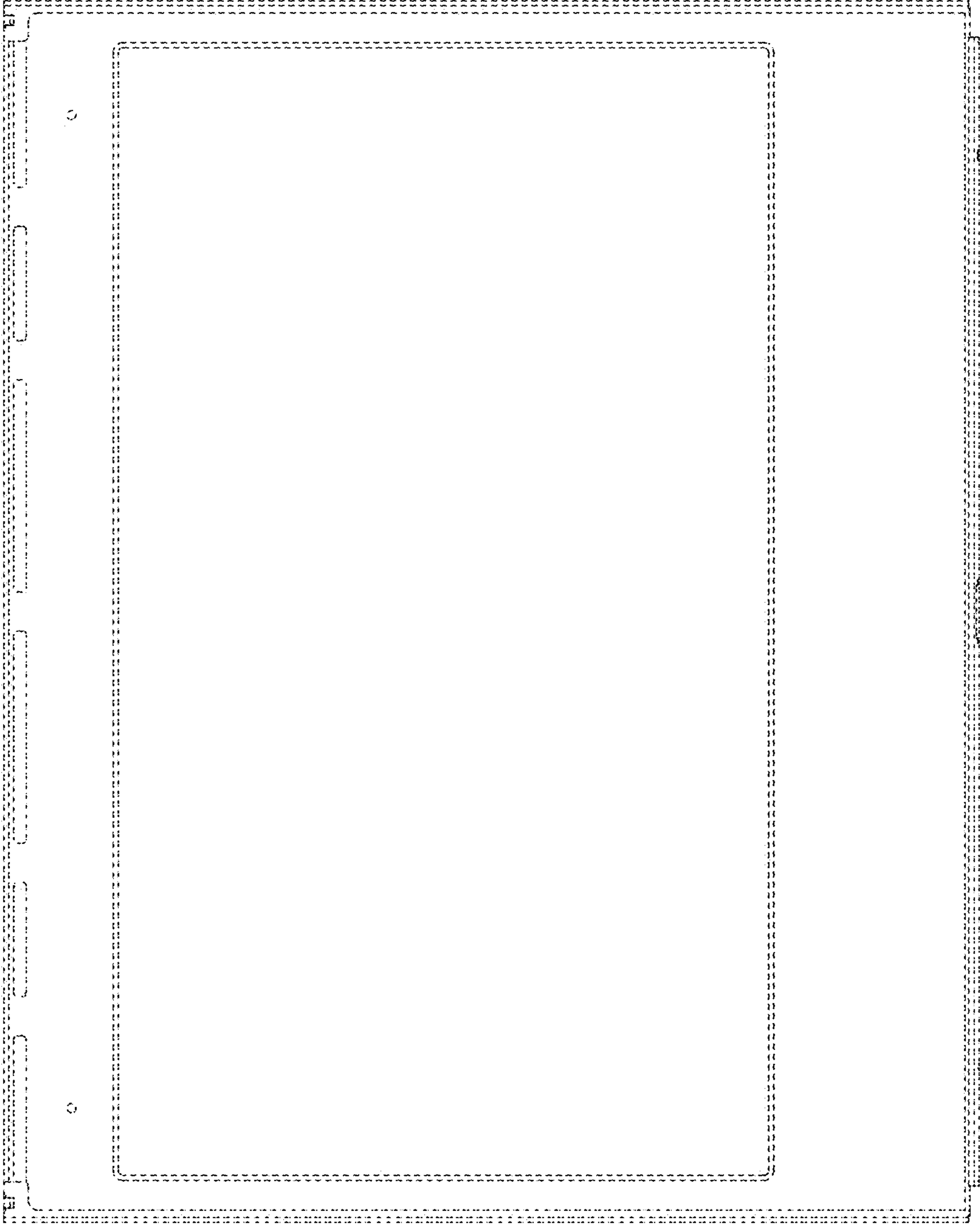

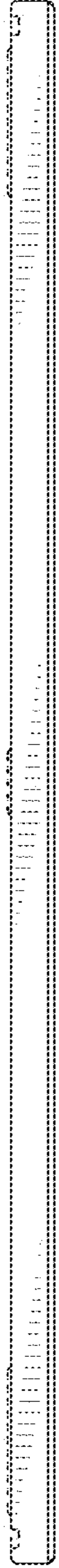

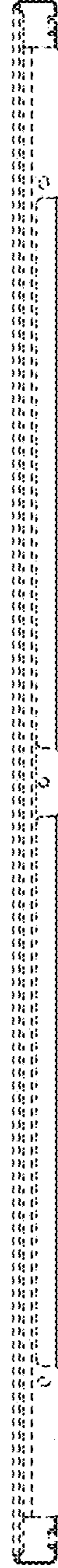
