(57) **CLAIM**

I claim the ornamental design for a dinosaur shaped pancake mold, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a dinosaur shaped pancake mold.

FIG. 2 is a front view of the dinosaur shaped pancake mold.

FIG. 3 is a back view of the dinosaur shaped pancake mold.

FIG. 4 is a side view of the dinosaur shaped pancake mold.

FIG. 5 is another side view of the dinosaur shaped pancake mold.

FIG. 6 is a top view of the dinosaur shaped pancake mold.

FIG. 7 is a bottom view of the dinosaur shaped pancake mold.

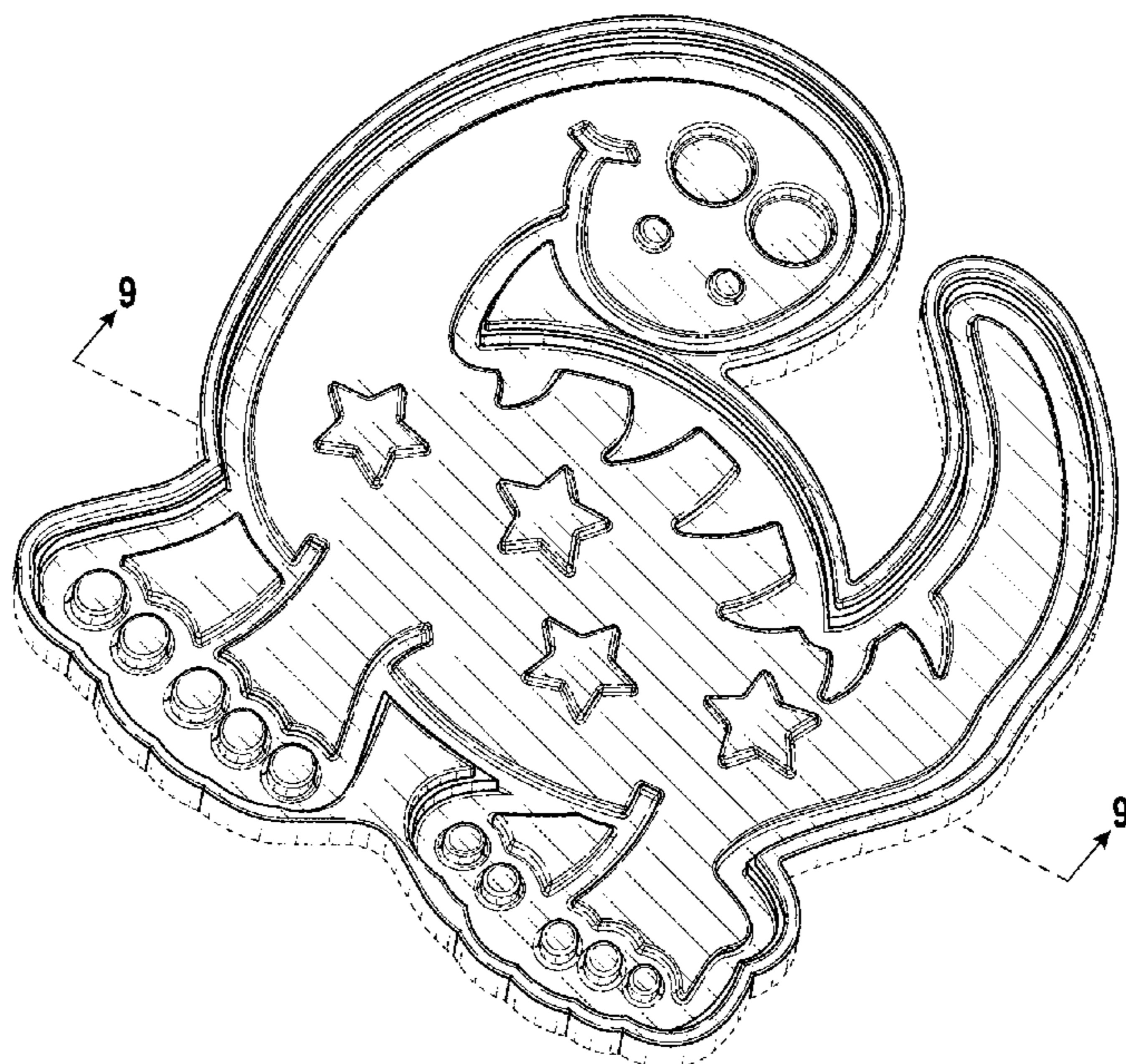
FIG. 8 is a cross-sectional view through a centerline of the dinosaur shaped pancake mold.

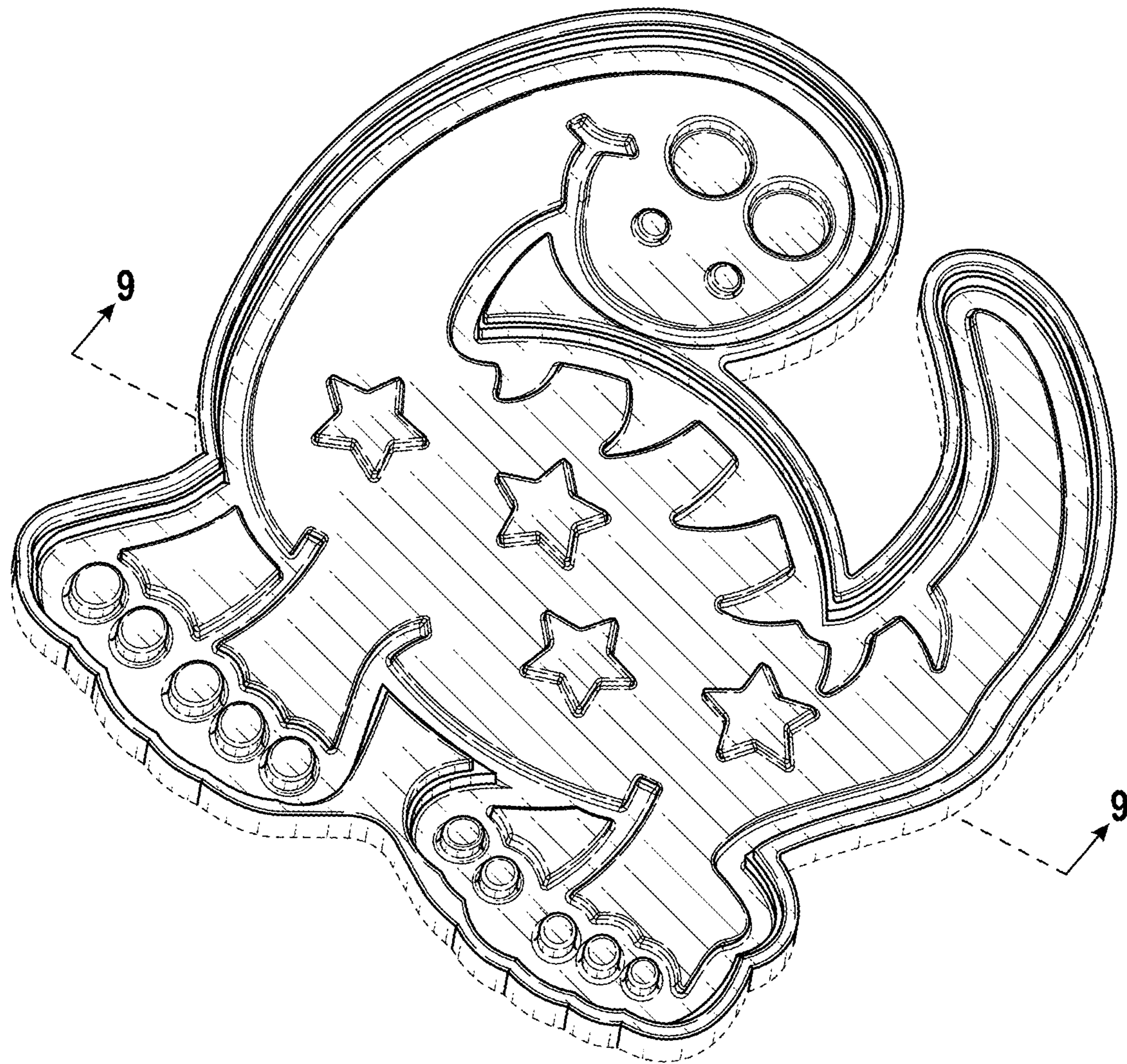

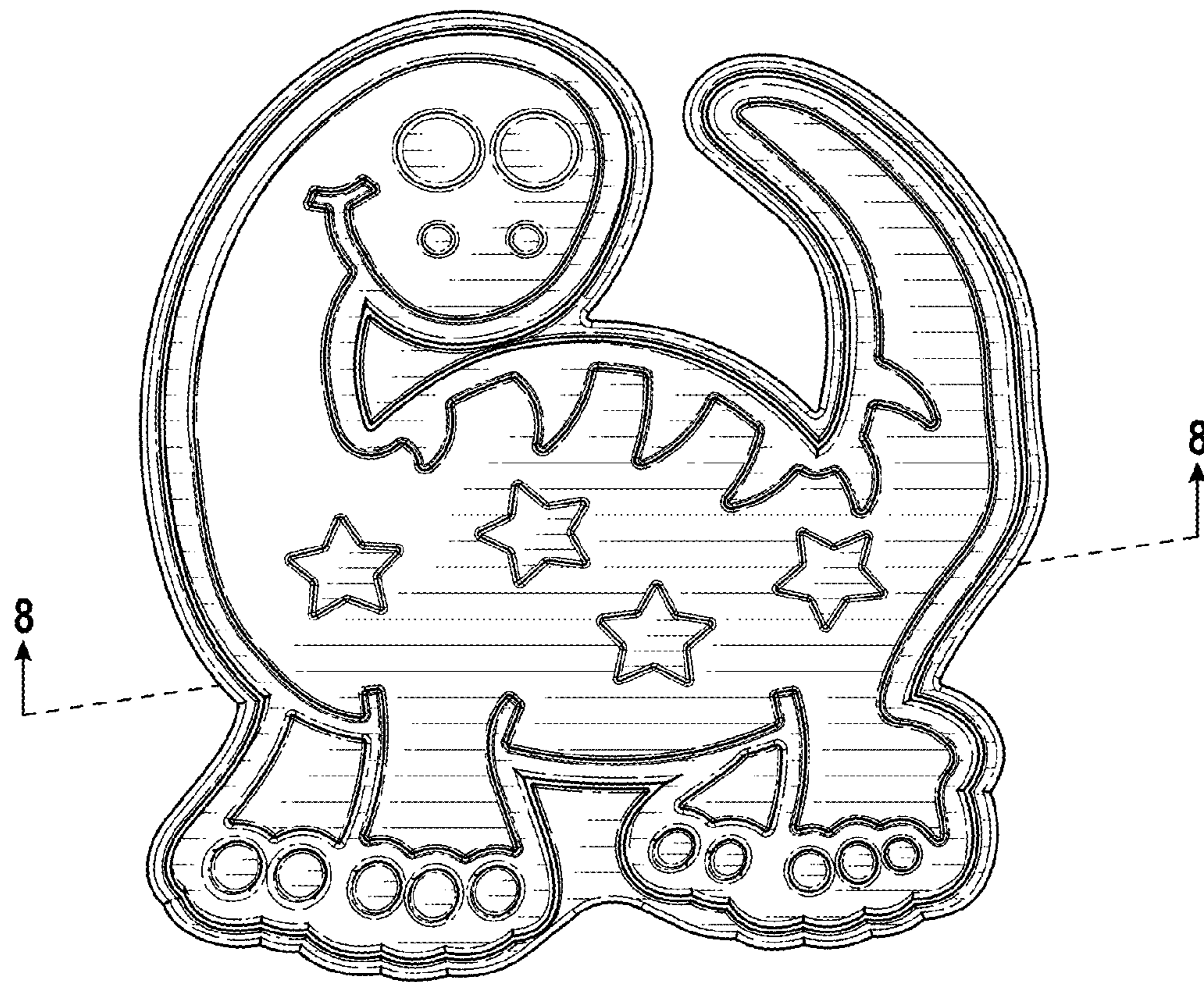

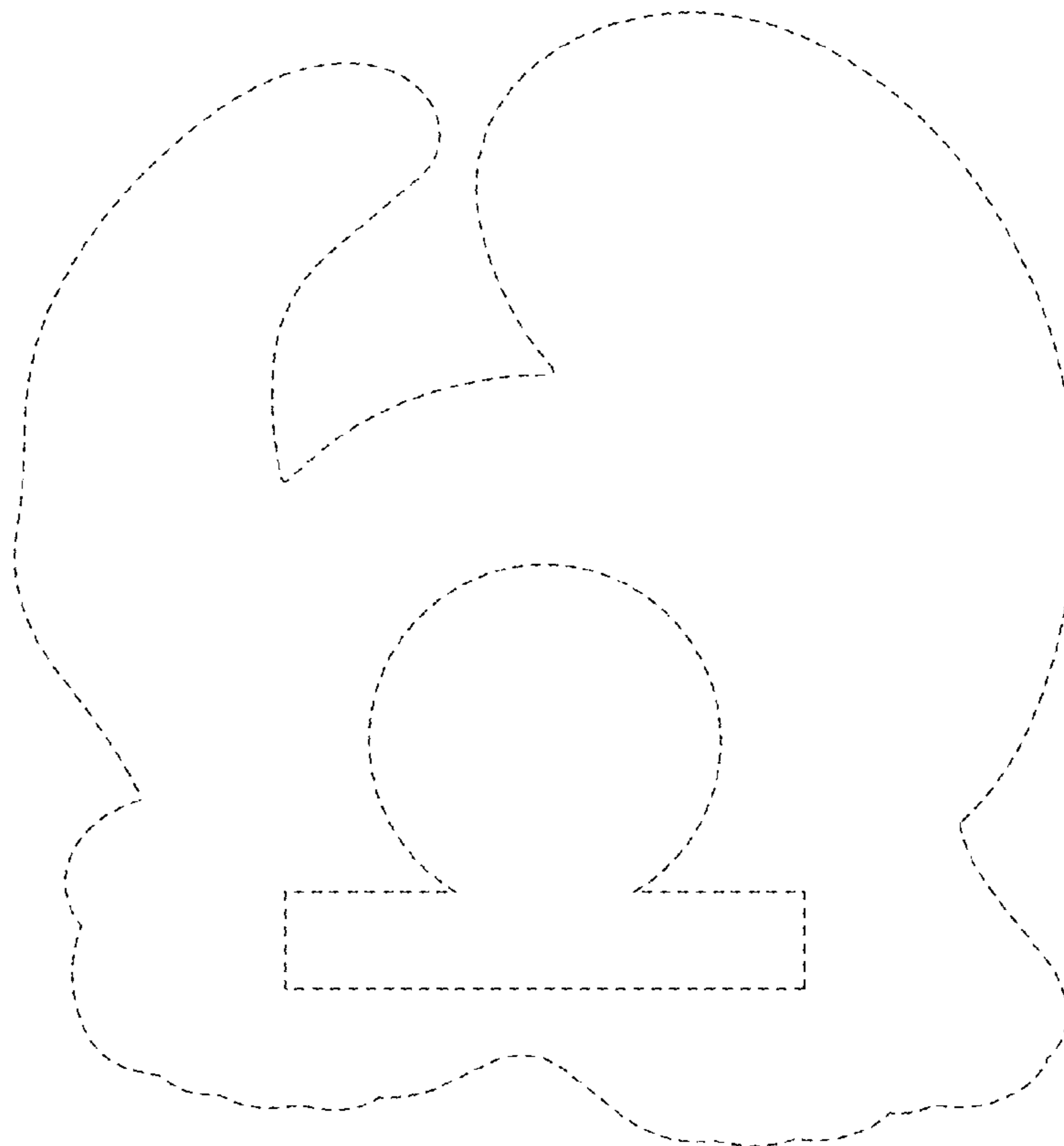

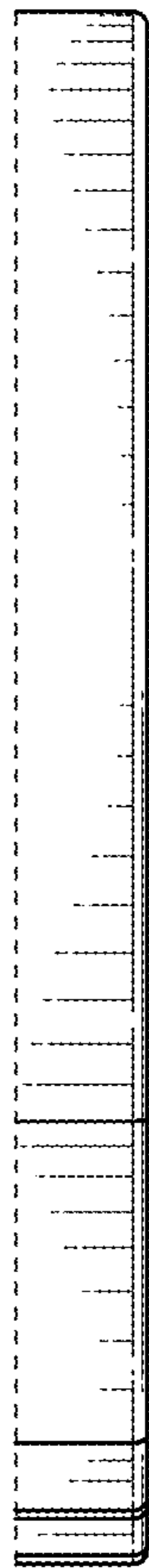

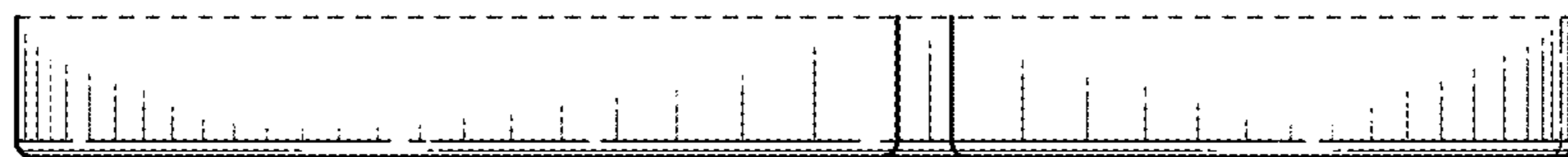

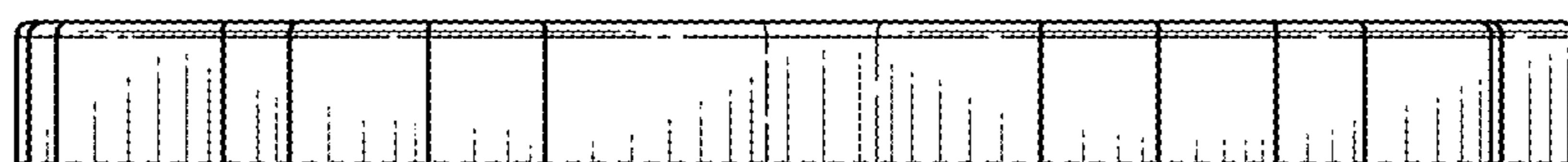

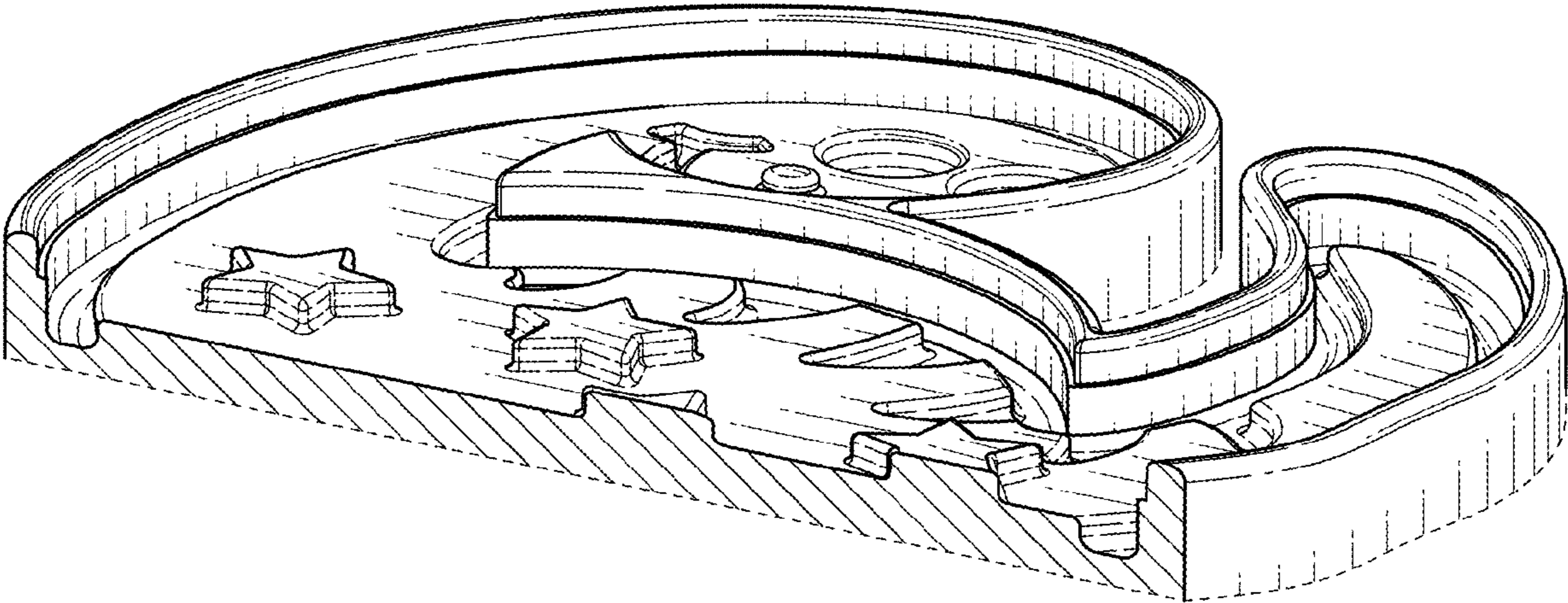

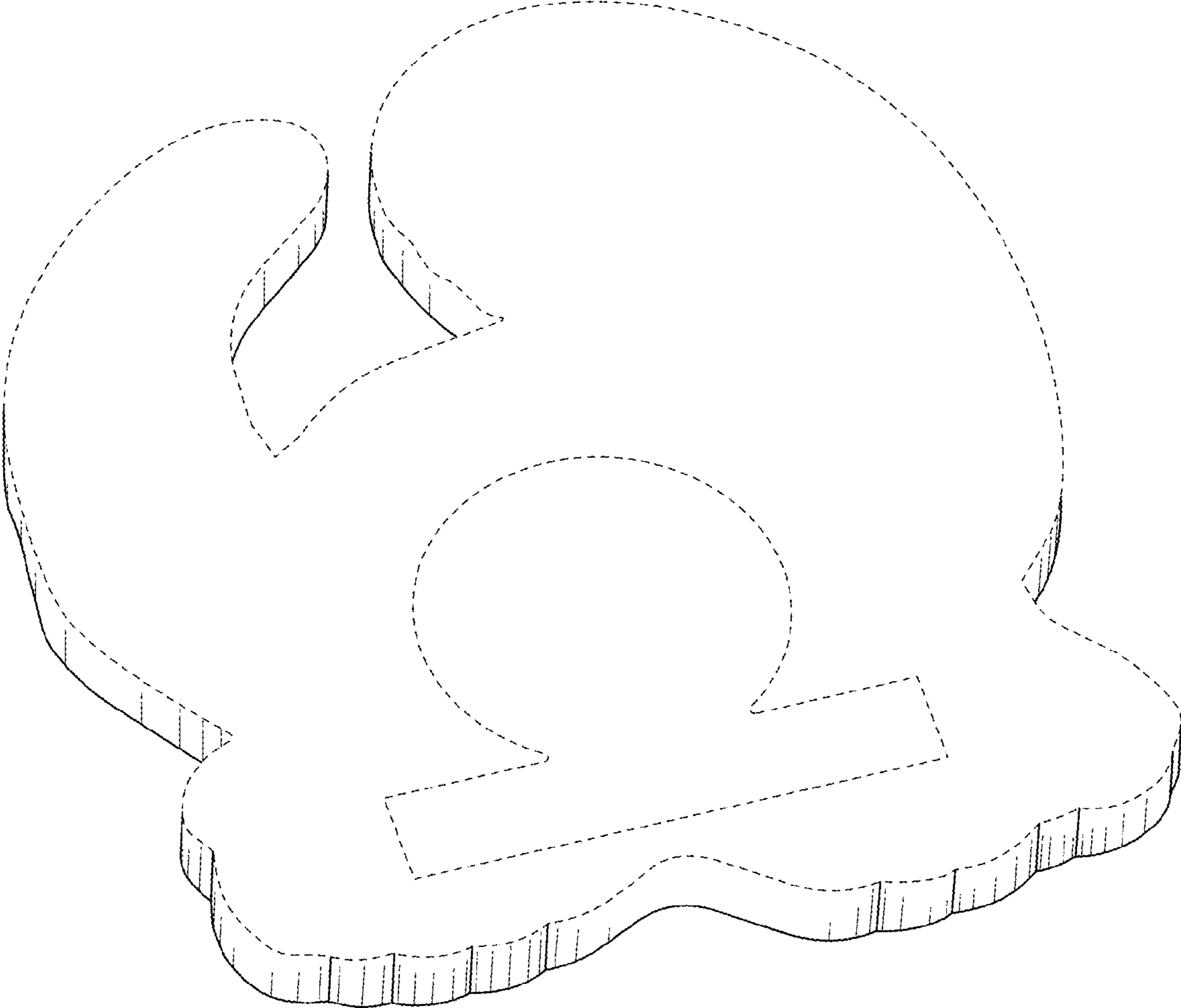
