(57) **CLAIM**

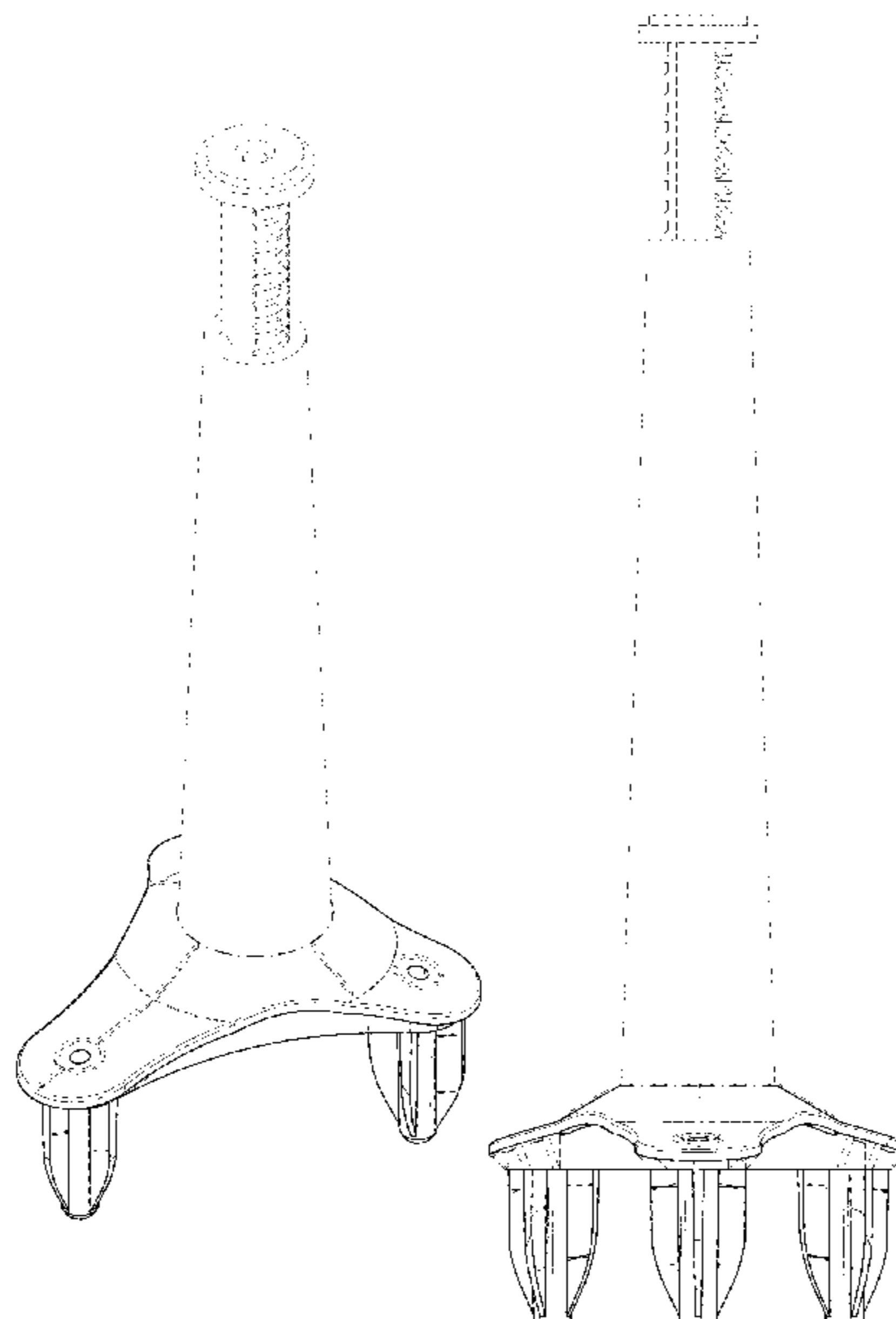
The ornamental design for a support for embedding objects in concrete, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a support for embedding objects in concrete in accordance with the present invention. FIG. 2 is a front view thereof. FIG. 3 is a rear view thereof. FIG. 4 is a left side view thereof. FIG. 5 is a right side view thereof. FIG. 6 is a top view thereof. FIG. 7 is a bottom view thereof. FIG. 8 is a partial enlarged view thereof taken along broken circle 8-8 of FIG. 6; and, FIG. 9 is a cross-sectional view taken along line 9-9 of FIG. 8.

Broken lines shown in the drawings illustrate portions of the support for embedding objects in concrete that form no part of the claimed design.

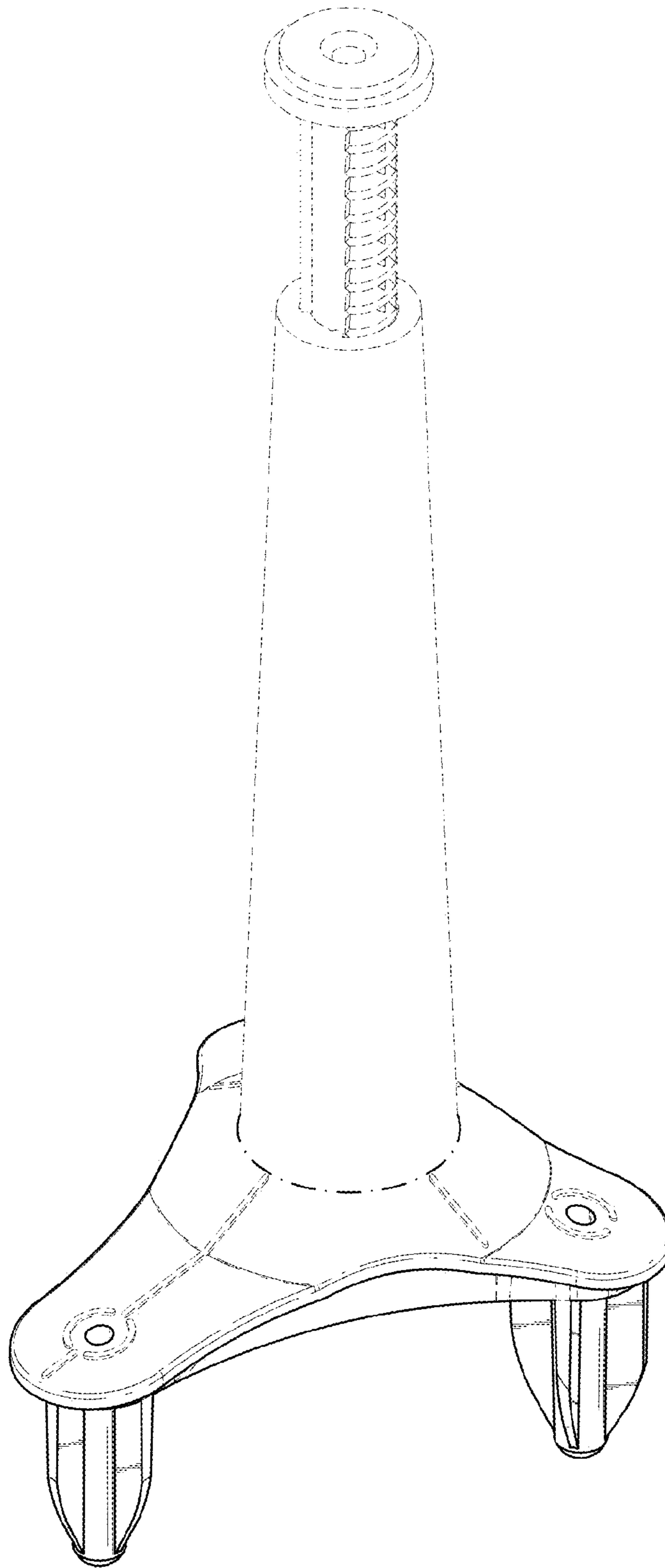

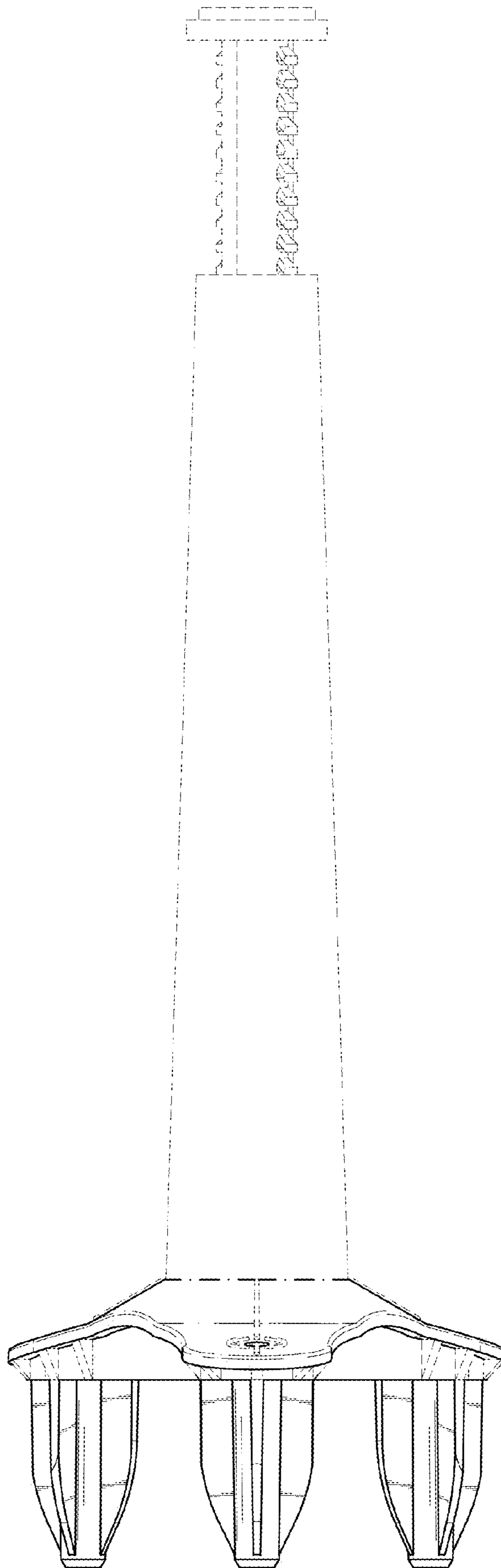

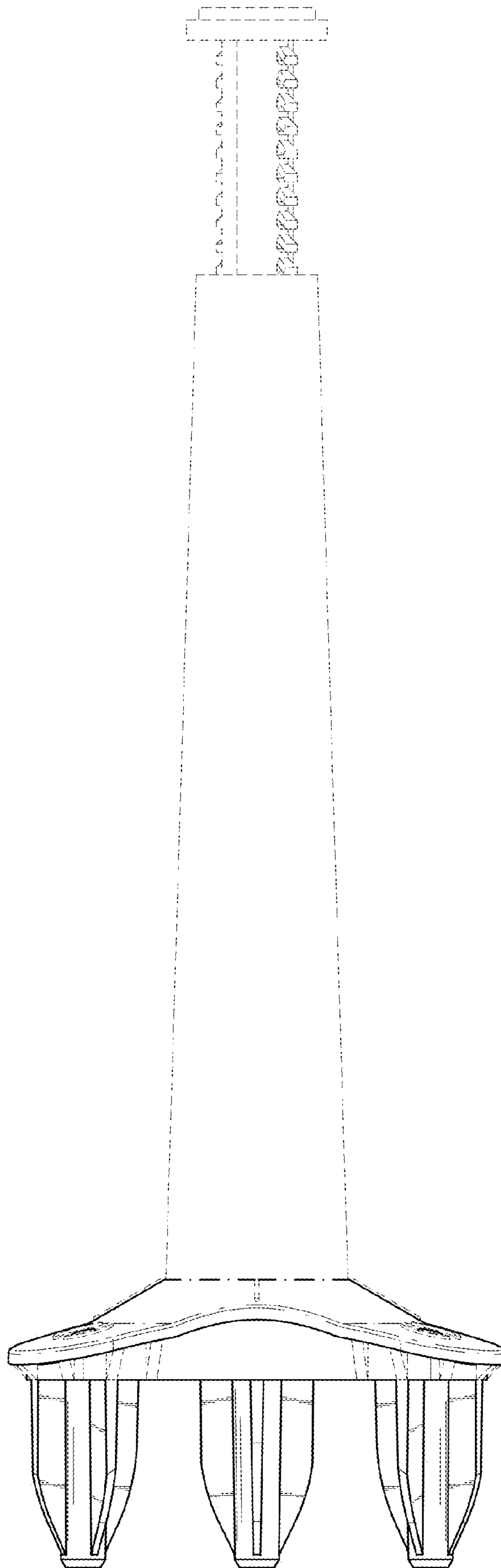

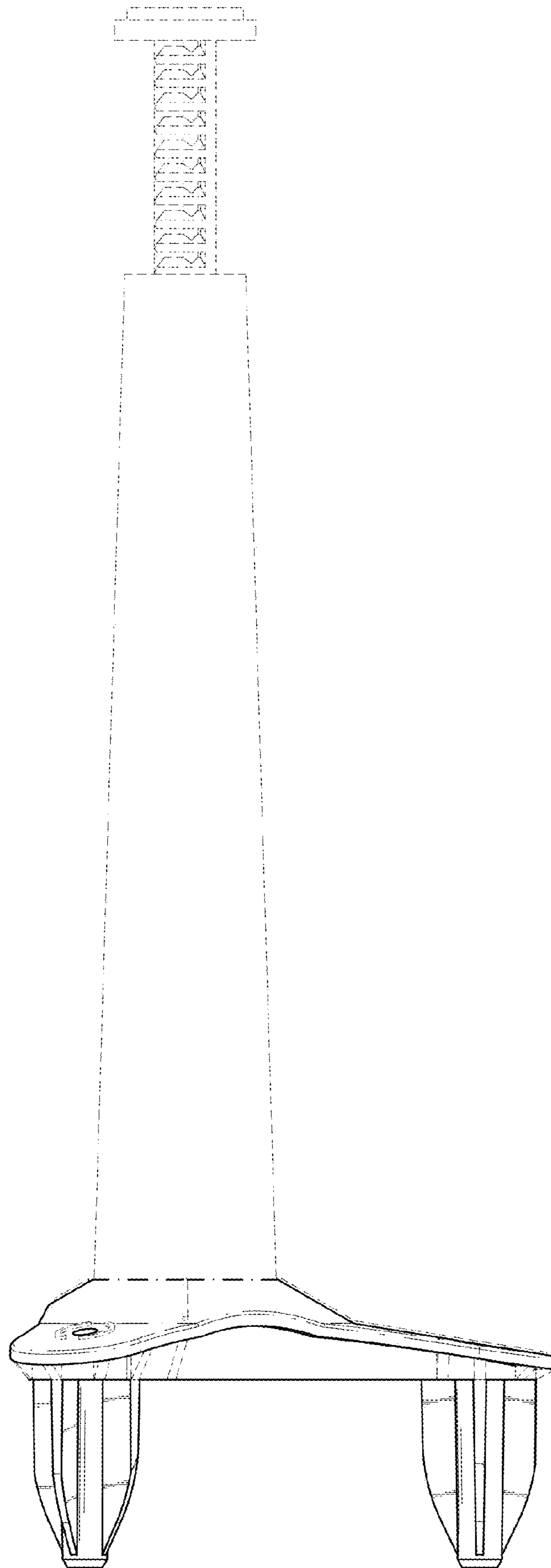

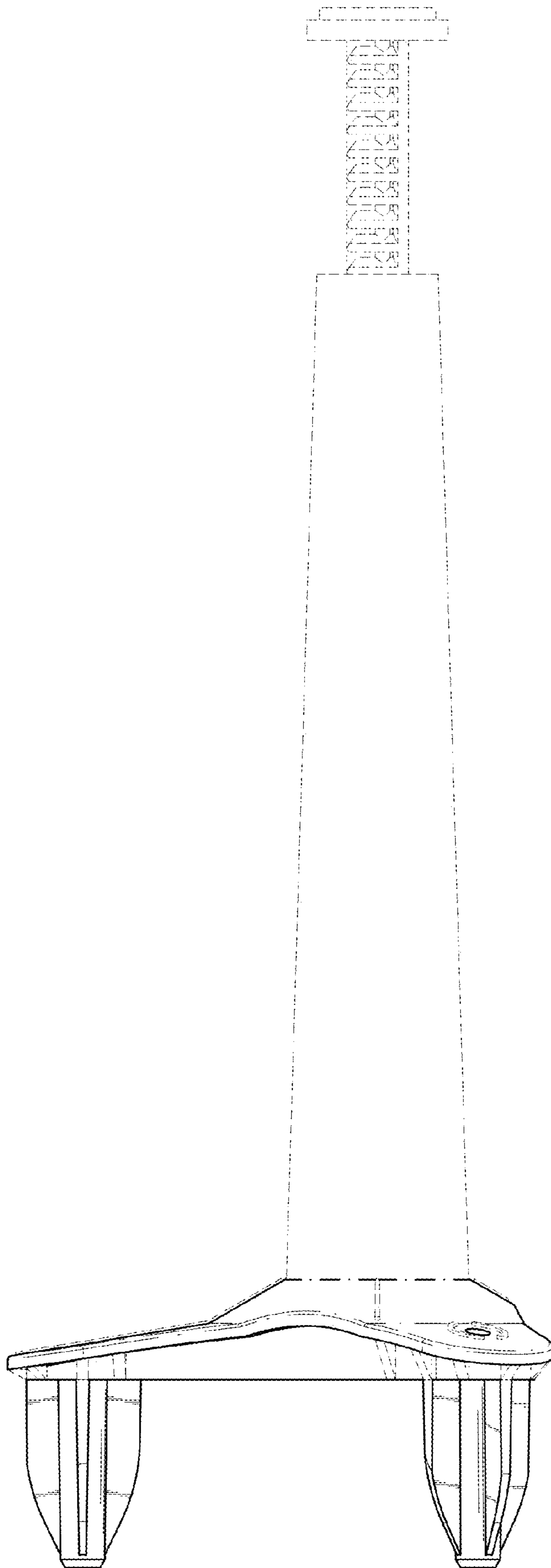

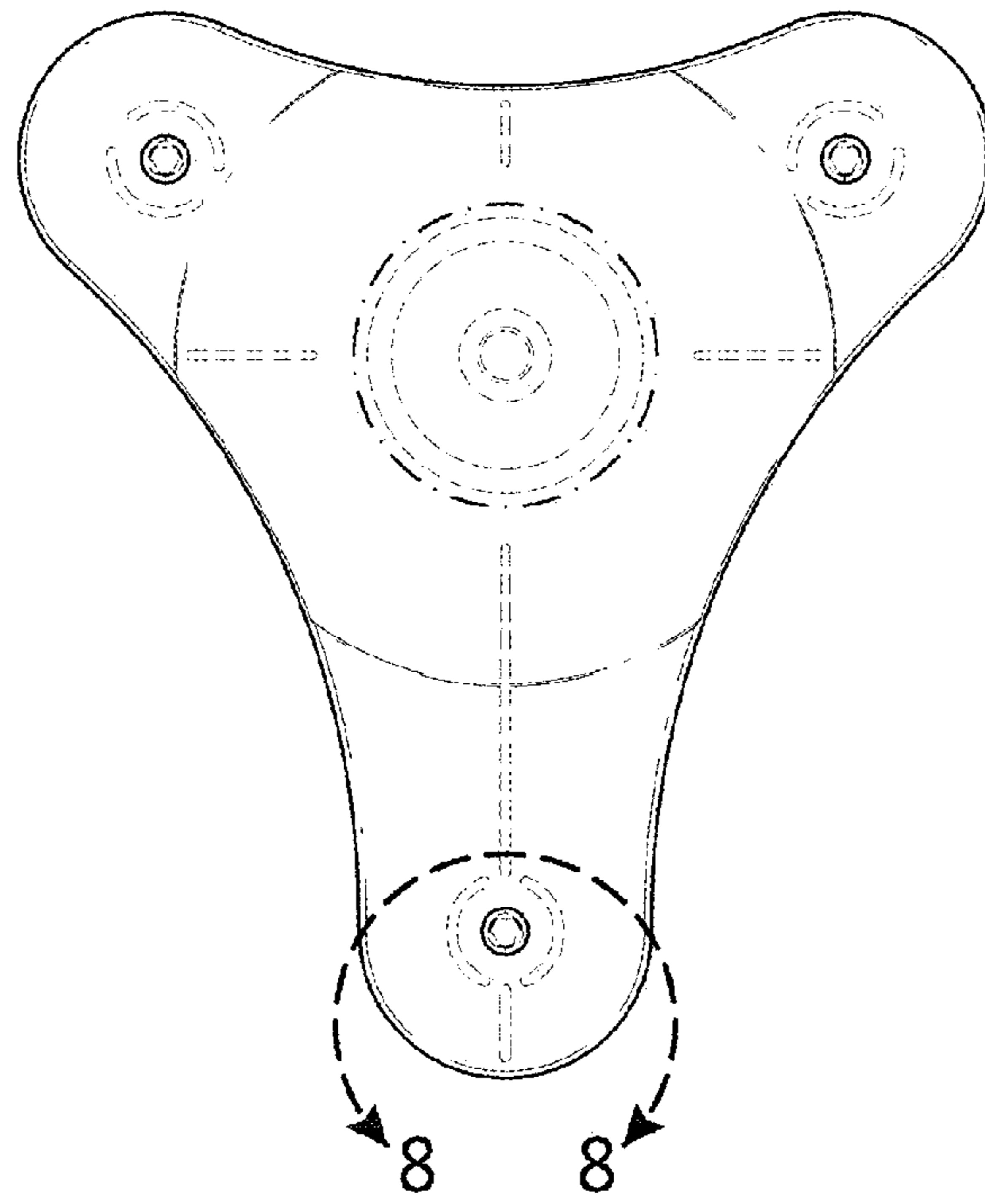

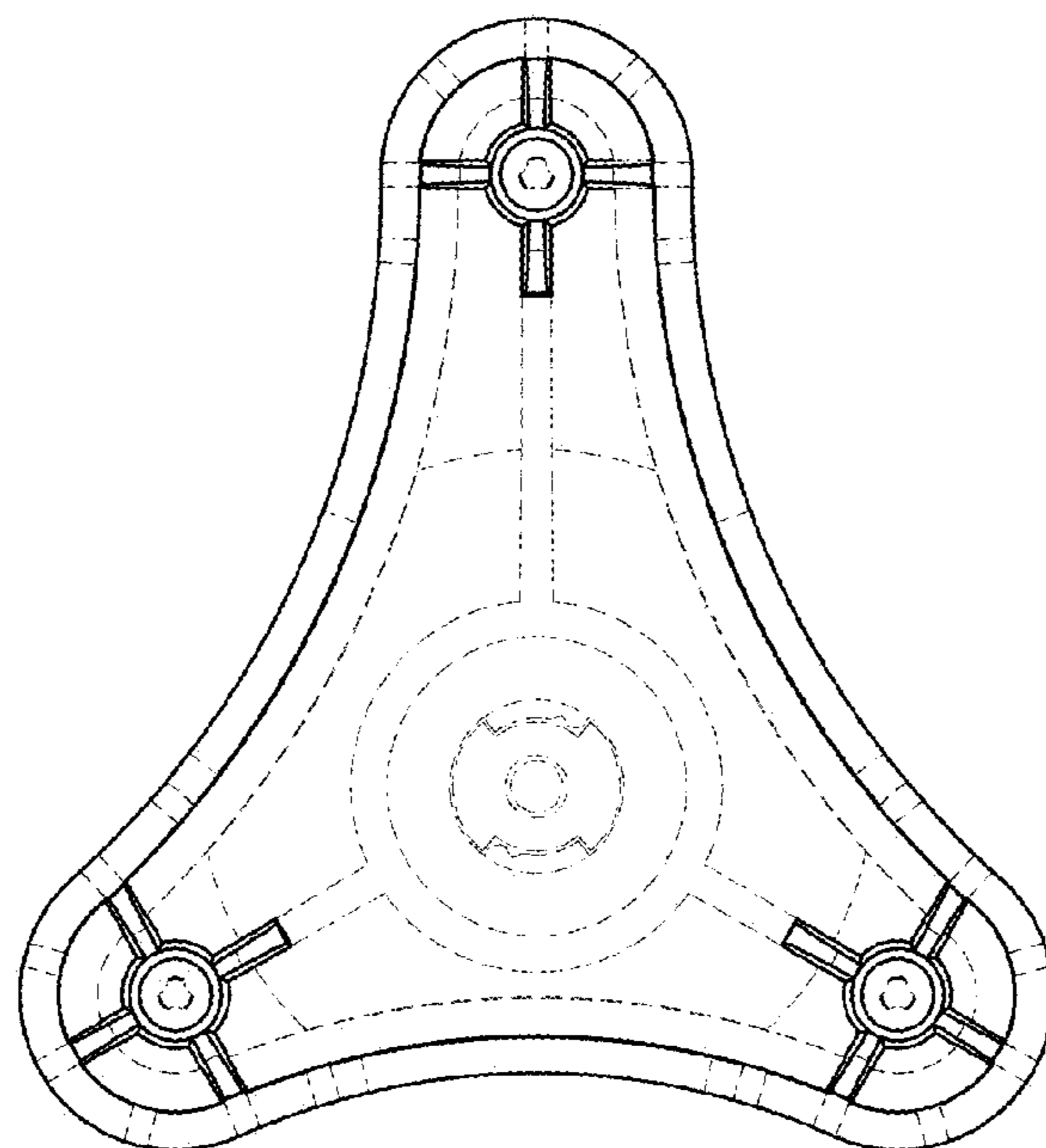

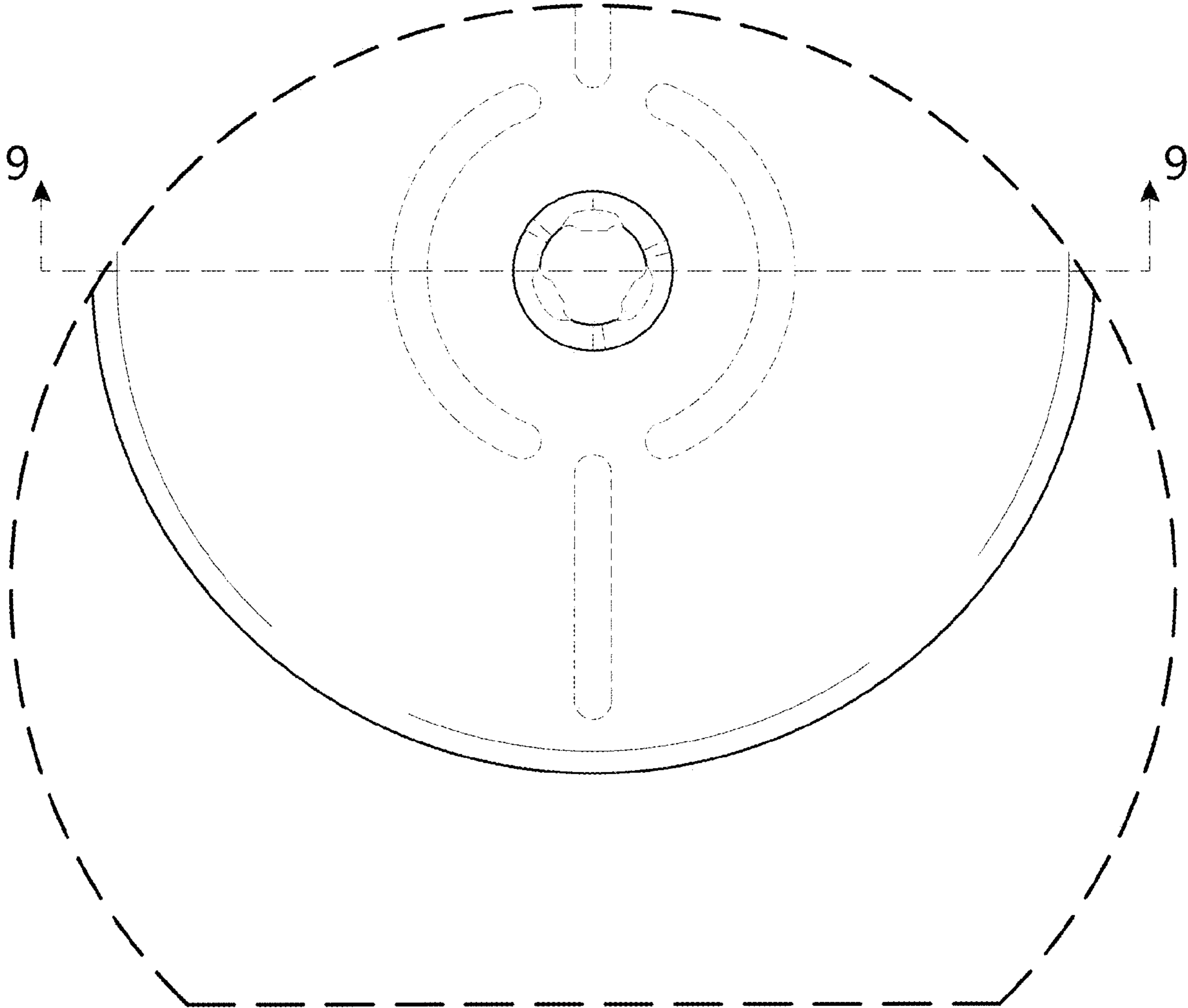

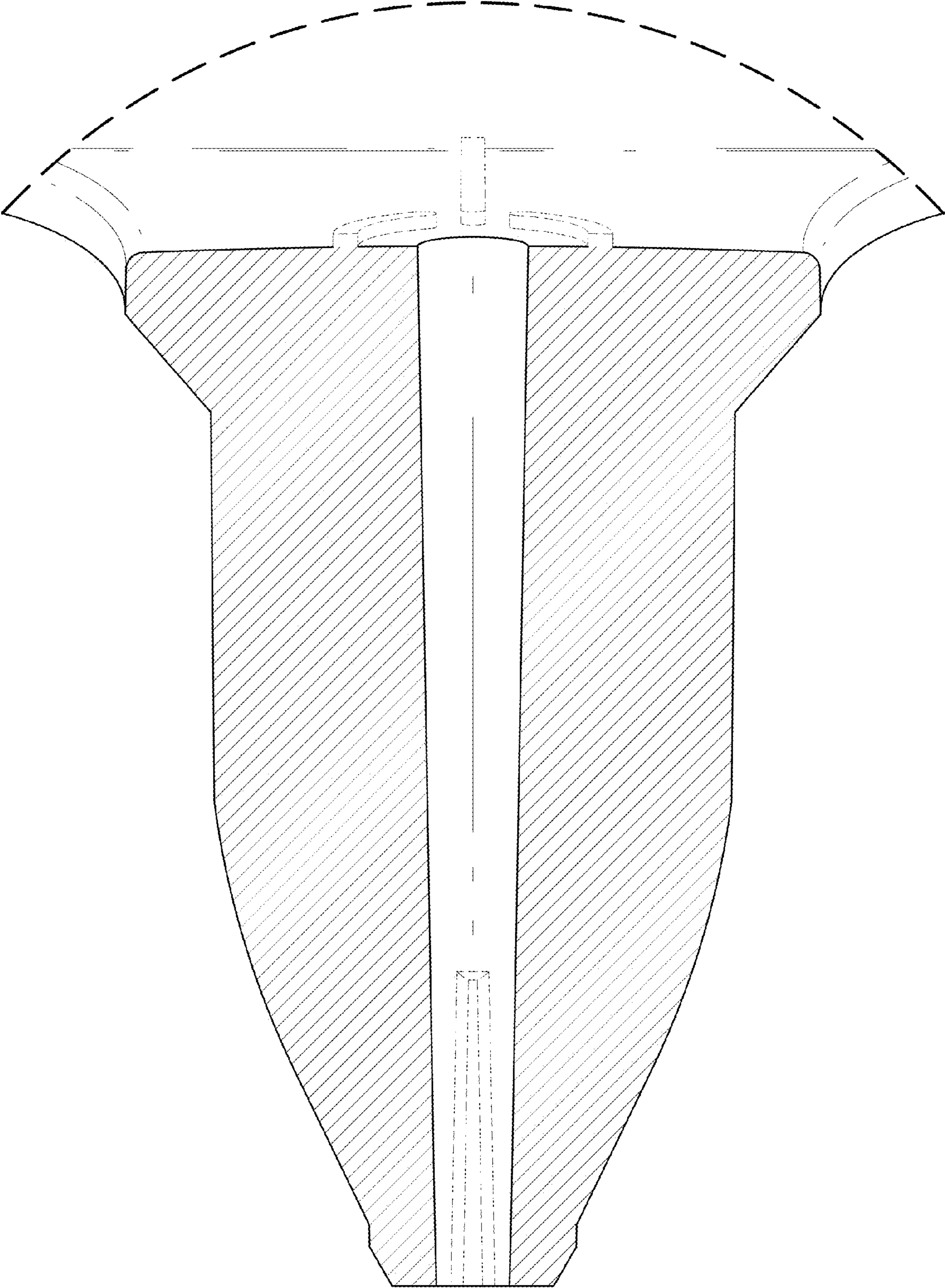
