The ornamental design for a gift and gift card packaging, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the gift and gift card packaging of the present invention, with box in a closed position.

FIG. 2 is a bottom up view of the gift and gift card packaging of FIG. 1.

FIG. 3 is a top down view of the gift and gift card packaging of FIG. 1.

FIG. 4 is a right side view of the gift and gift card packaging of FIG. 1, the left side view being a mirror image thereof.

FIG. 5 is a front view of the gift and gift card packaging of FIG. 1.

FIG. 6 is a rear view of the gift and gift card packaging of FIG. 1.

FIG. 7 is a perspective view of the gift and gift card packaging of FIG. 1, with box in an open position.

FIG. 8 is a bottom up view of the gift and gift card packaging of FIG. 7.

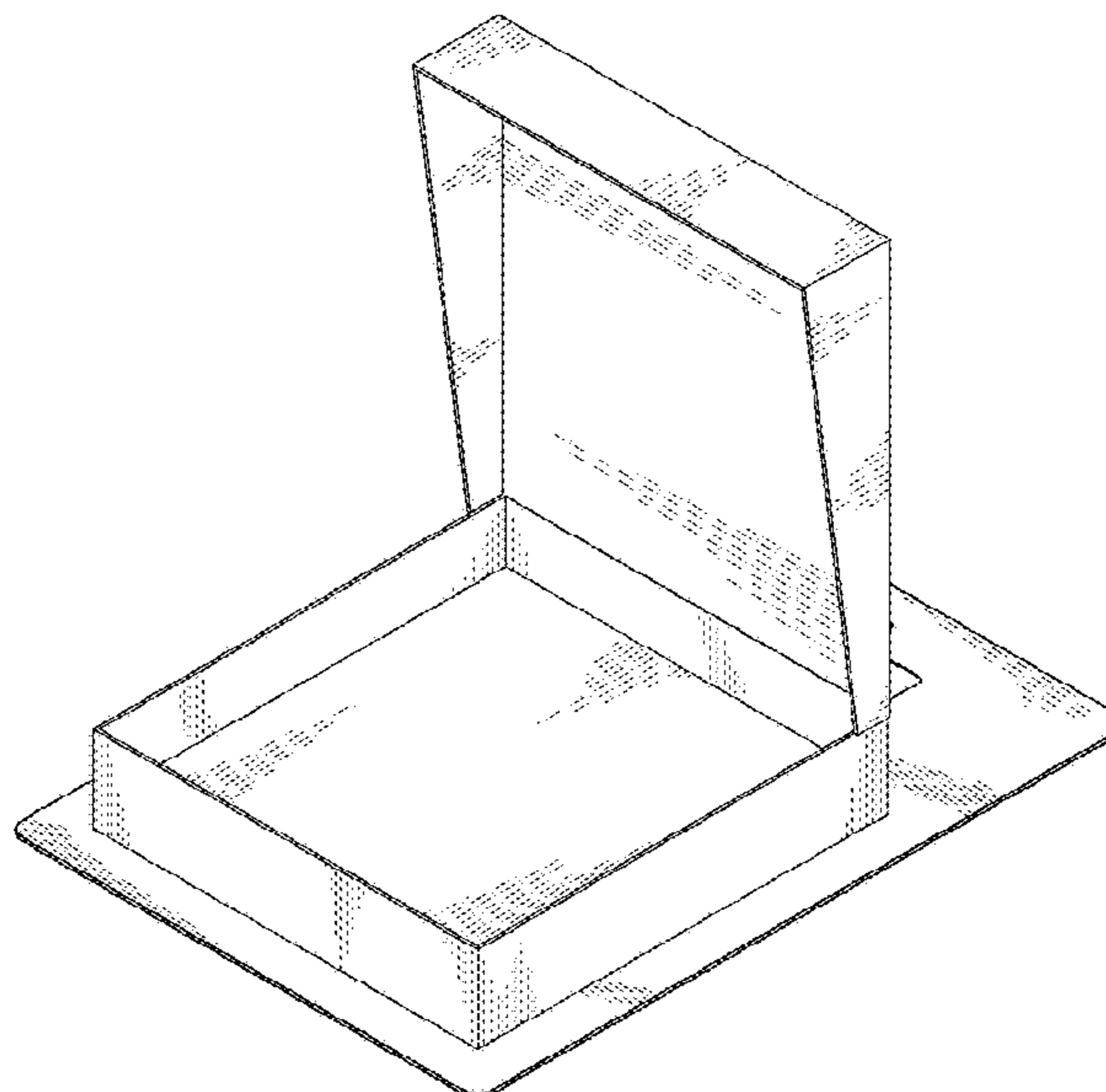
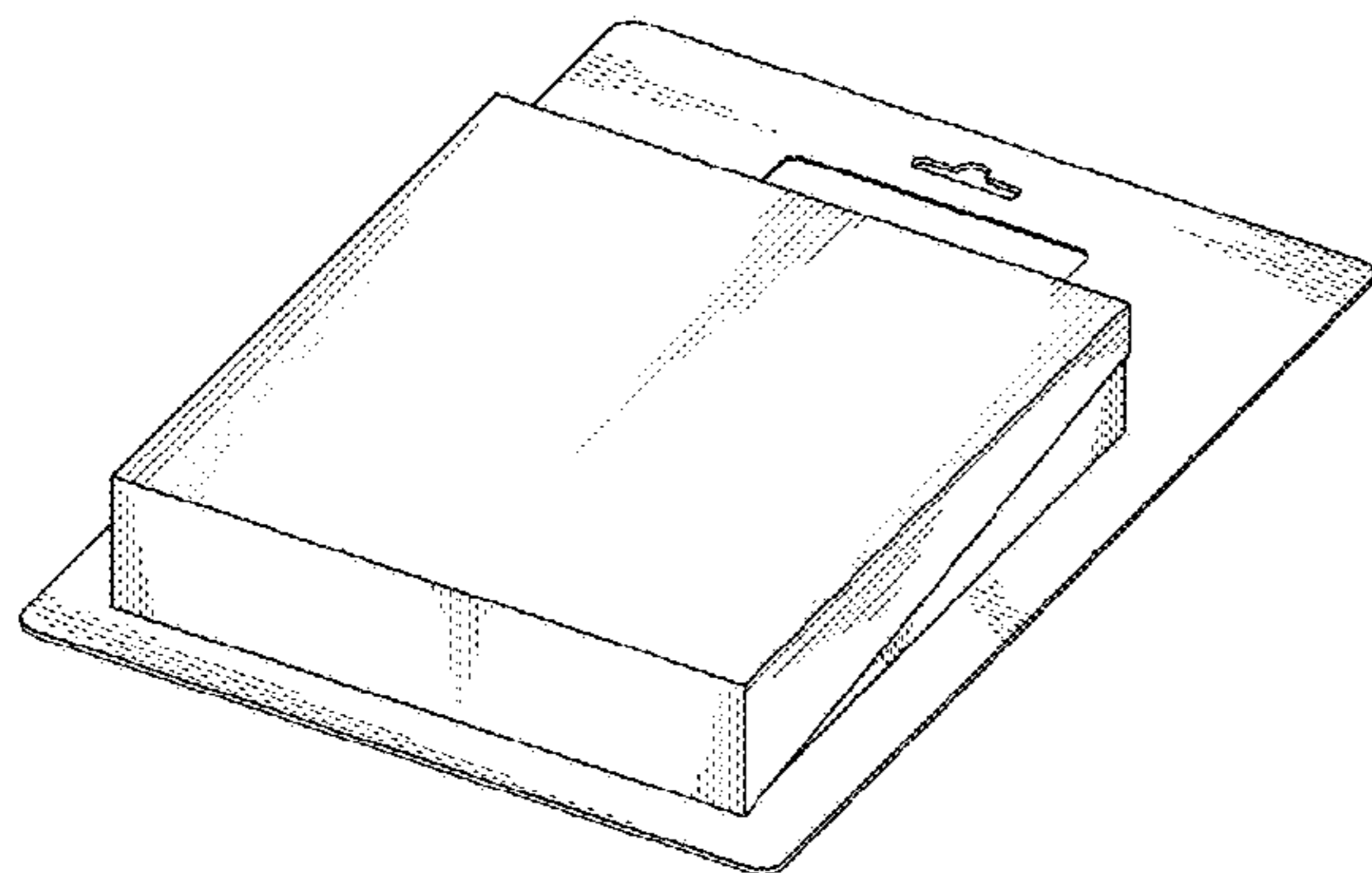
FIG. 9 is a top down view of the gift and gift card packaging of FIG. 7.

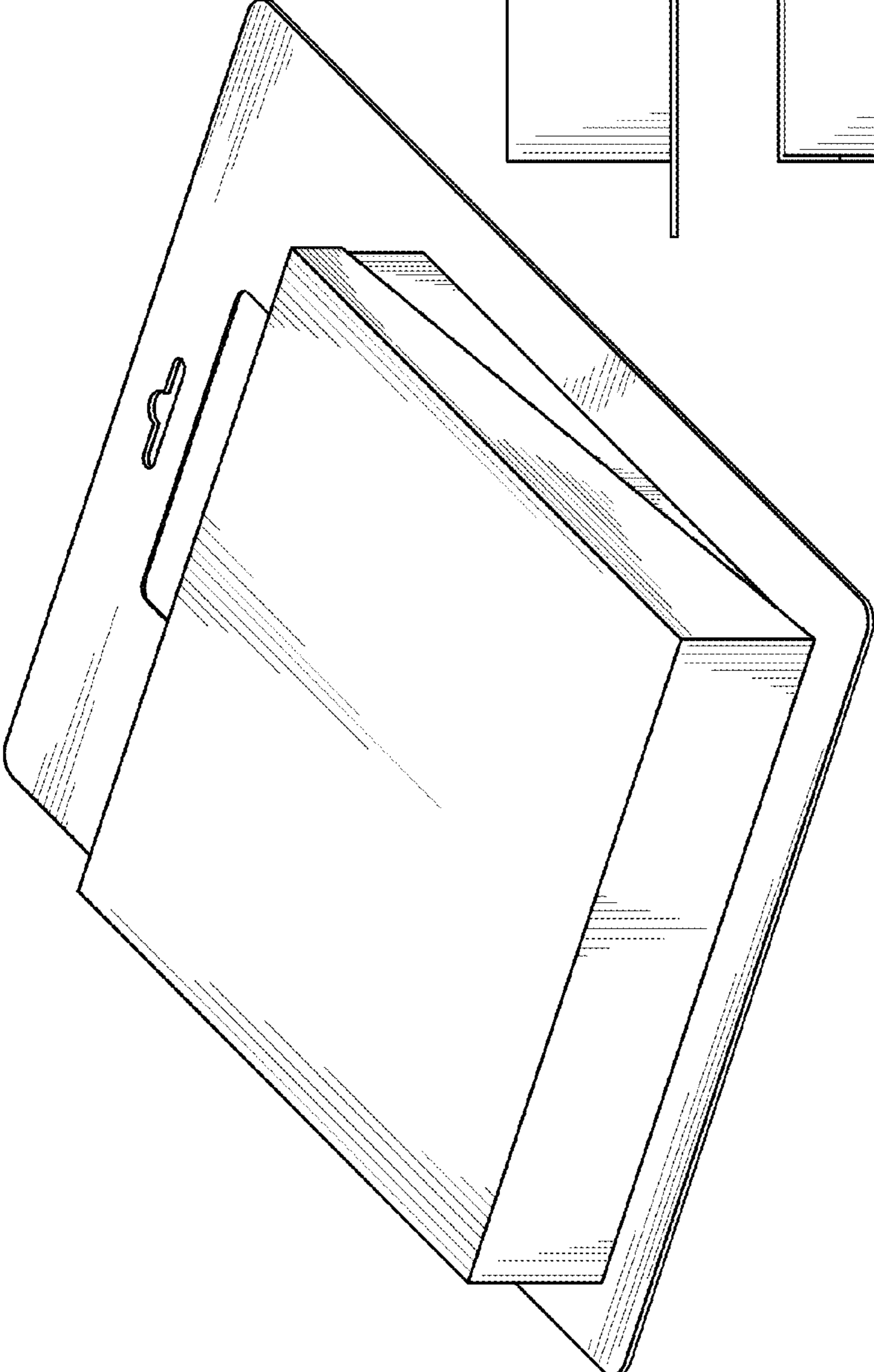

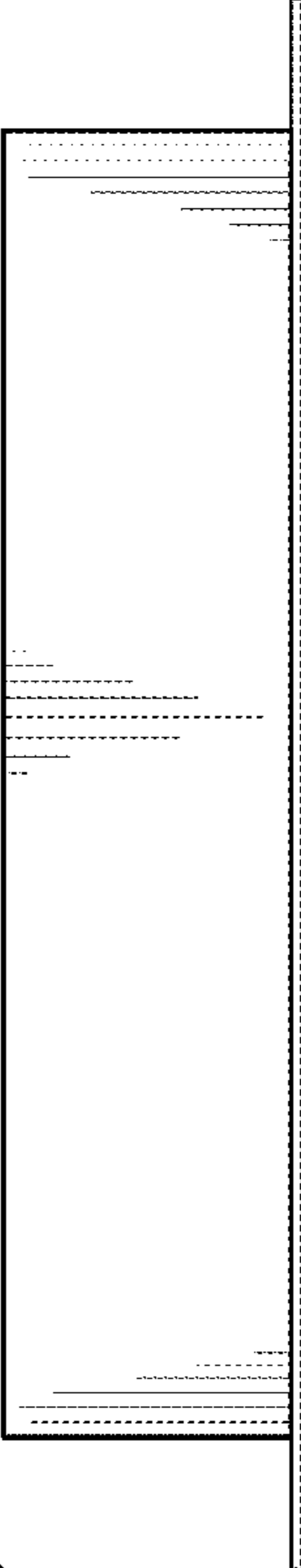

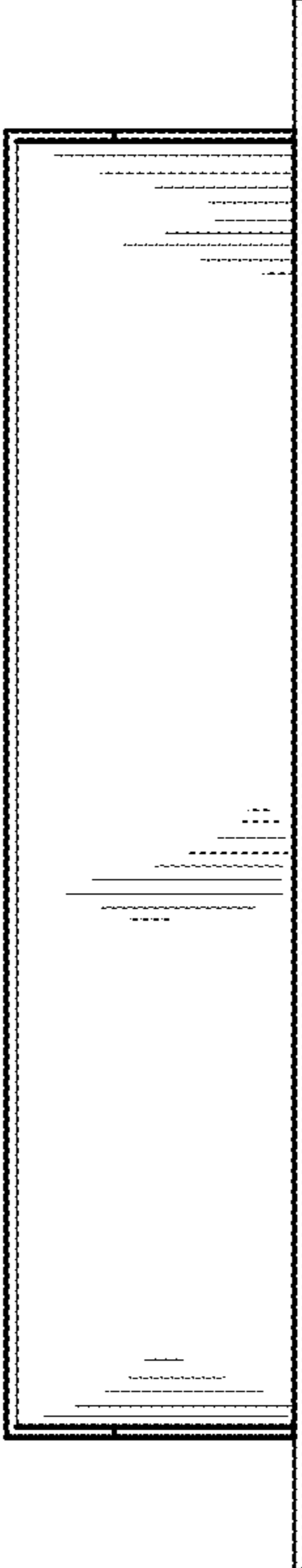

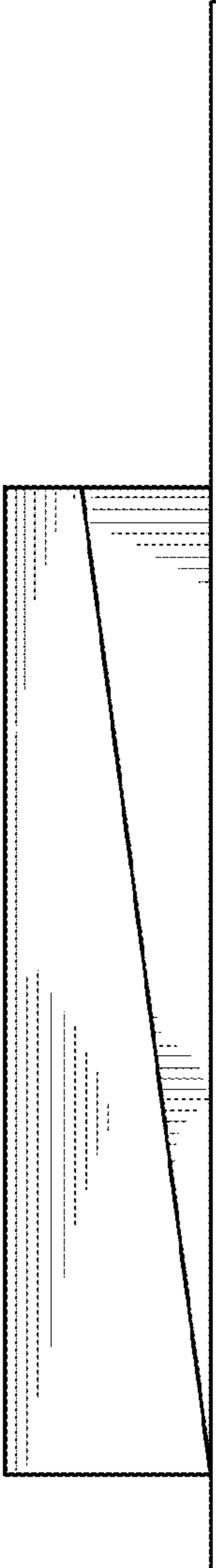

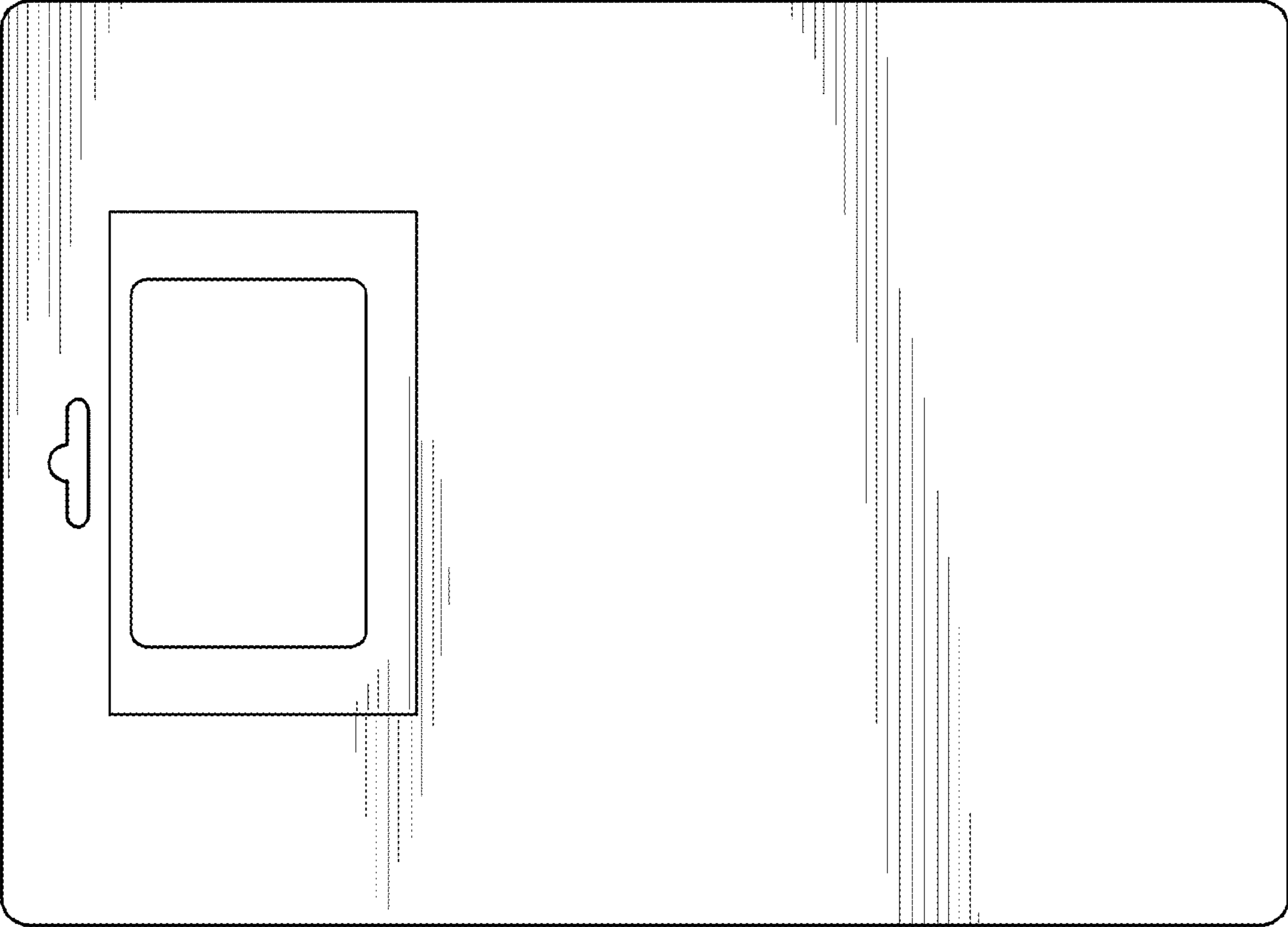

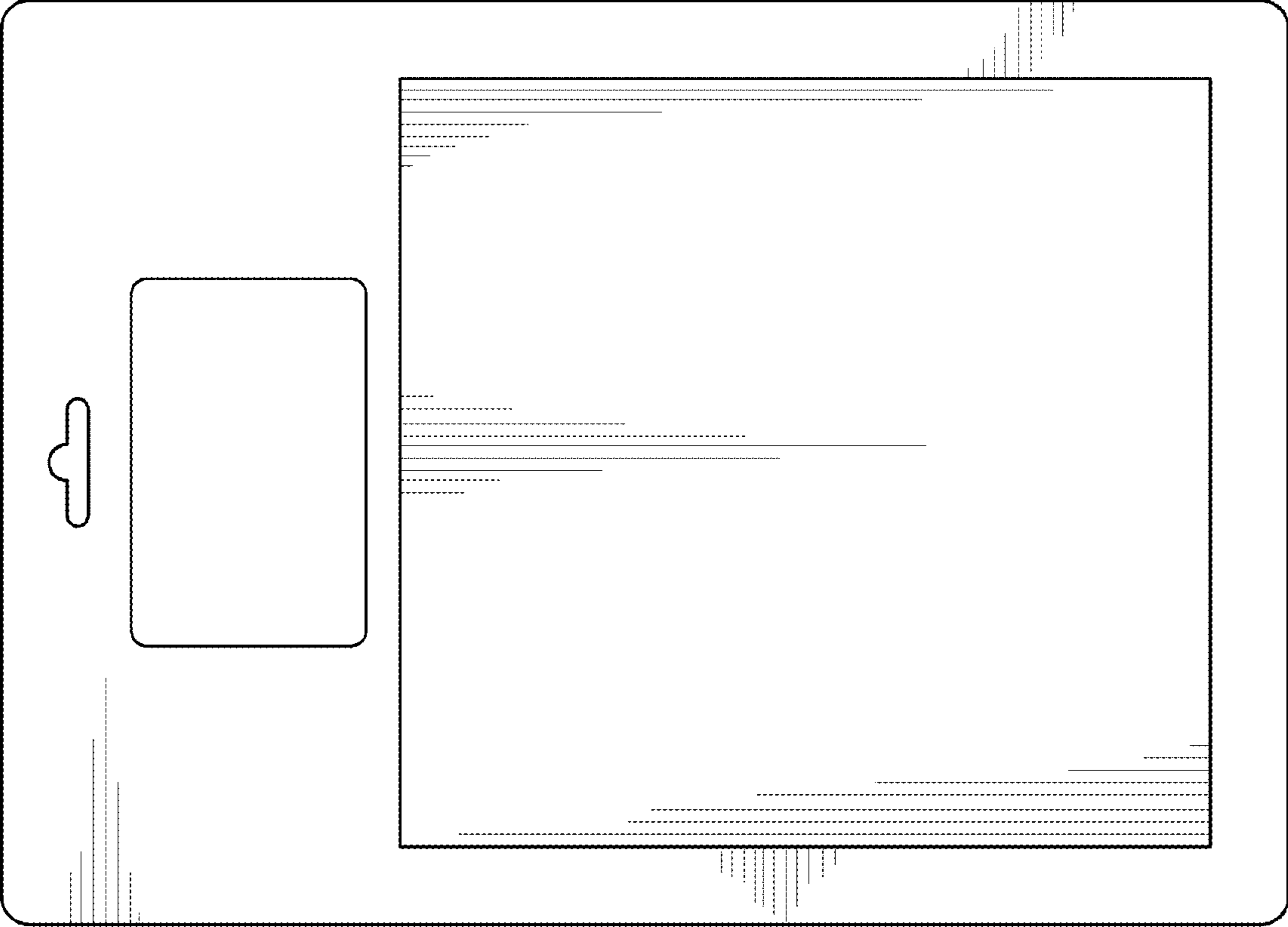

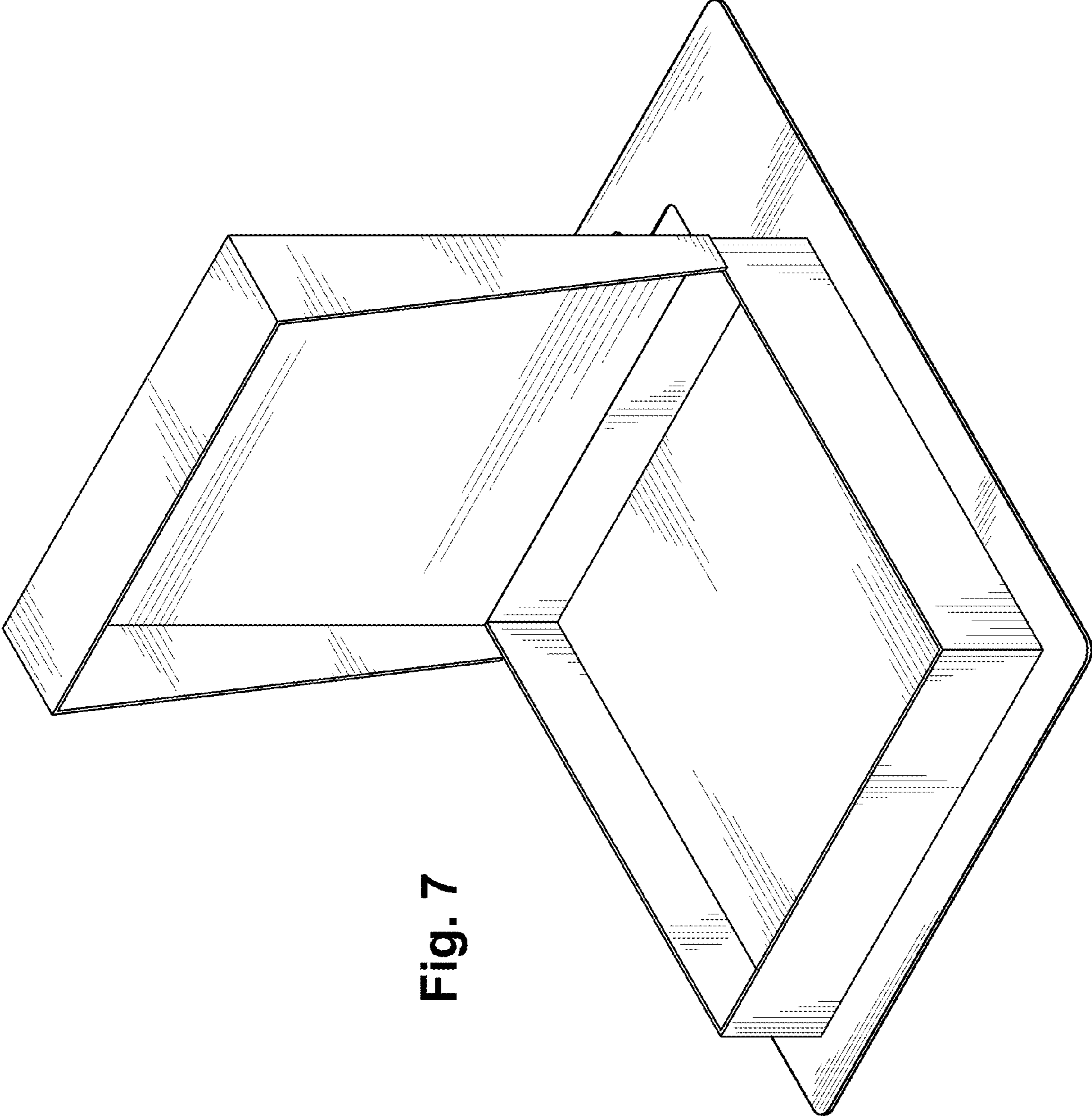

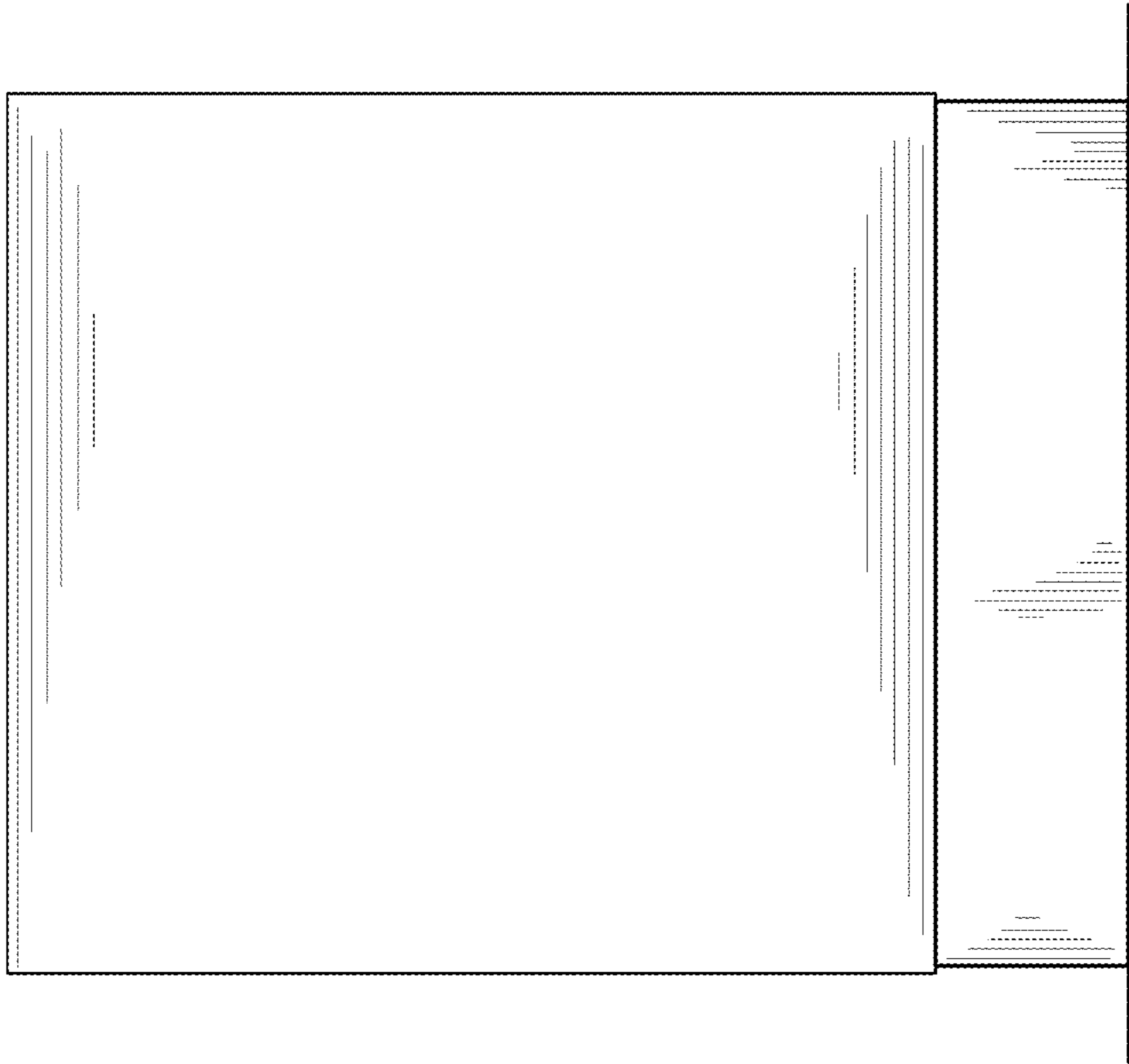

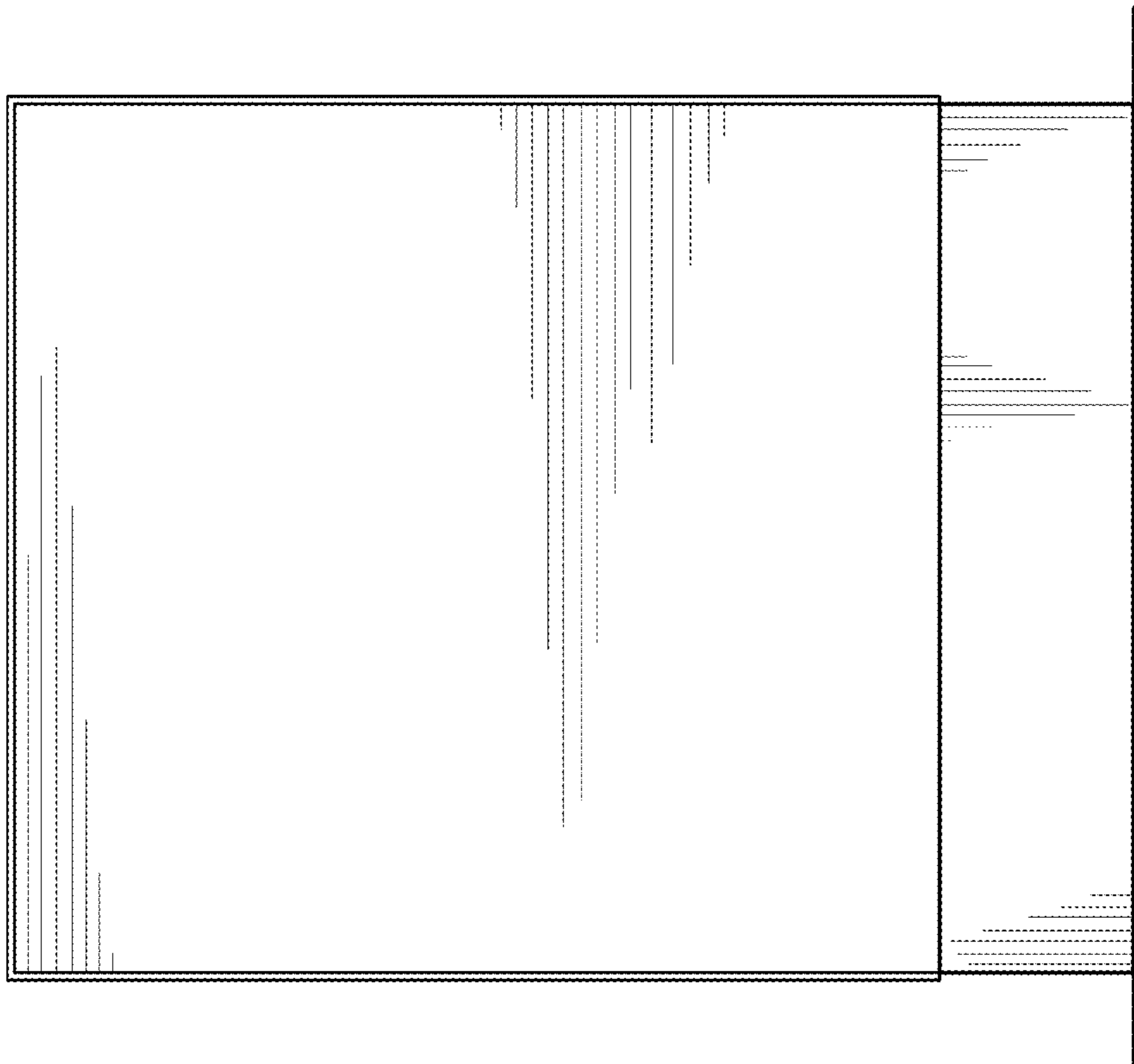

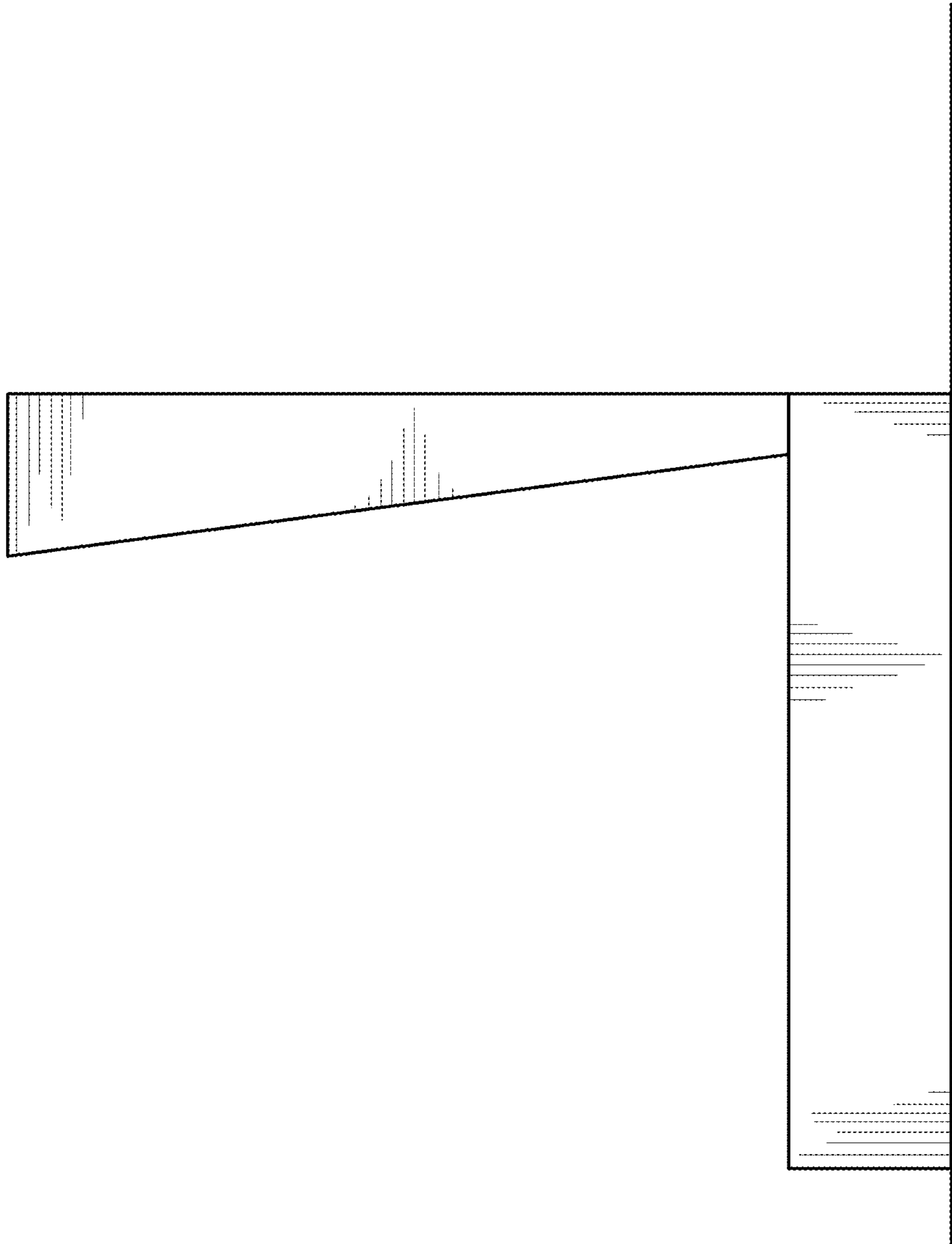

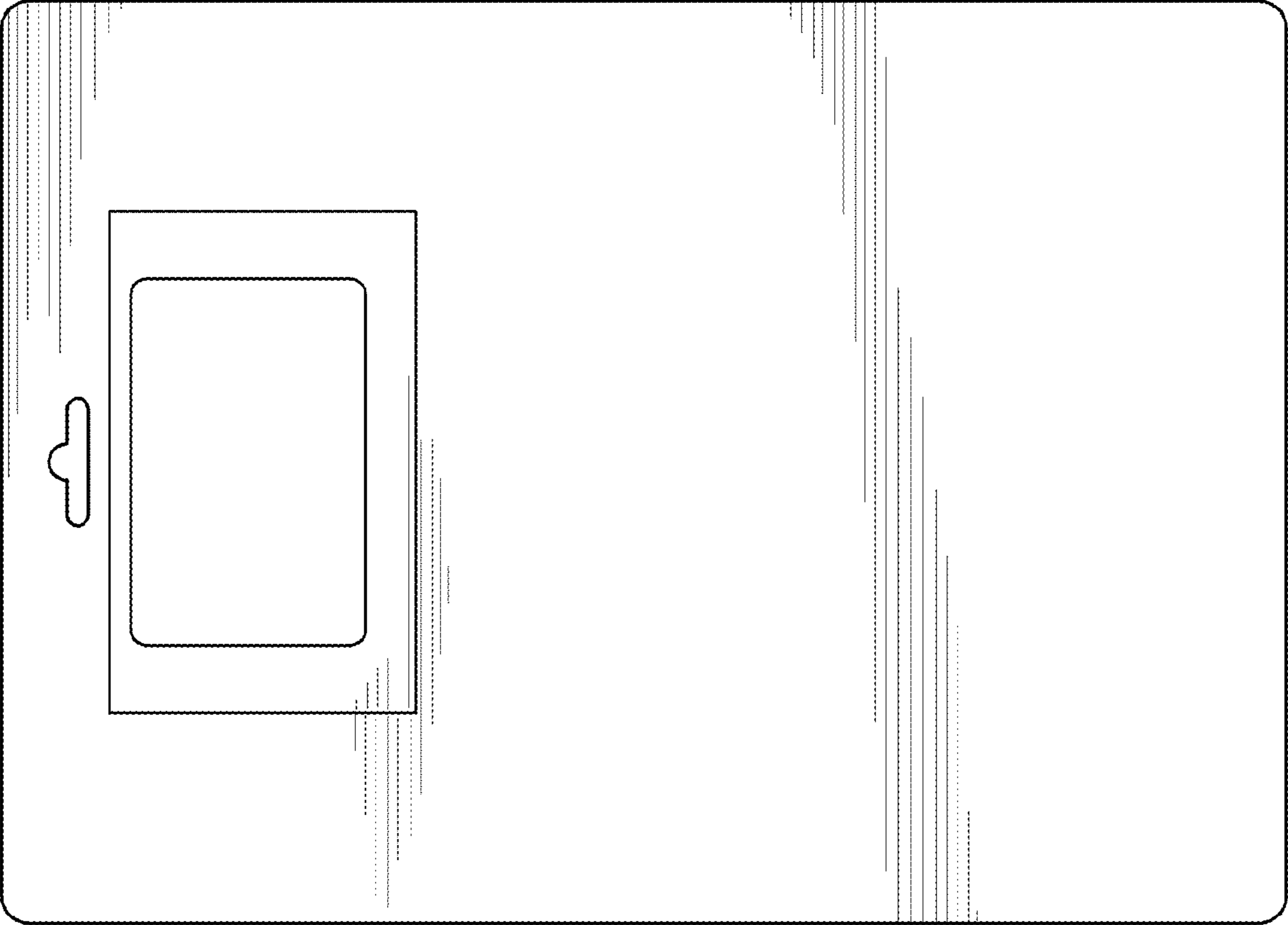

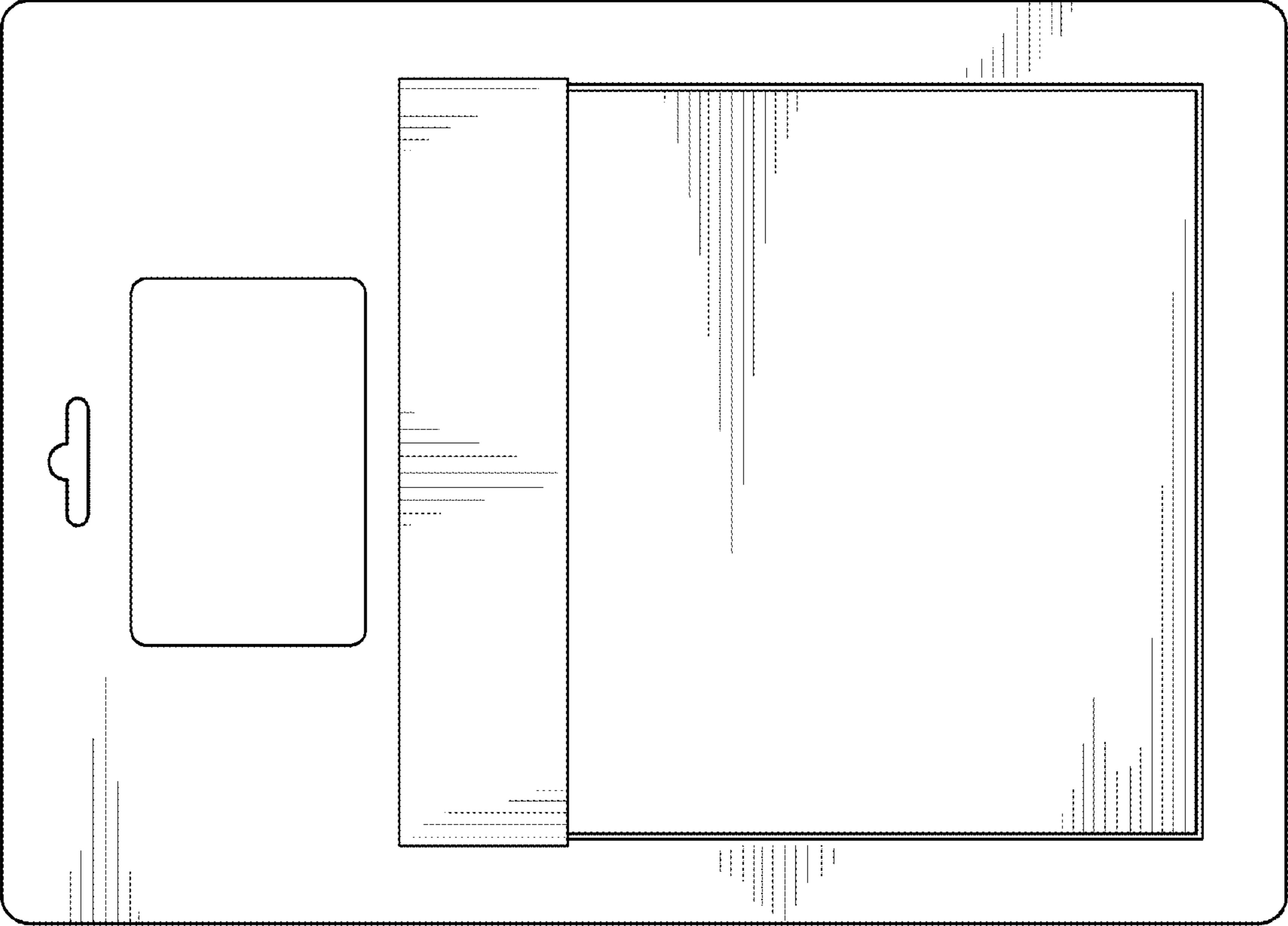
