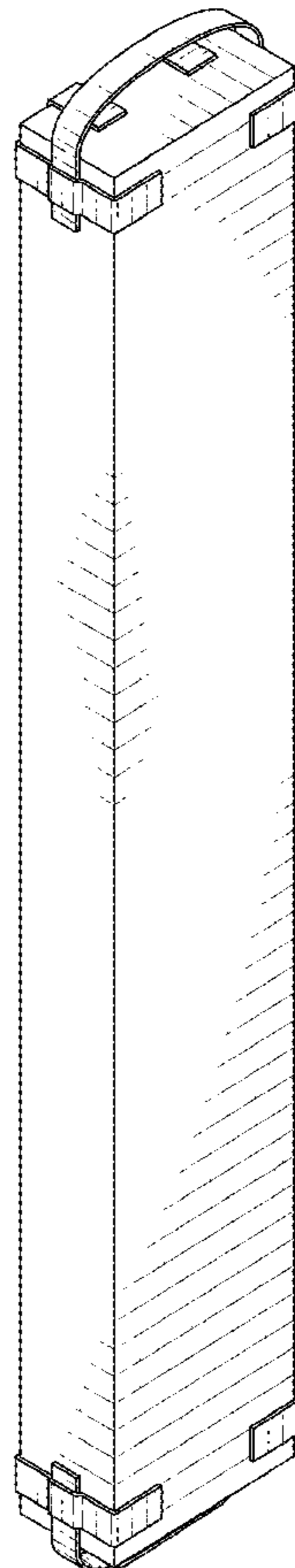
The ornamental design for a plastic carrying bag, as shown and described.

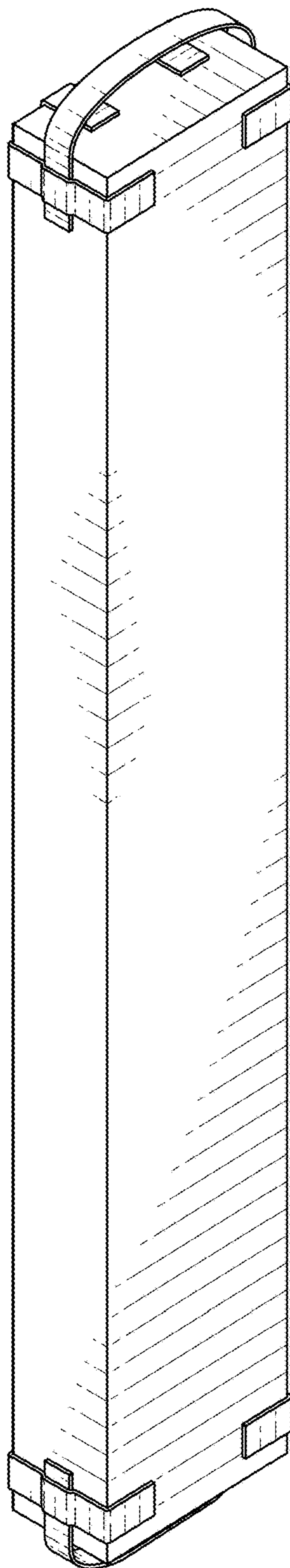

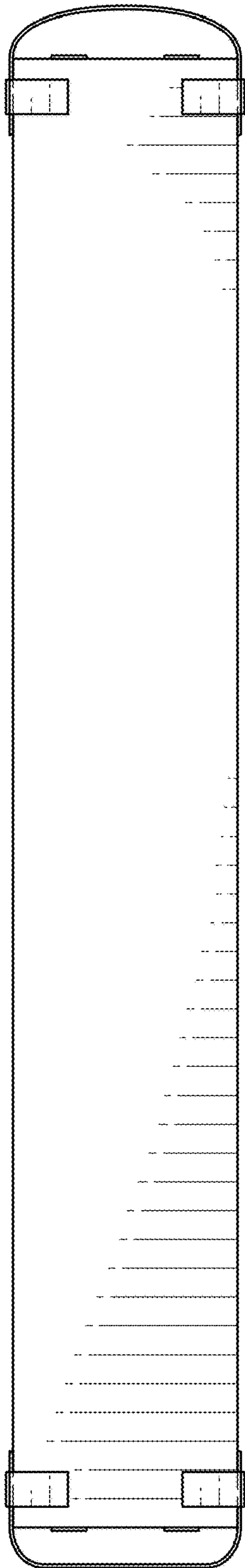

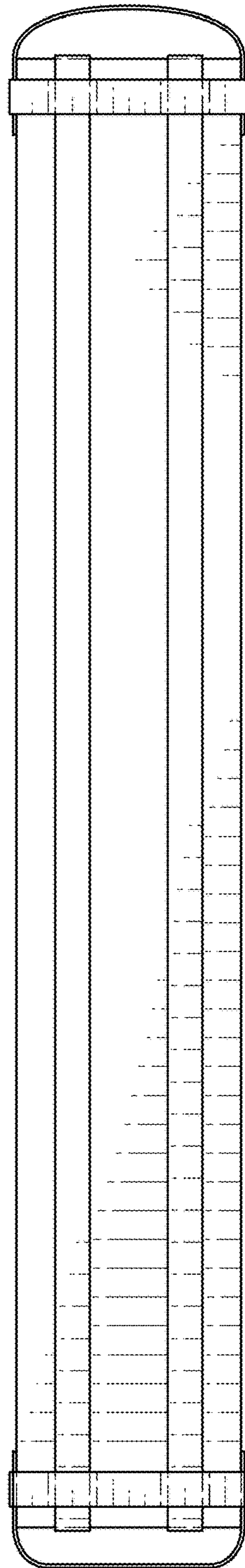

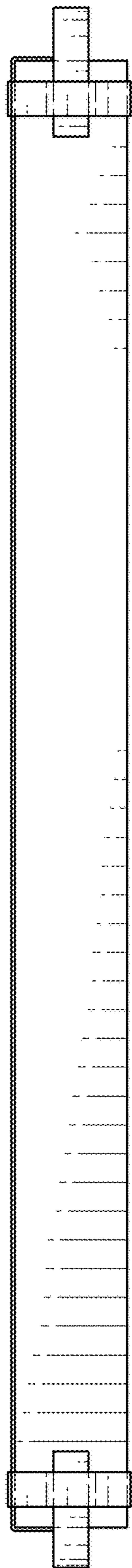

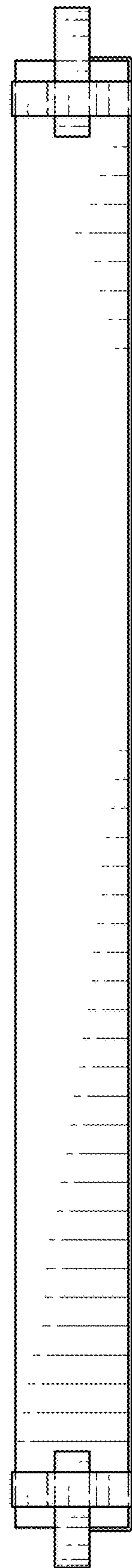

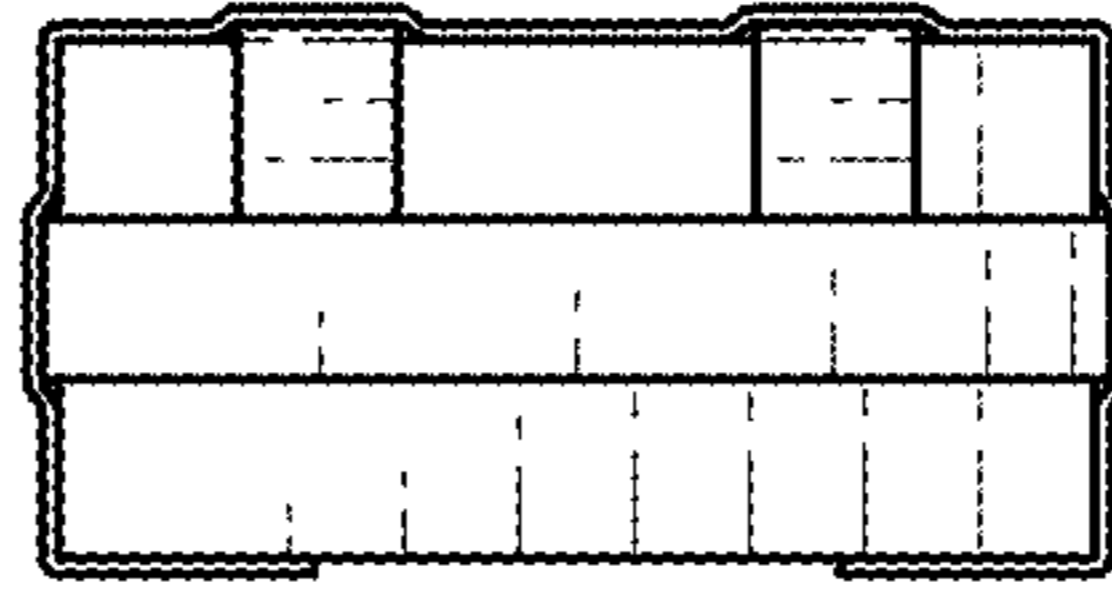

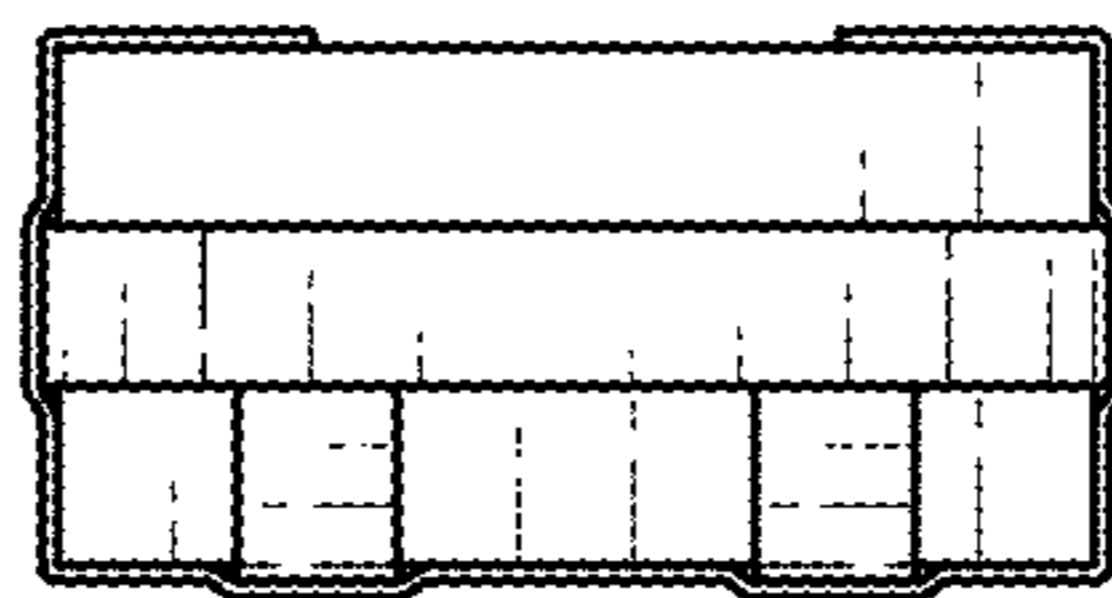
