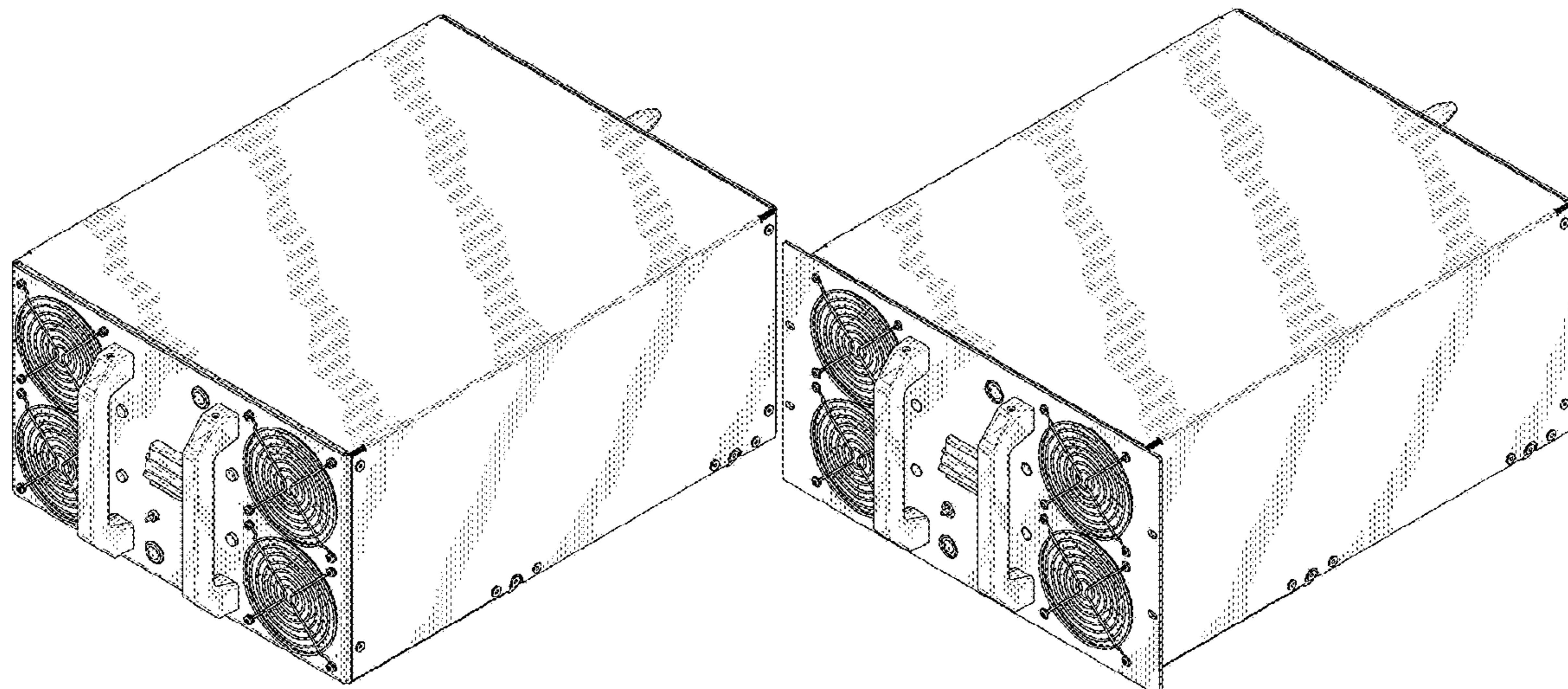
(57) **CLAIM**

The ornamental design for a power supply, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of a first embodiment of a power supply, showing my new design; FIG. 2 is a top, rear, left perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a top, front, left perspective view of a second embodiment of a power supply, showing my new design; FIG. 10 is a top, rear, left perspective view thereof; FIG. 11 is a front elevation view thereof; FIG. 12 is a rear elevation view thereof; FIG. 13 is a right side elevation view thereof; FIG. 14 is a left side elevation view thereof; FIG. 15 top plan view thereof; and, FIG. 16 is a bottom plan view thereof. 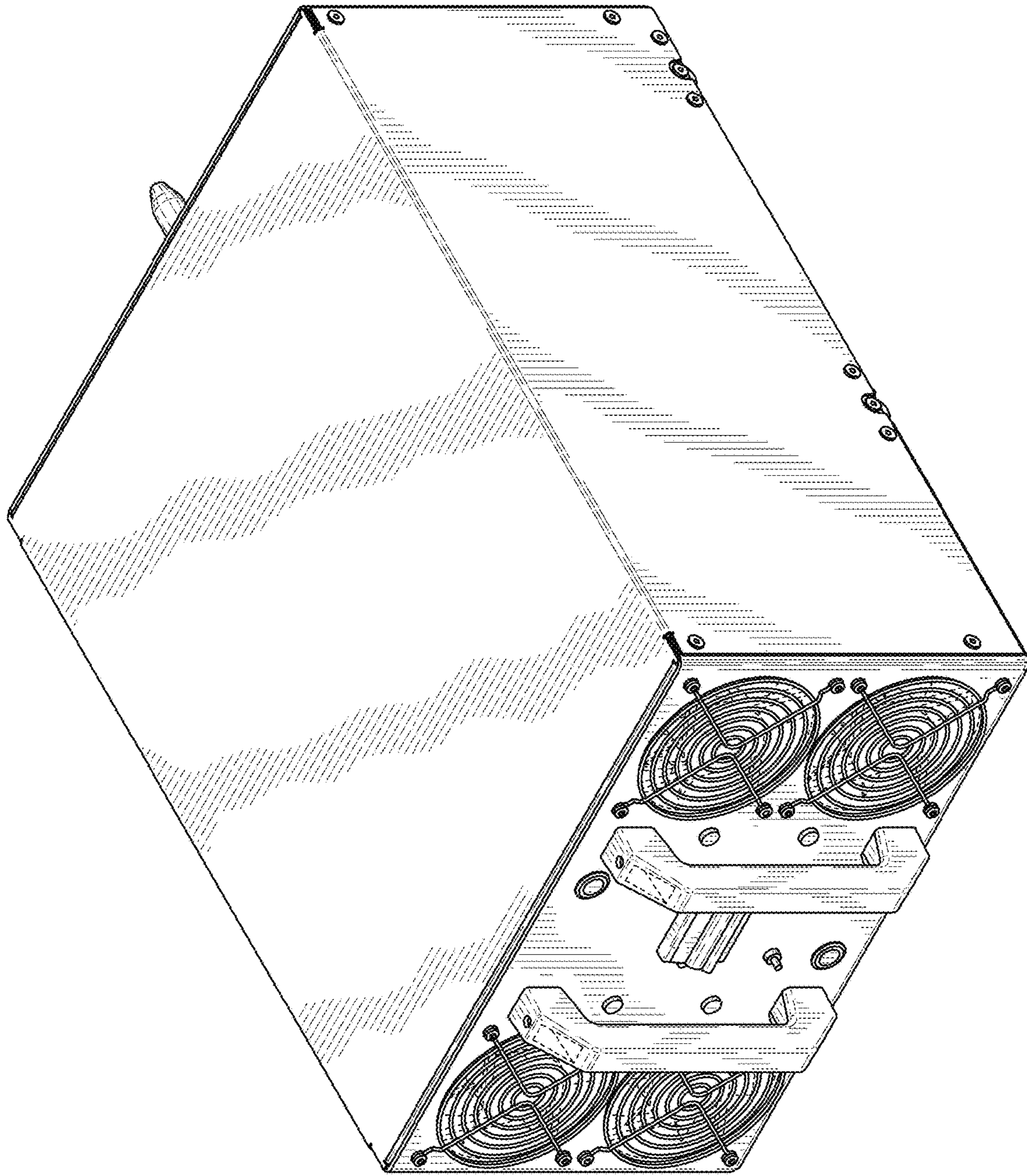

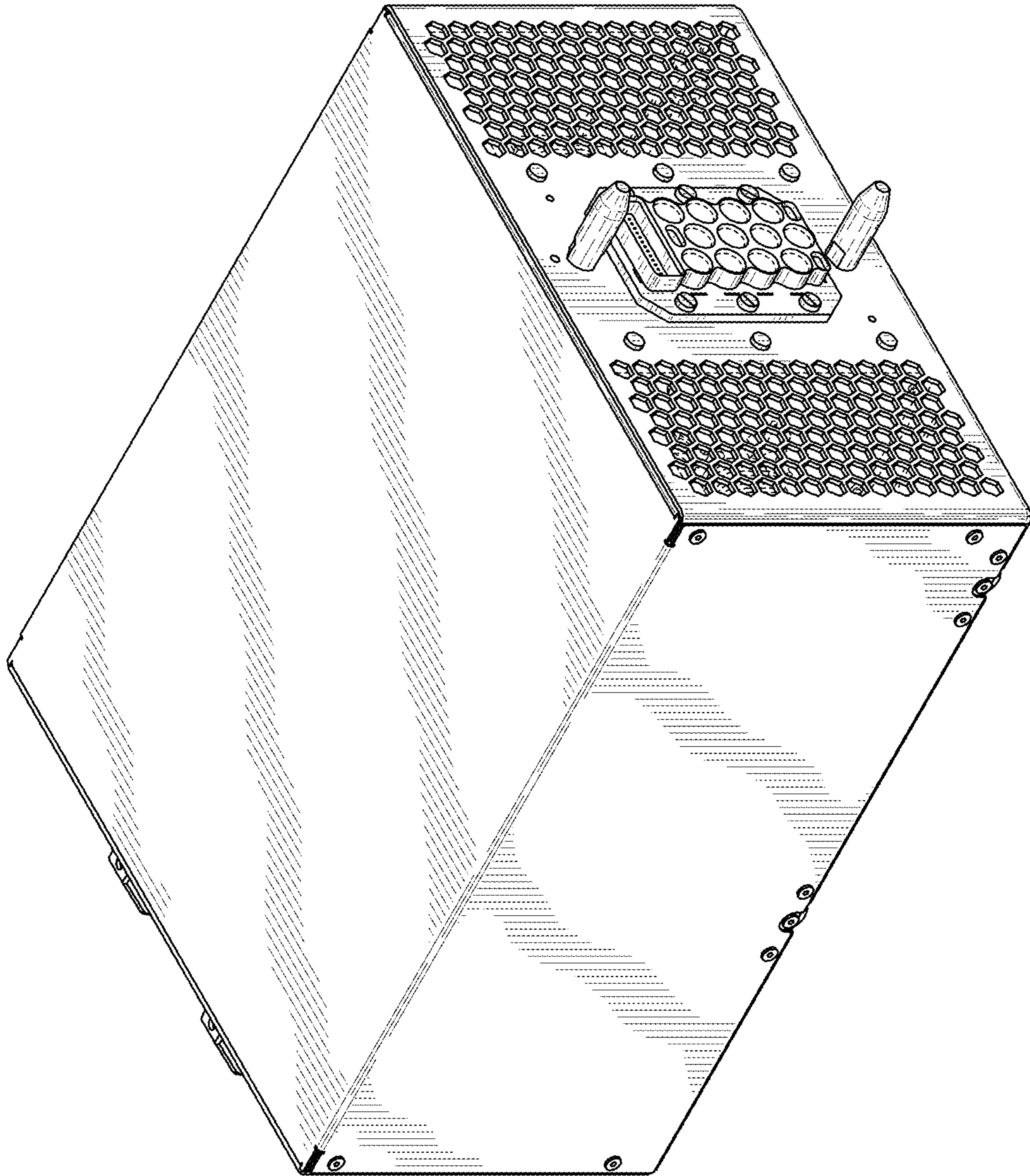

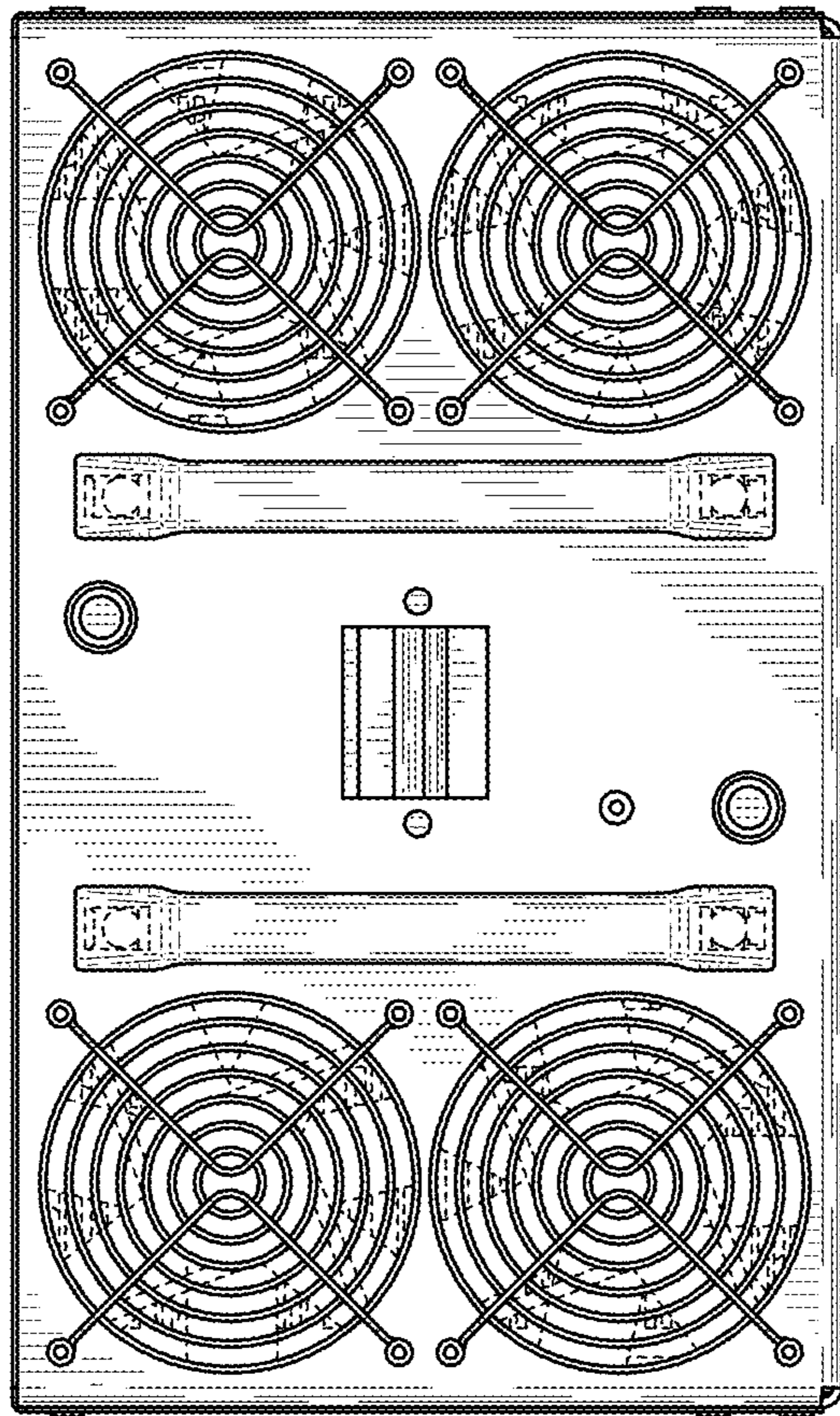

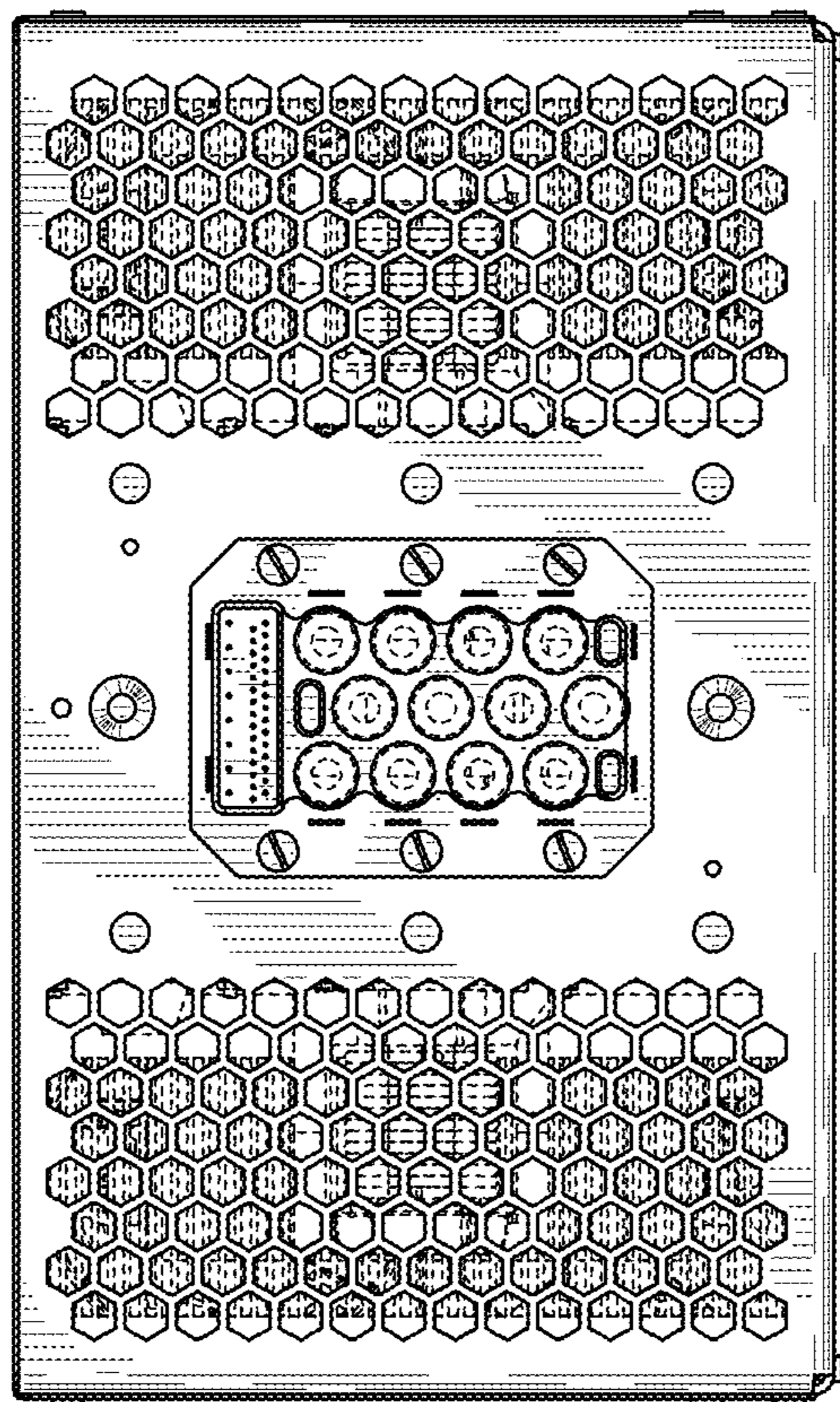

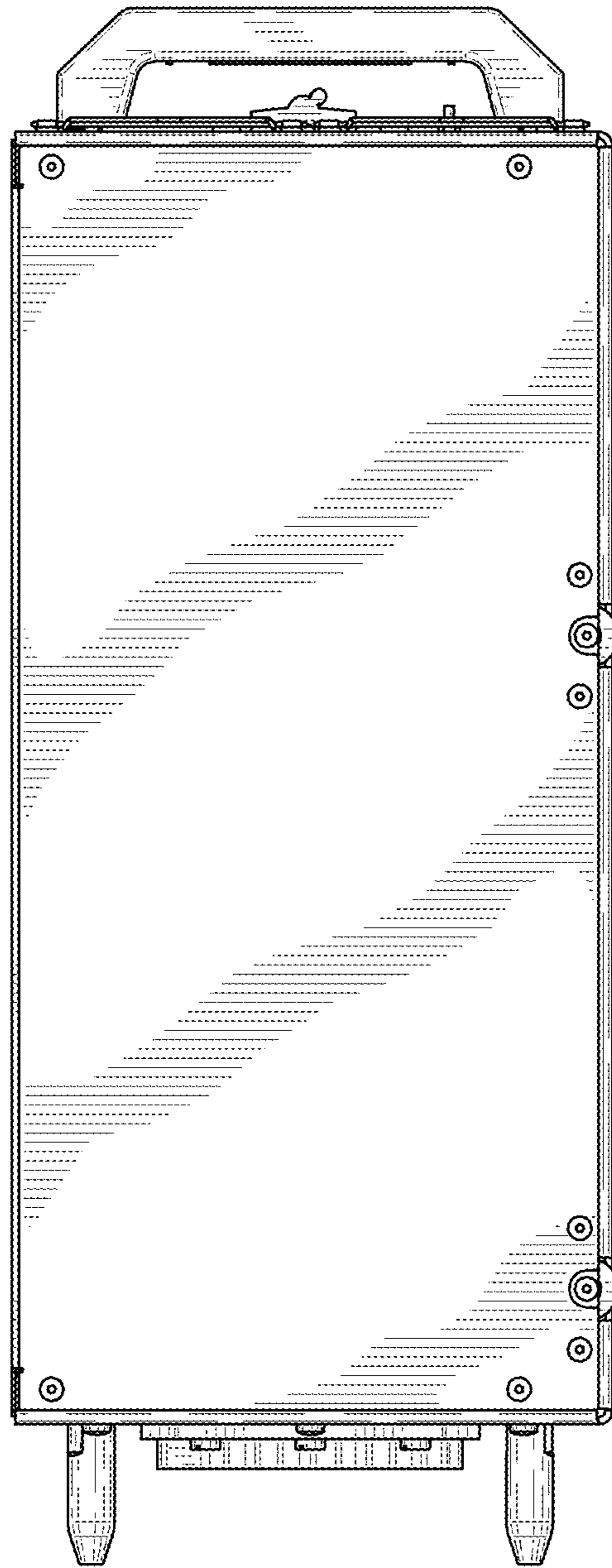

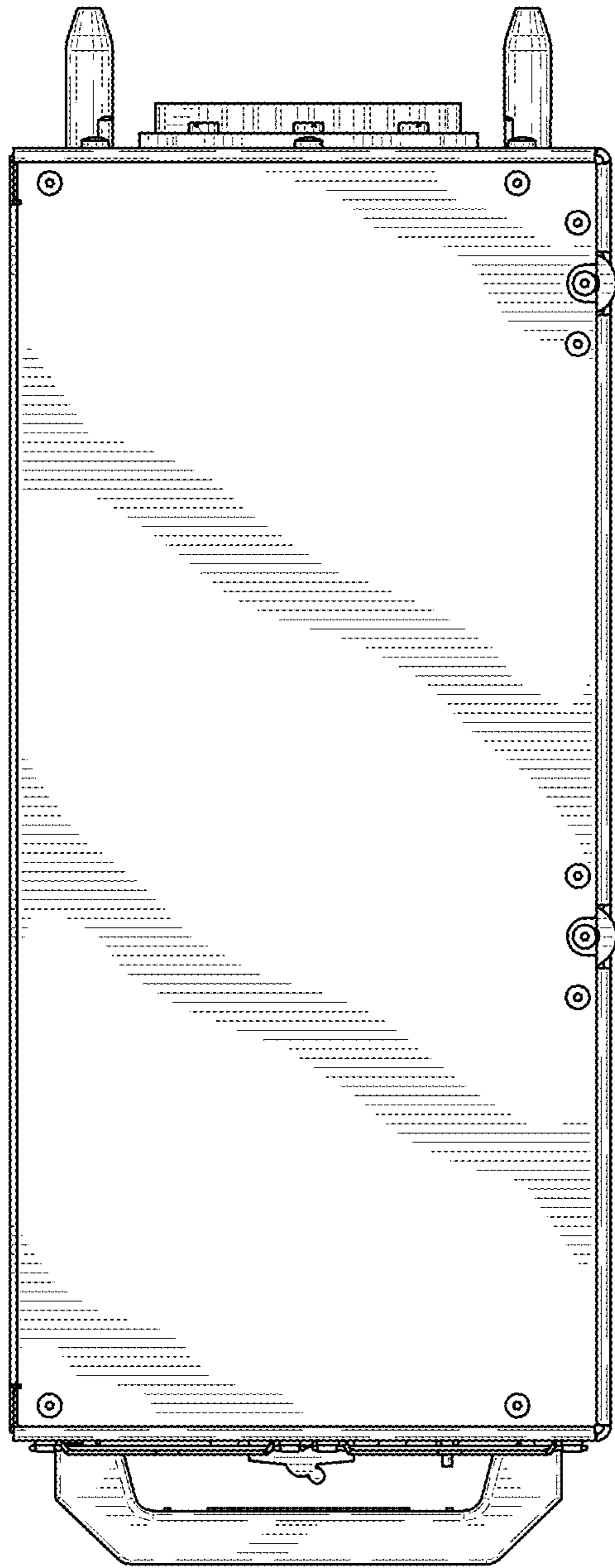

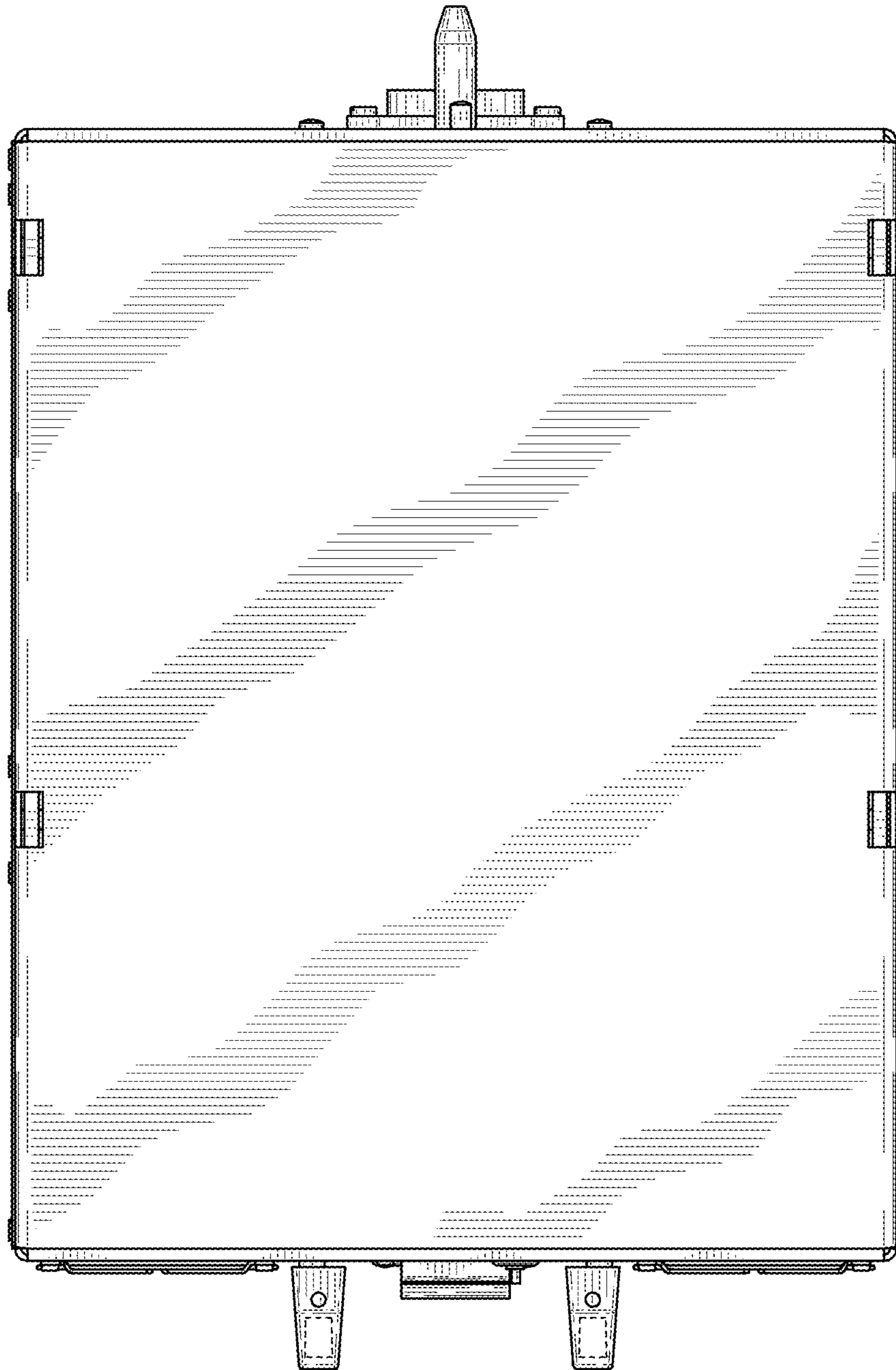

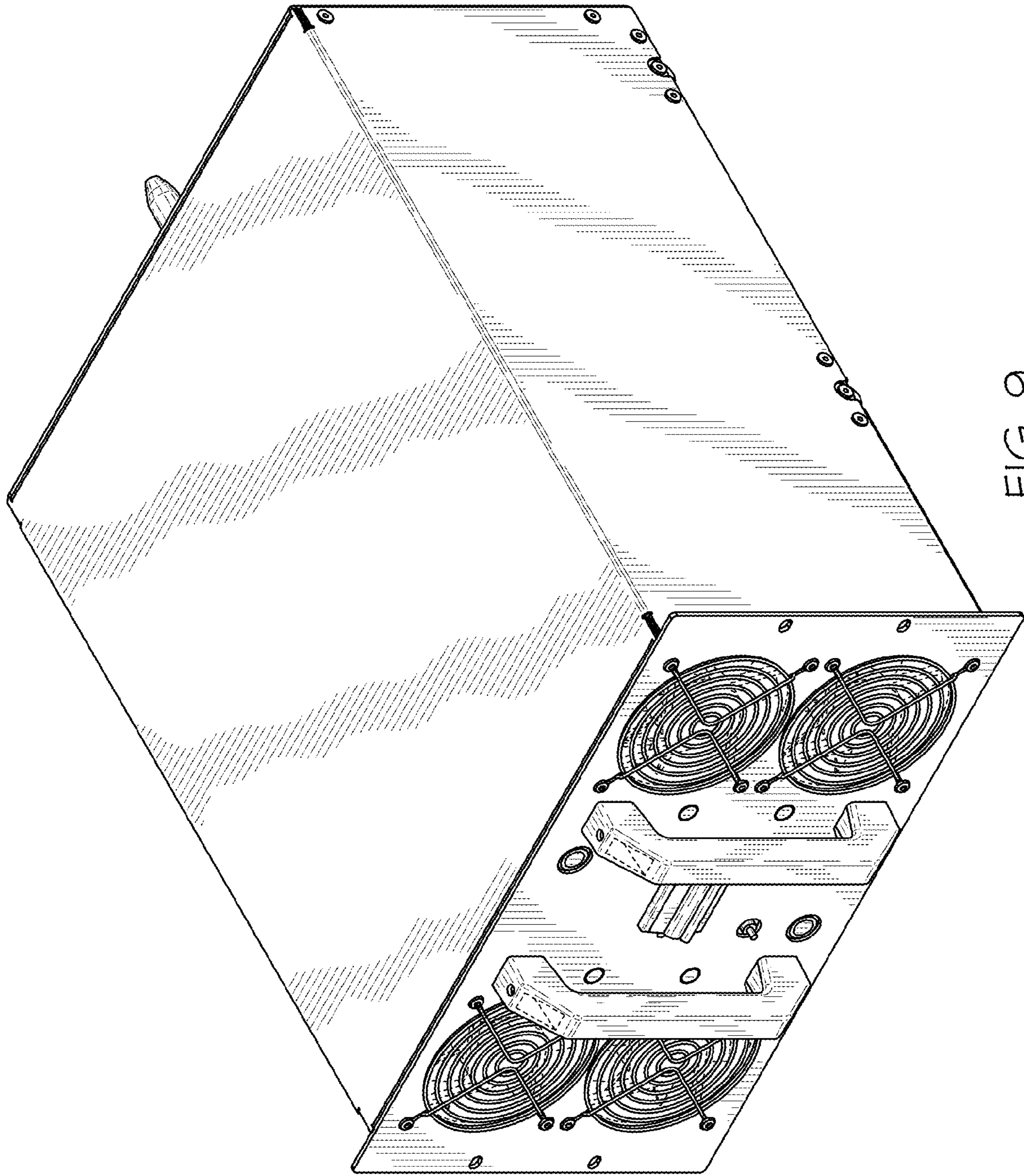

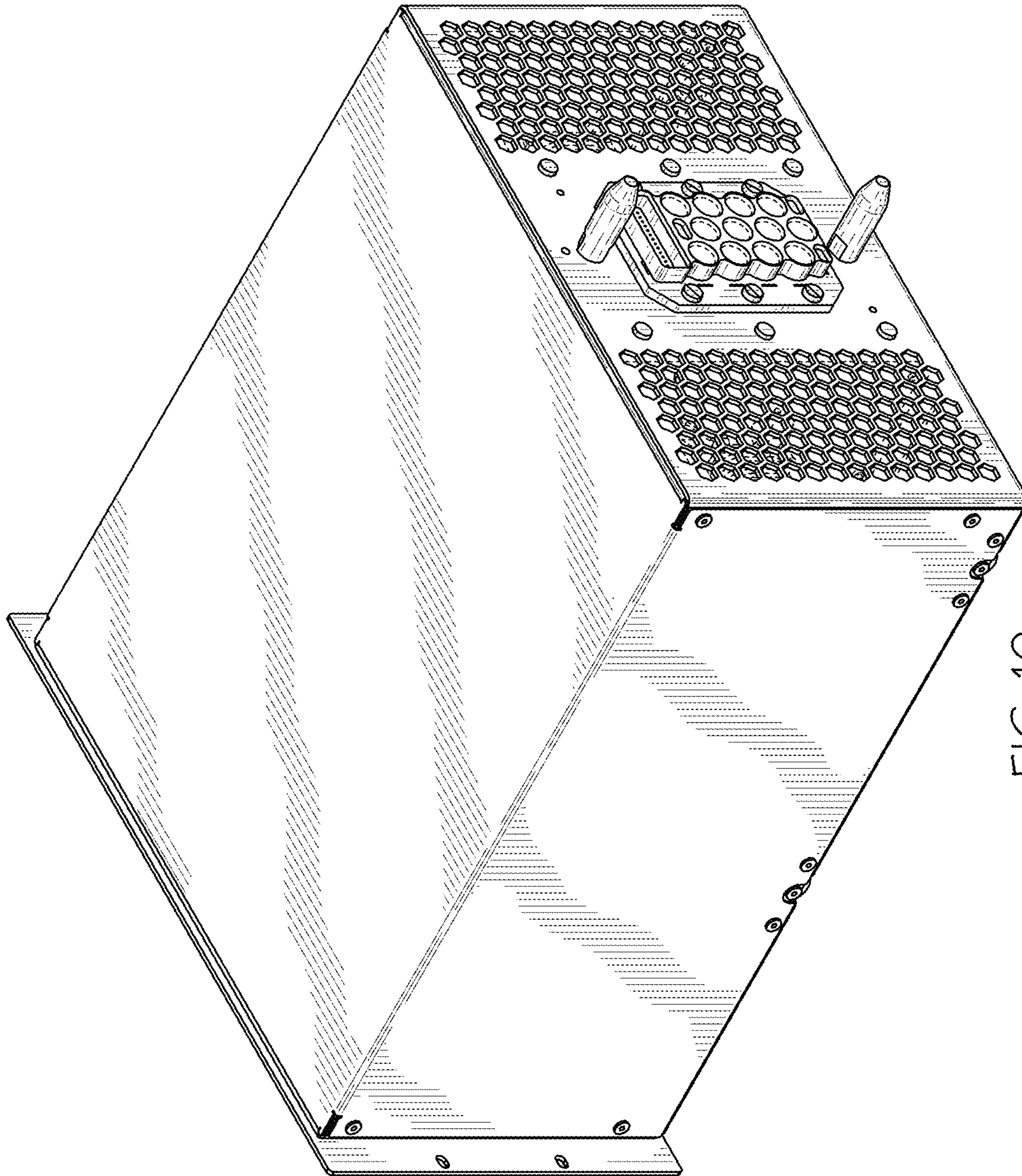

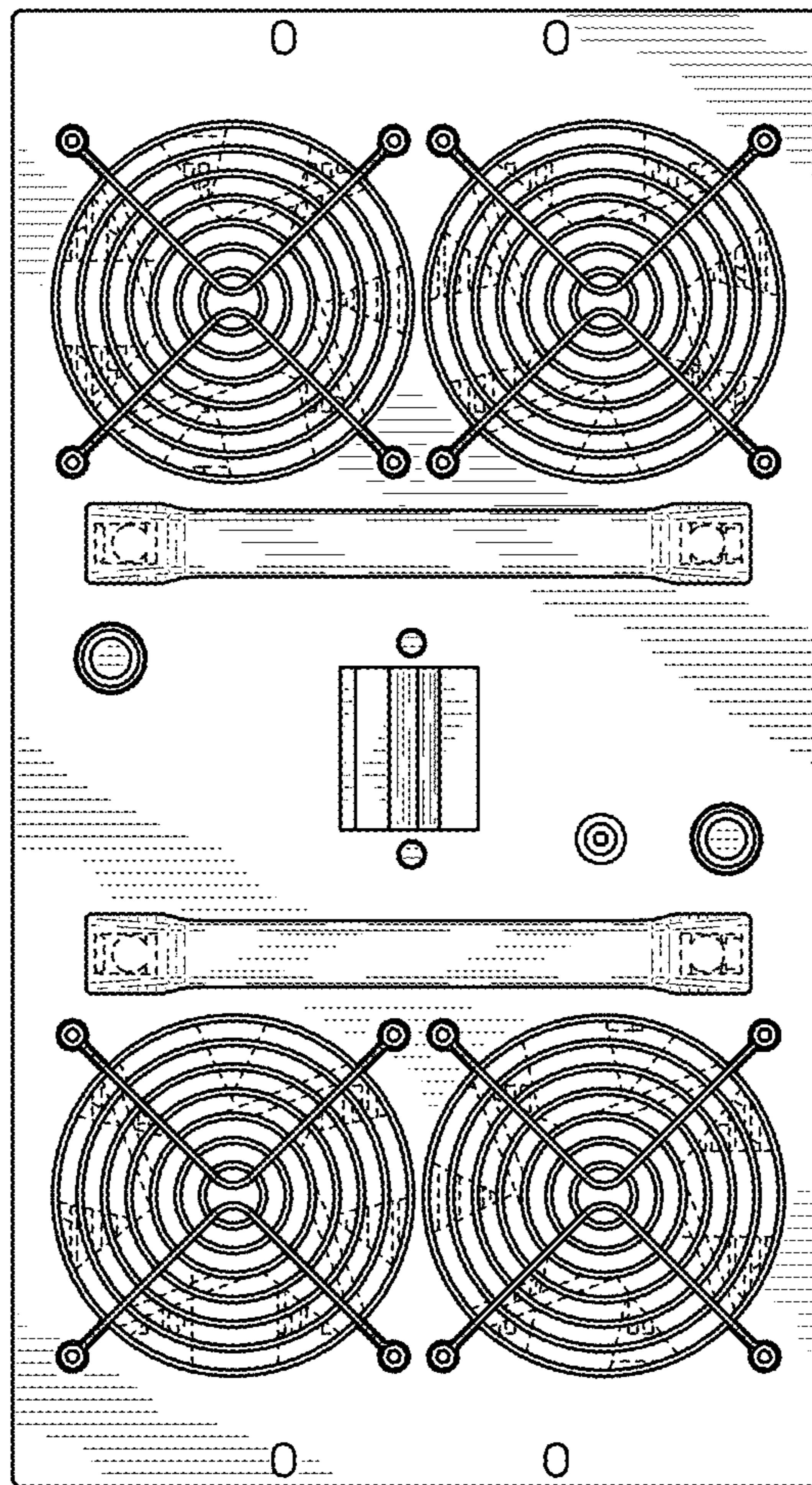

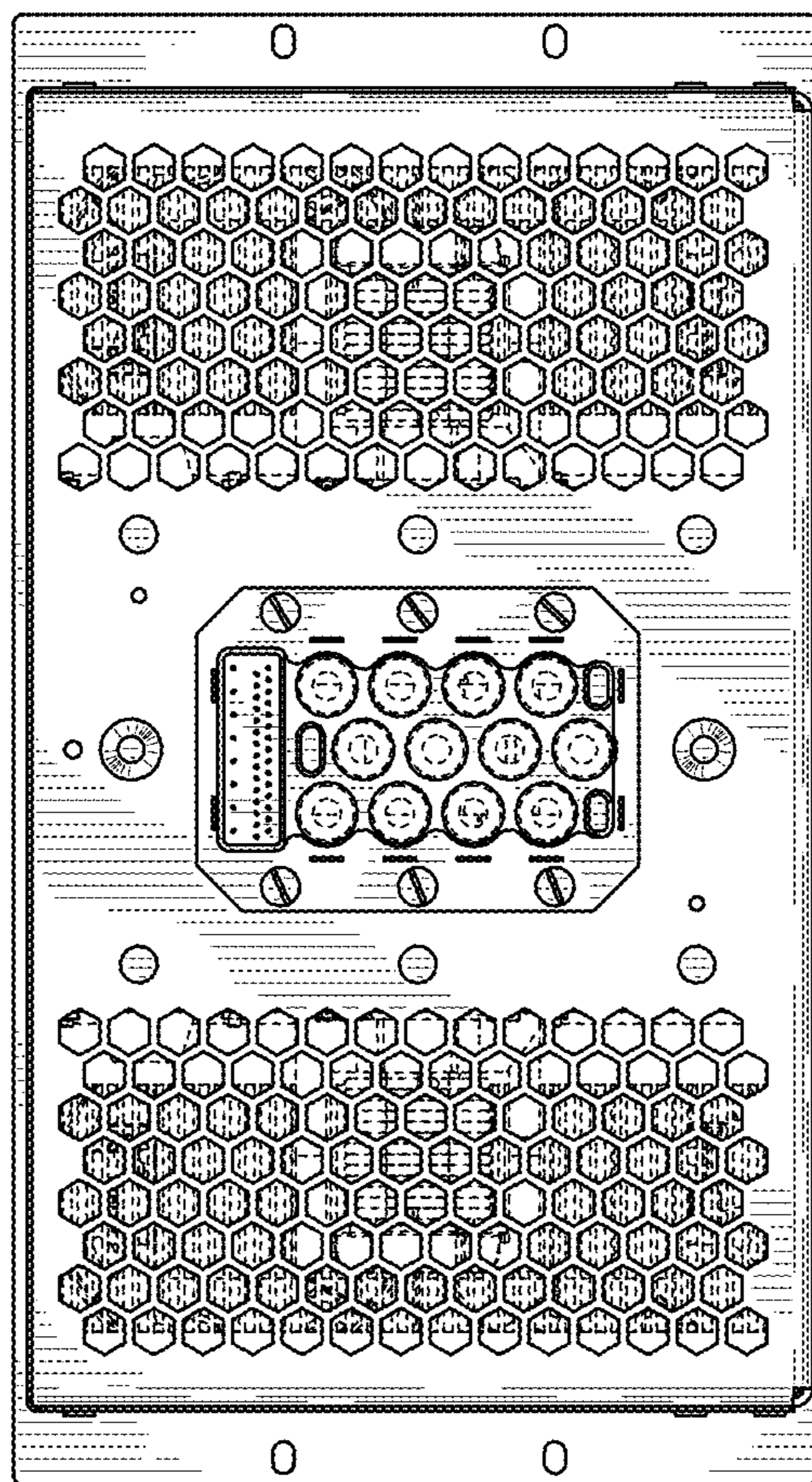

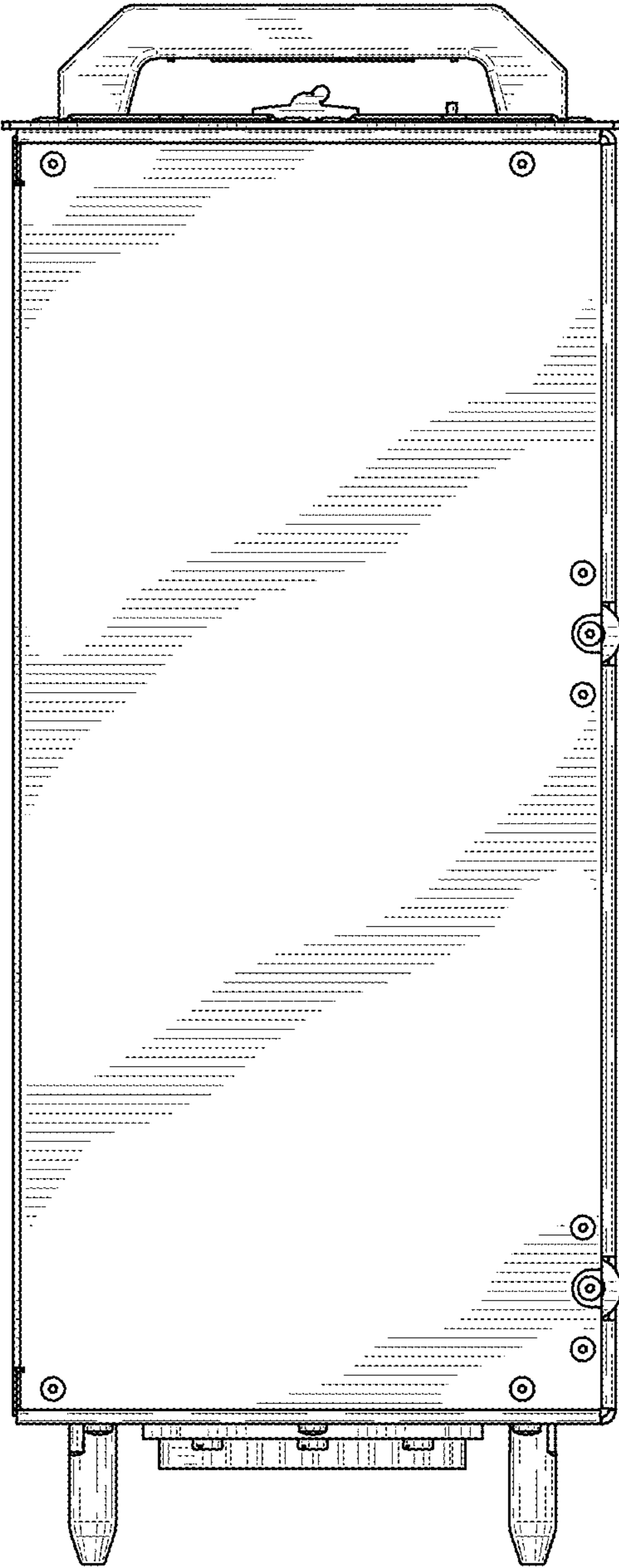

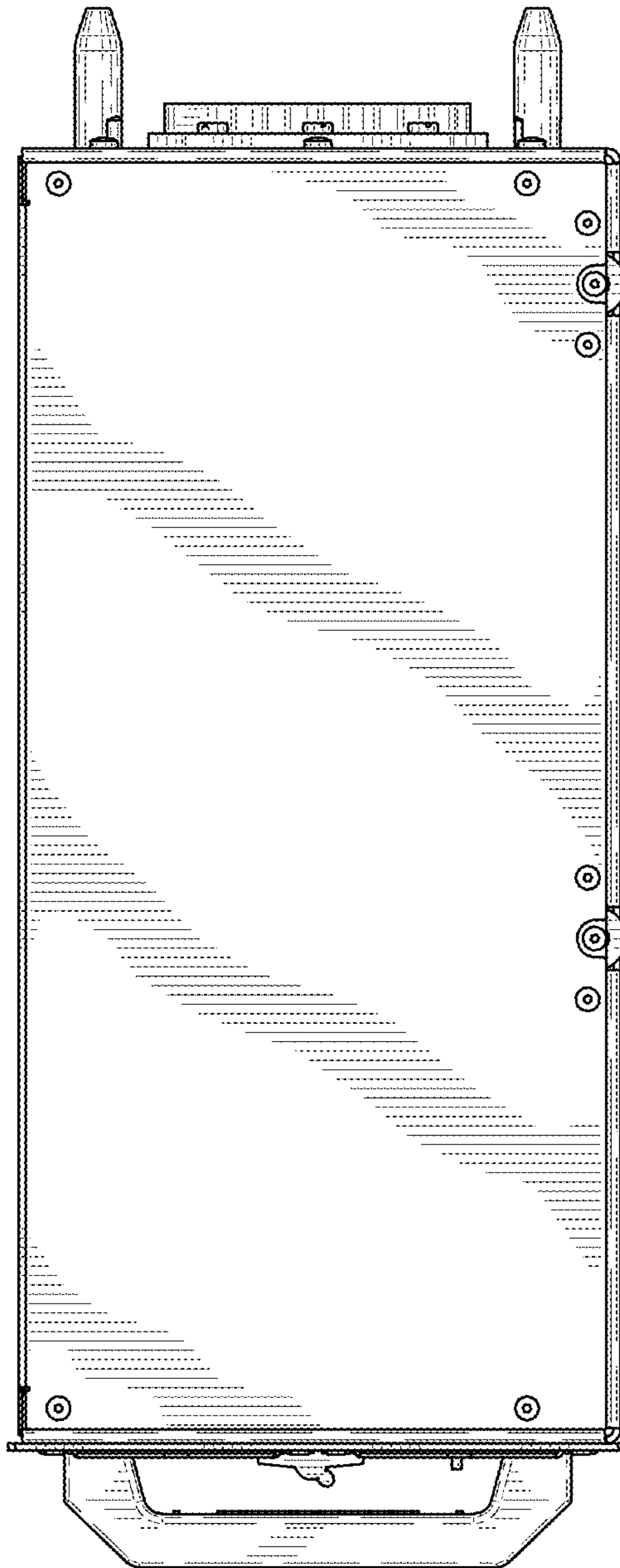

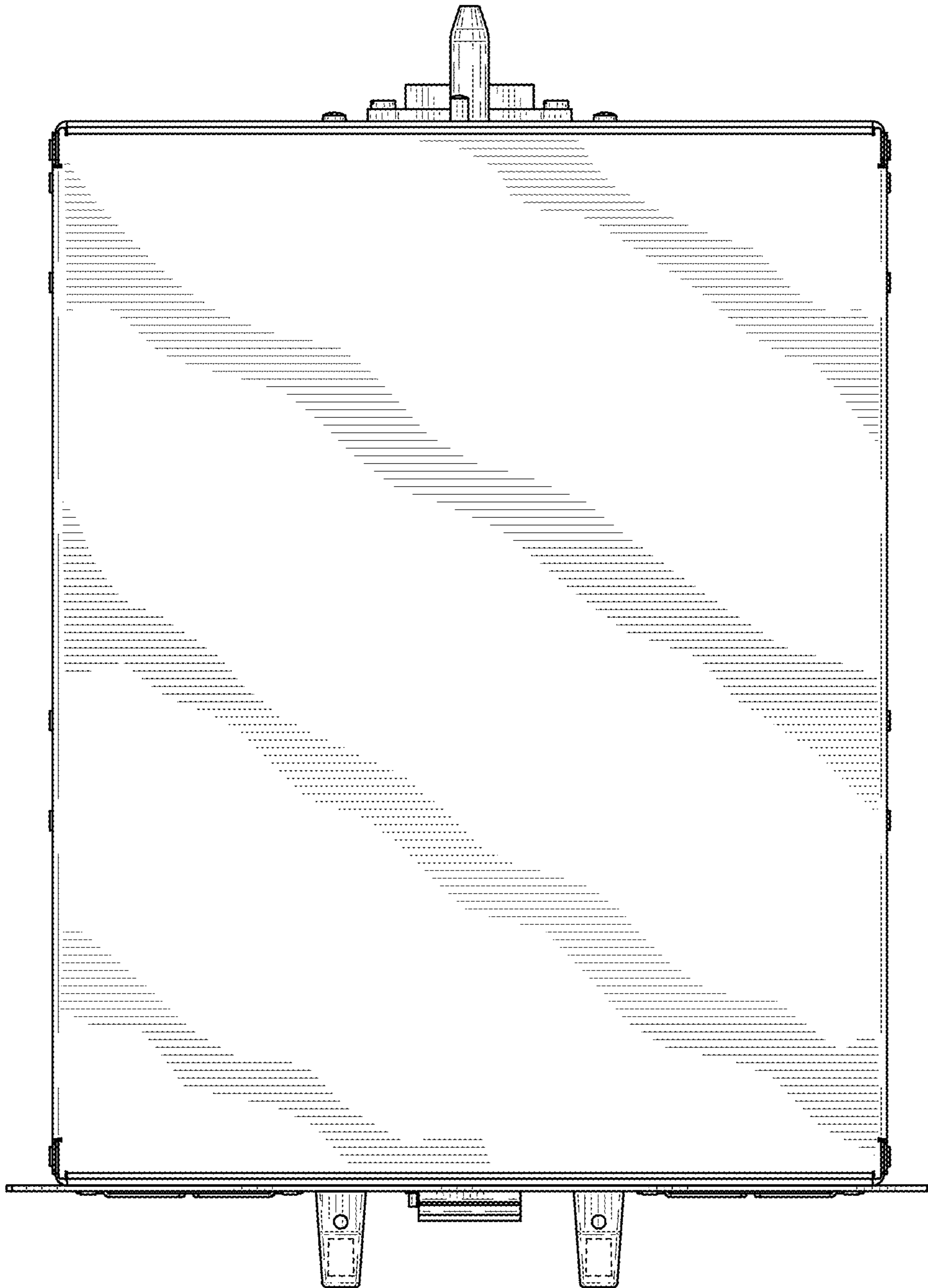

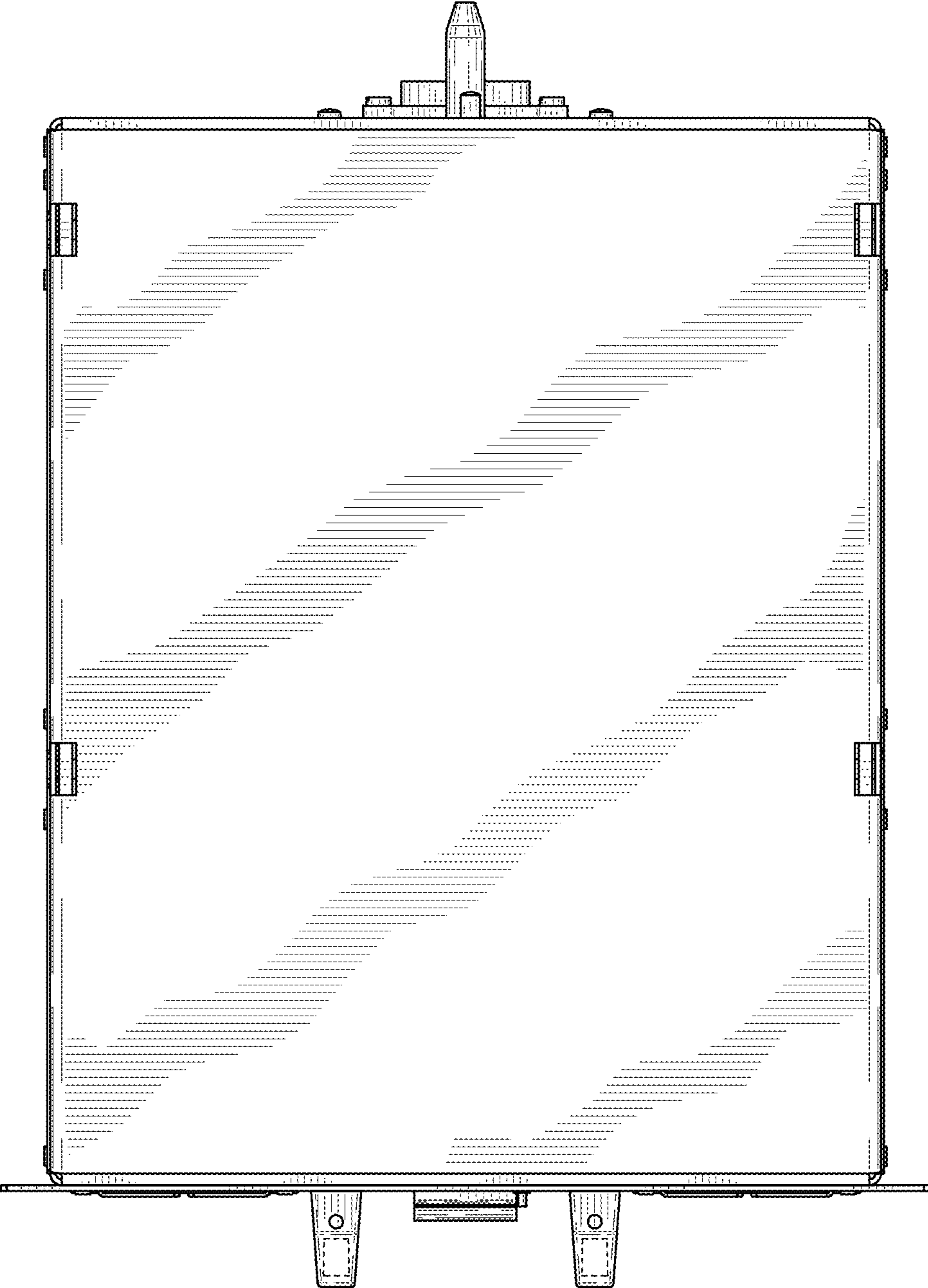
