The ornamental design for a display screens or portion thereof with graphical user interface, as shown and described.

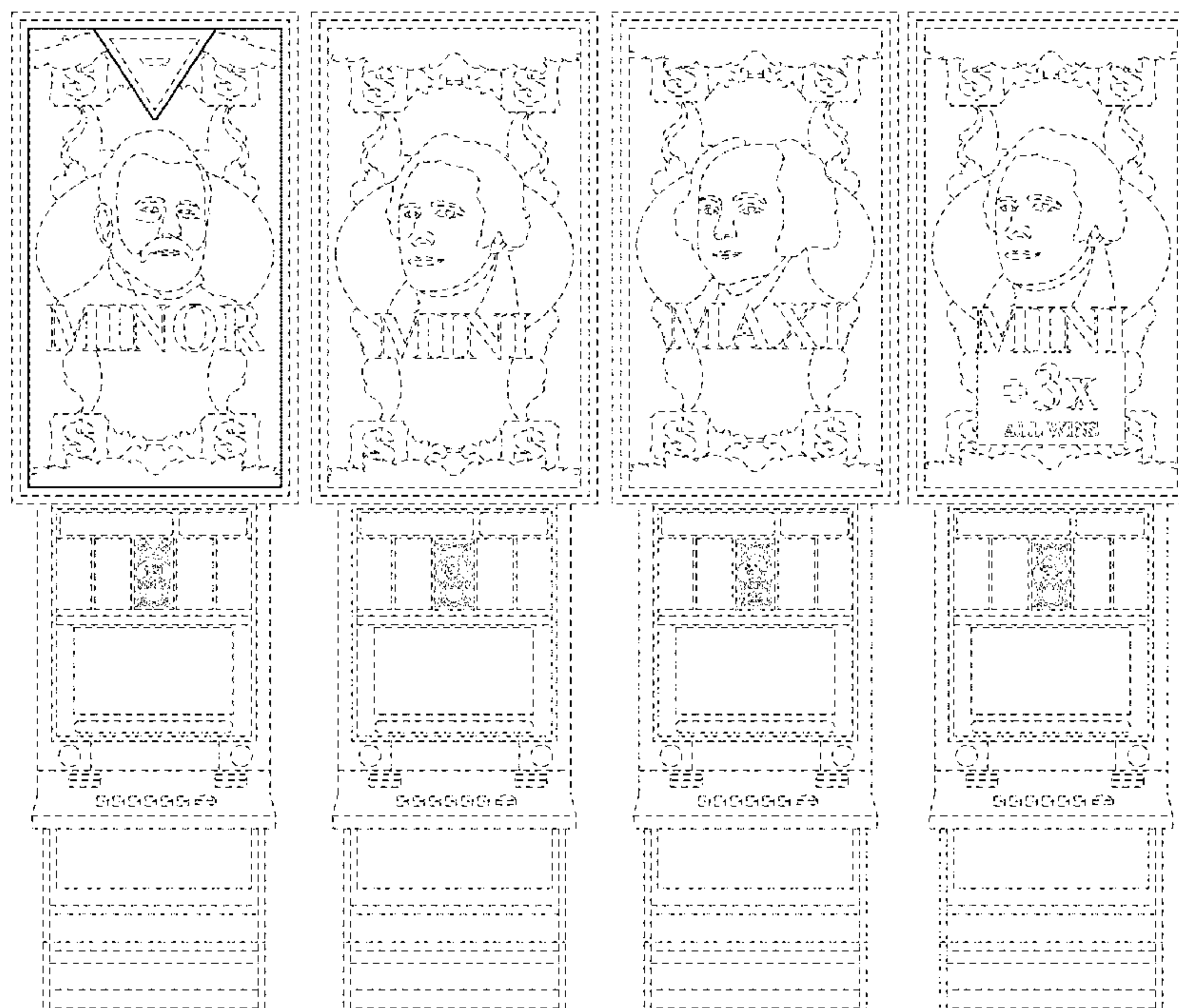
DESCRIPTION

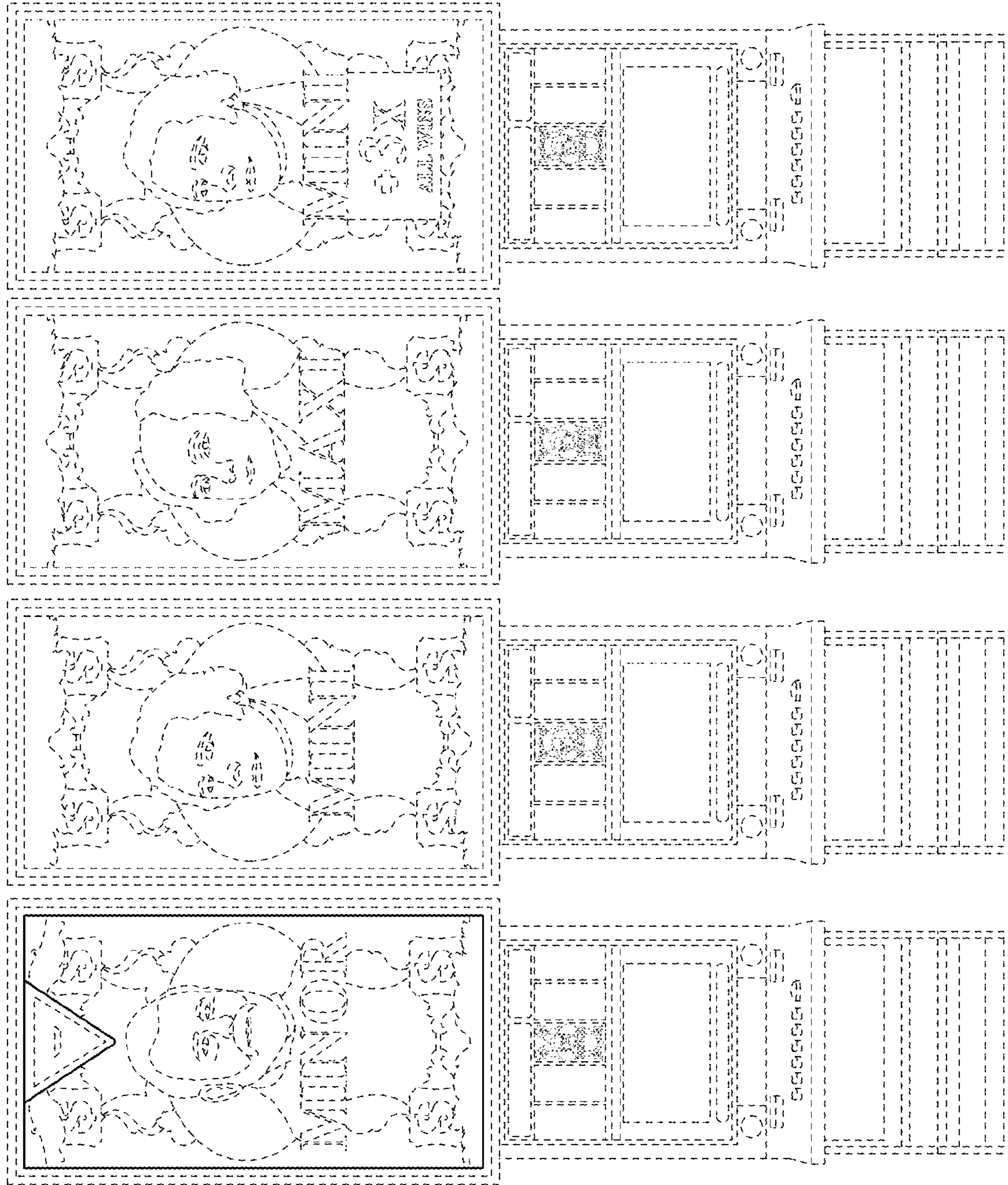

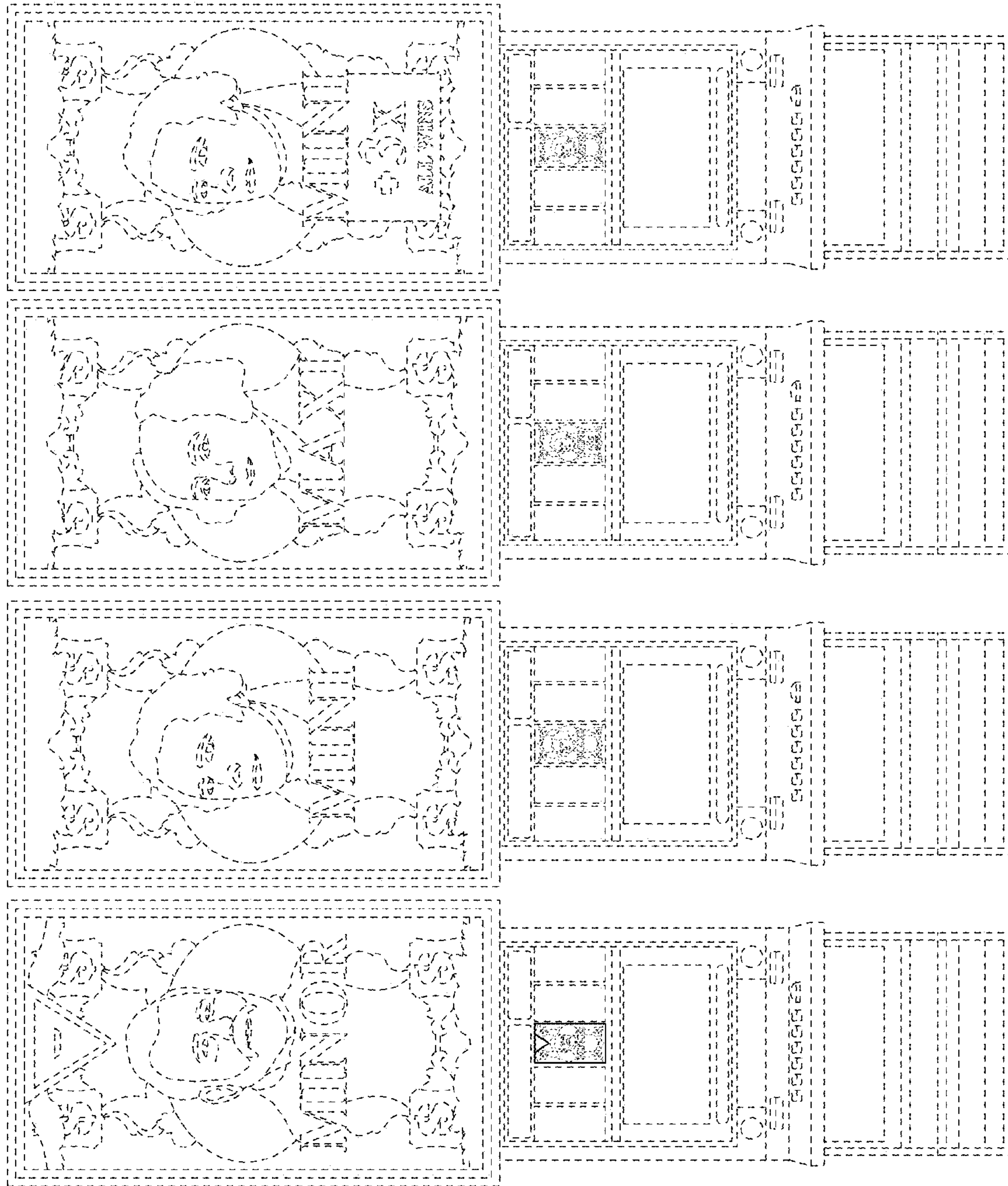
