**DESCRIPTION**

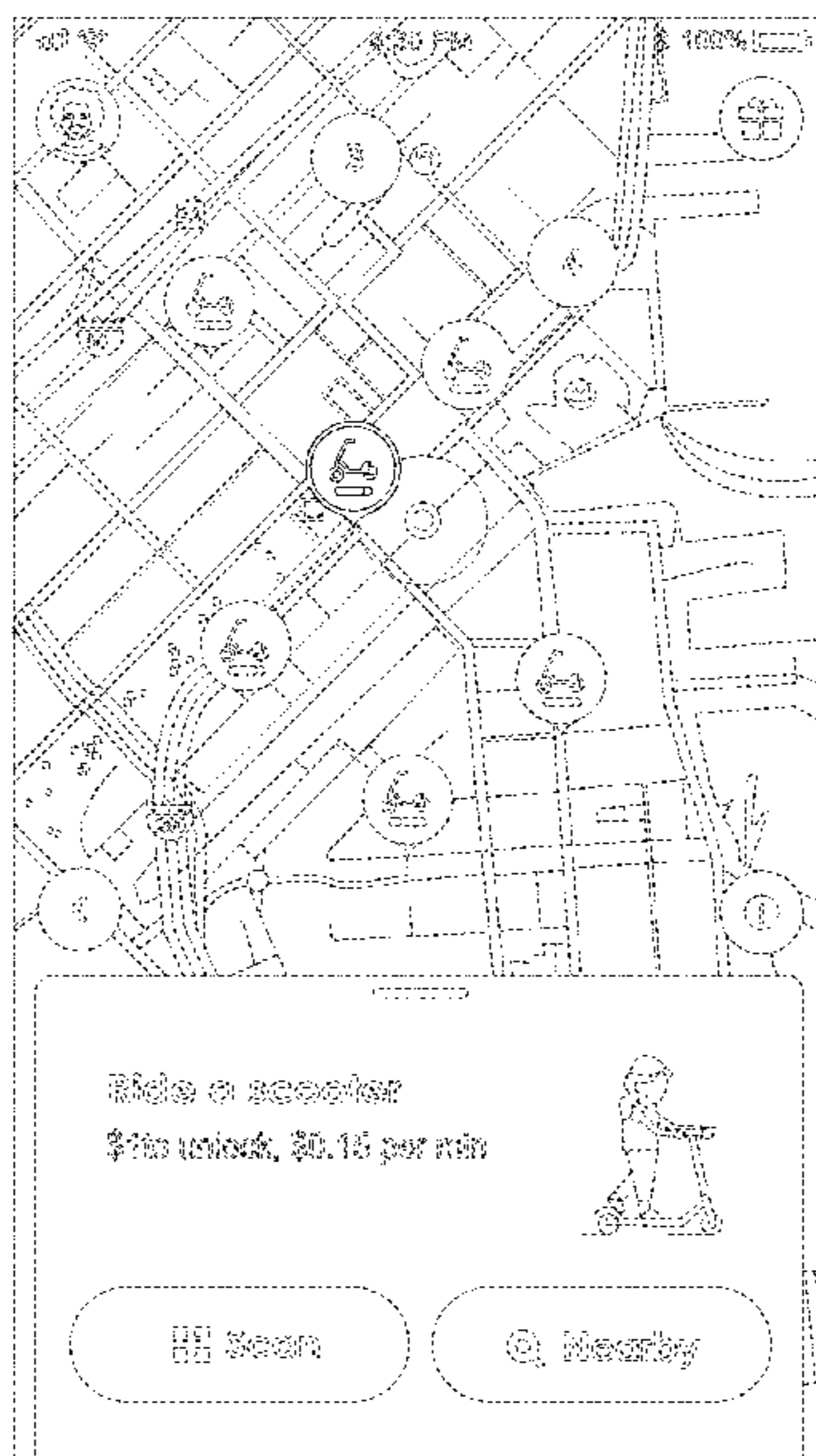
The FIGURE is a front view of a display device with graphical user interface.
