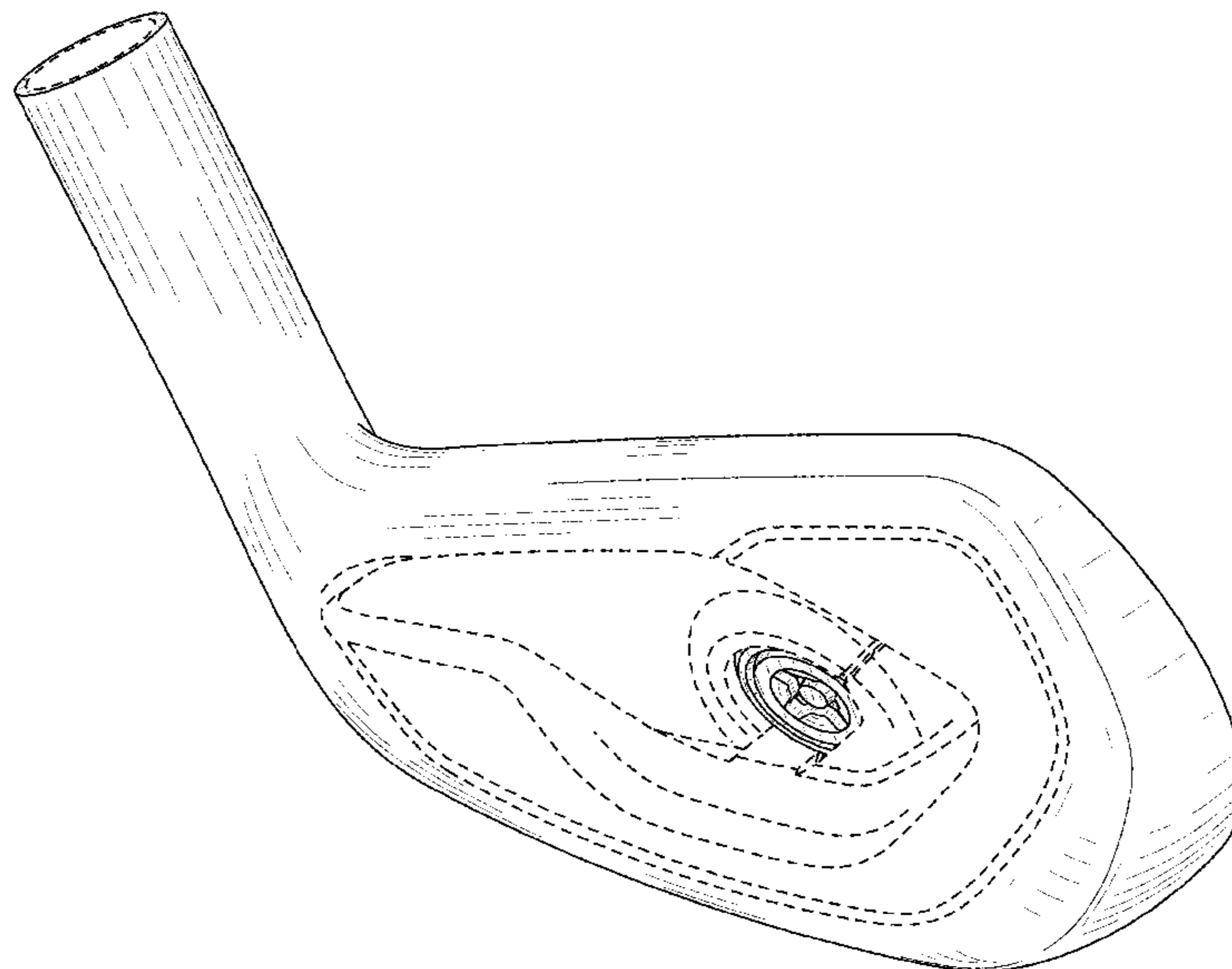
(57) **CLAIM**

The ornamental design for iron golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective back view of an iron golf club head showing my design;  
 FIG. 2 is a rear elevational view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a front elevation view thereof;  
 FIG. 6 is a toe end view thereof;  
 FIG. 7 is a heel end view thereof; and,  
 FIG. 8 is an exploded perspective back view thereof.  
 The broken lines showing portions of the iron golf club head forms no part of the claimed design.

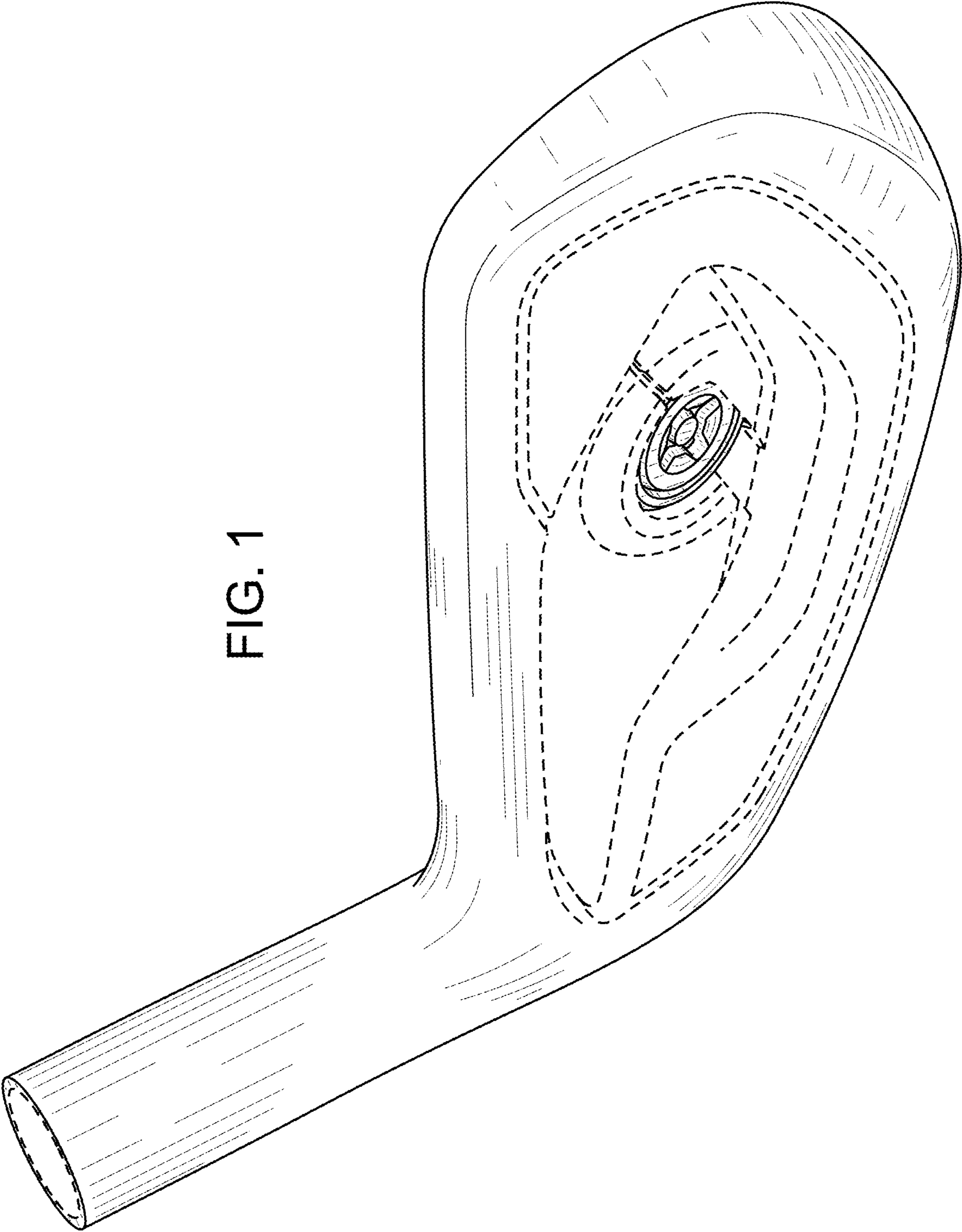

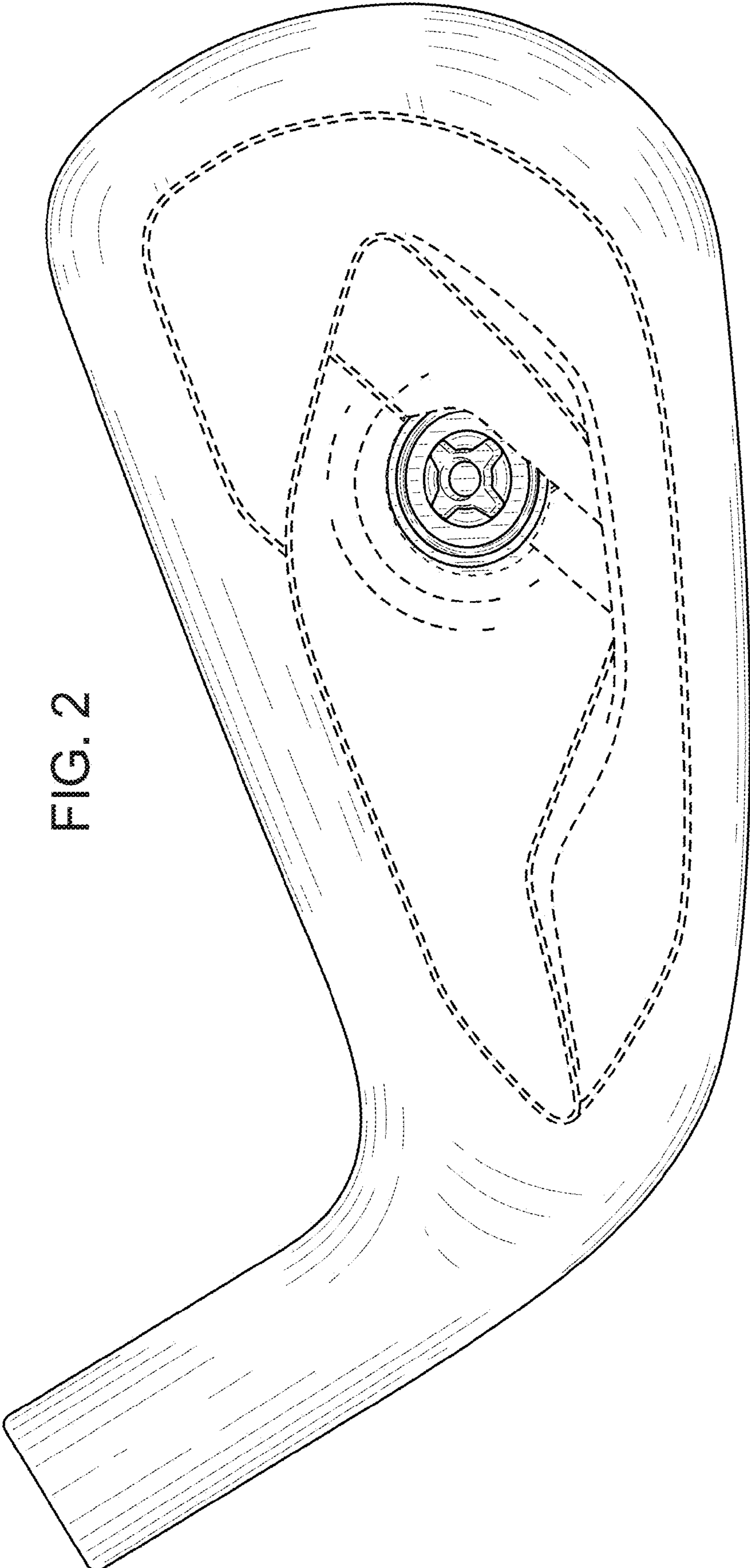

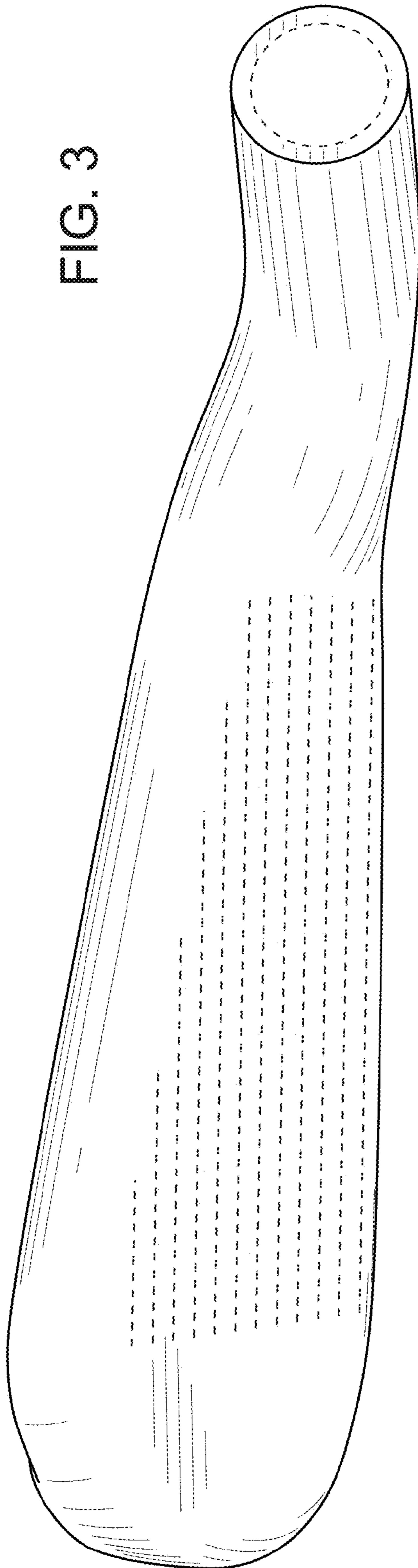
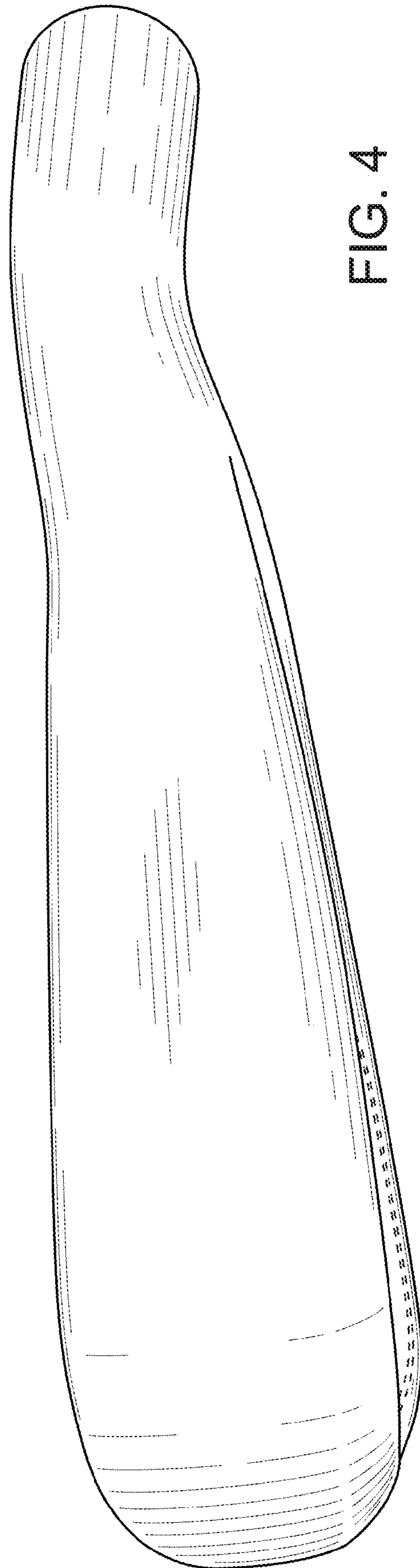

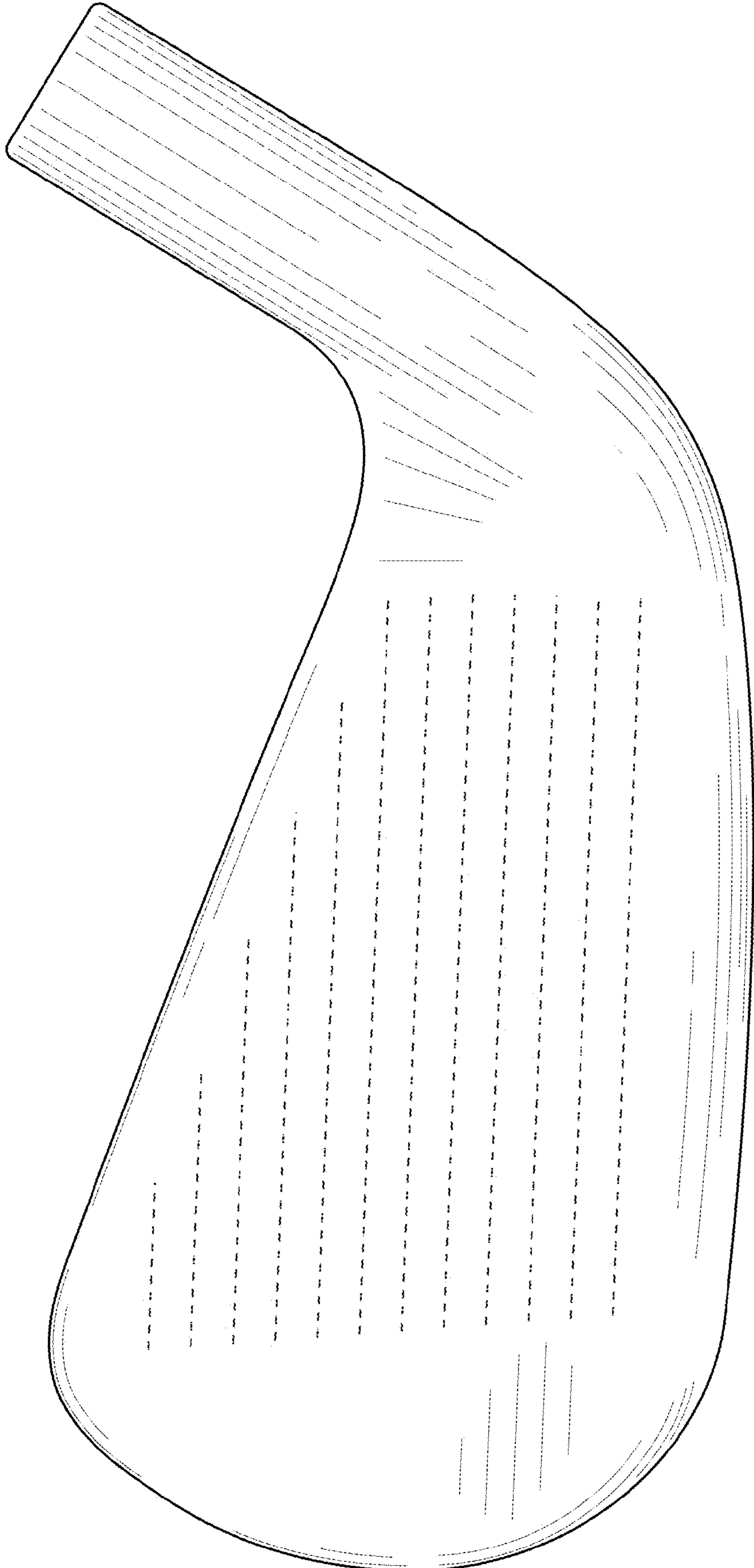

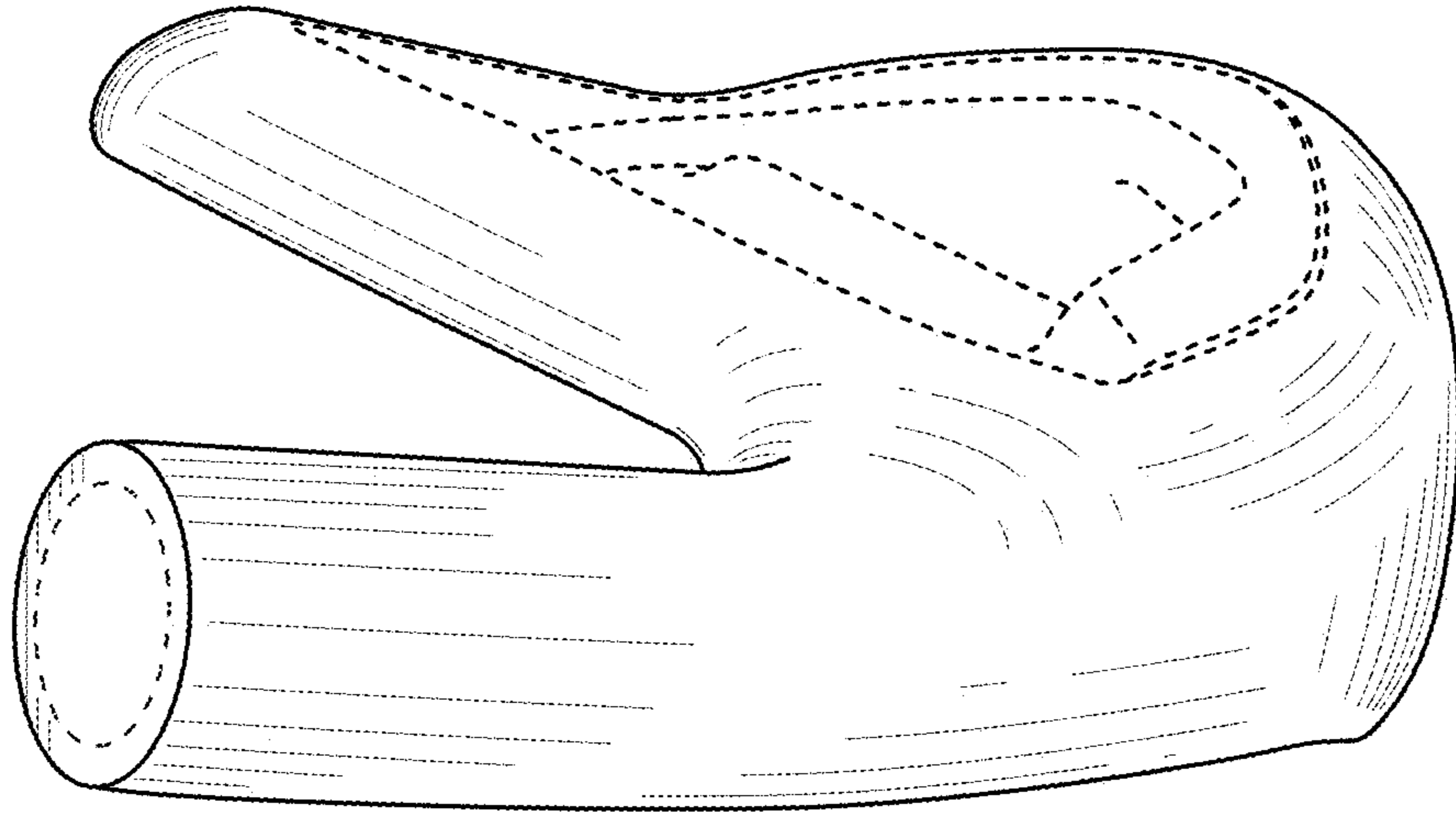

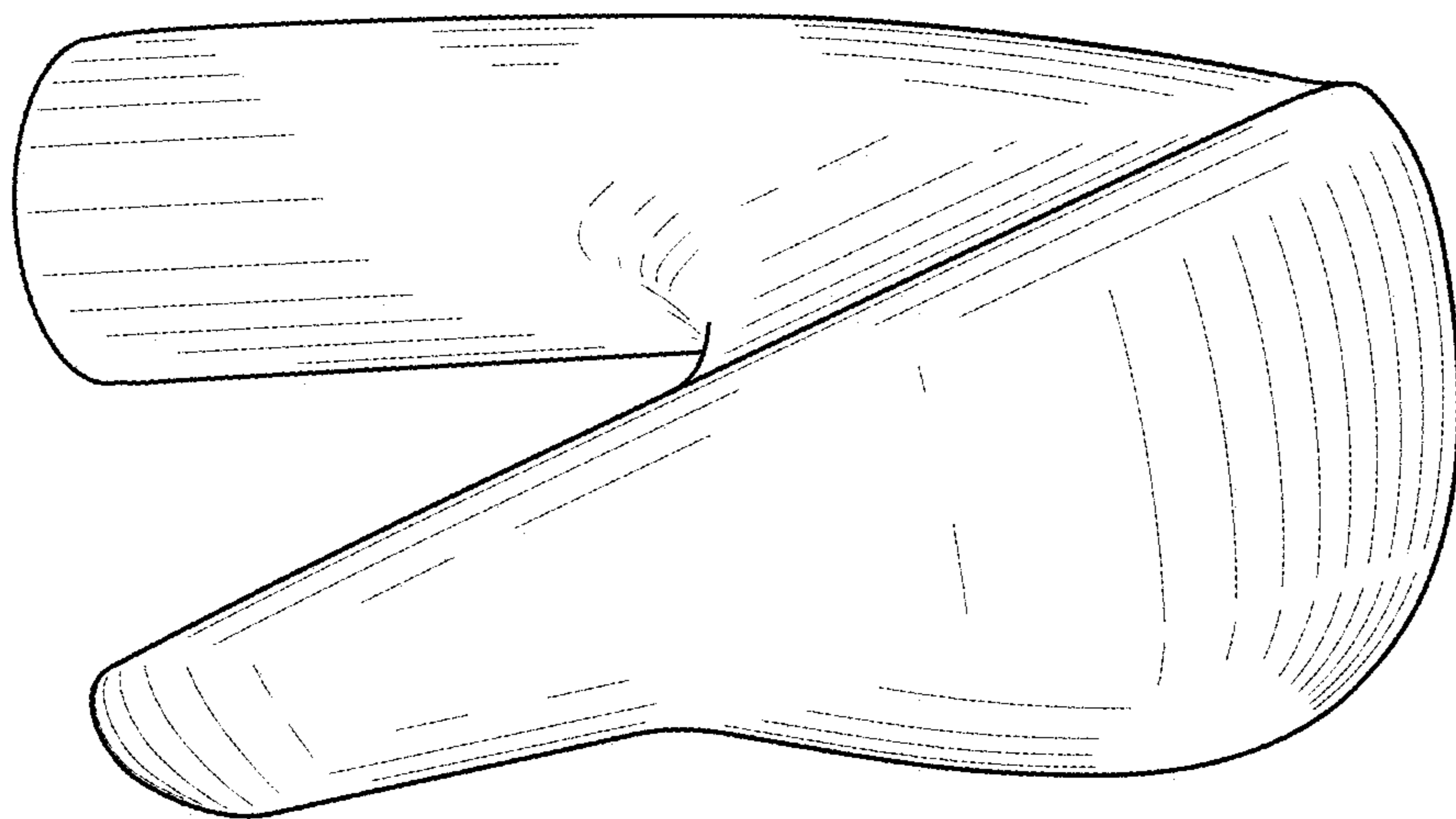

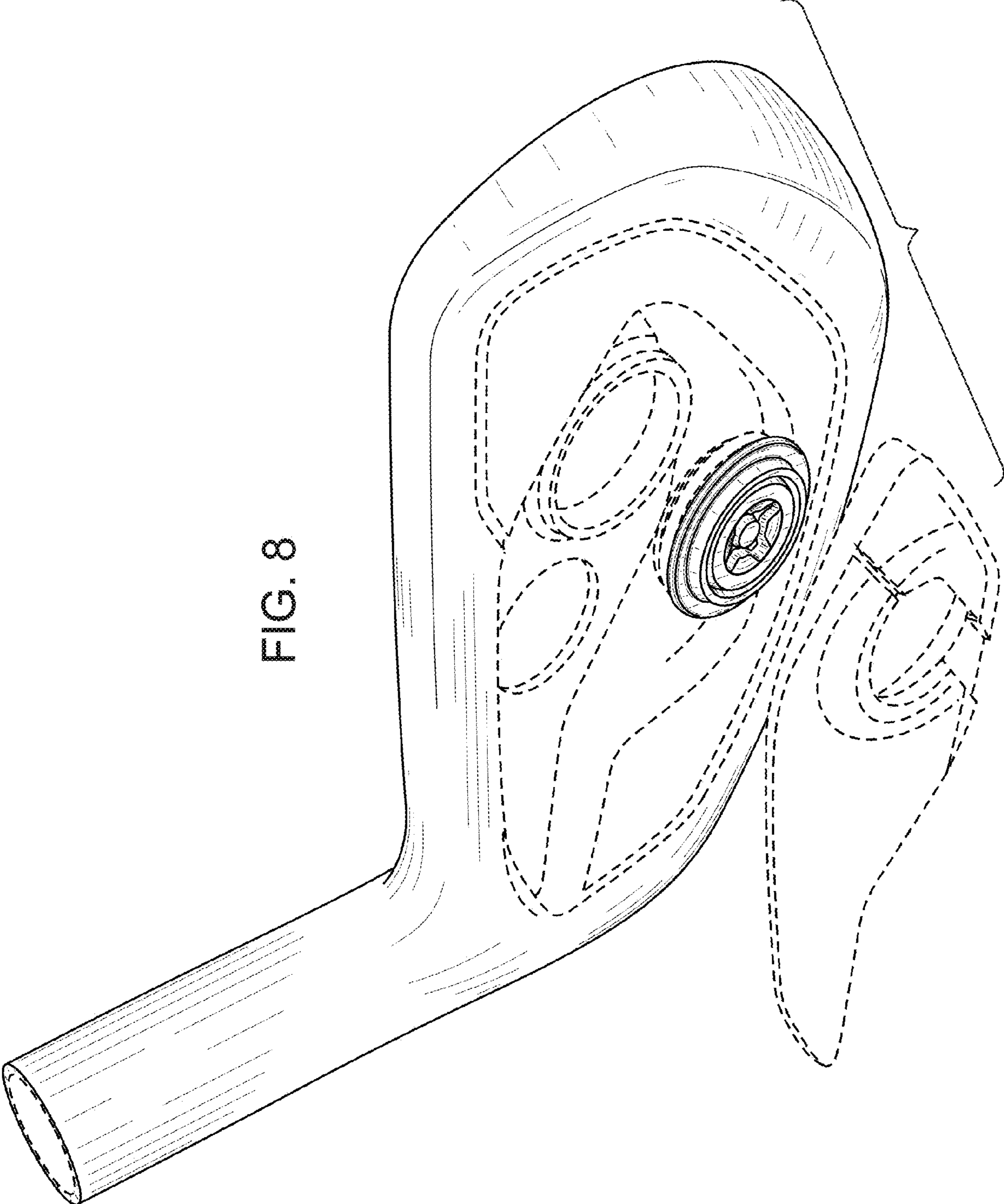
