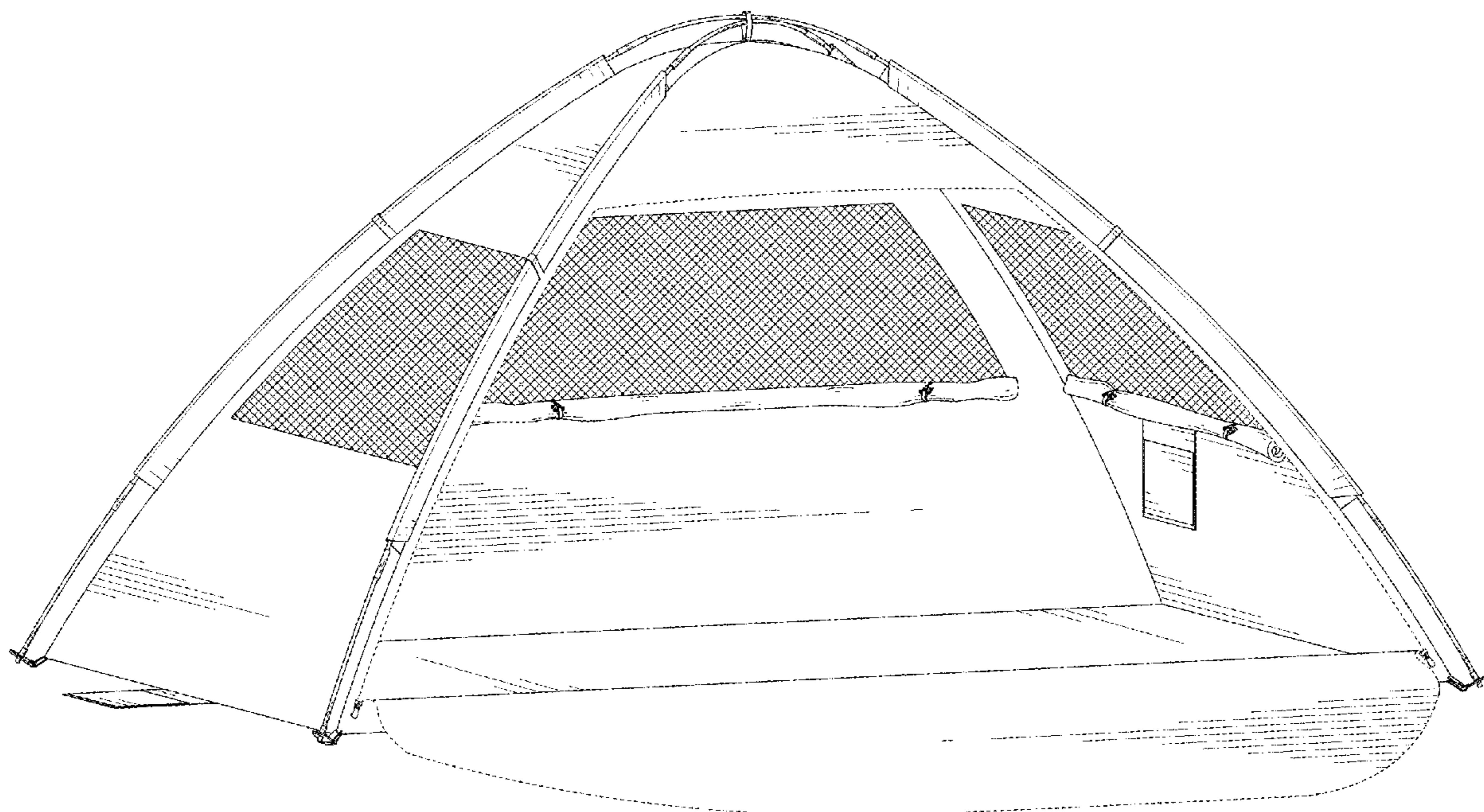
(57) **CLAIM**

The ornamental design for a tent, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left side, top perspective view of the tent showing my new design;  
 FIG. 2 is a rear, right side, top perspective view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a right side elevational view thereof;  
 FIG. 7 is a top plan view thereof;  
 FIG. 8 is a bottom plan view thereof; and,  
 FIG. 9 is a front, left side, top perspective view thereof when the front flap of the tent is in its open position.  
 The broken lines immediately adjacent to the claimed portions are boundaries, all other broken lines are environmental structures; all the broken lines form no part of the claimed design.

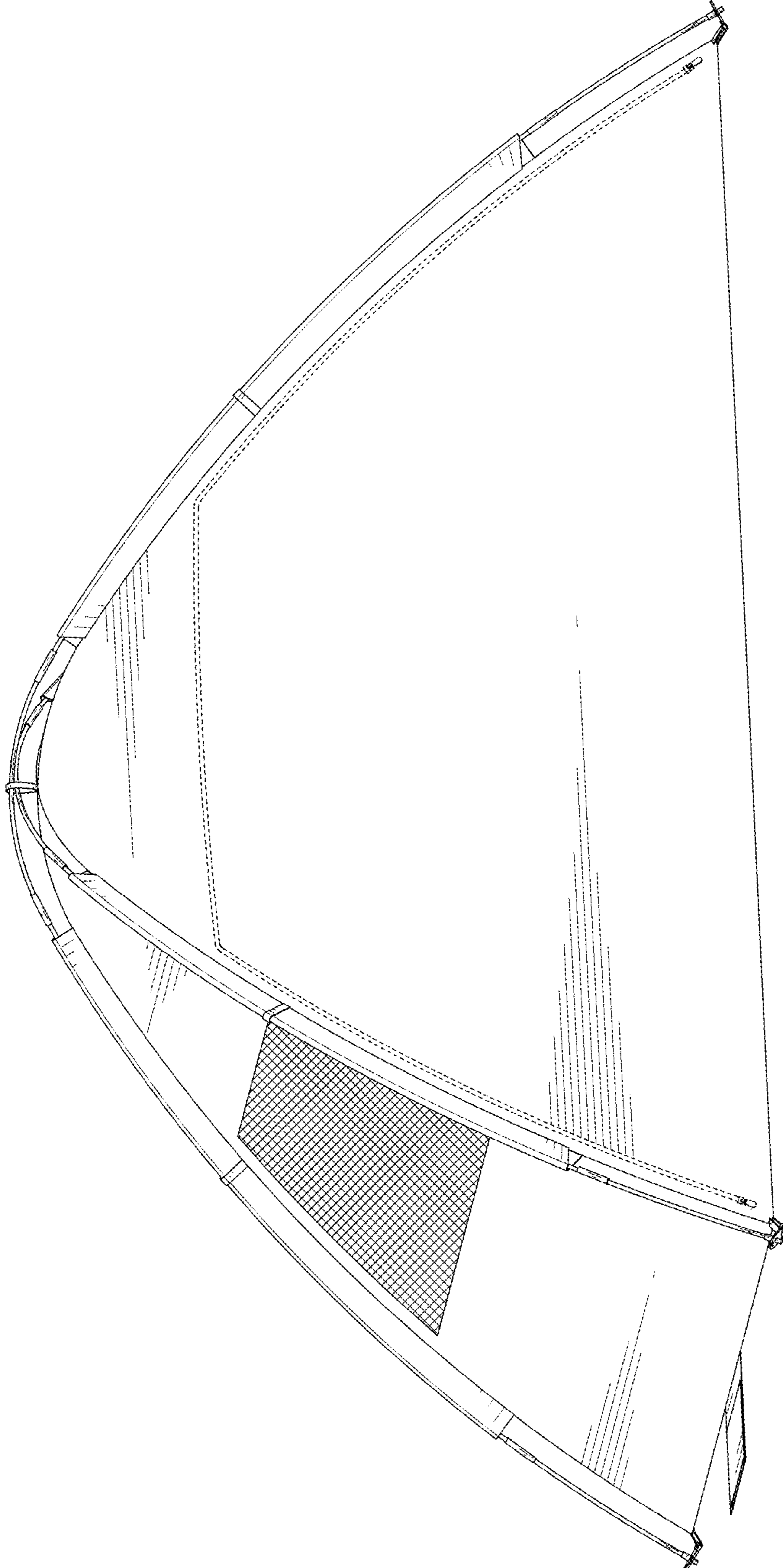

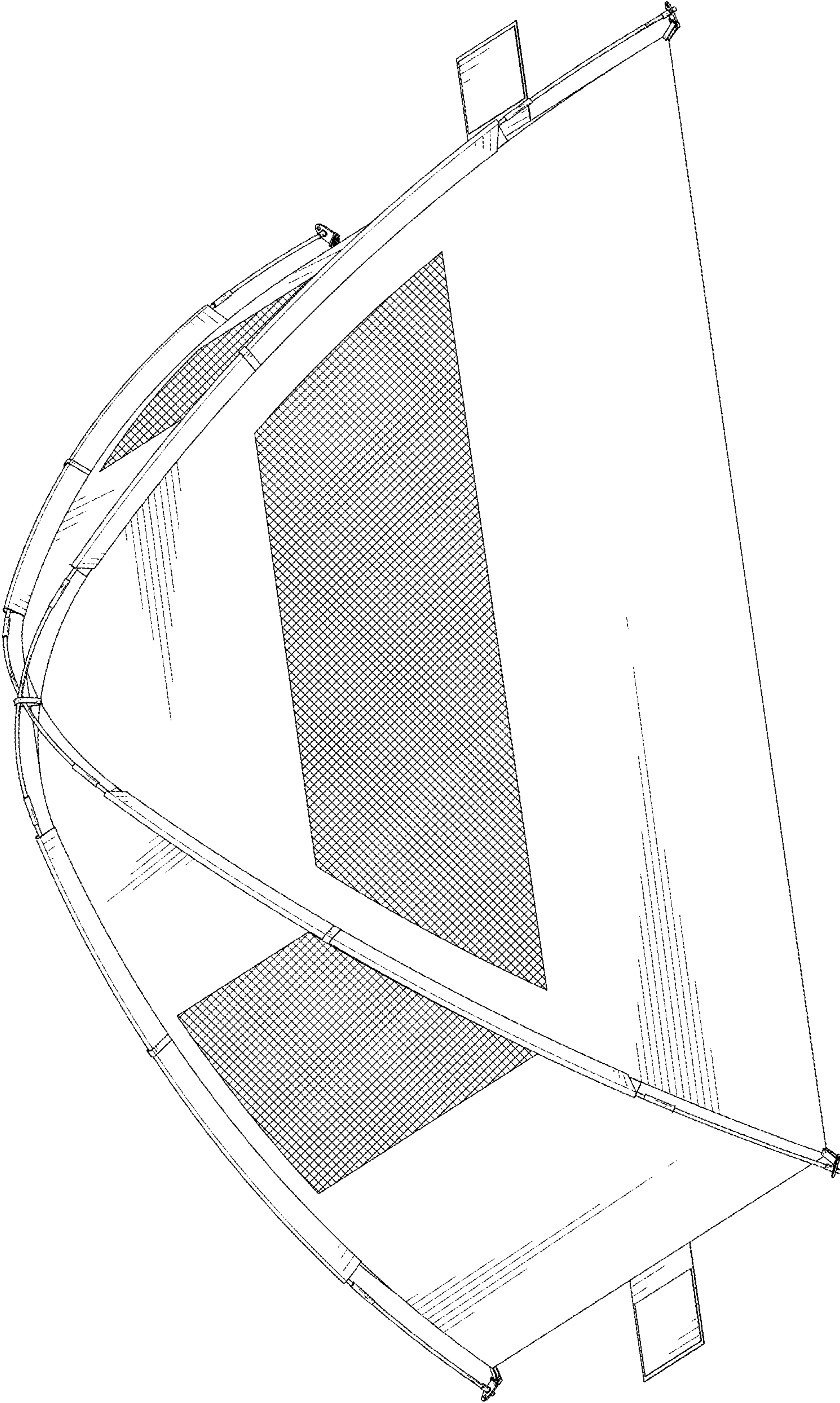

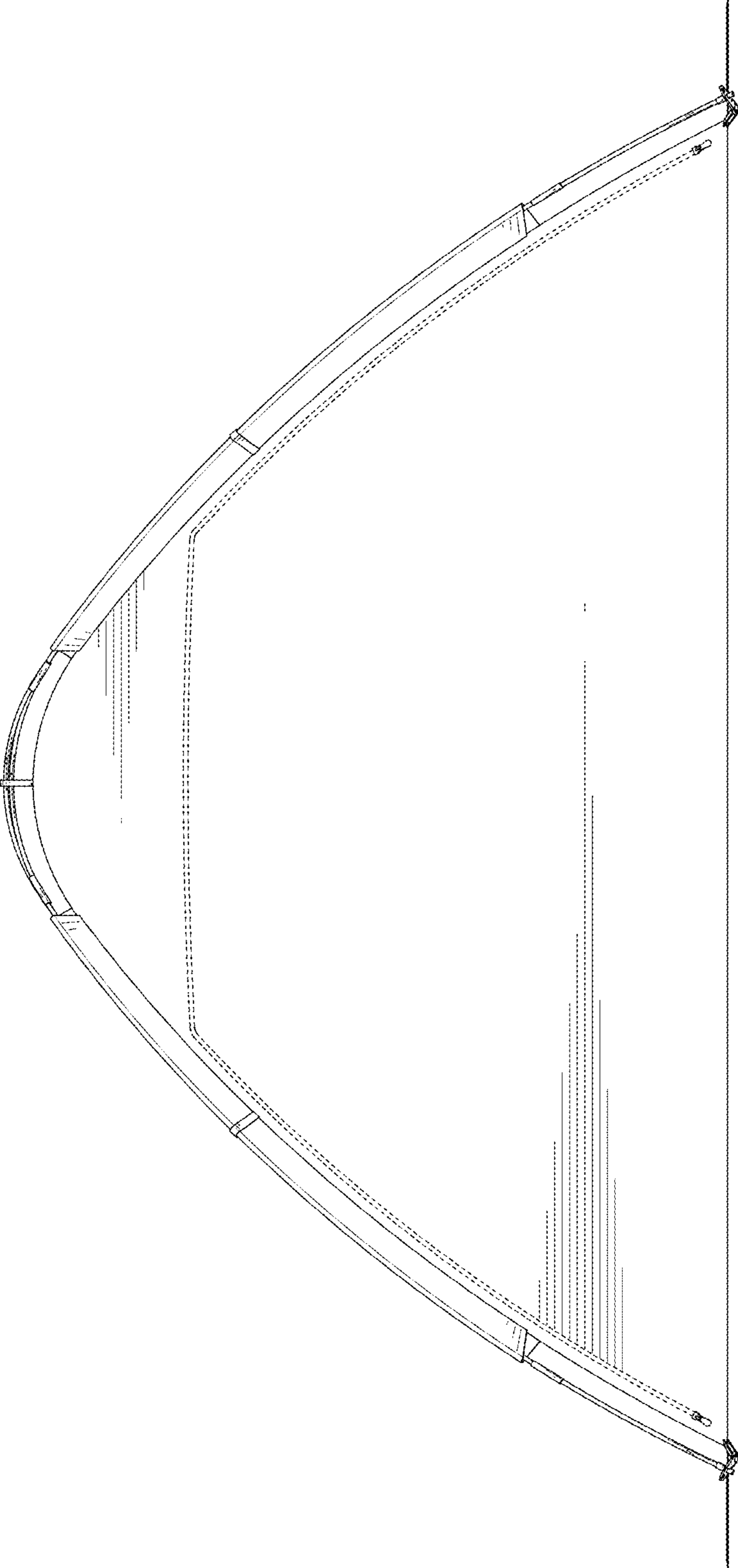

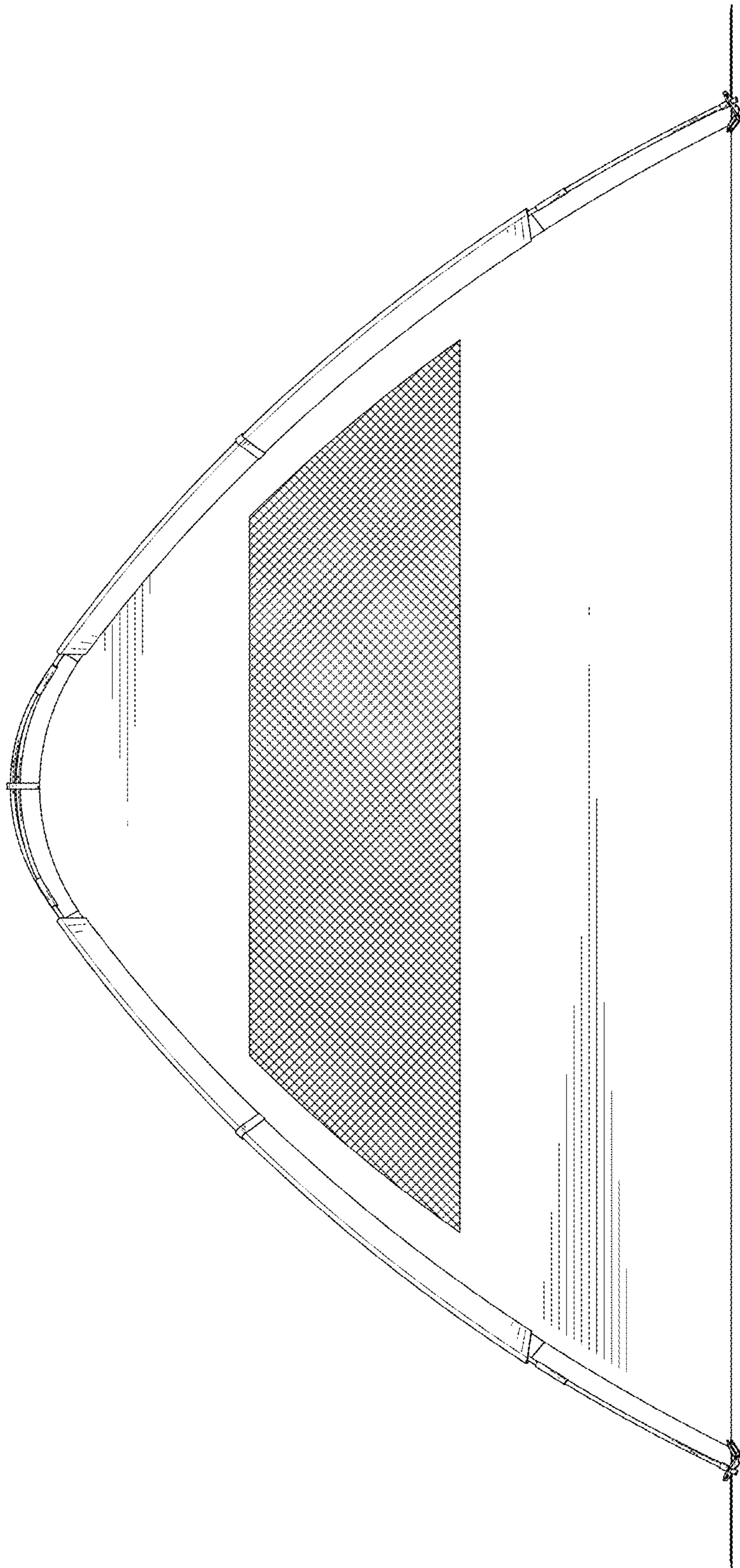

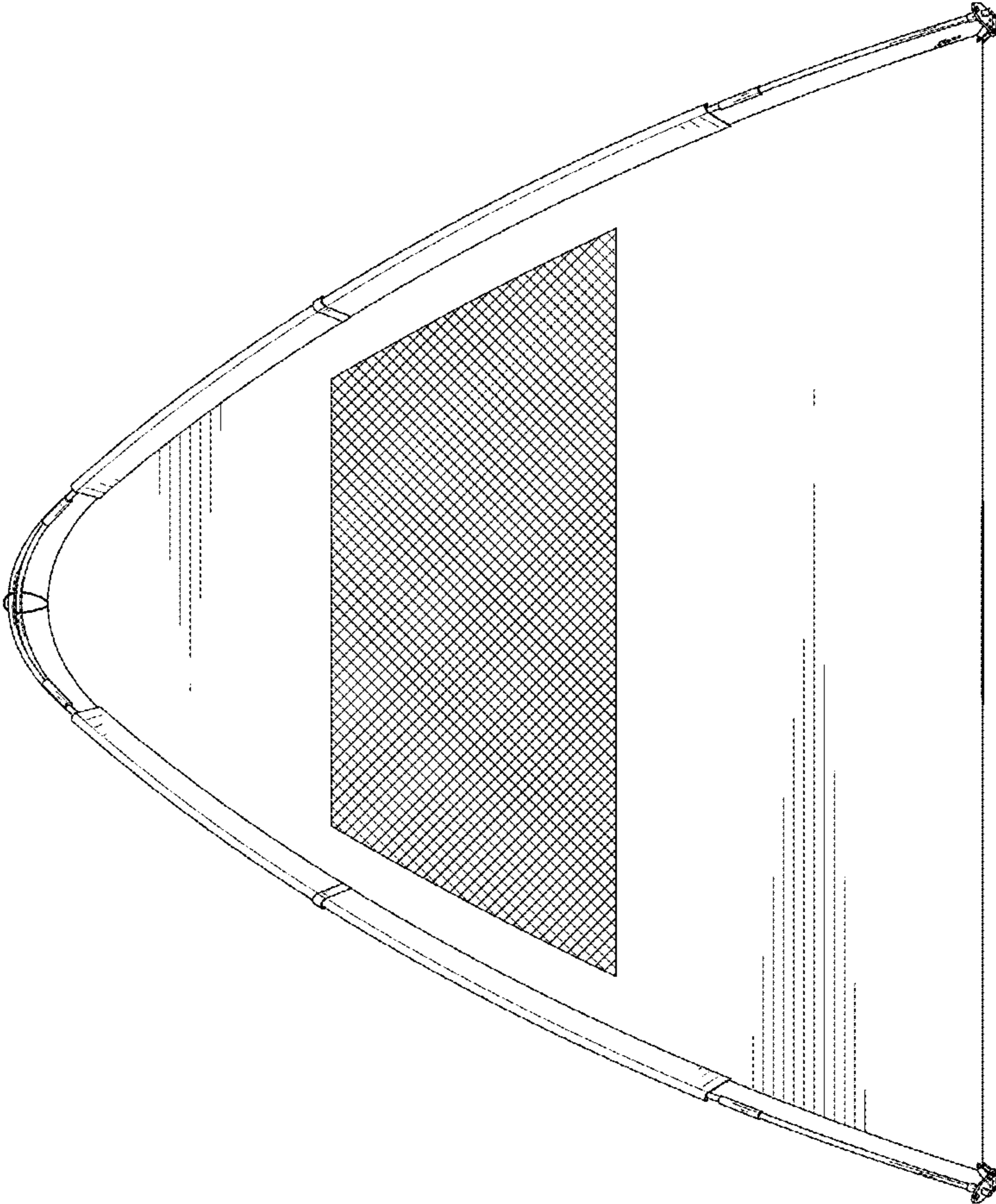

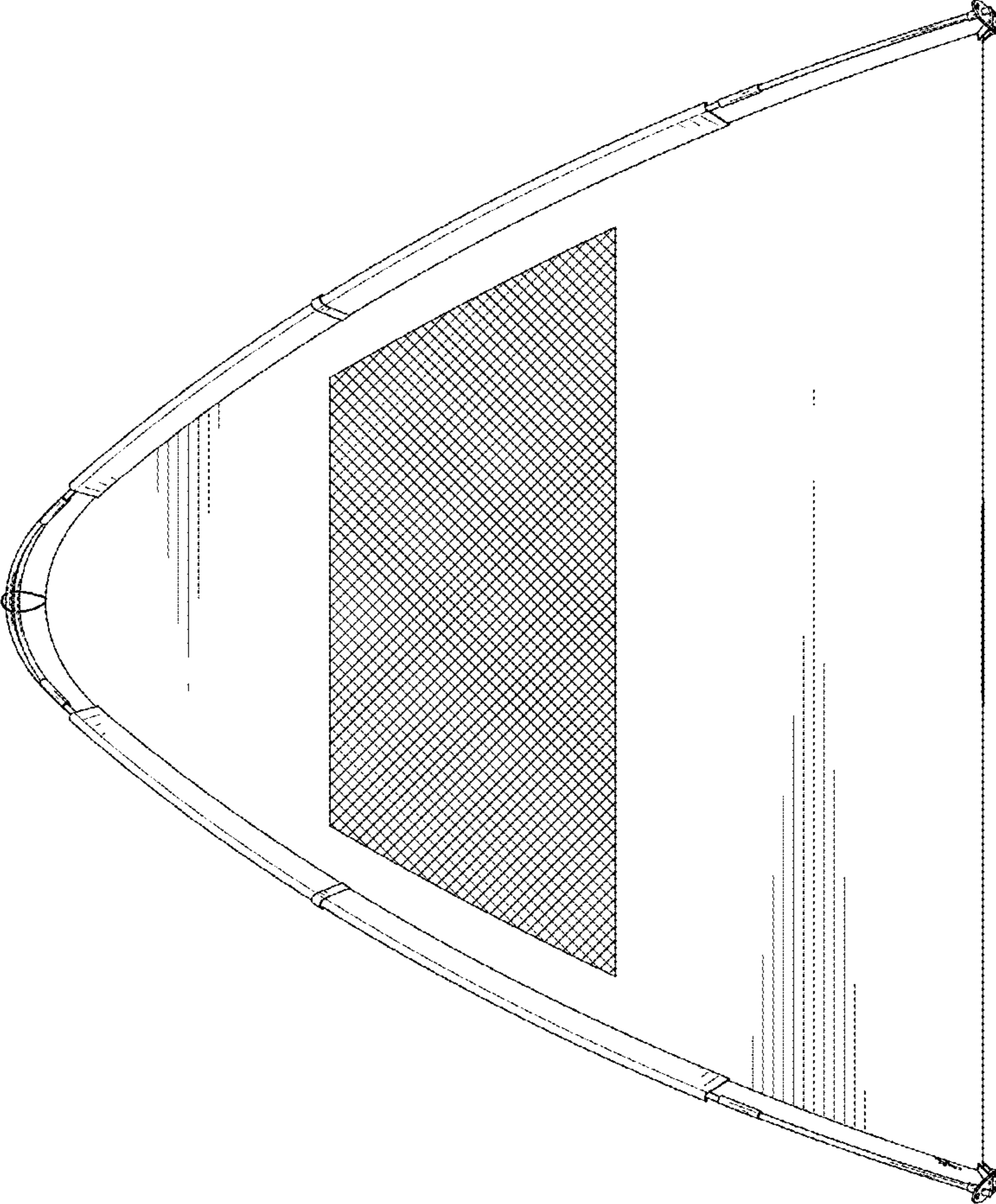

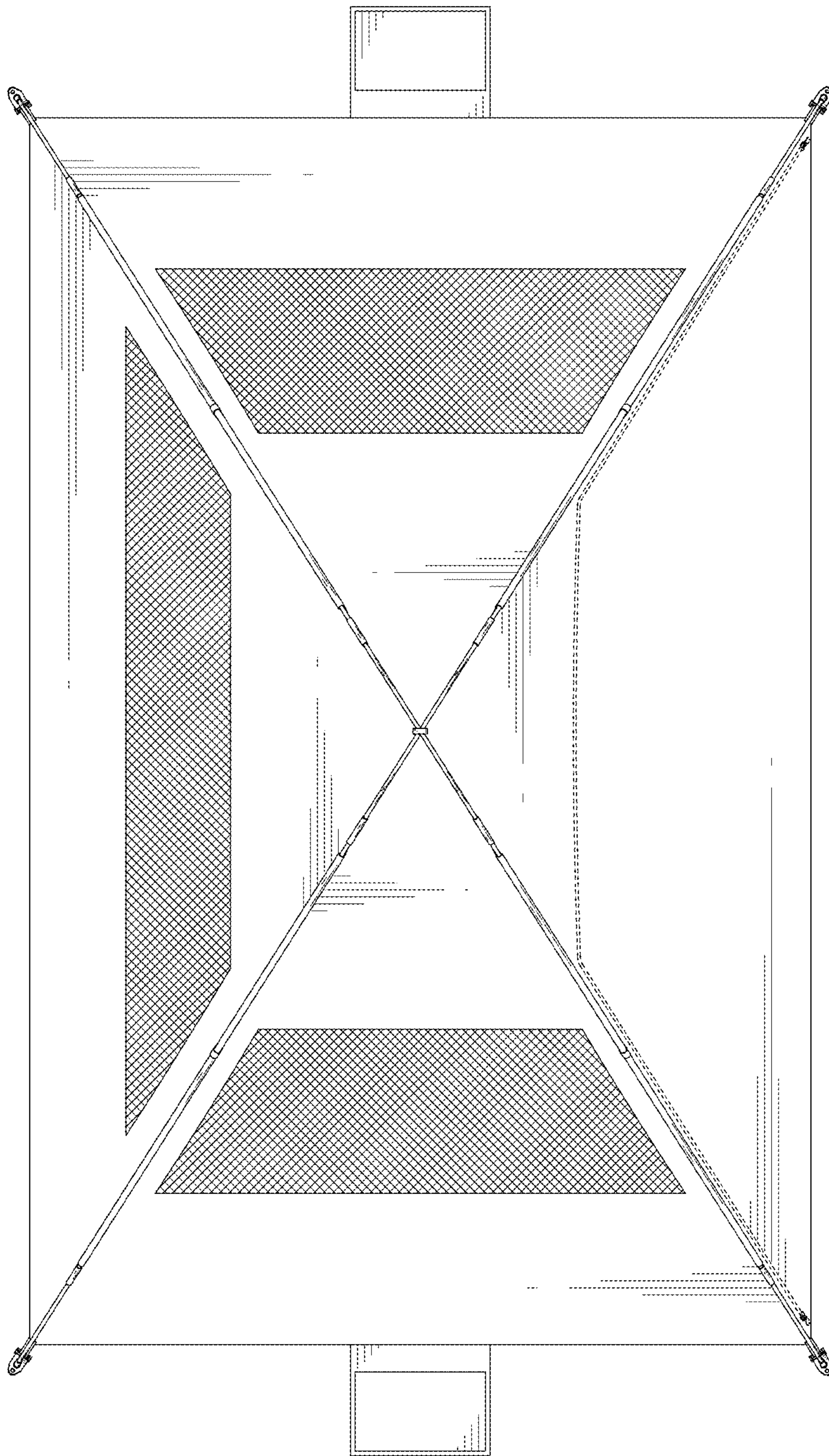

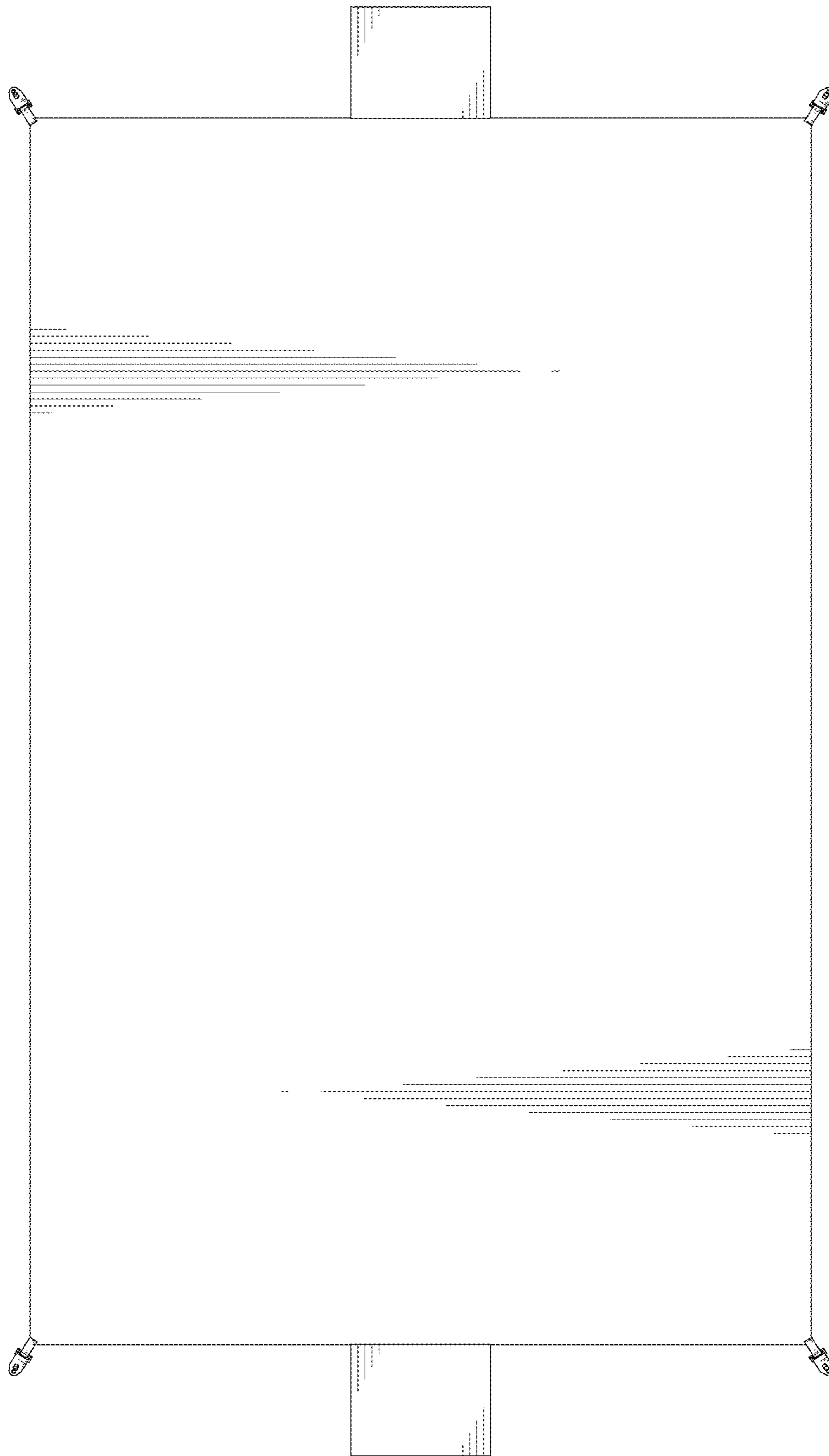

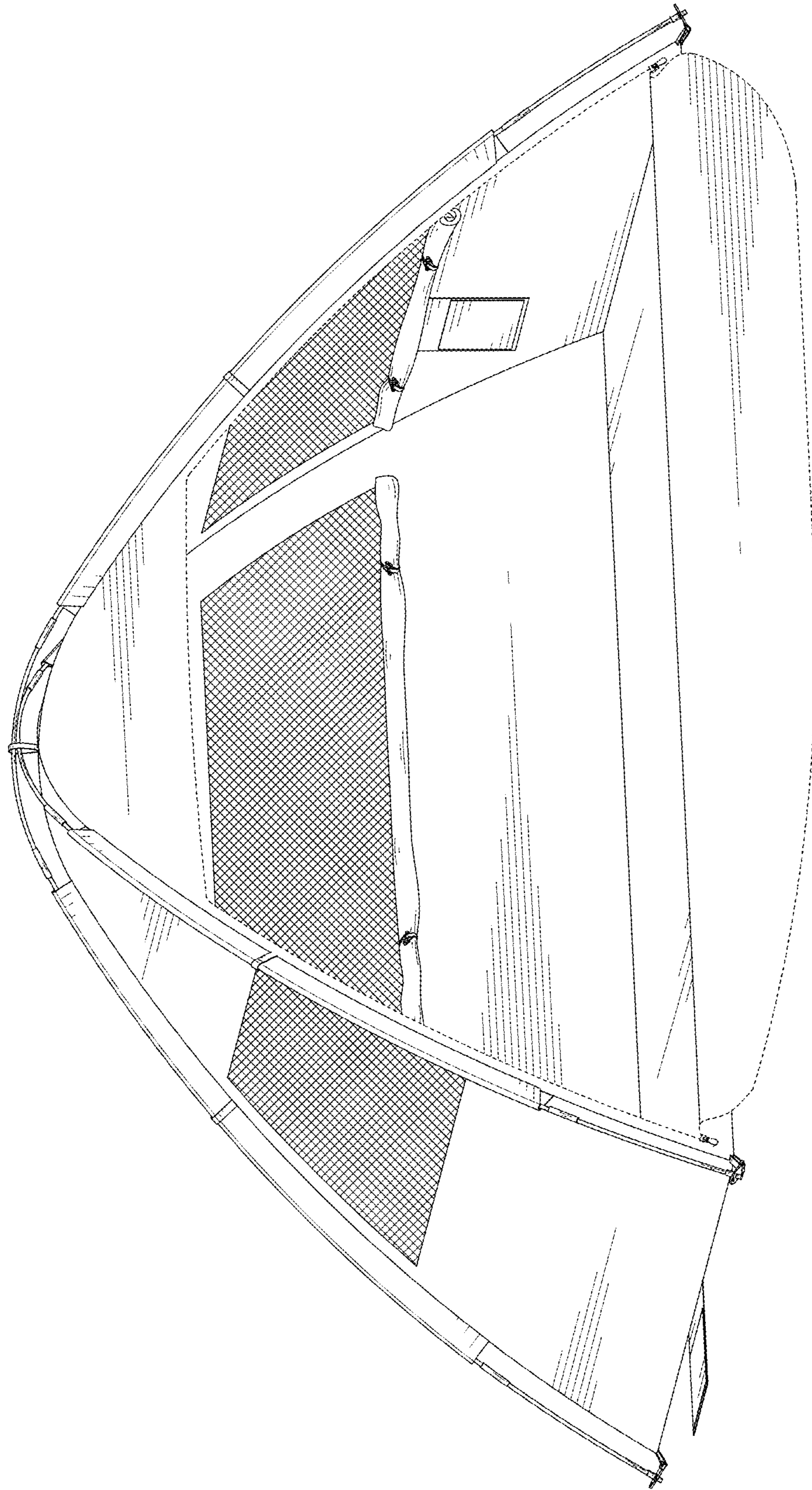
