(57) **CLAIM**

The ornamental design for a pet carrying backpack, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pet carrying backpack showing the new design.  
FIG. 2 is a back view of the pet carrying backpack shown in FIG. 1.  
FIG. 3 is a front view of the pet carrying backpack shown in FIG. 1.  
FIG. 4 is a side view of the pet carrying backpack shown in FIG. 1.  
FIG. 5 is a side view of the pet carrying backpack shown in FIG. 1.  
FIG. 6 is a top view of the pet carrying backpack shown in FIG. 1; and,  
FIG. 7 is a bottom view of the pet carrying backpack shown in FIG. 1.

The broken lines illustrate stitching and form part of the claimed design.  
The dash-dot-dash broken lines illustrate portions of the bottom-entry pet carrying backpack that form no part of the claimed design.

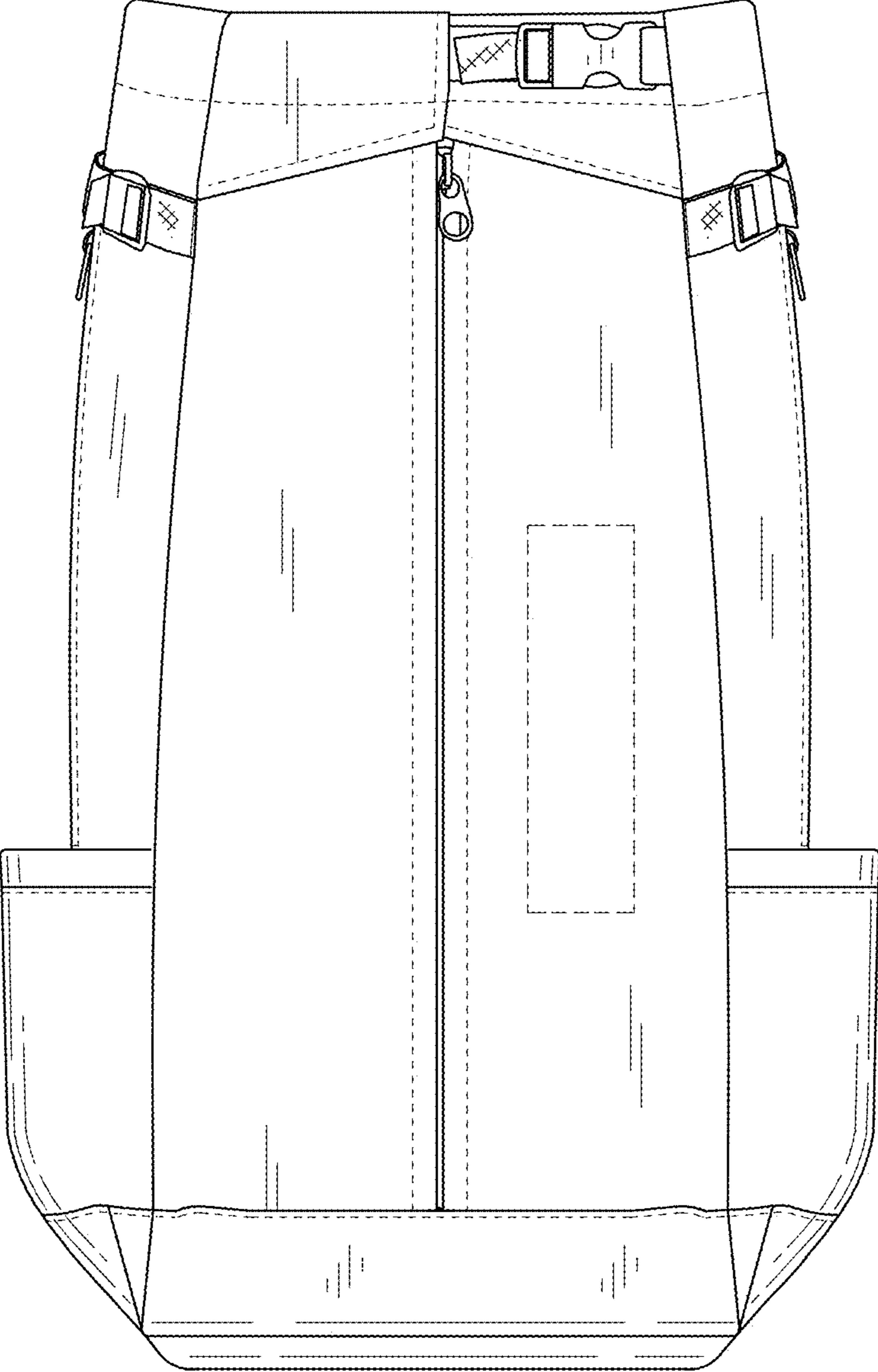

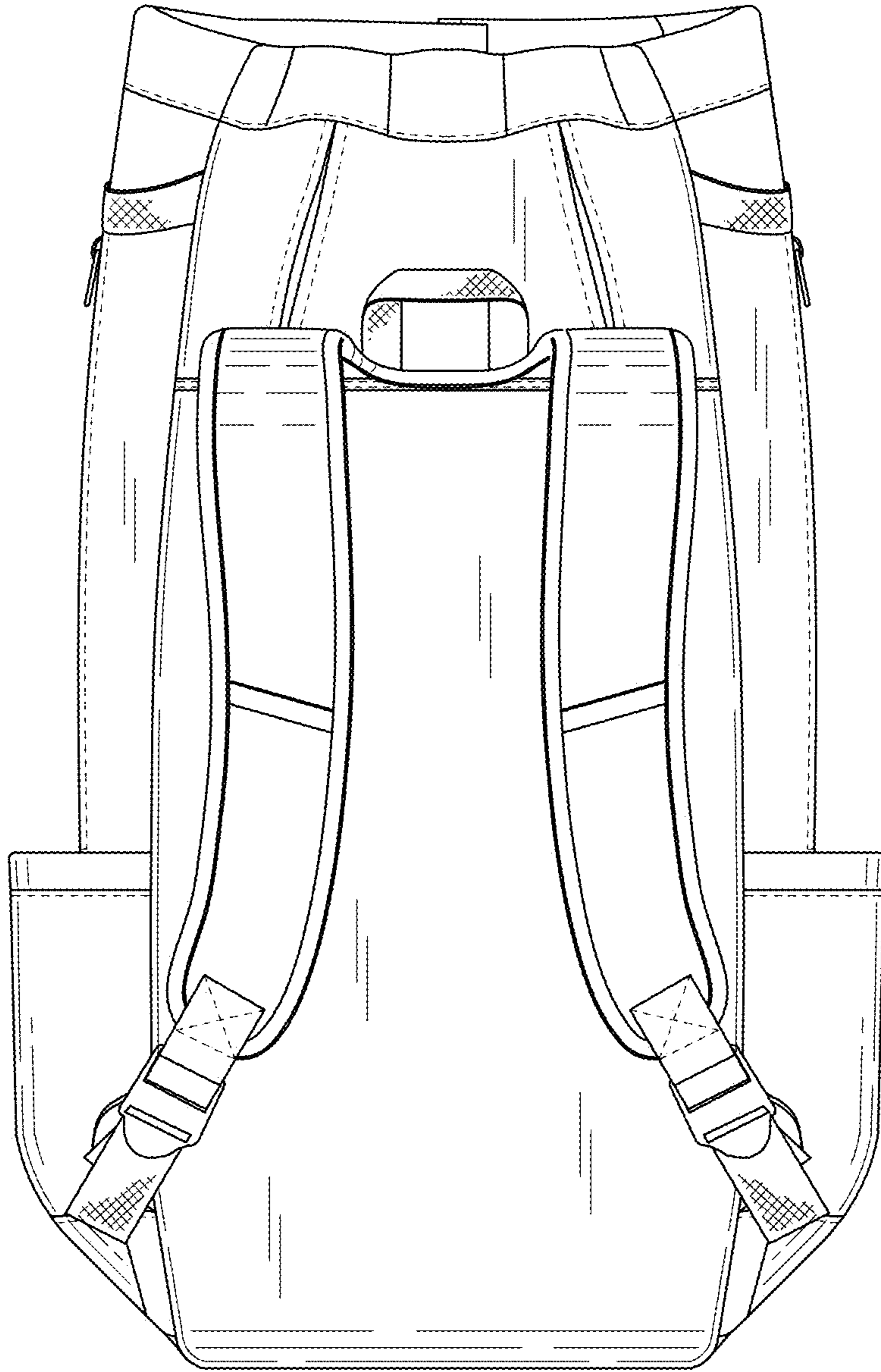

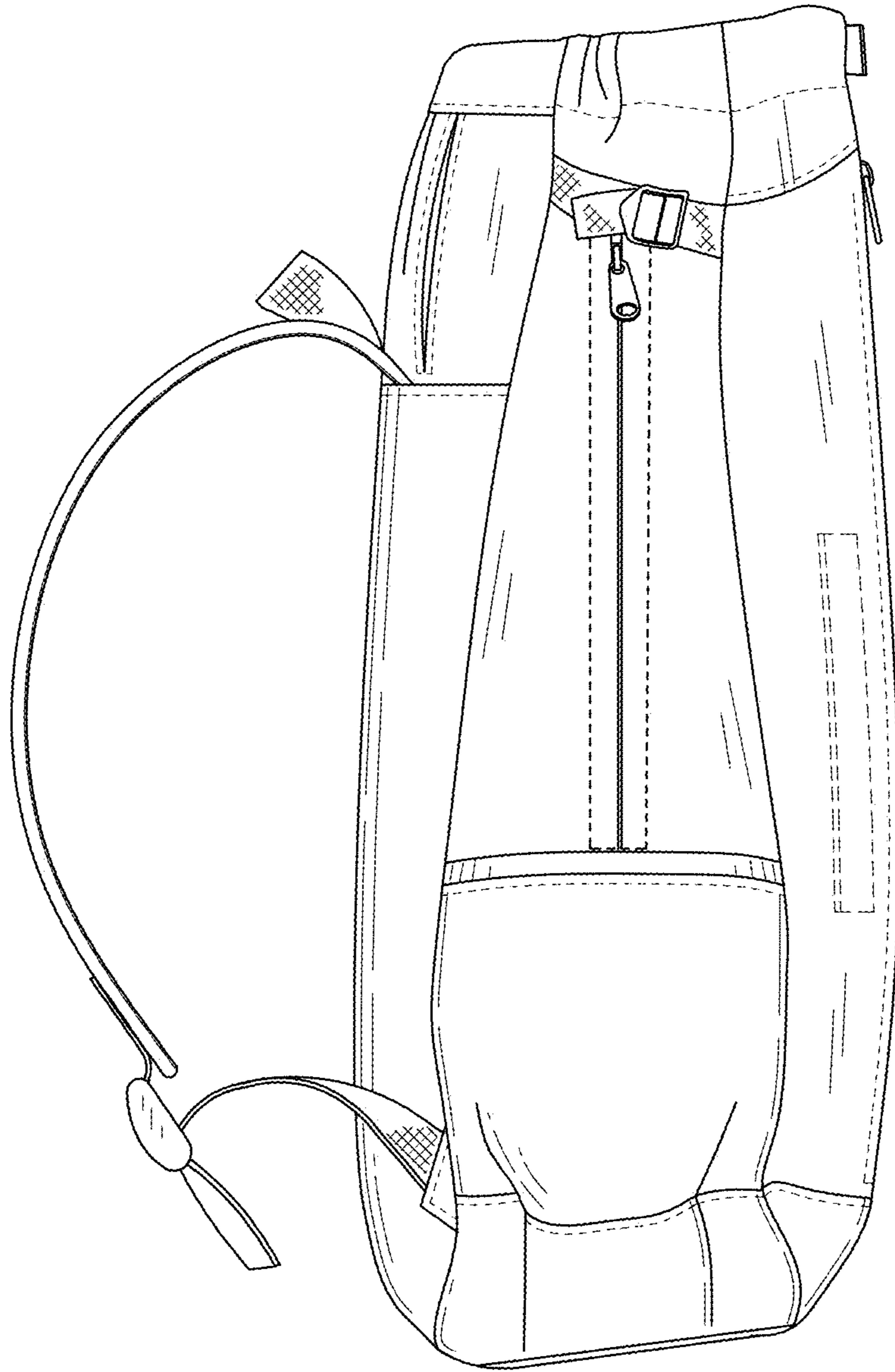

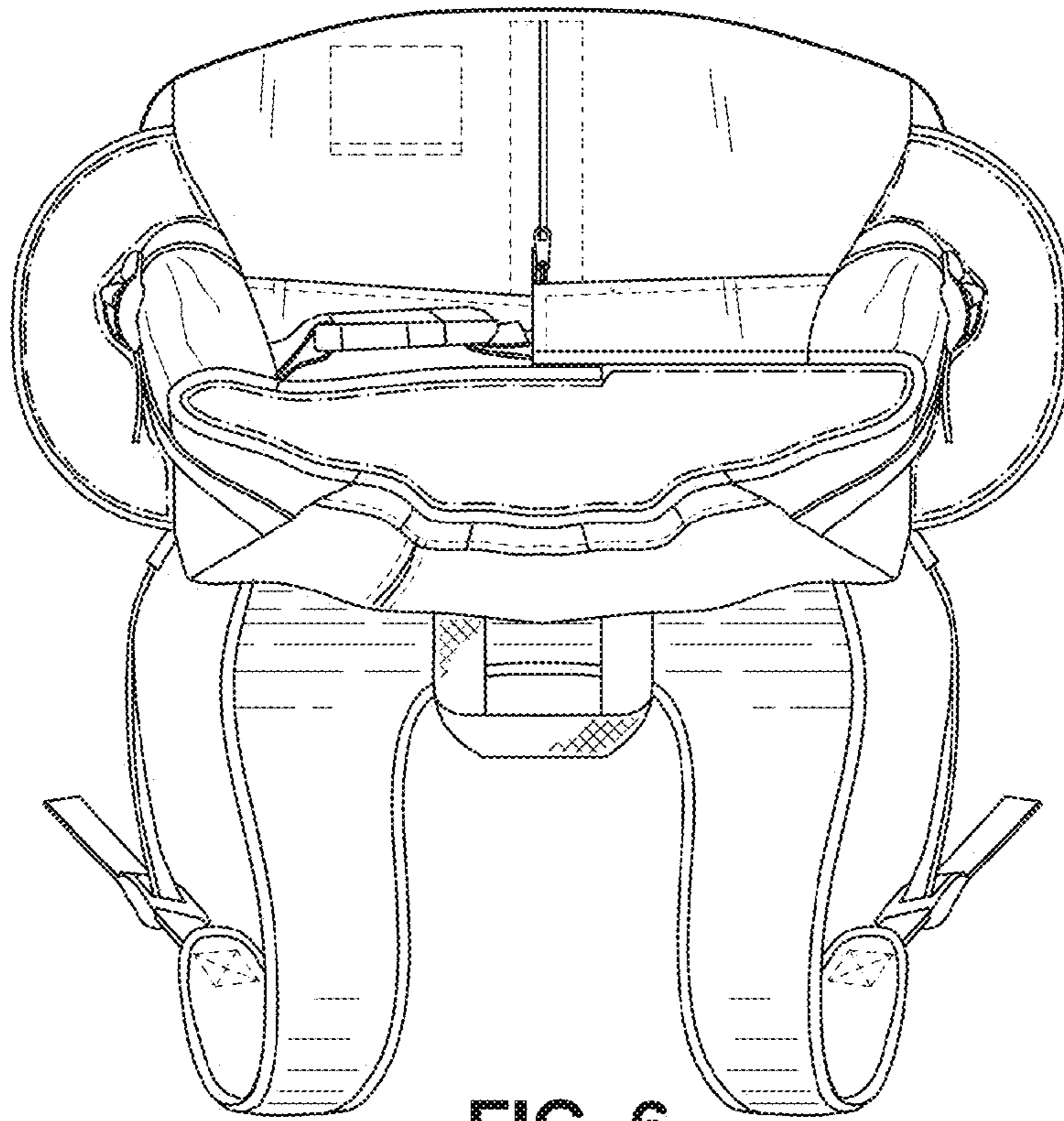

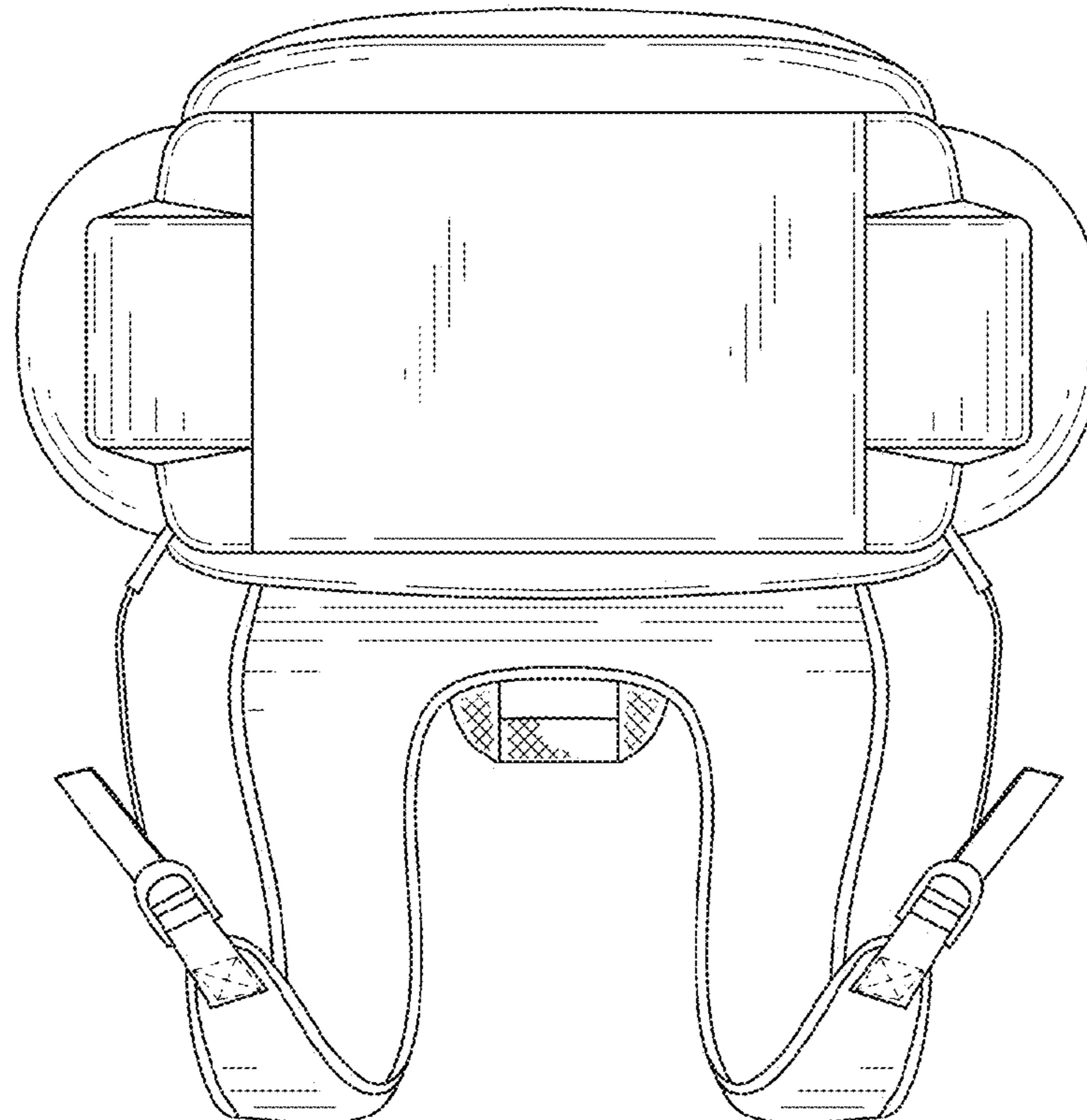
