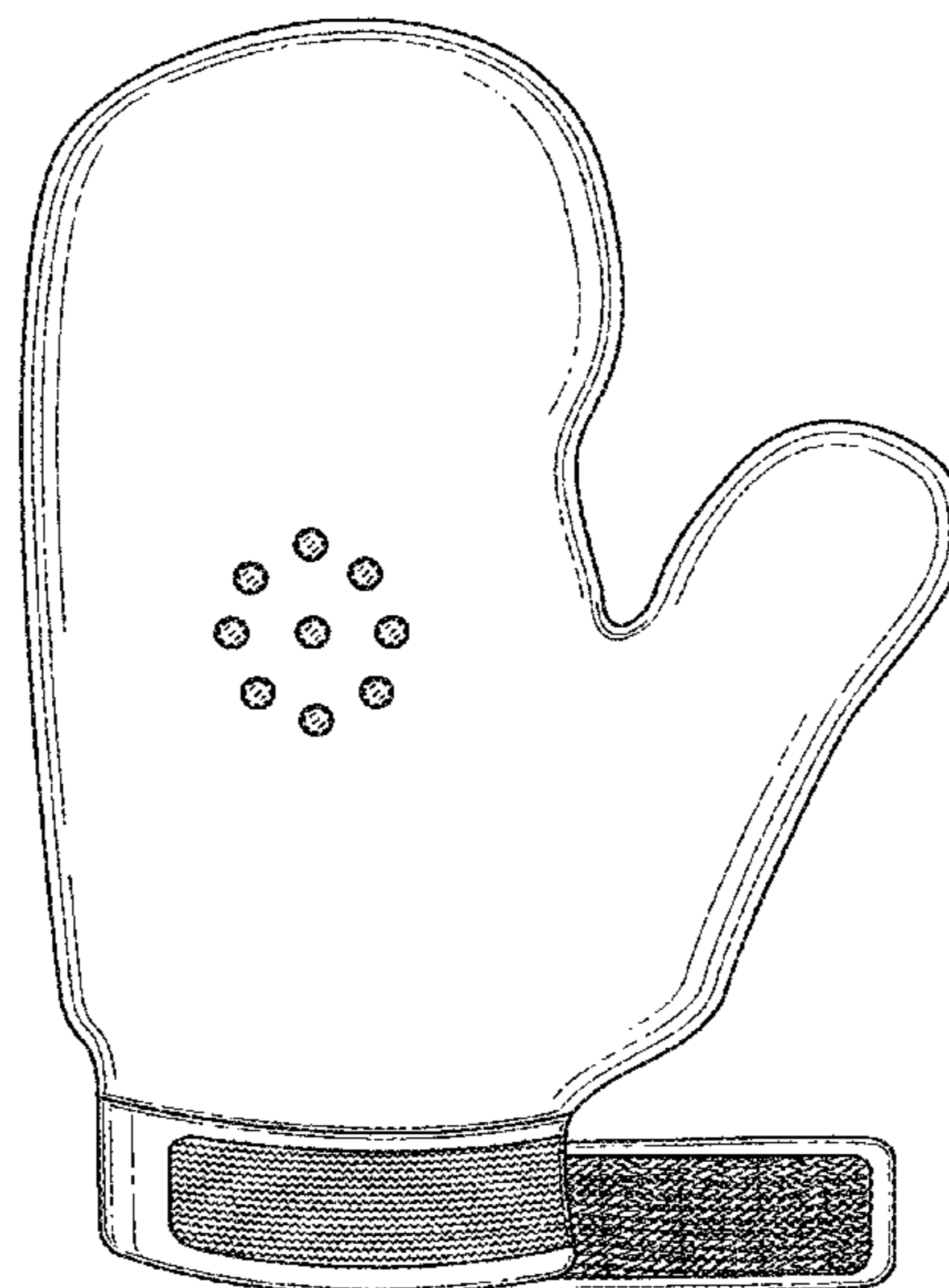
(57) **CLAIM**

The ornamental design for a car washing glove, as shown and described.

DESCRIPTION

FIG. 1 is a rear view of my new design for a car washing glove with the strap in an open configuration; FIG. 2 is a front view thereof; FIG. 3 is a right side view of FIG. 2; FIG. 4 is a left side view of FIG. 2; and, FIG. 5 is a bottom view of FIG. 2. The broken lines shown in the drawings depict portions of the car washing glove that form no part of the claimed design.

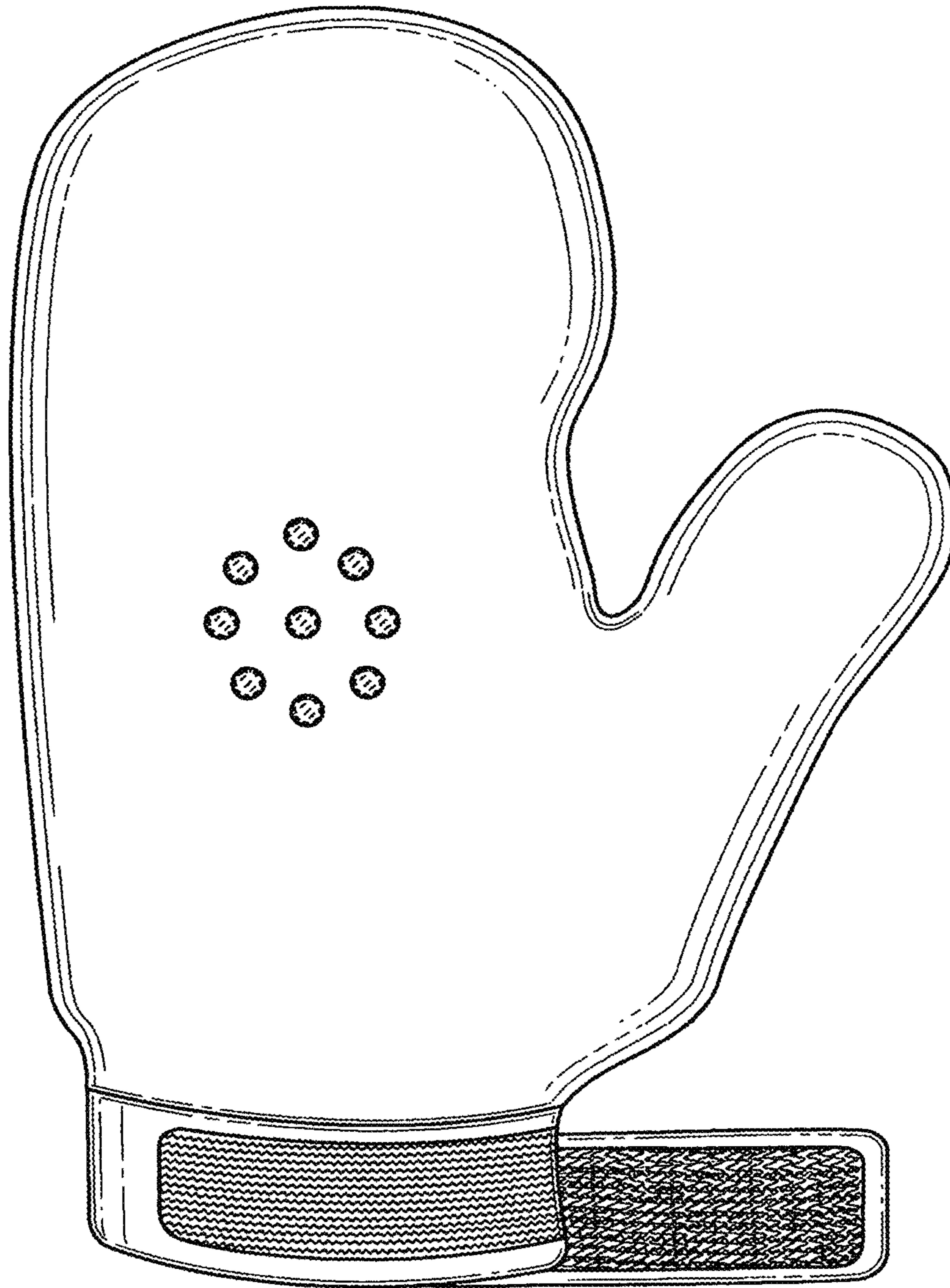

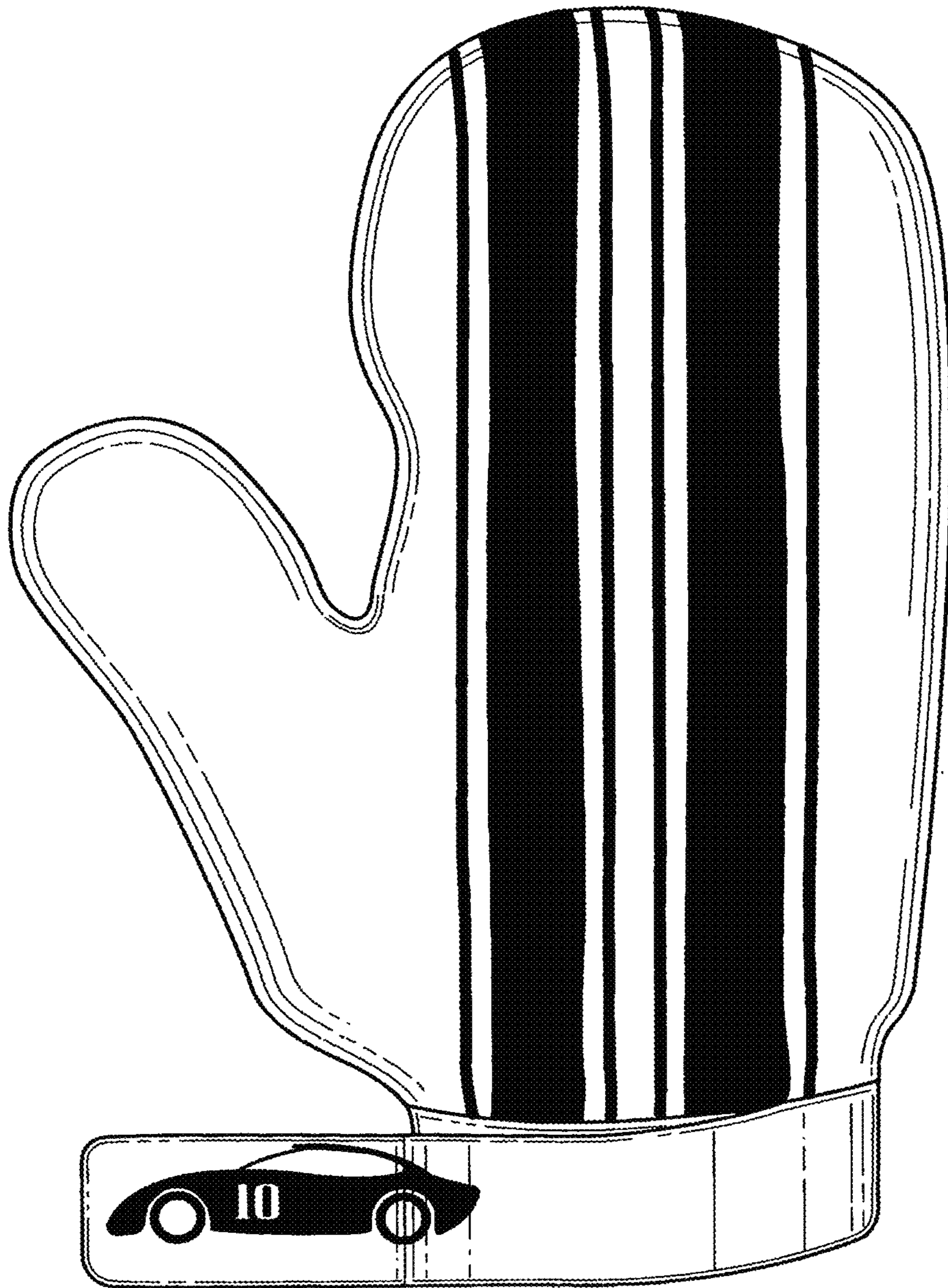

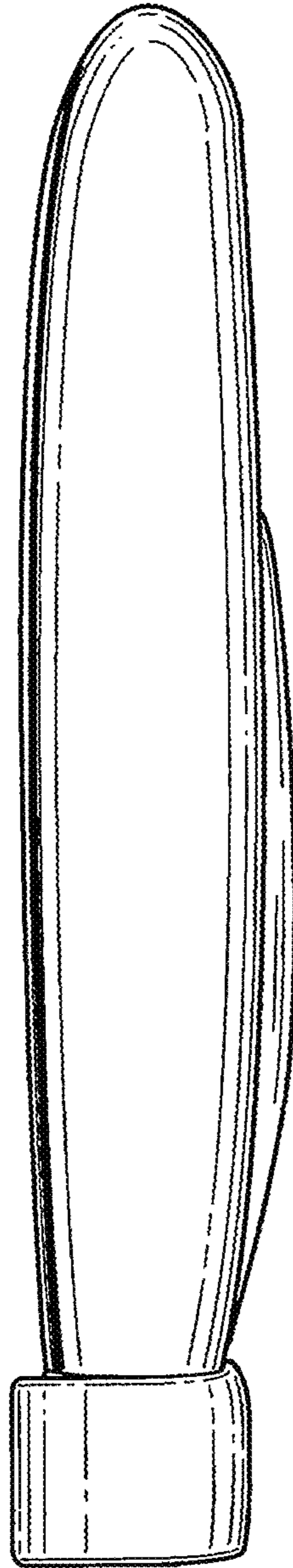

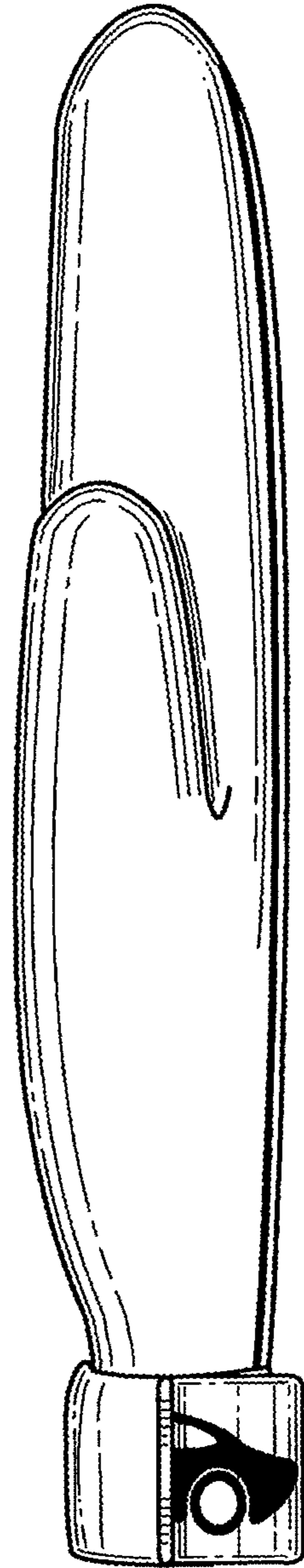

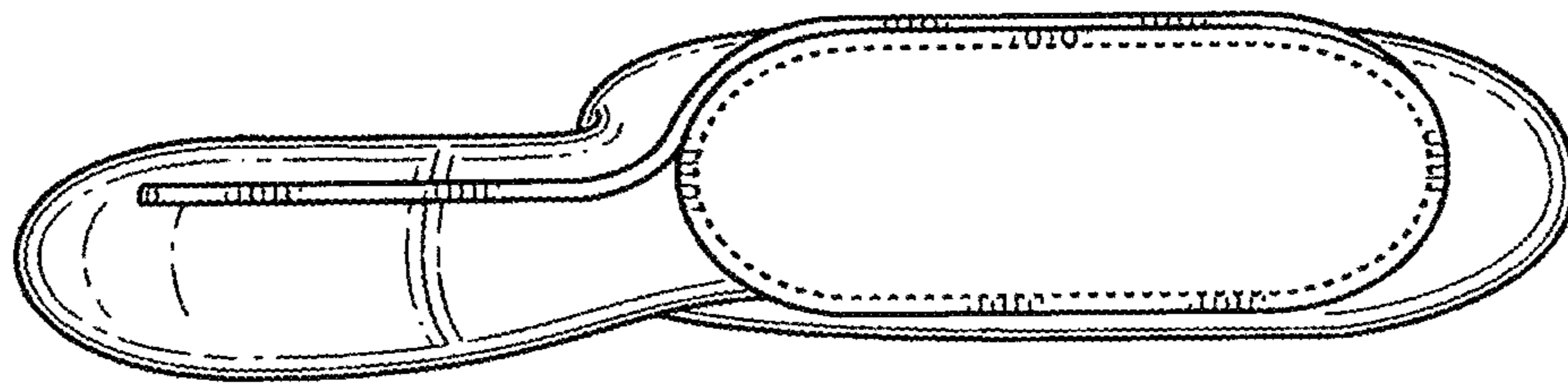
