DESCRIPTION

FIG. 1 is a front bottom perspective view of a shoe showing my new design;

FIG. 2 is a rear bottom perspective view thereof;

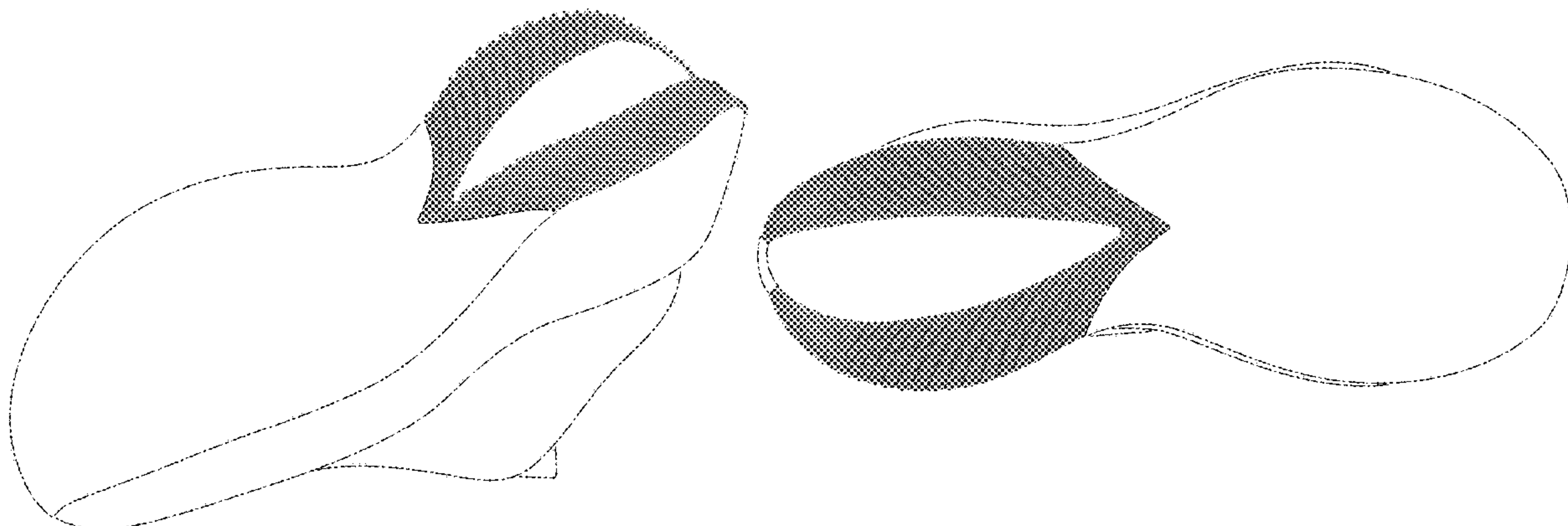
FIG. 3 is a bottom view thereof;

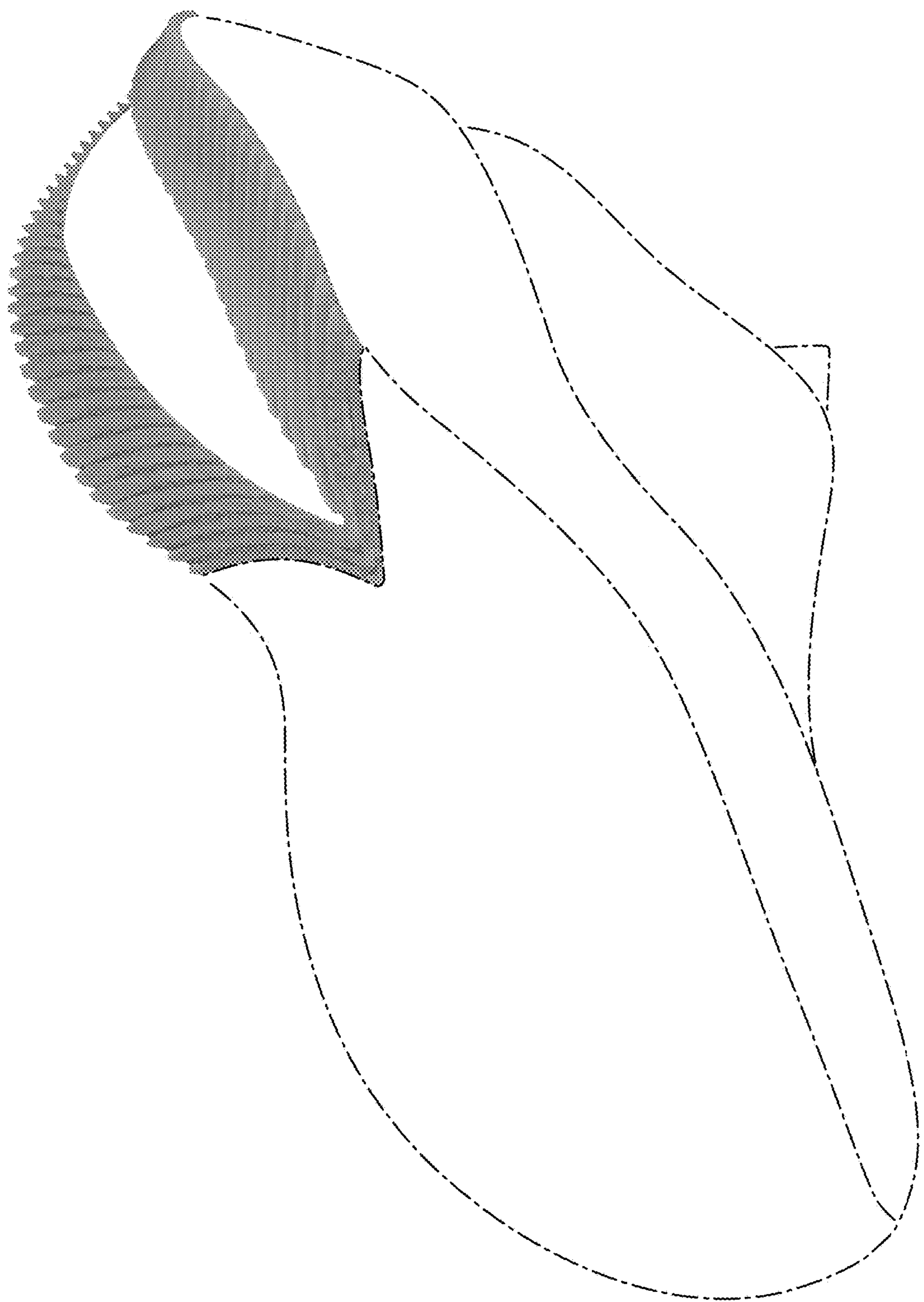

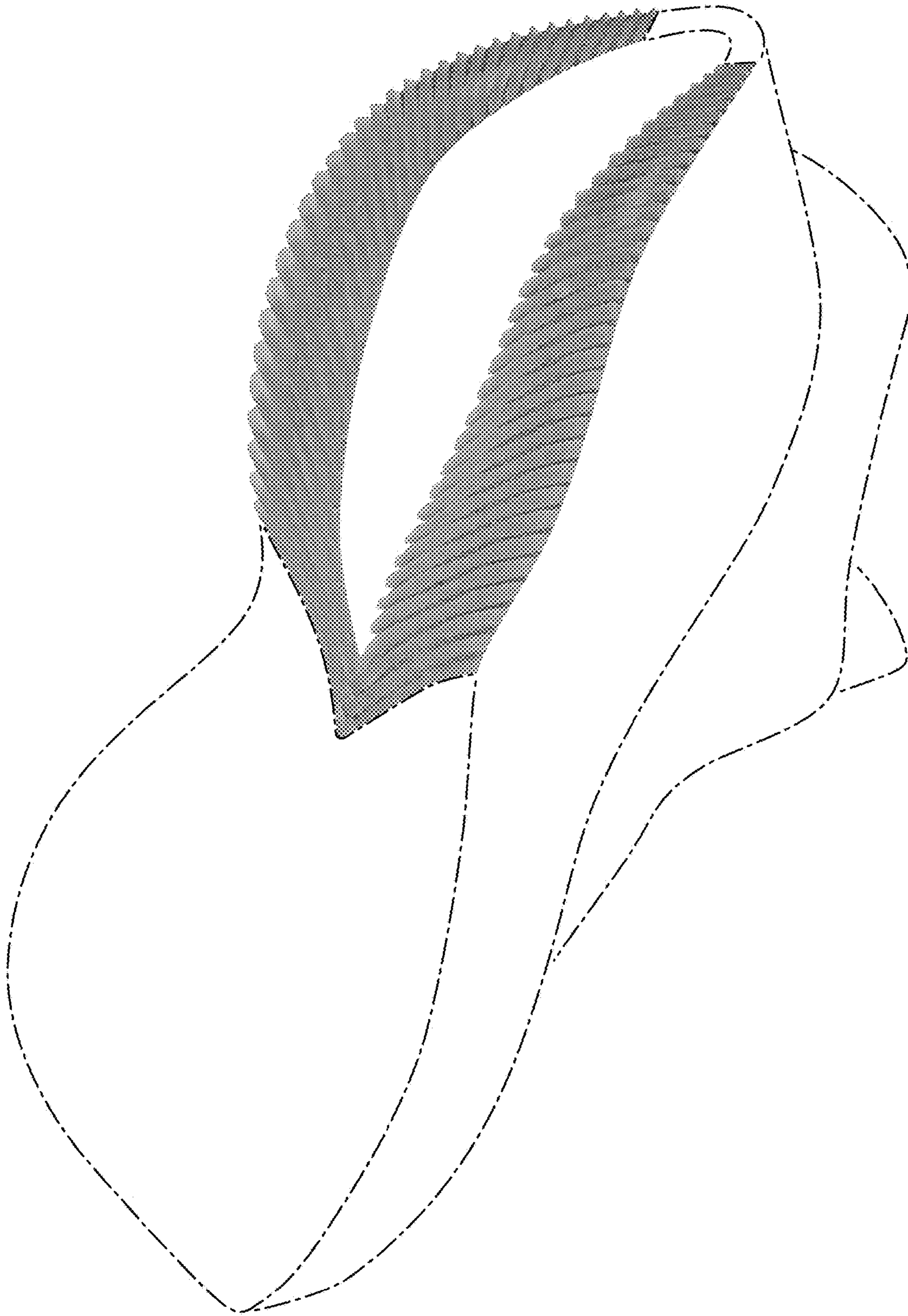

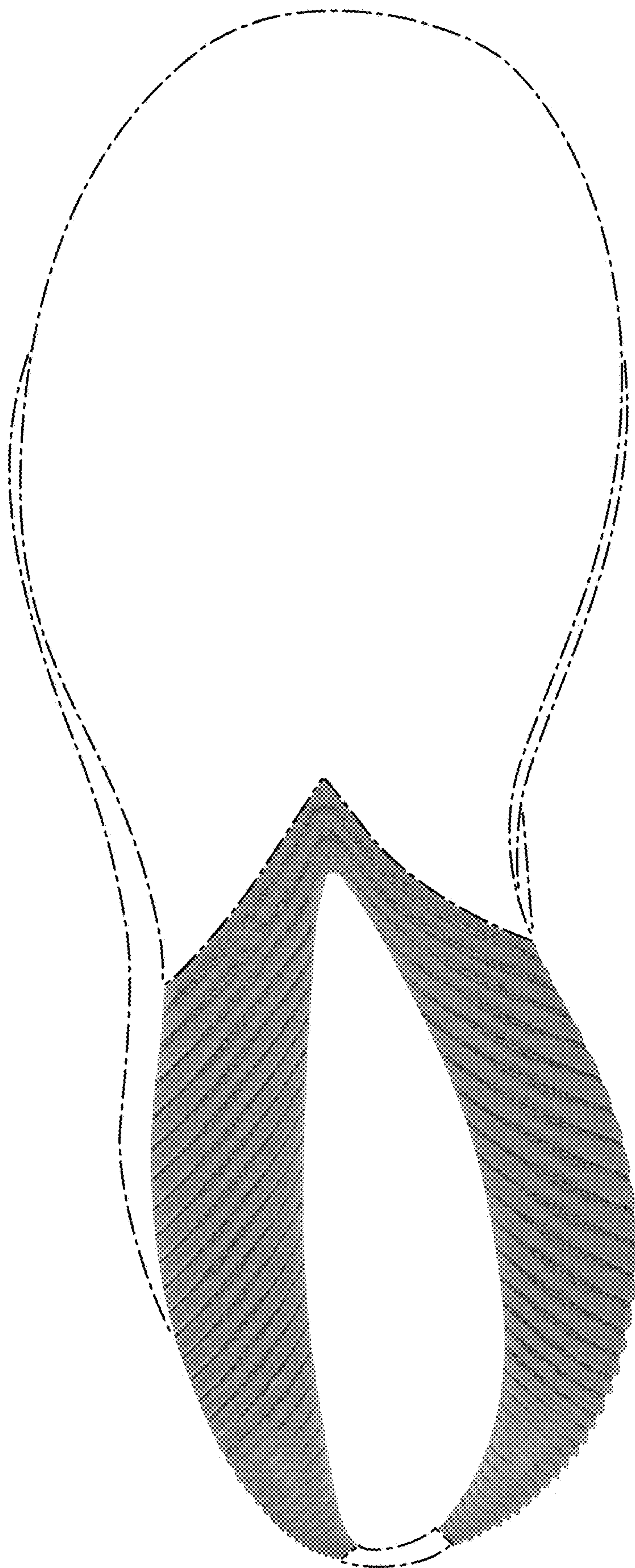

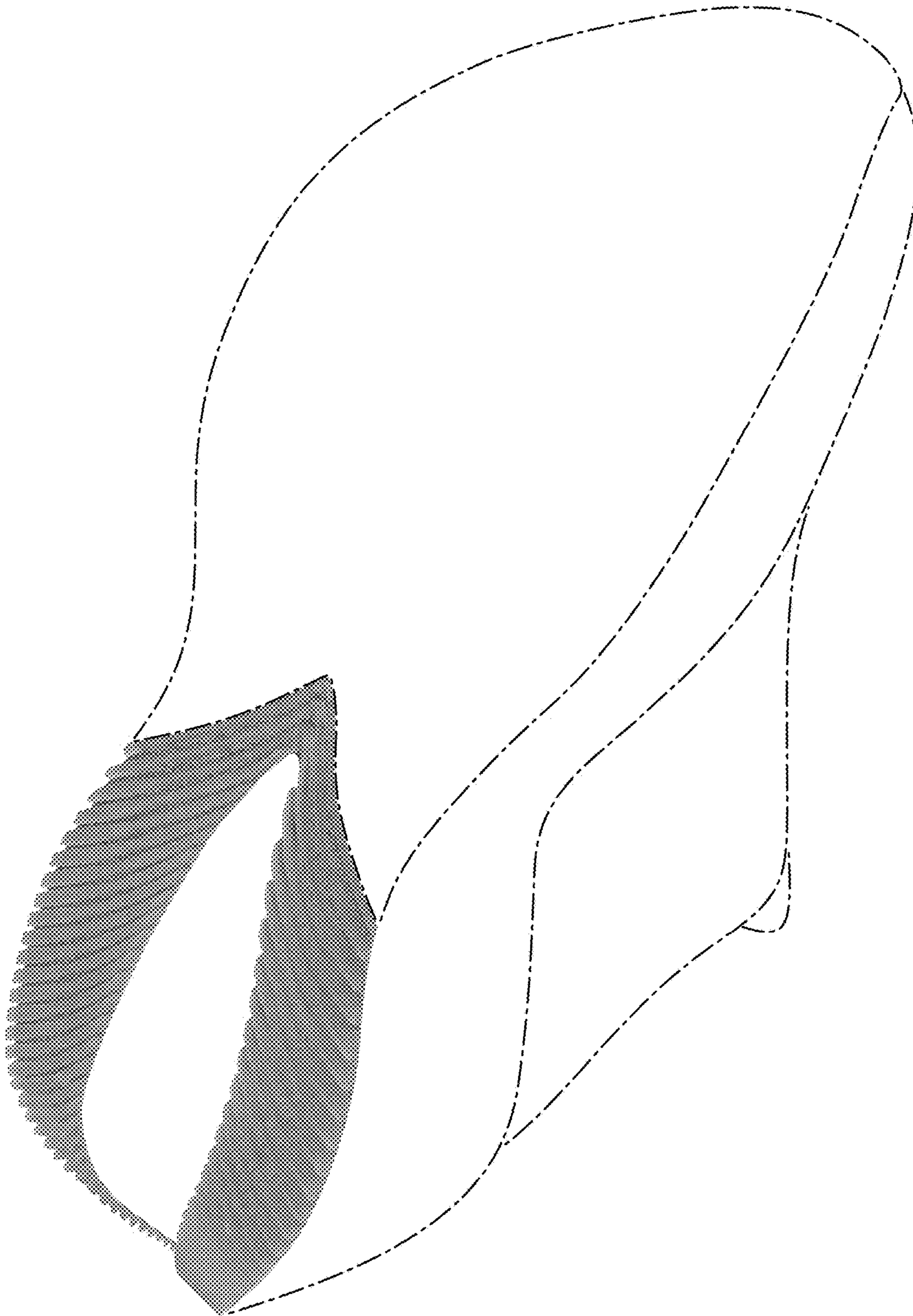

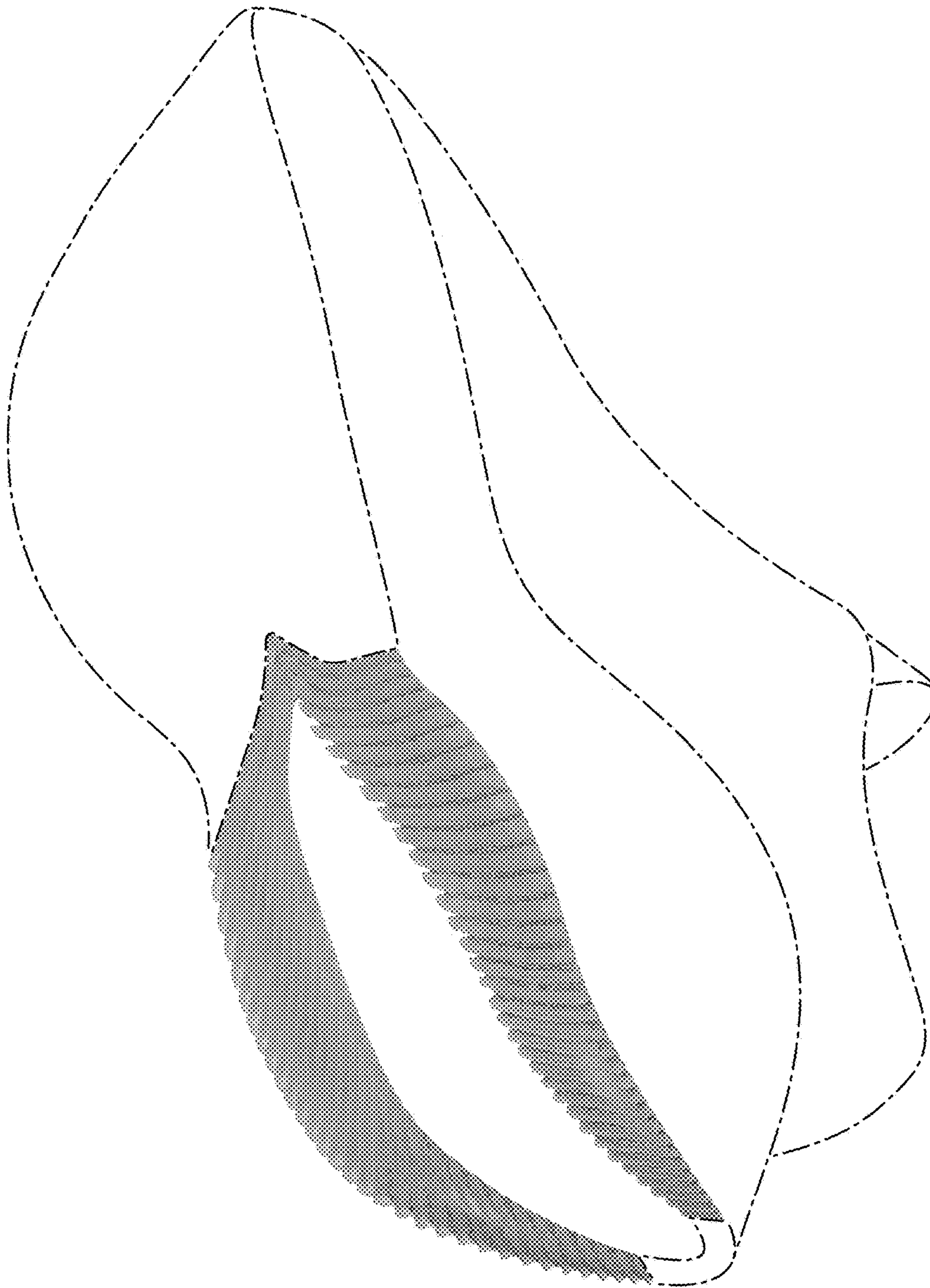
