(57) **CLAIM**

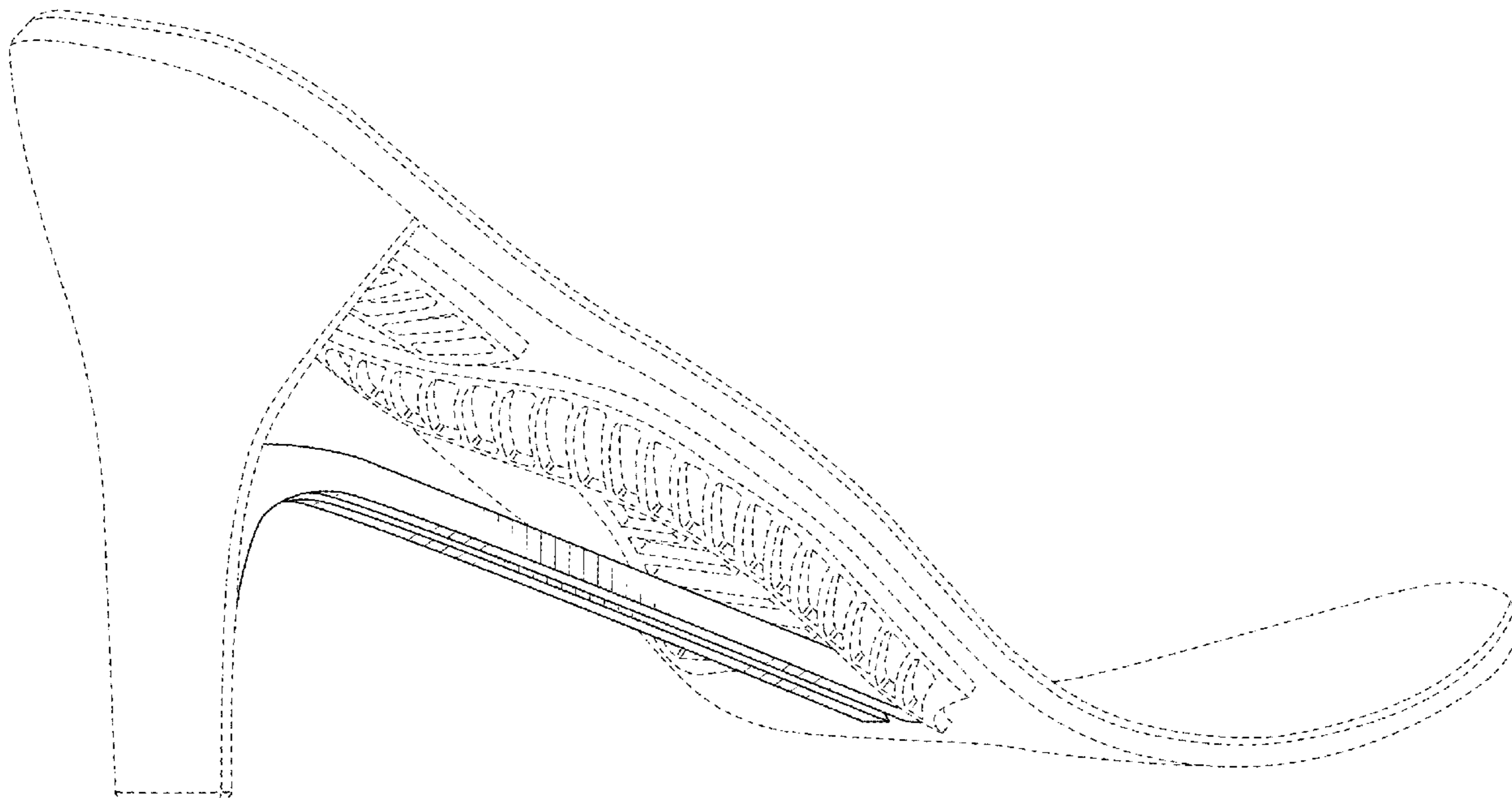
The ornamental design for a heel shank, as shown and described.

DESCRIPTION

FIG. 1 is a top, left perspective view of a heel shank showing a new design;

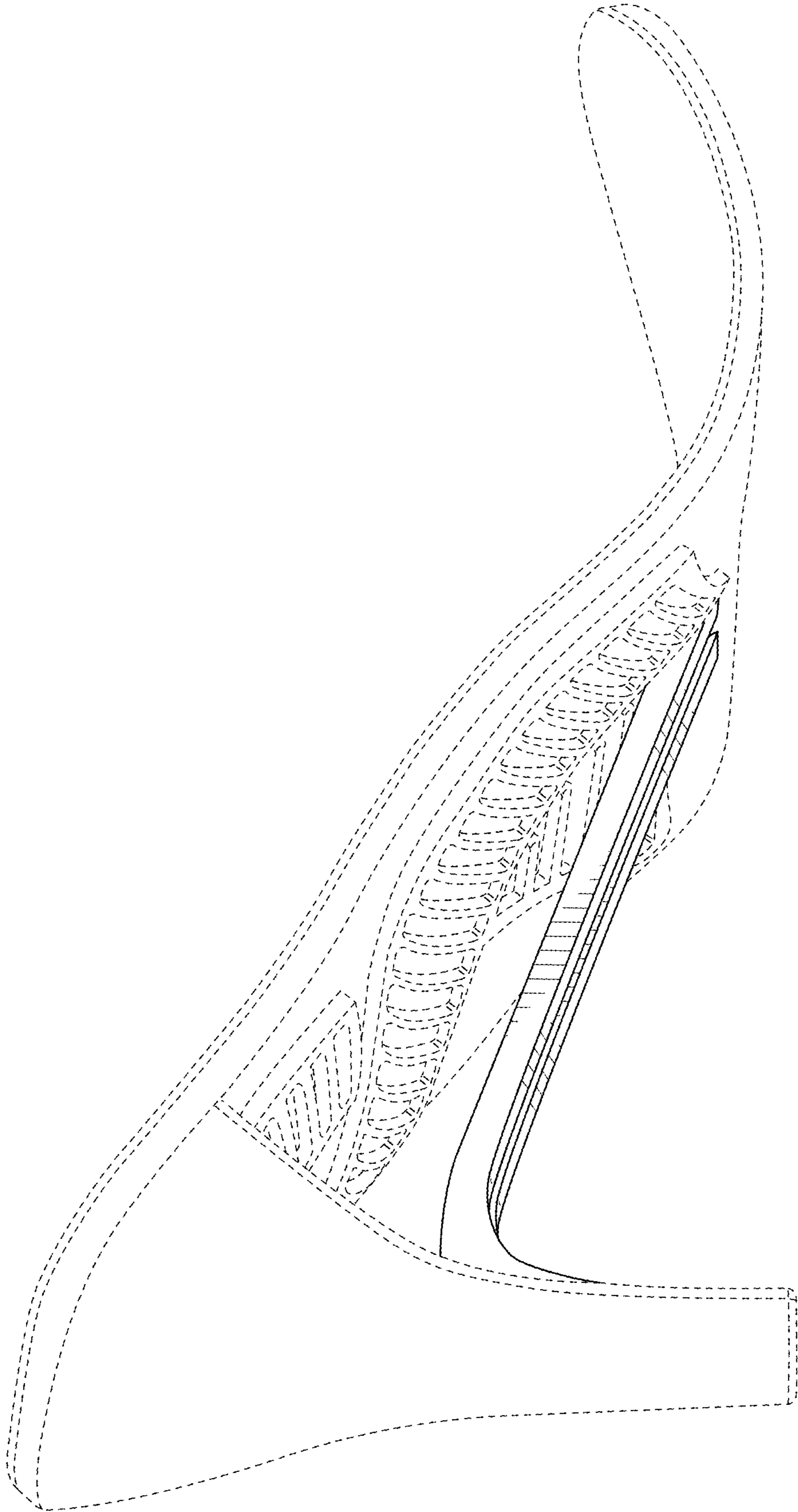

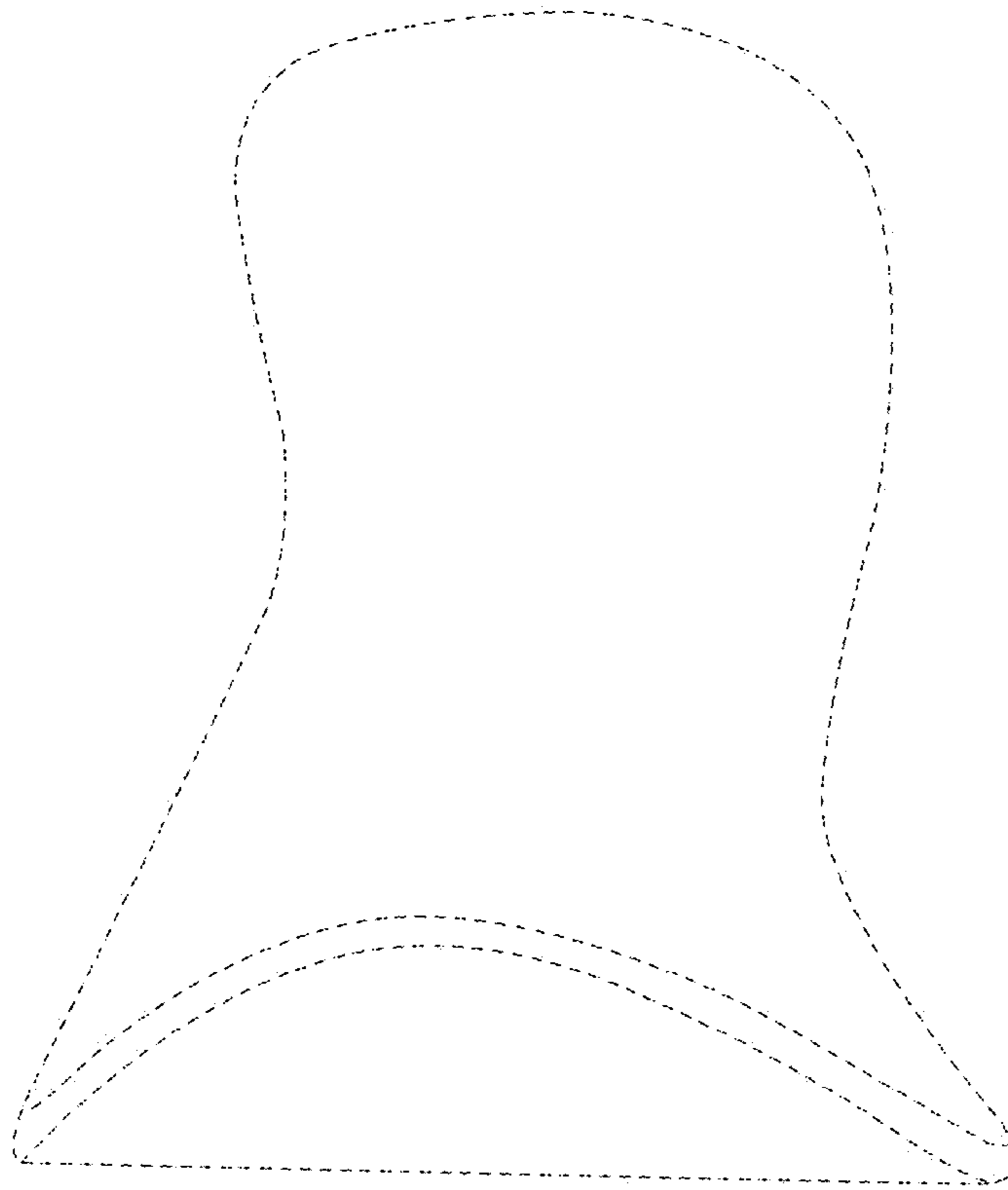

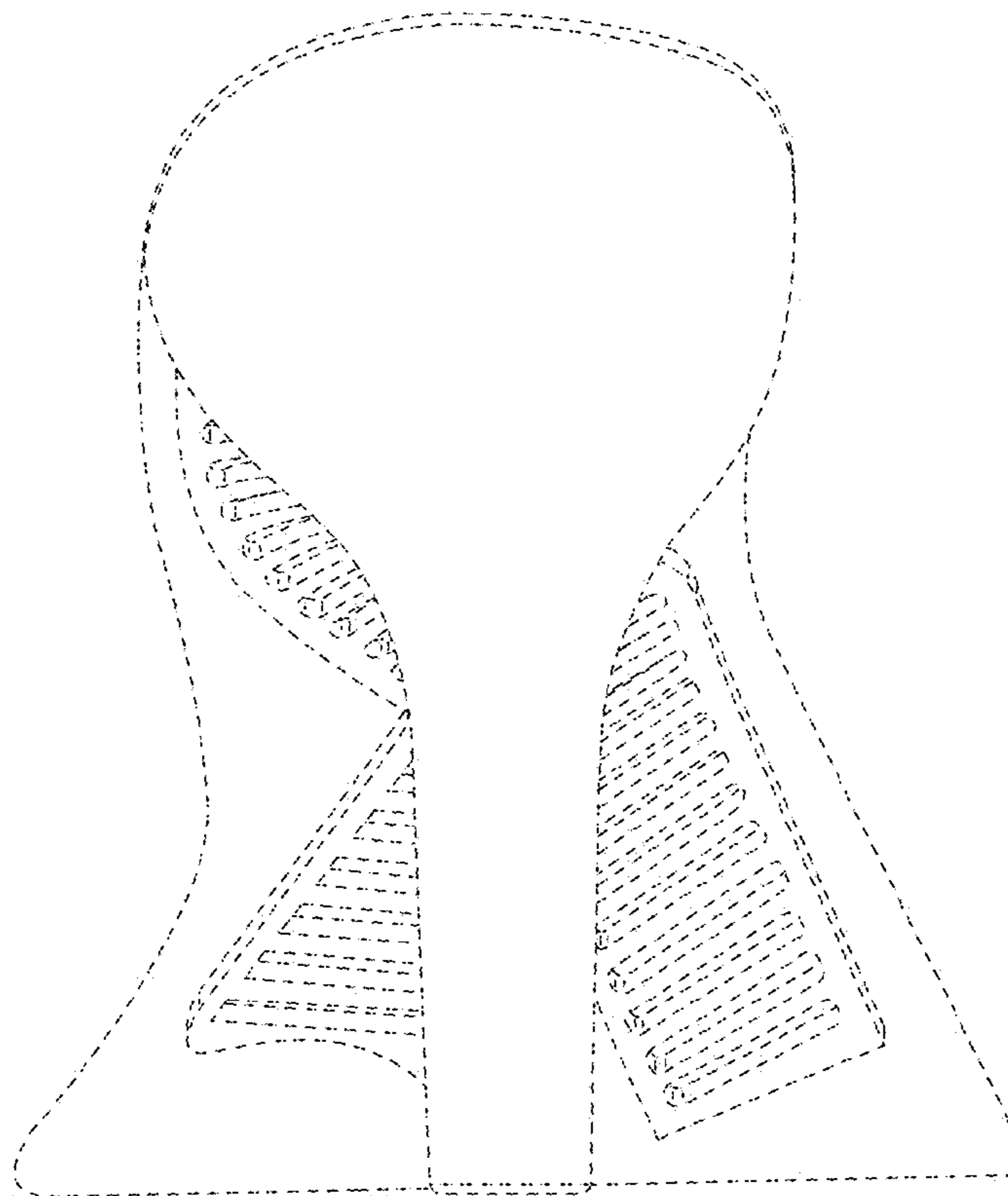

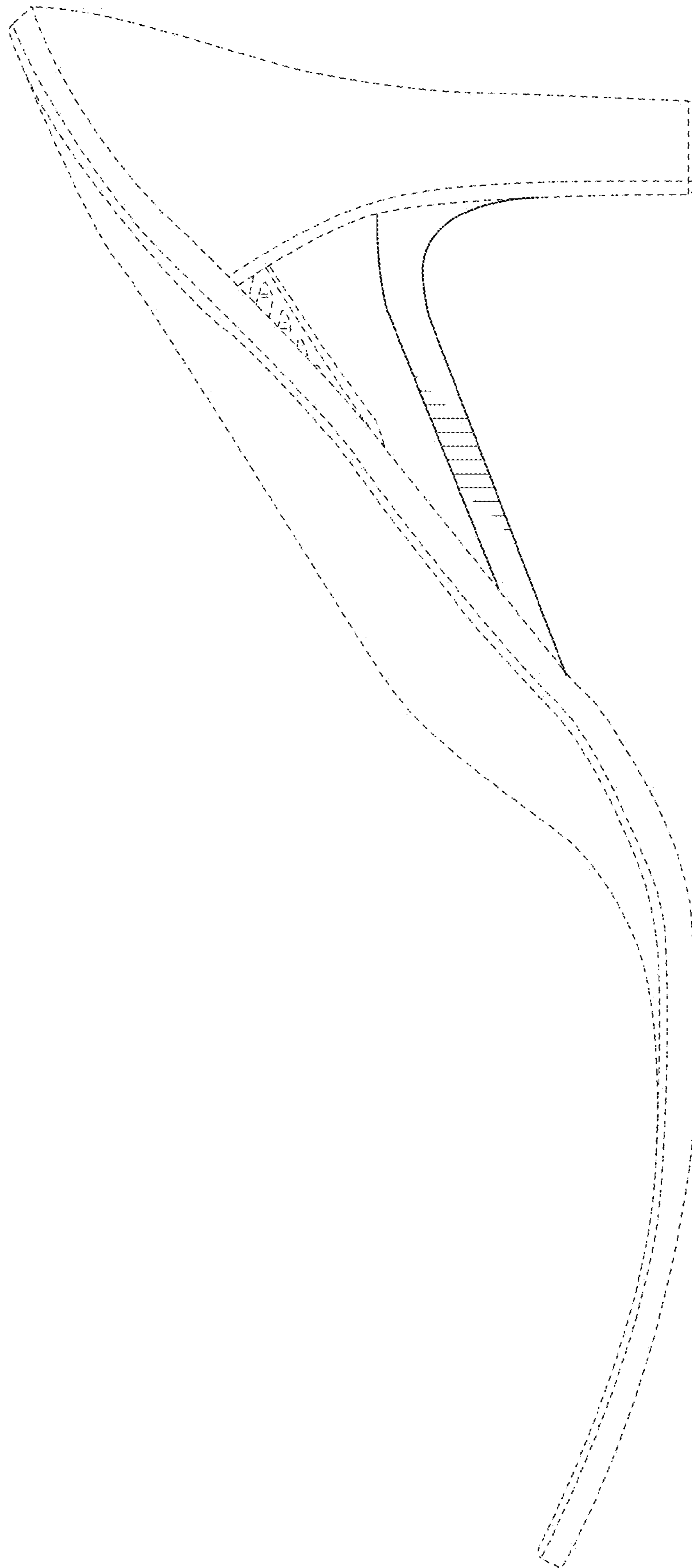

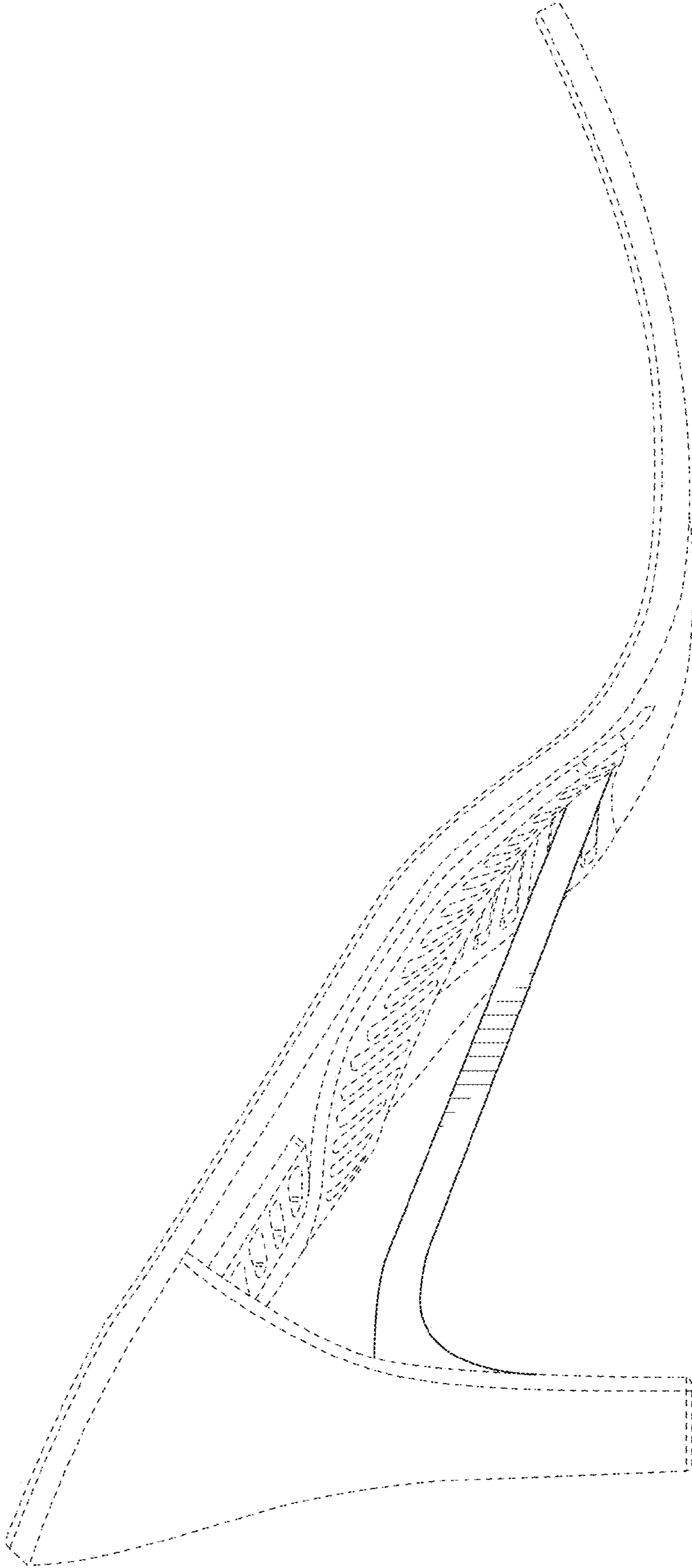

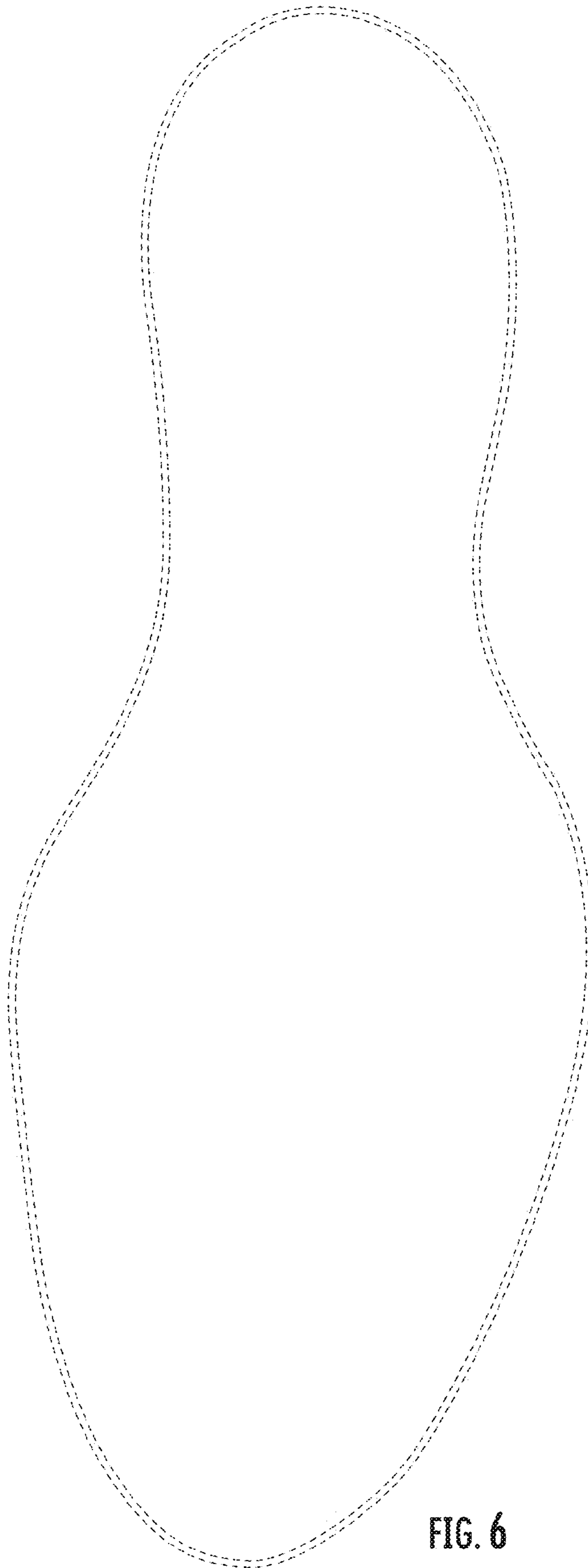

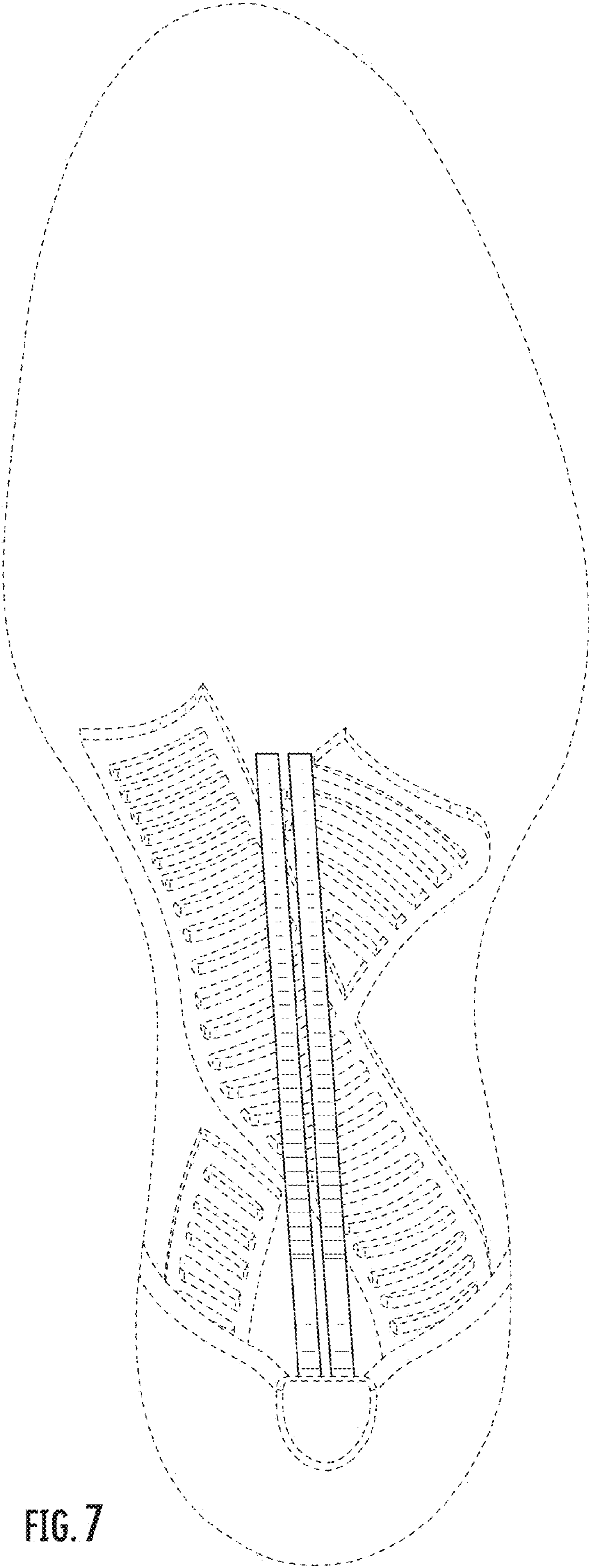
