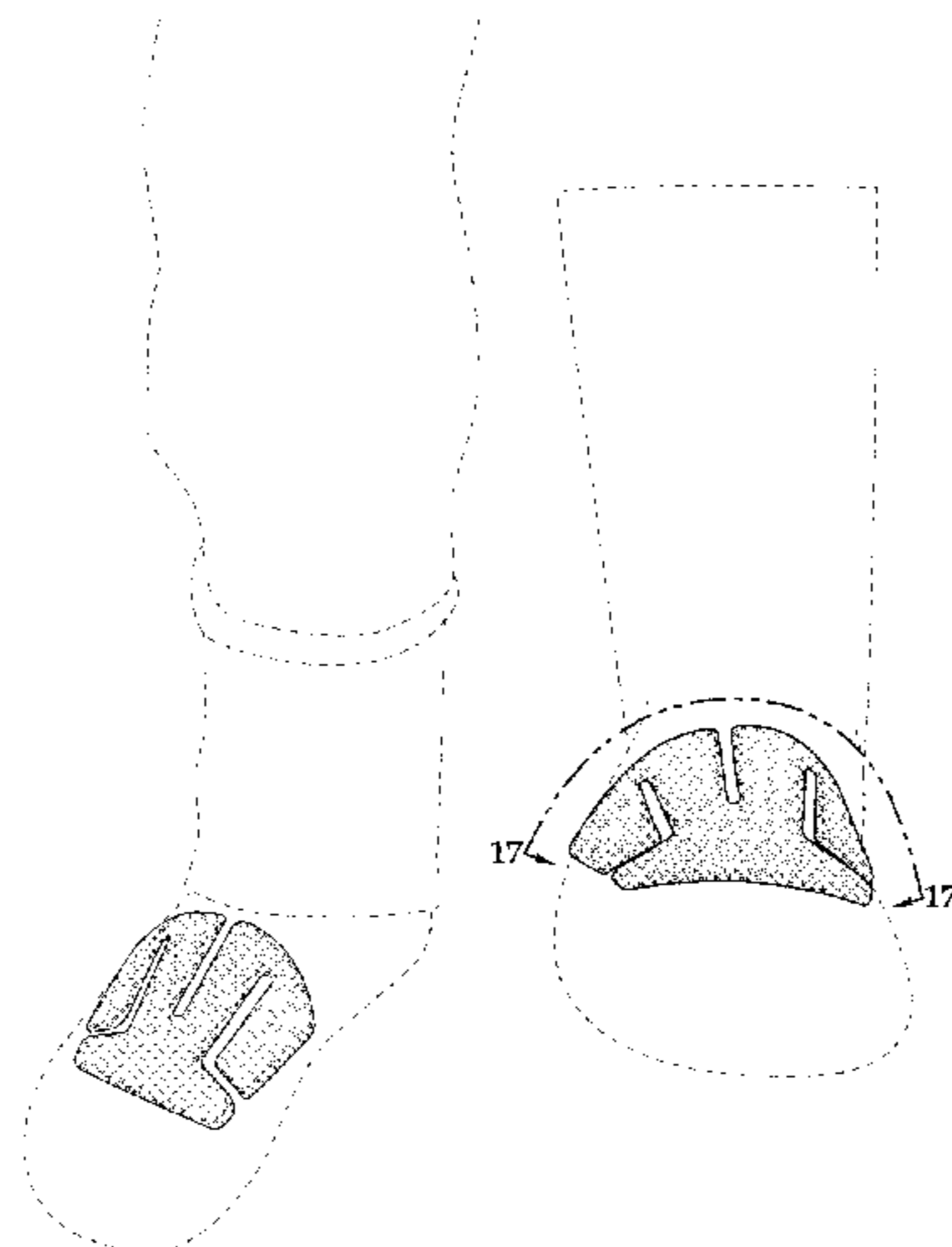


FIG. 12 is a top view of the bootie portion of a stockingfoot wader showing the new design with the bootie standing alone and turned inside out.

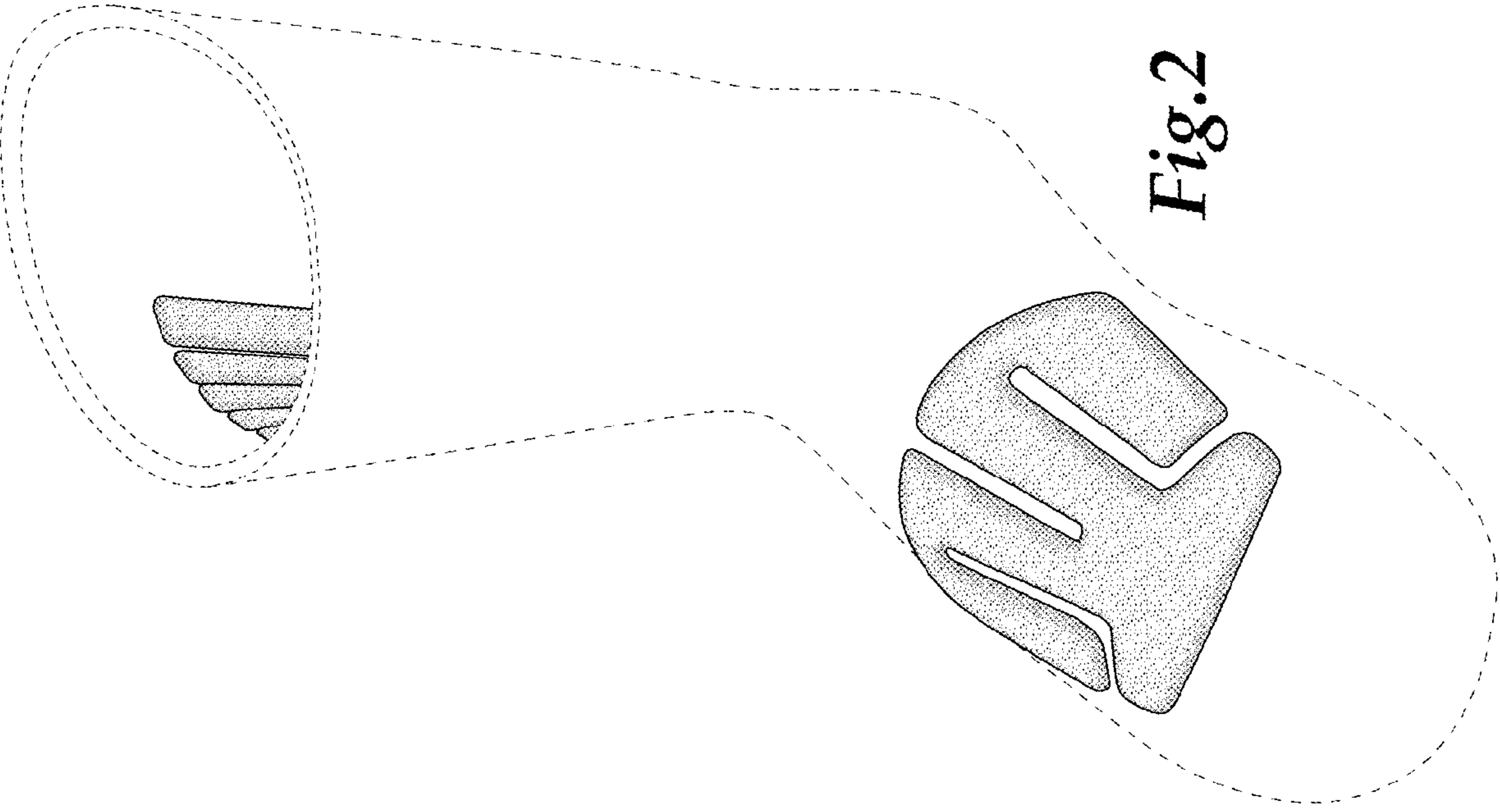

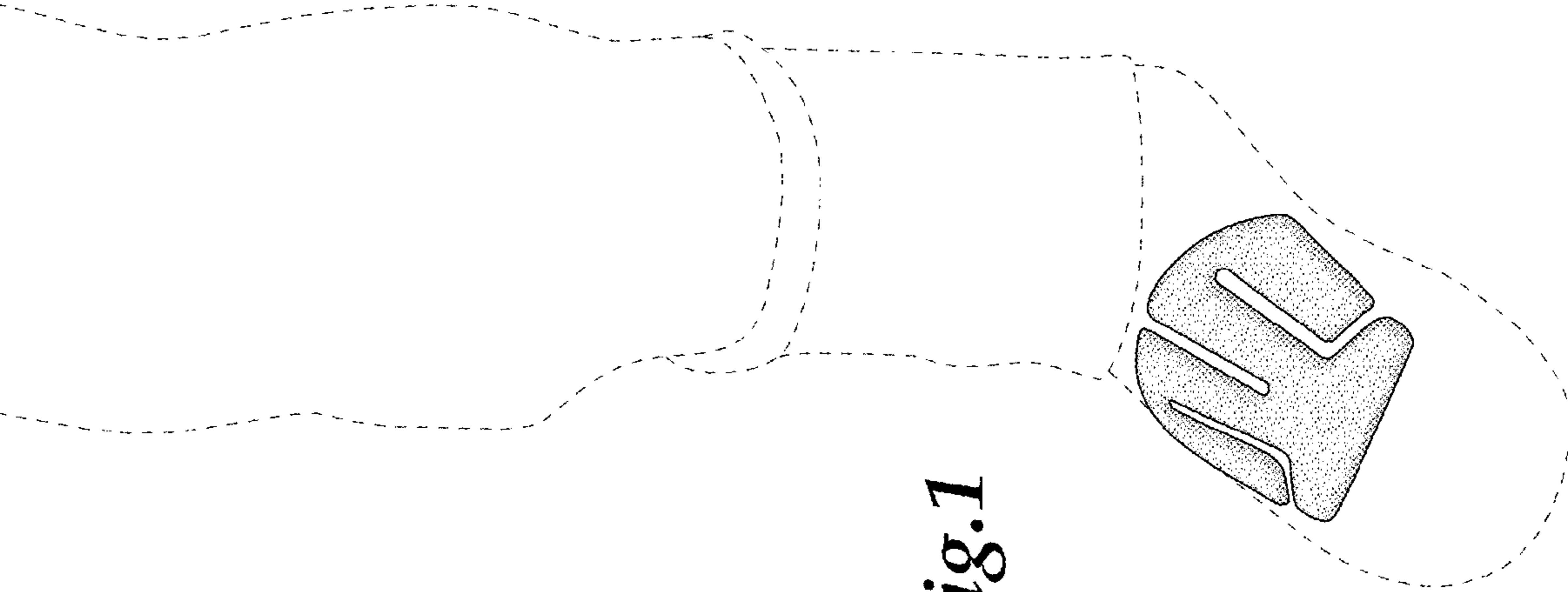

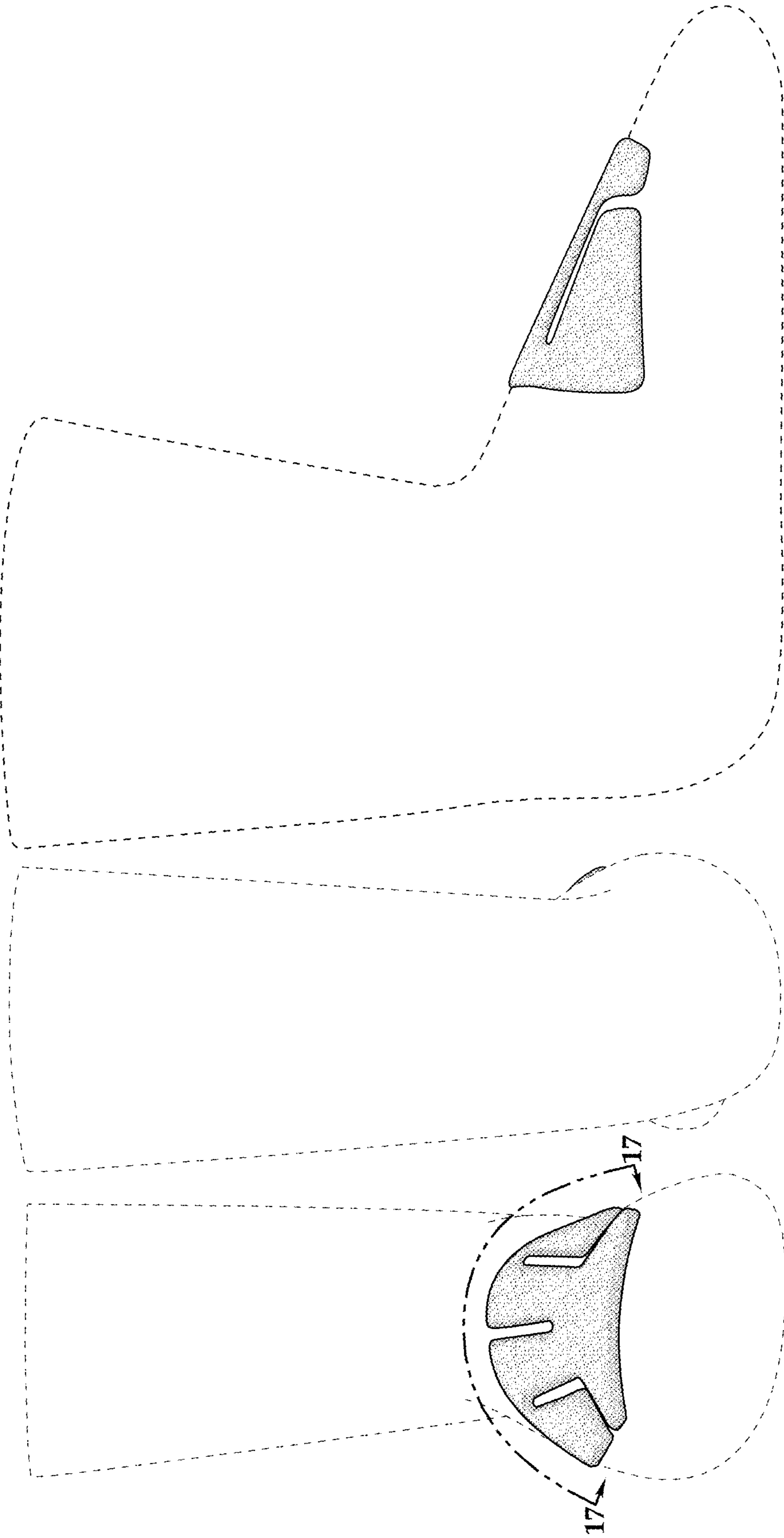

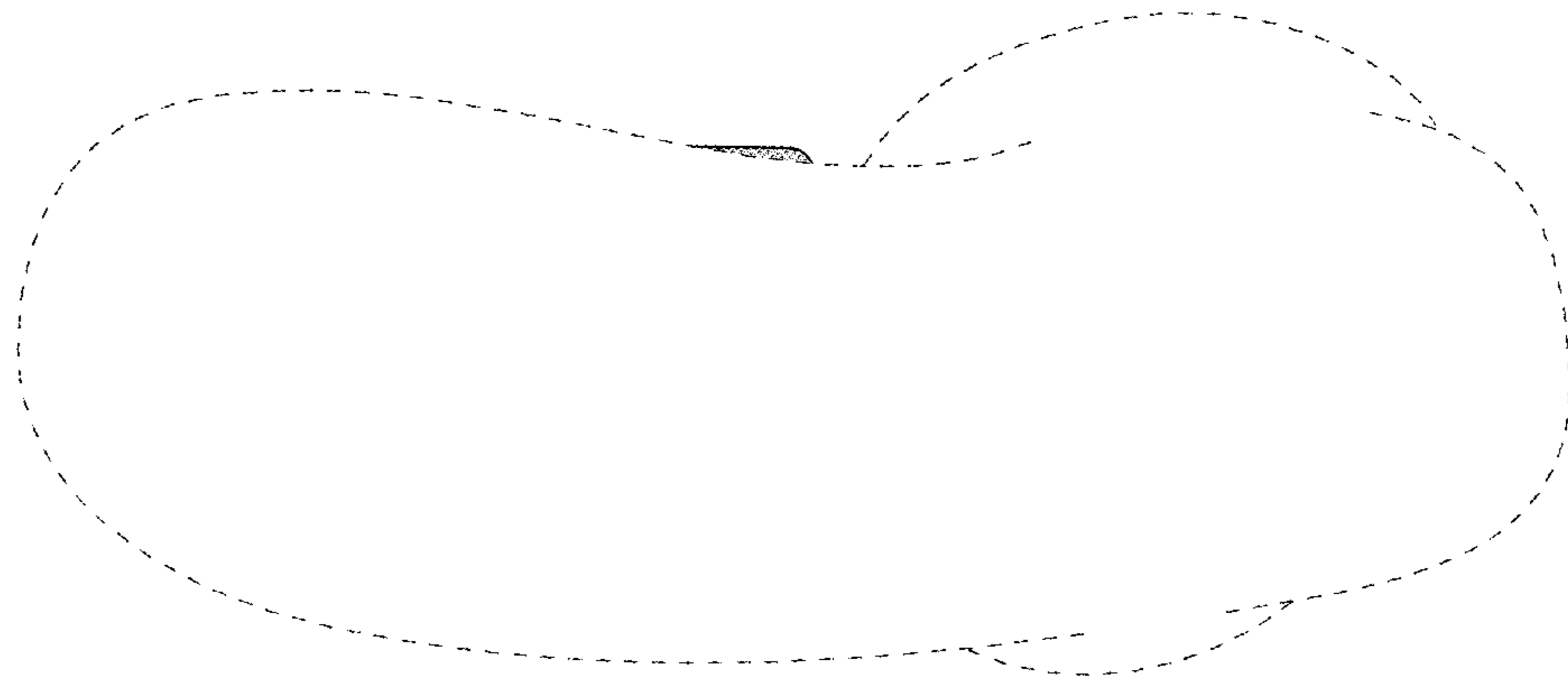

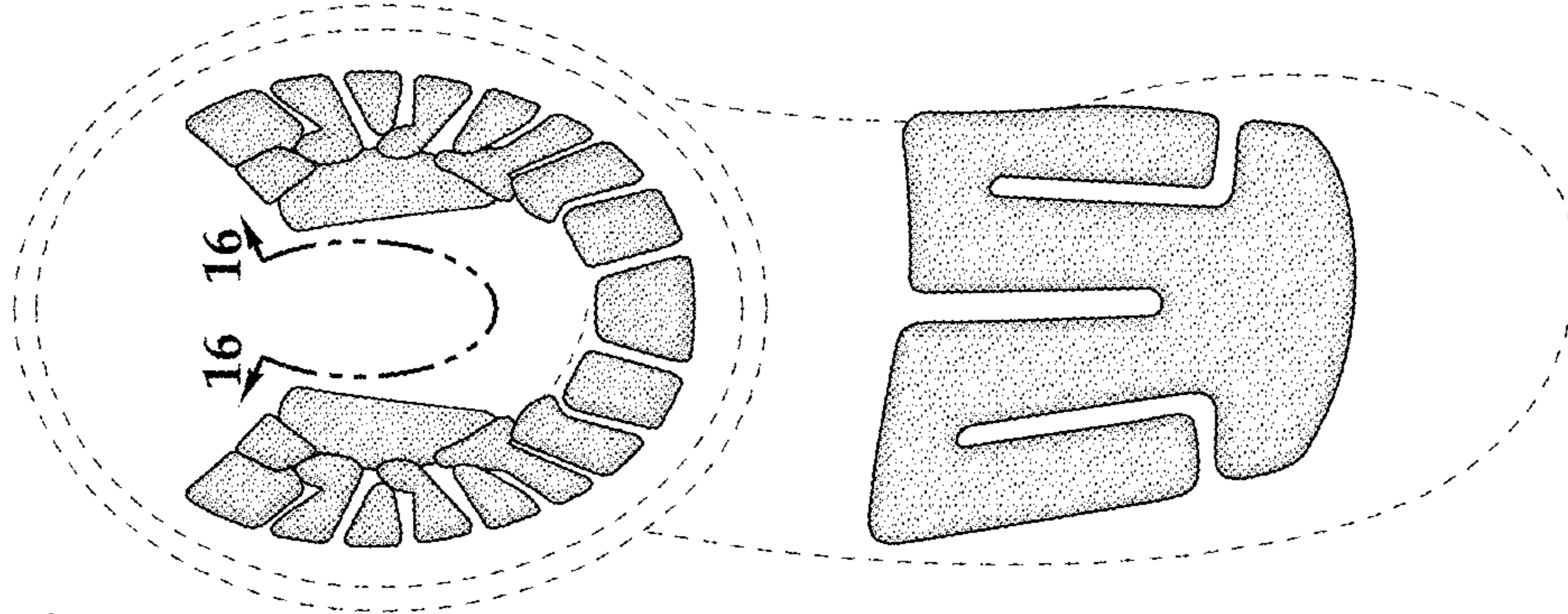

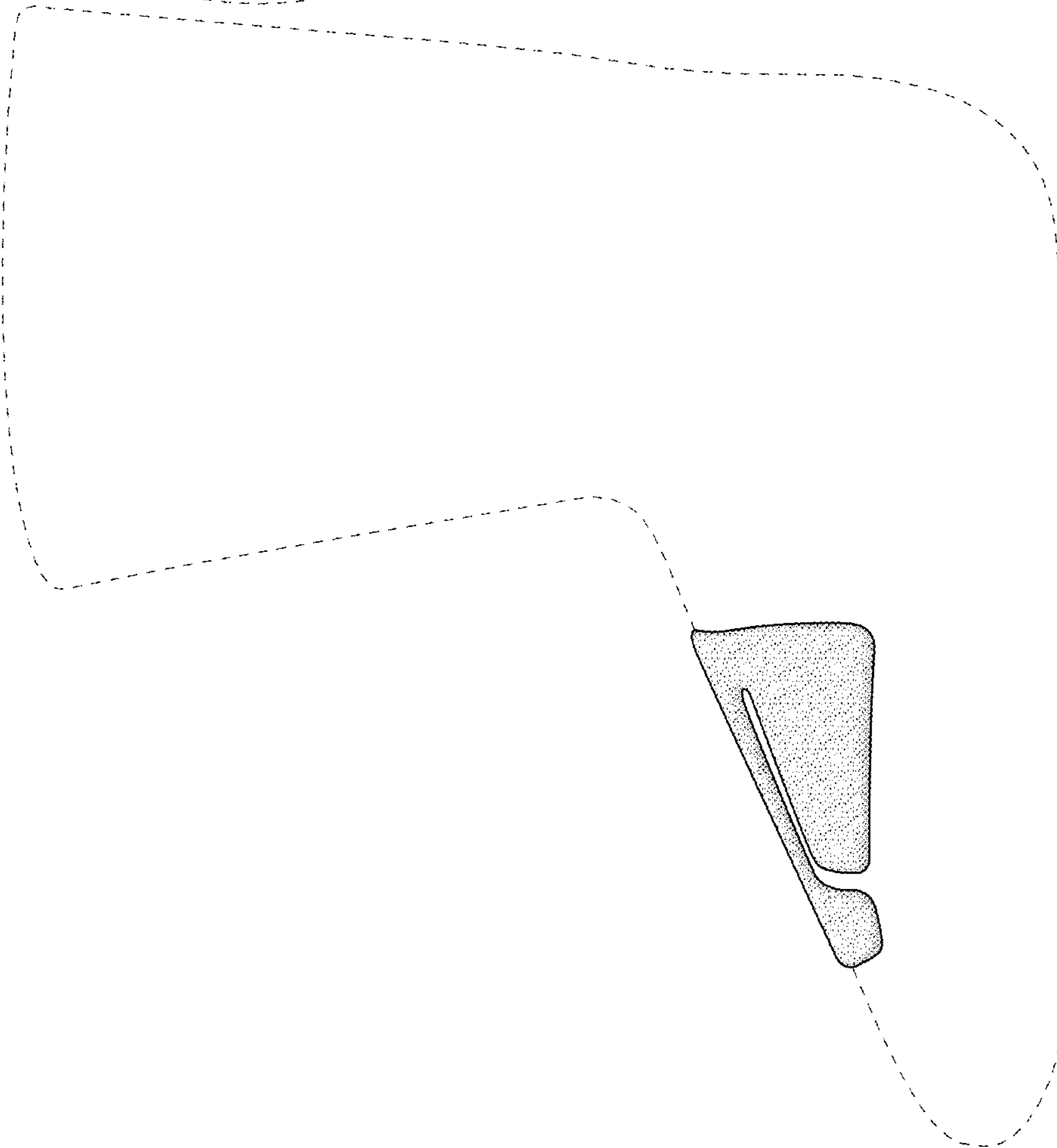
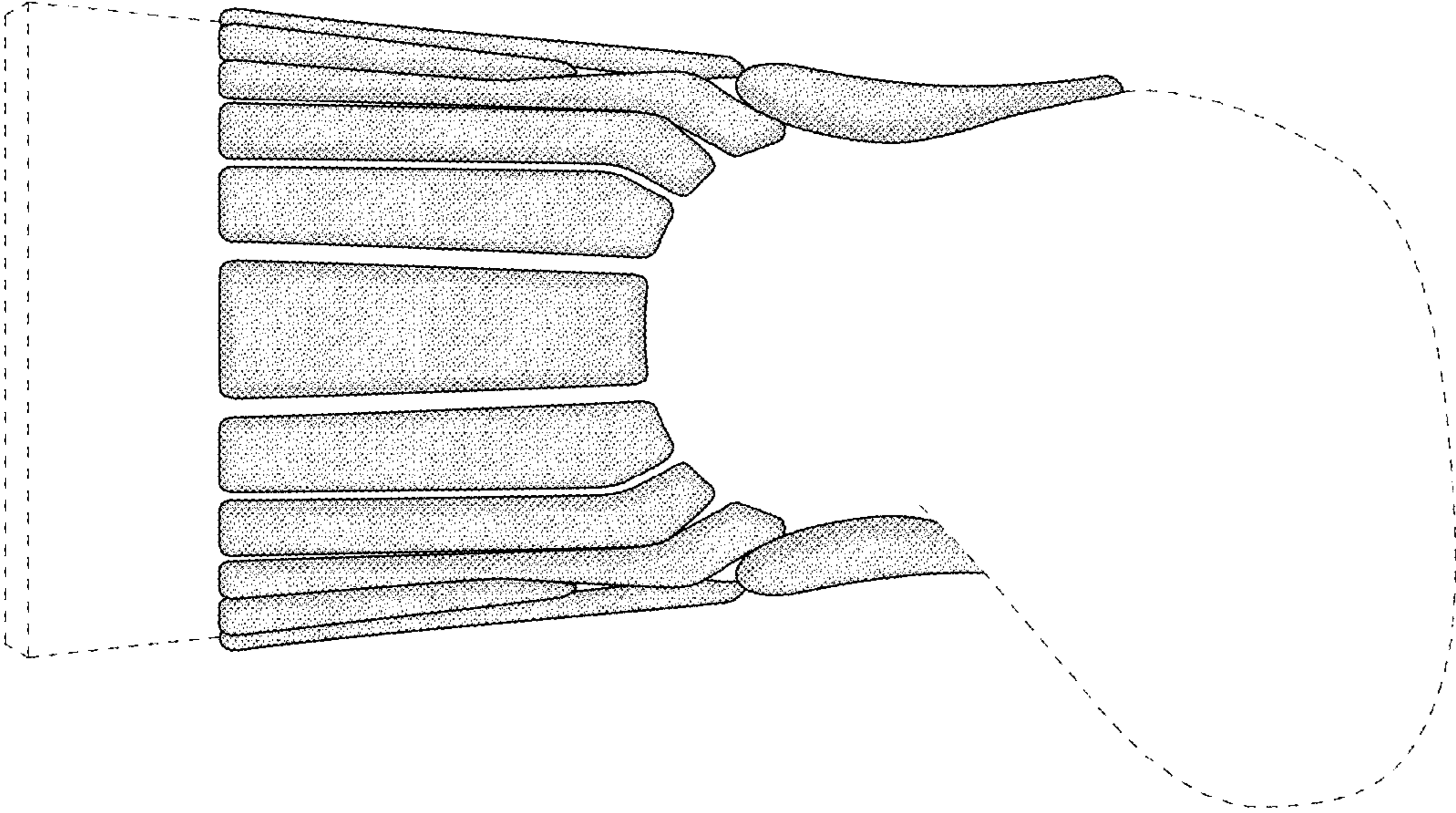
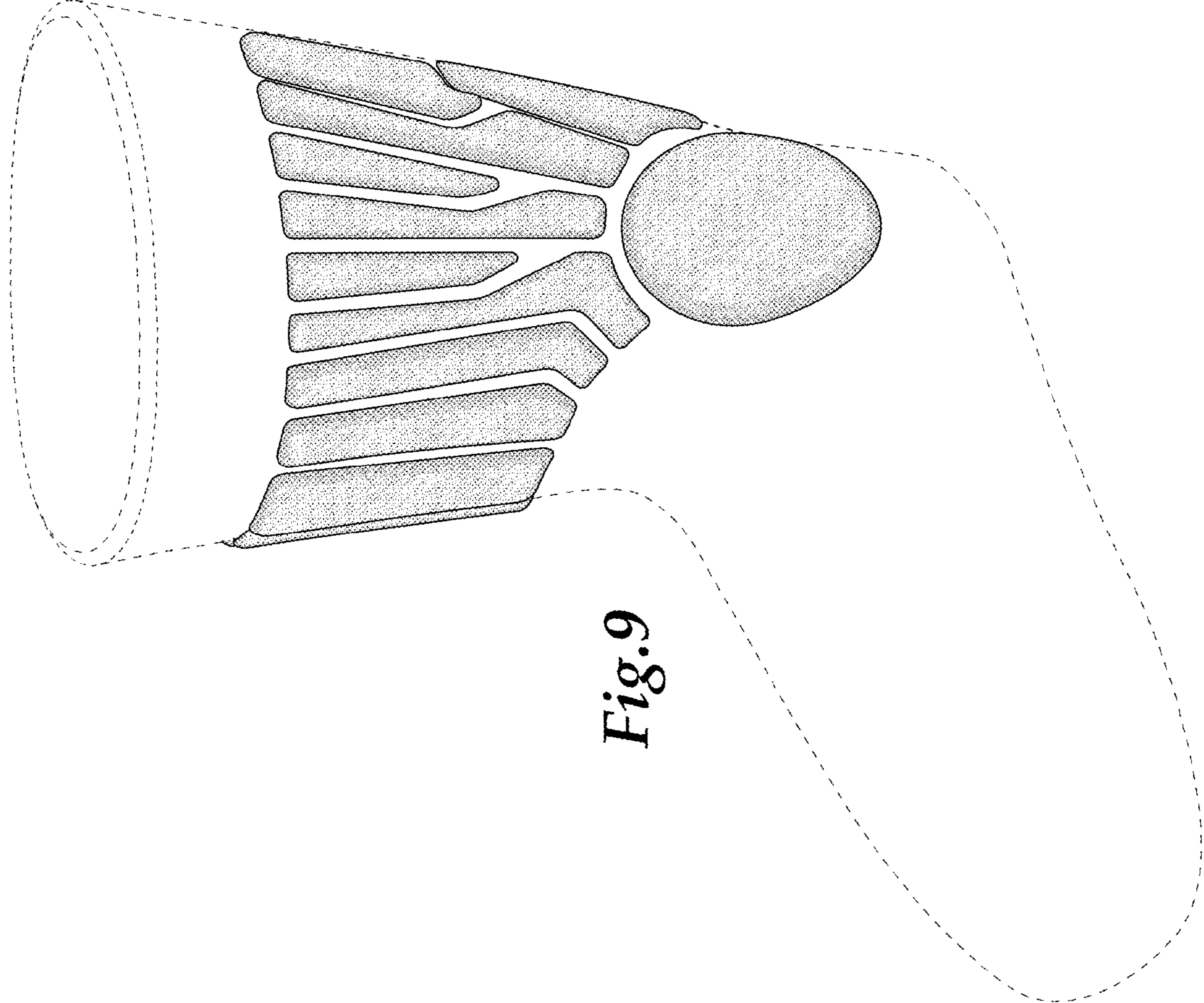


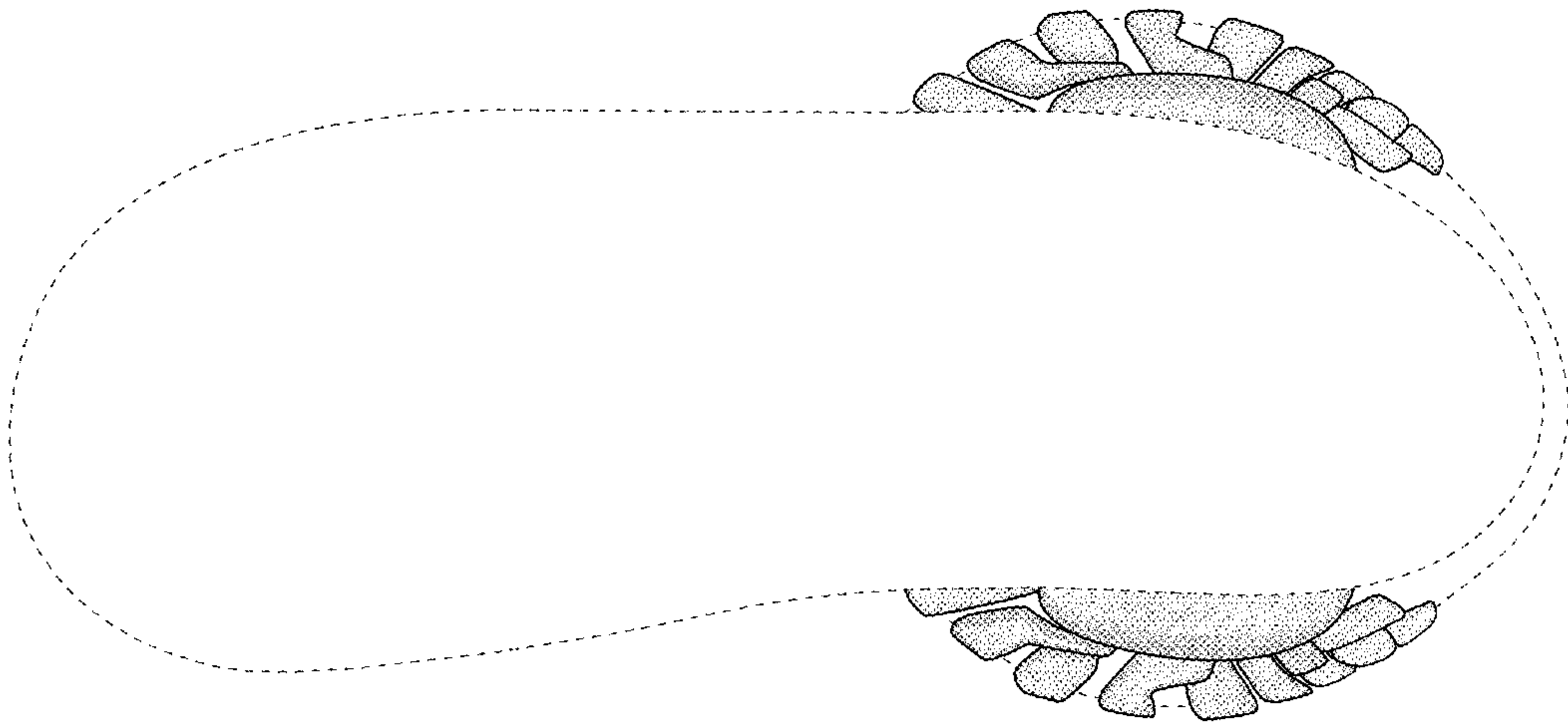

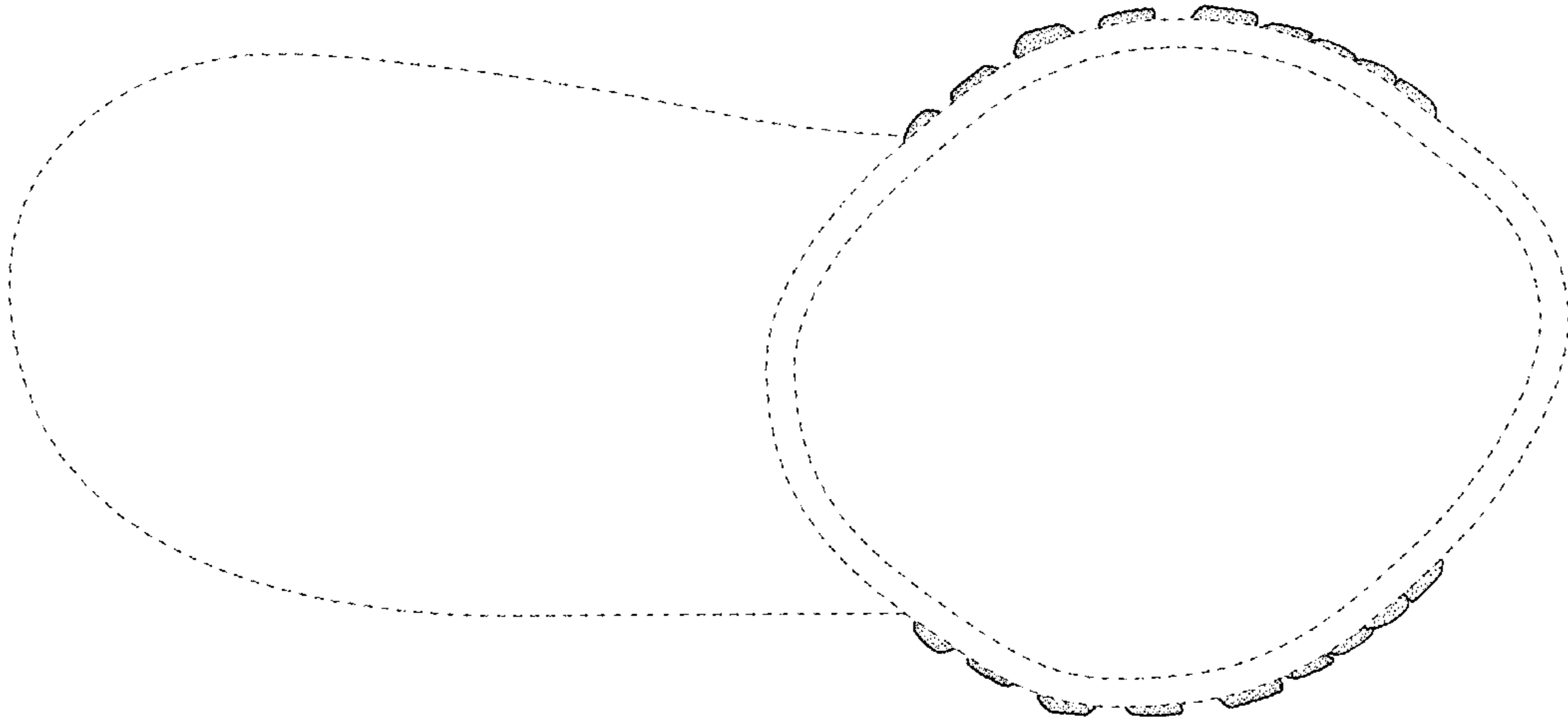

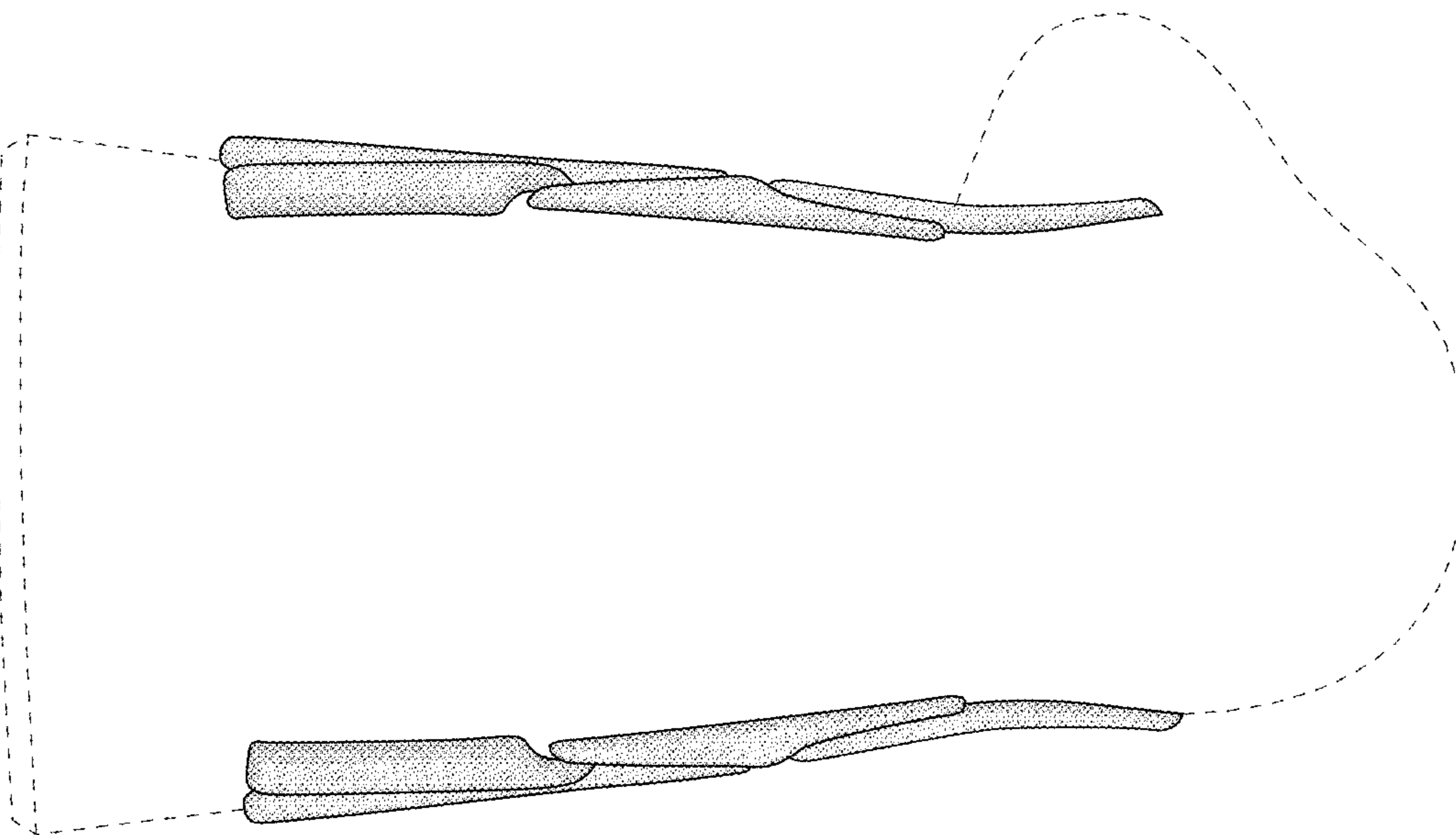

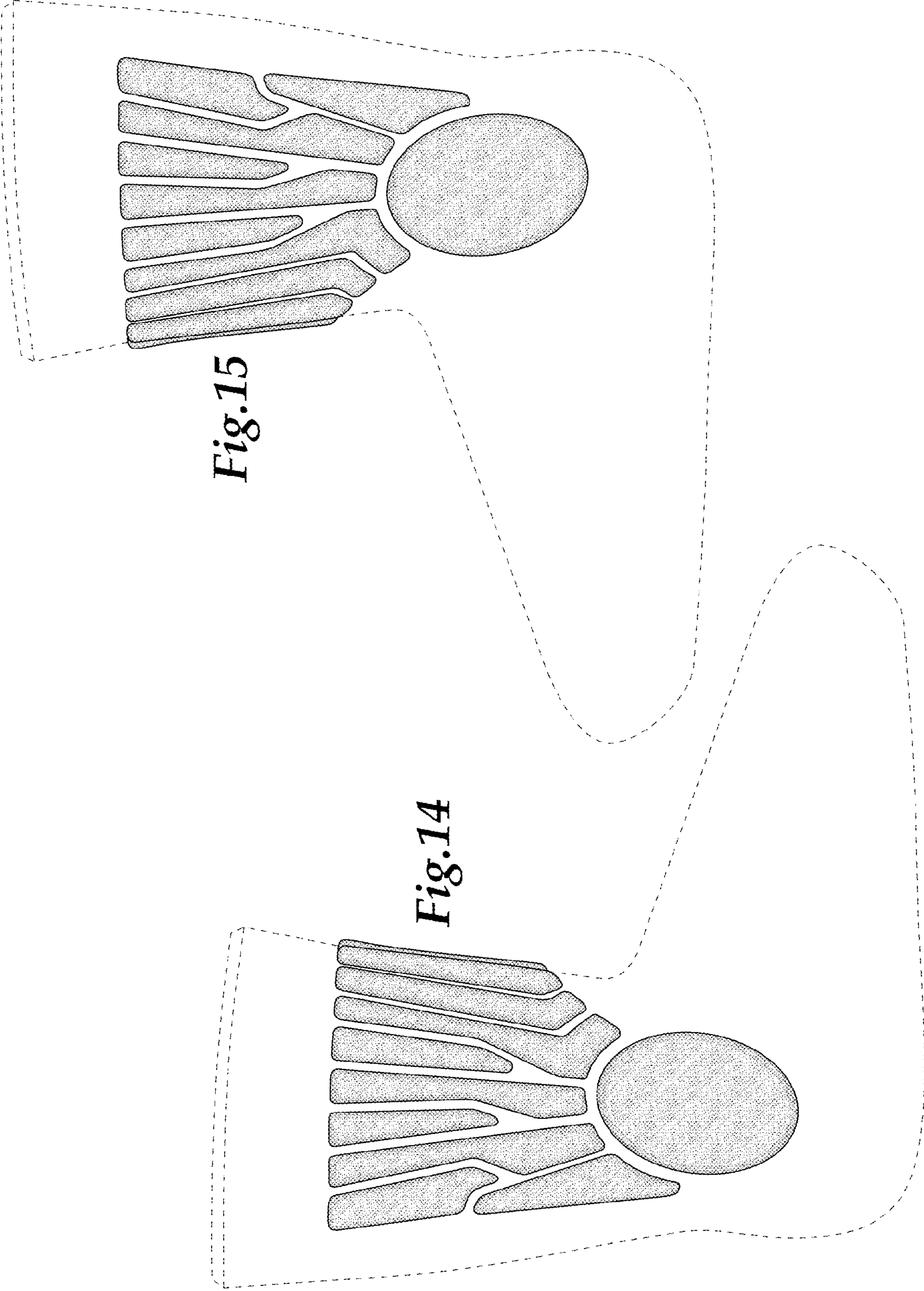

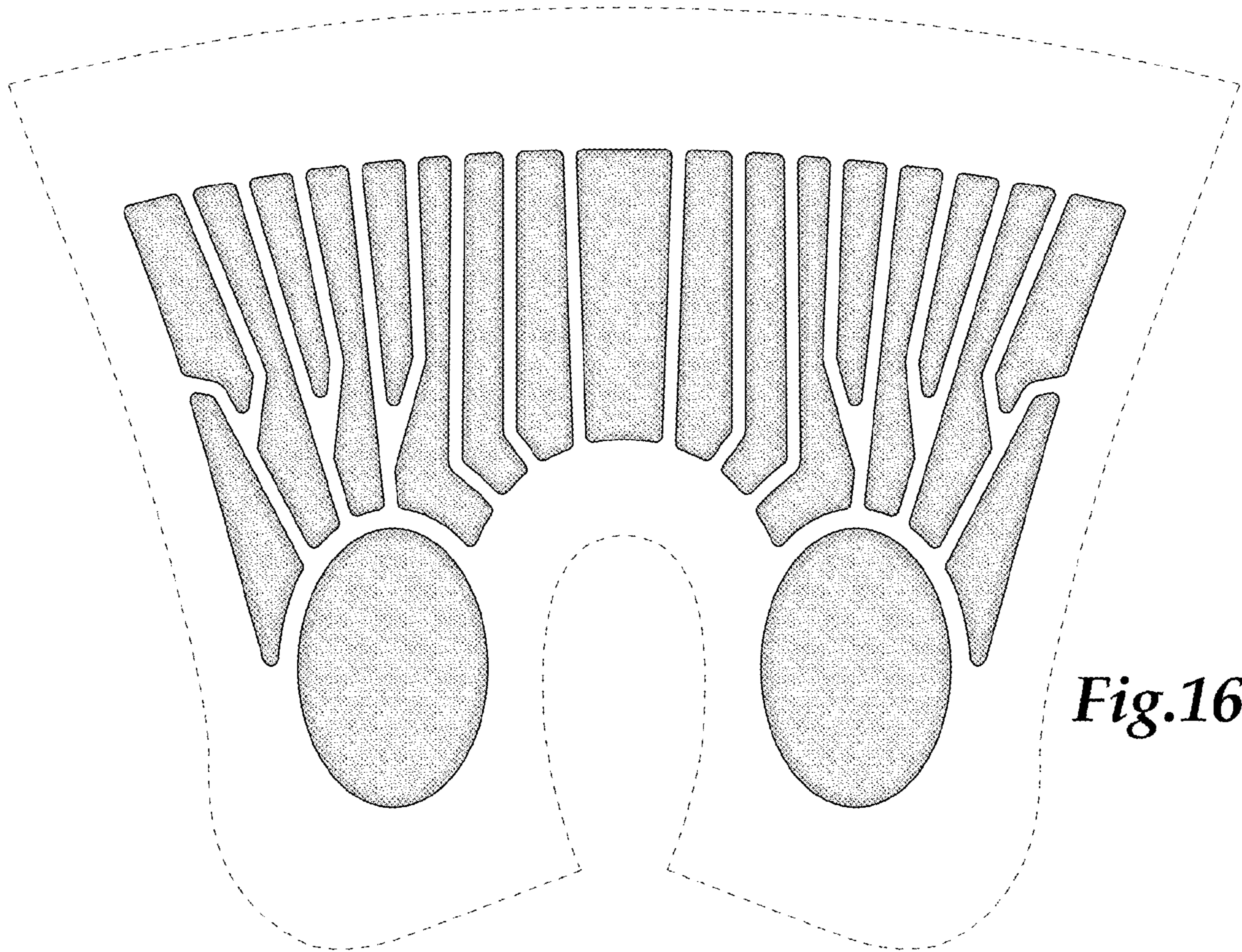

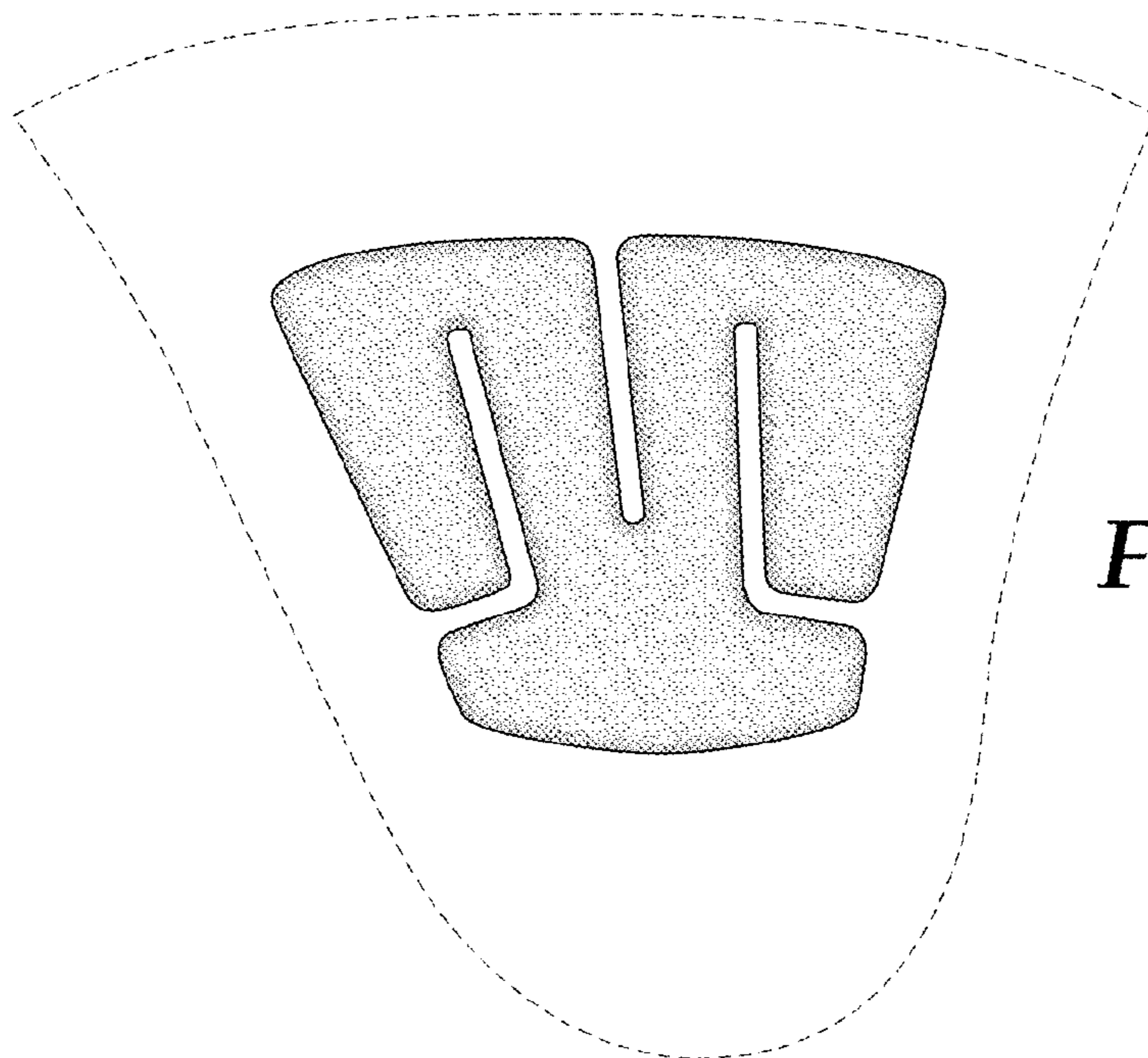
