The ornamental design for an airbed, as shown and described.

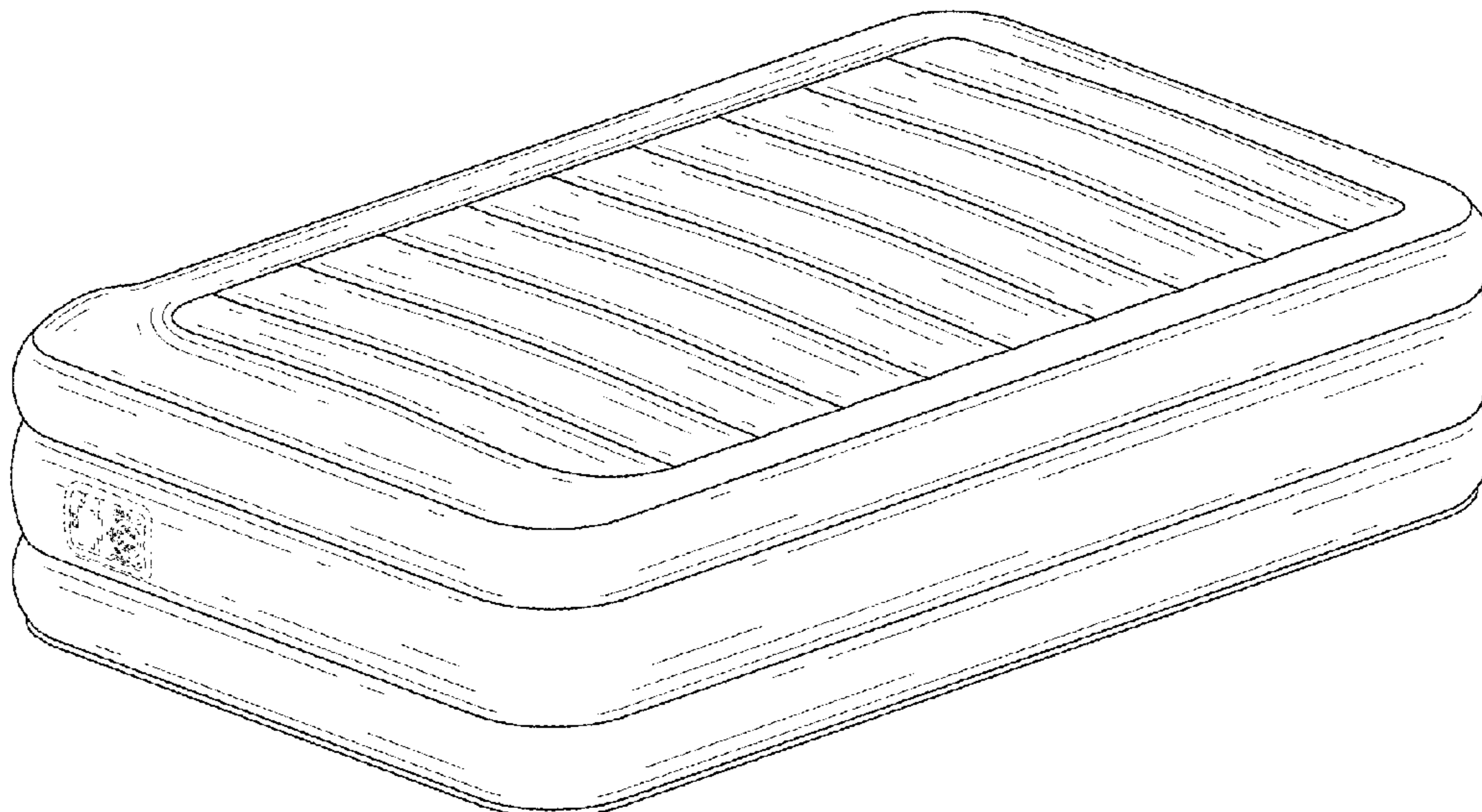
DESCRIPTION

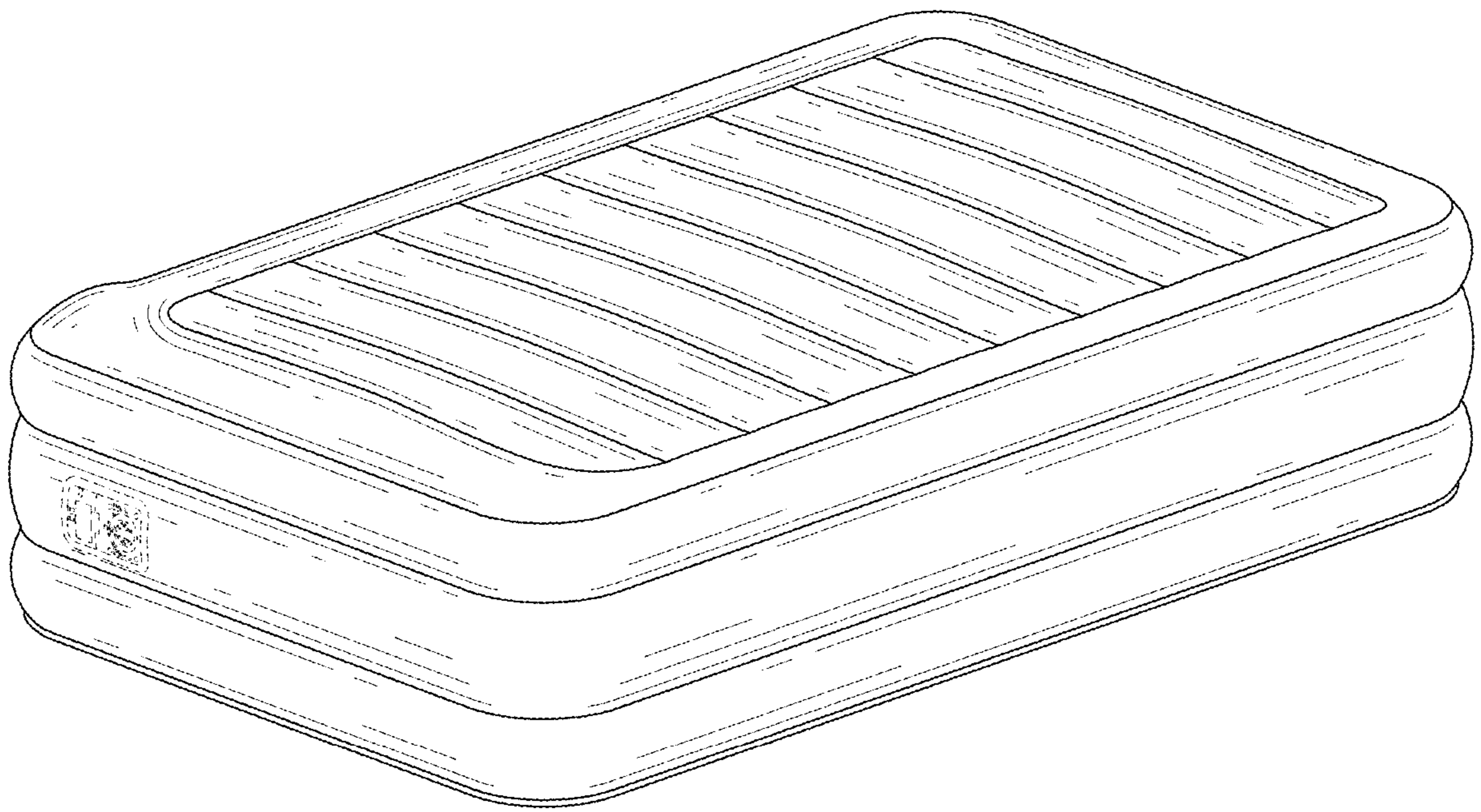

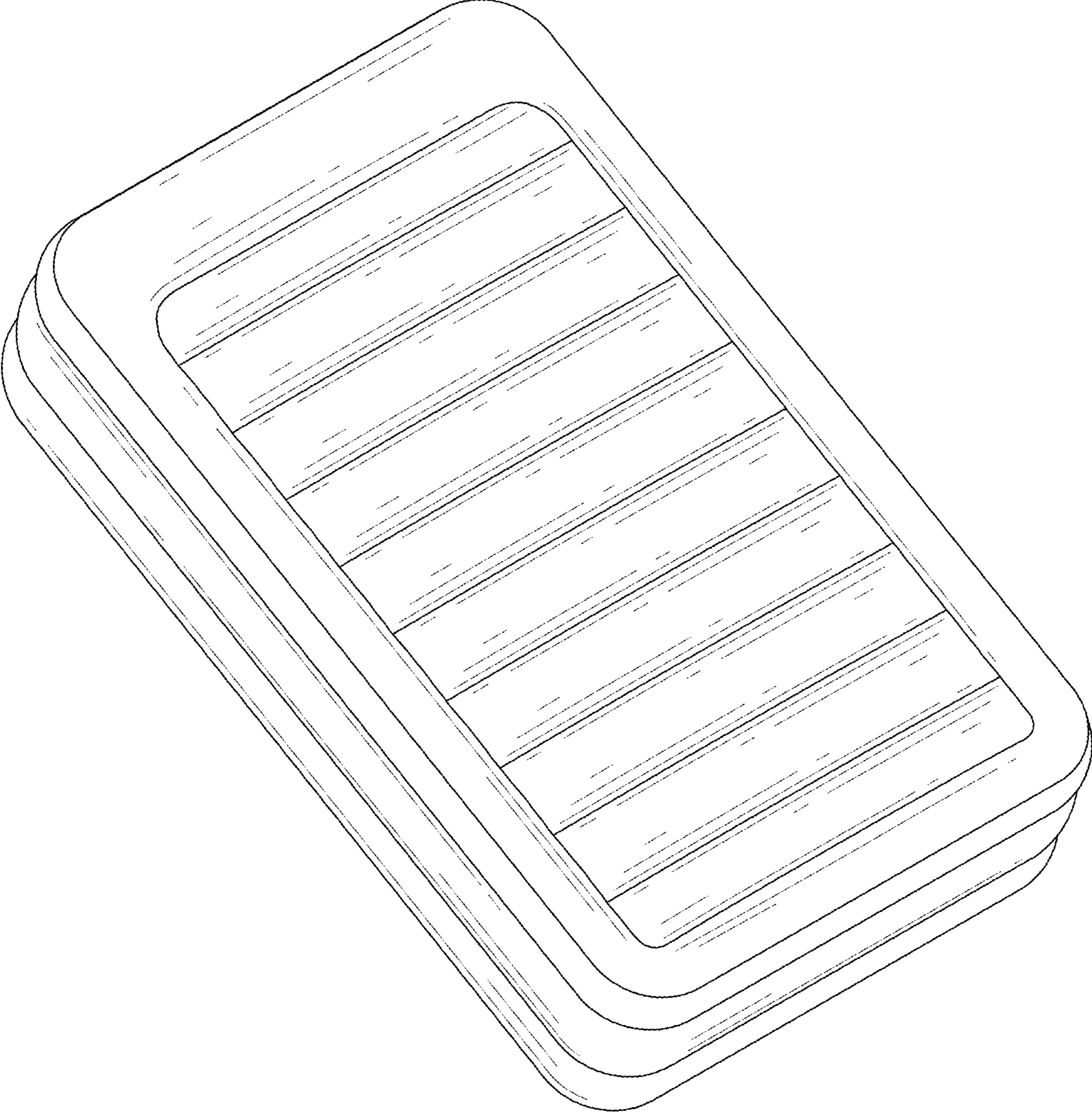

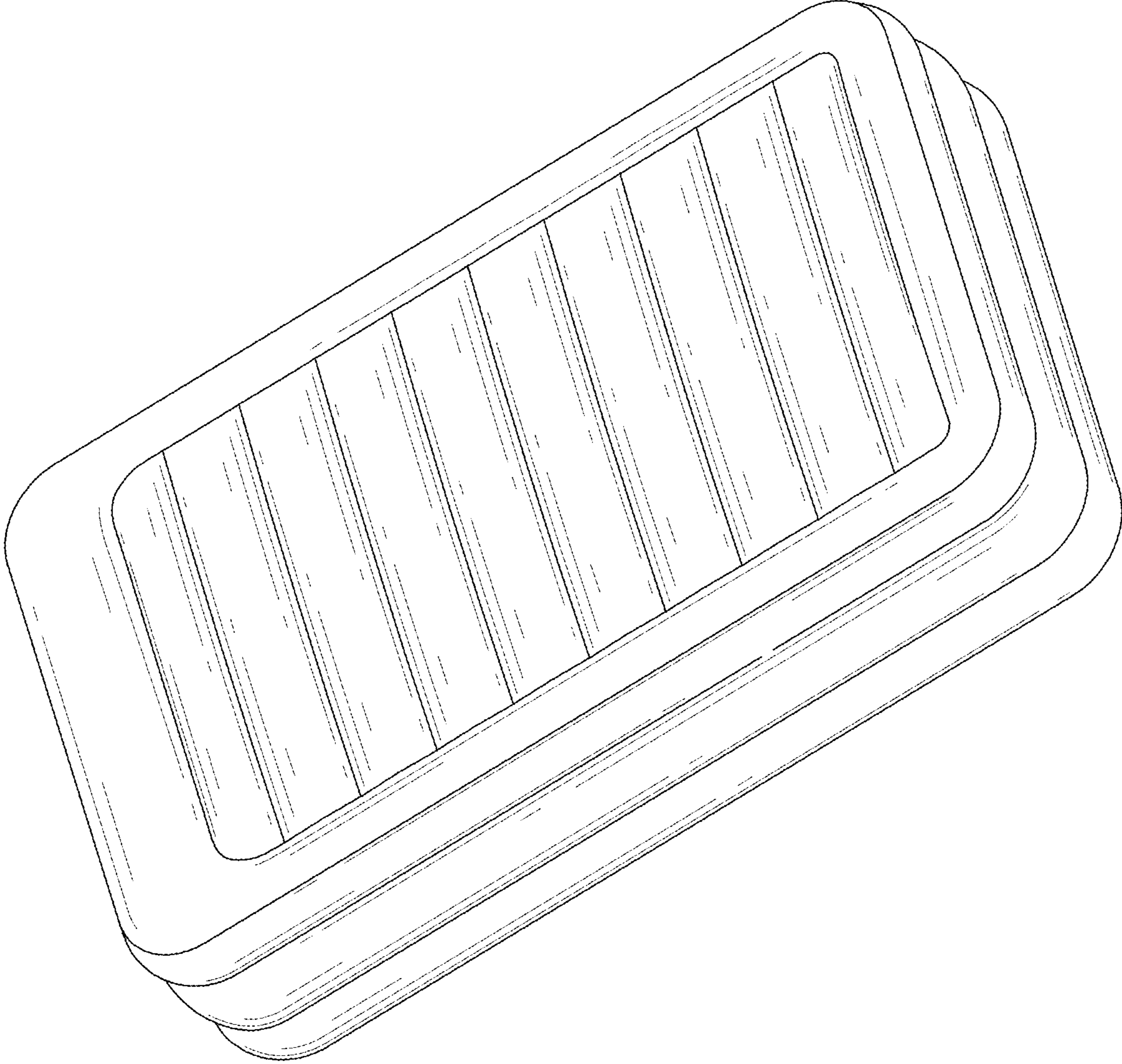

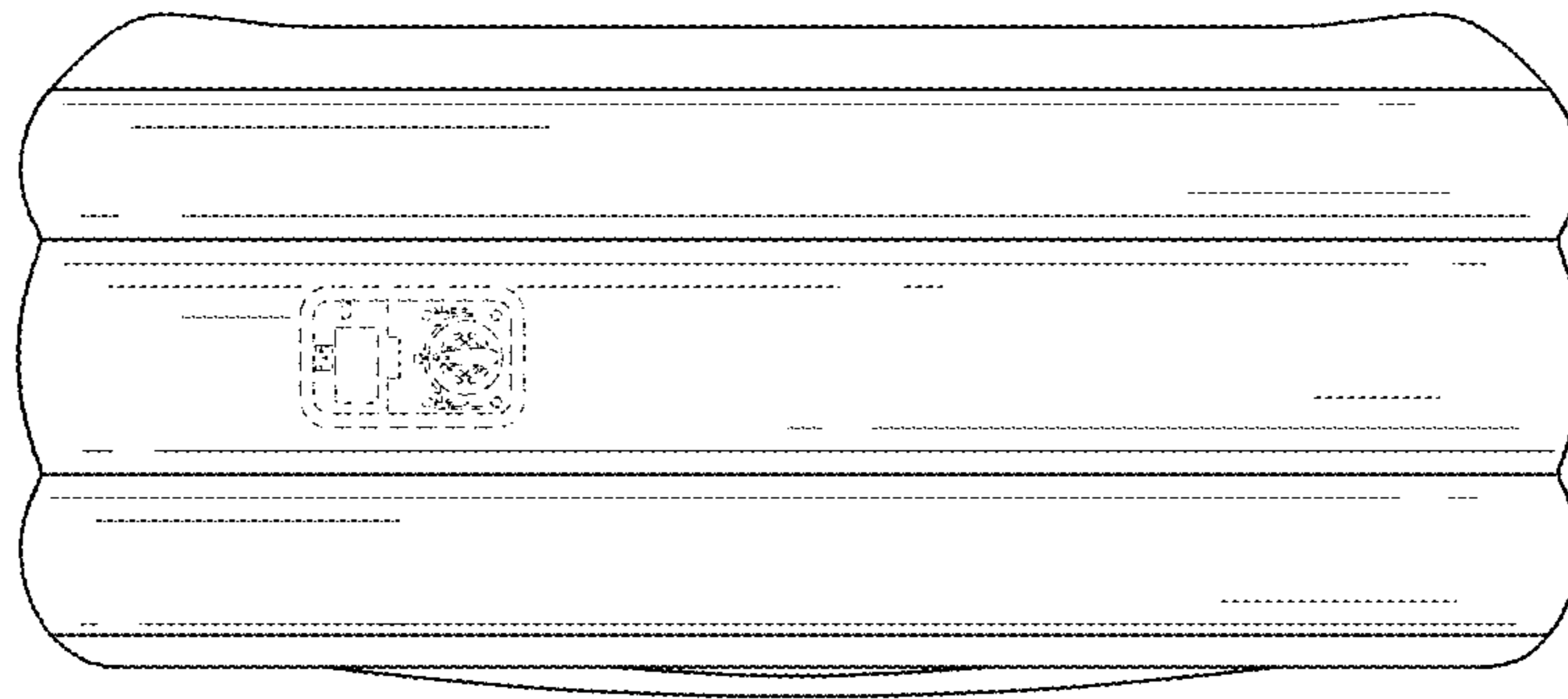

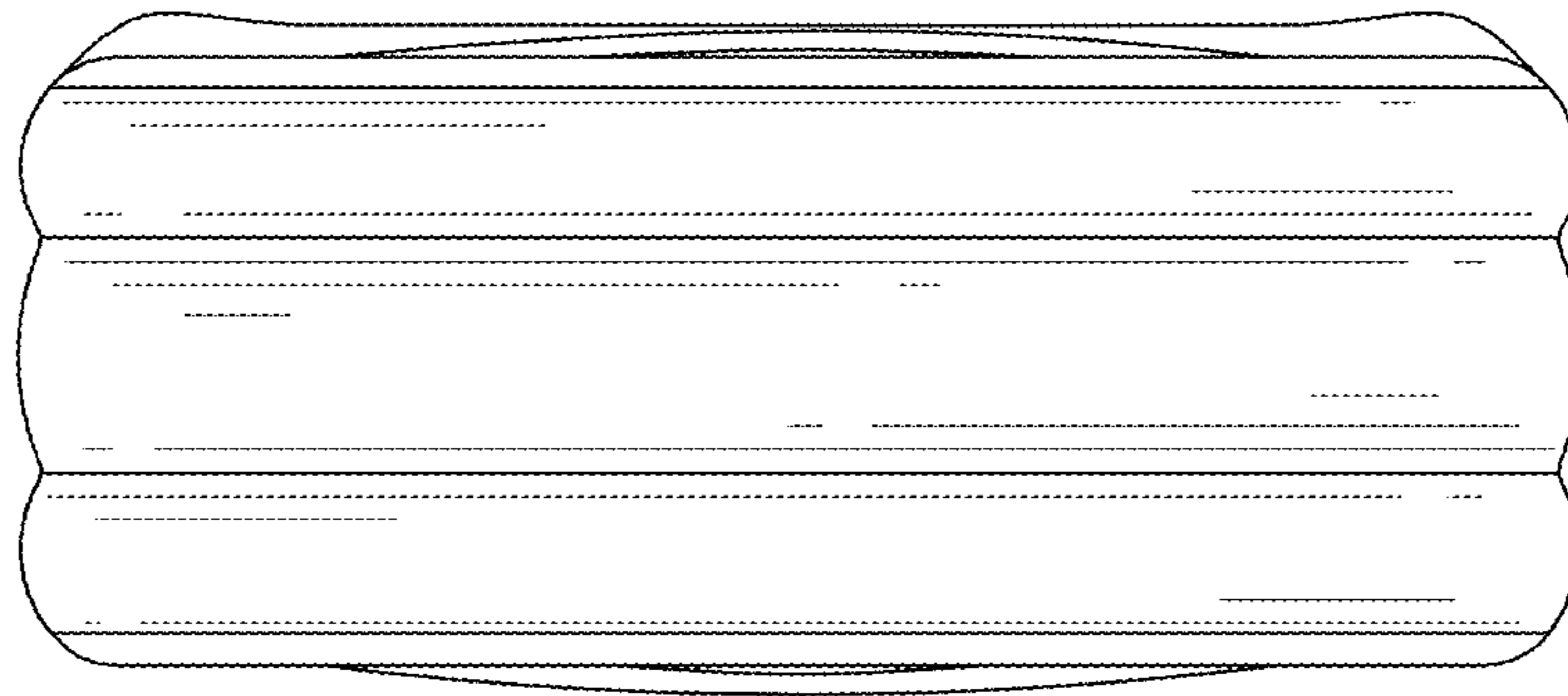

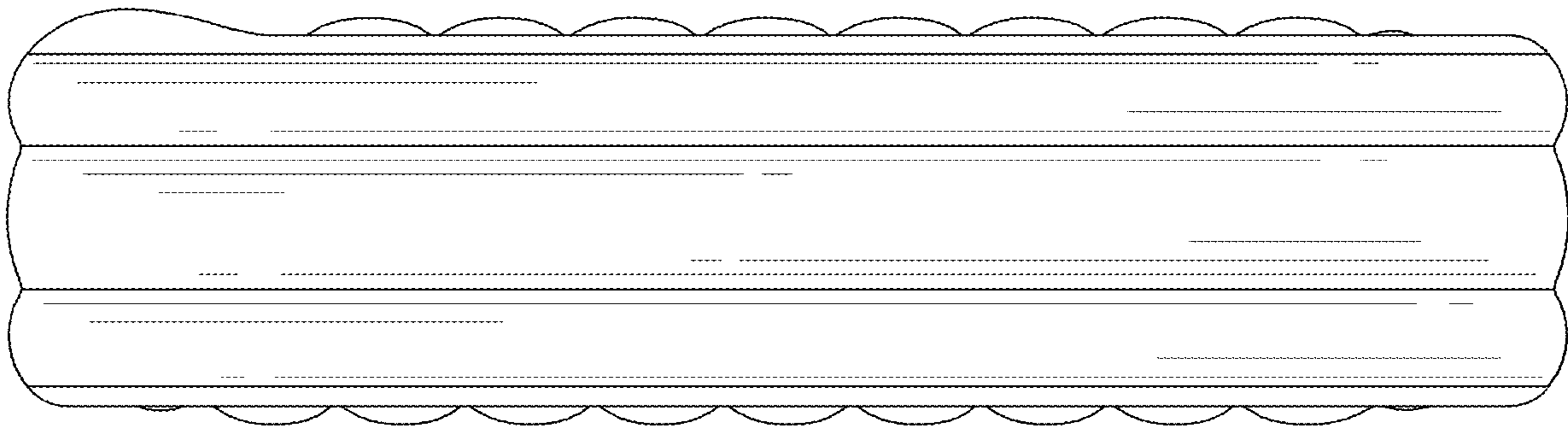

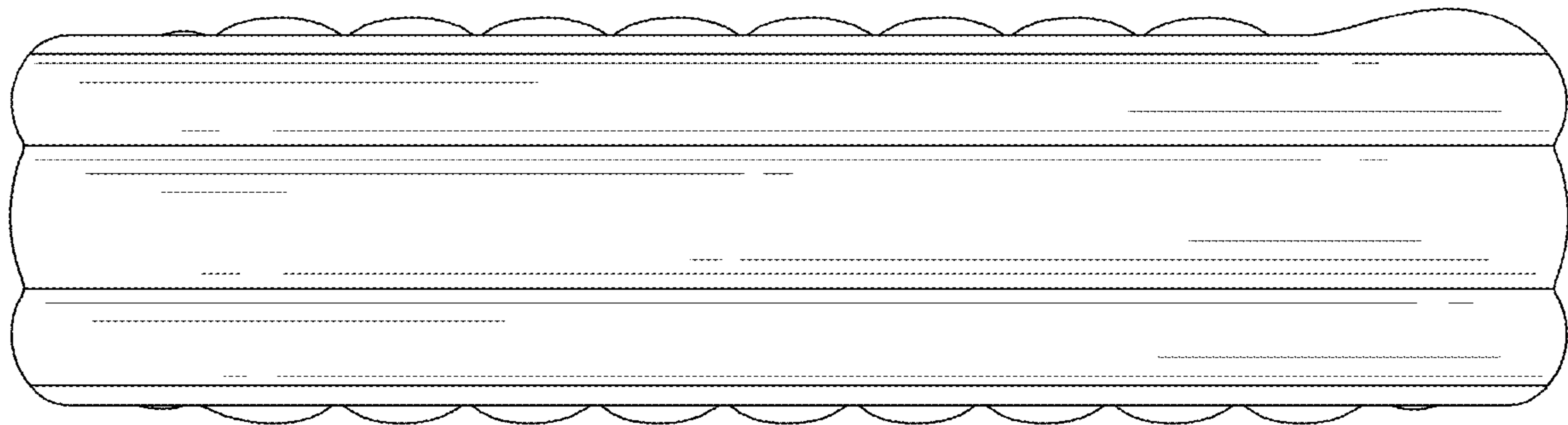

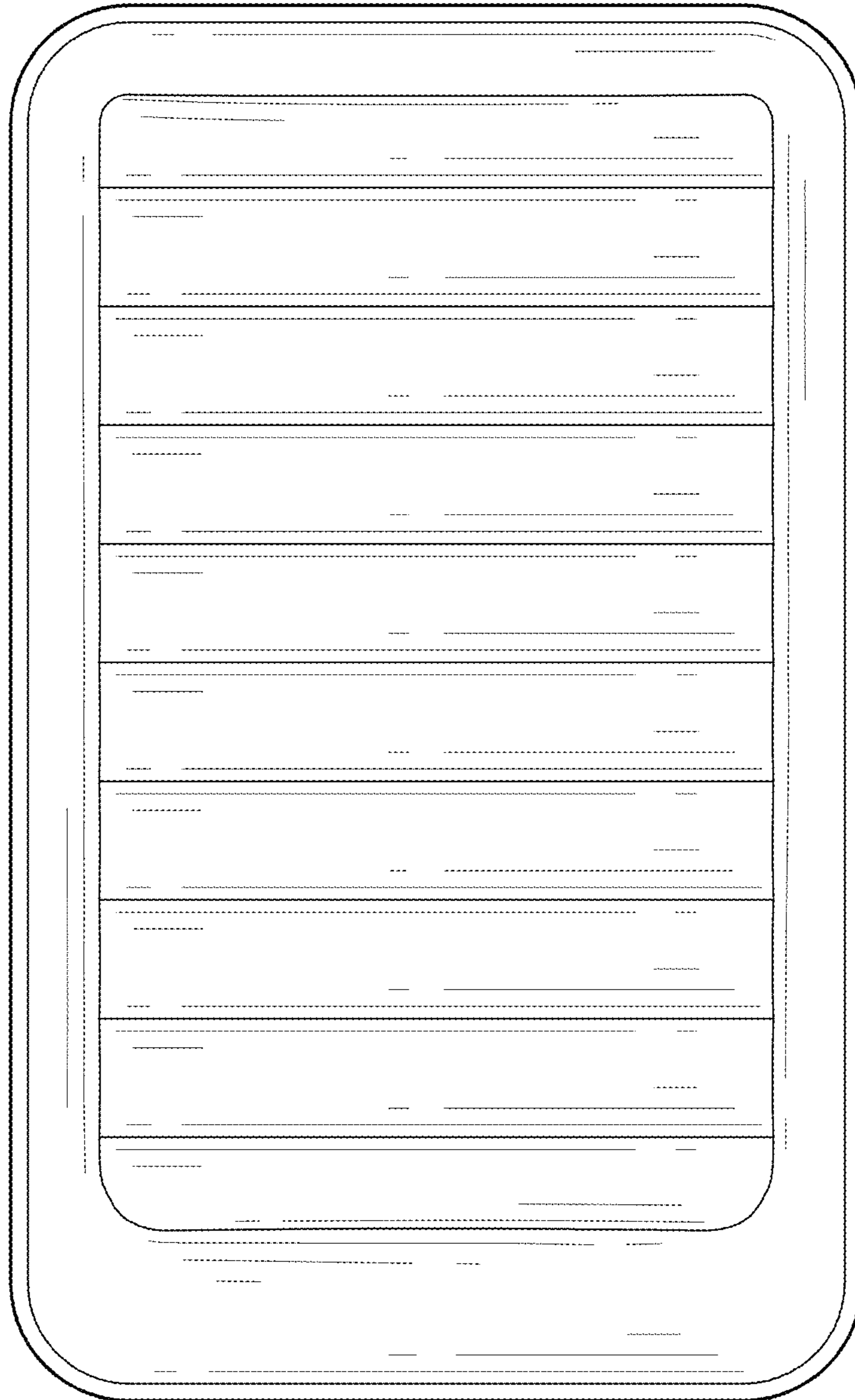

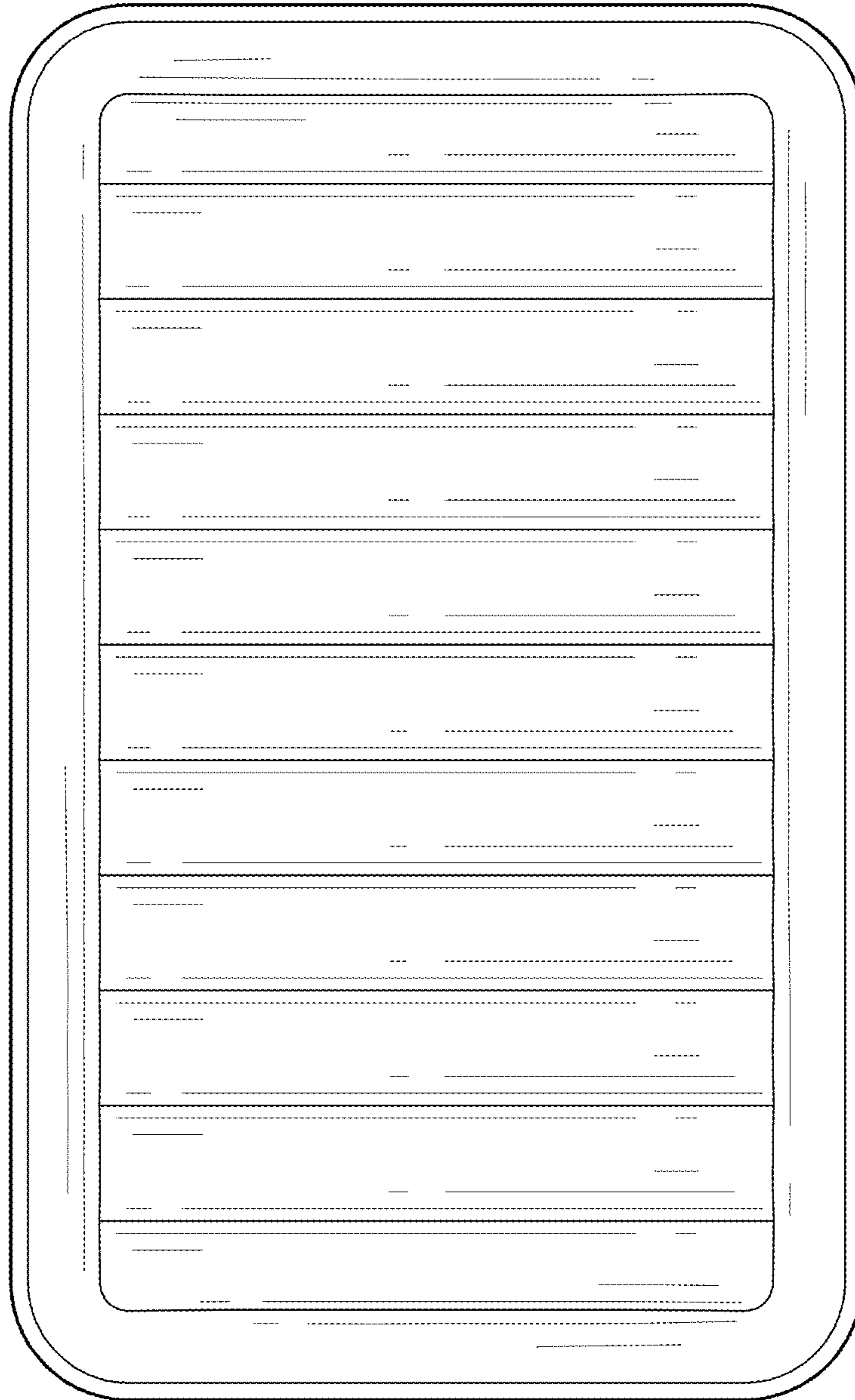
