(57) **CLAIM**

The ornamental design for a license plate support with removable blade, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a license plate support with removable blade showing an embodiment of the design of the invention.

FIG. 2 is a front view thereof.

FIG. 3 is a back view thereof.

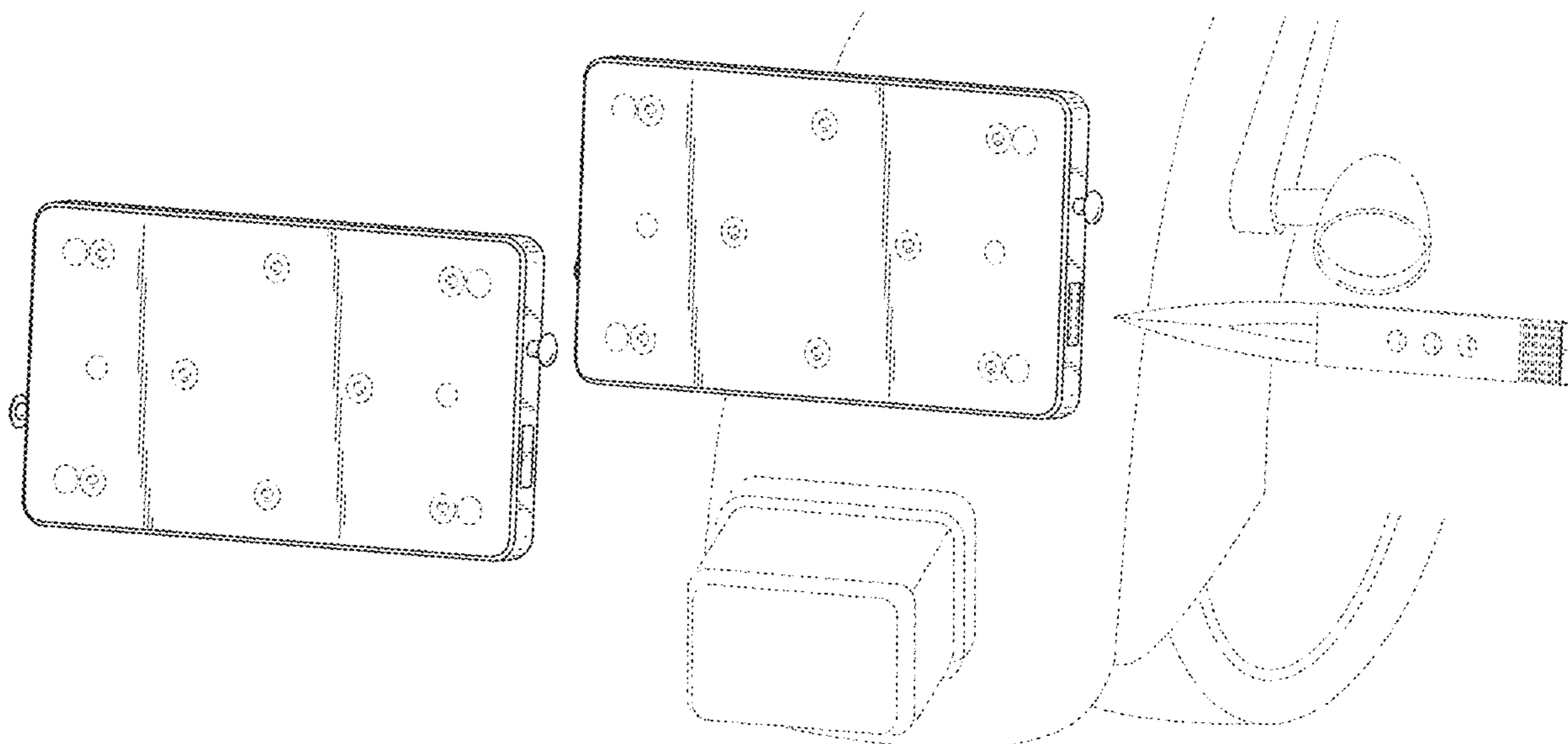
FIG. 4 is an end view thereof.

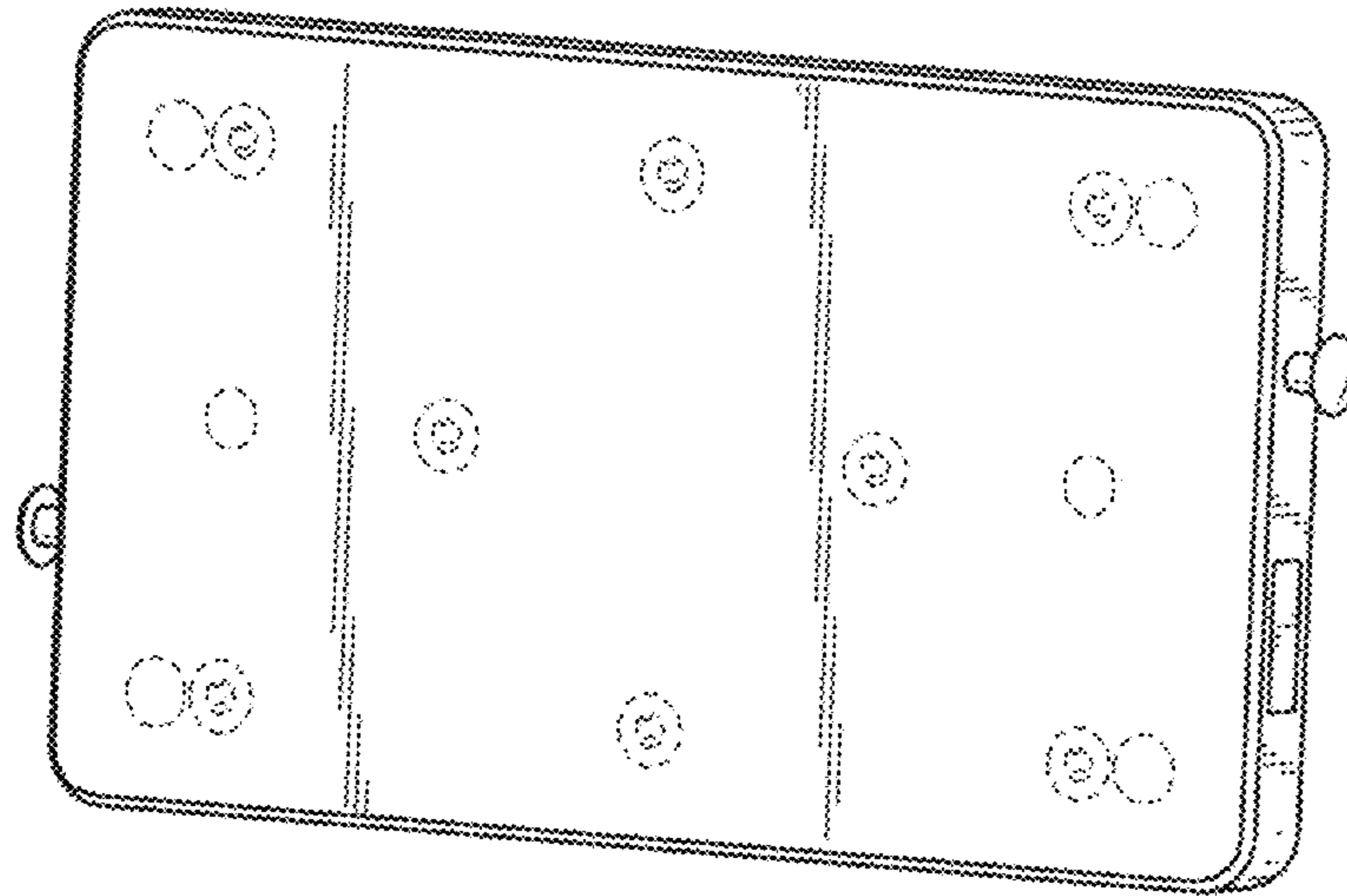

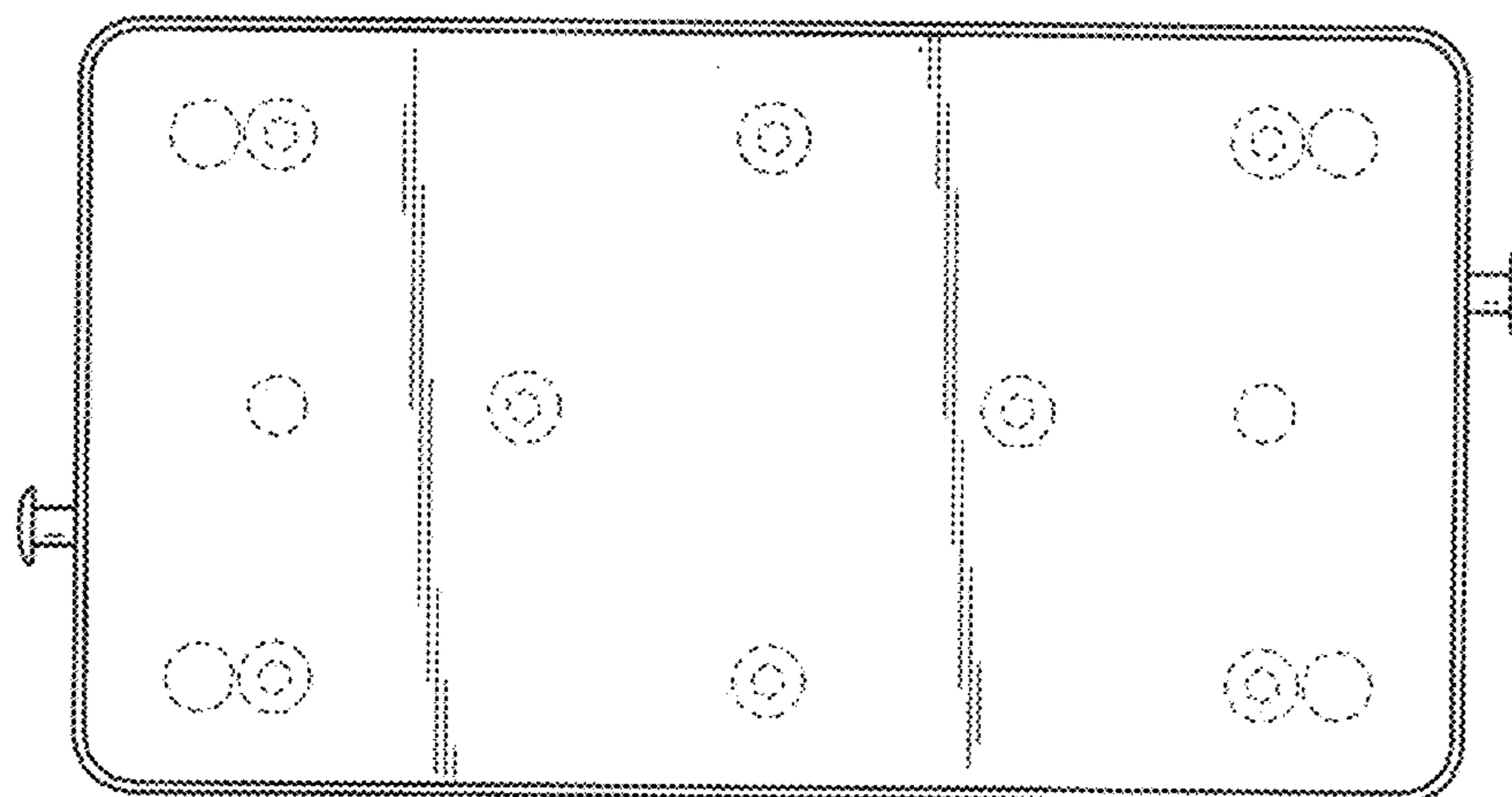

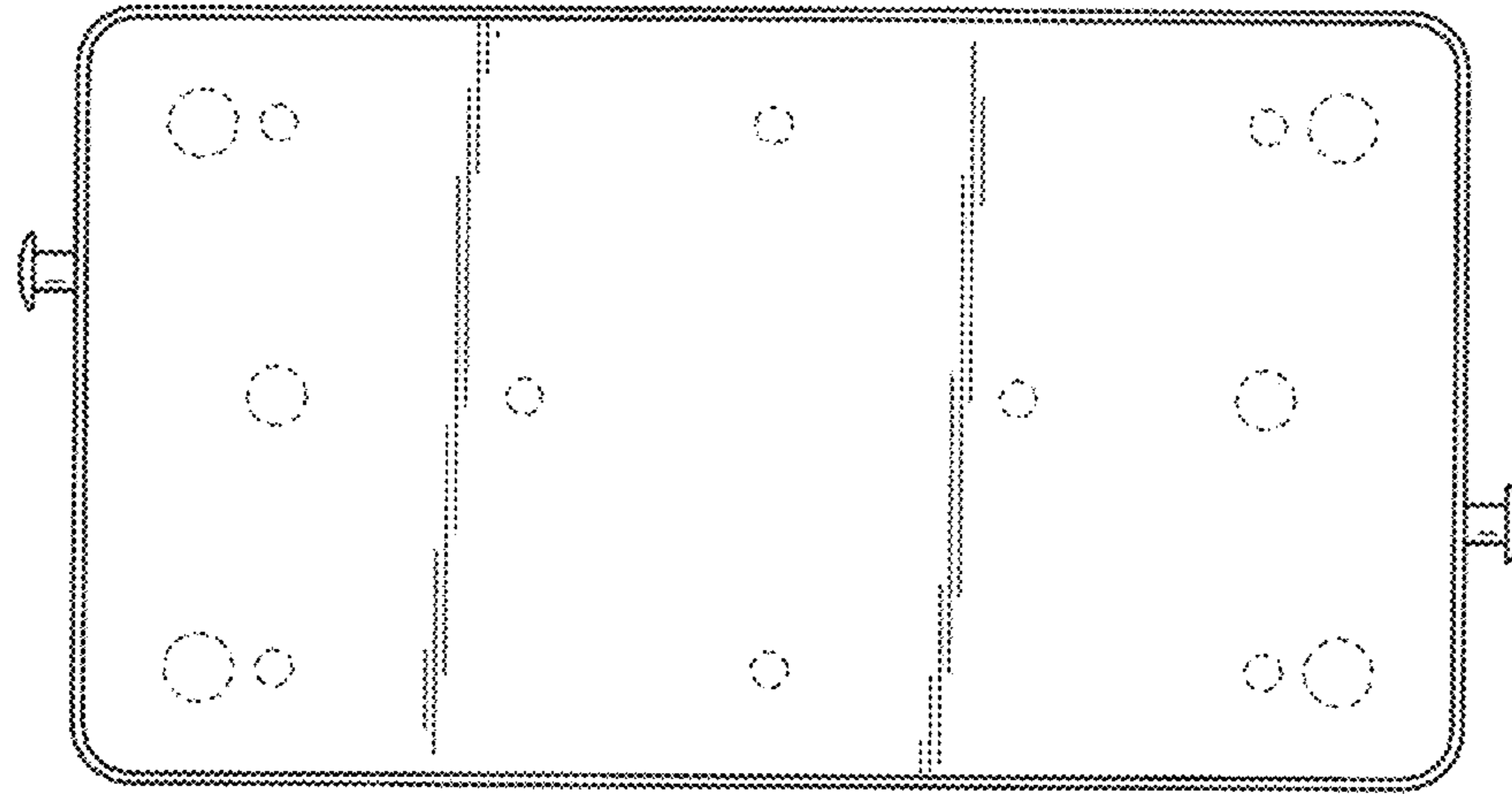

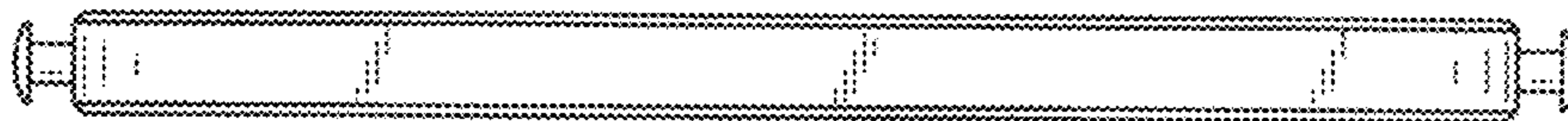
