**DESCRIPTION**

FIG. 7 is a left side view thereof;

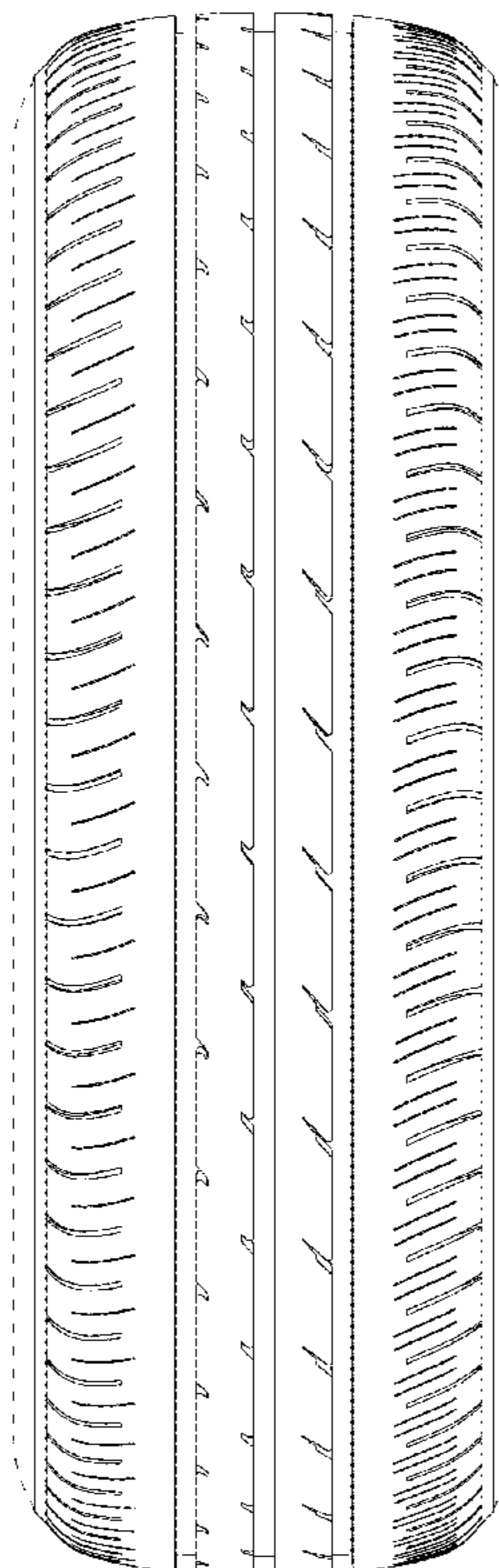
FIG. 8 is an enlarged view taken along line 8-8 in FIG. 1;

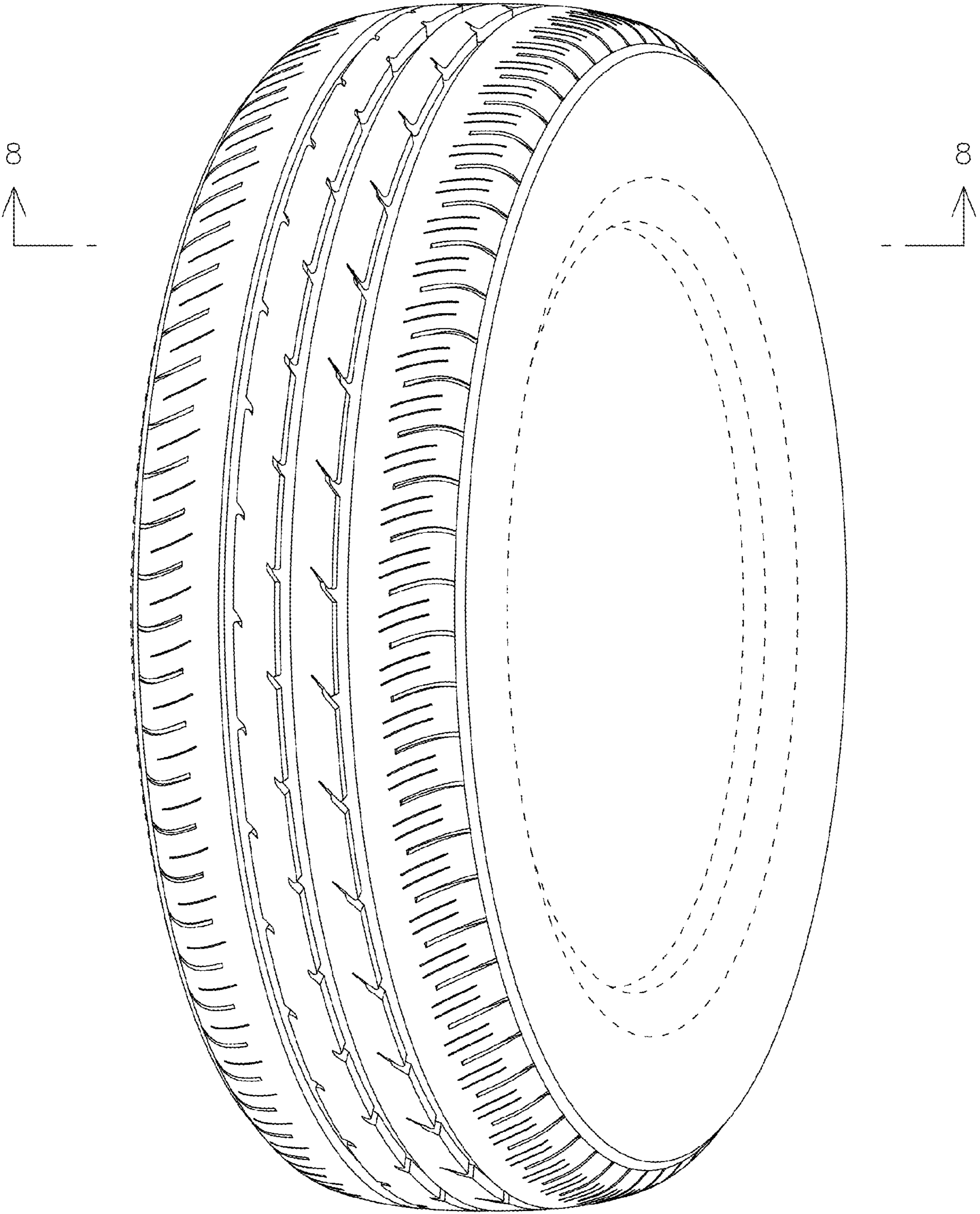

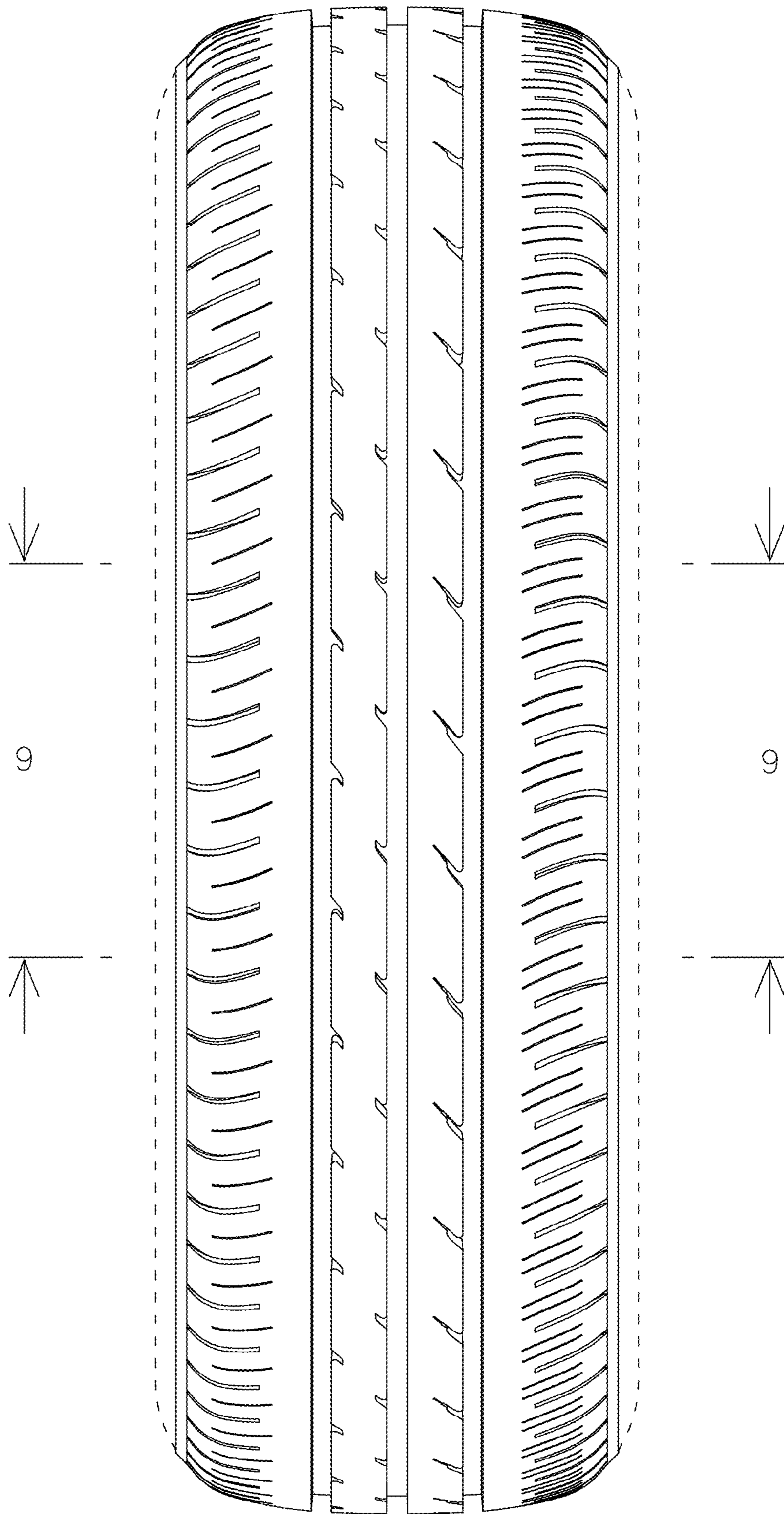

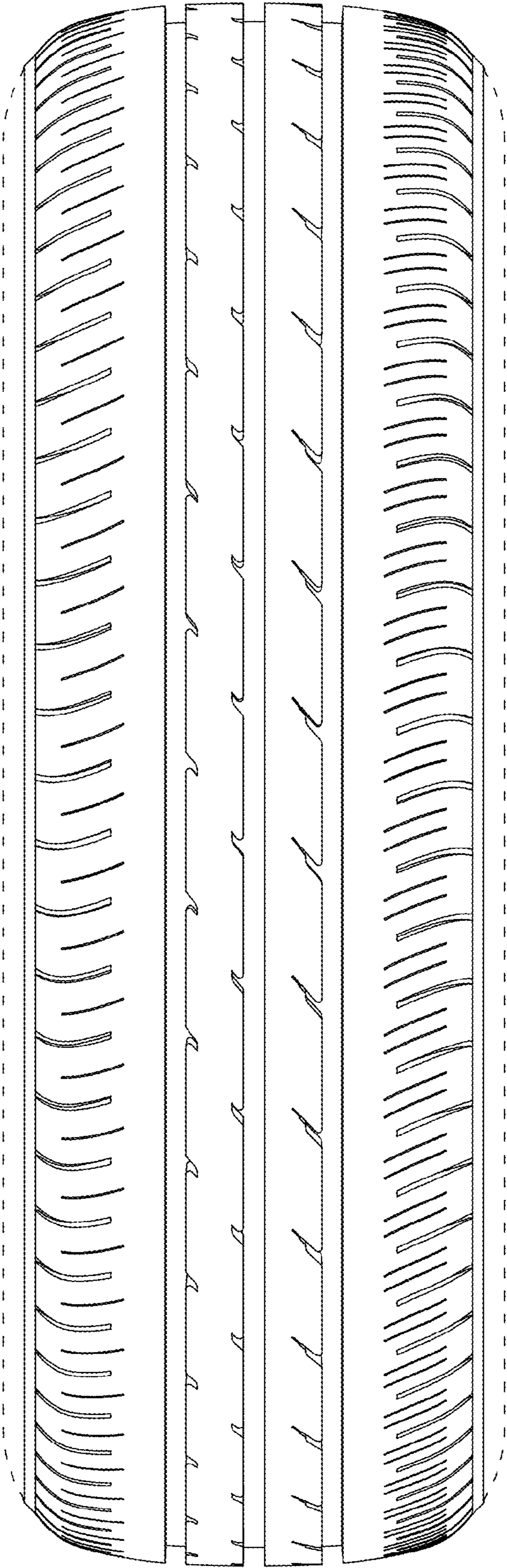

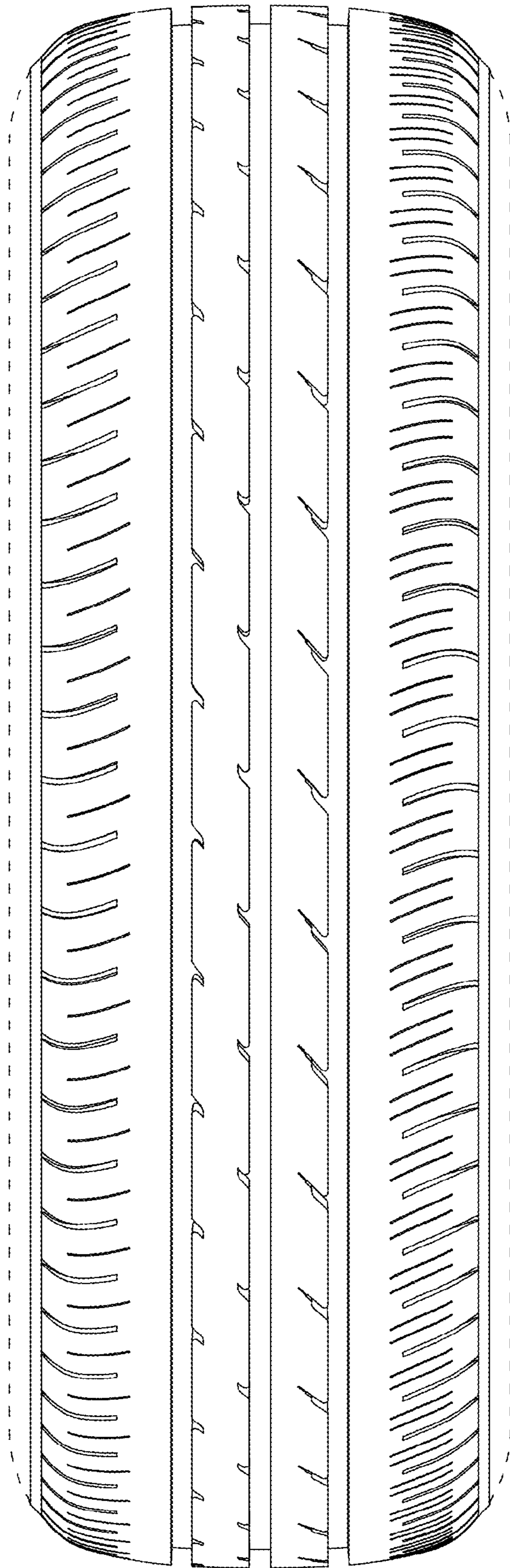

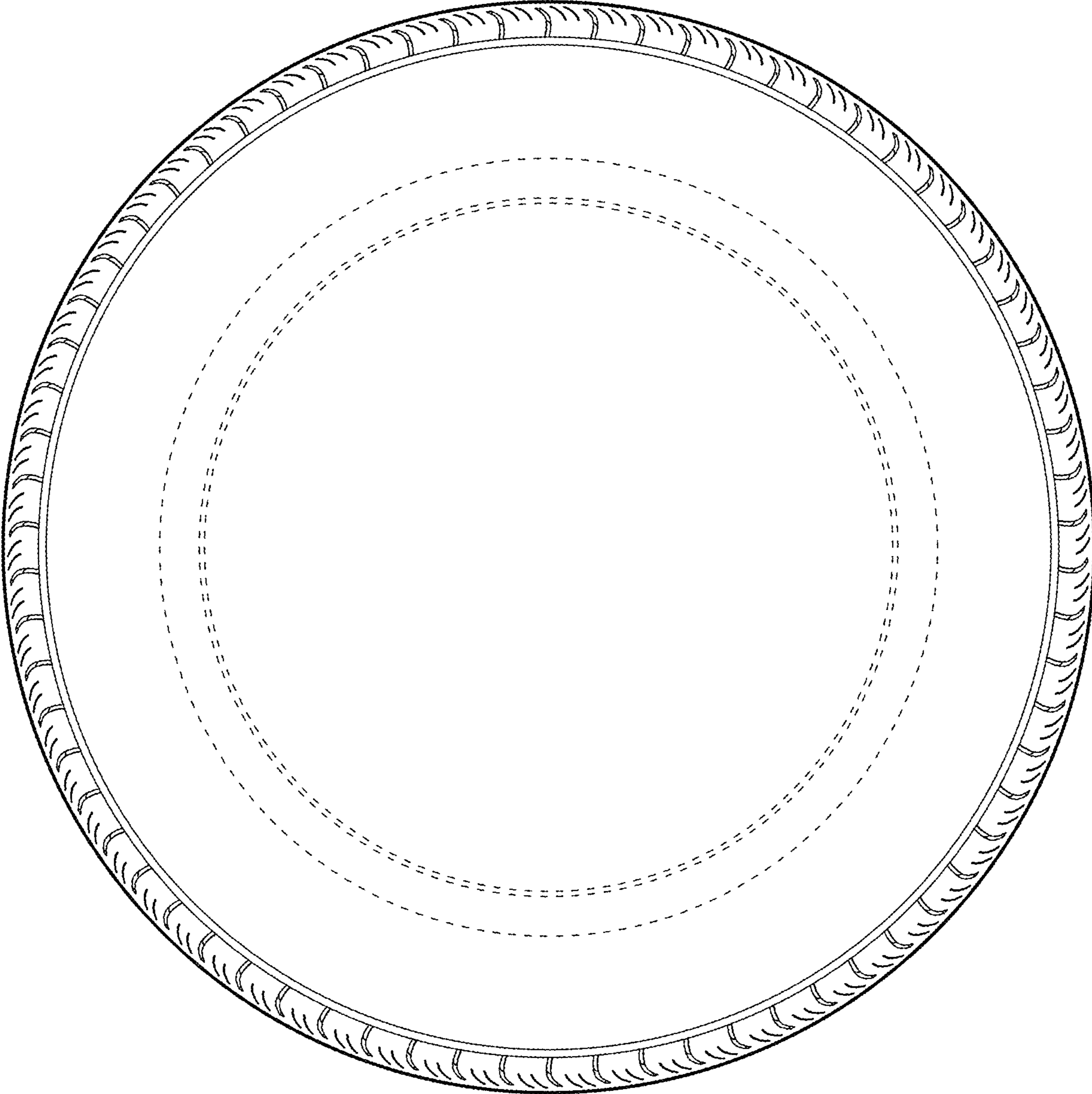

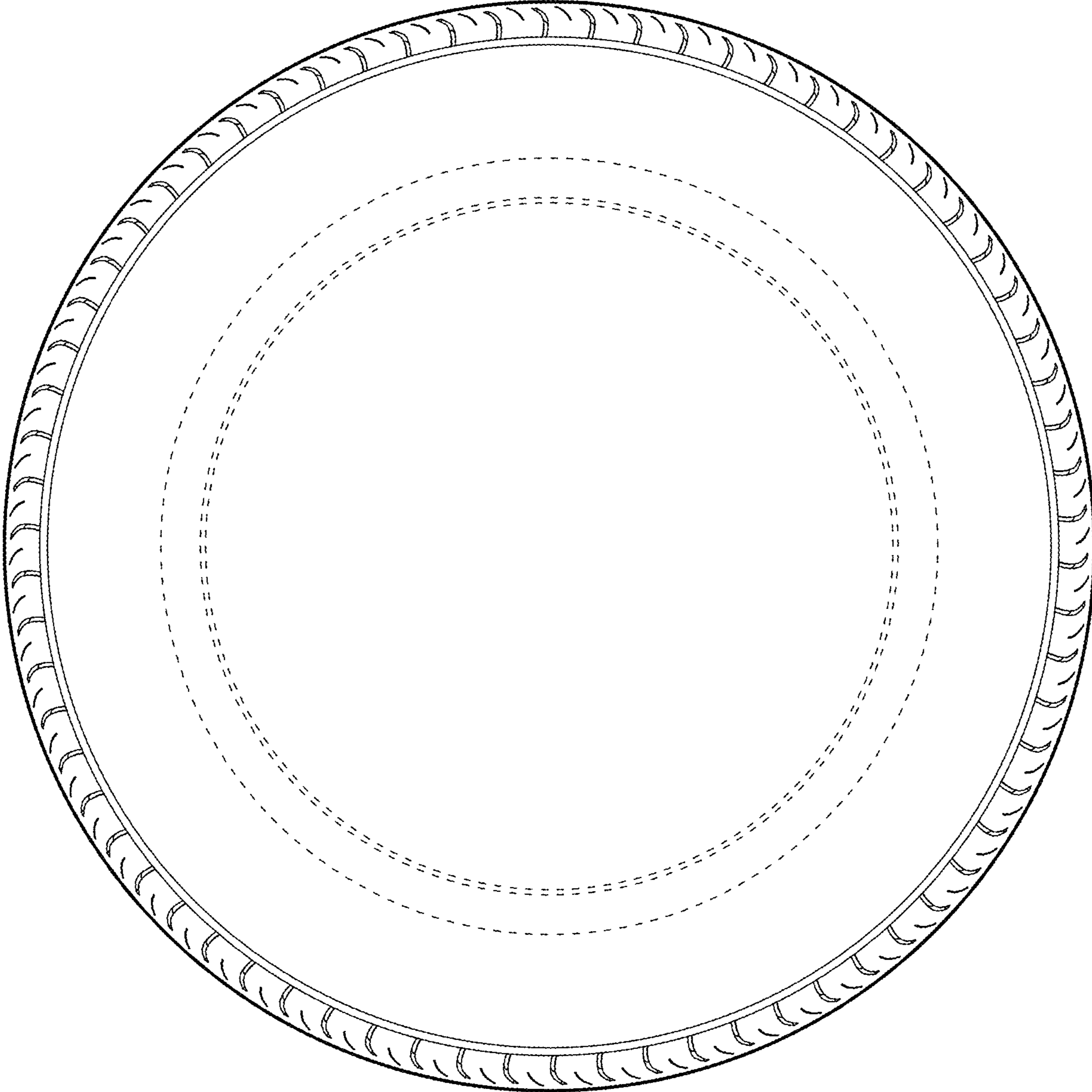

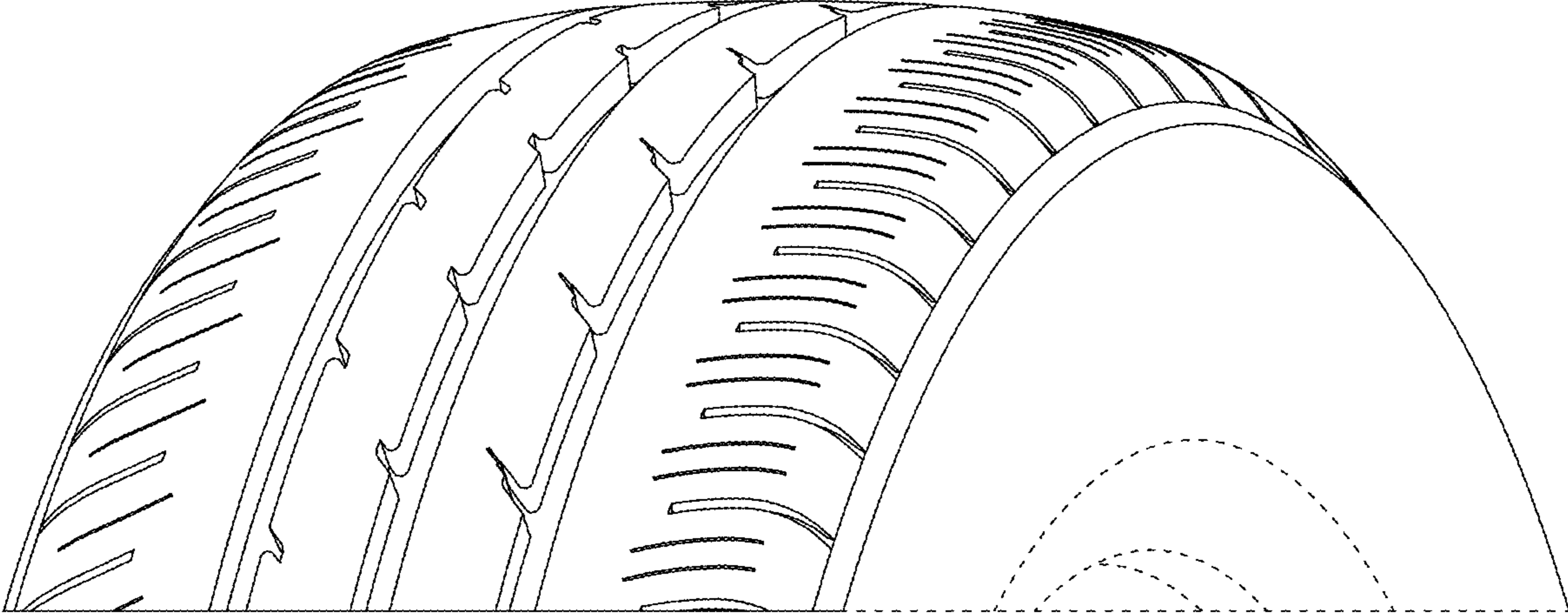

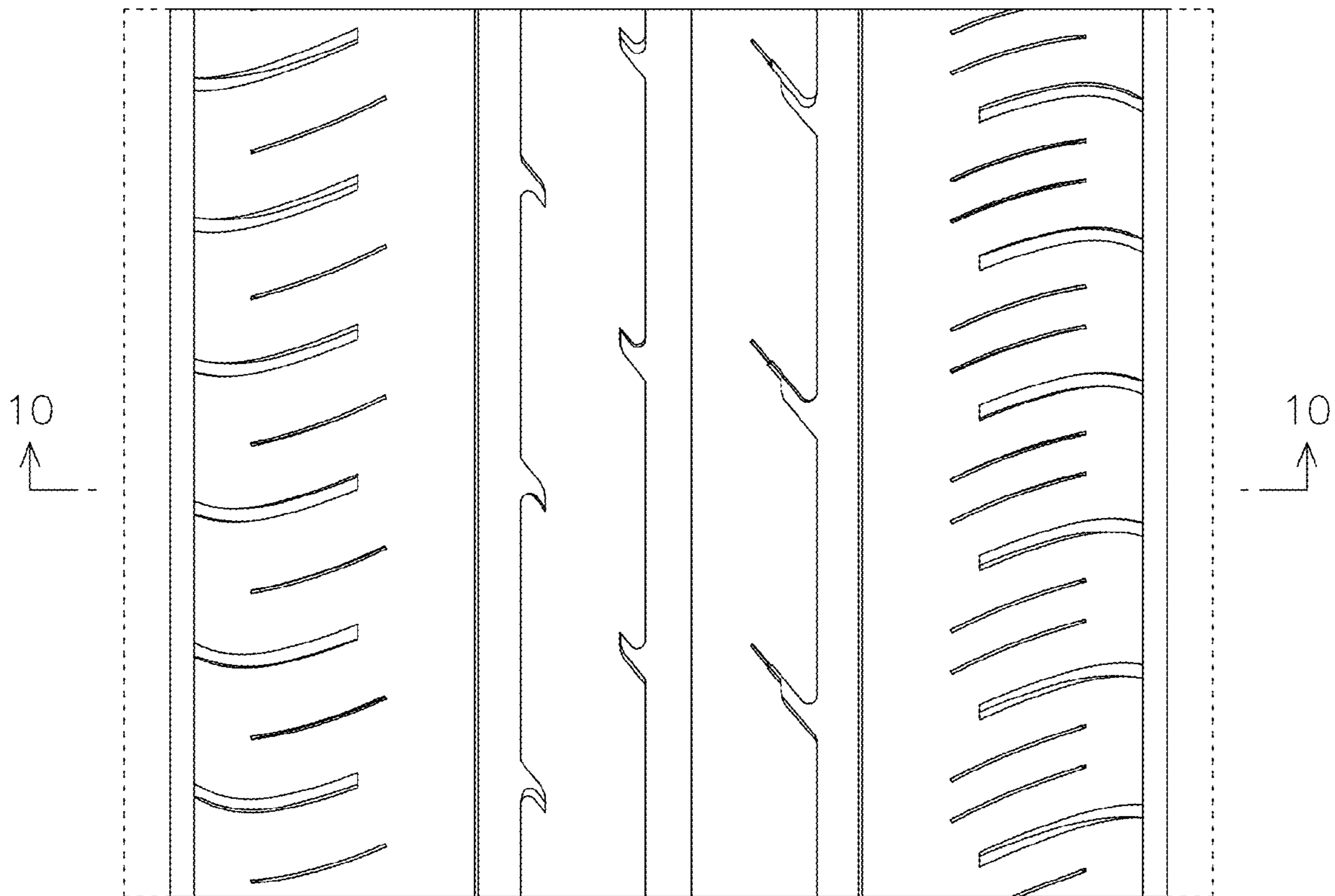

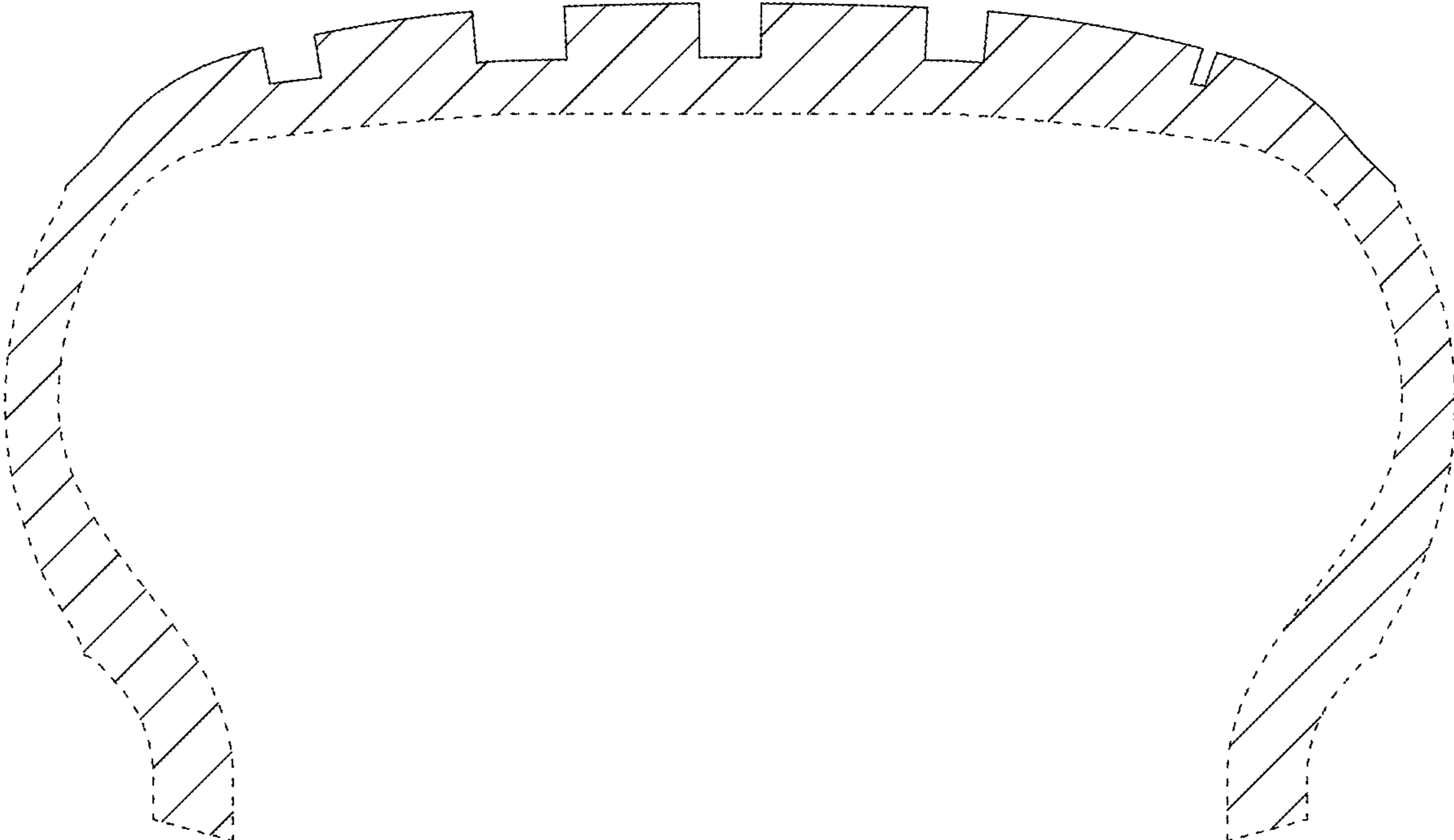
