FIG. 16 is a sixth perspective view of the enlarged portion shown in FIG. 9;

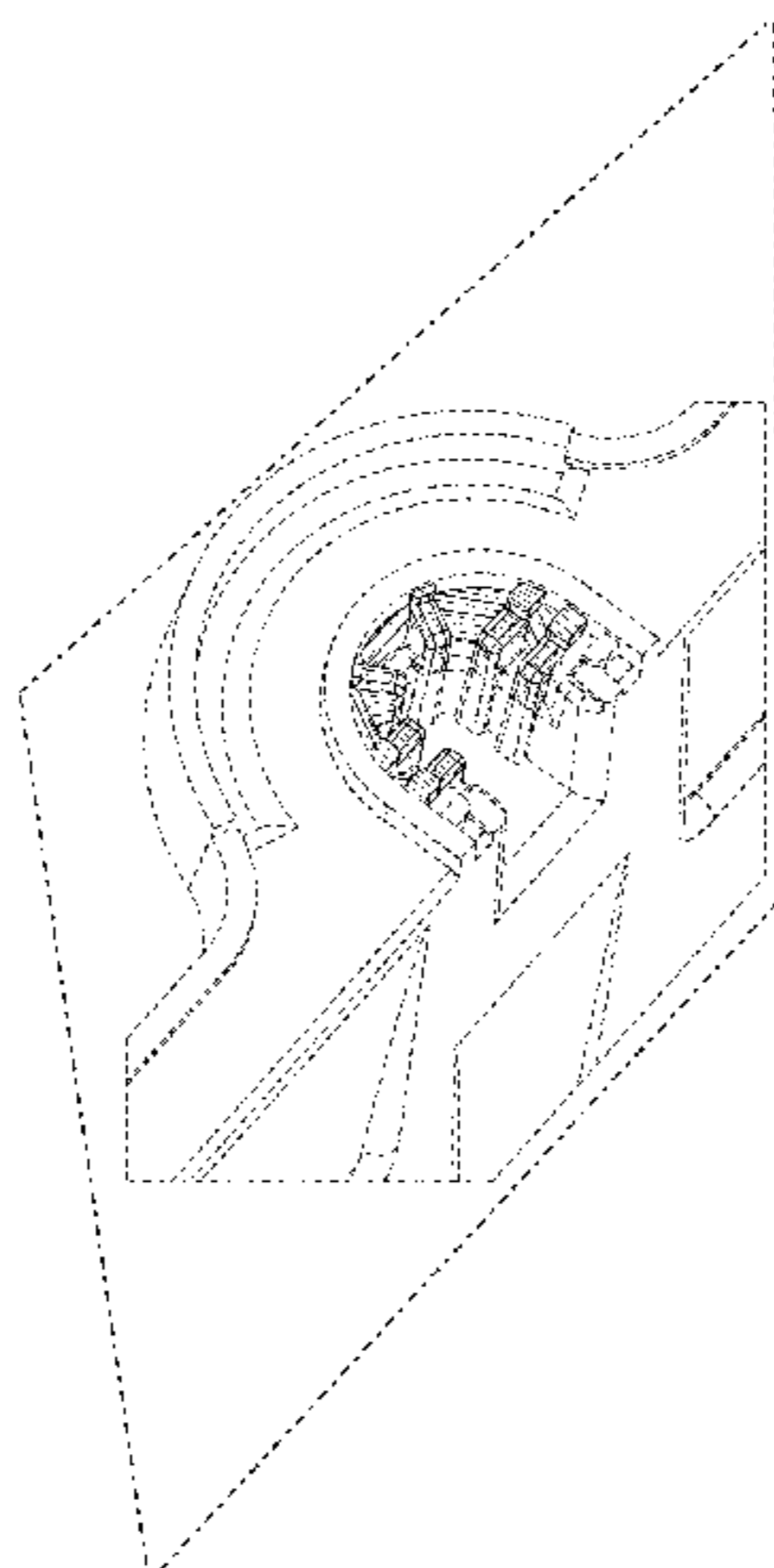
FIG. 17 is a top view of the enlarged portion shown in FIG. 9, shown in an environment of use

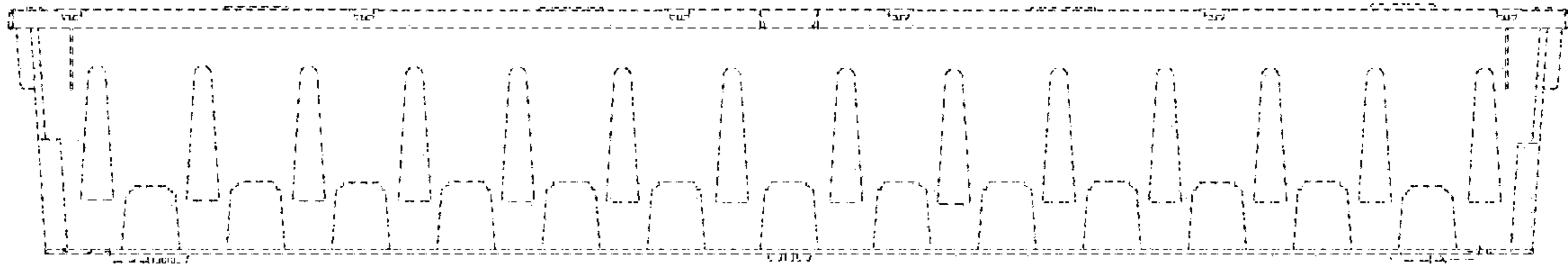

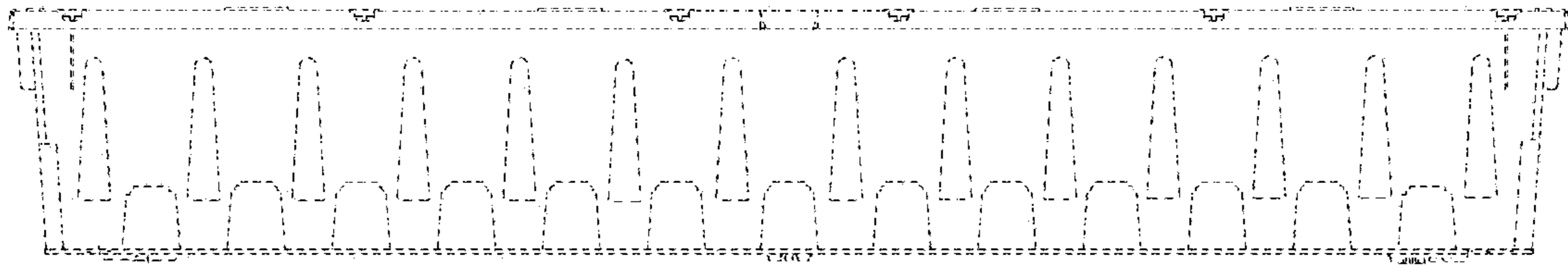

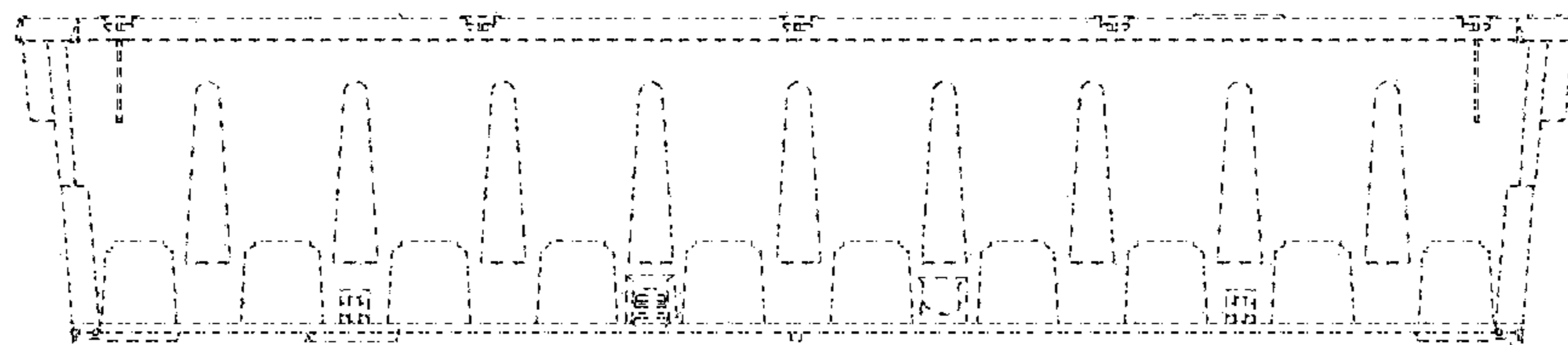

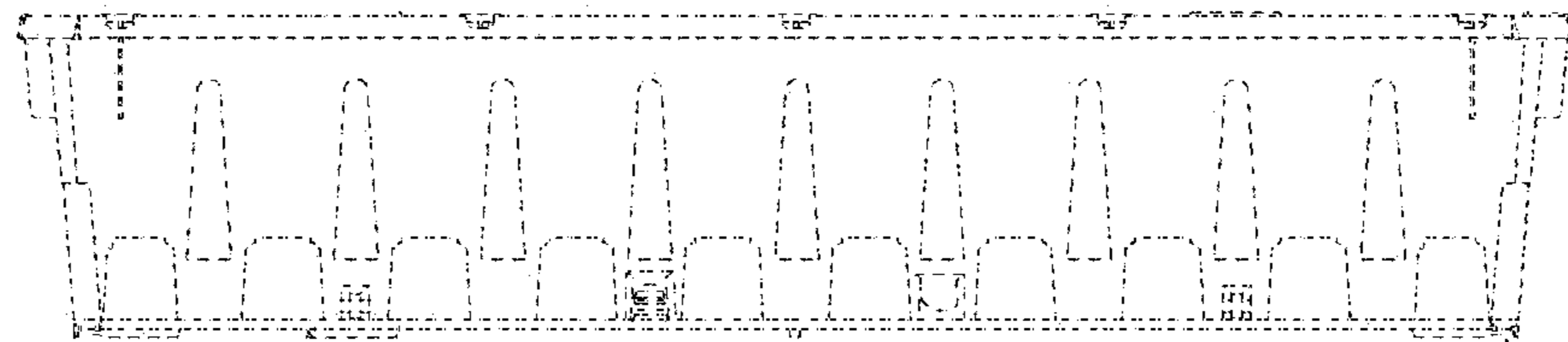

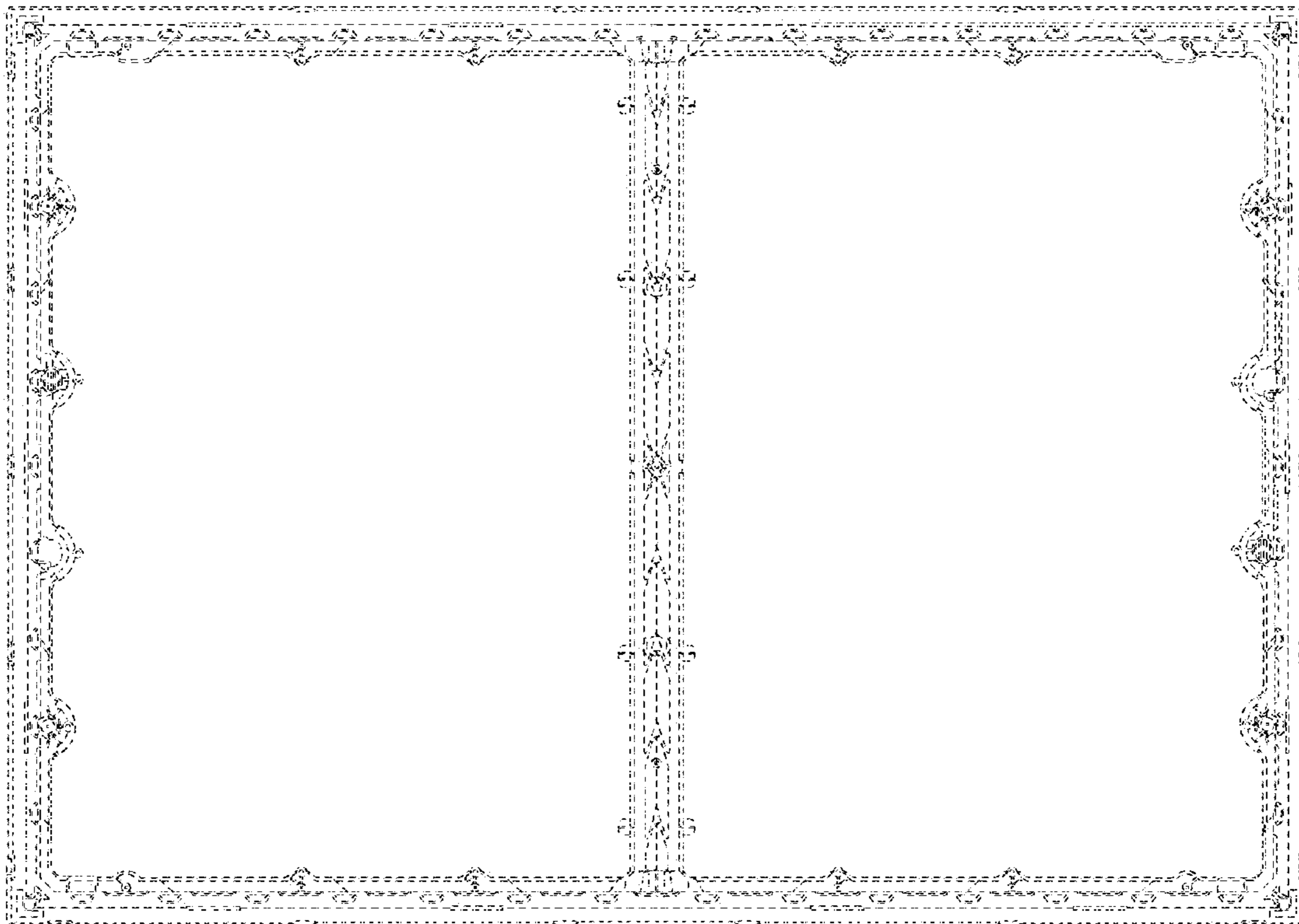

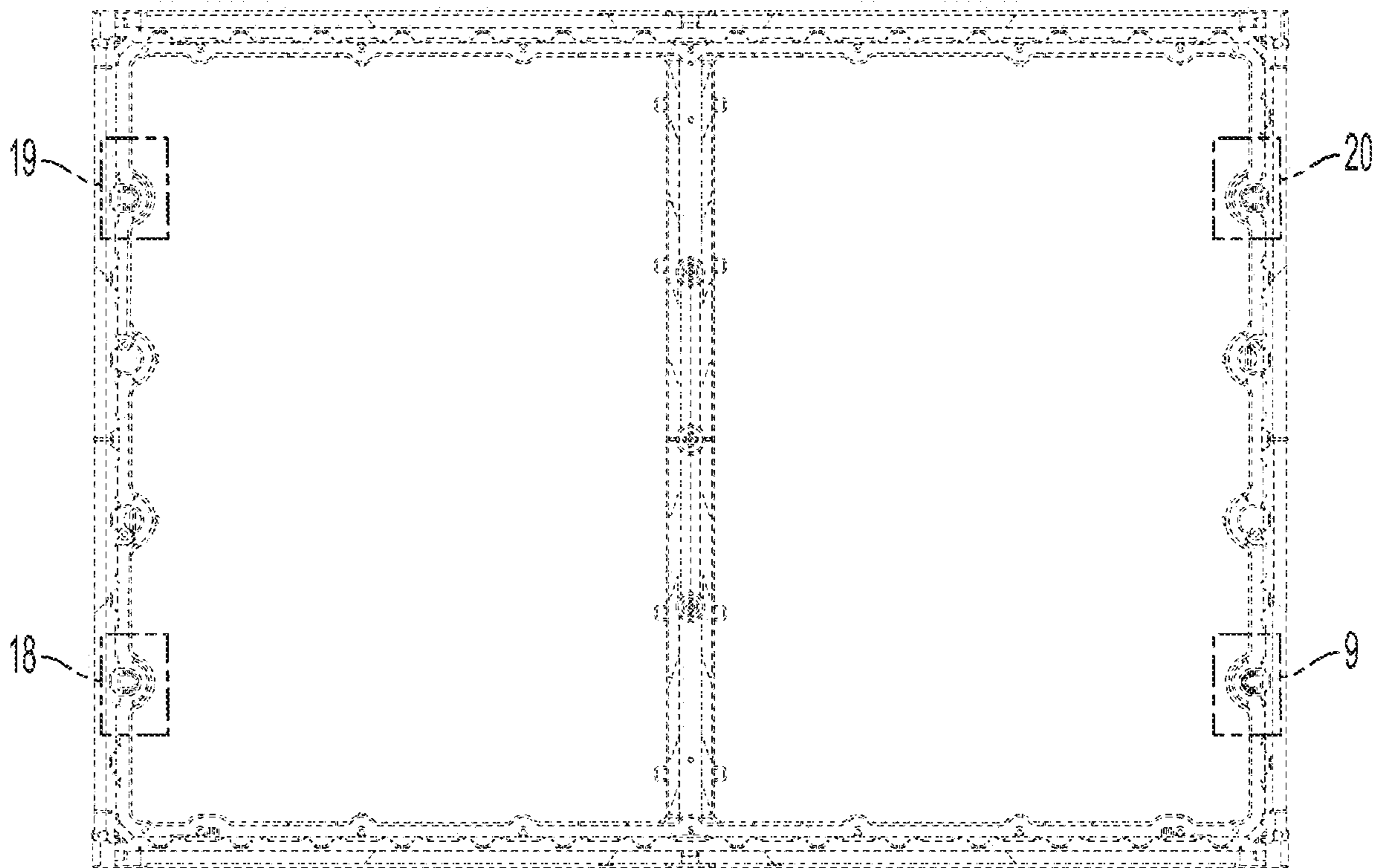

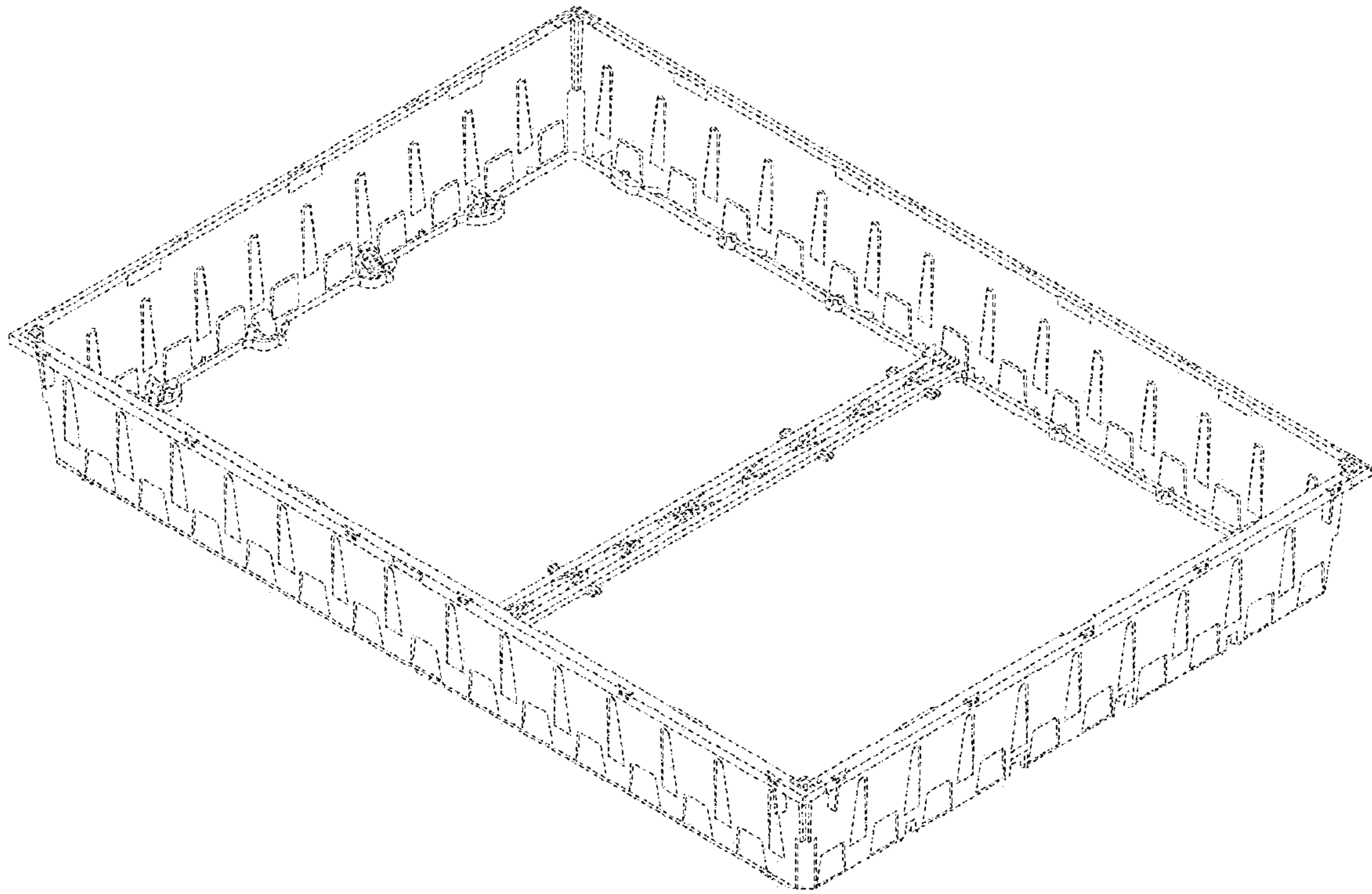

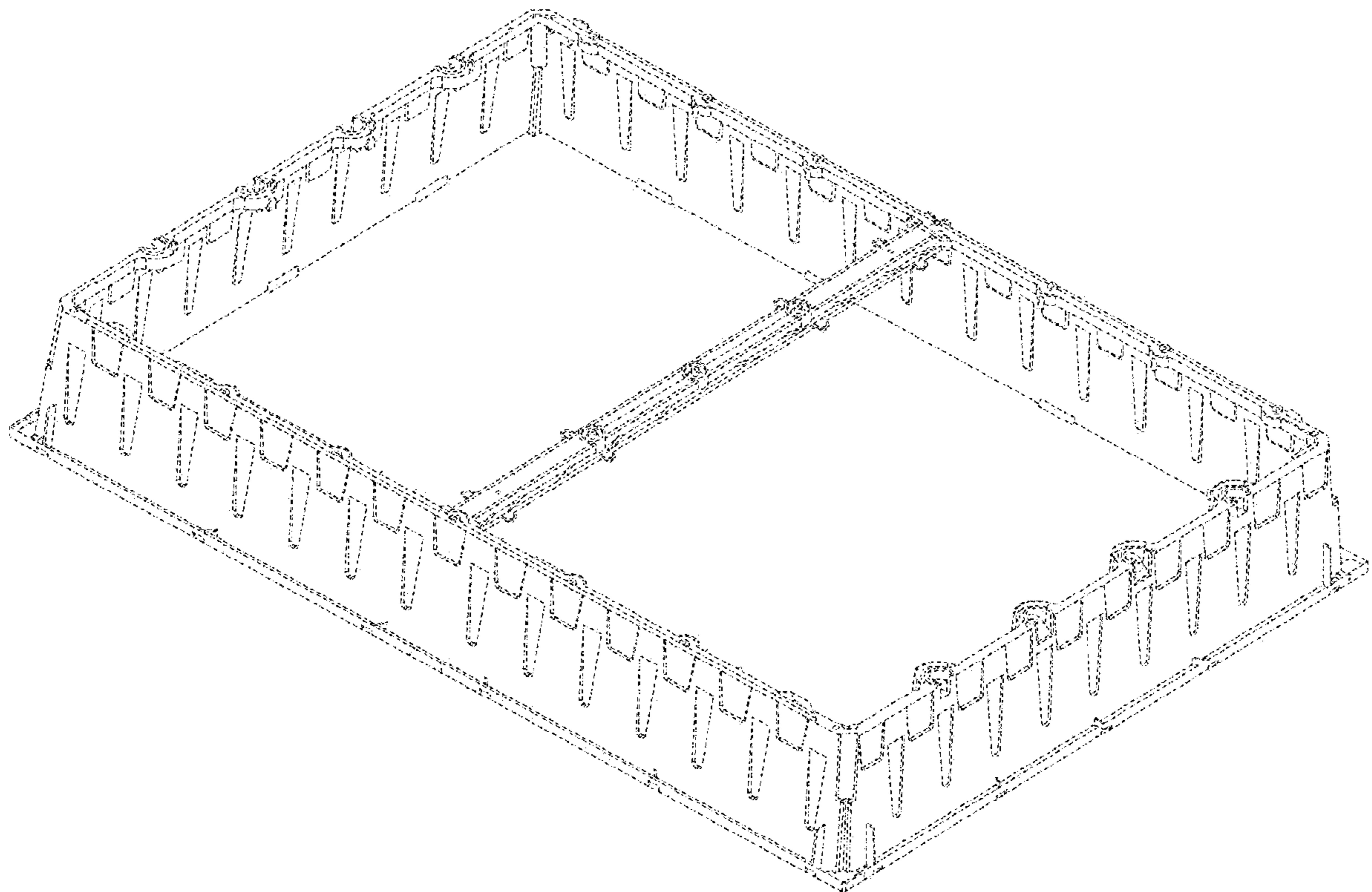

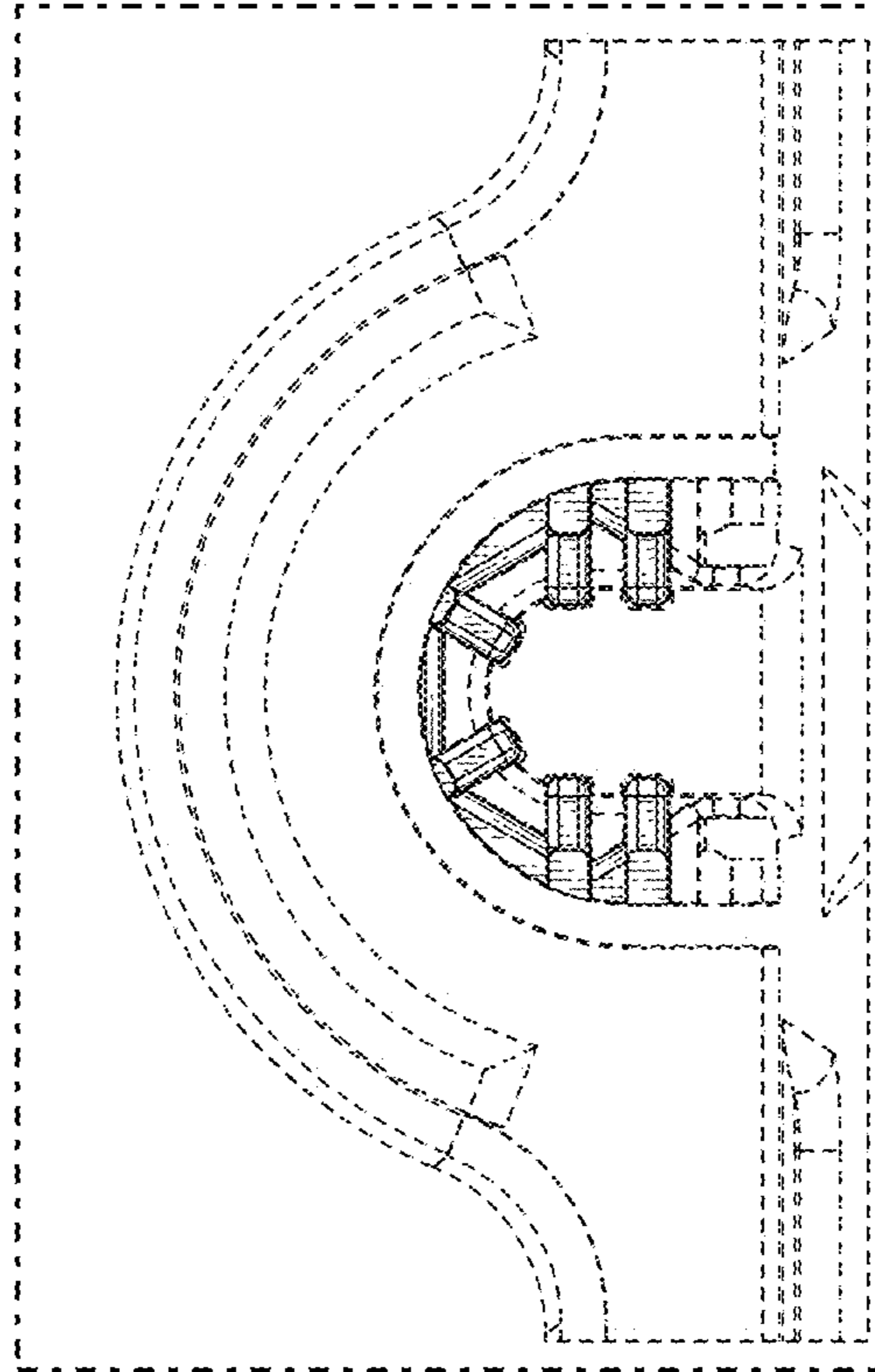

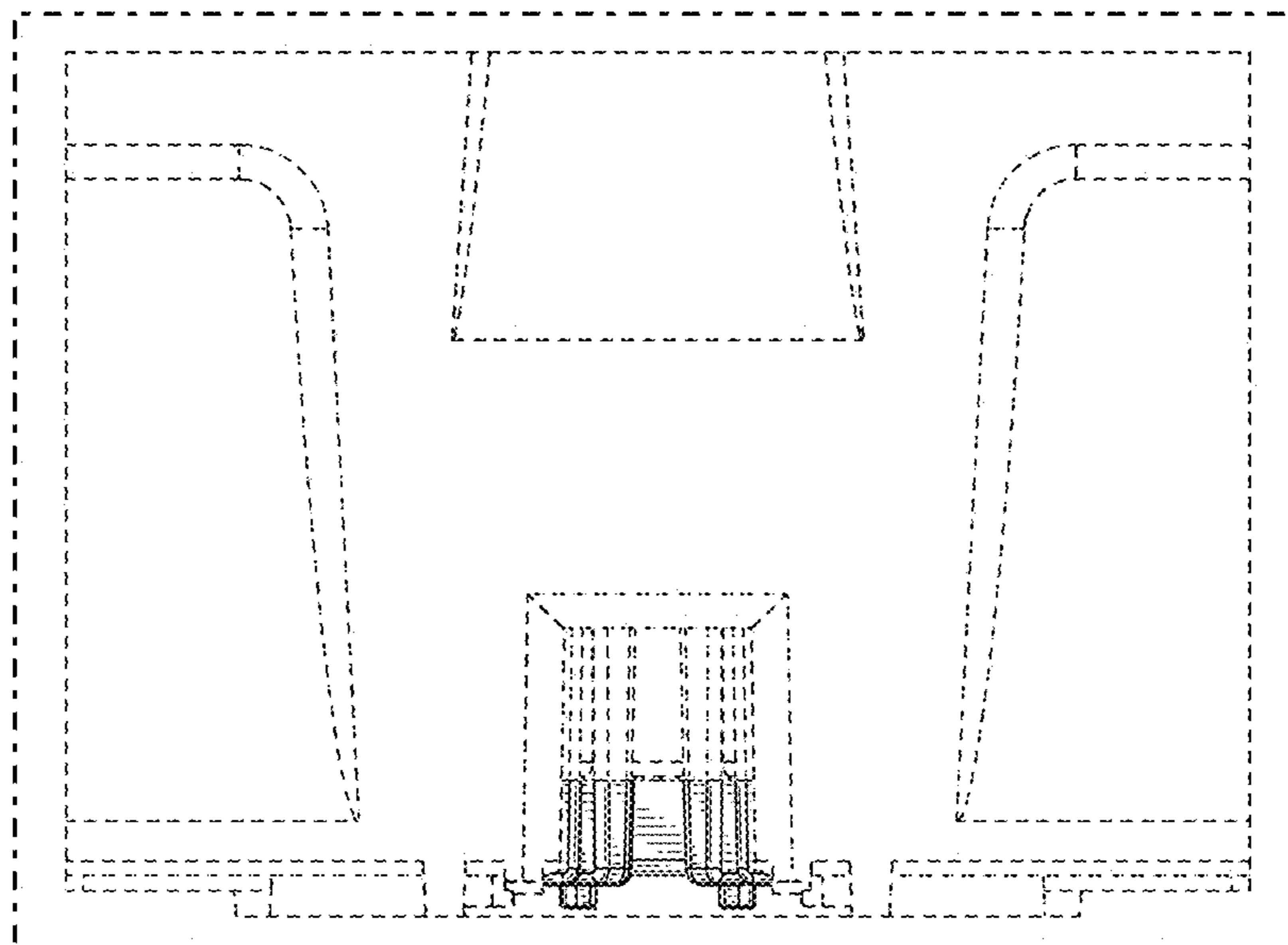

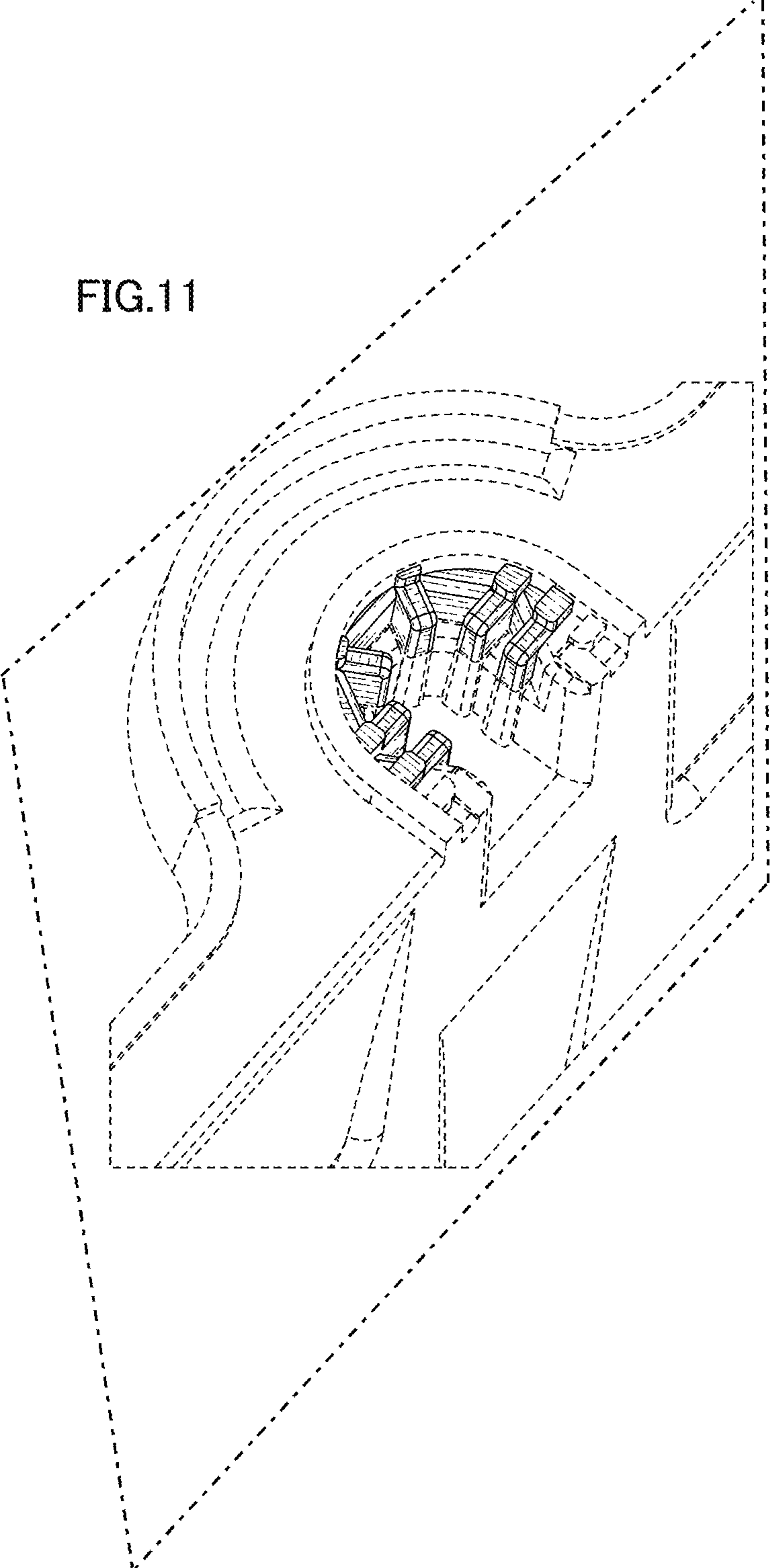

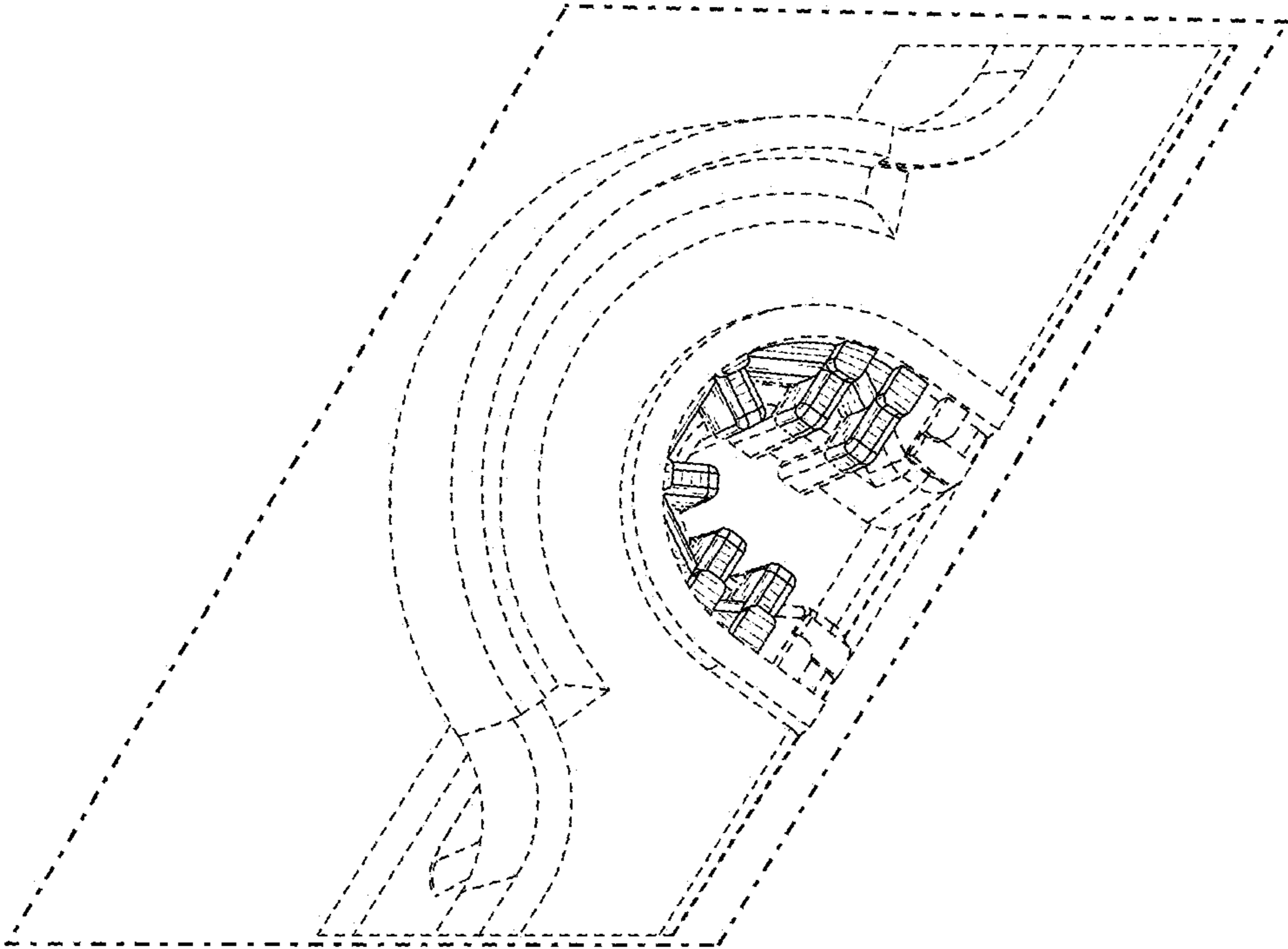

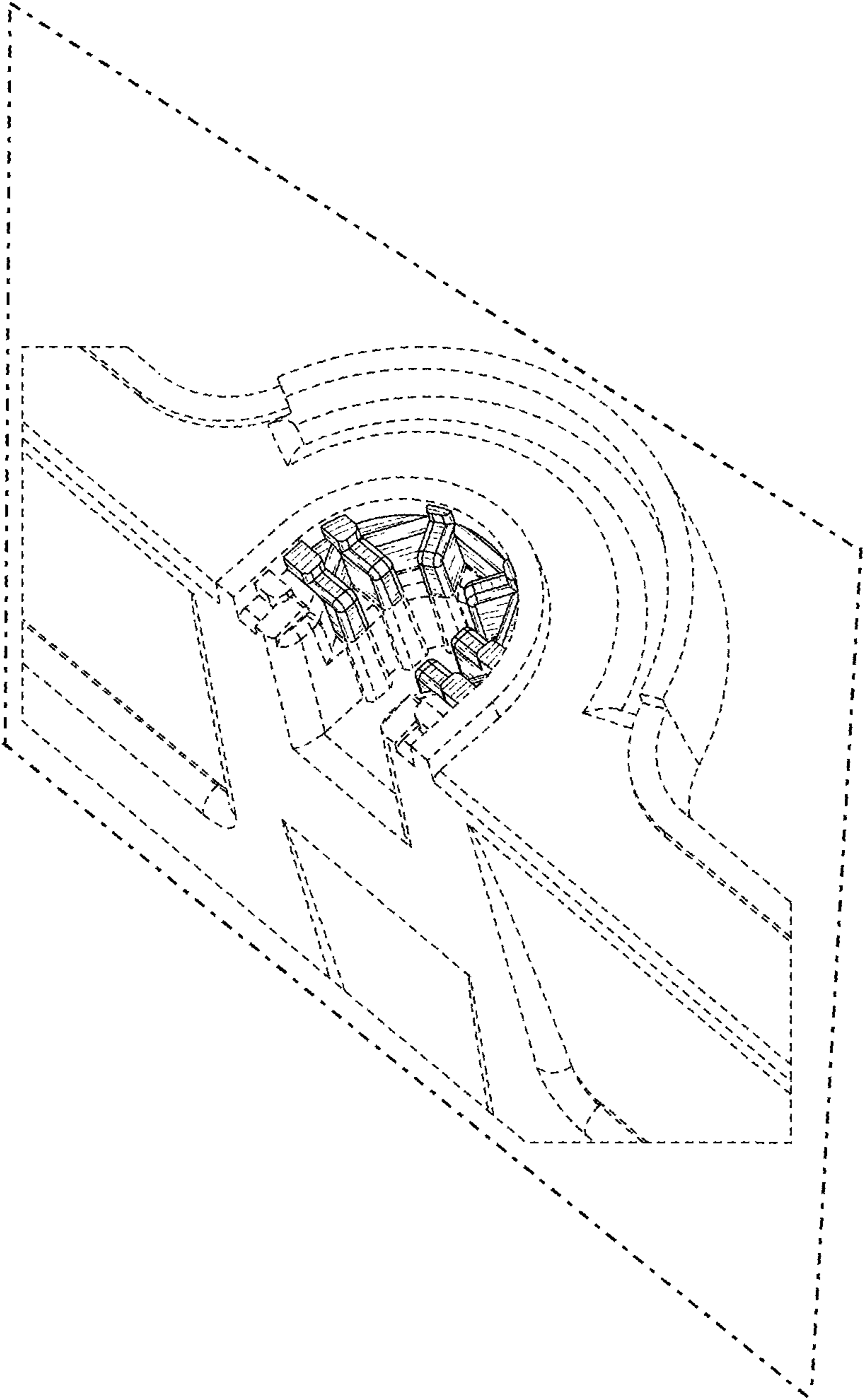

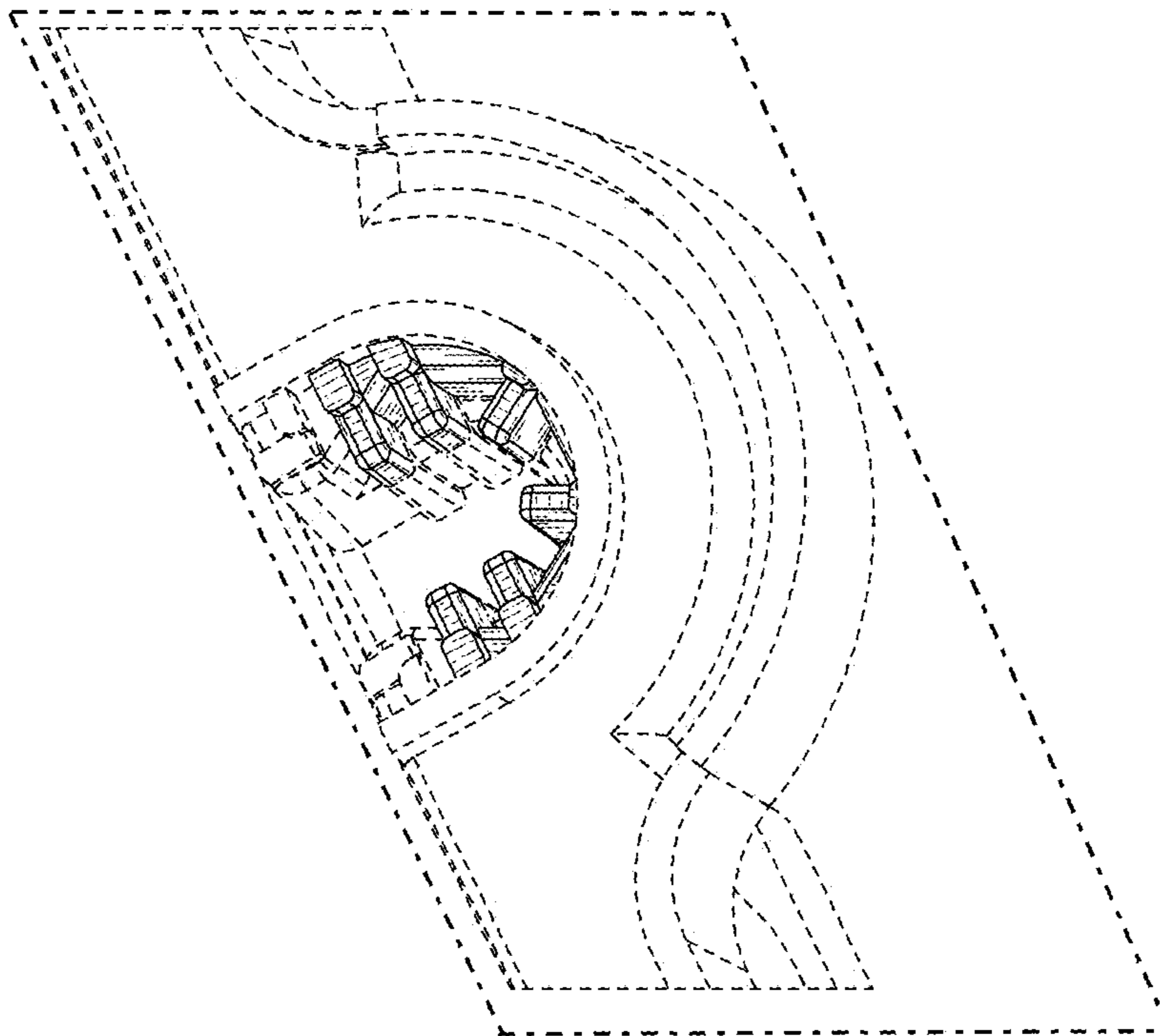

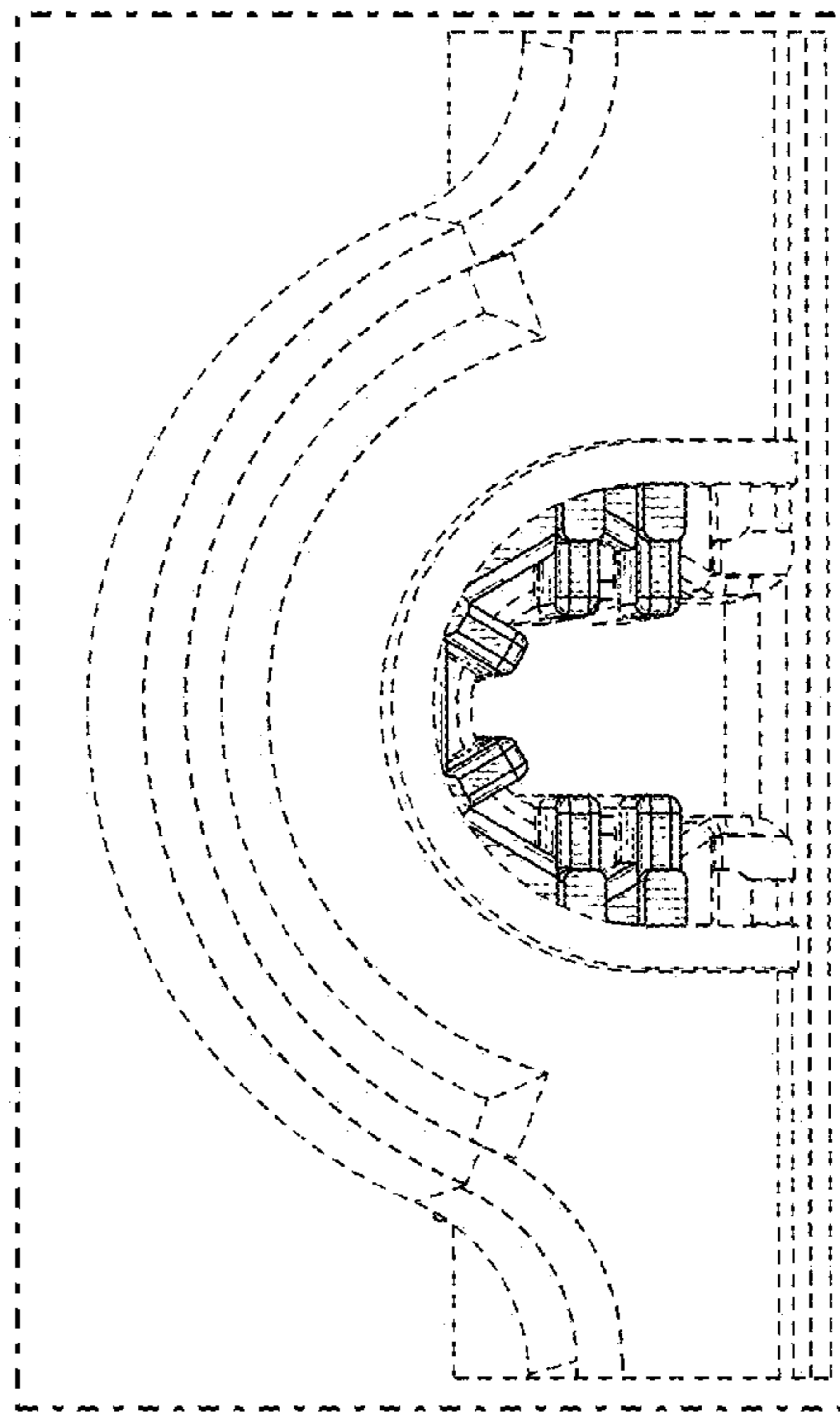

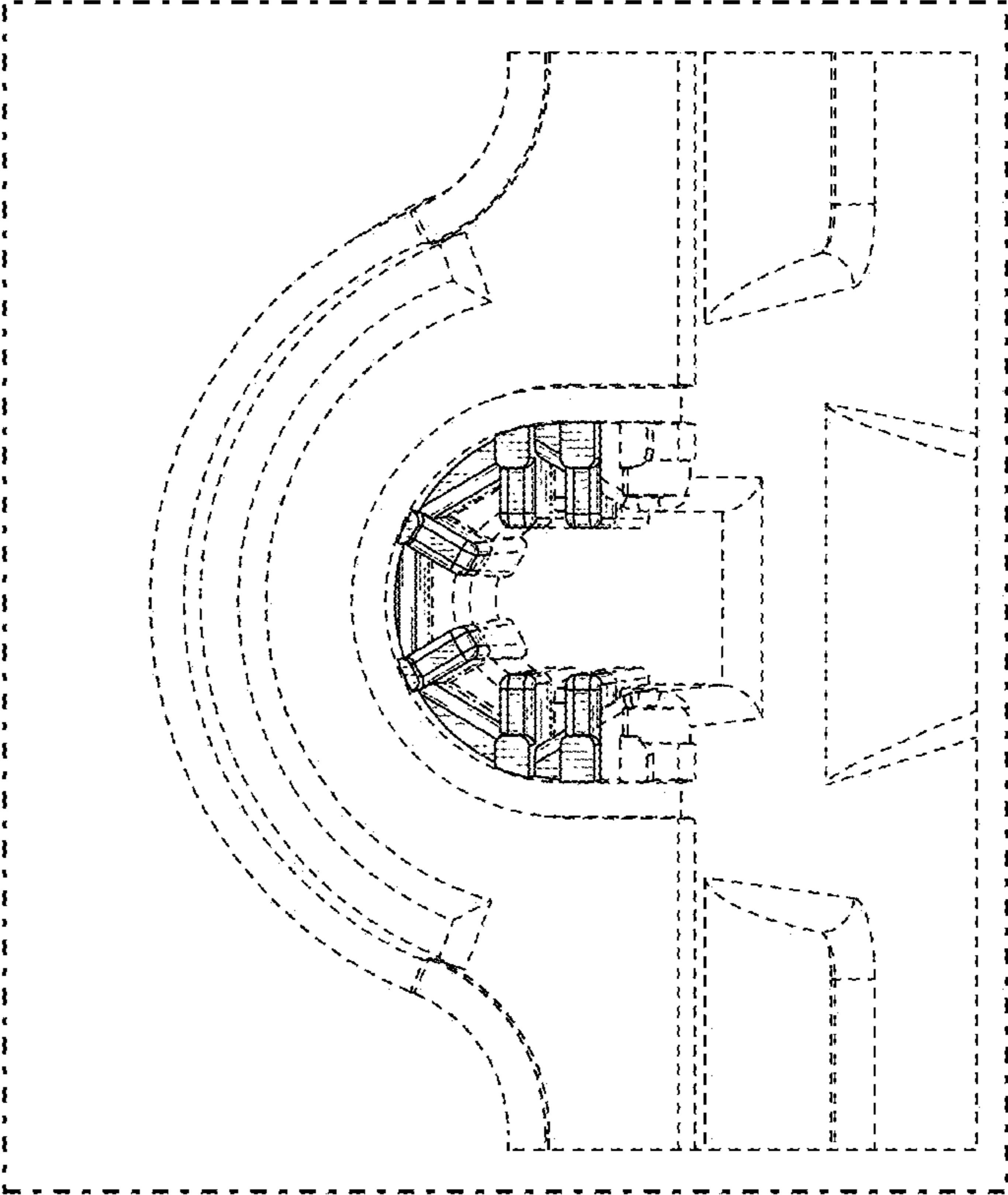

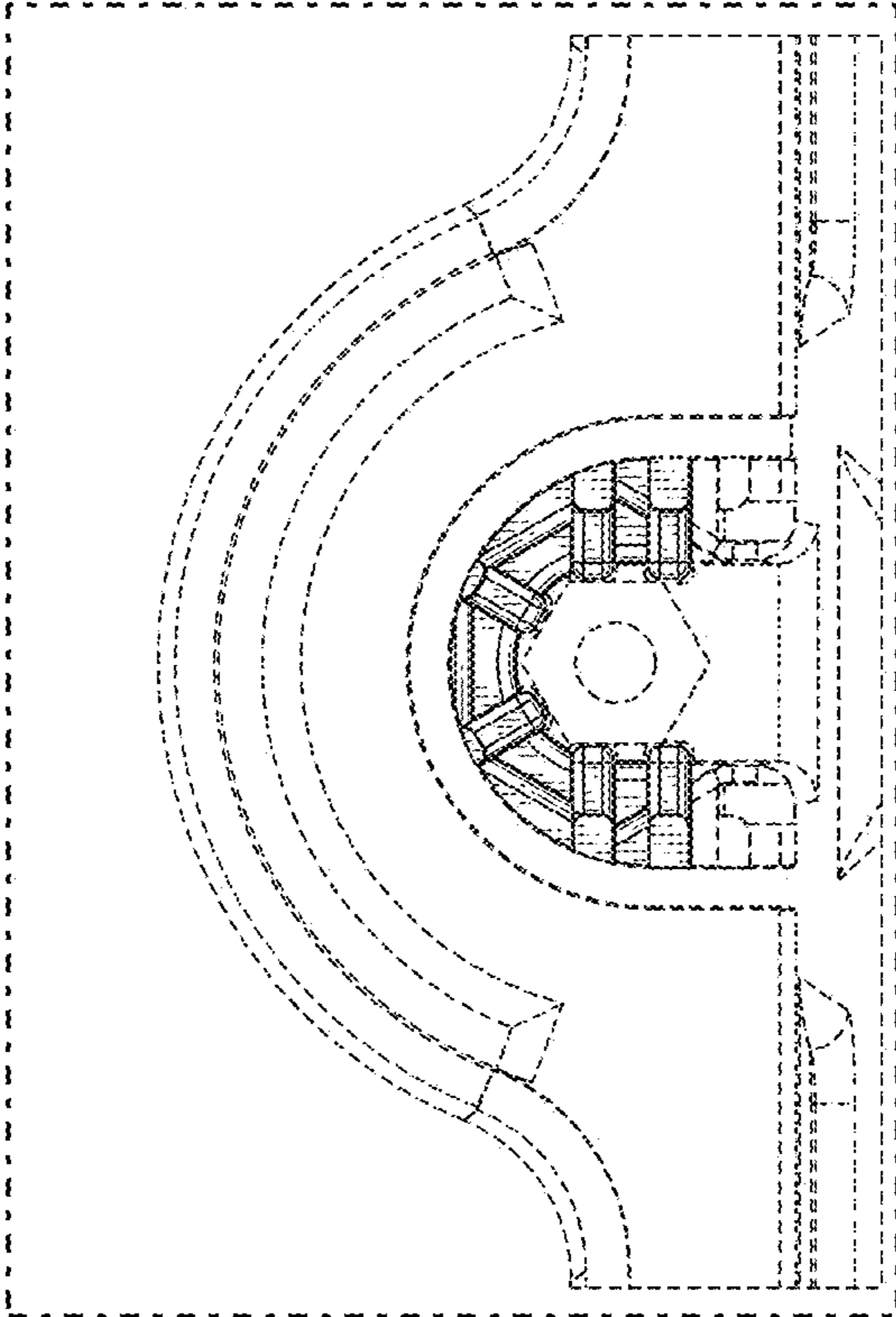

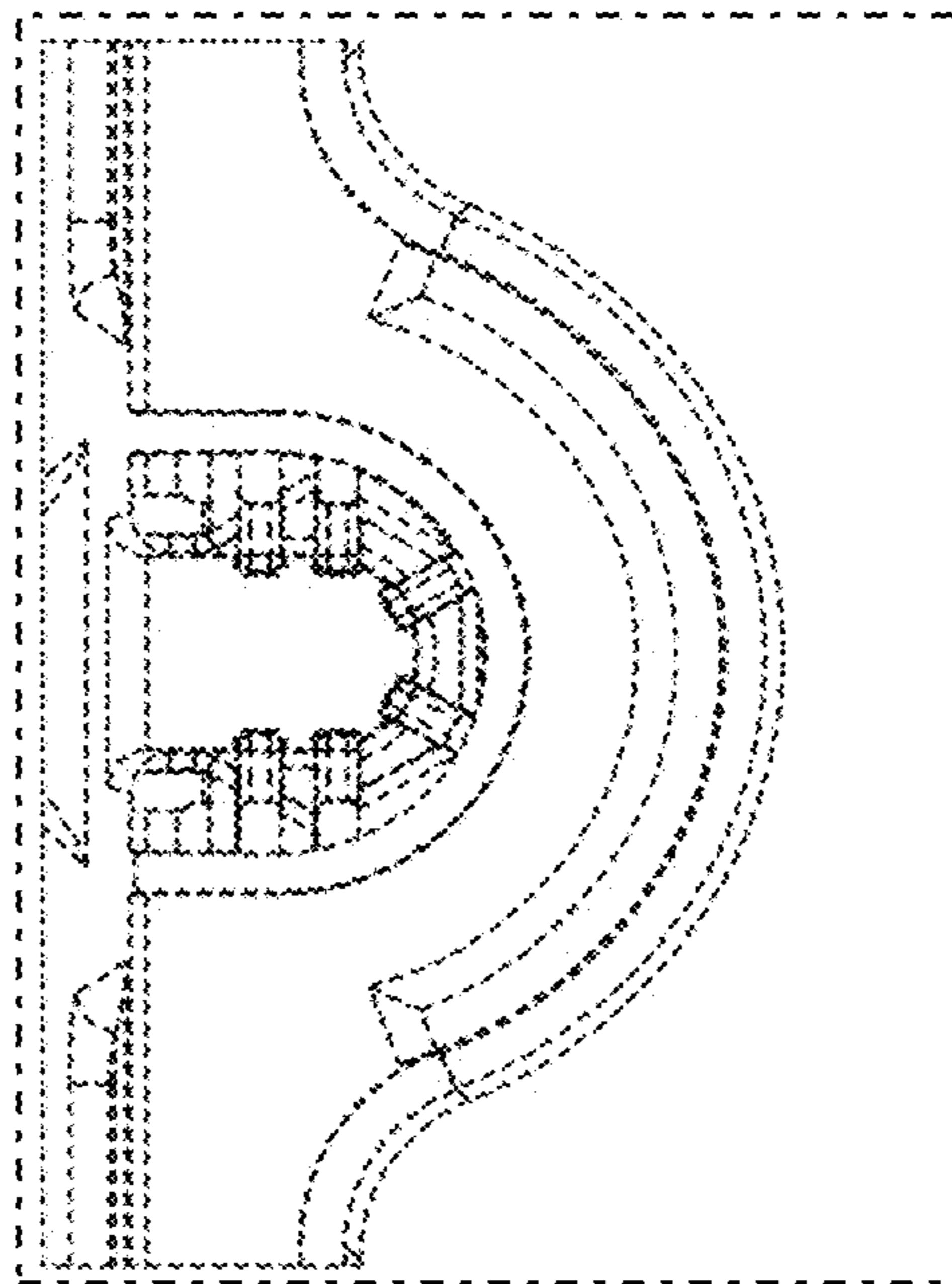

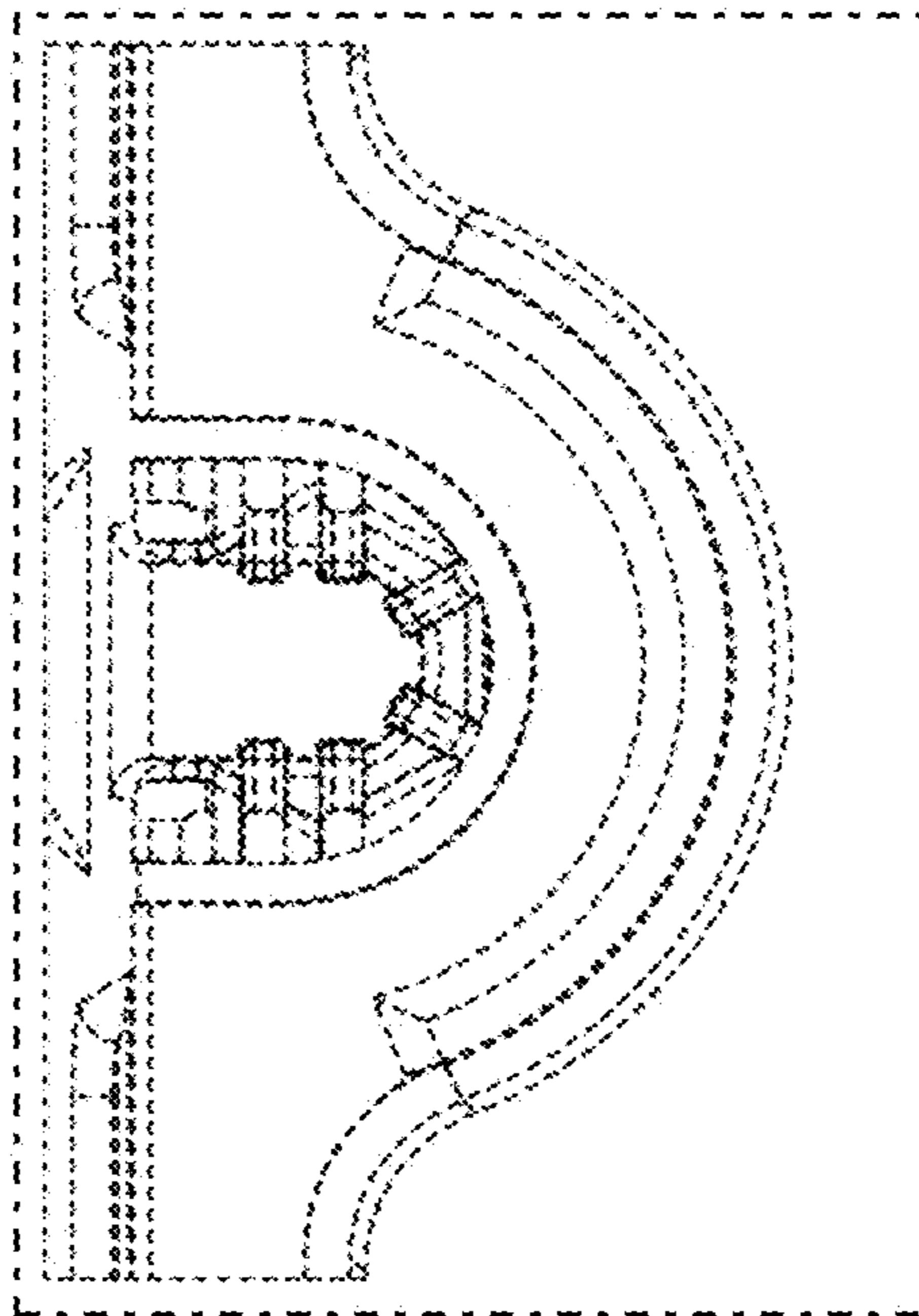
