FIG. 11 is a top view of the electric terminal of FIG. 8.

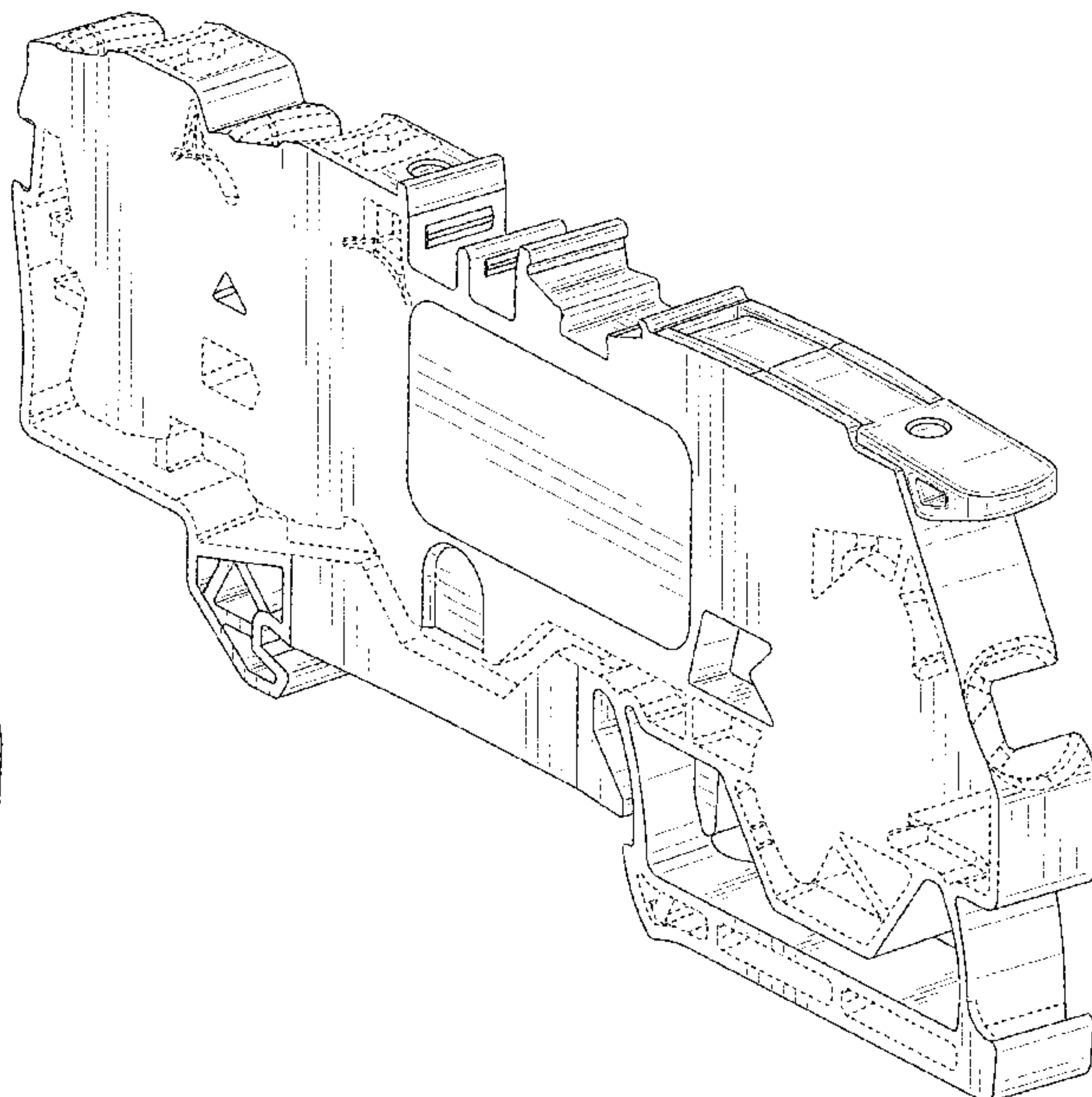
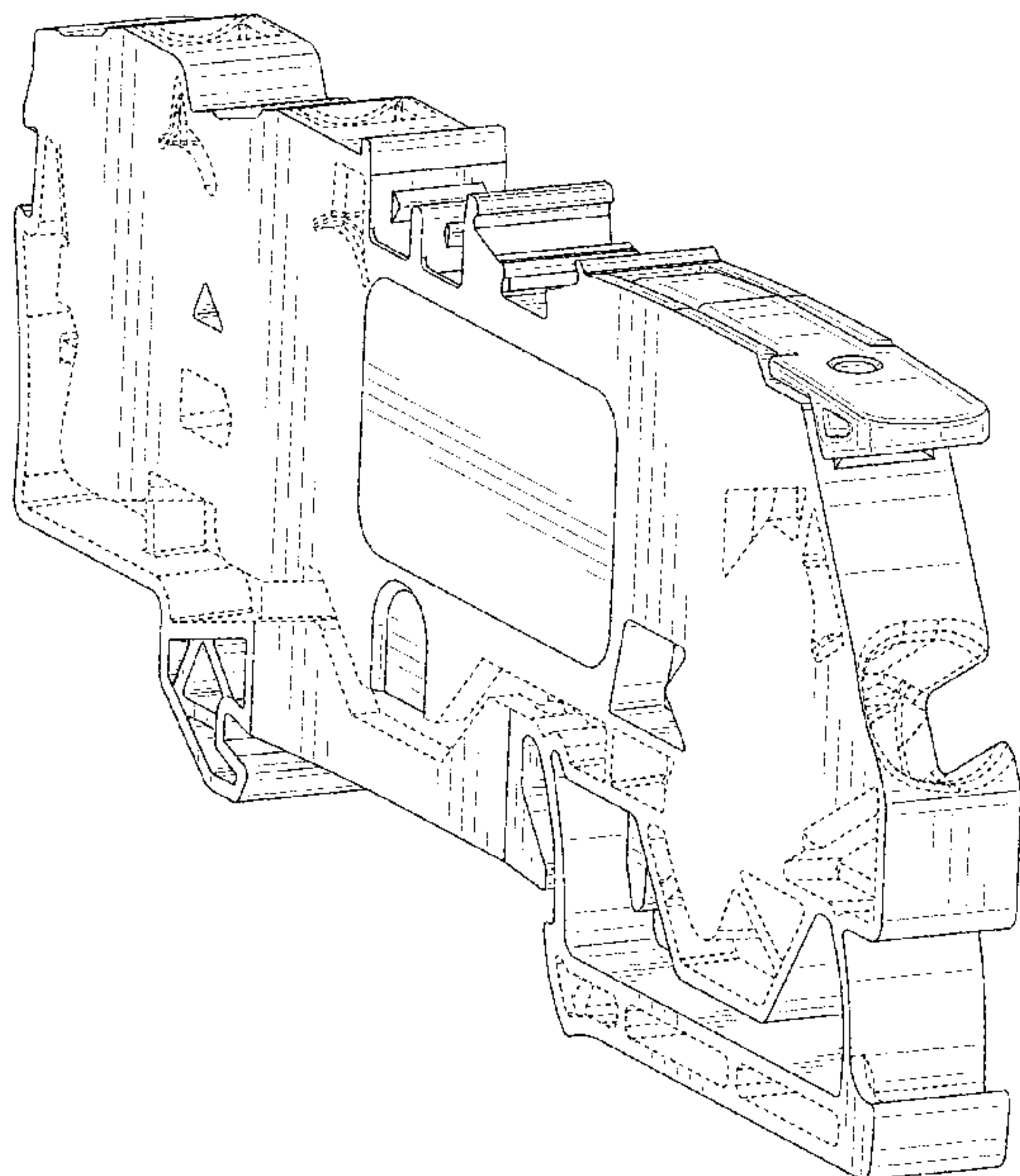
FIG. 12 is a right side view of the electric terminal of FIG. 8.

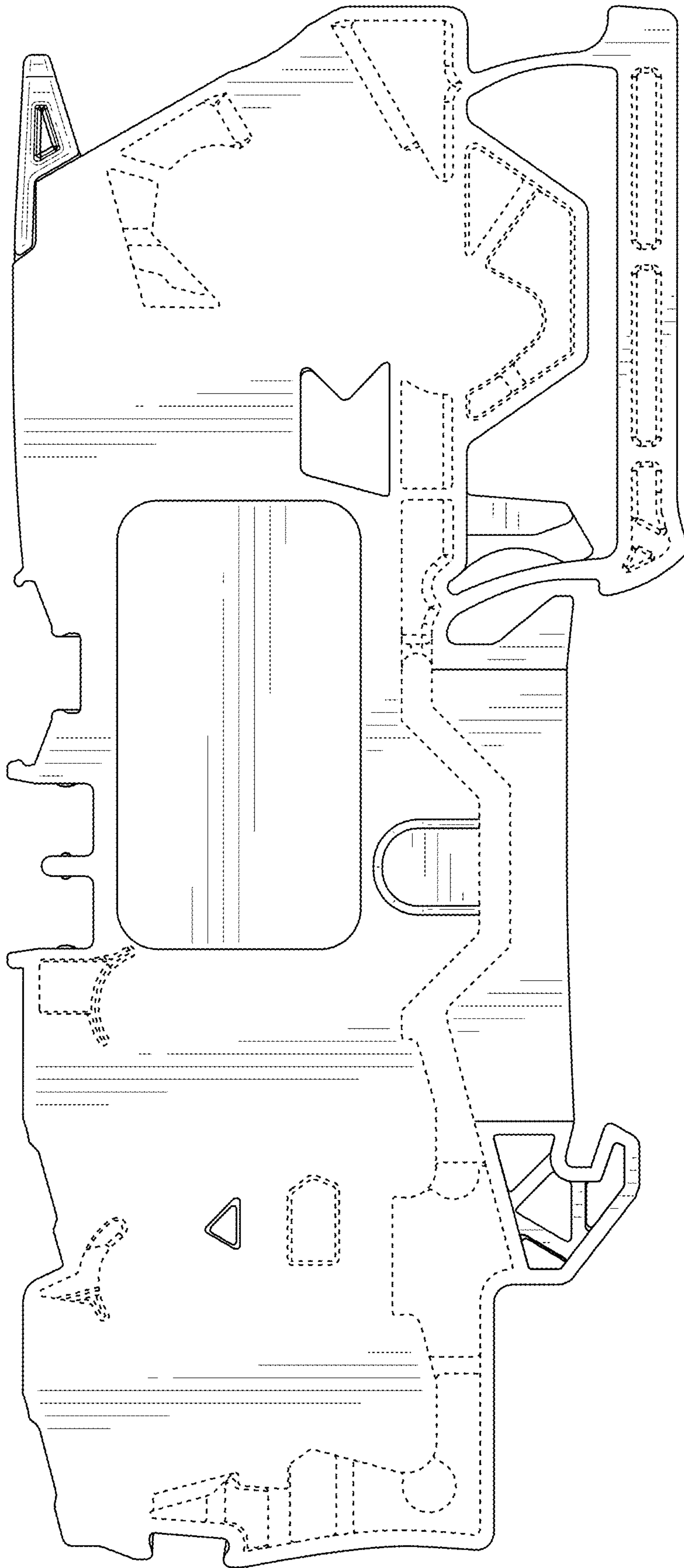

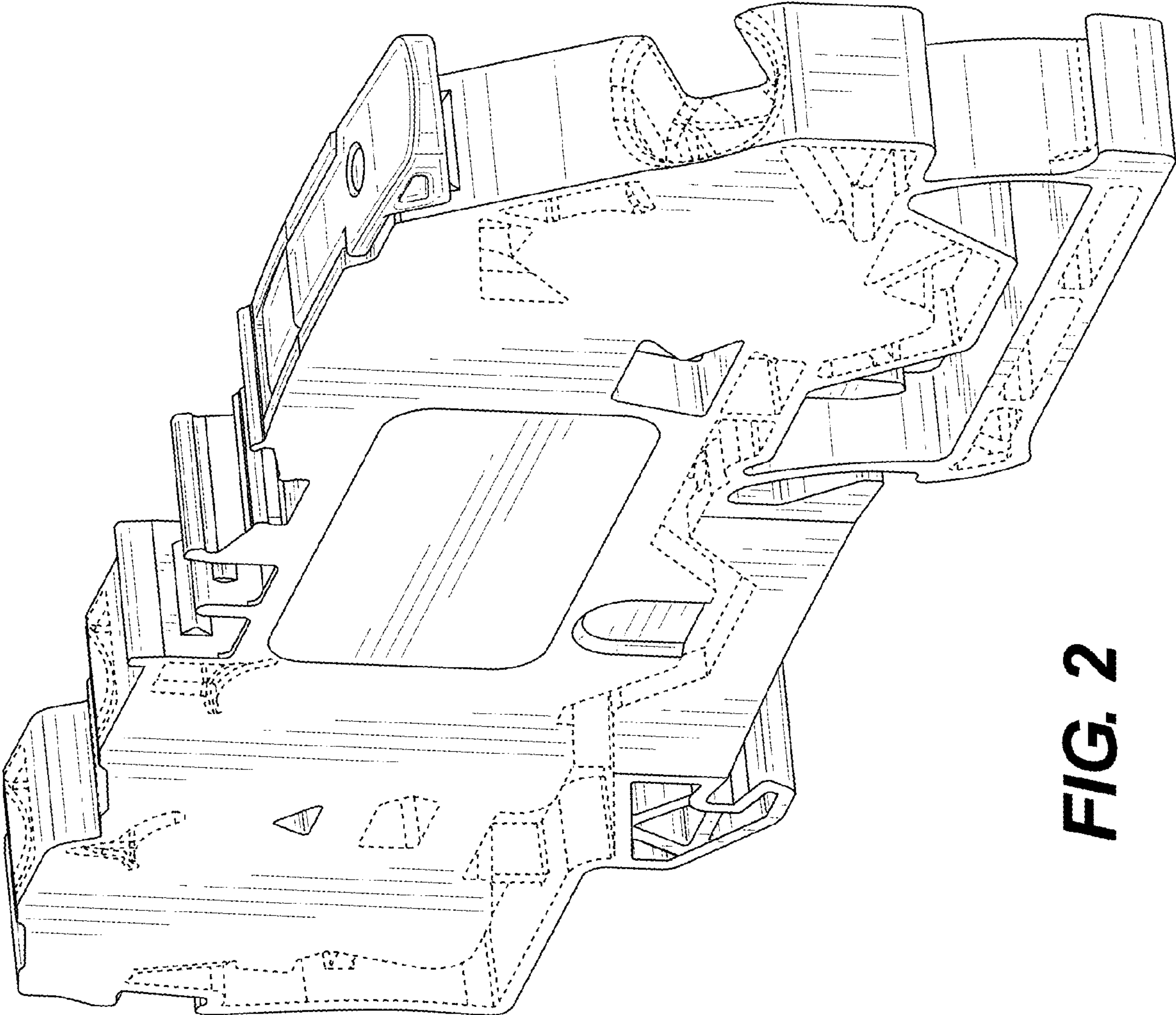

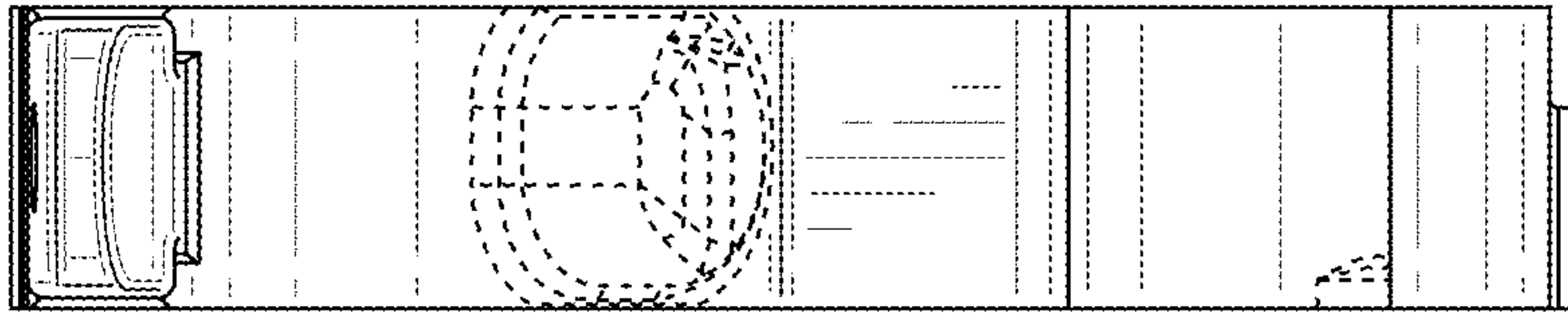

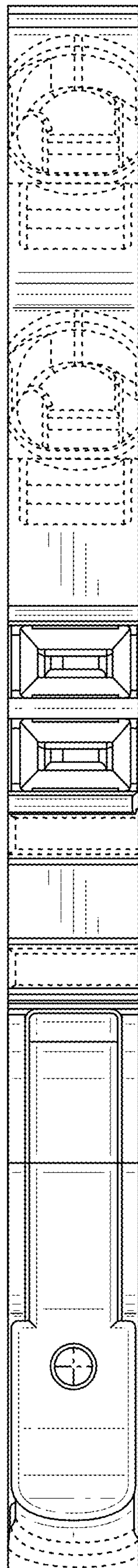

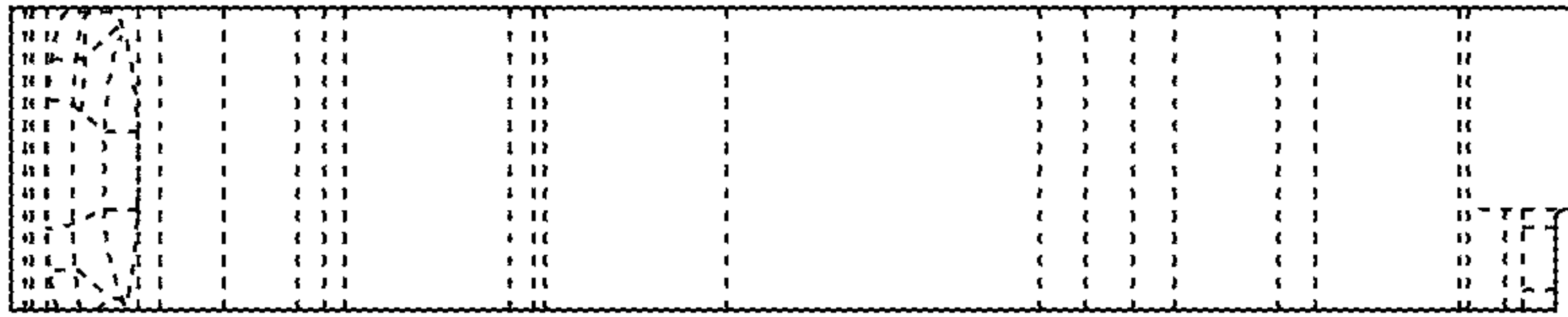

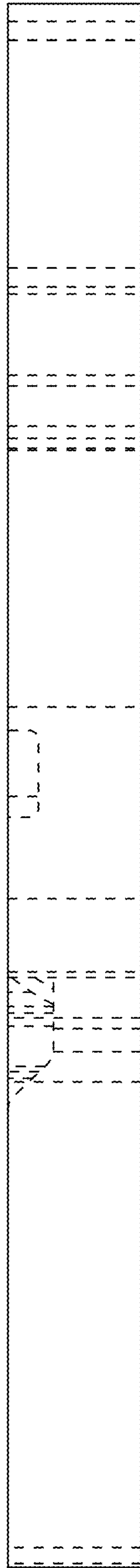

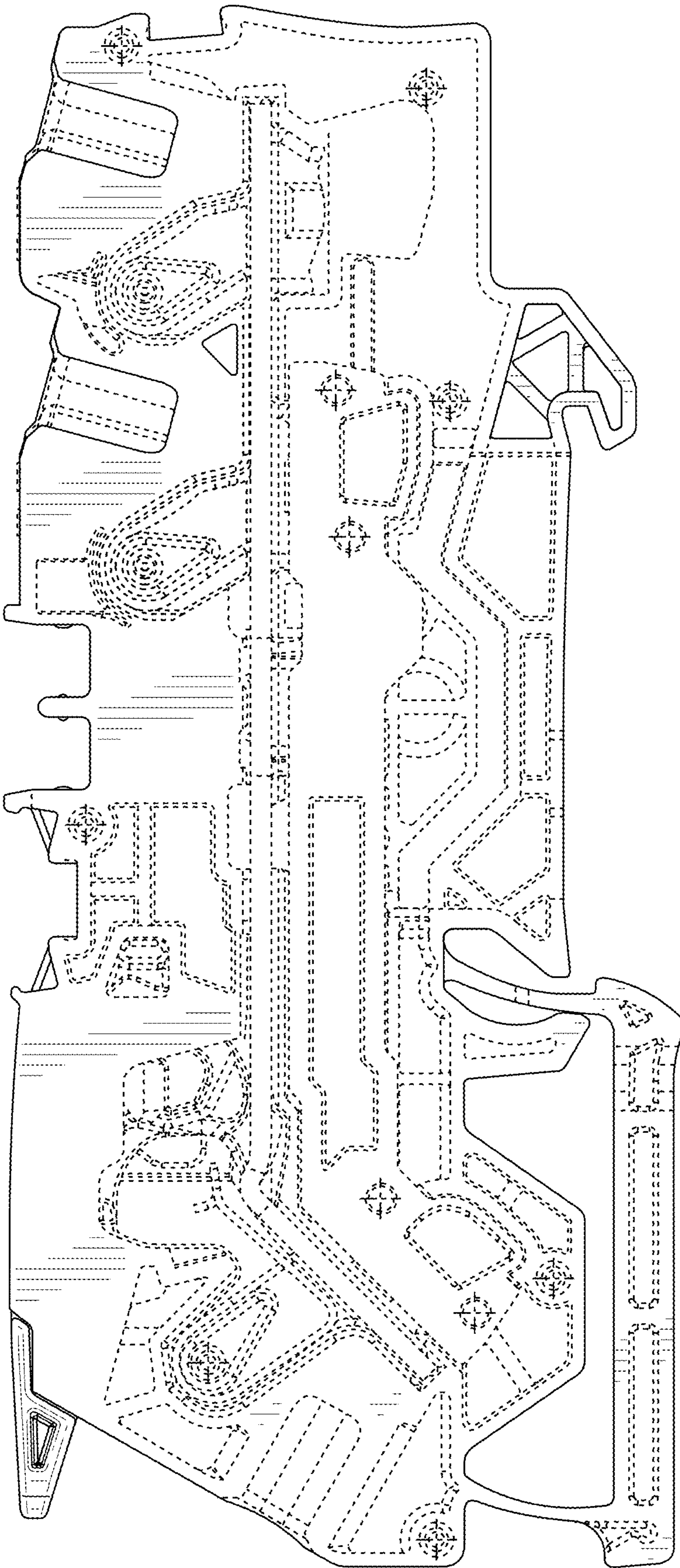

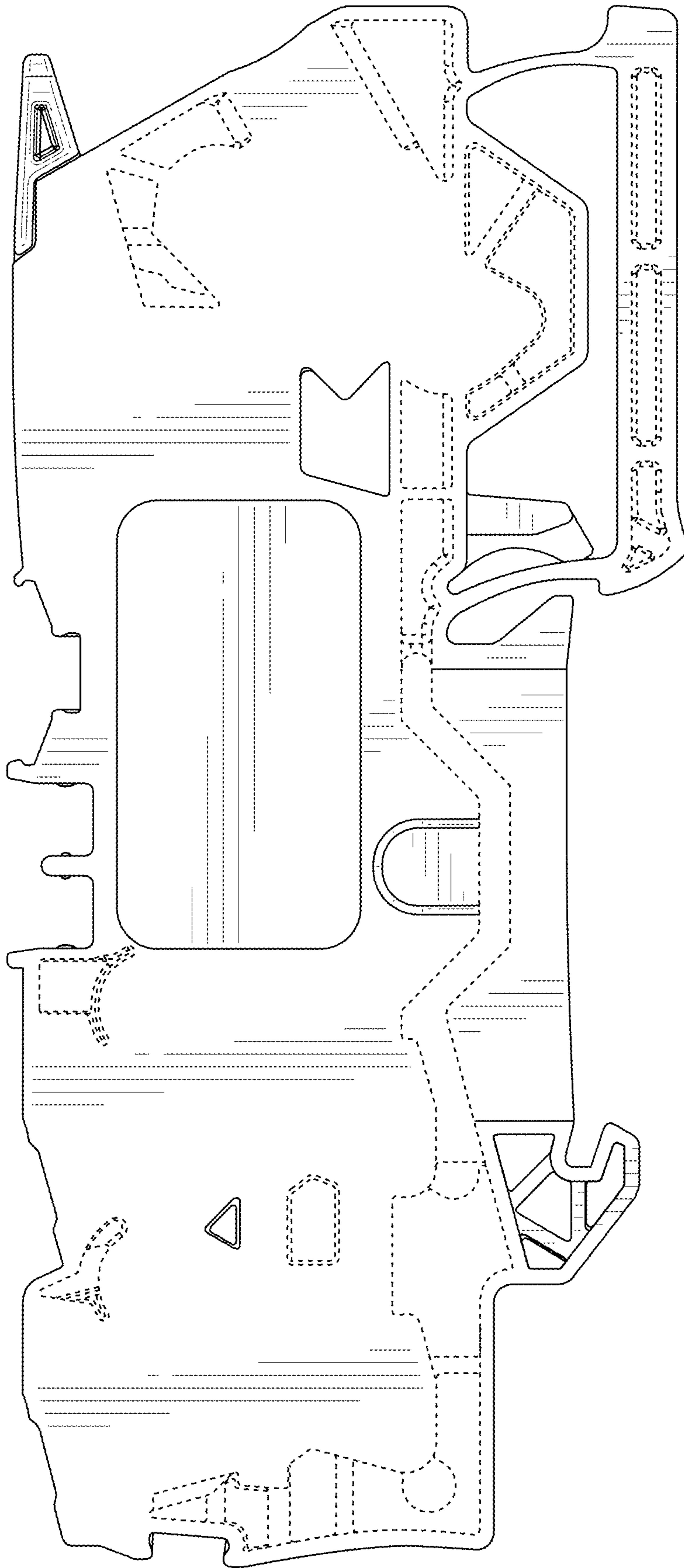

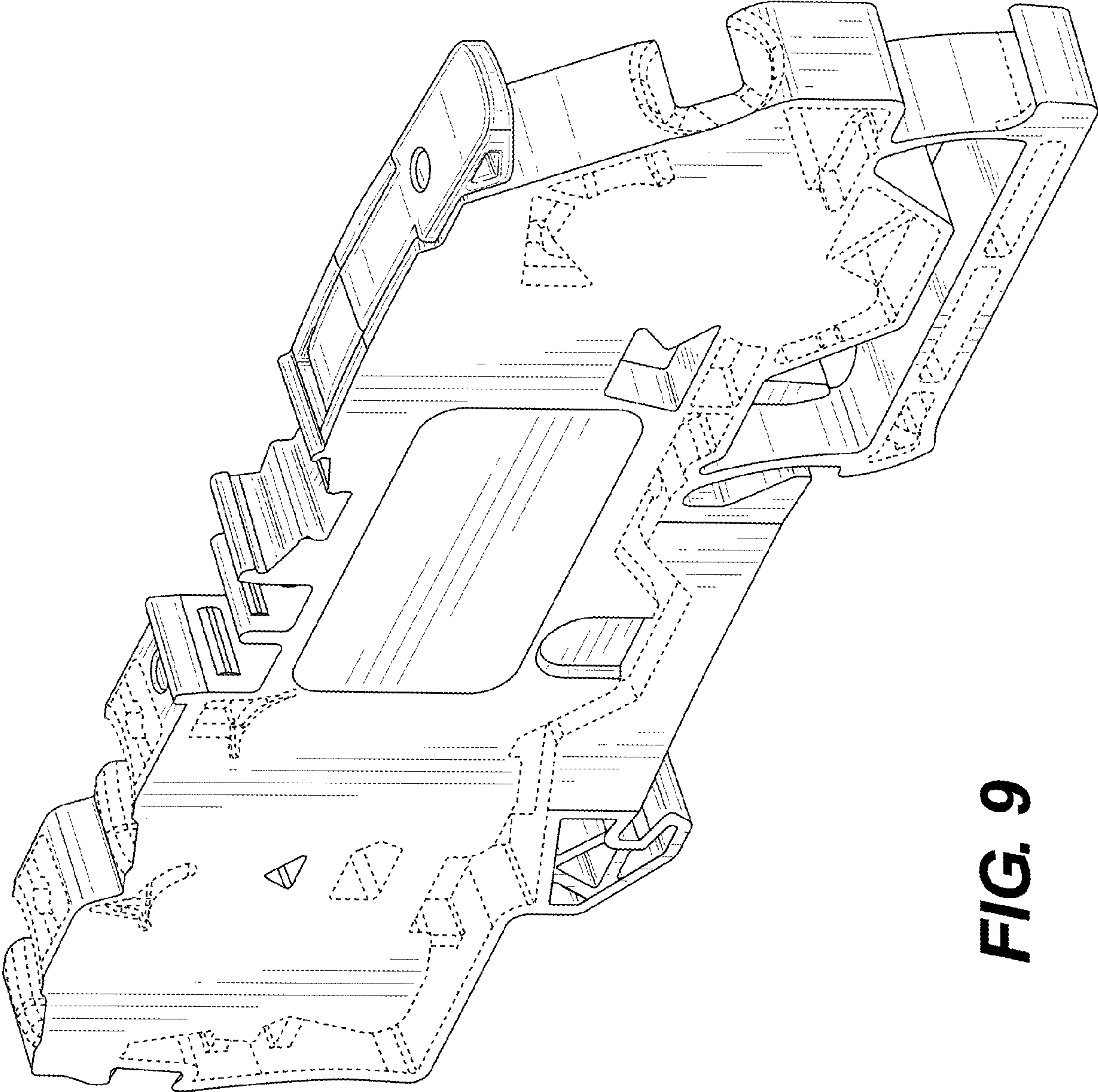

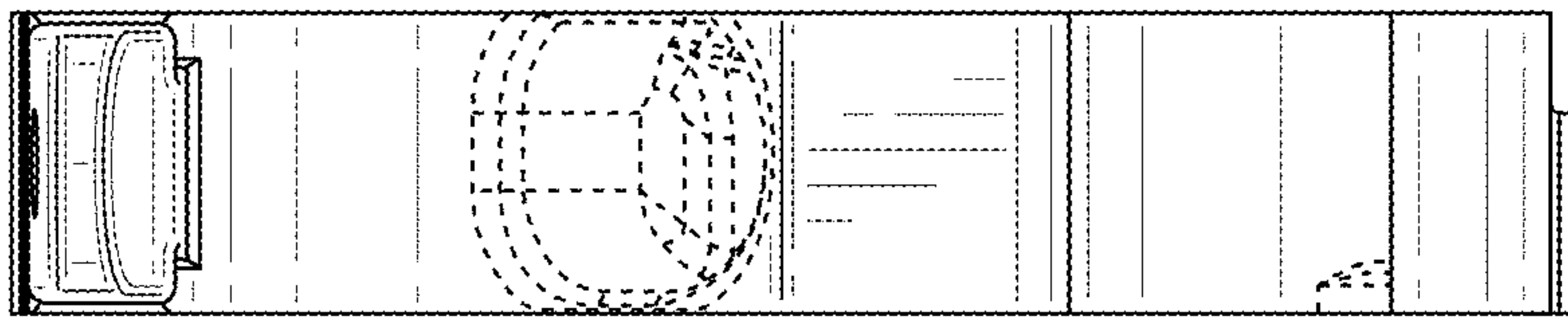

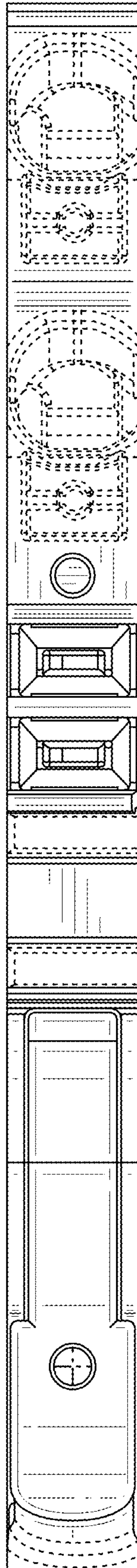

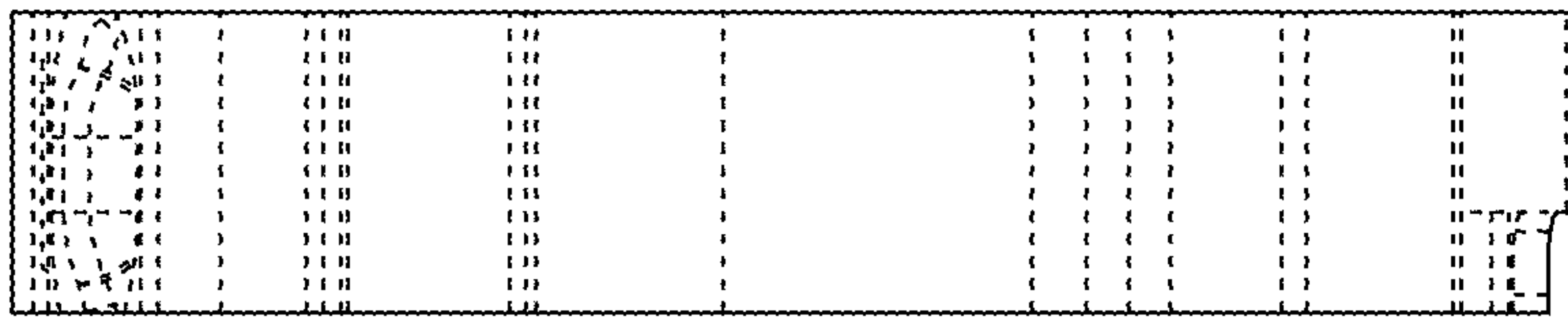

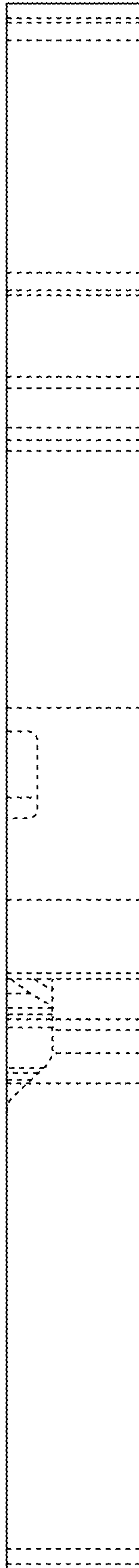

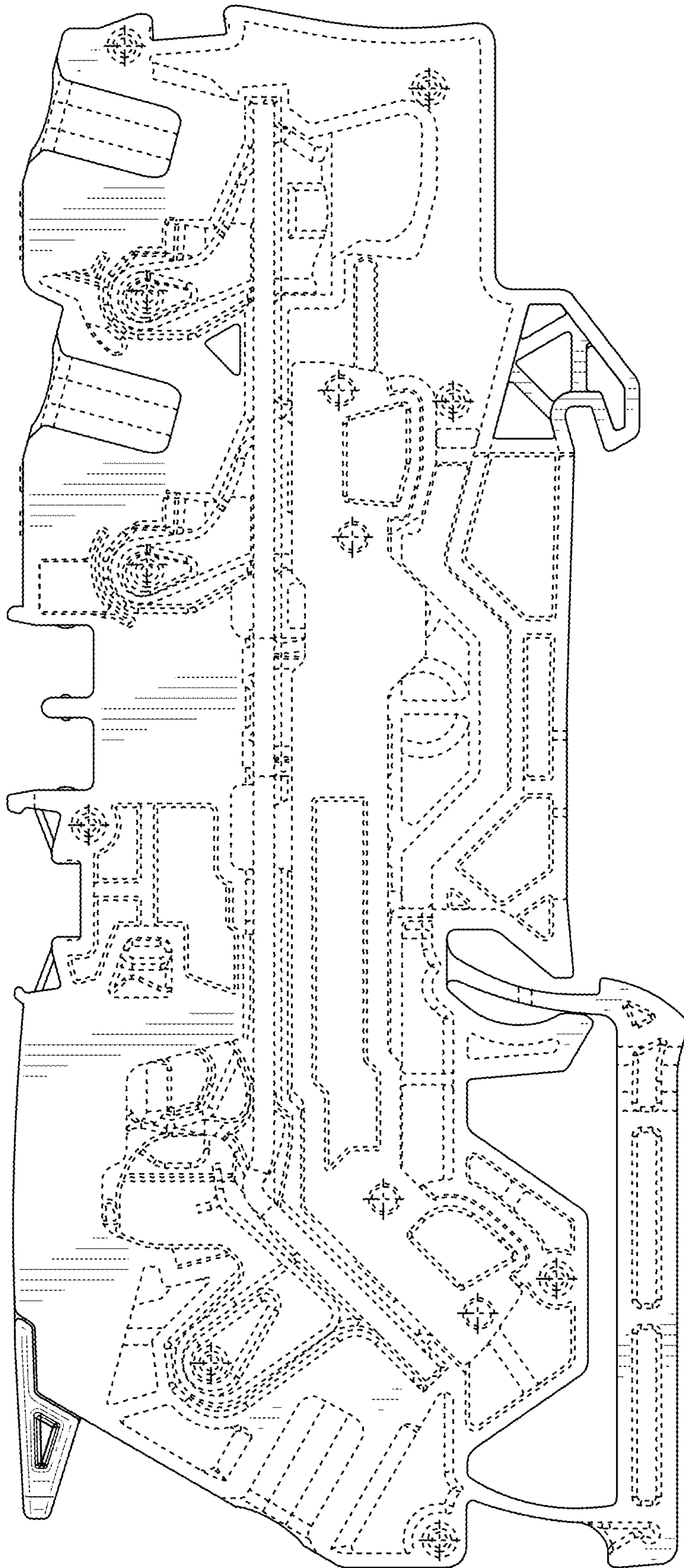
