(57) **CLAIM**

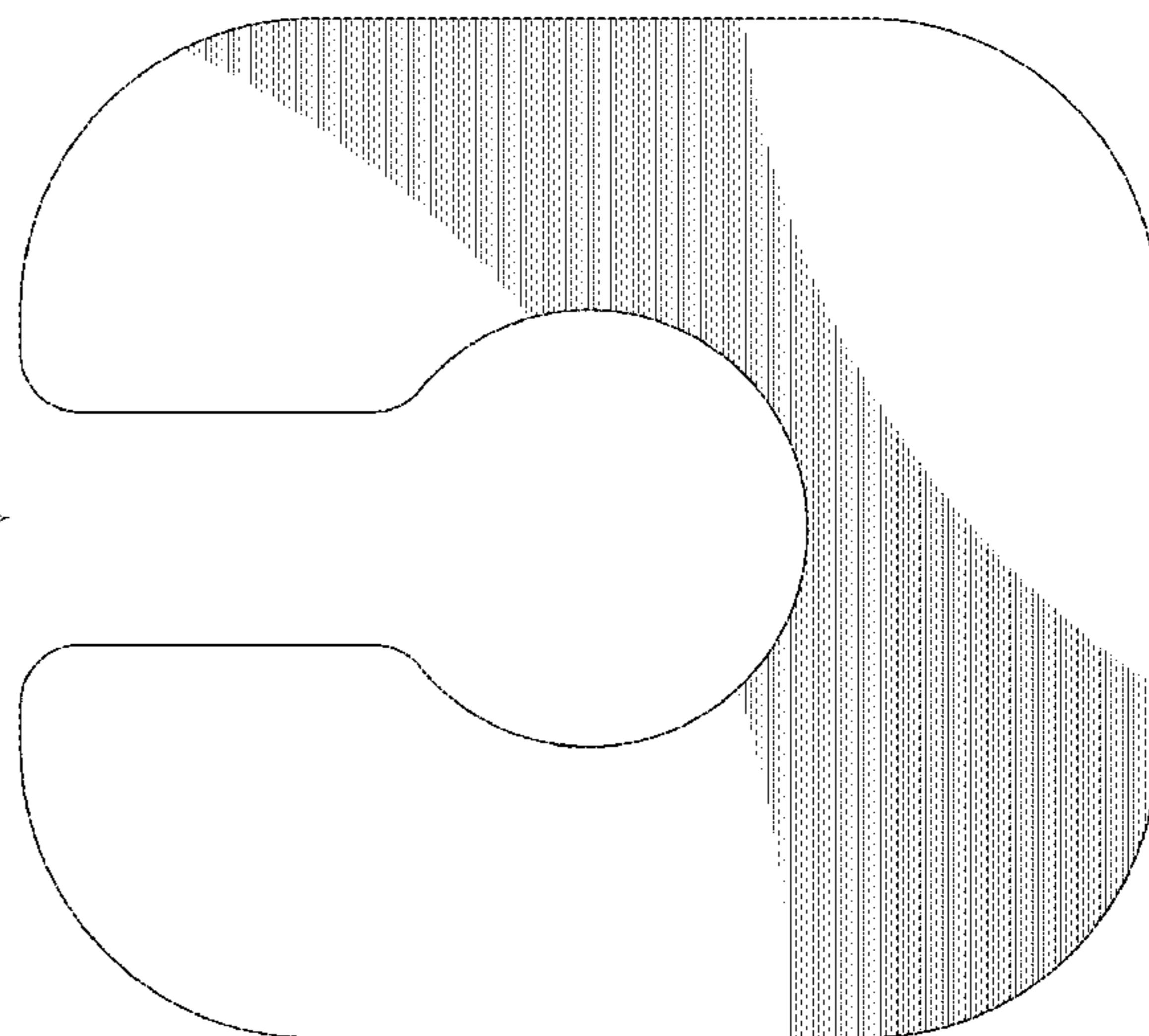
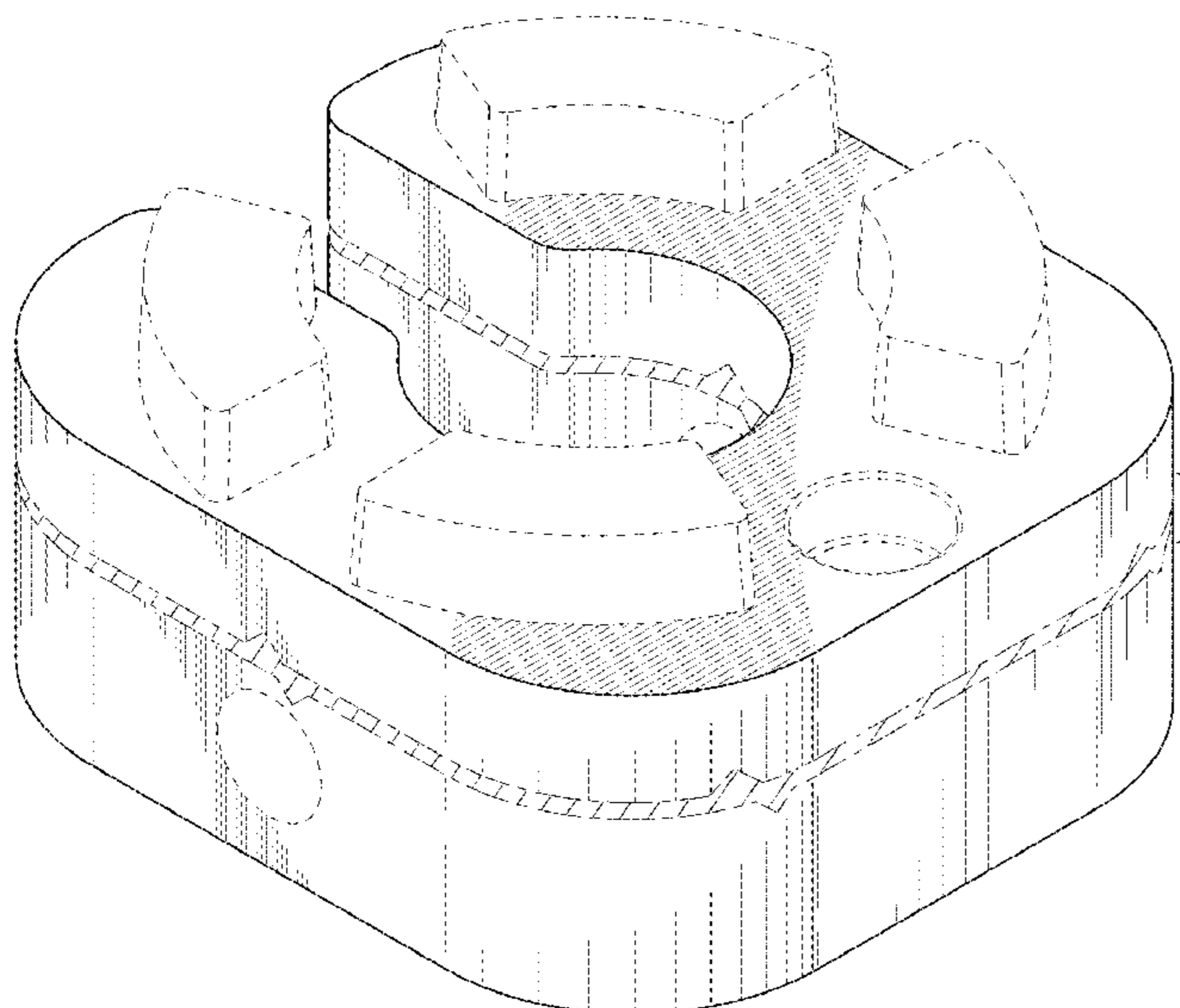
The ornamental design for a restrictor block for a fan mount, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a restrictor block for a fan mount showing our new design; FIG. 2 is a bottom perspective view of the restrictor block; FIG. 3 is a front view of the restrictor block; FIG. 4 is a right side view of the restrictor block; FIG. 5 is a rear view of the restrictor block; FIG. 6 is a left side view of the restrictor block; FIG. 7 is a top view of the restrictor block; and, FIG. 8 is a bottom view of the restrictor block.

The restrictor block for a fan mount is shown with a symbolic break in its height. The appearance of any portion of the article between the break lines forms no part of the claimed design. The broken dashed lines in the drawings depict portions of the restrictor block for a fan mount that form no part of the claim.

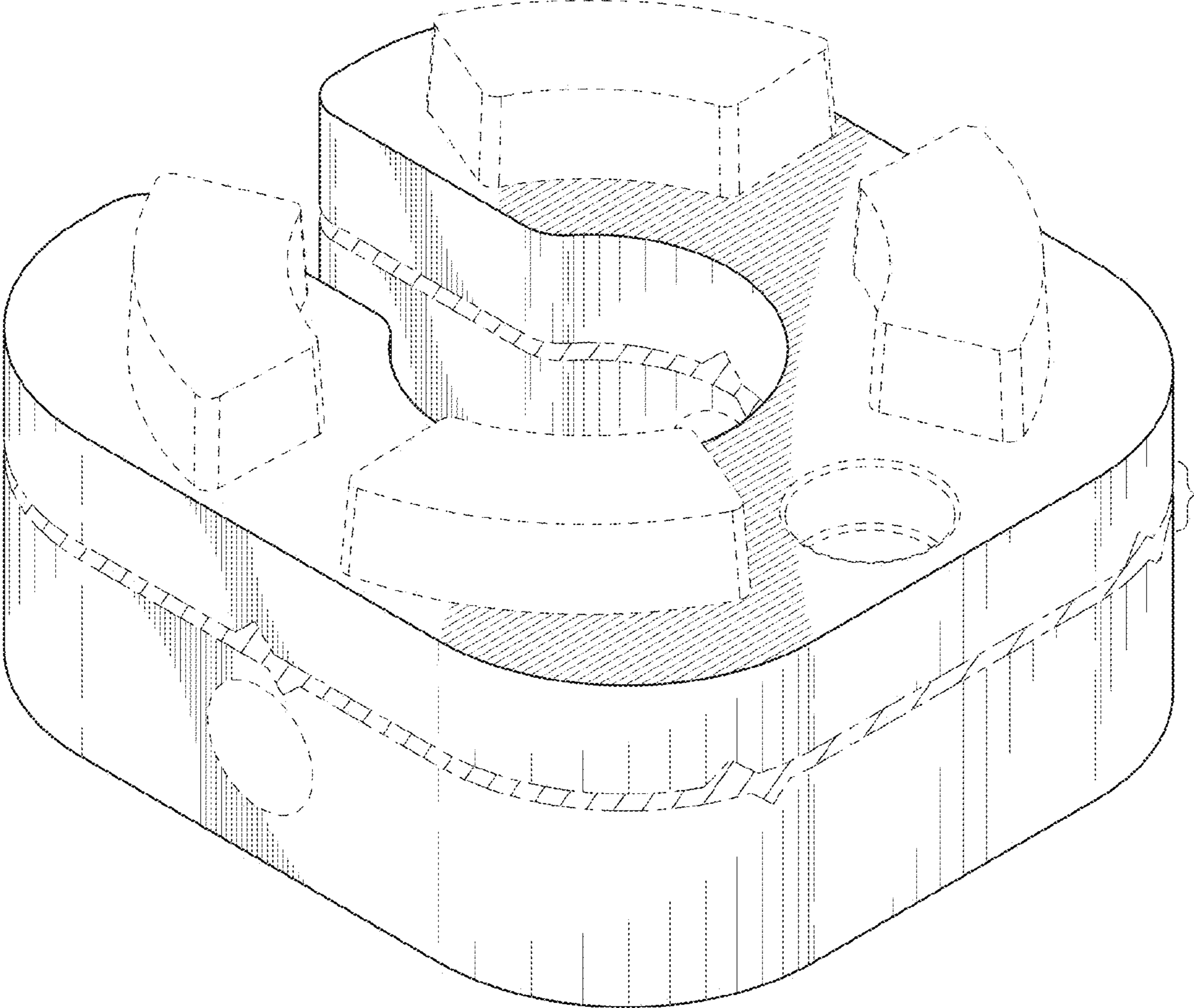

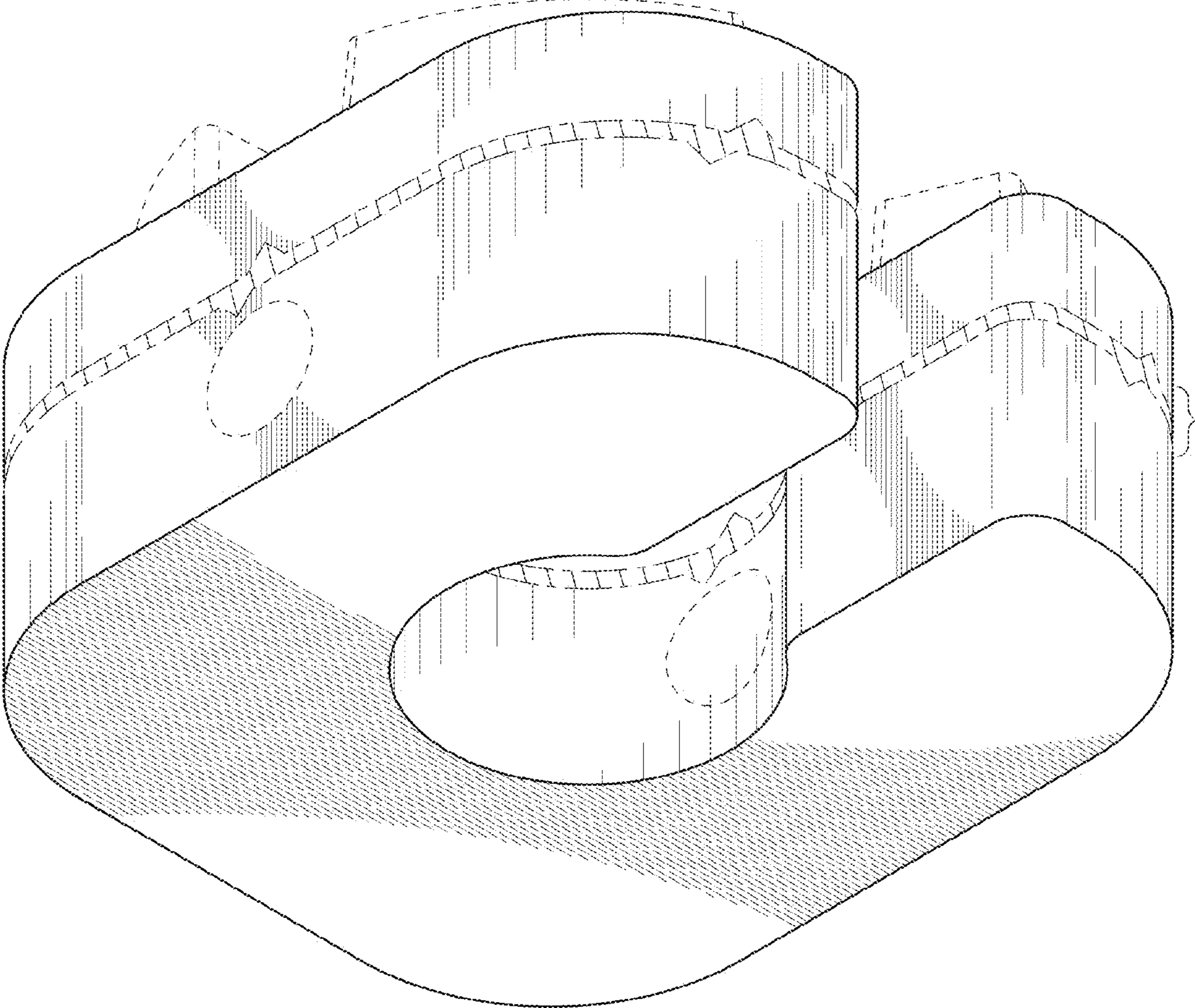

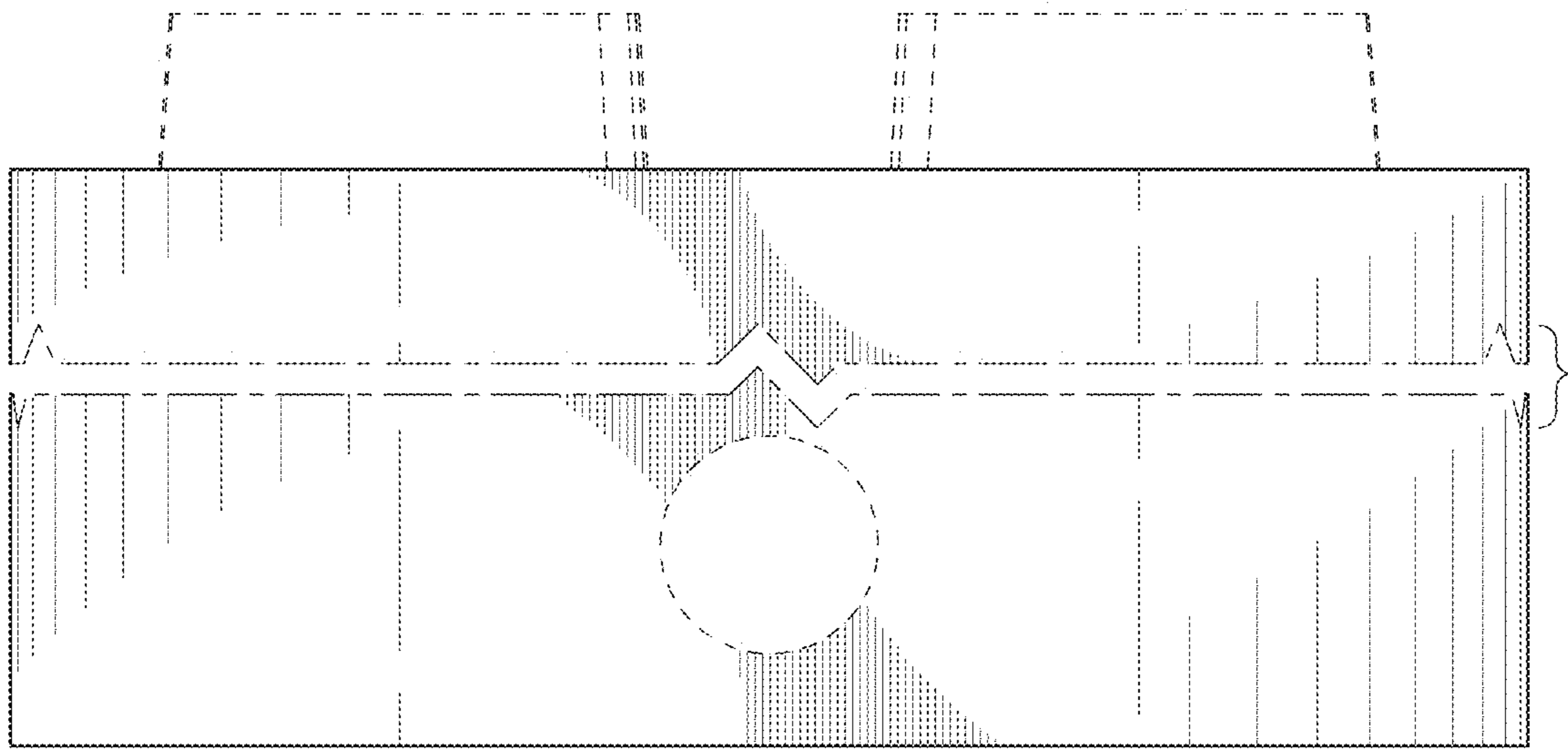

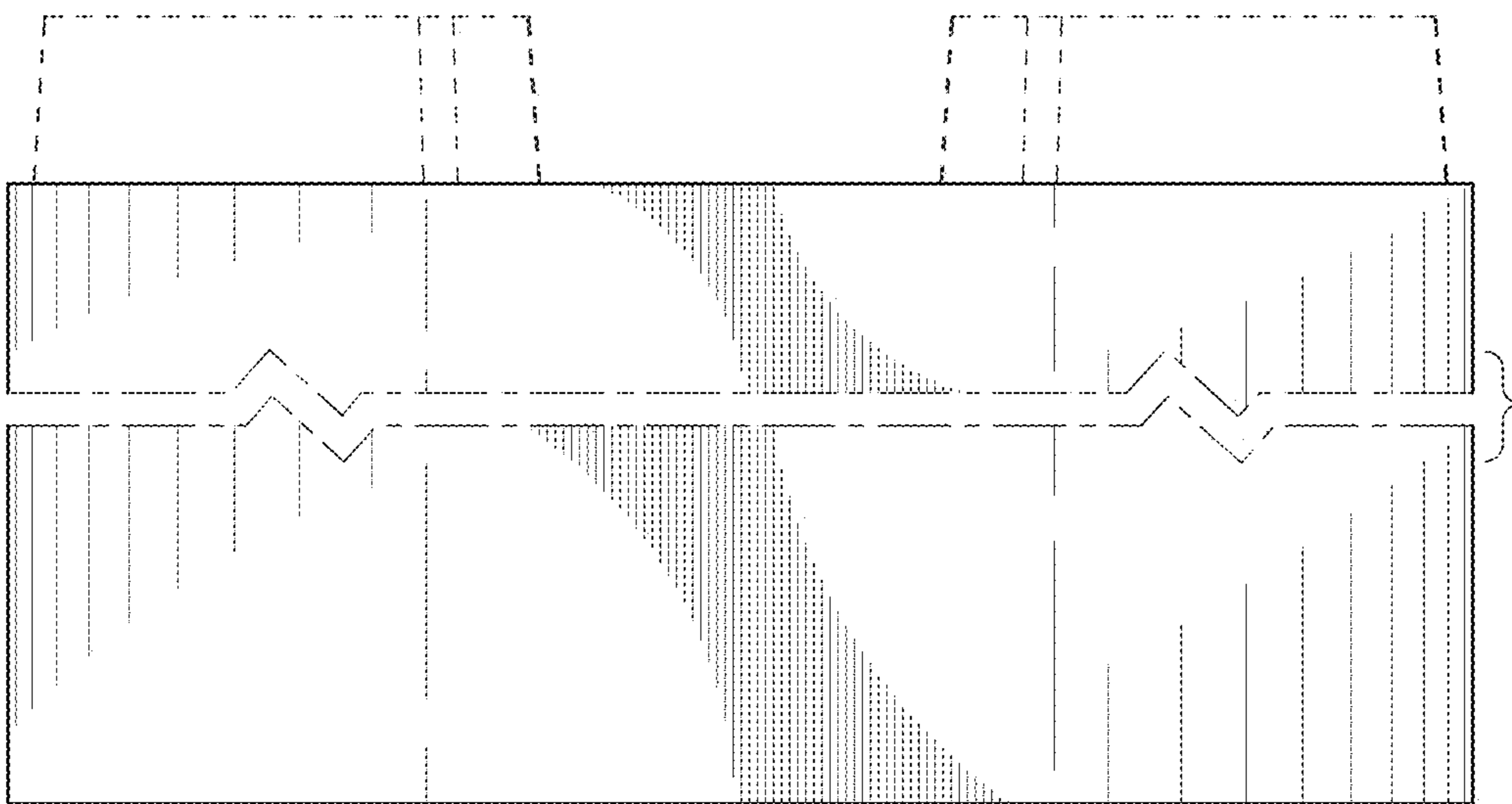

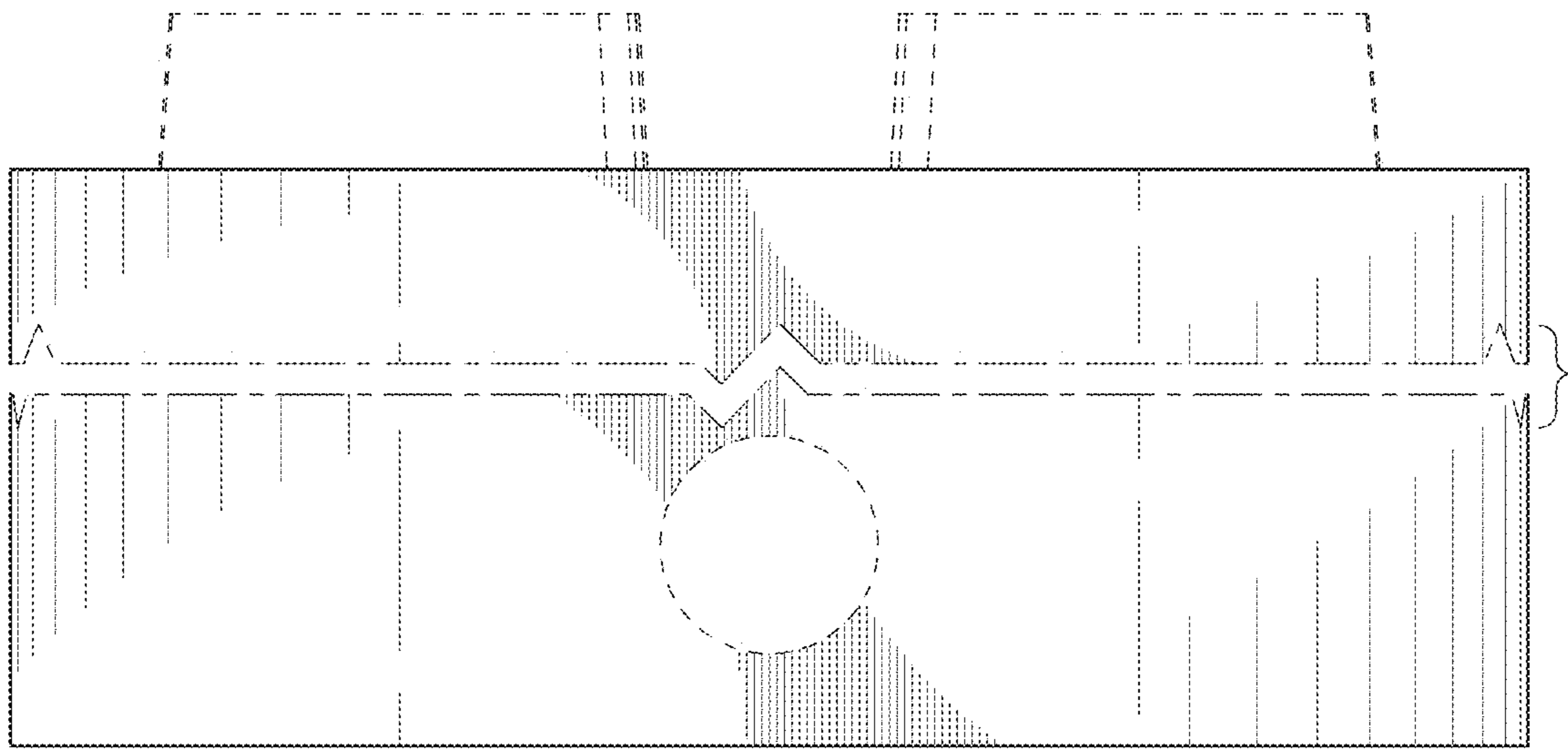

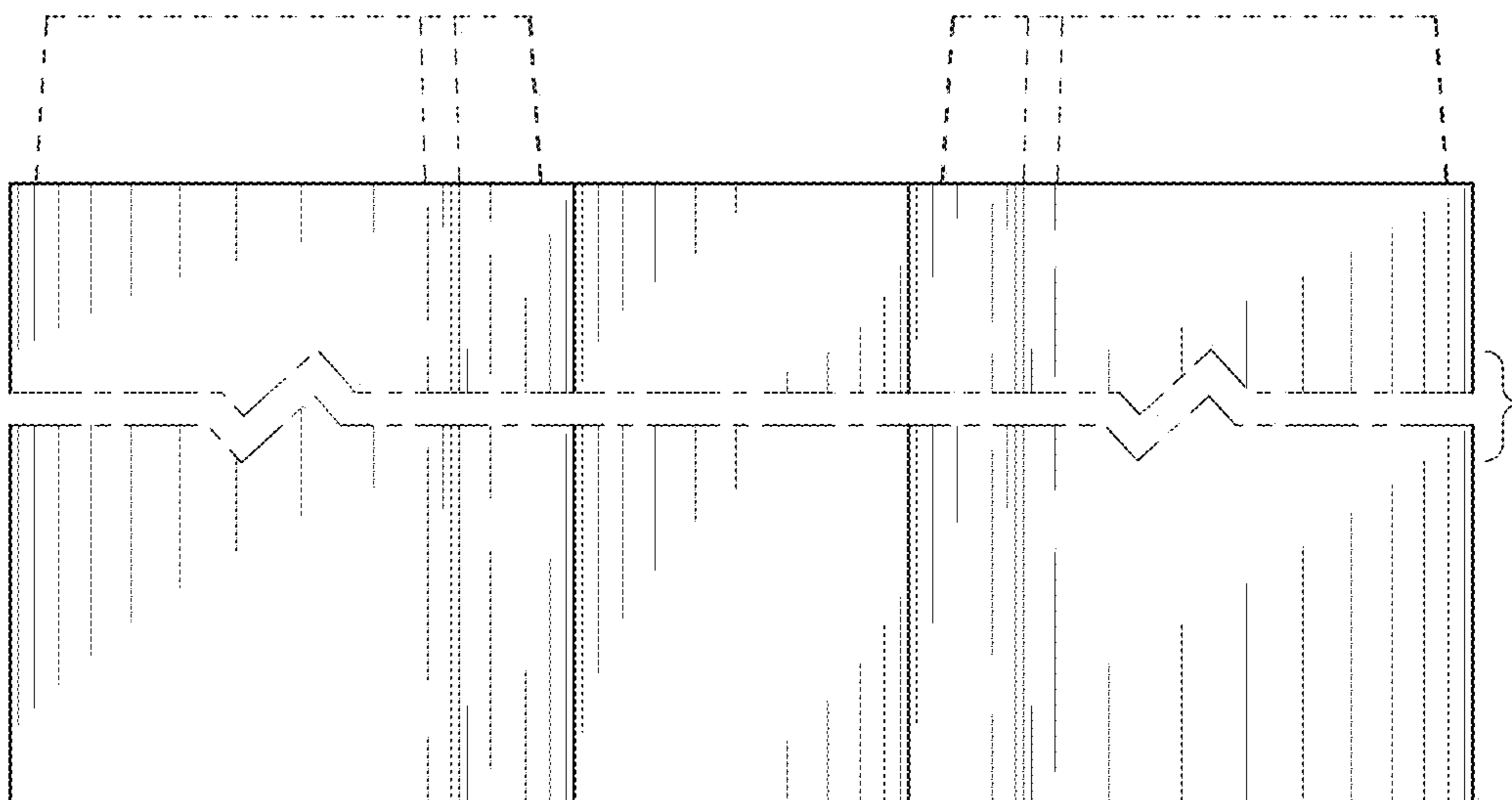

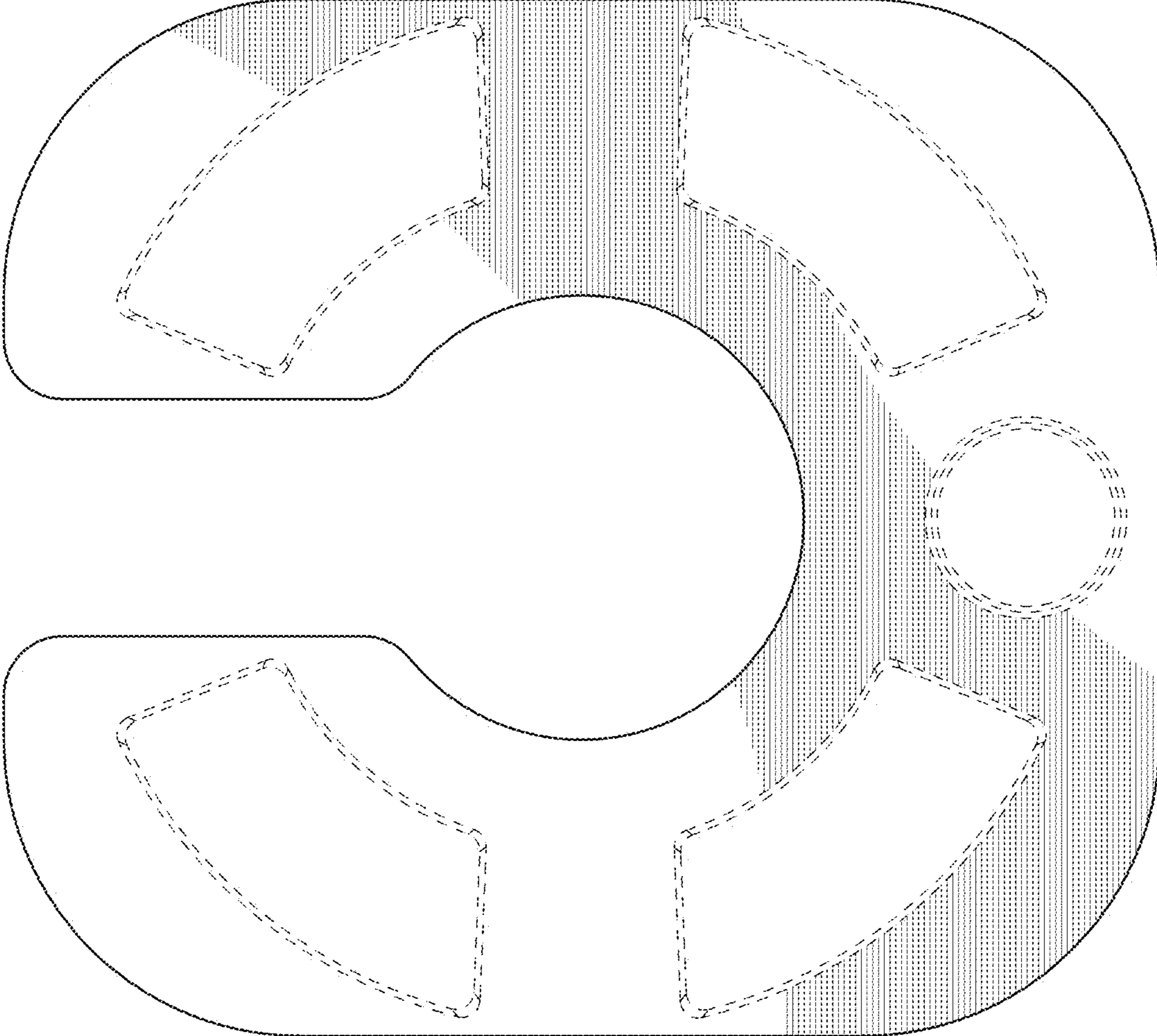

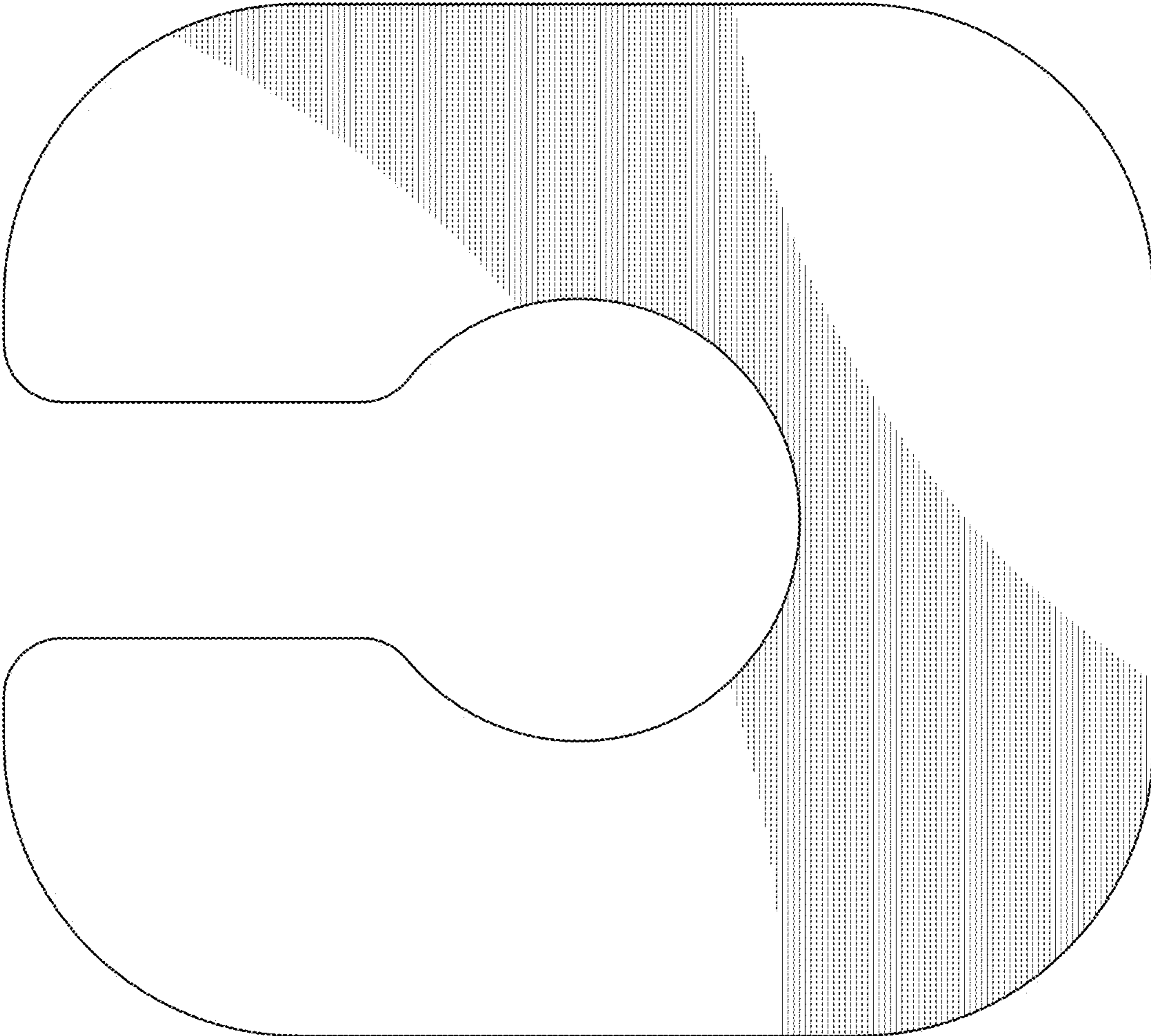
