DESCRIPTION

FIG. 9 is an elevation back view of the second embodiment of the manufactured home.

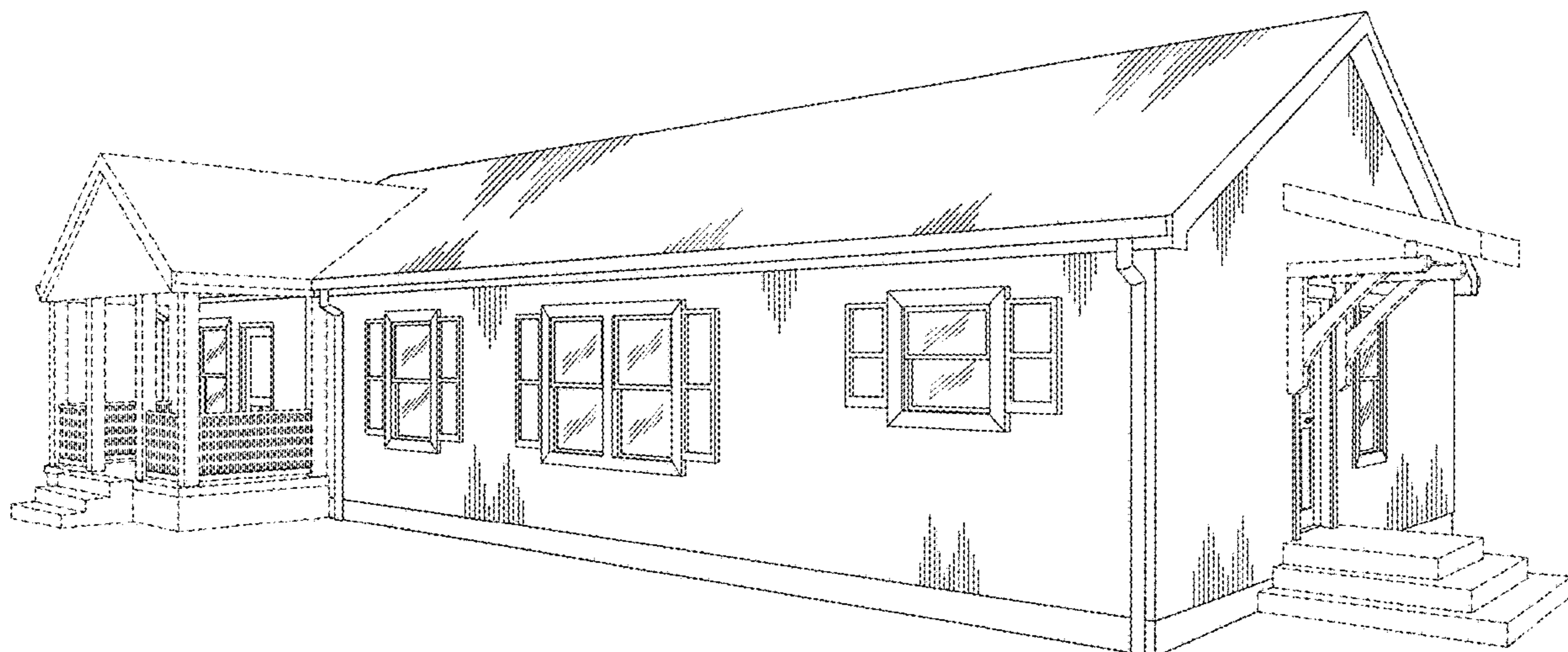
FIG. 10 a top plan view of the second embodiment of the manufactured home.

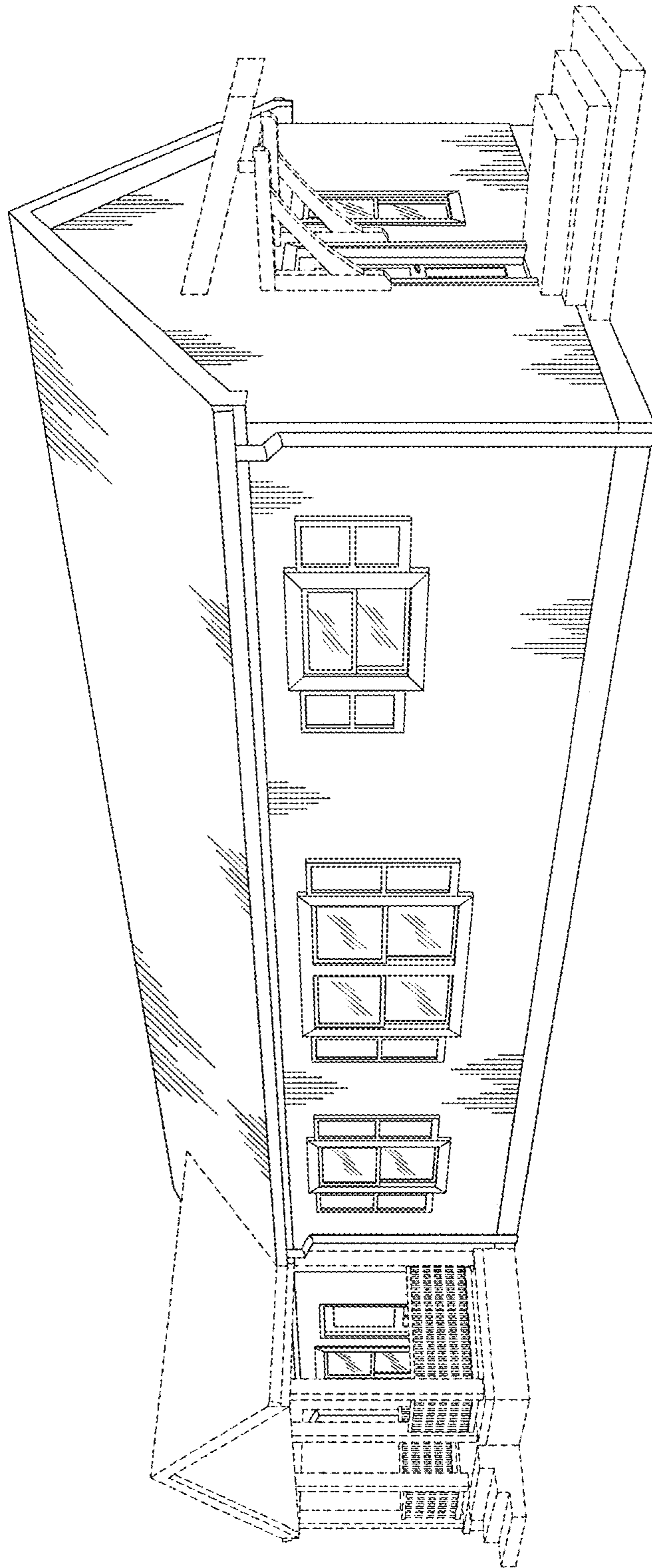

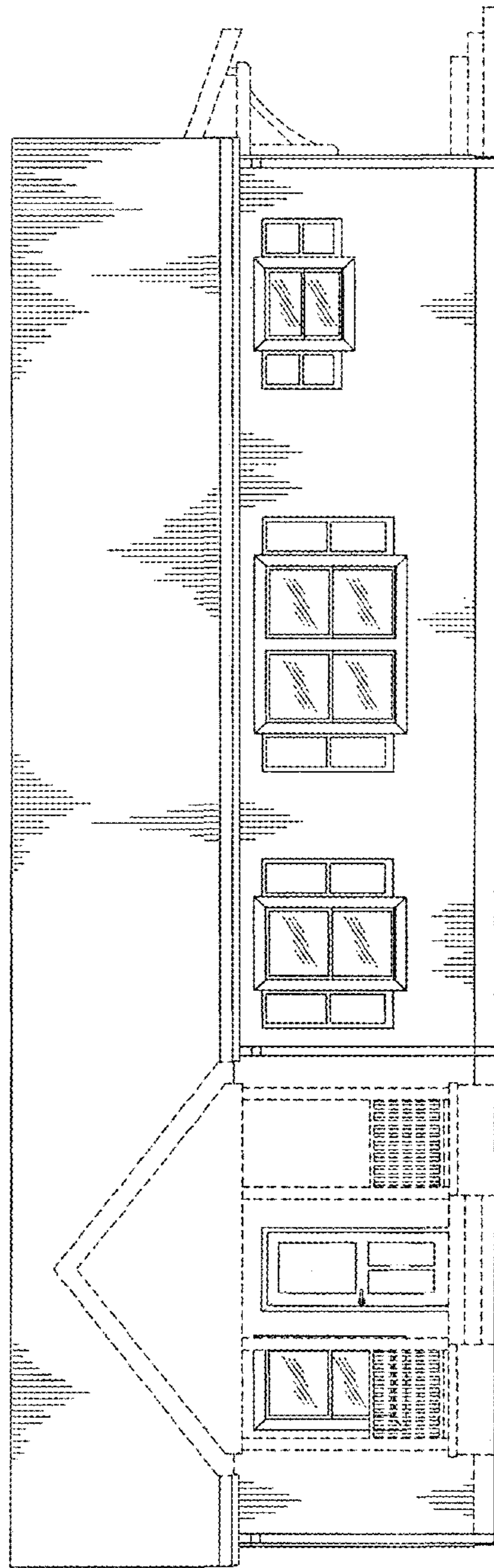

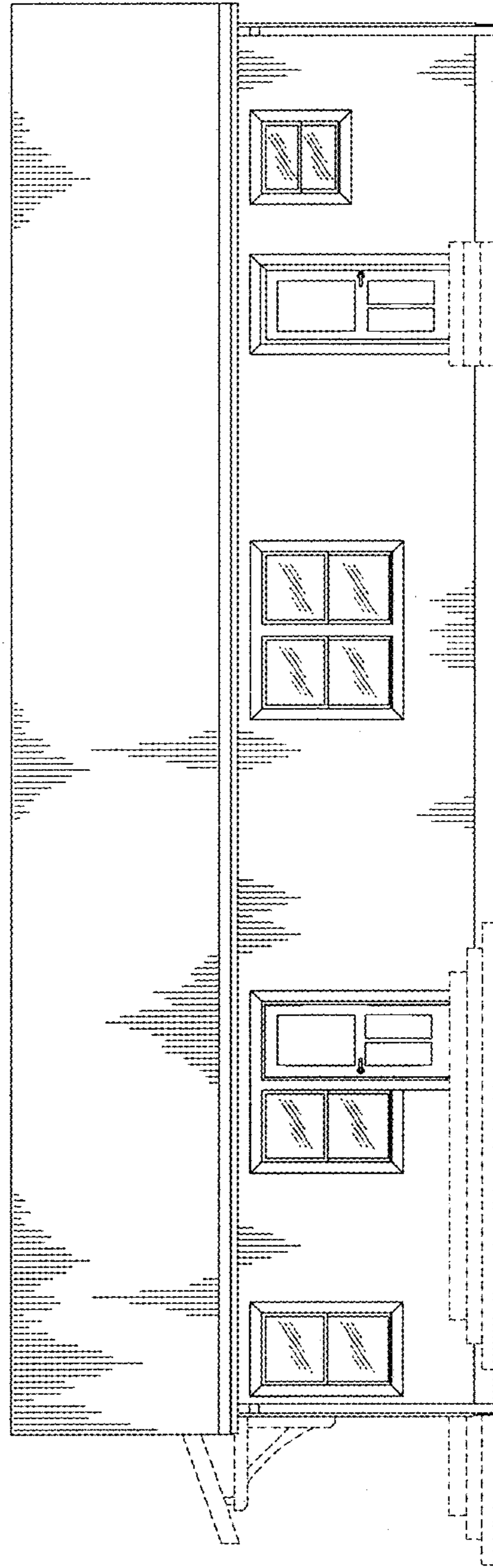

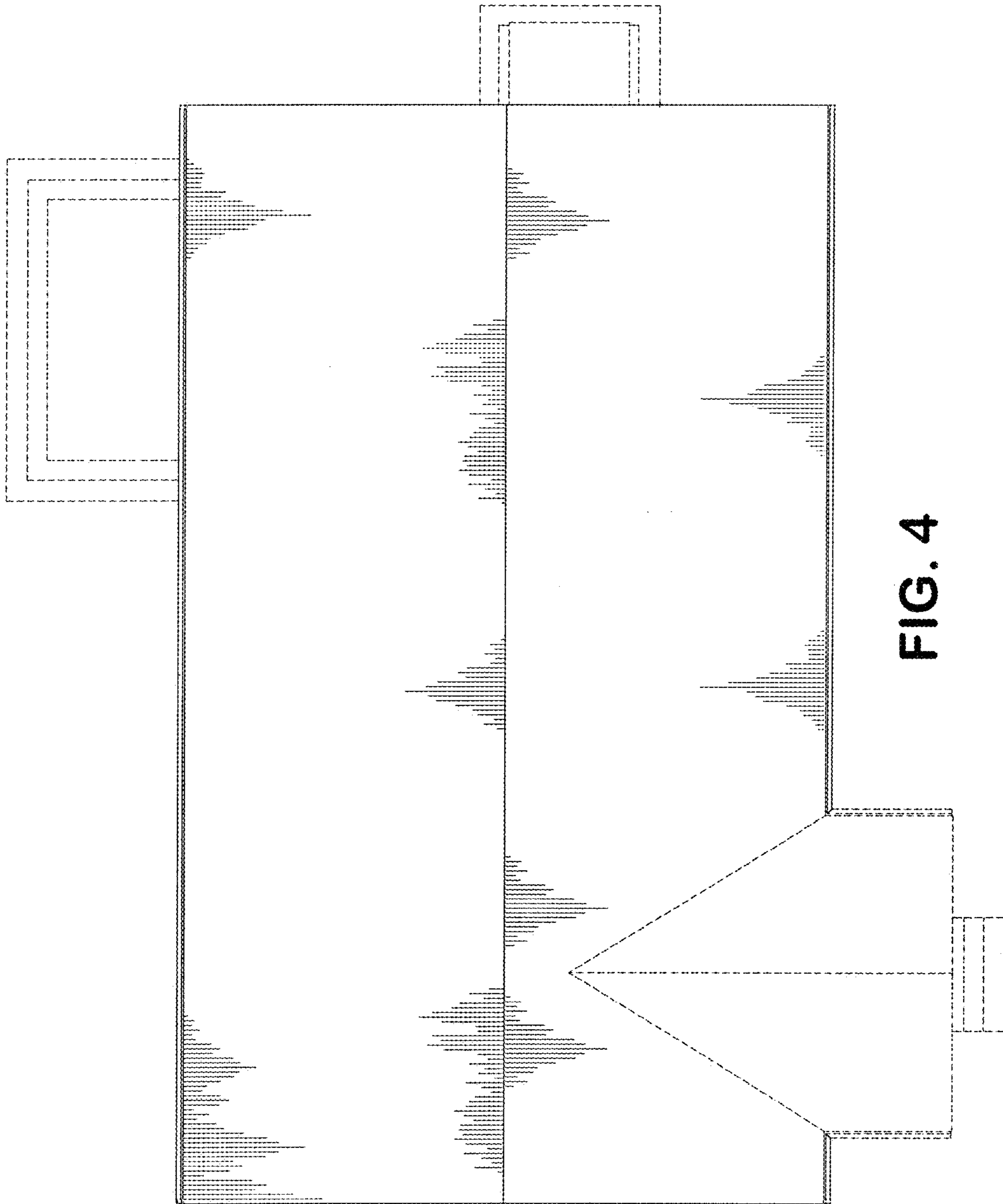

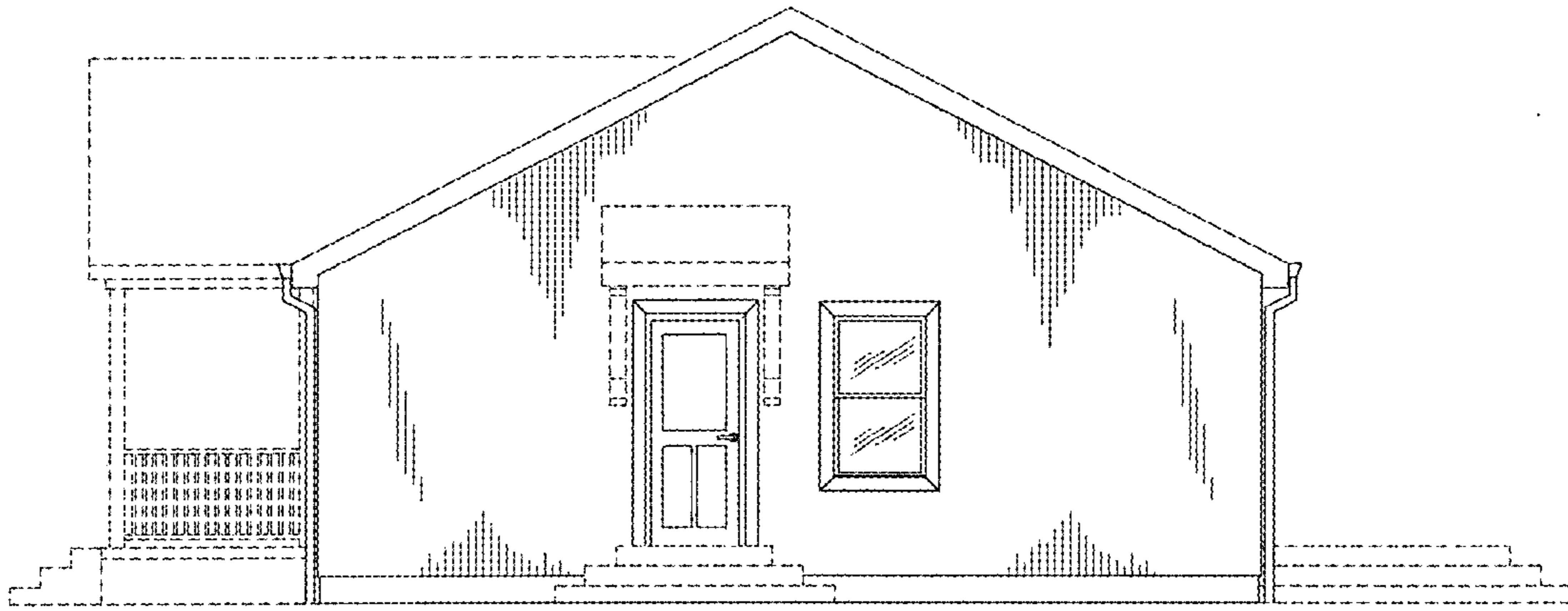

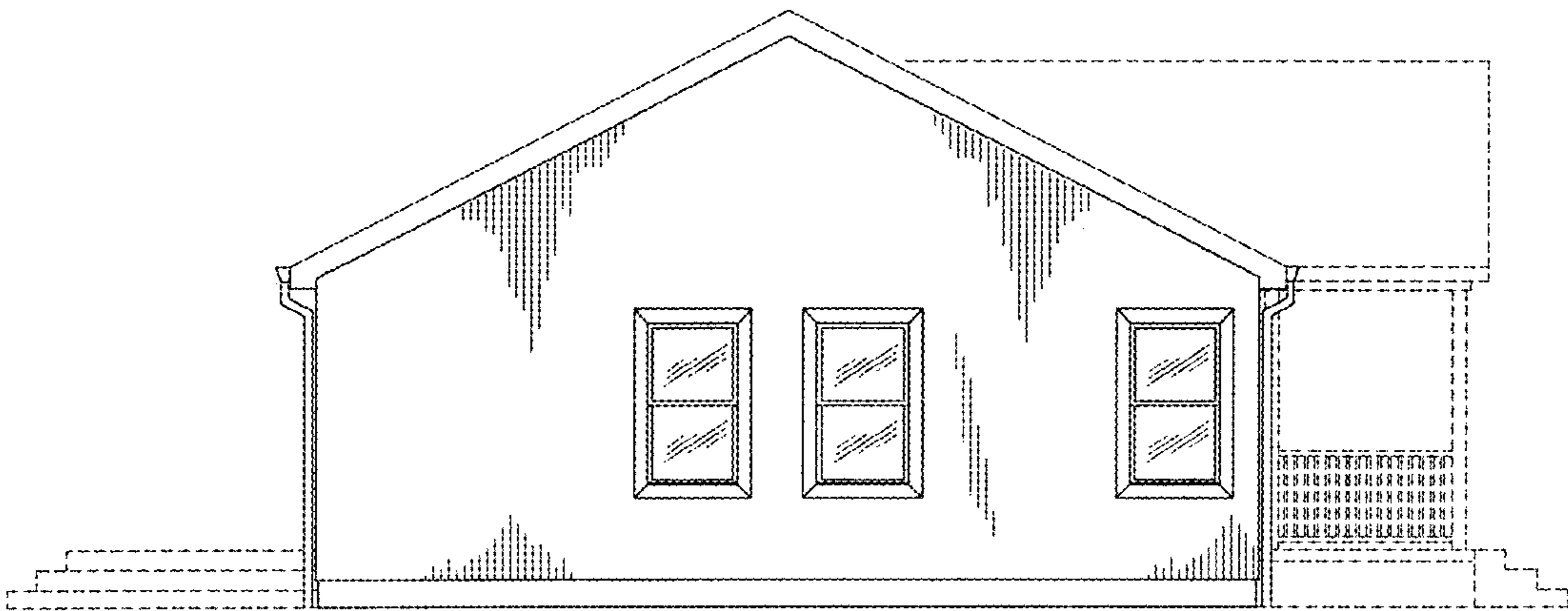

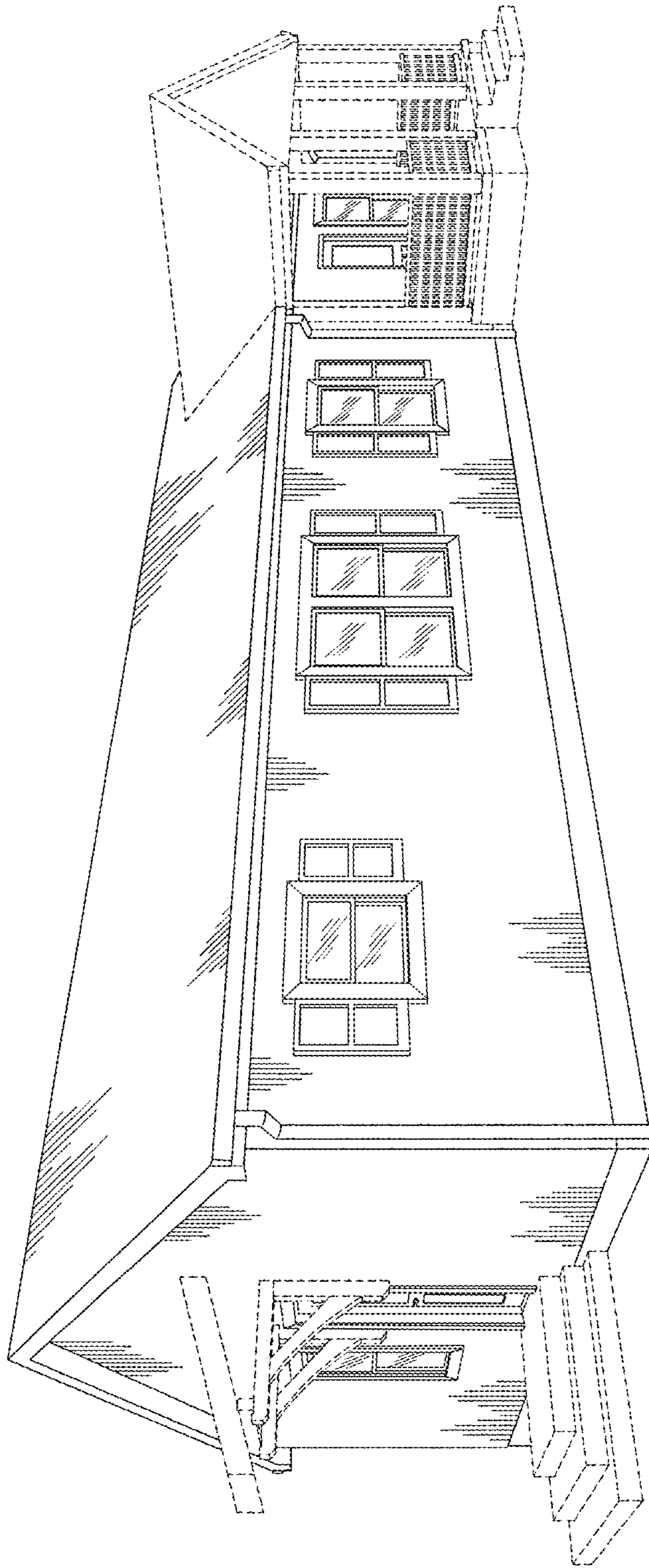

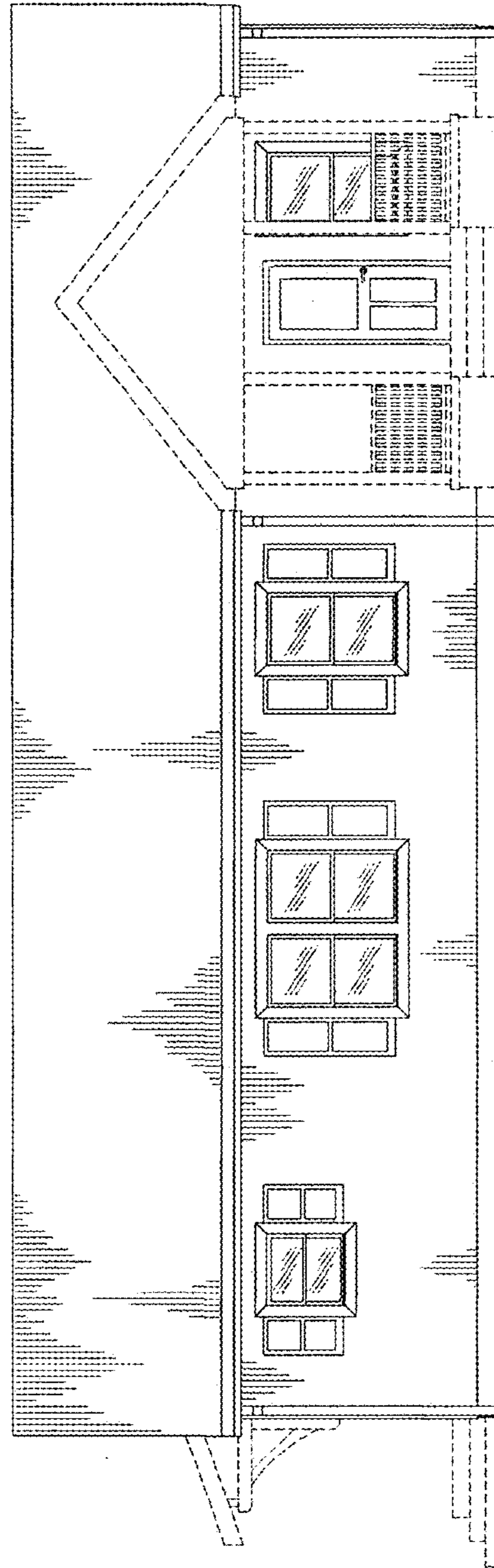

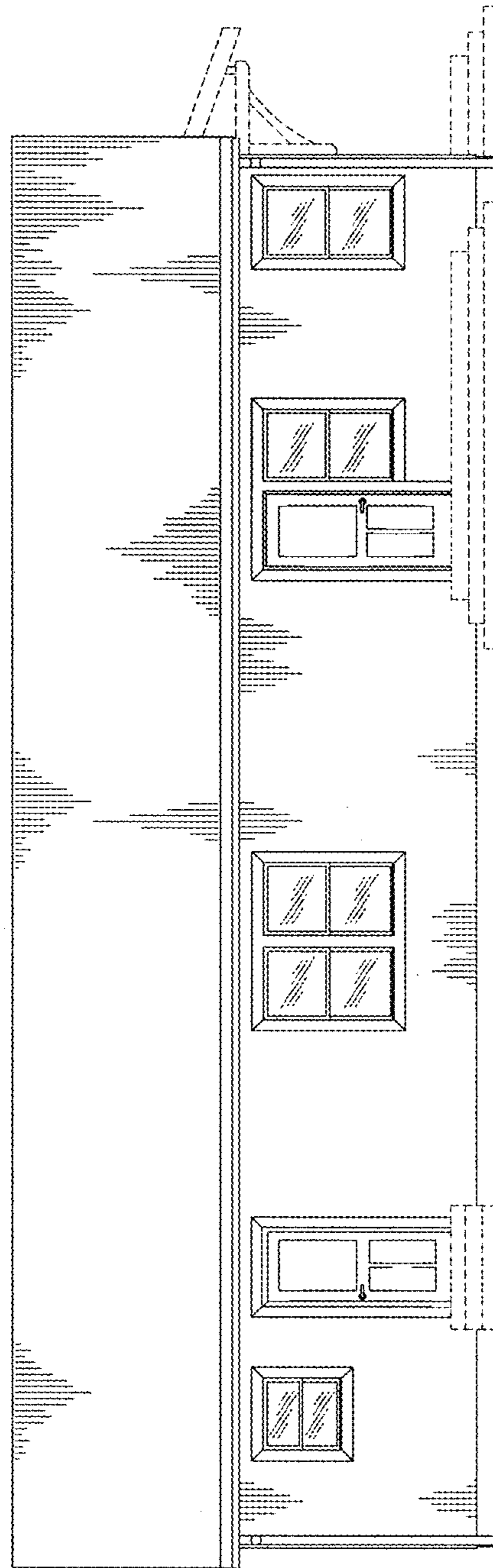

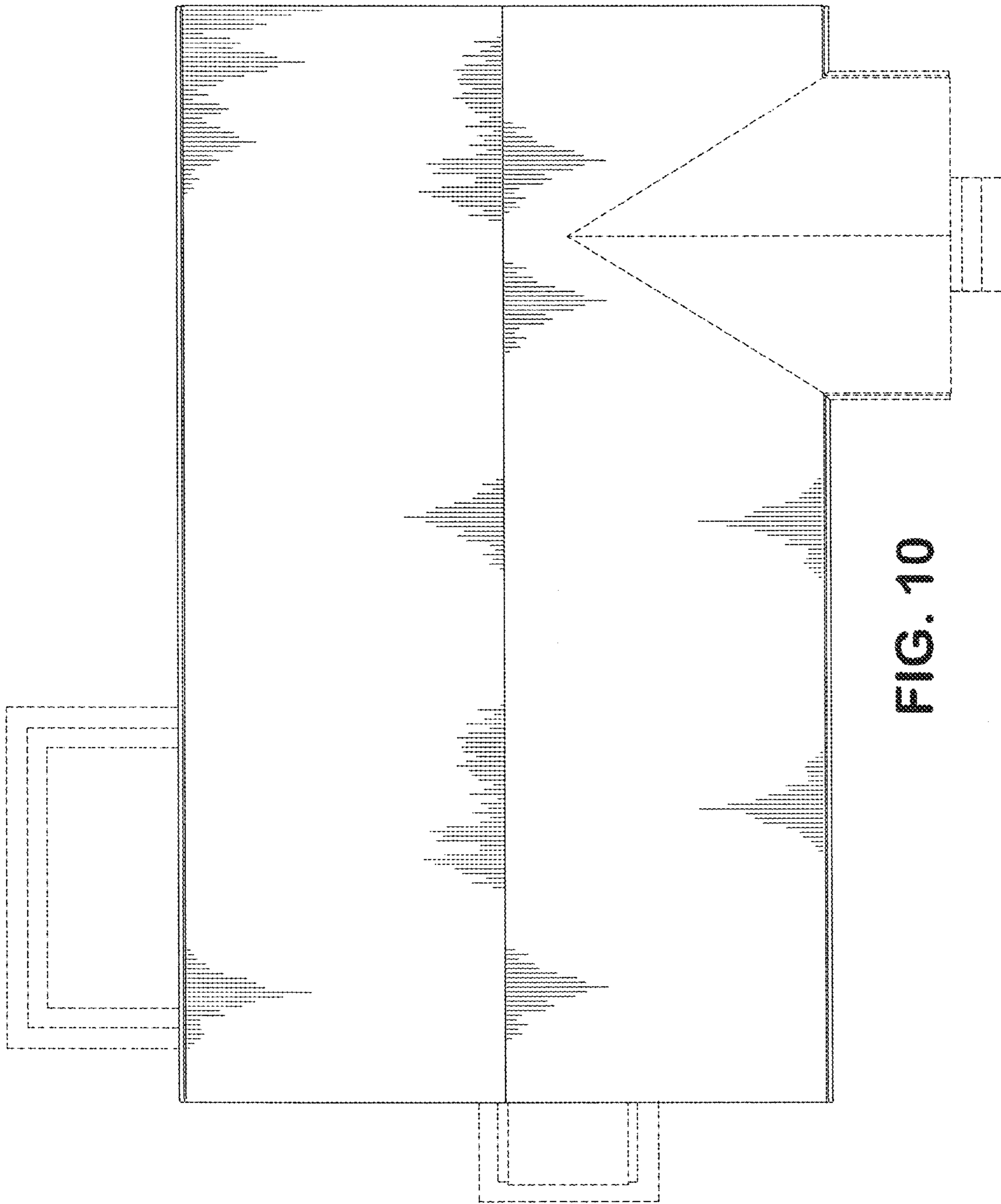

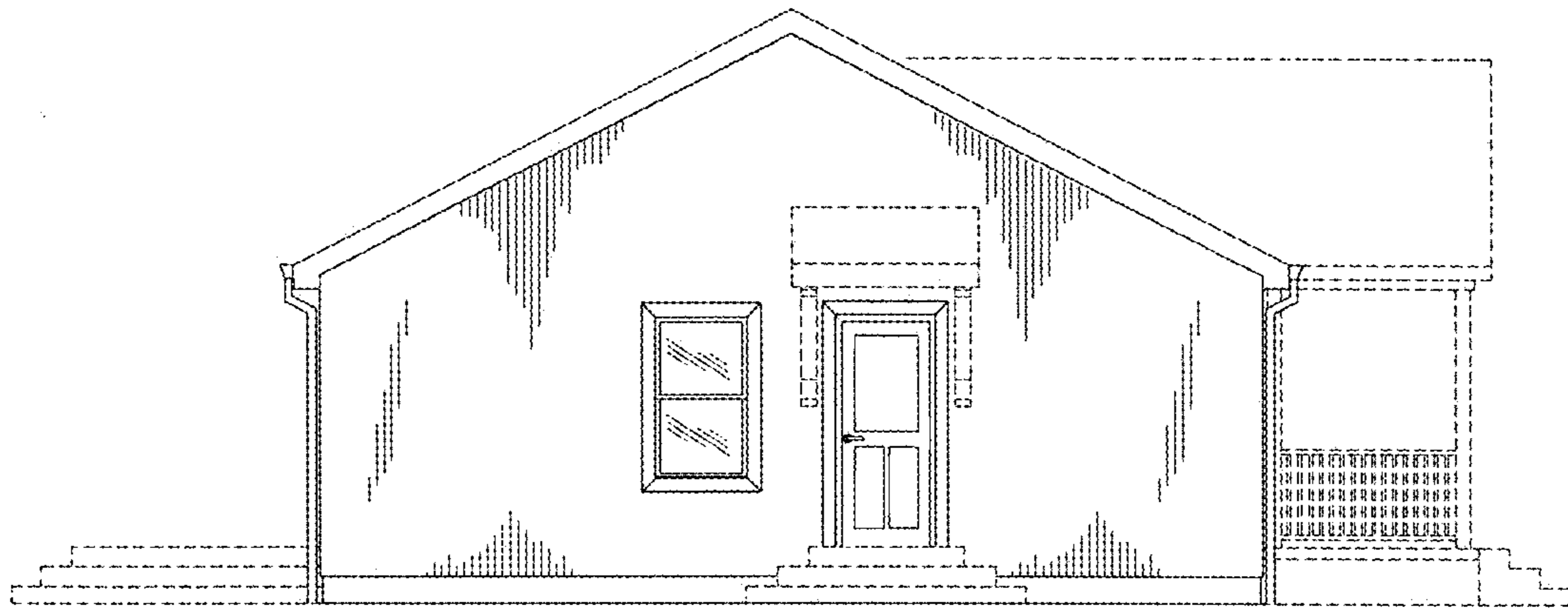

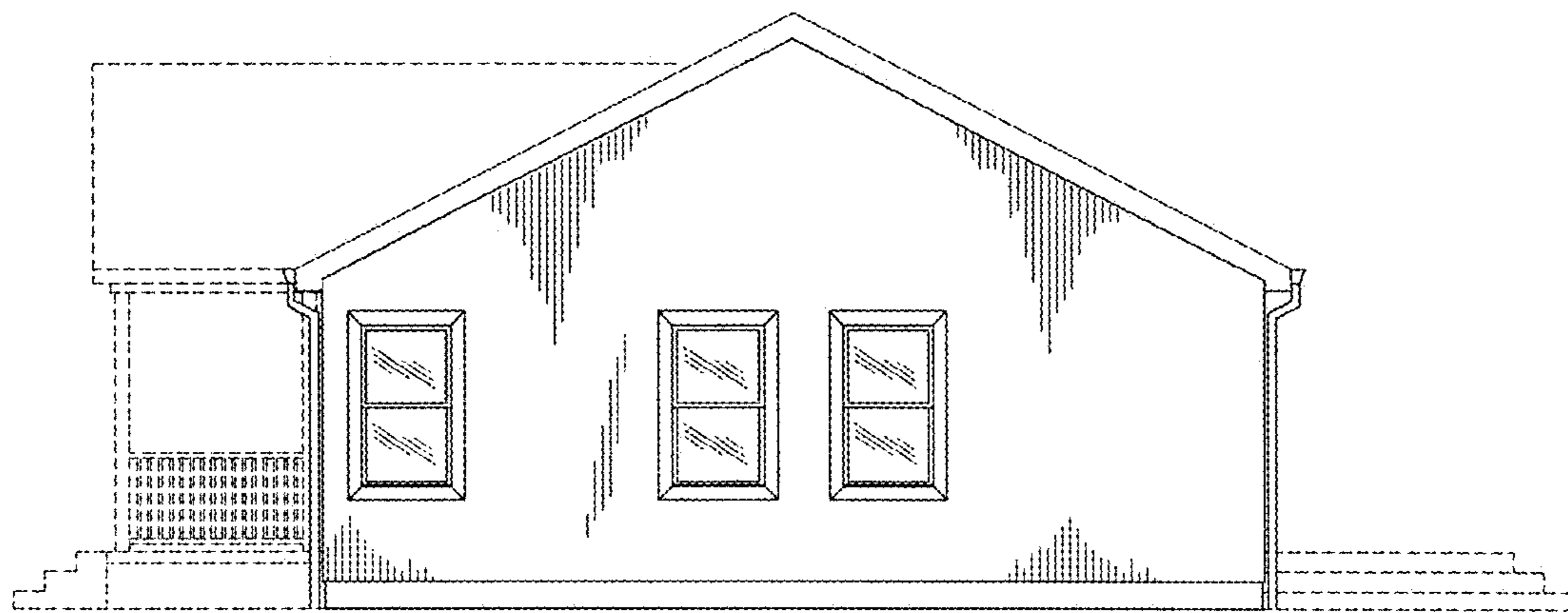
