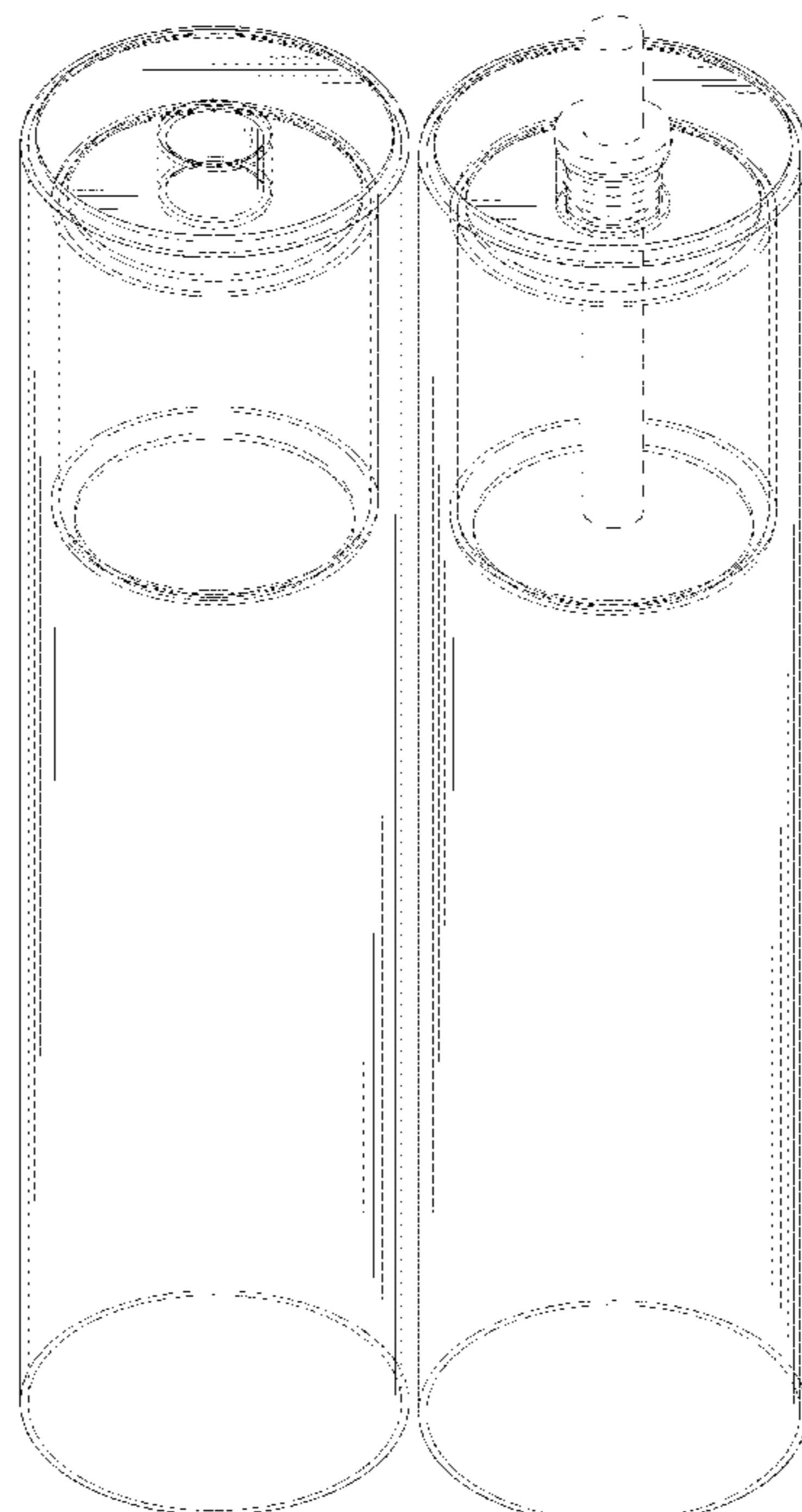
The ornamental design for a fuel container, as shown and described.

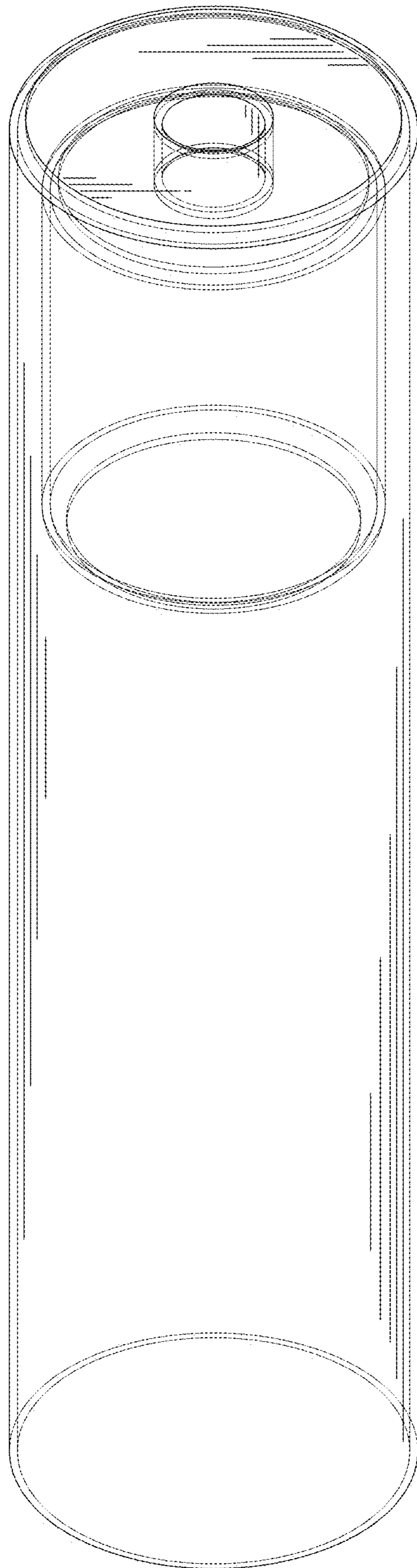

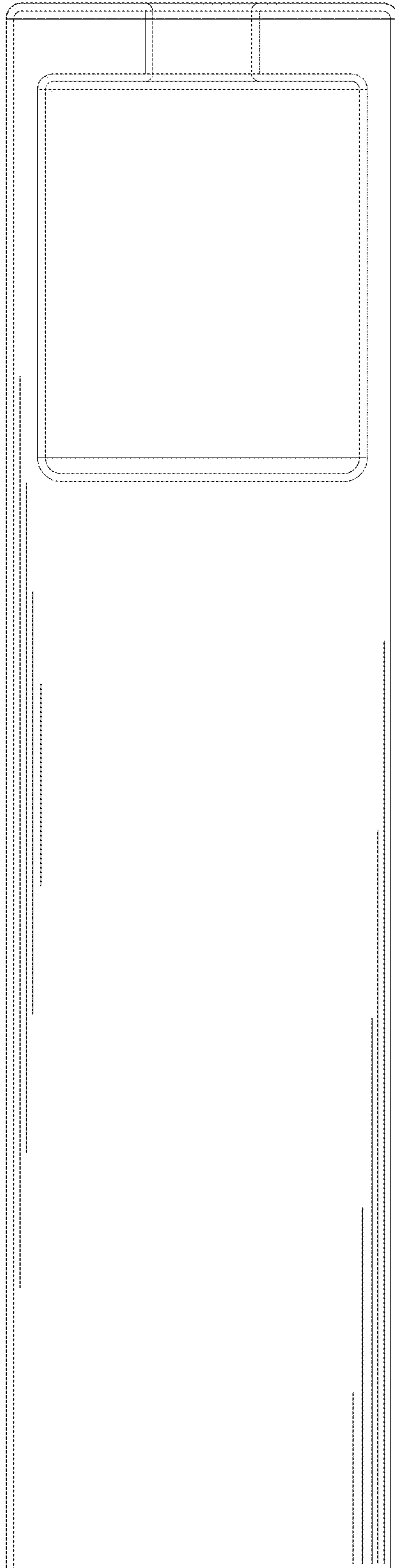

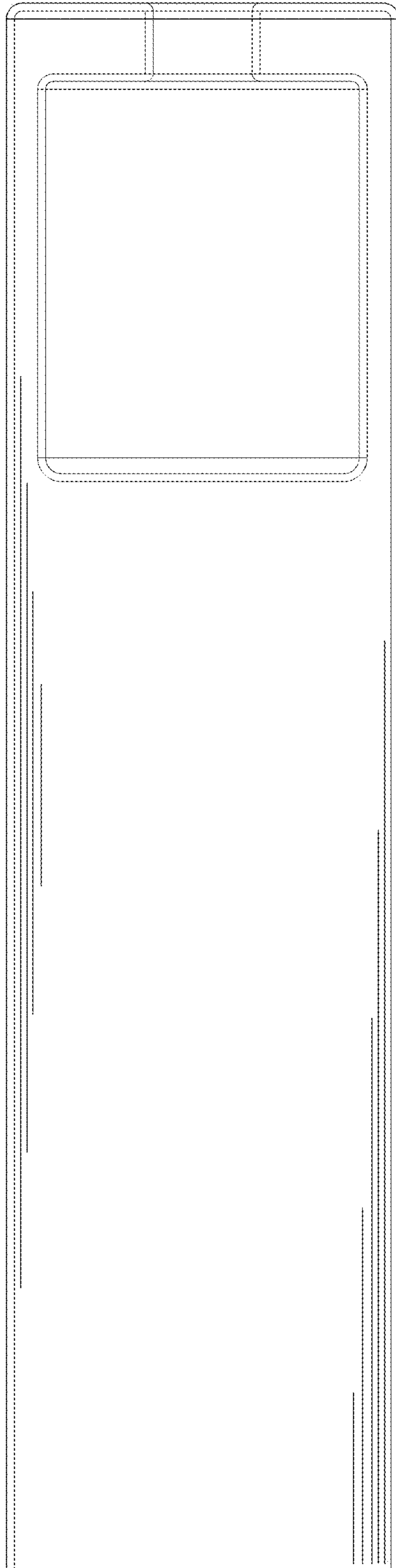

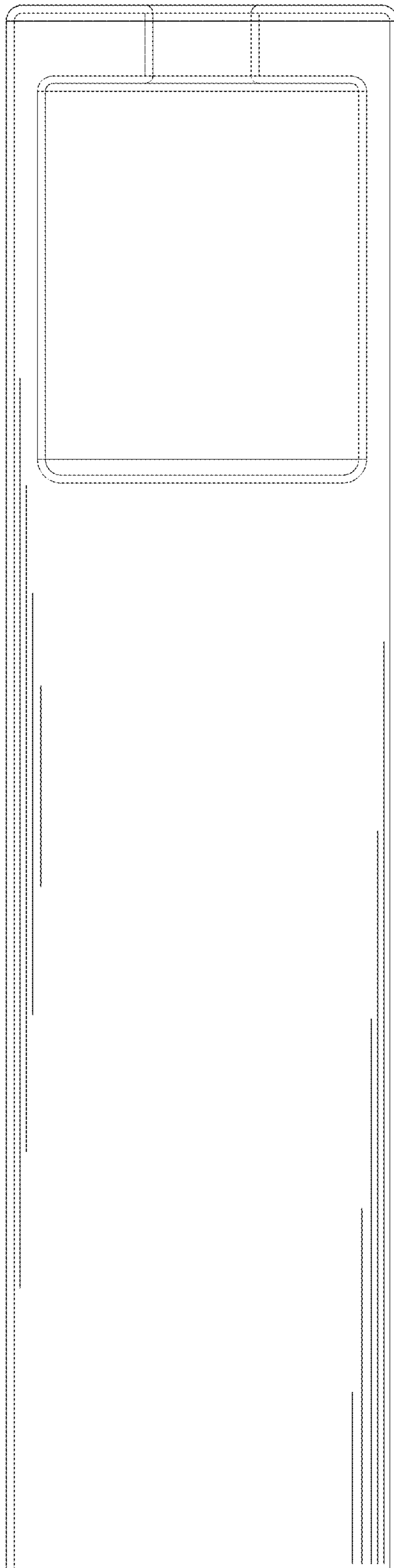

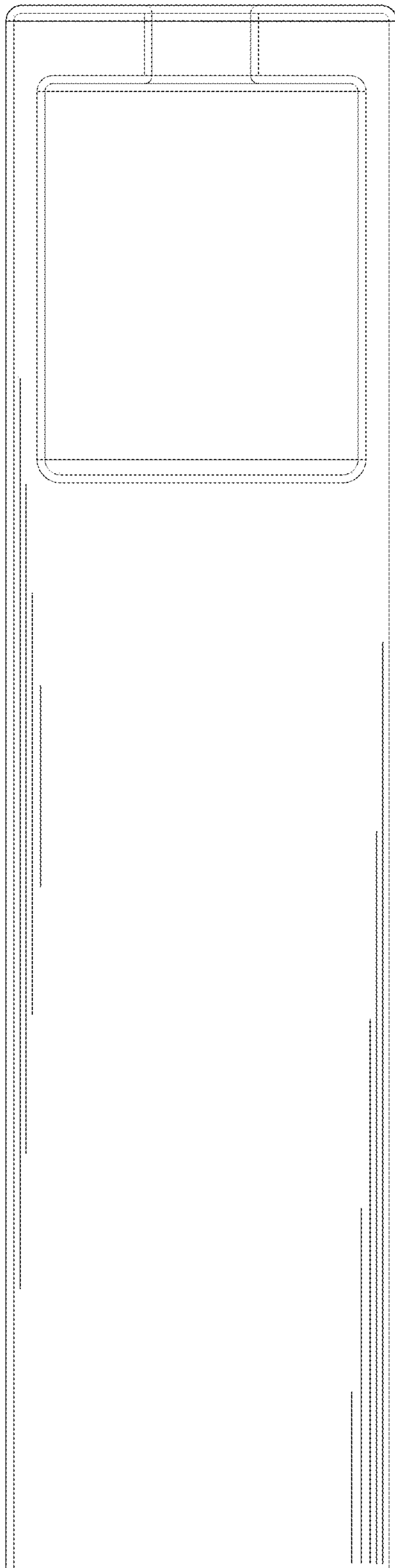

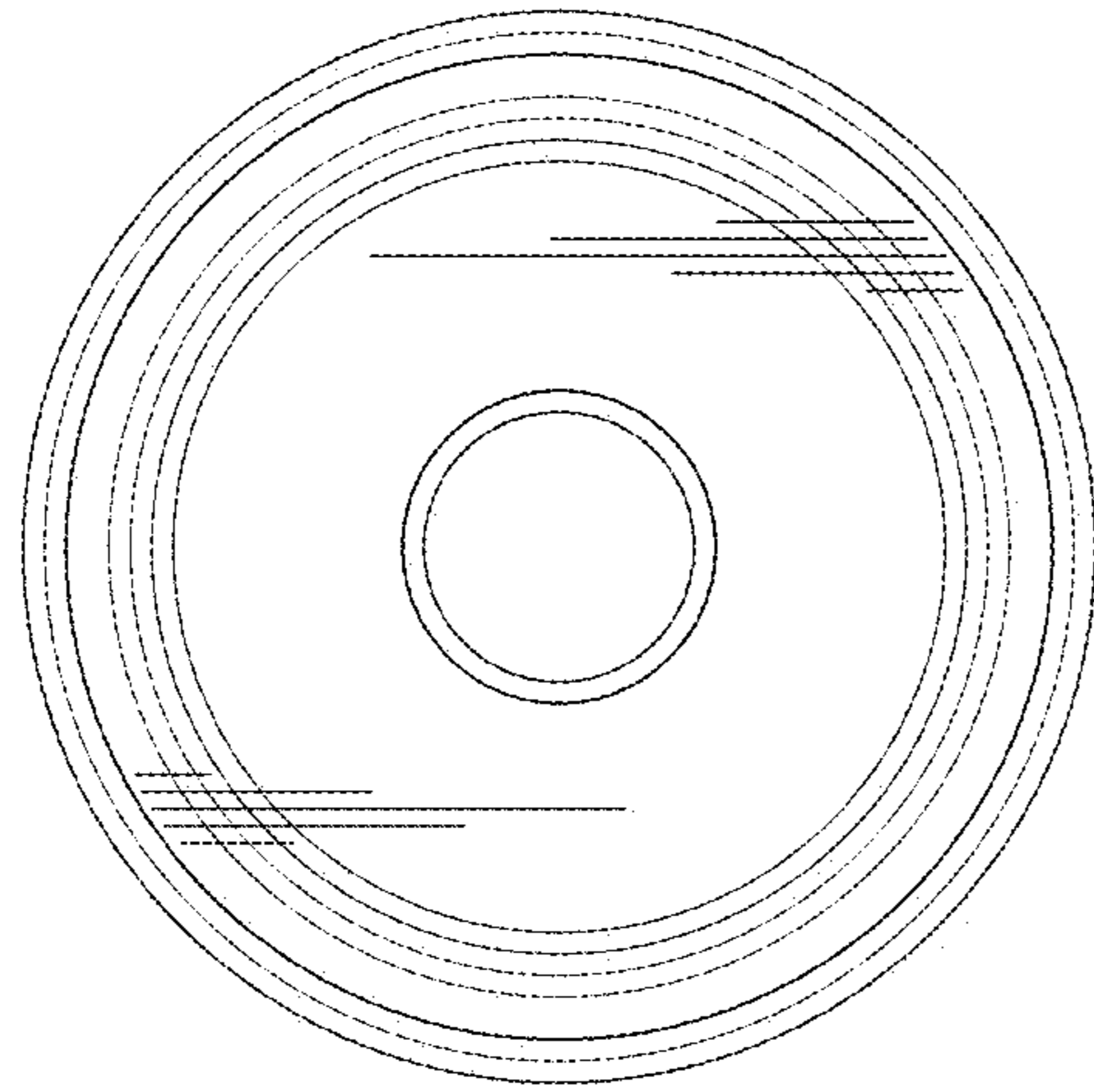

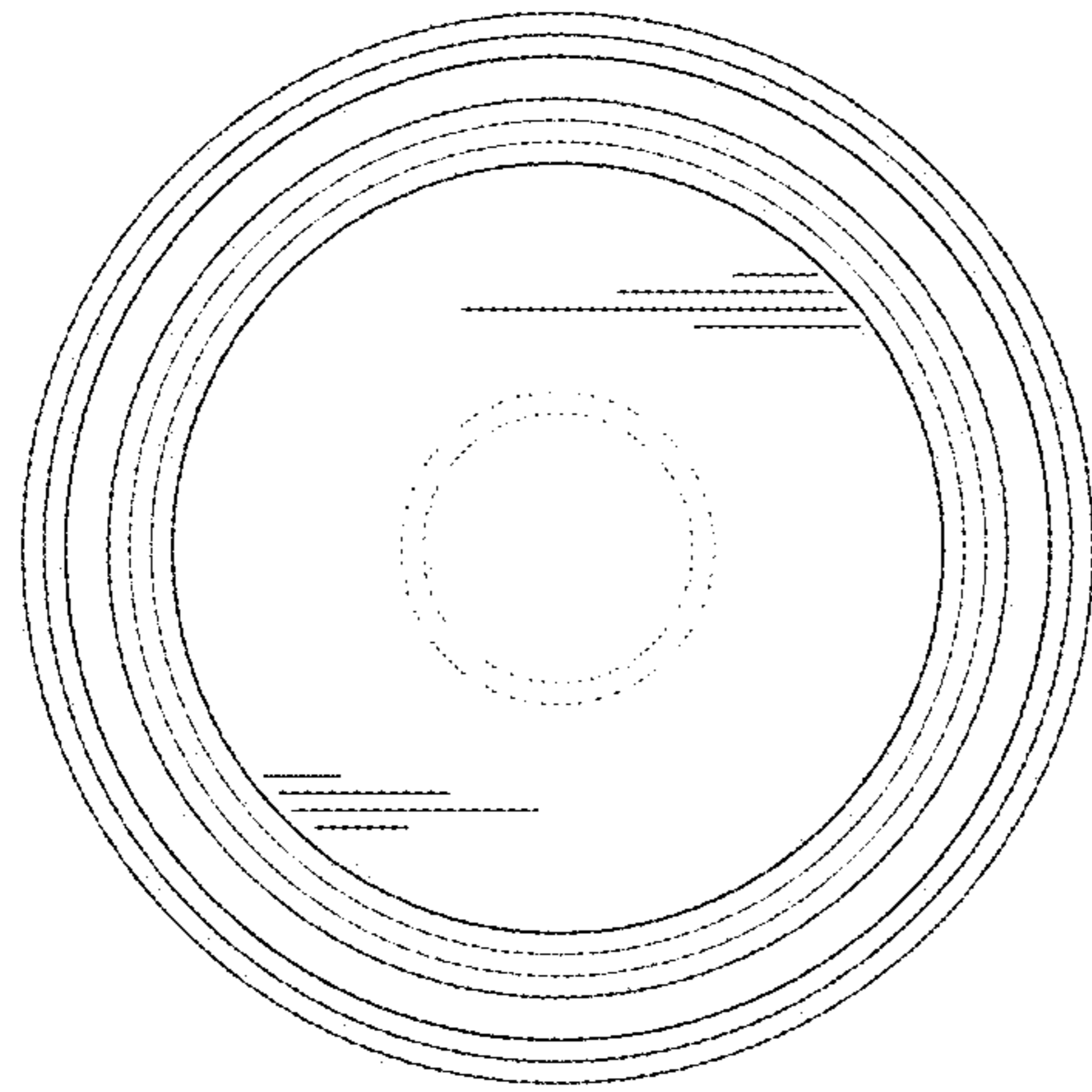

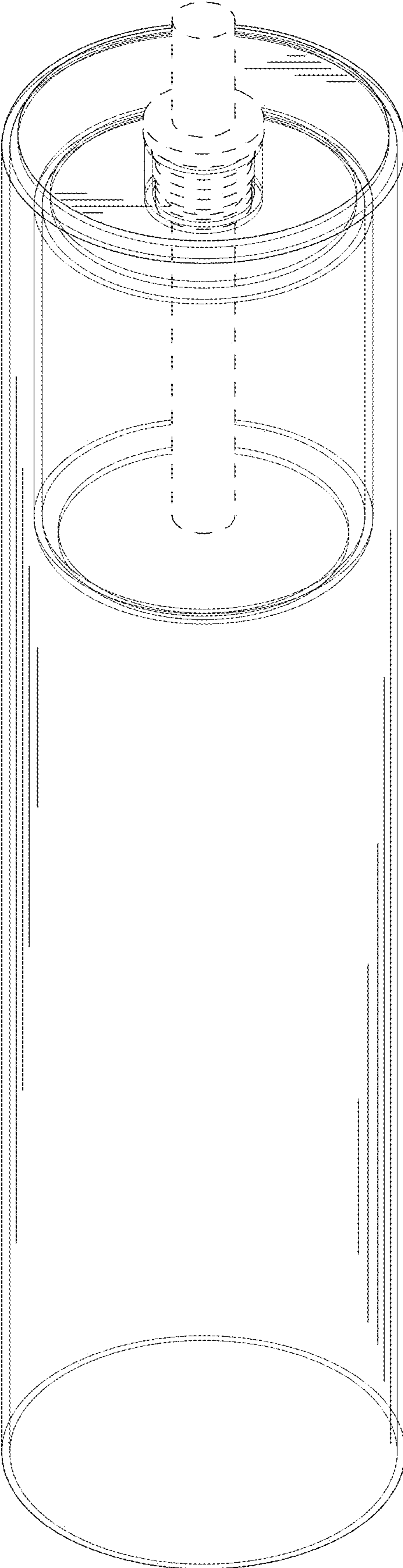
