I claim the ornamental design for a wire basket, as shown and described.

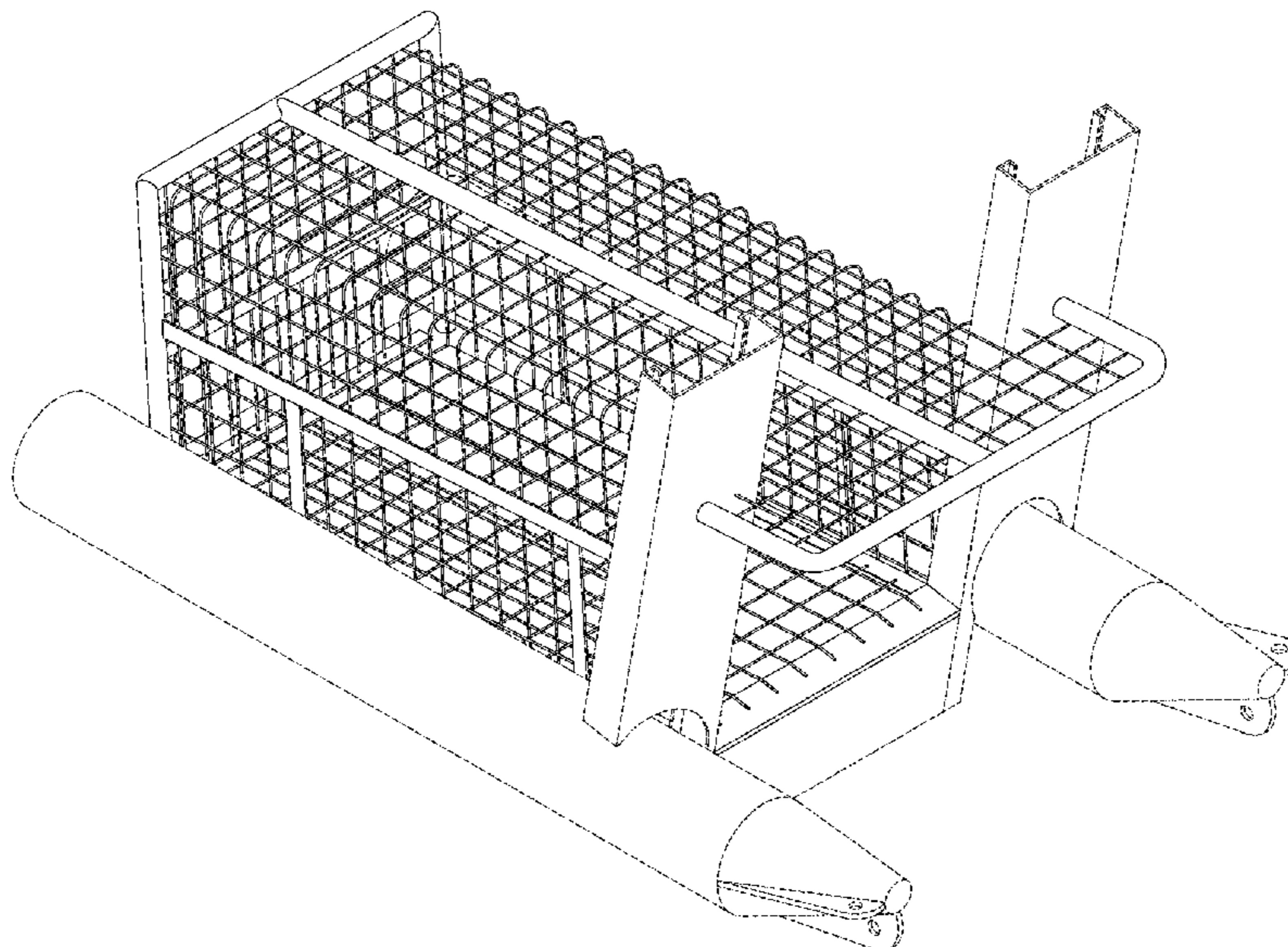
**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a wire basket showing my new design;  
FIG. 2 is a top, rear, left side perspective view thereof;  
FIG. 3 is a left side elevational view thereof; the right side elevational view being a mirror image of the left side elevational view;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a front elevational view thereof; and,  
FIG. 7 is a rear elevational view thereof.  
The broken lines shown in the figures represent portions of the wire basket that form no part of the claimed design.

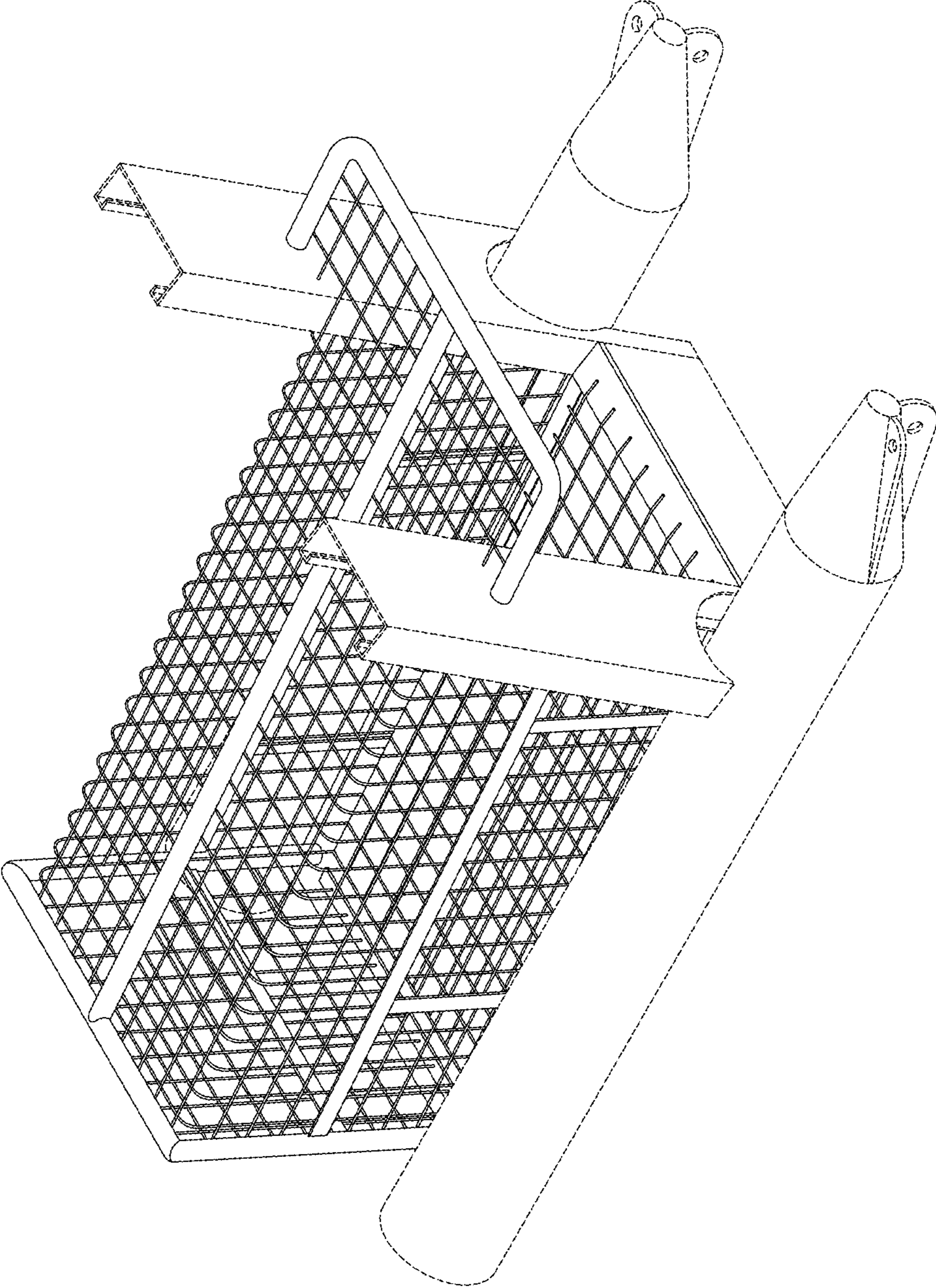

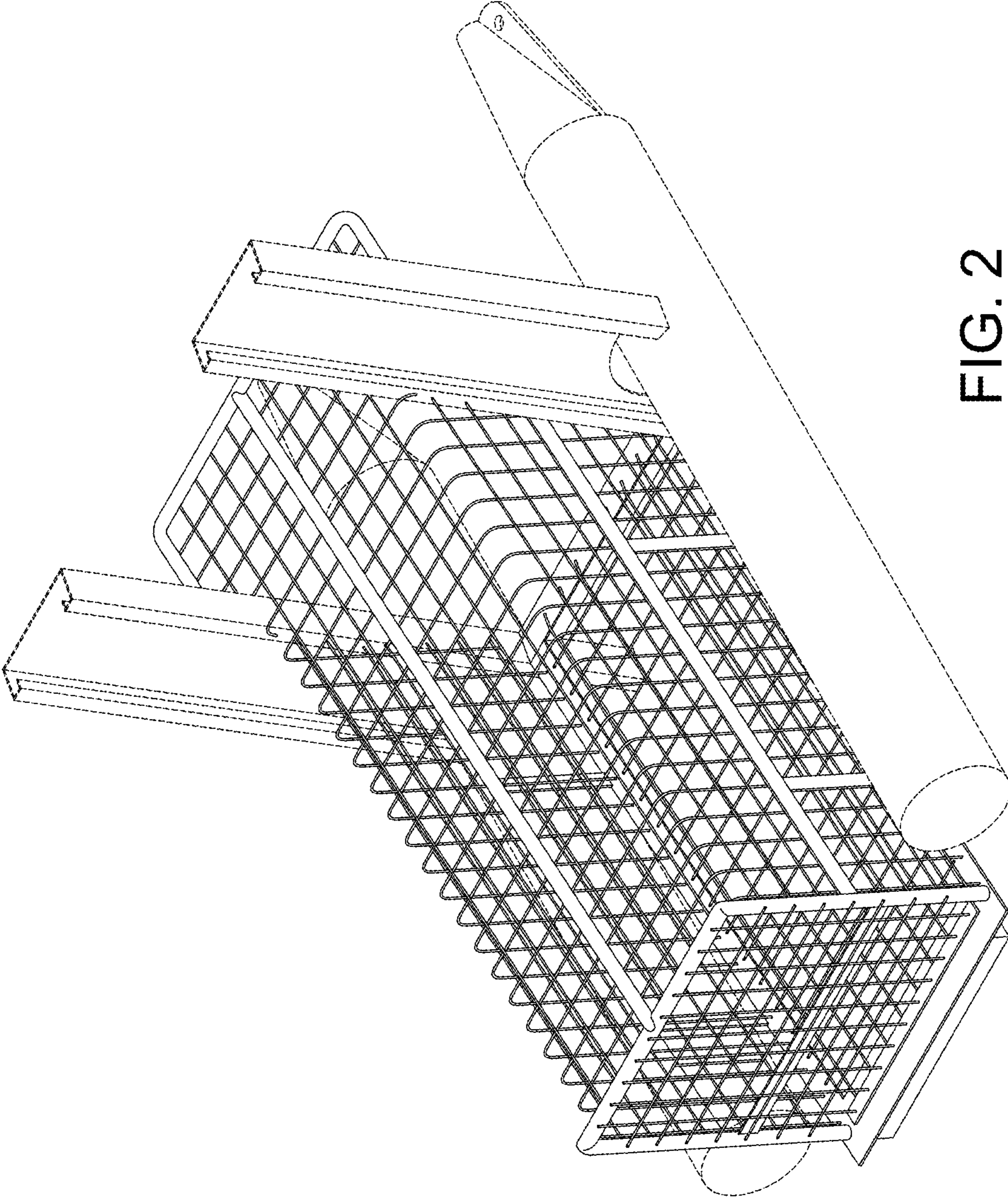

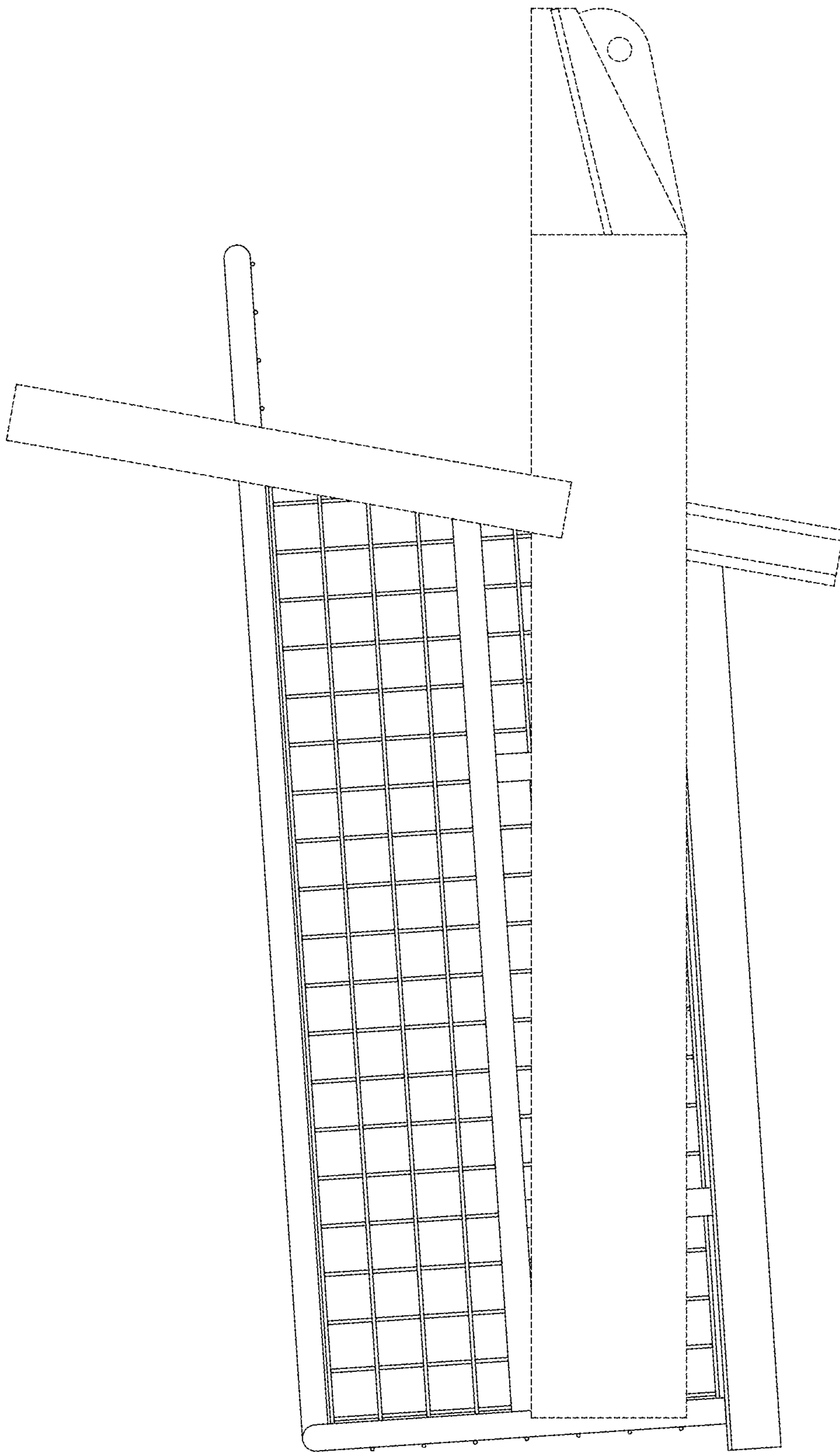

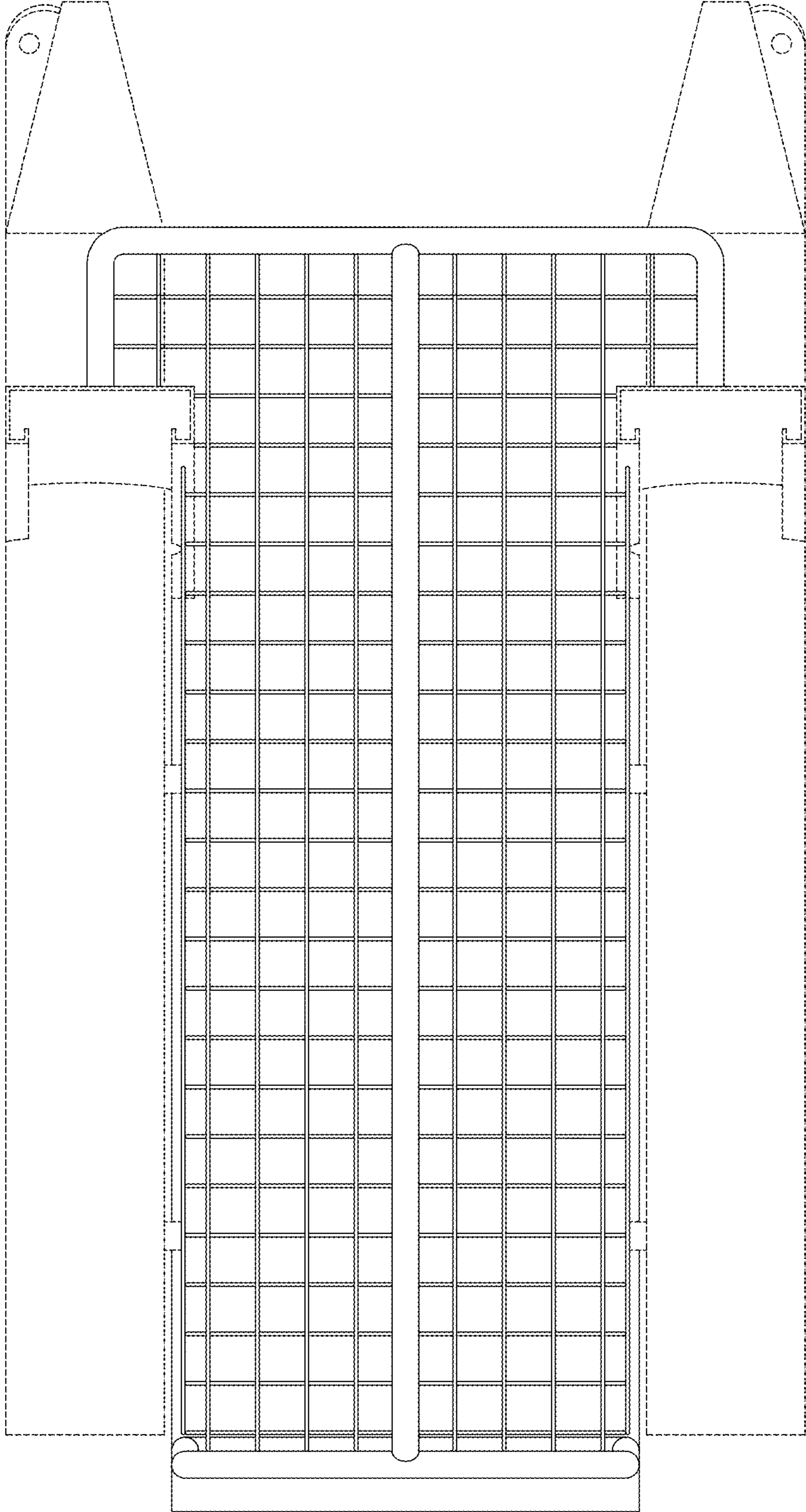

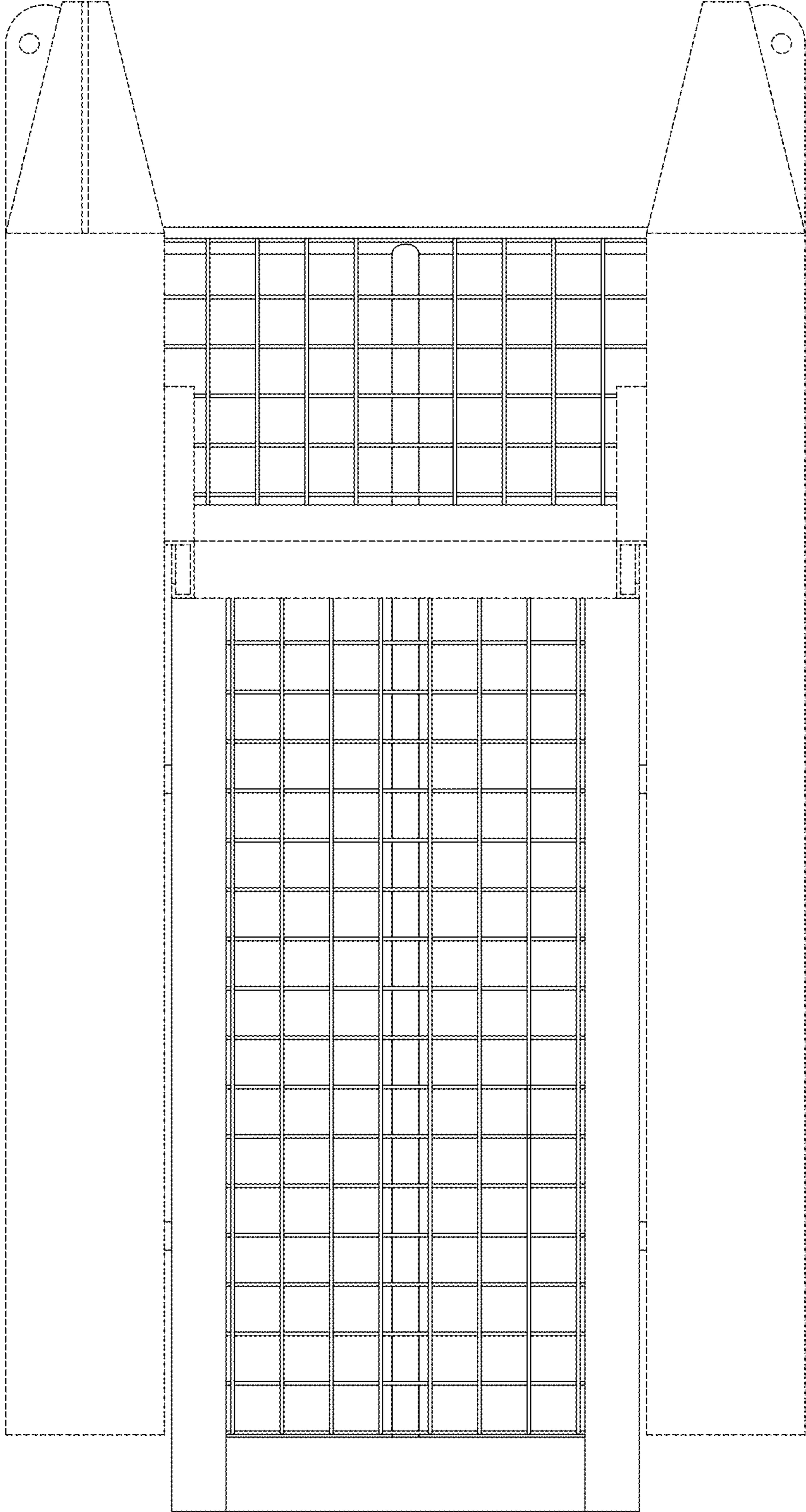

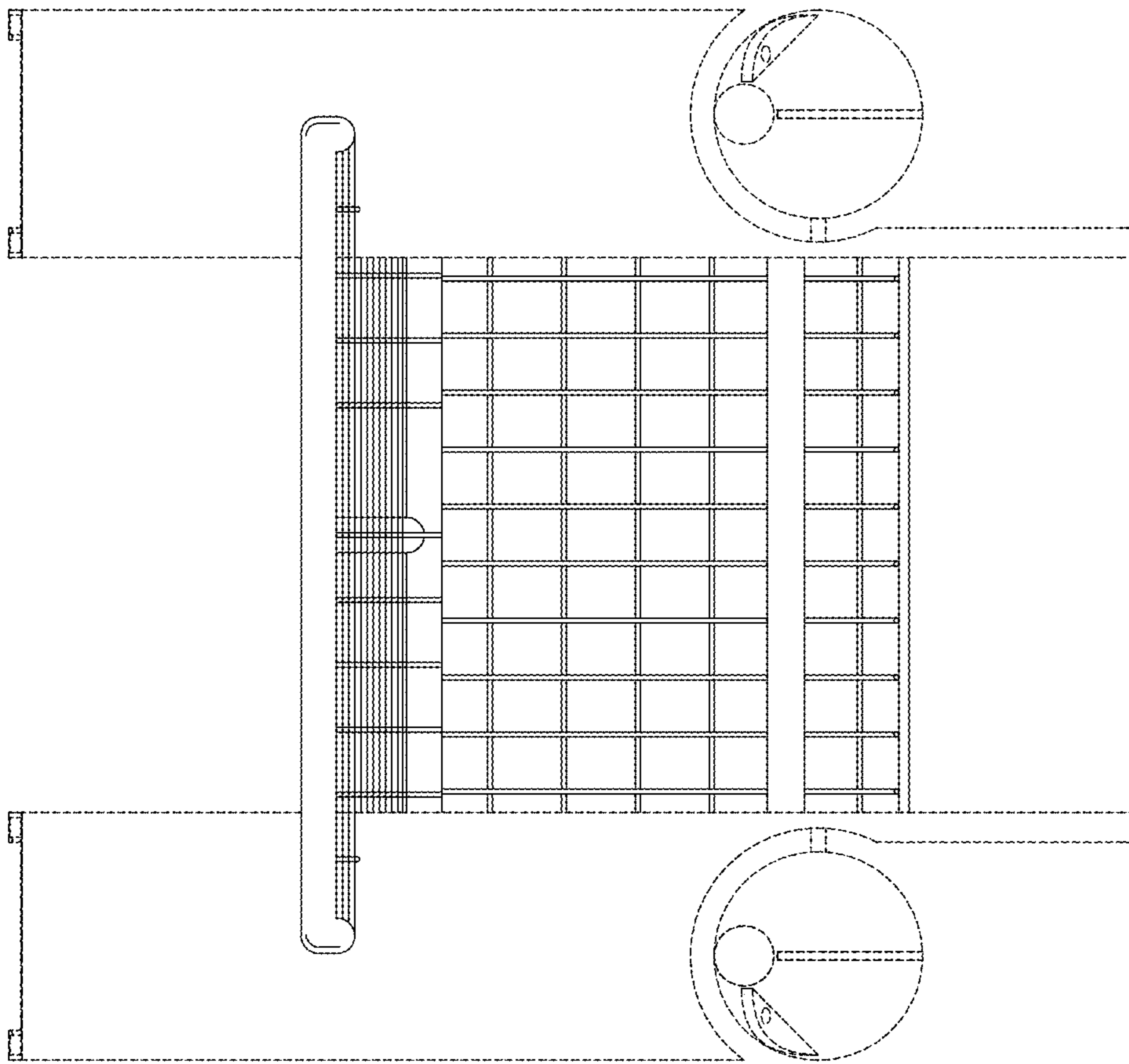

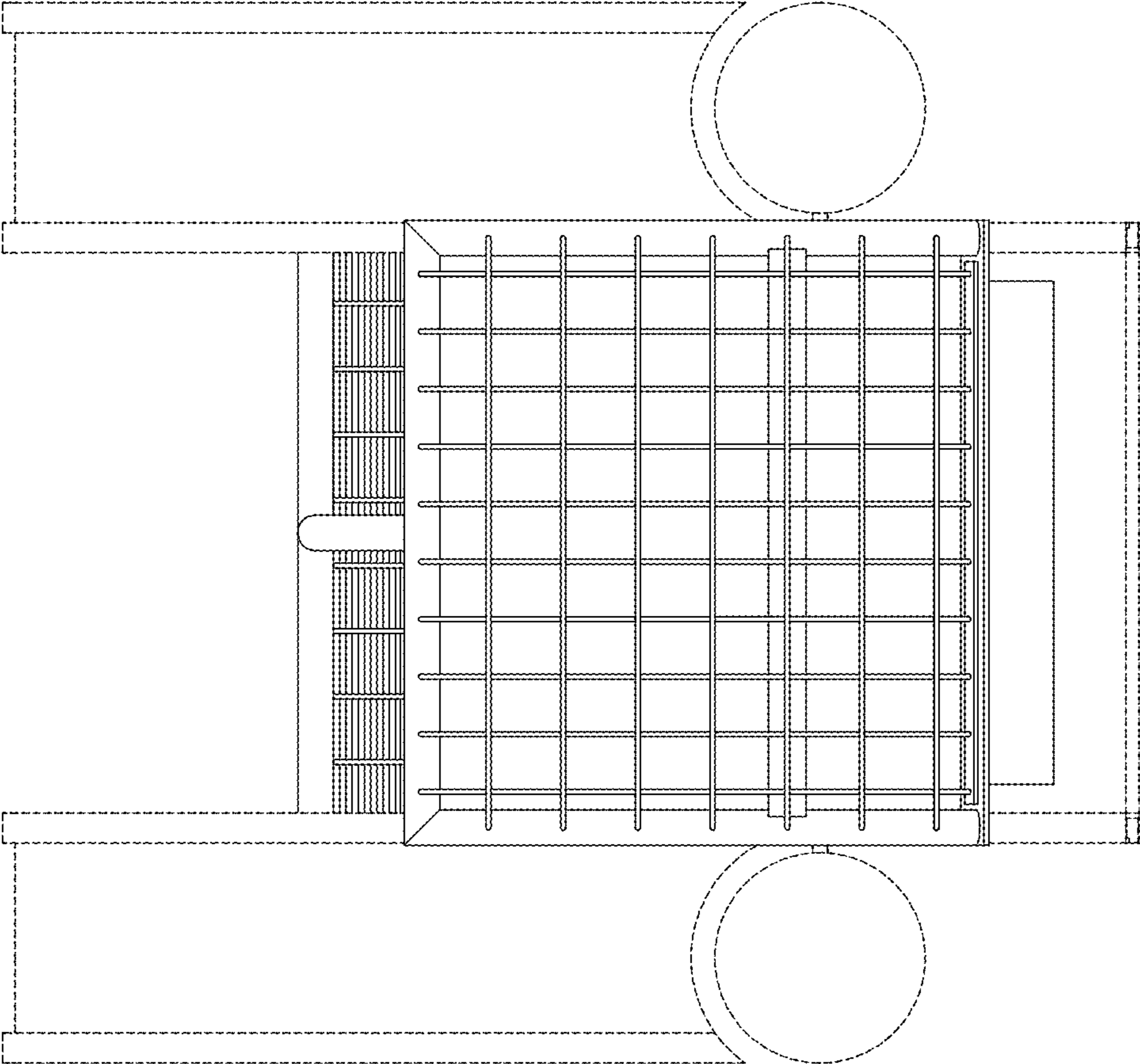
