(57) **CLAIM**

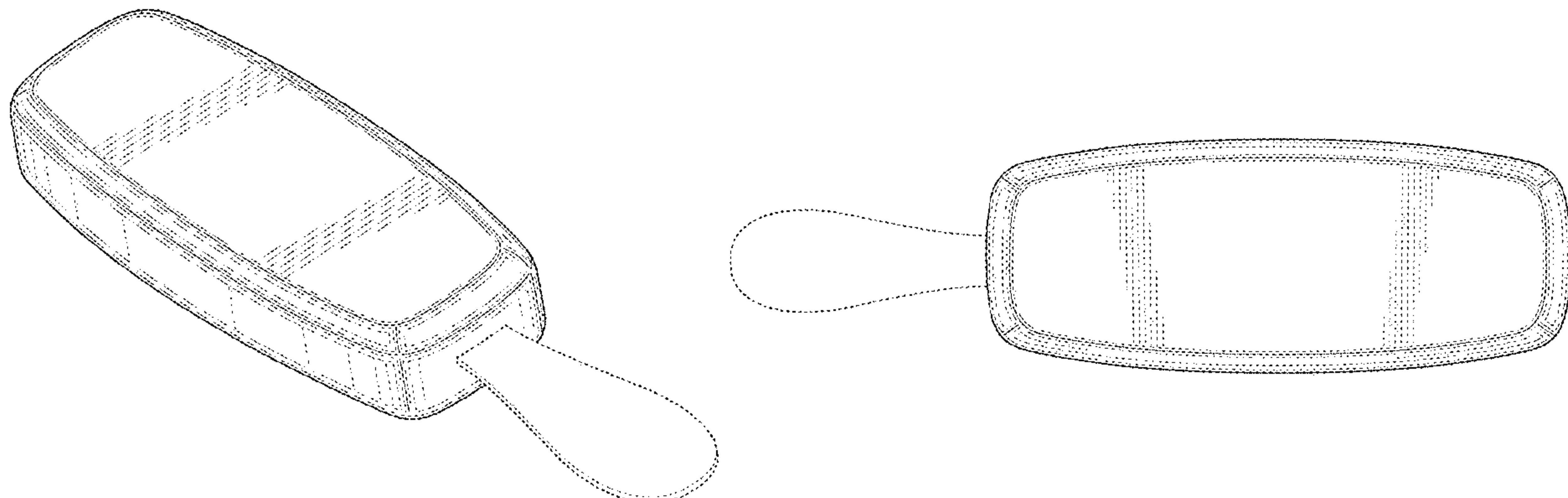
The ornamental design for a frozen food bar, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of a frozen food bar according to our design;
FIG. 2 is a front elevational view of the frozen food bar of FIG. 1;
FIG. 3 is a rear elevational view of the frozen food bar of FIG. 1;
FIG. 4 is a left side view of the frozen food bar of FIG. 1;
FIG. 5 is a right side view of the frozen food bar of FIG. 1;
FIG. 6 is a top plan view of the frozen food bar of FIG. 1;
and,
FIG. 7 is a bottom plan view of the frozen food bar of FIG. 1.

The broken lines in the figures illustrate a handle, such as a stick, for holding the frozen food bar and represent unclaimed portions that form no part of the claimed design.

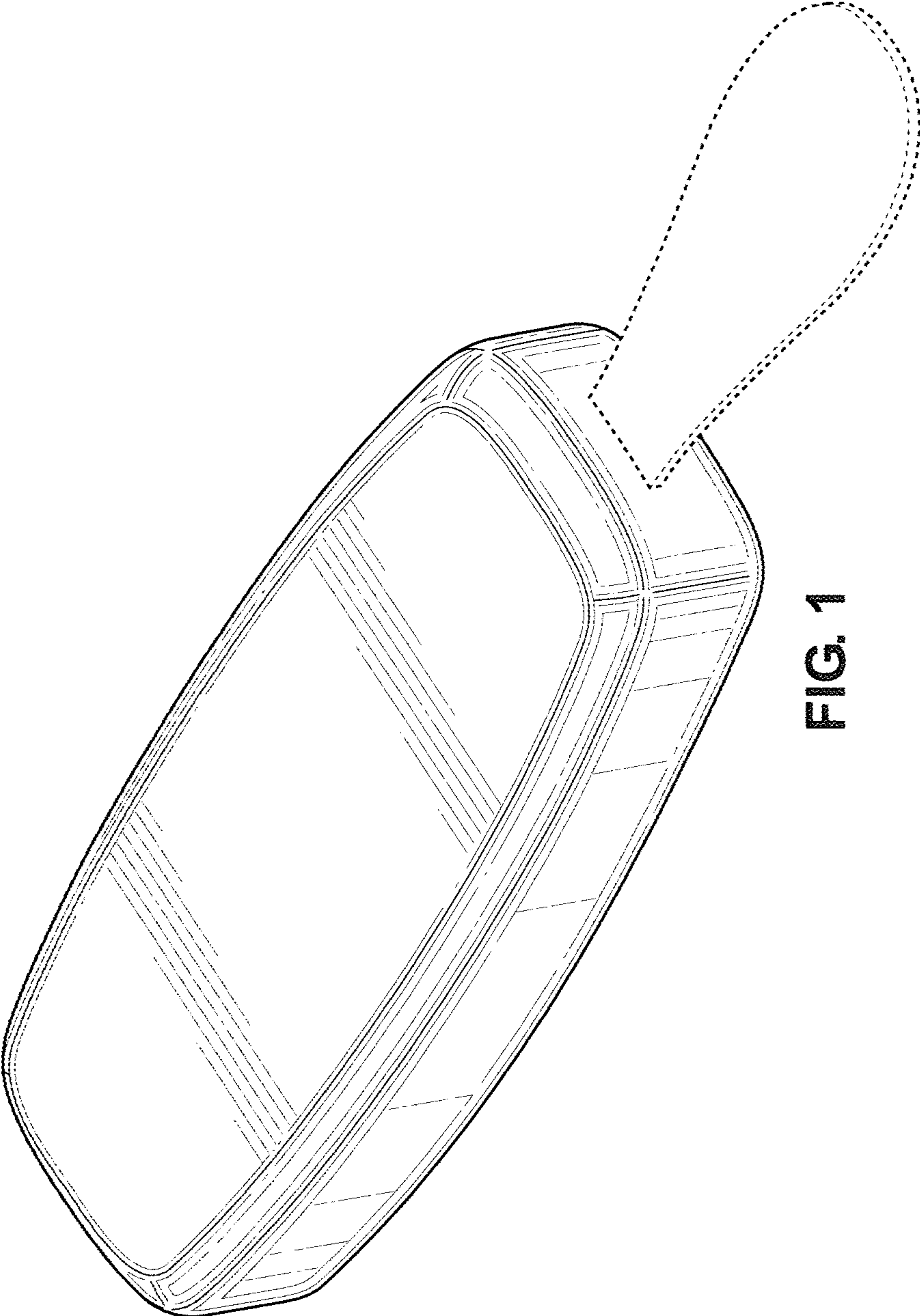
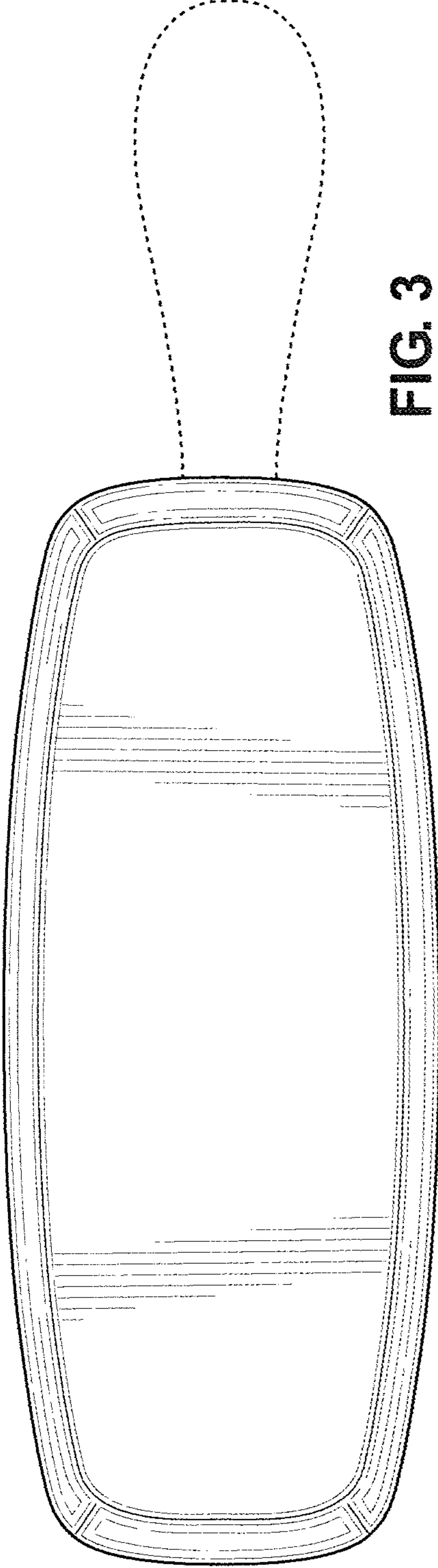
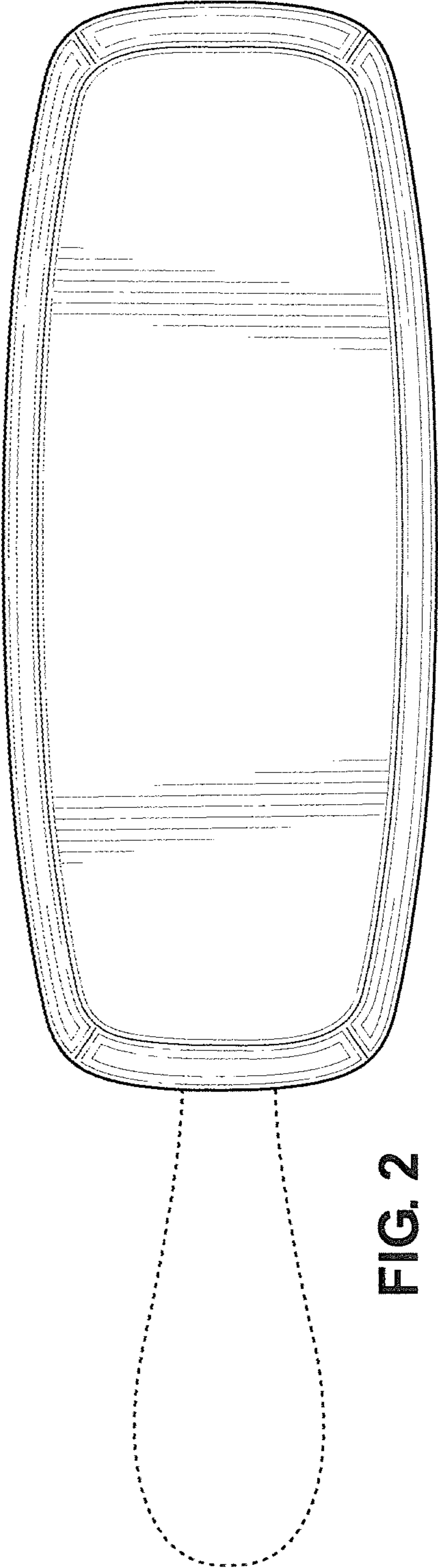

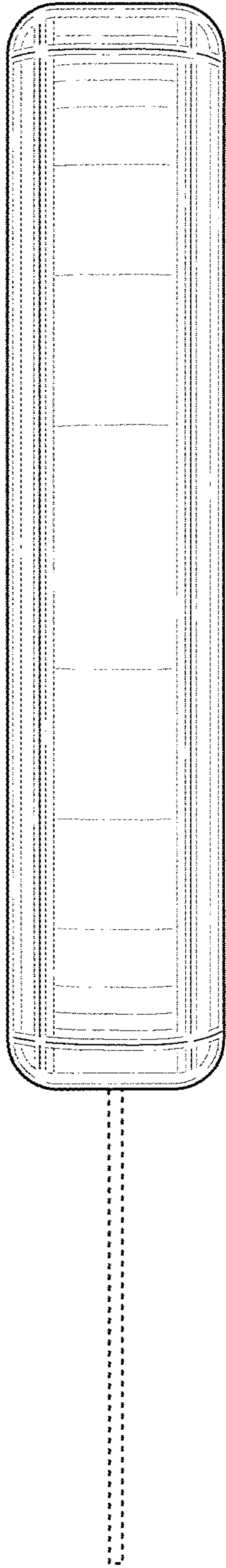

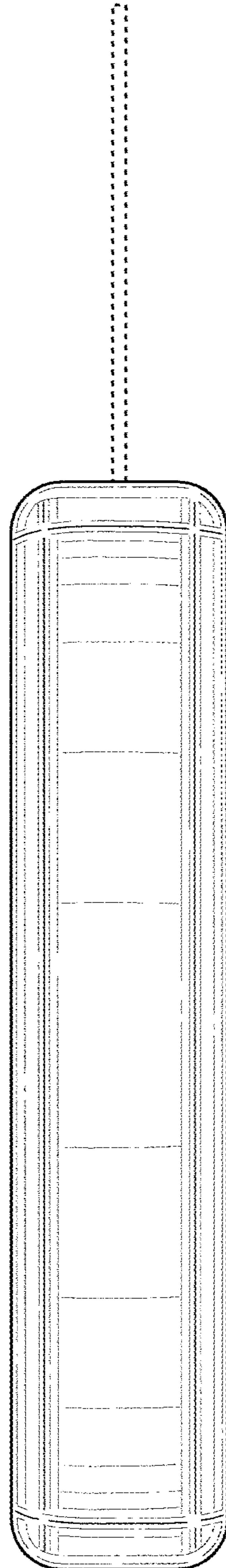

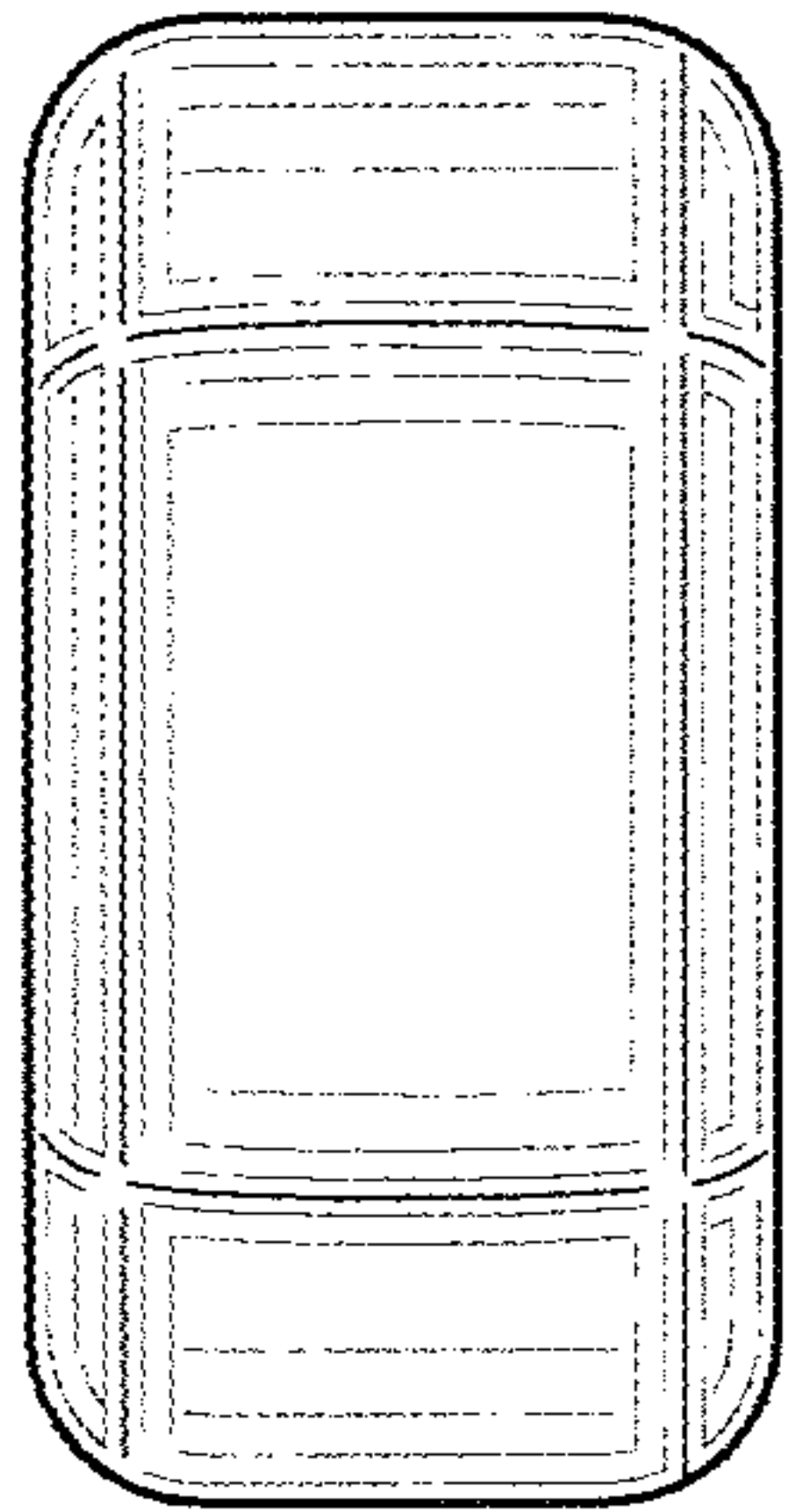

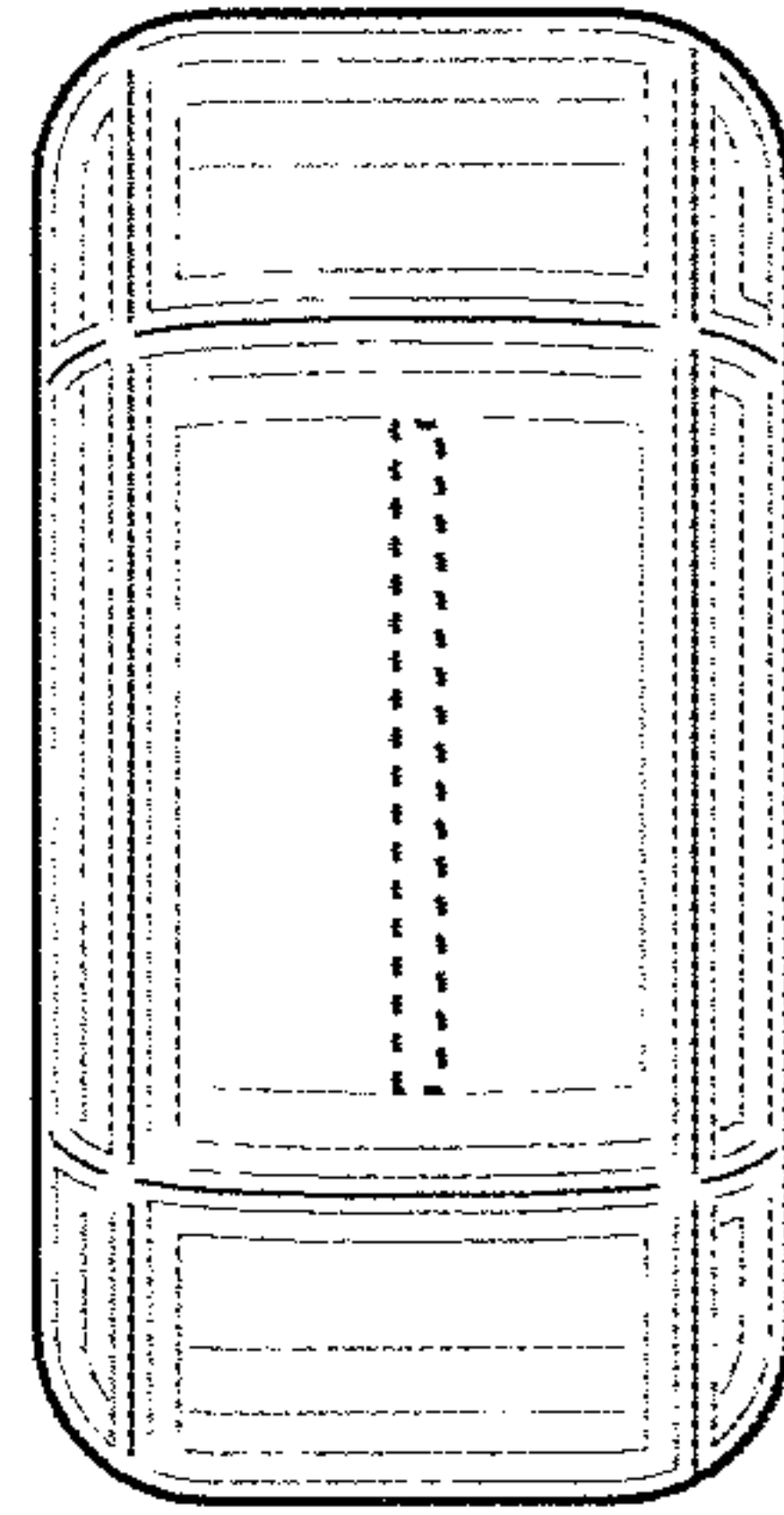
