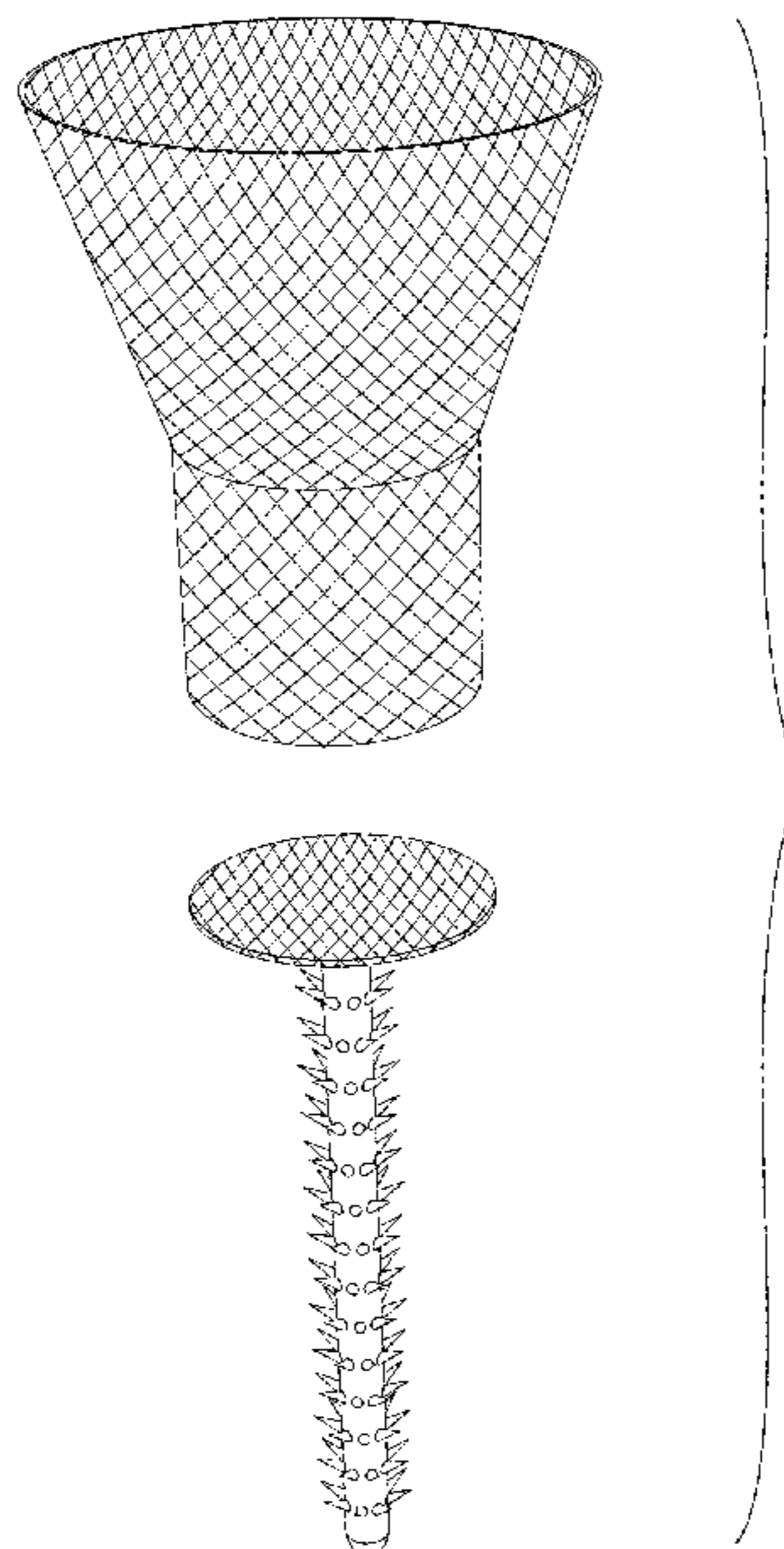
FIG. 1 is an exploded top perspective view of a scaffolding for ice cream cone handle variations;

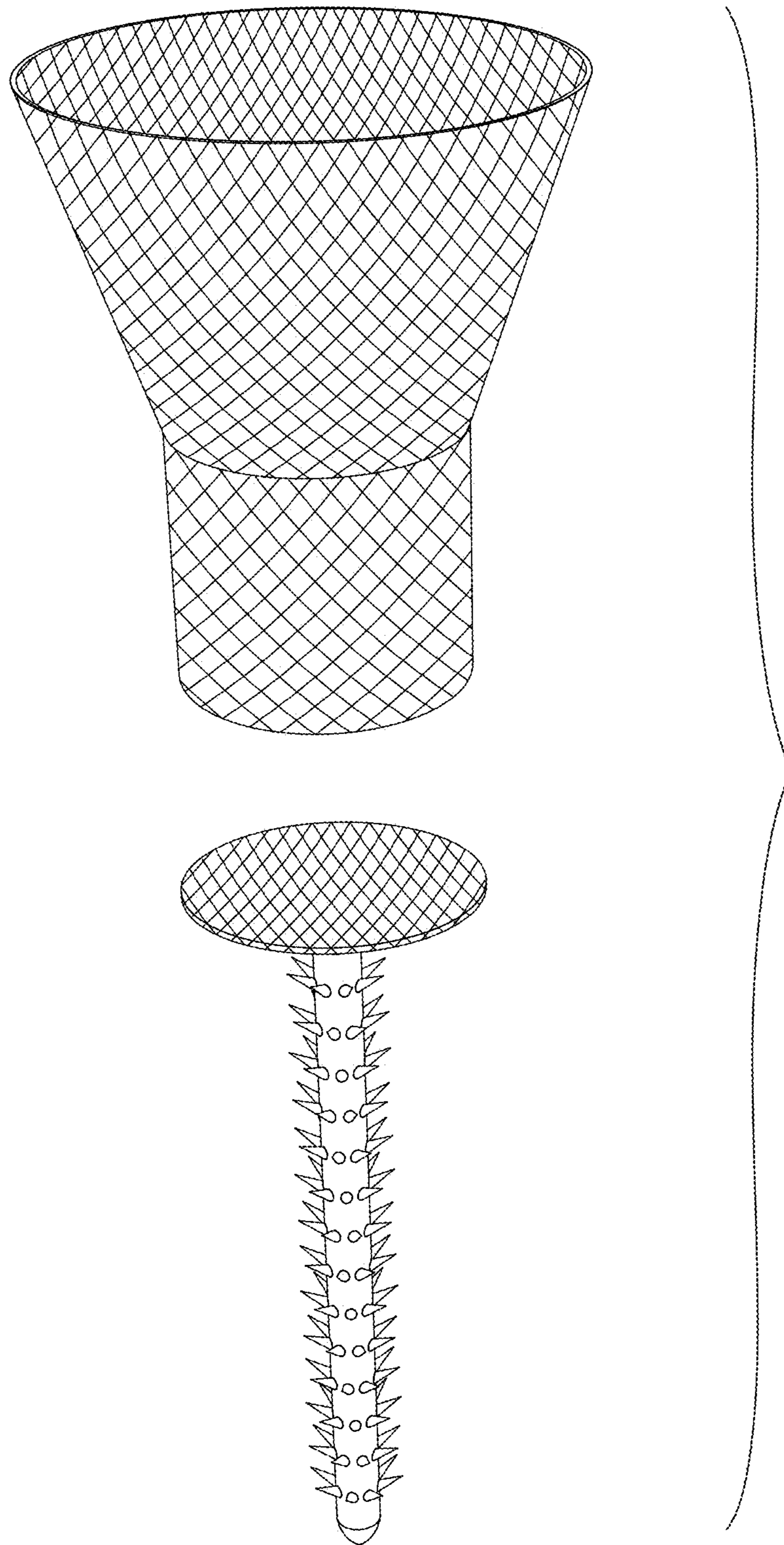

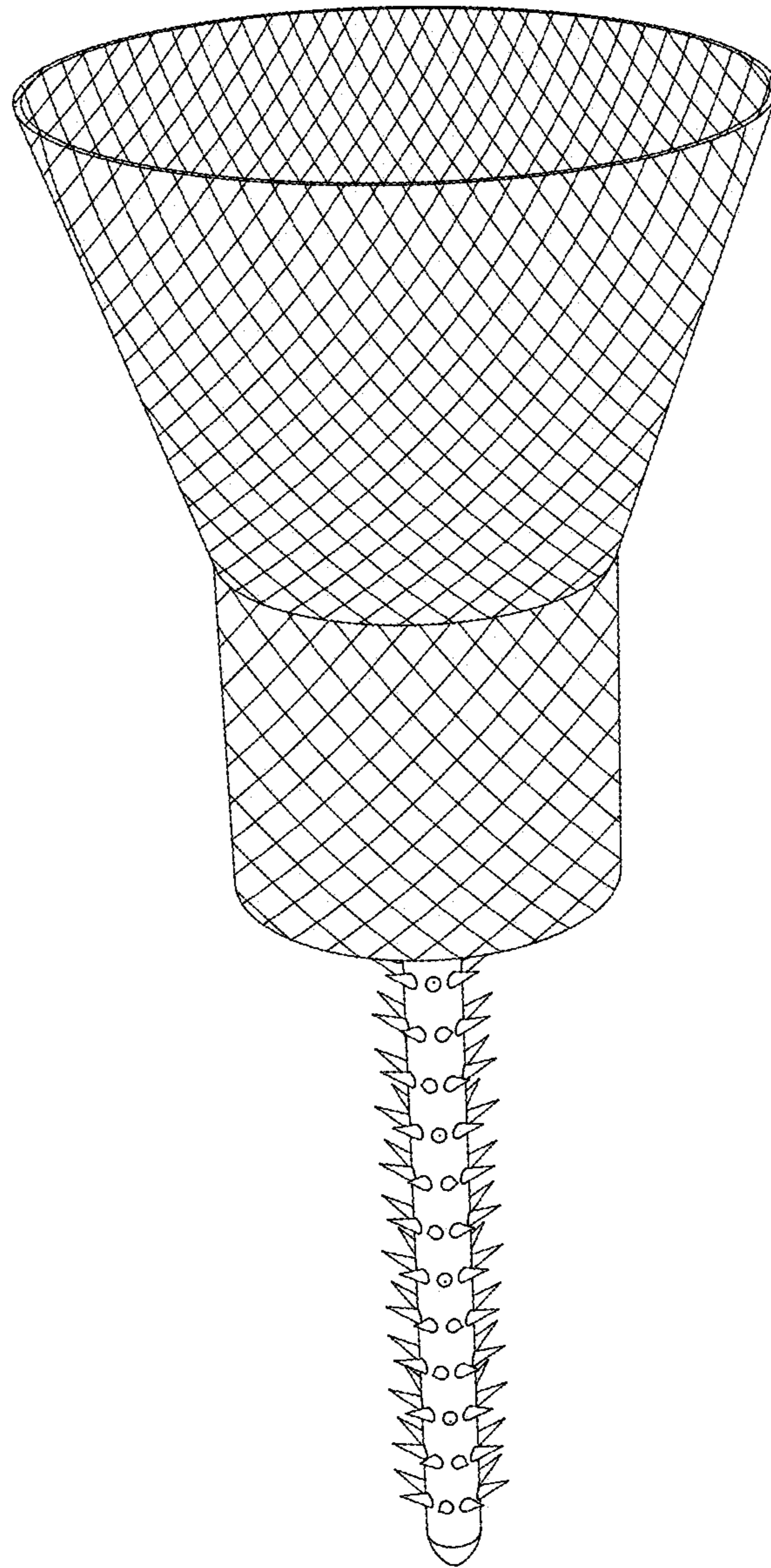

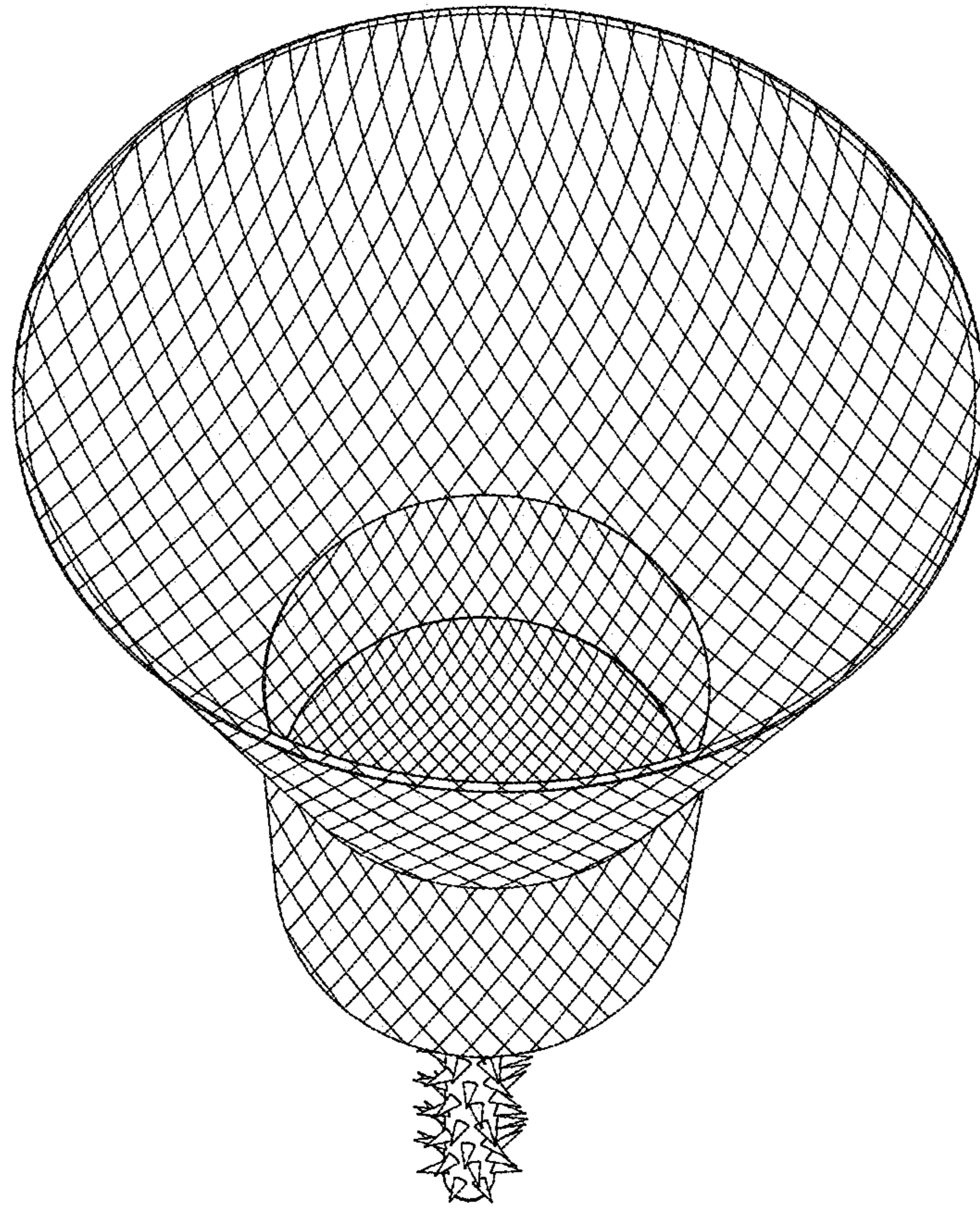

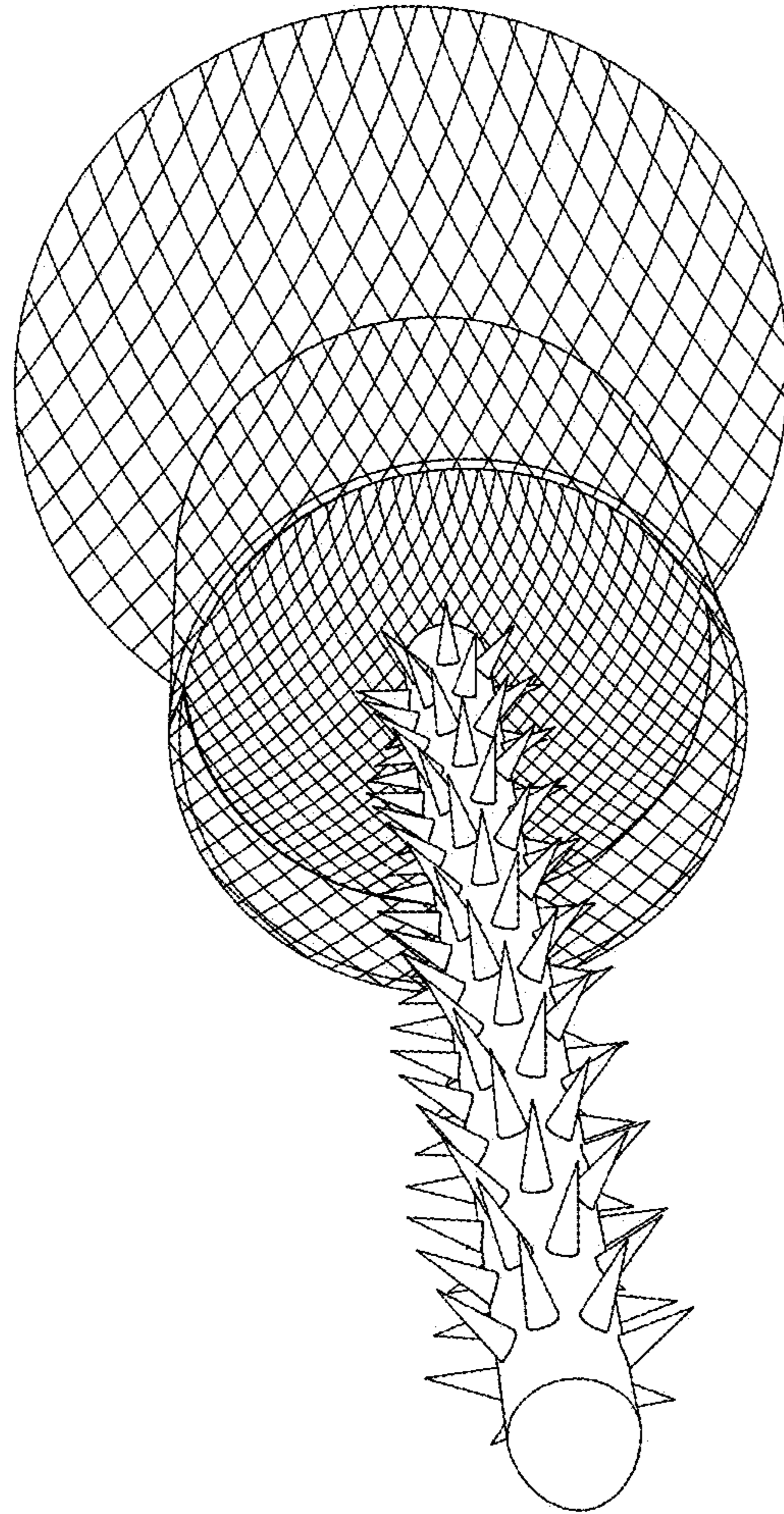

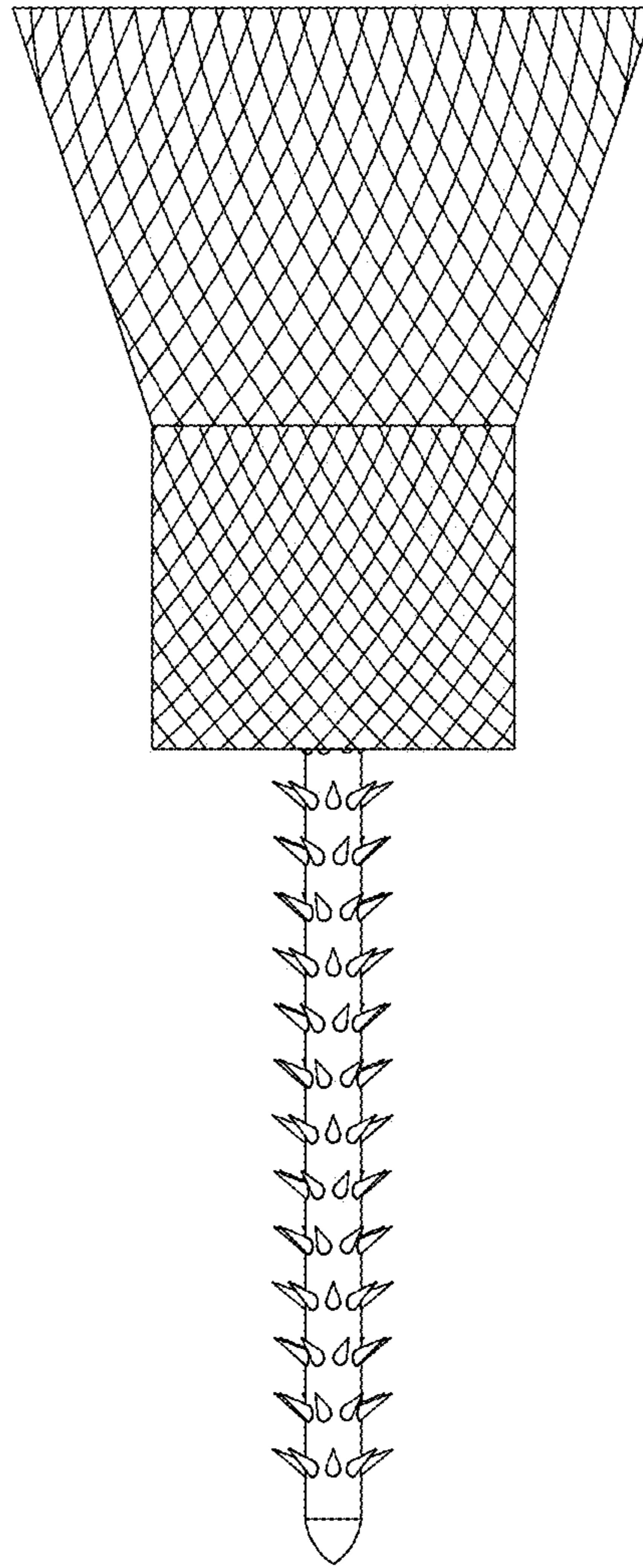

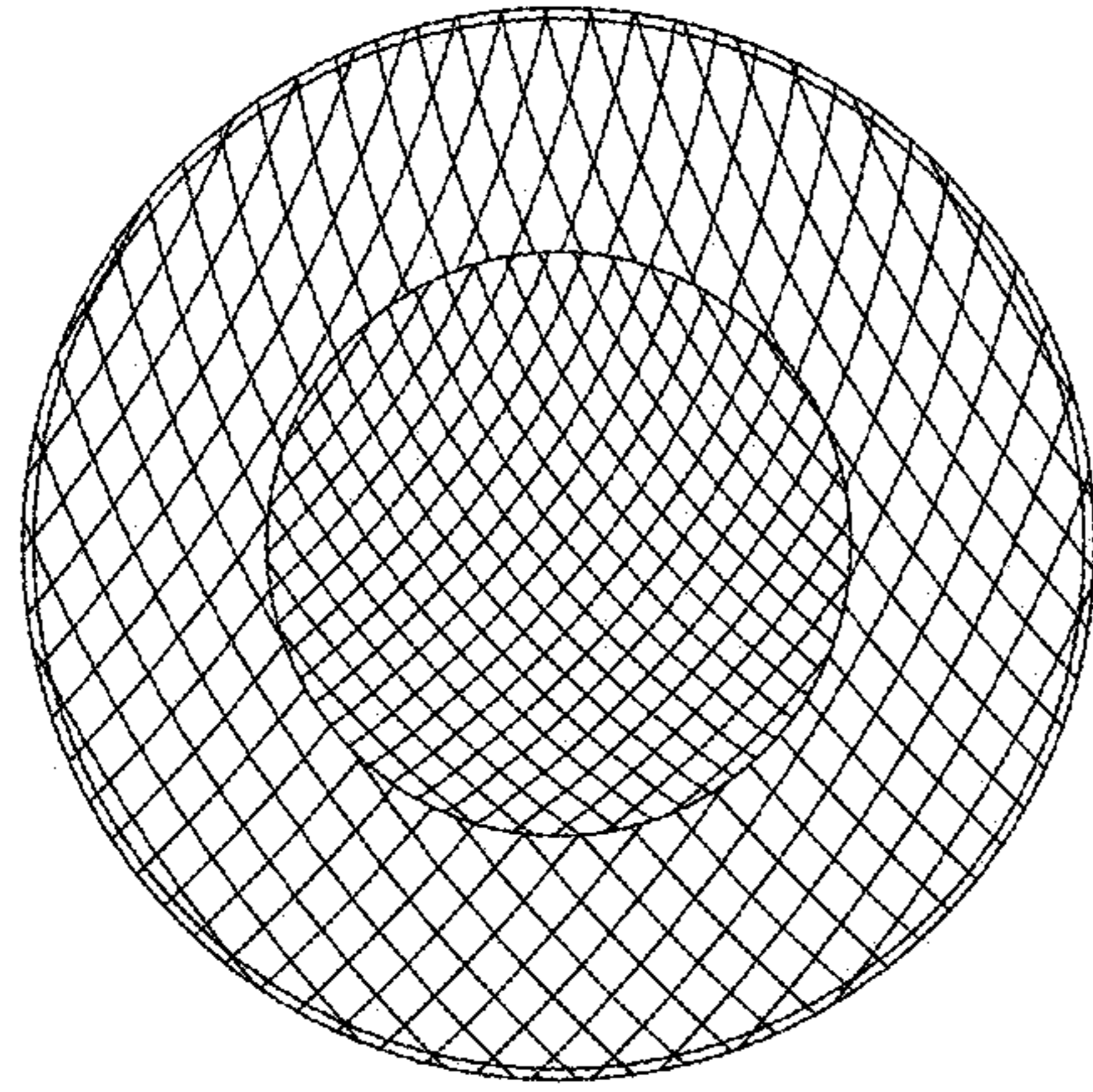

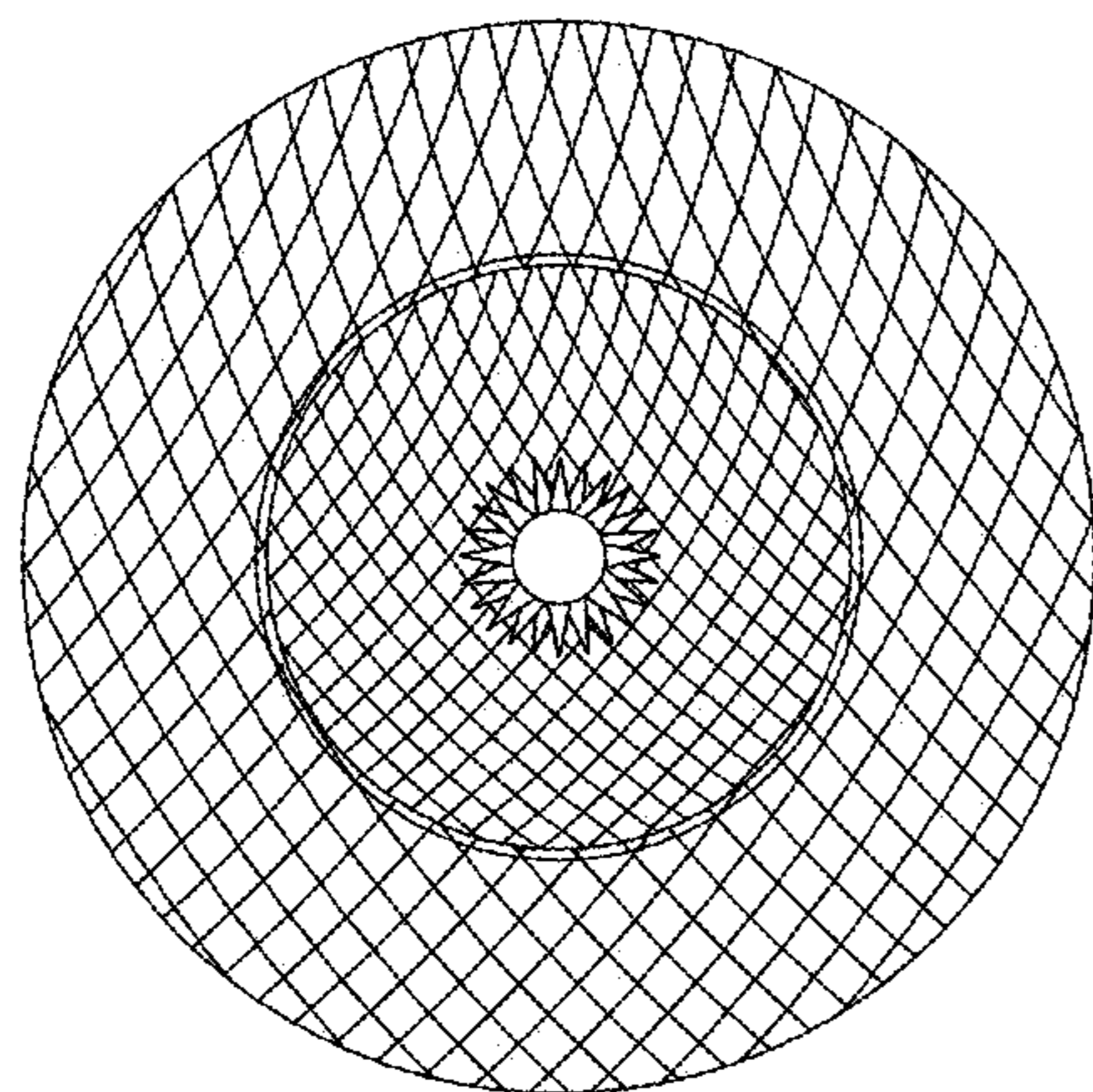

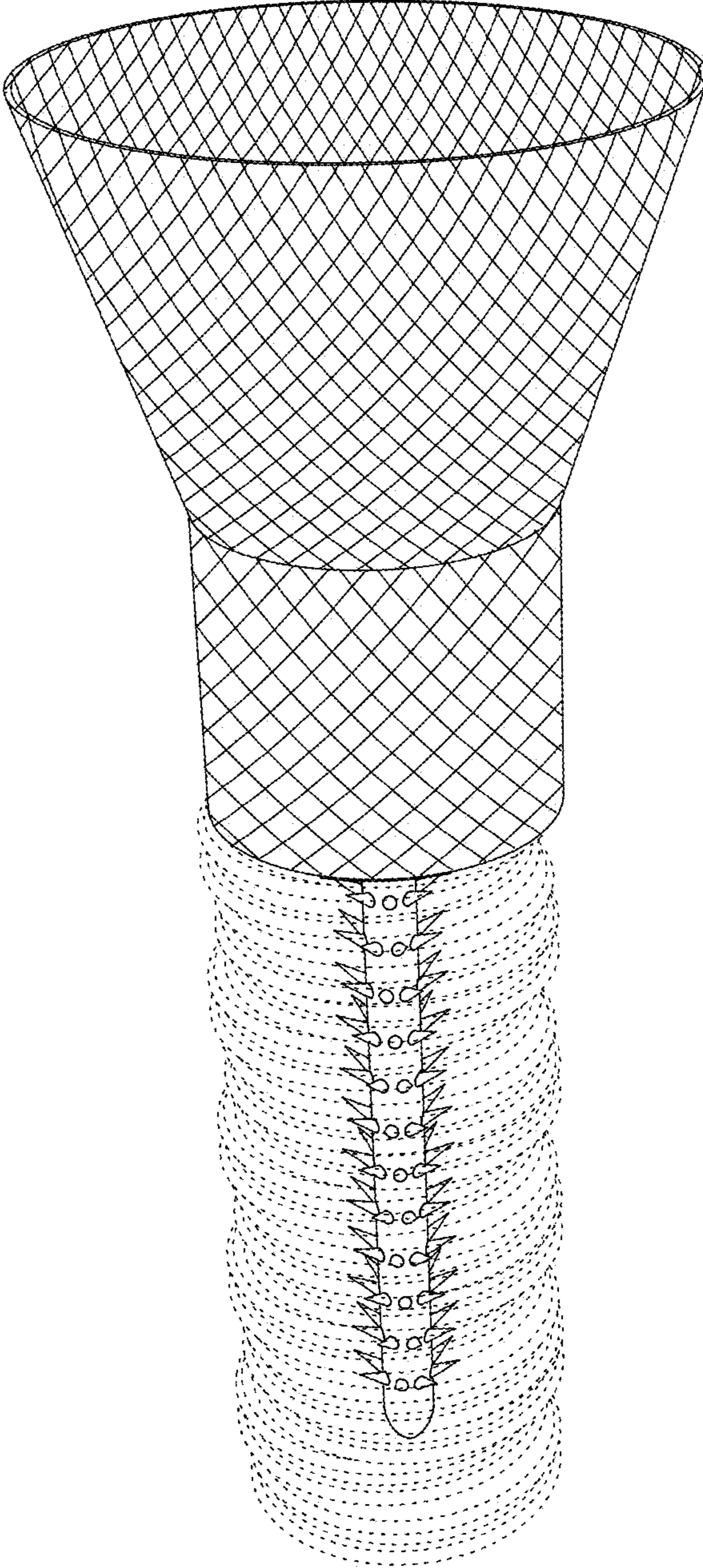

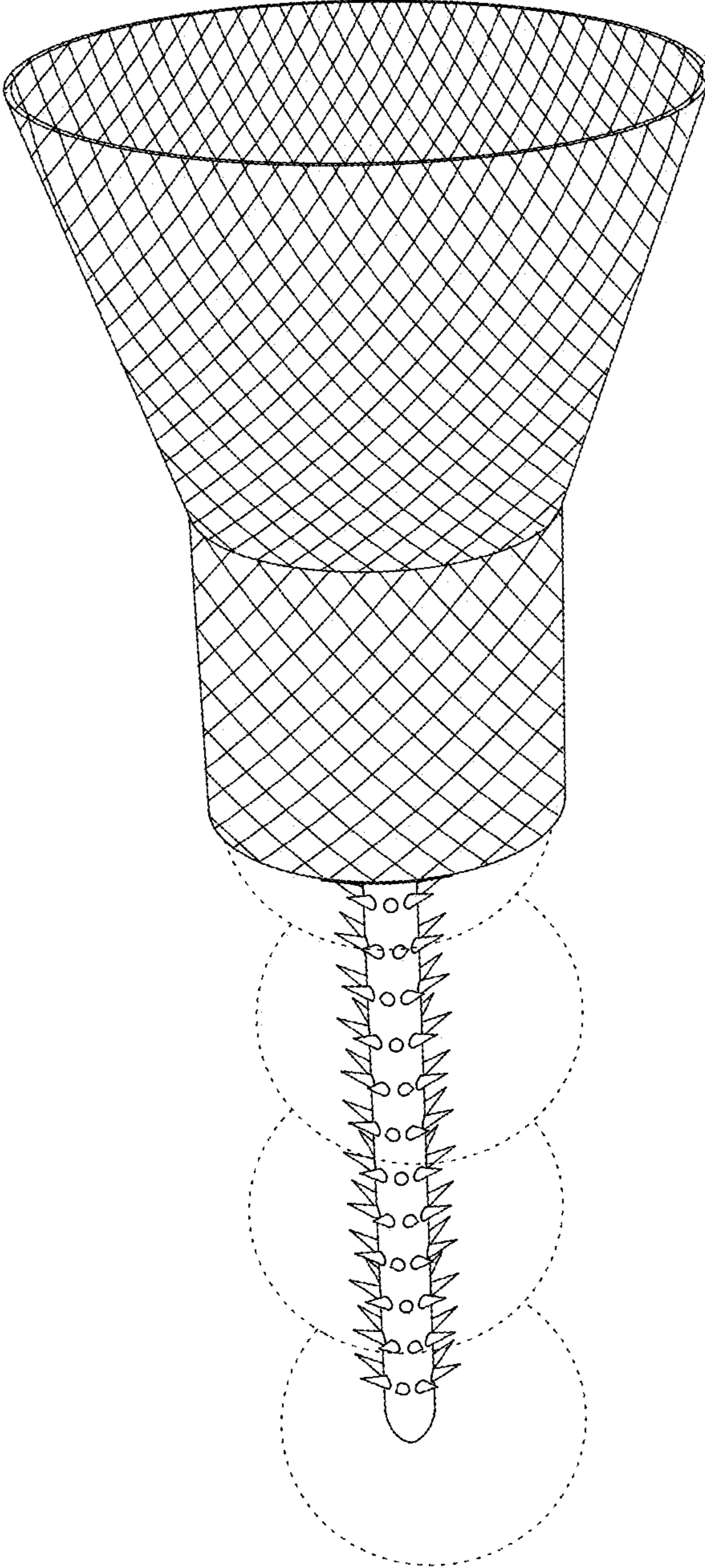

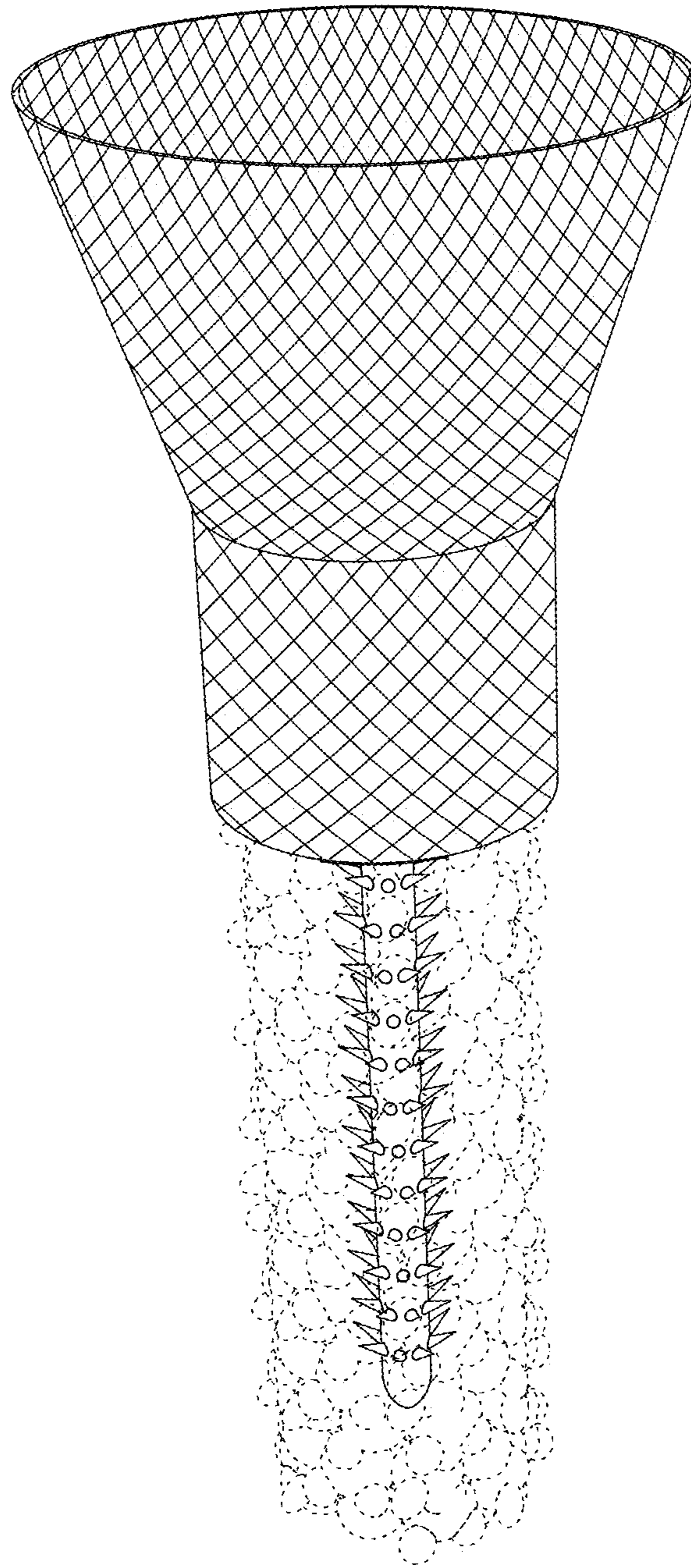

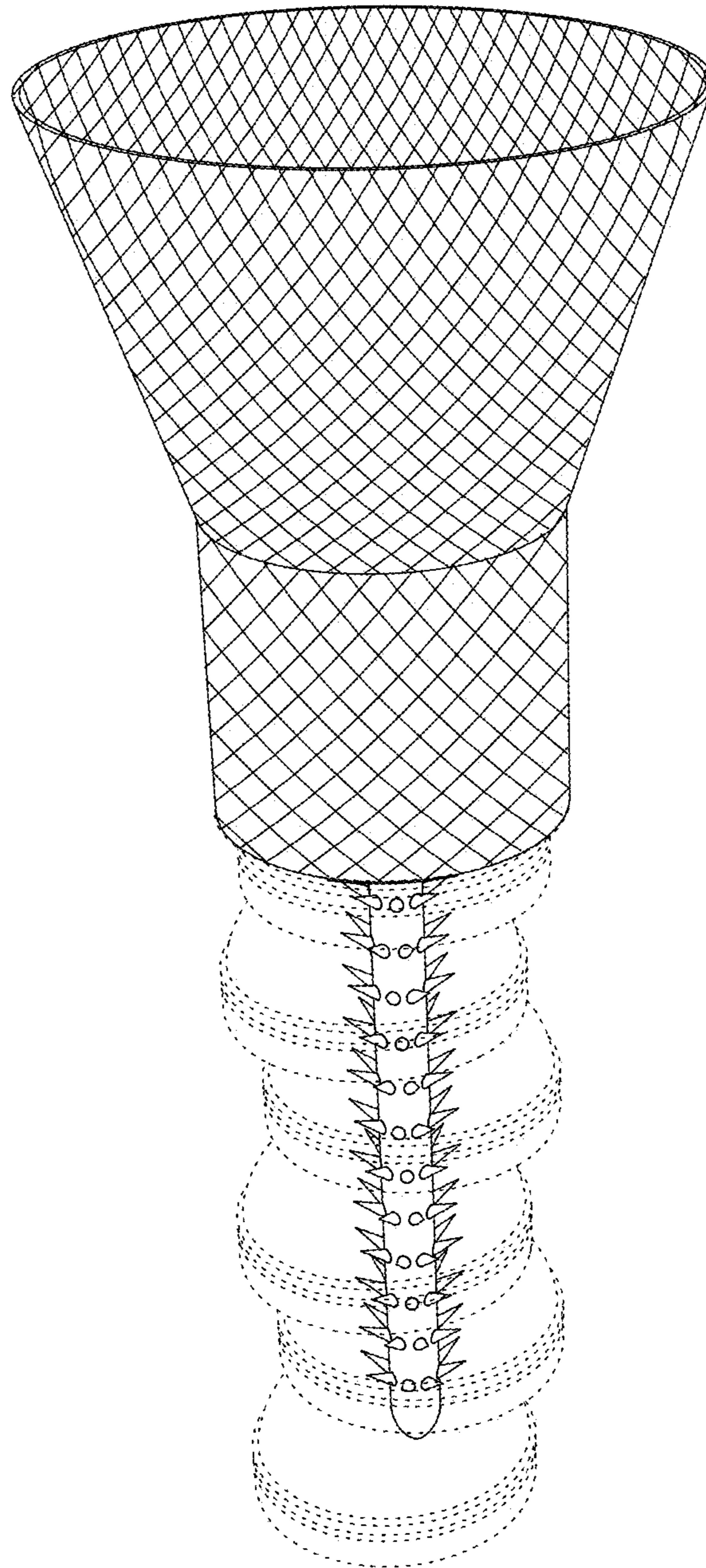

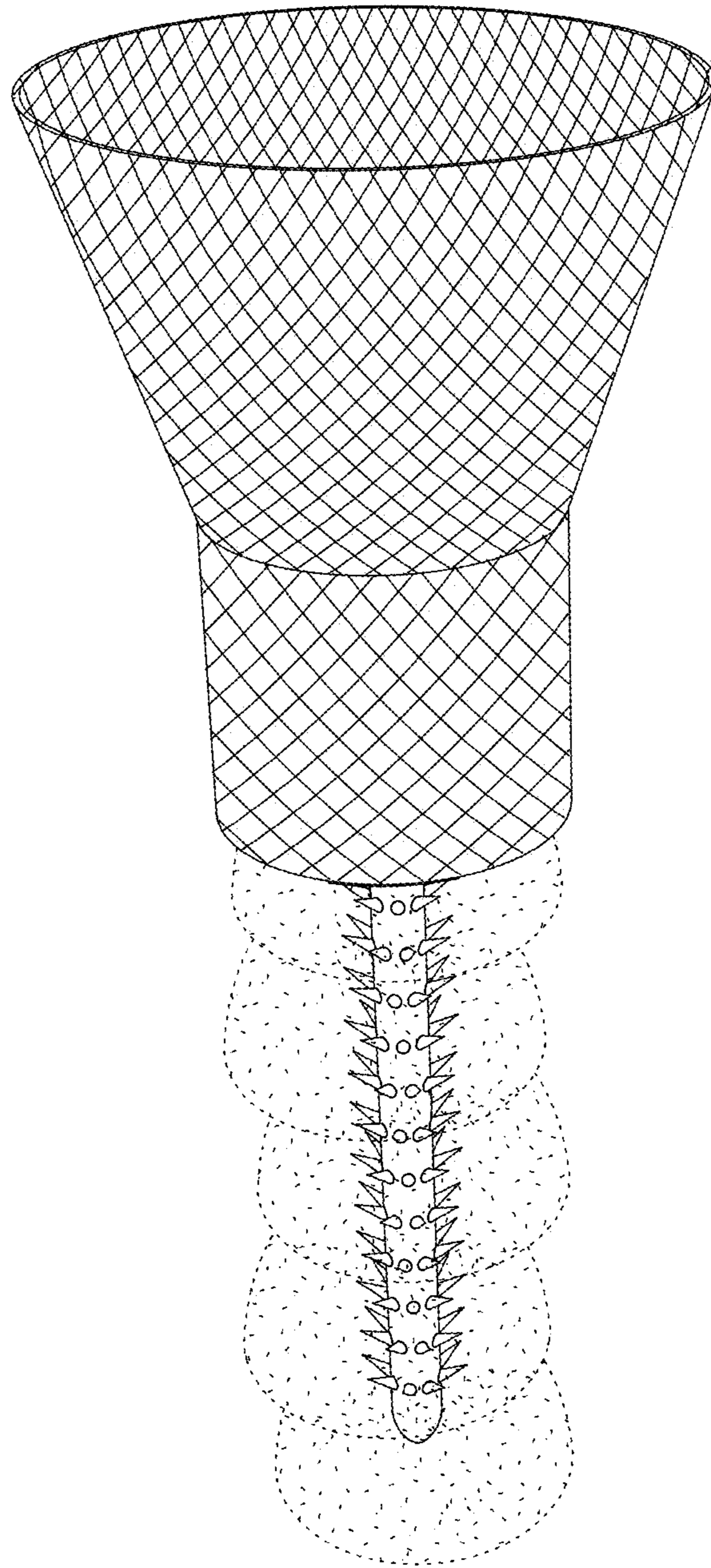

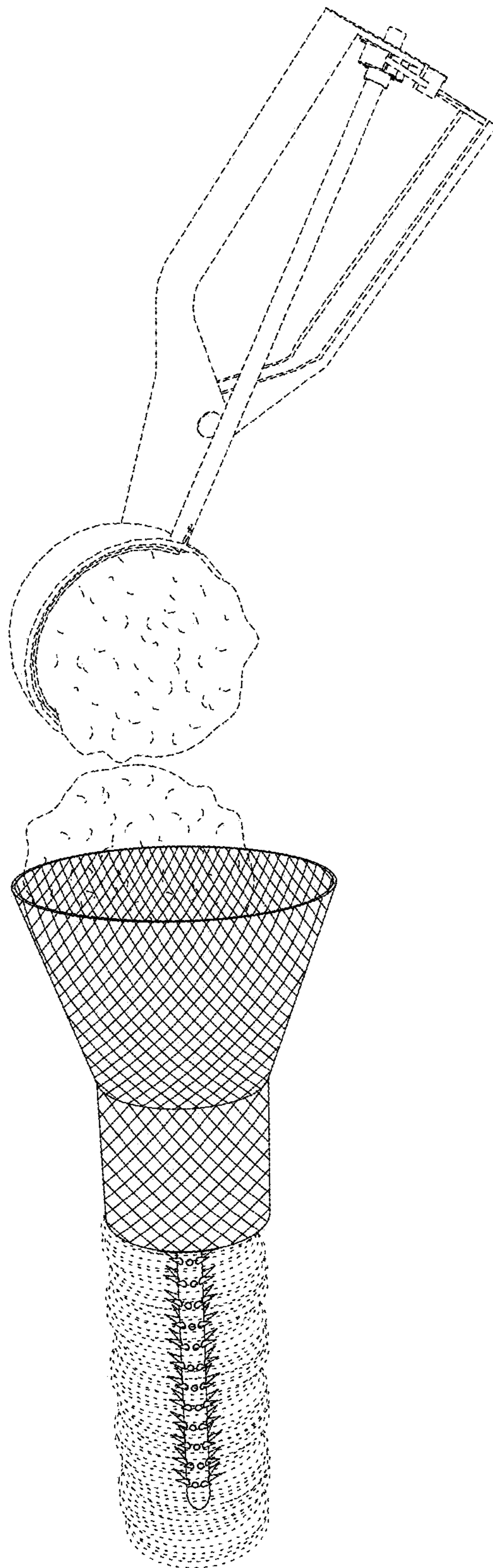
