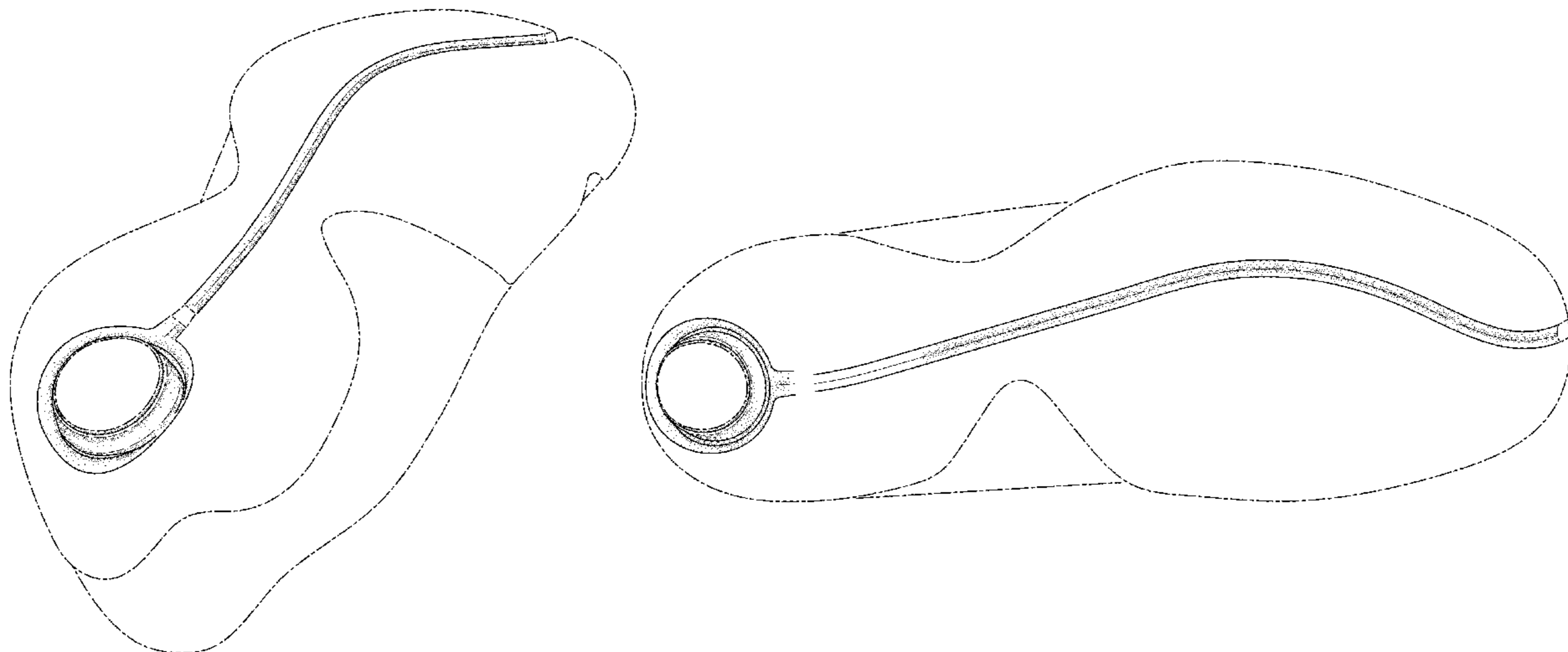
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a rear bottom perspective view of a shoe showing my new design;  
FIG. 2 is a bottom view thereof; and,  
FIG. 3 is a front bottom perspective view thereof.  
The broken lines immediately adjacent to the ends of the shaded areas define the bounds of the claimed design and form no part thereof. 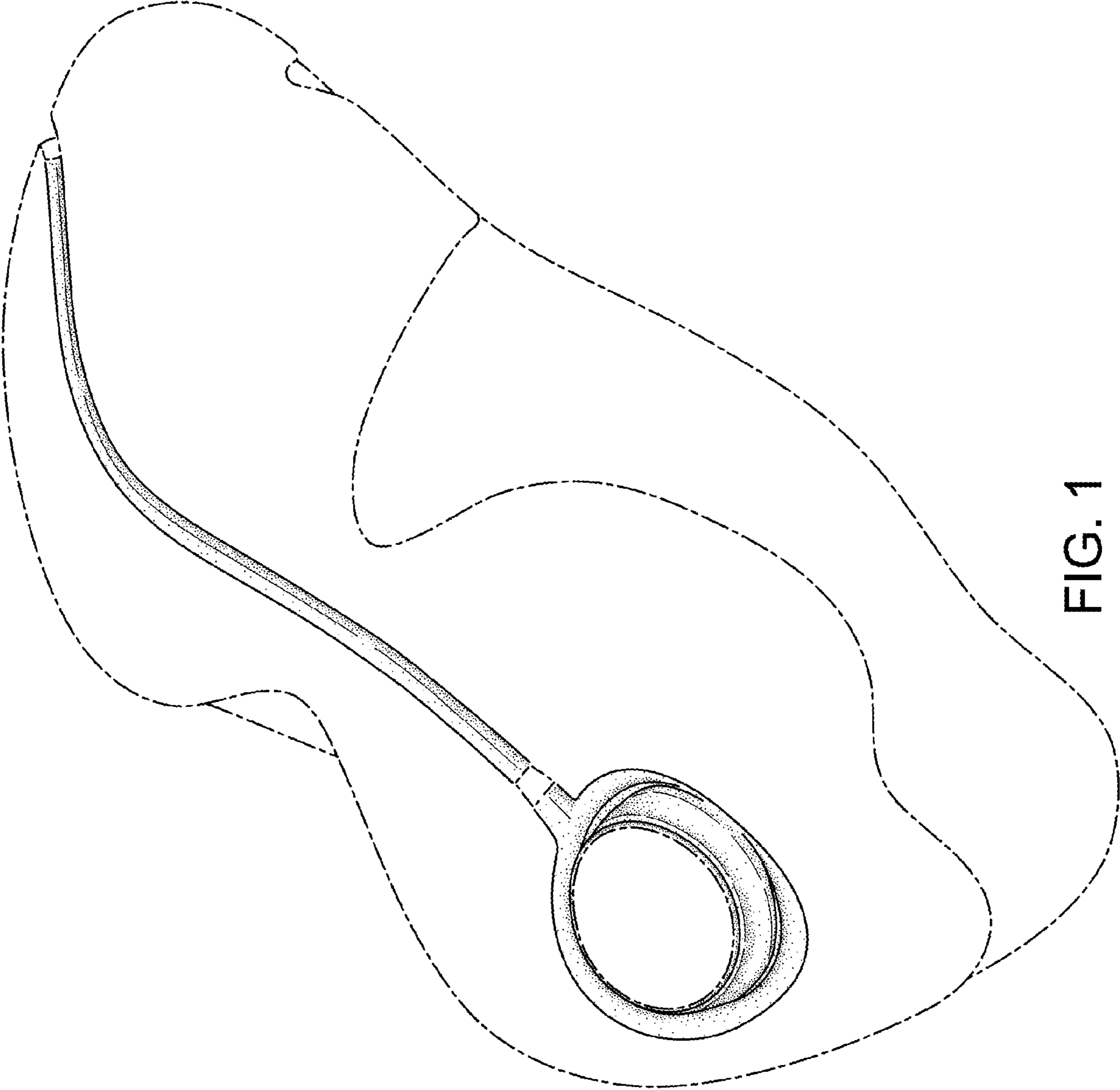

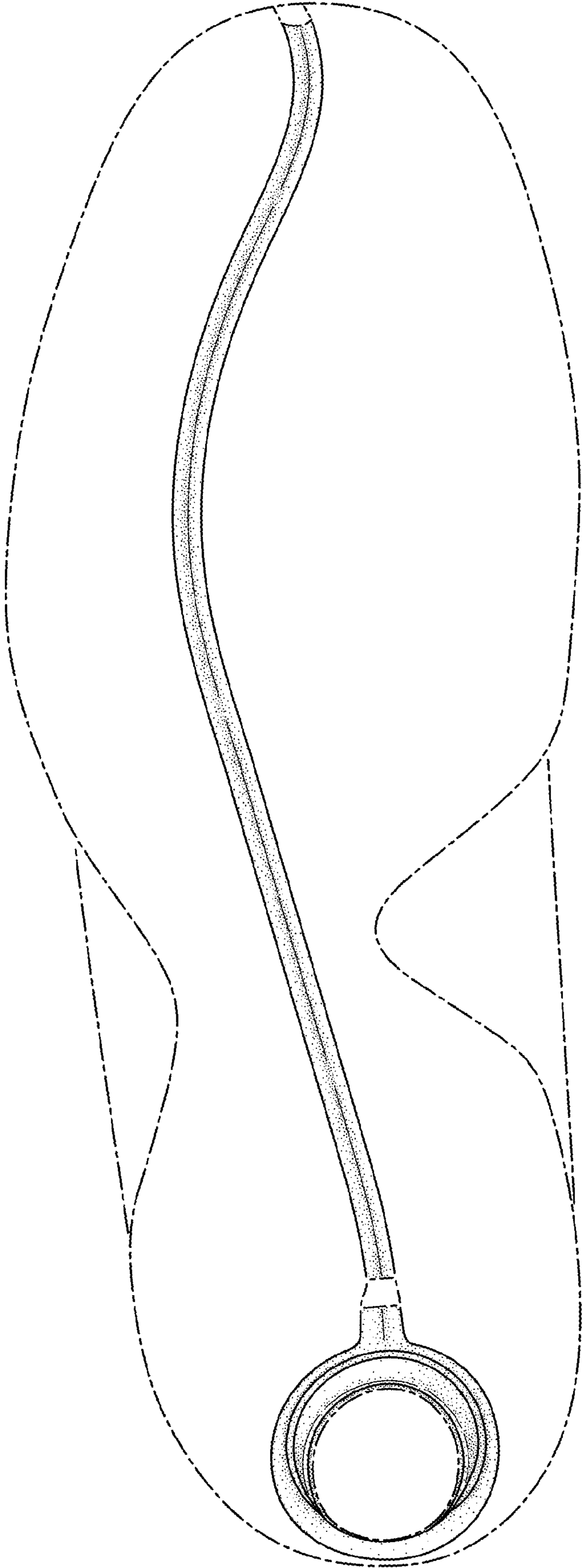

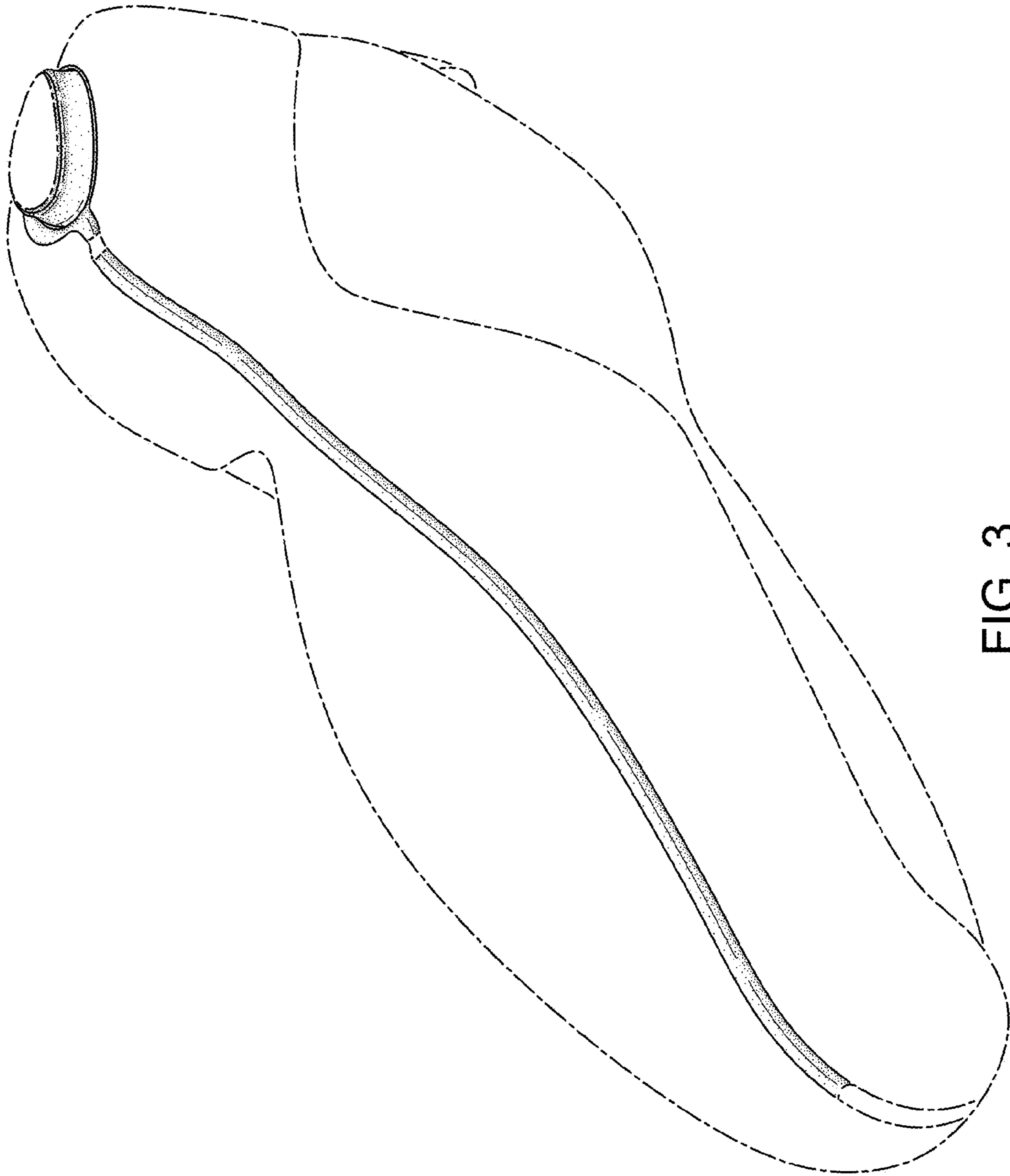
