DESCRIPTION

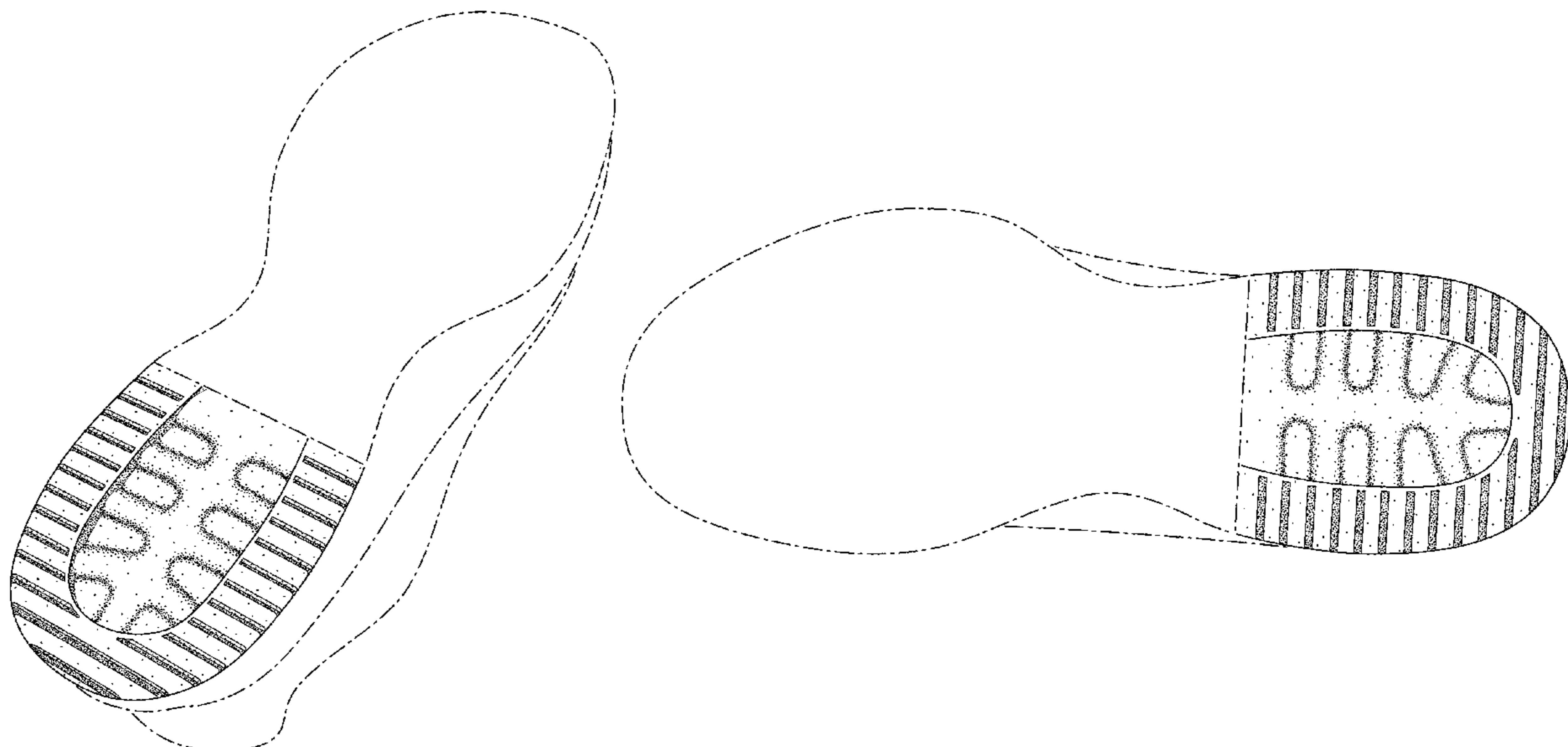
FIG. 1 is a rear perspective view of a shoe showing my new design;

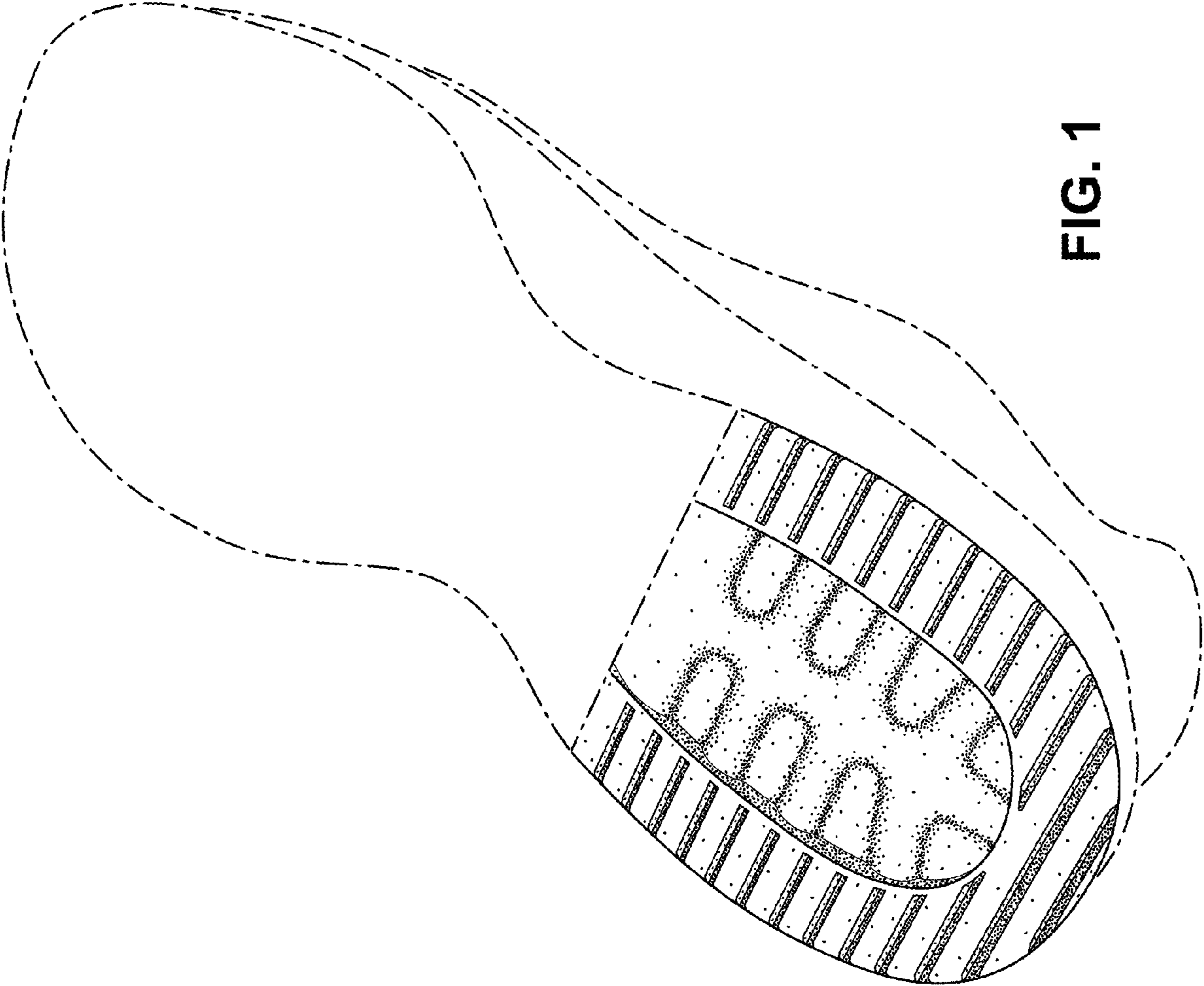

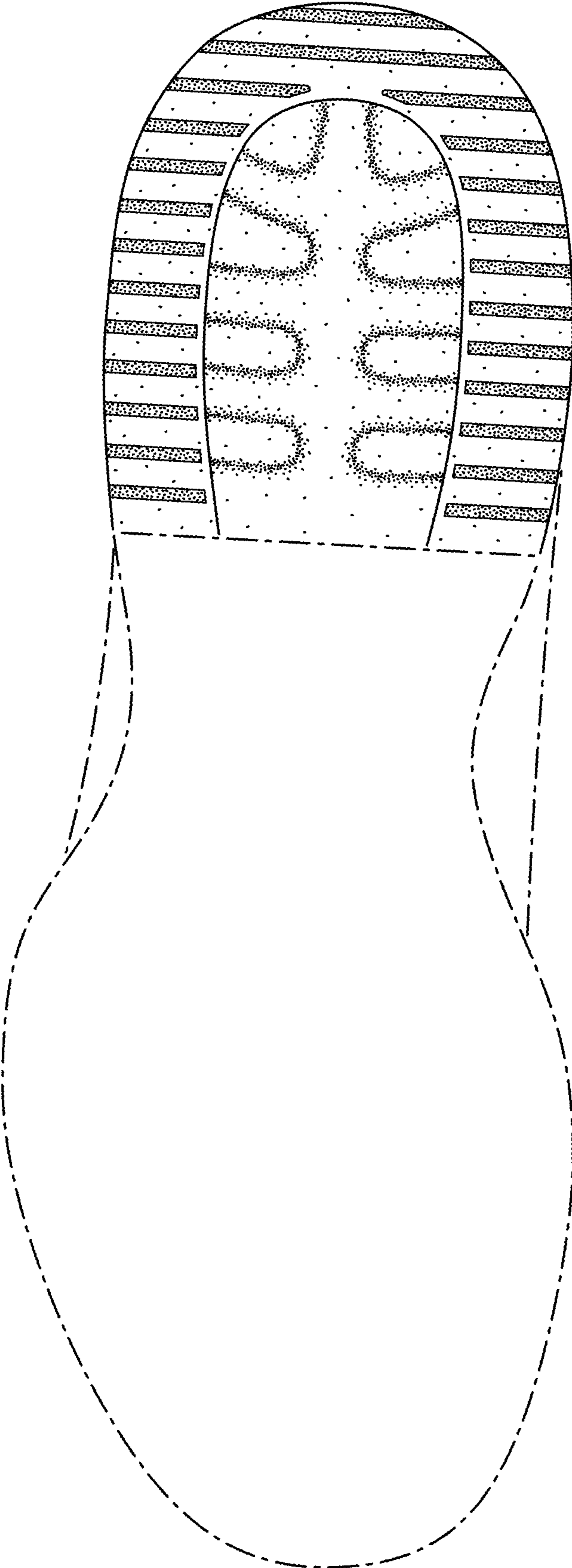

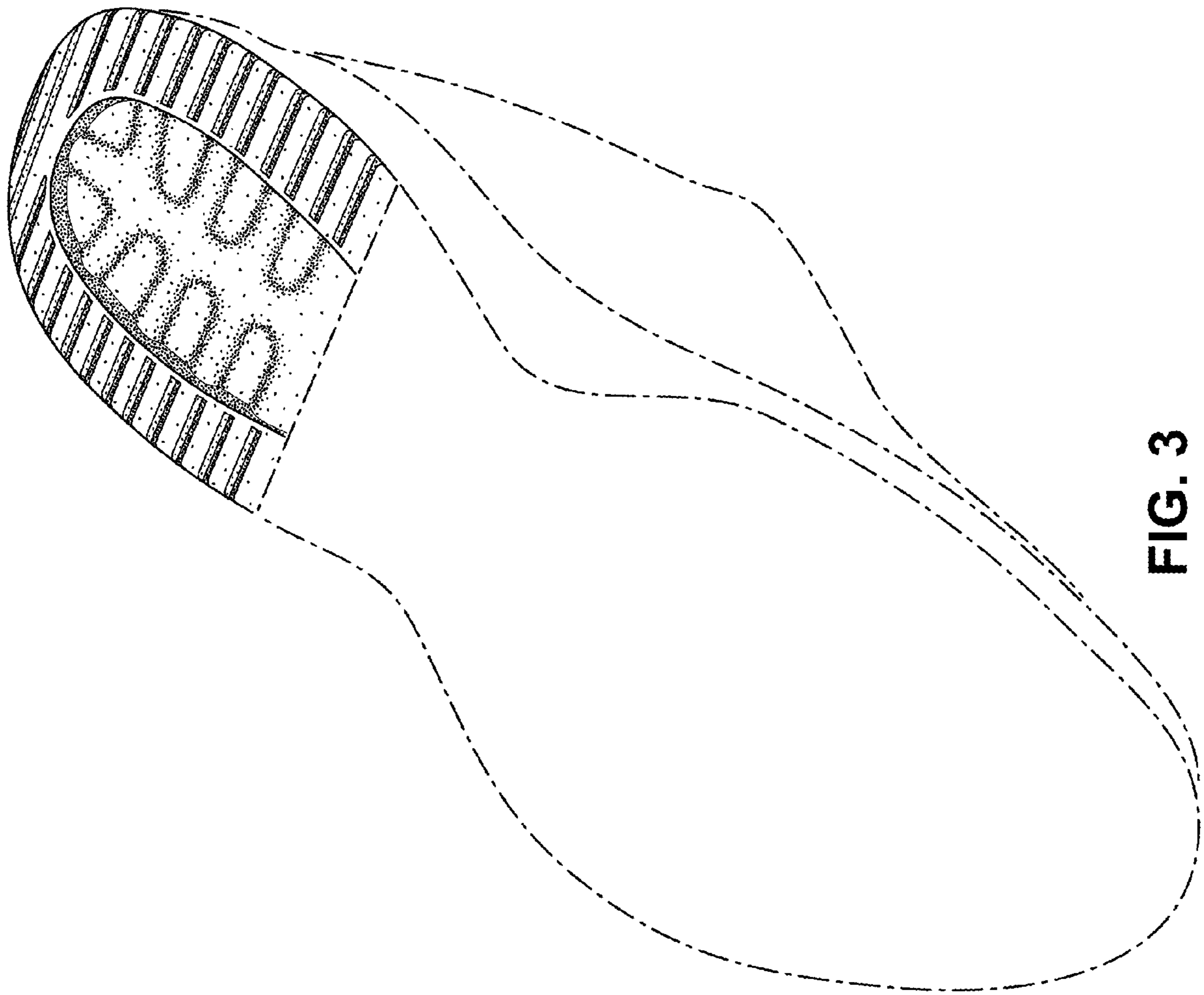
