FIG. 3 is a rear perspective view thereof;

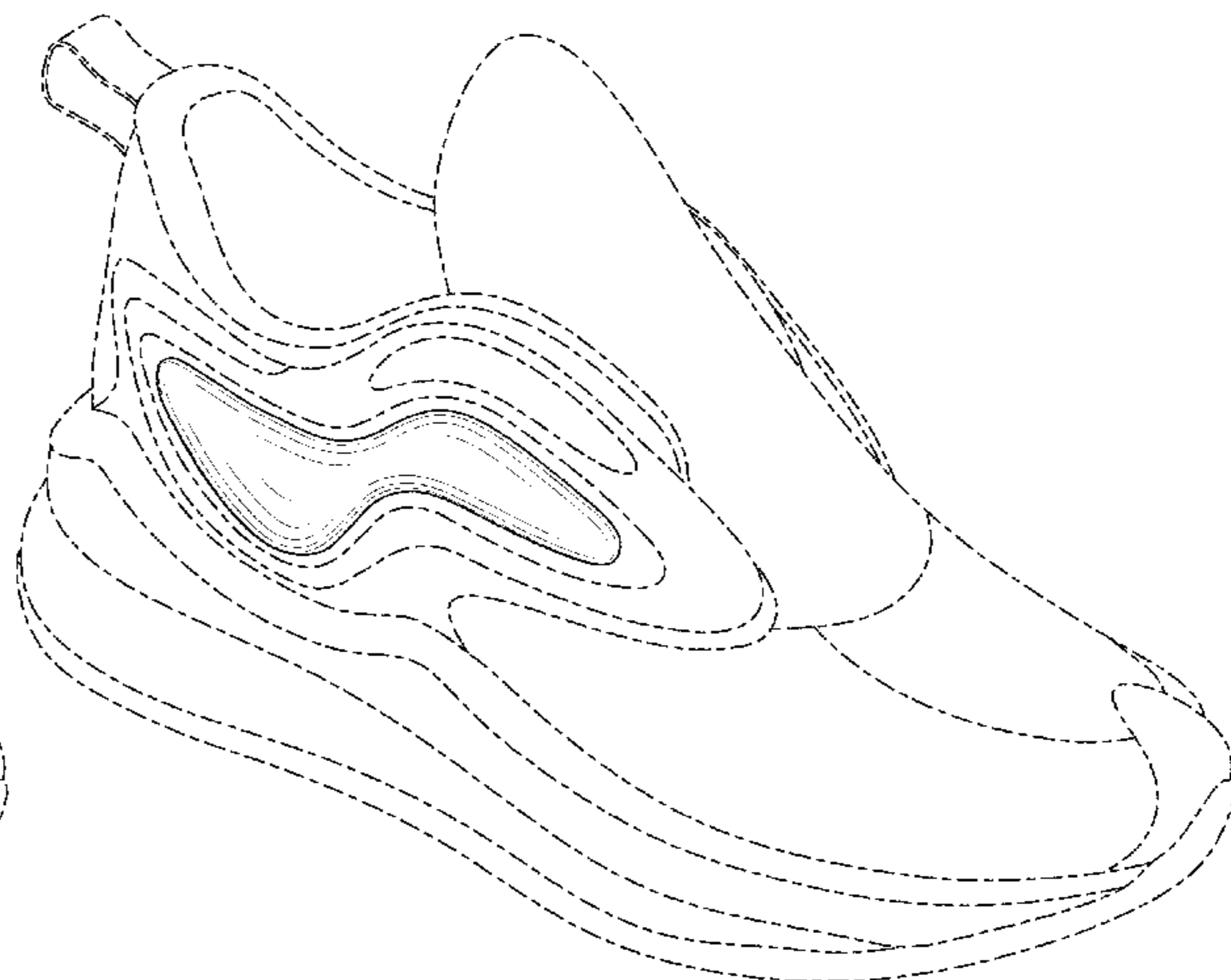
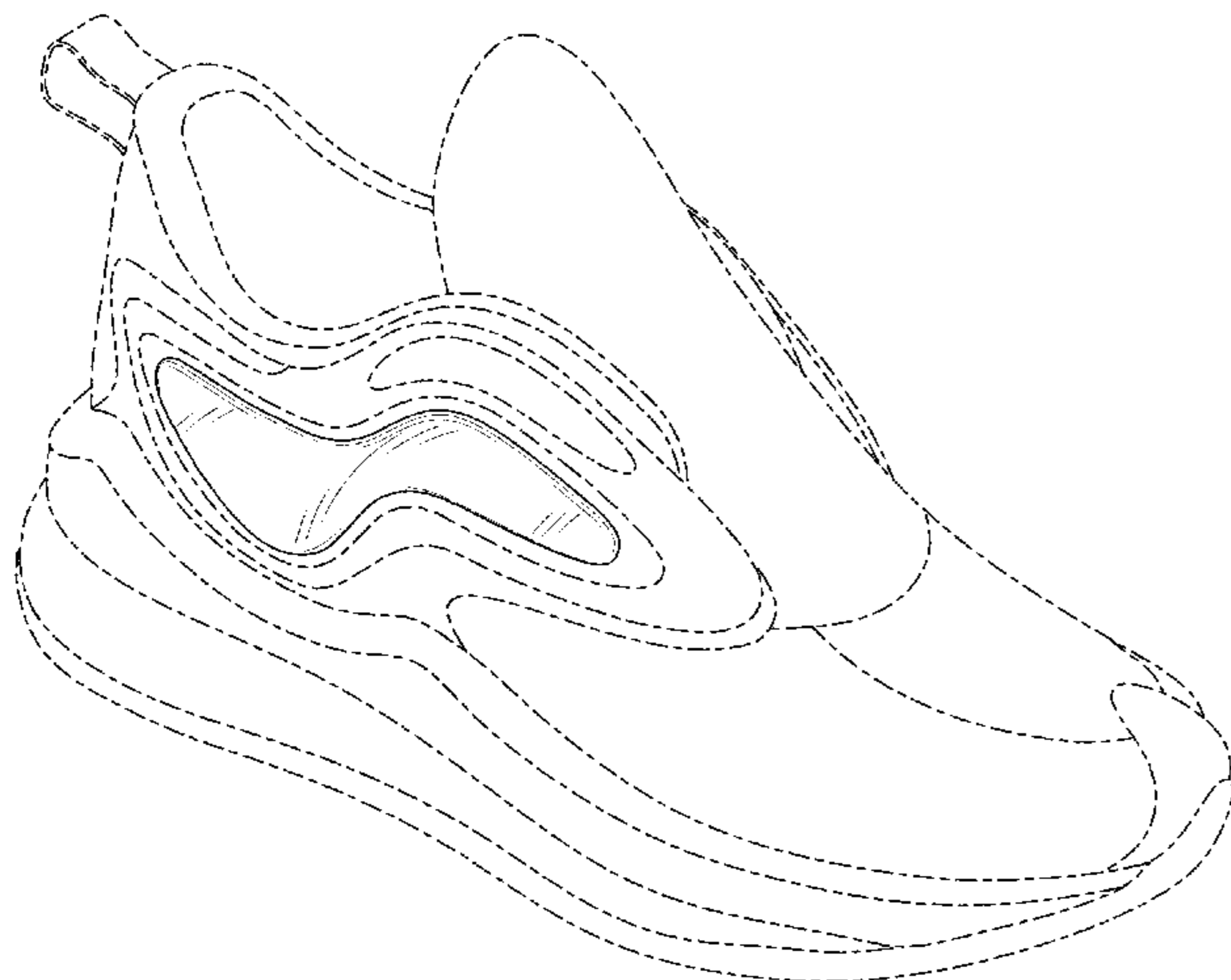
FIG. 4 is a front perspective view of an alternate embodiment of a shoe showing my new design;

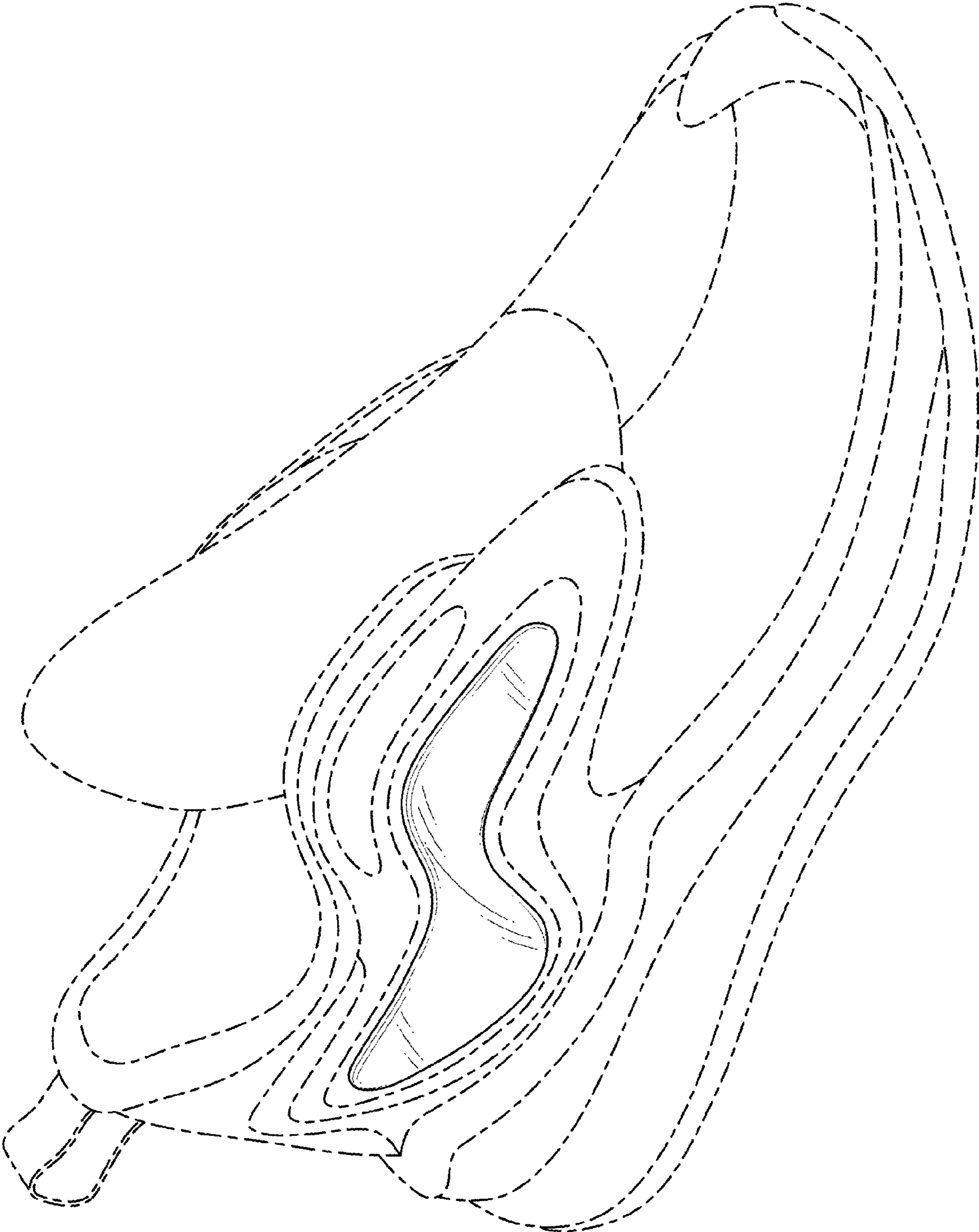

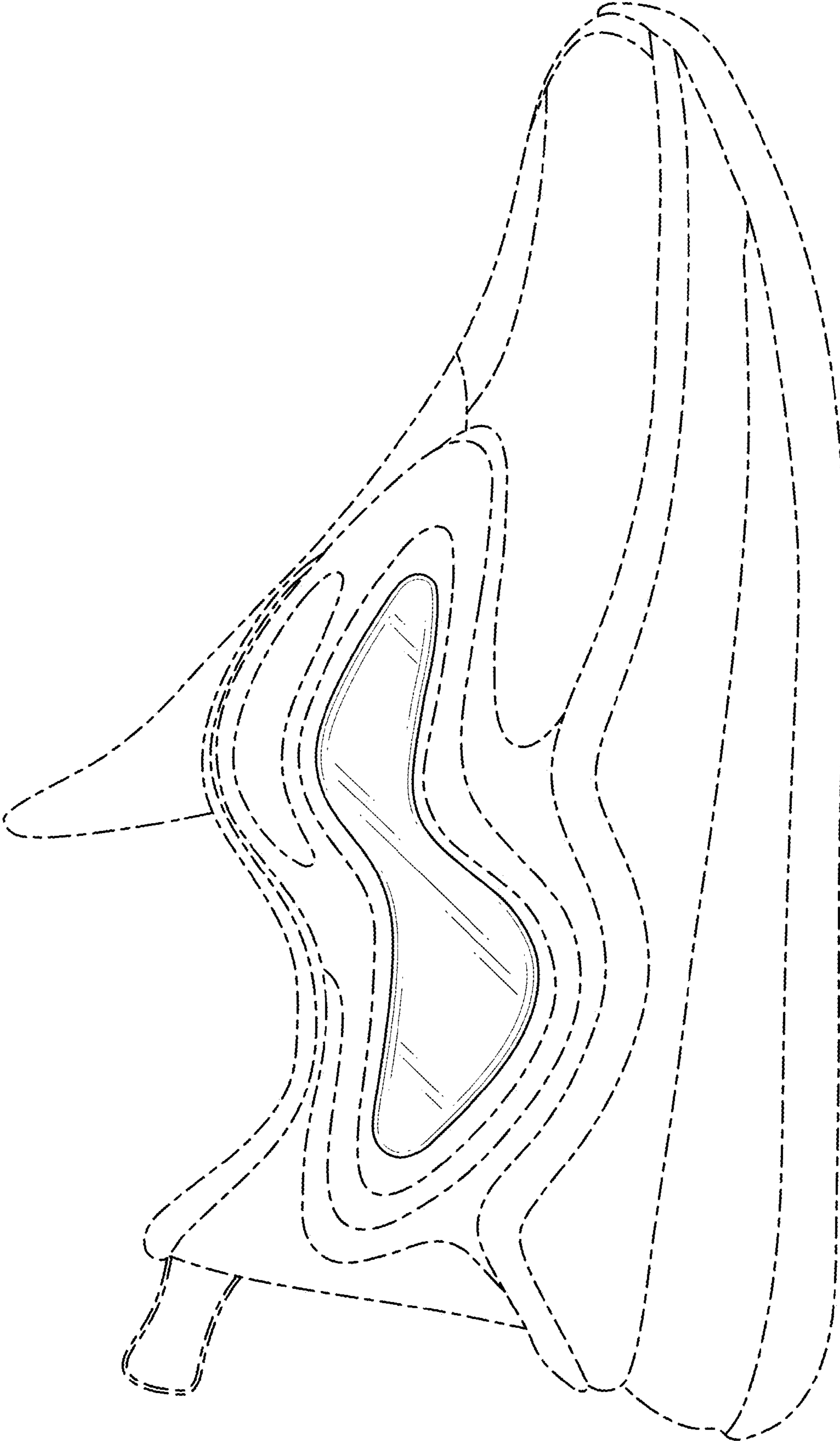

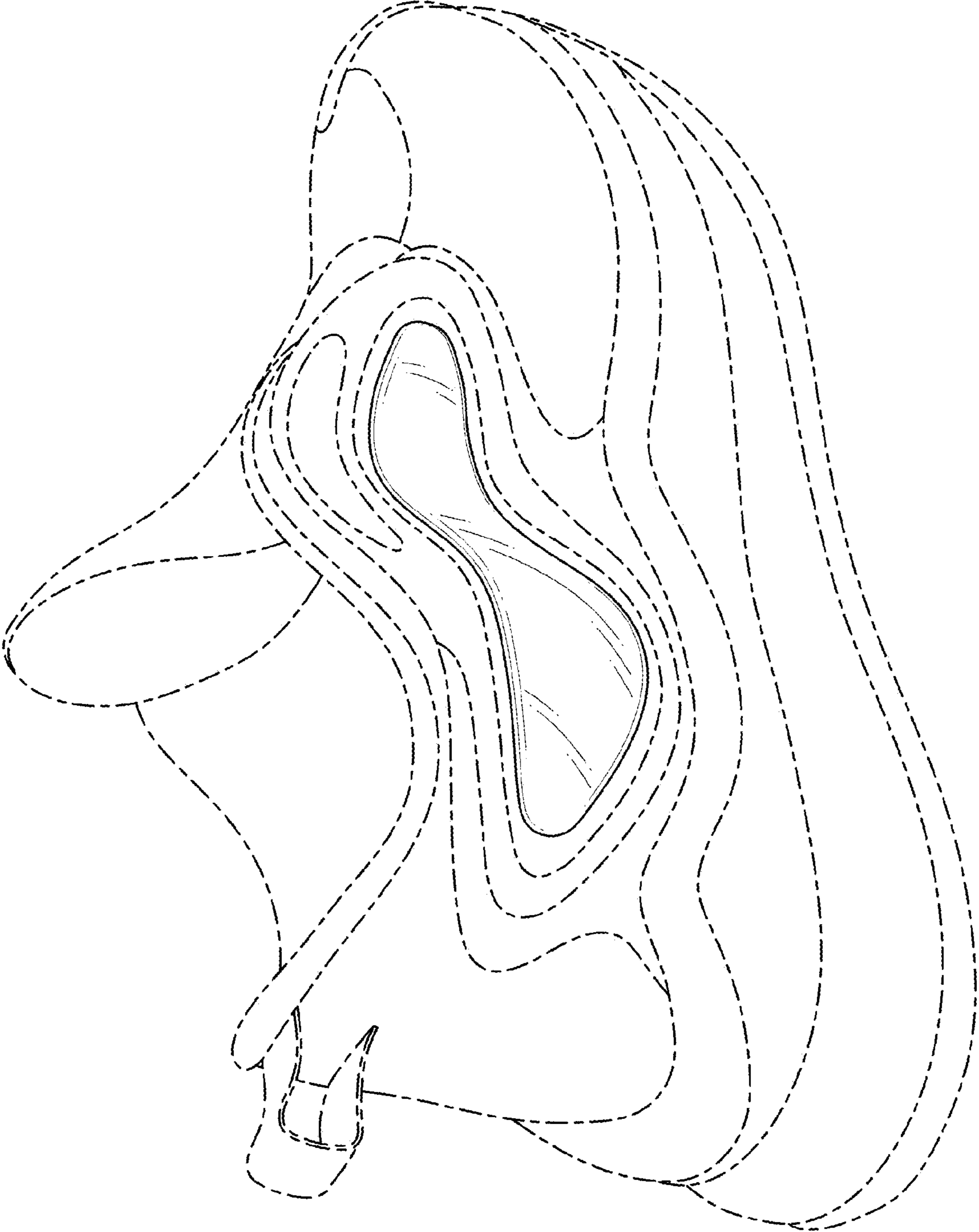

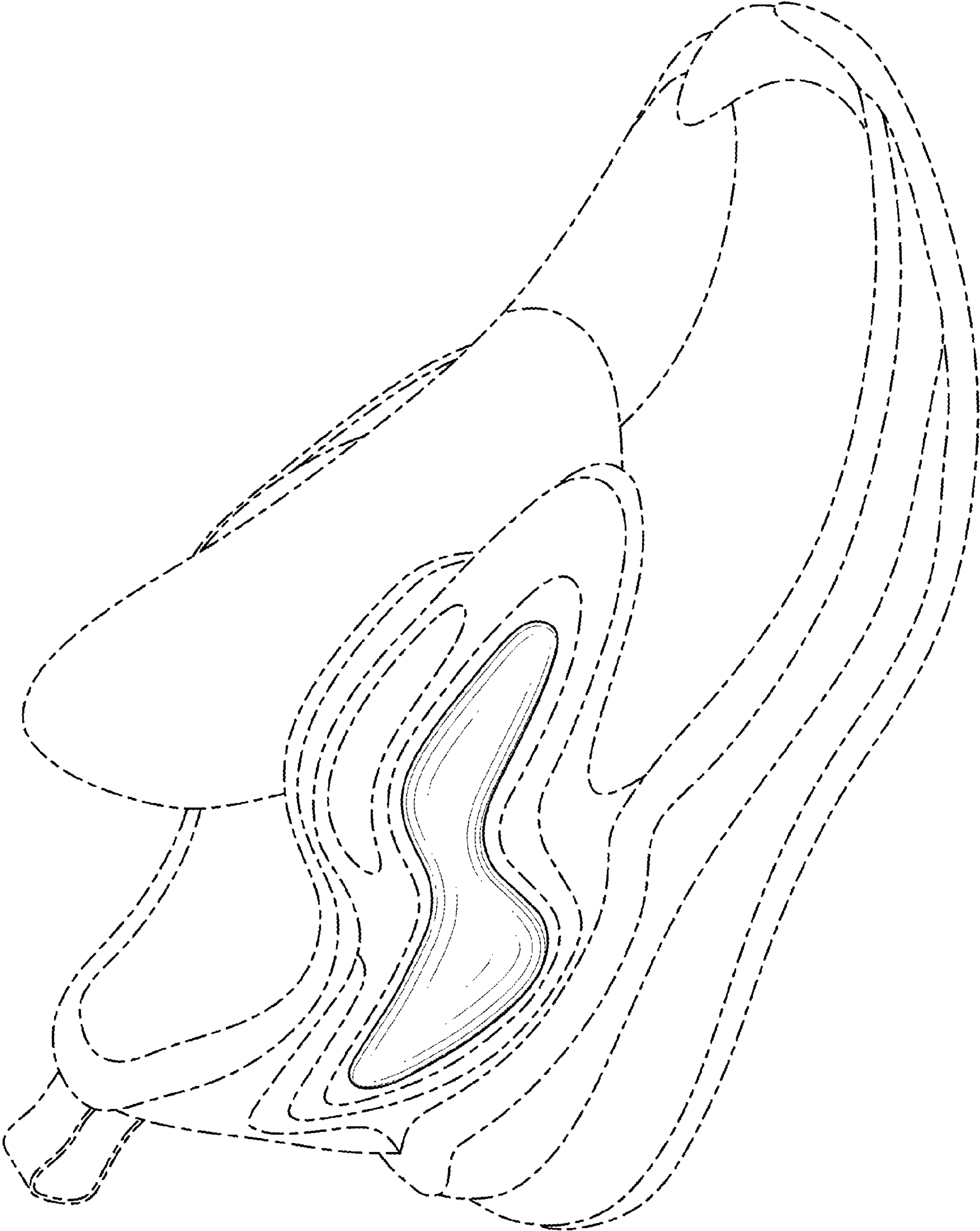

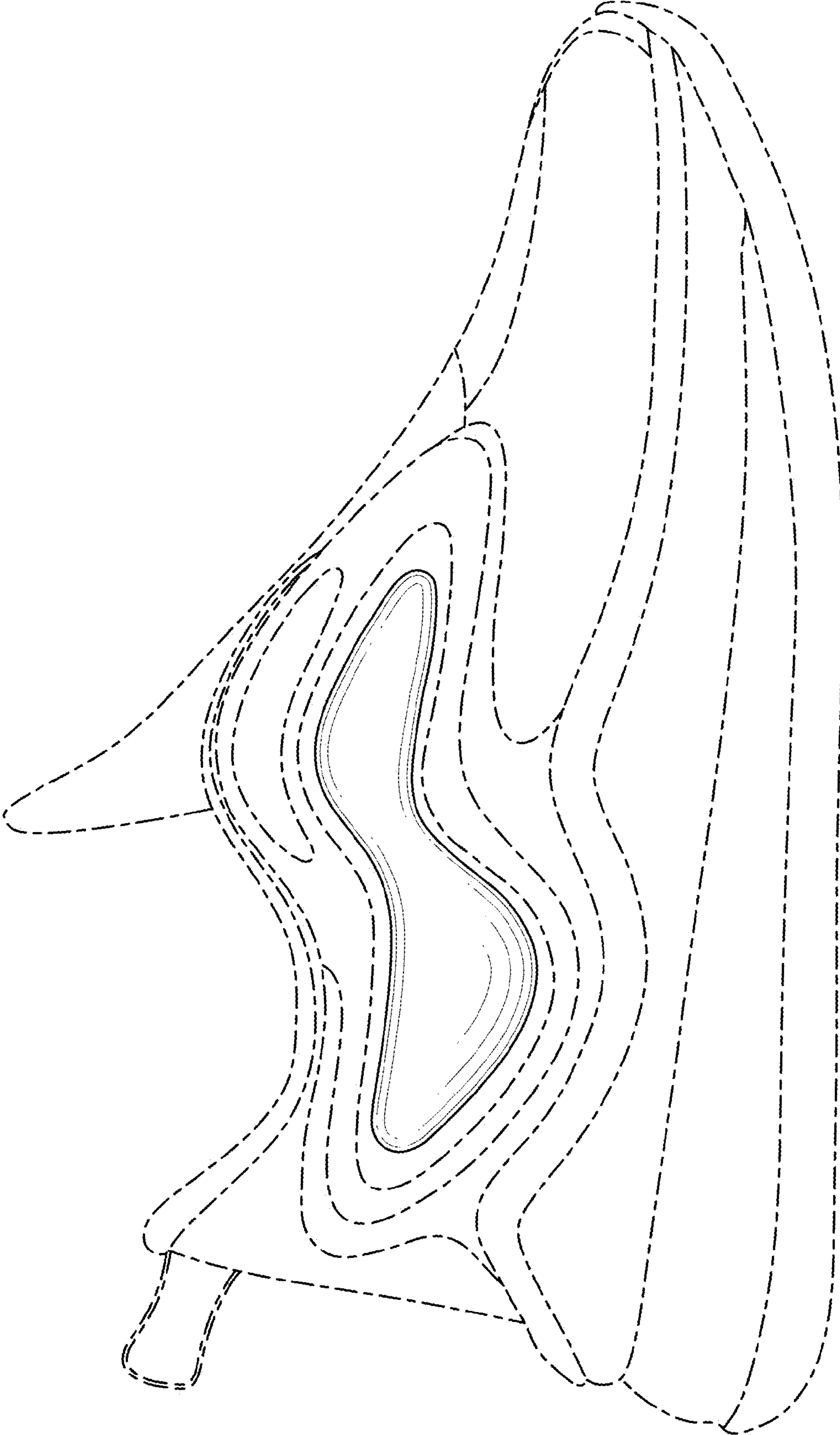

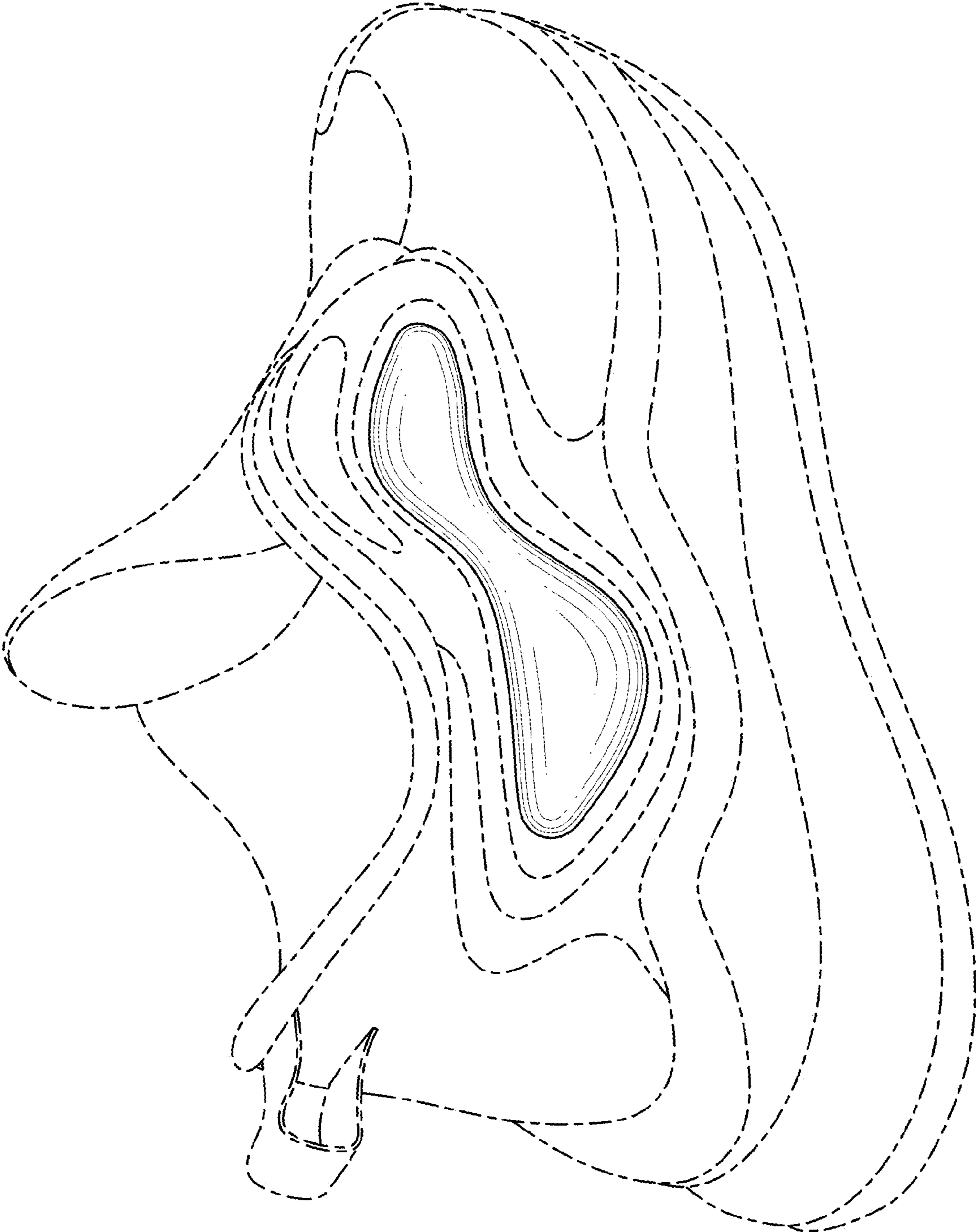
