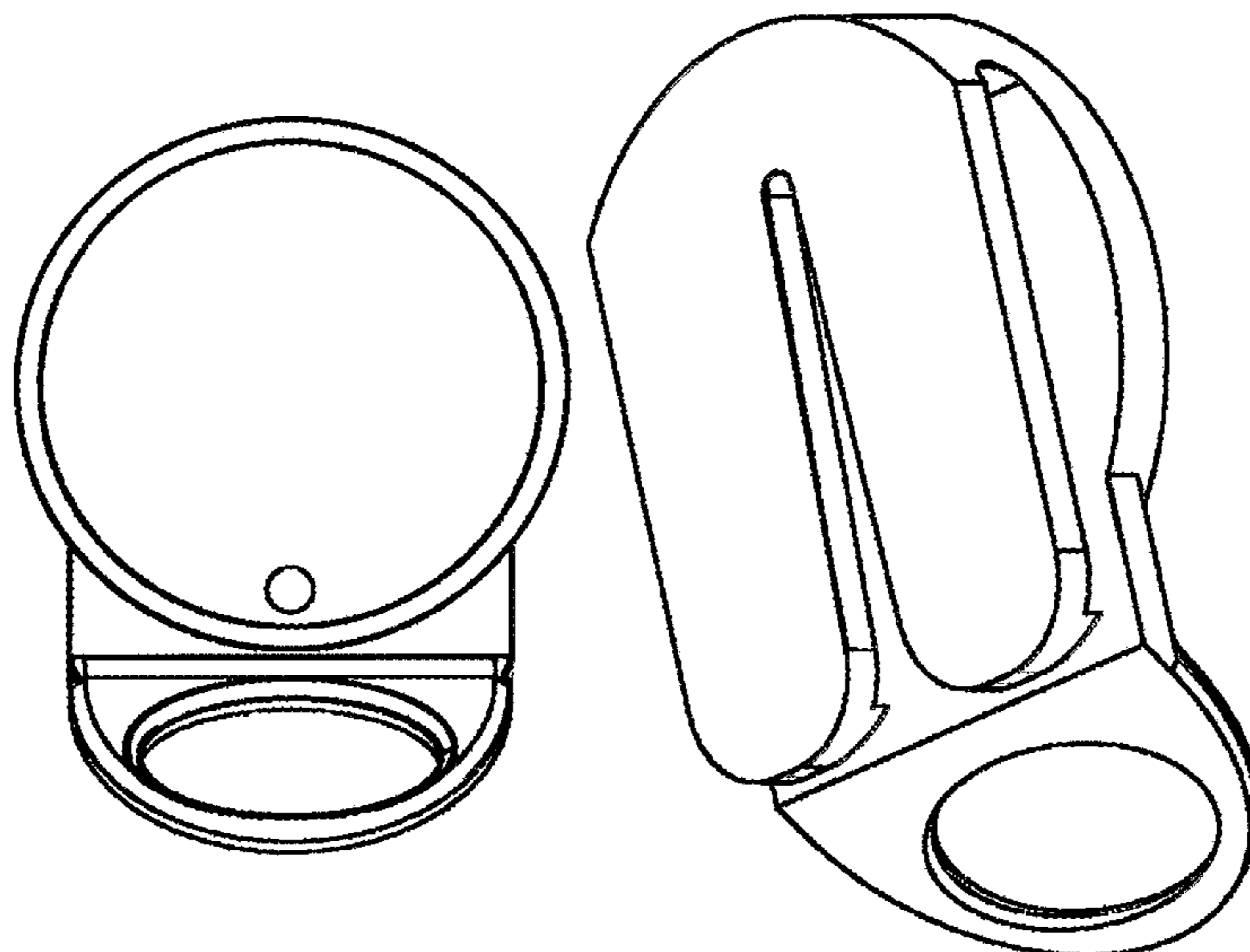
The ornamental design for a personal effects holder, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of a personal effects holder showing my design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a rear perspective view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a first front perspective view thereof; FIG. 9 is a second front perspective view thereof; FIG. 10 is a front elevational view thereof including an insert; FIG. 11 is a front elevation view of a second embodiment of a personal effects holder showing my design; FIG. 12 is a left side elevational view thereof; FIG. 13 is a rear elevational view thereof; FIG. 14 is a rear perspective view thereof; FIG. 15 is a right side elevational view thereof; FIG. 16 is a top plan view thereof; FIG. 17 is a bottom plan view thereof; FIG. 18 is a first front perspective view thereof; FIG. 19 is a second front perspective view thereof; and, FIG. 20 is a front elevational view thereof including an insert.

The broken lines showing an insert in the FIGS. 10 and 20 views show environmental structure associated with the design in a condition of use and form no part of the claimed design.

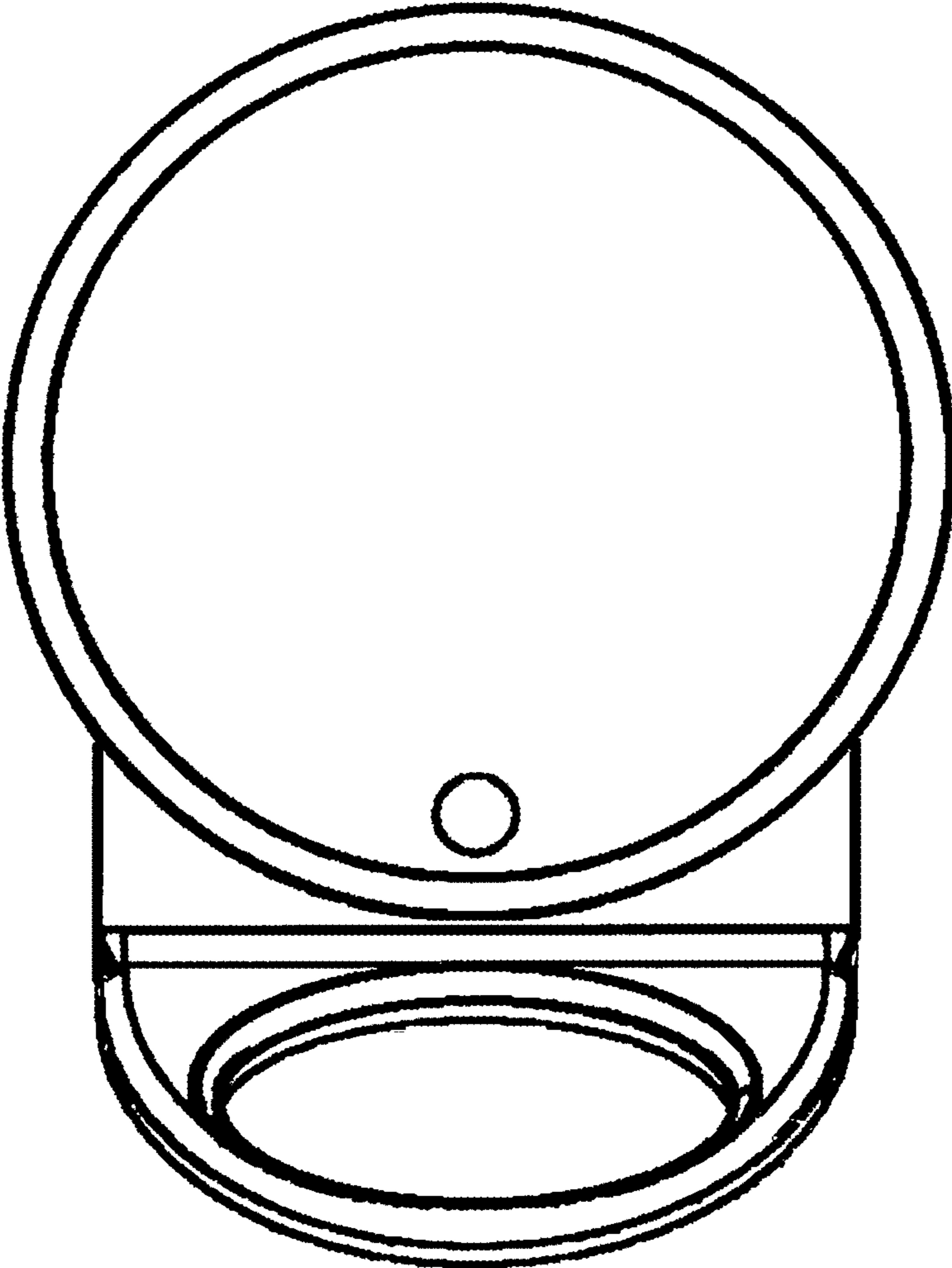

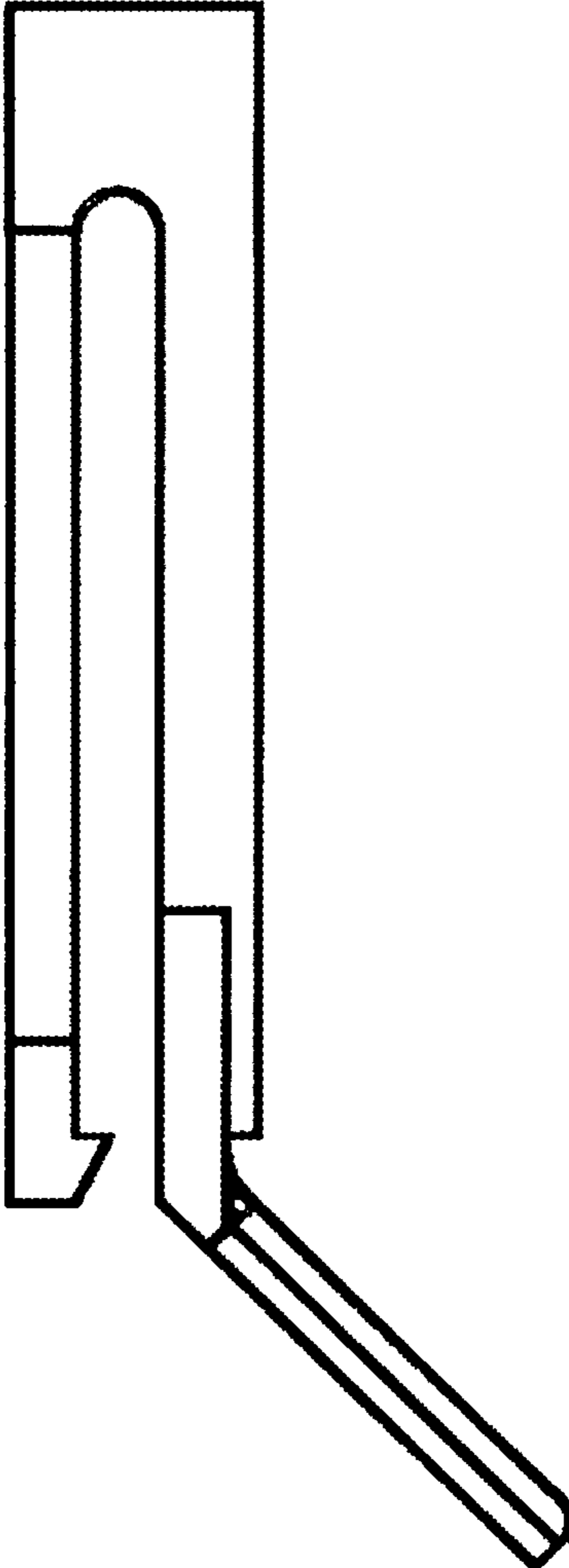

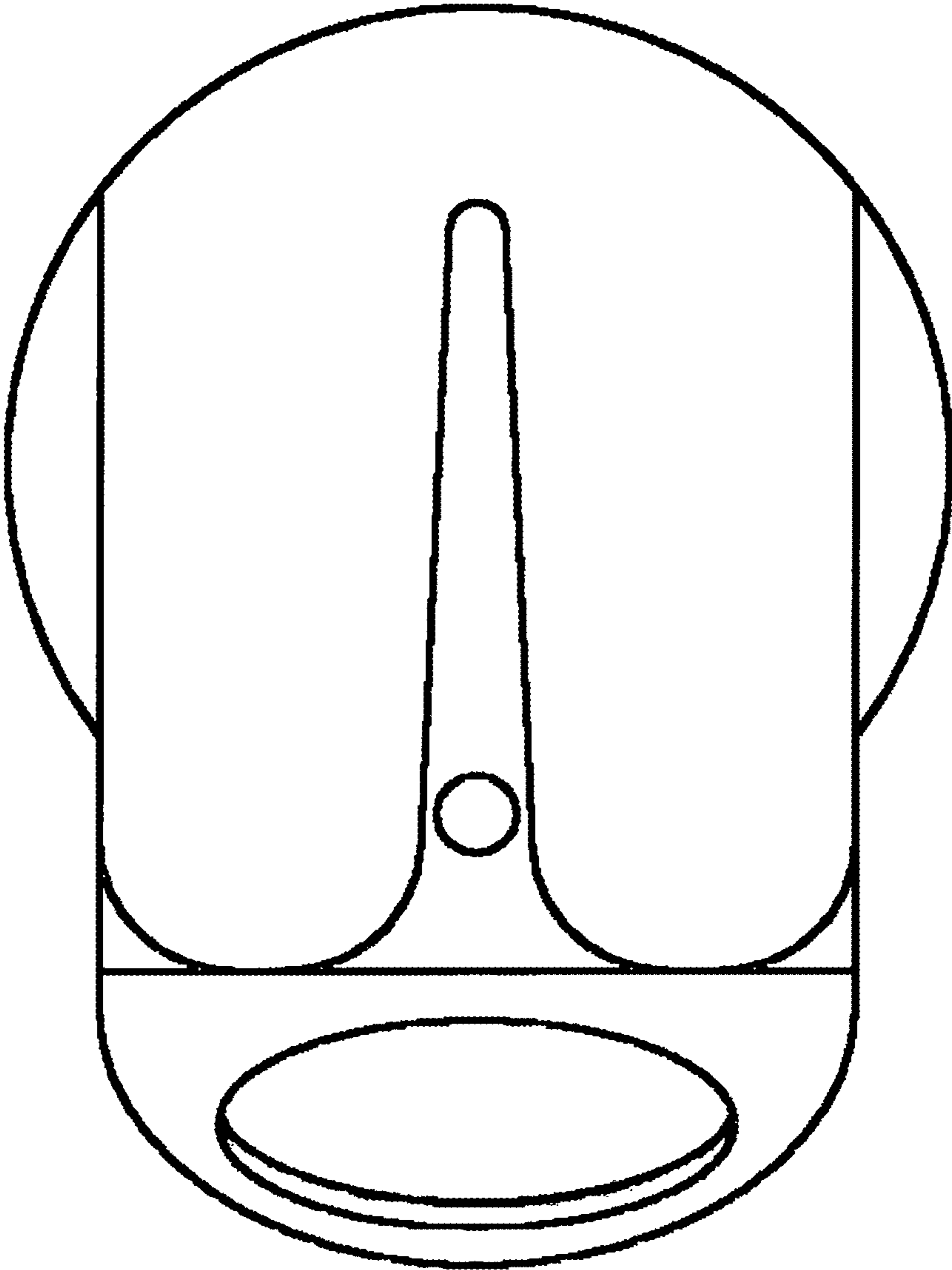

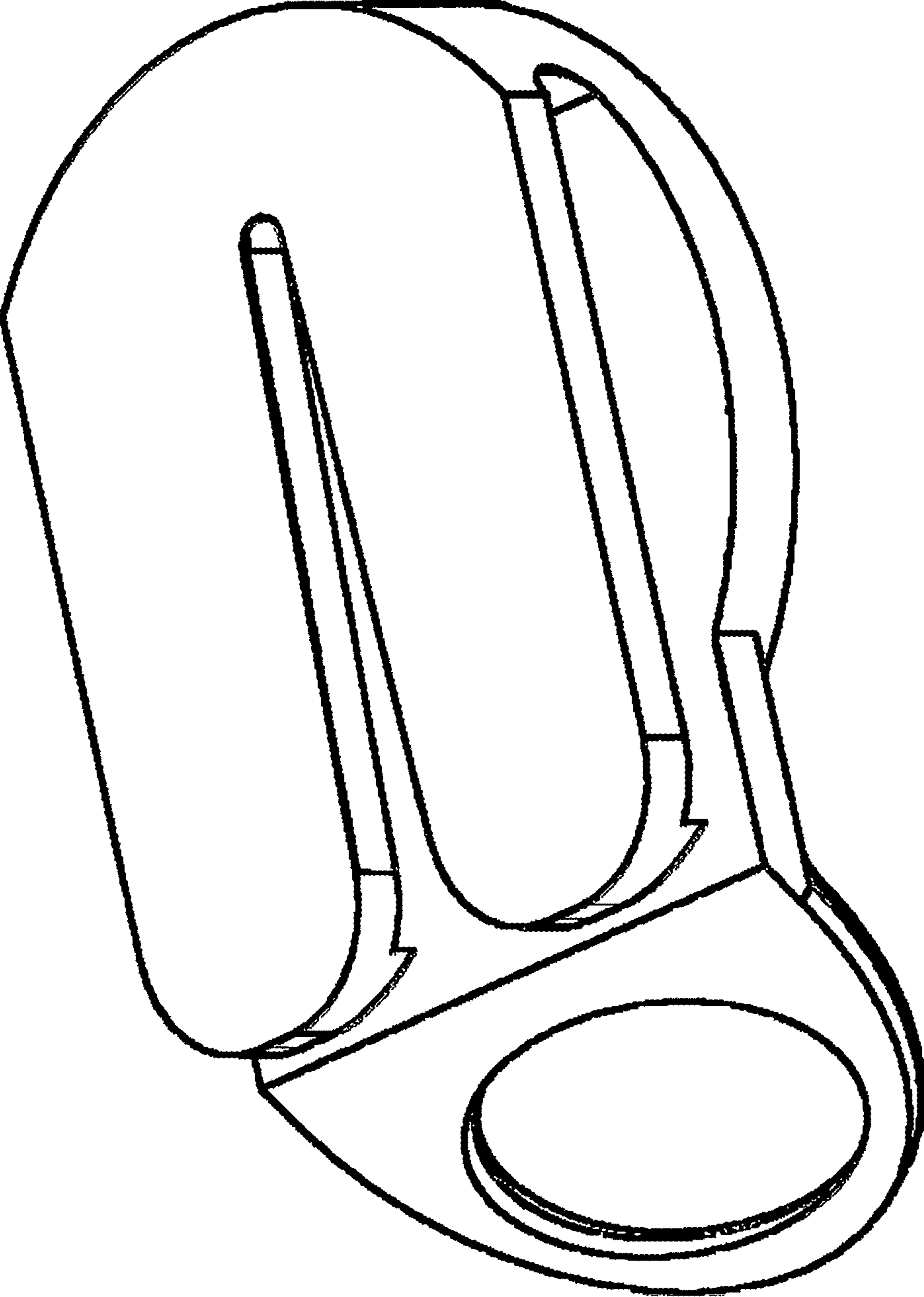

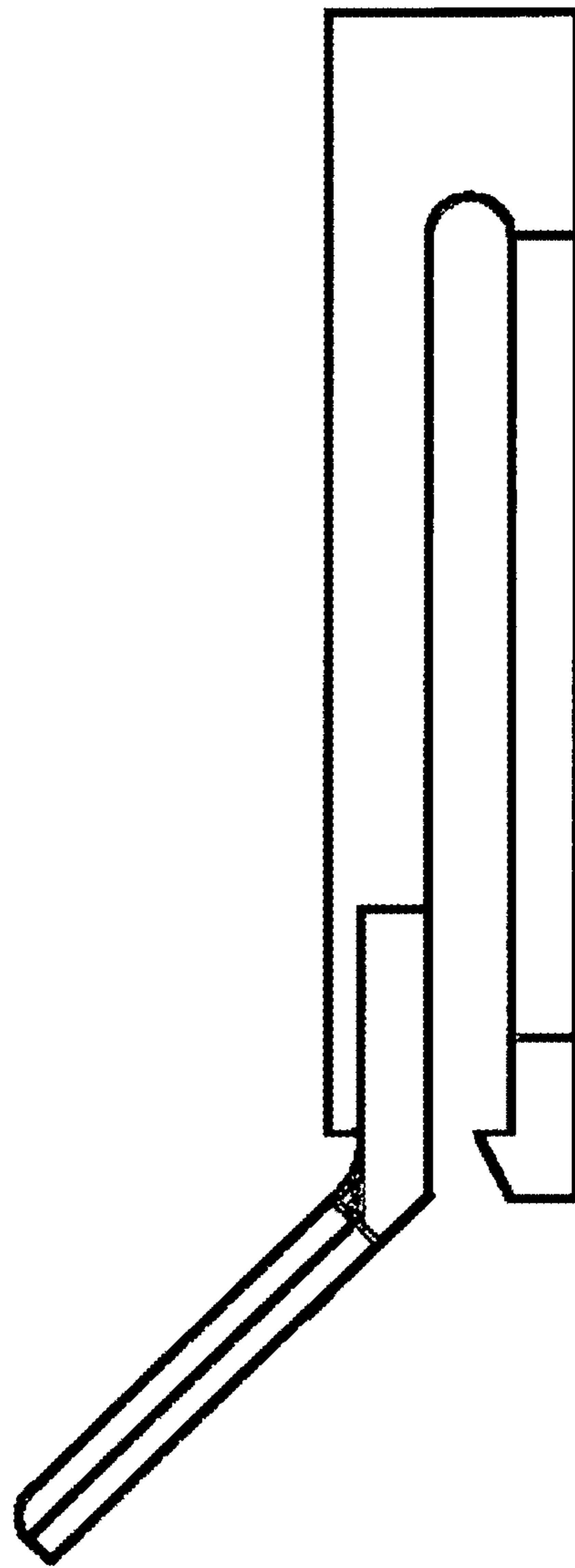

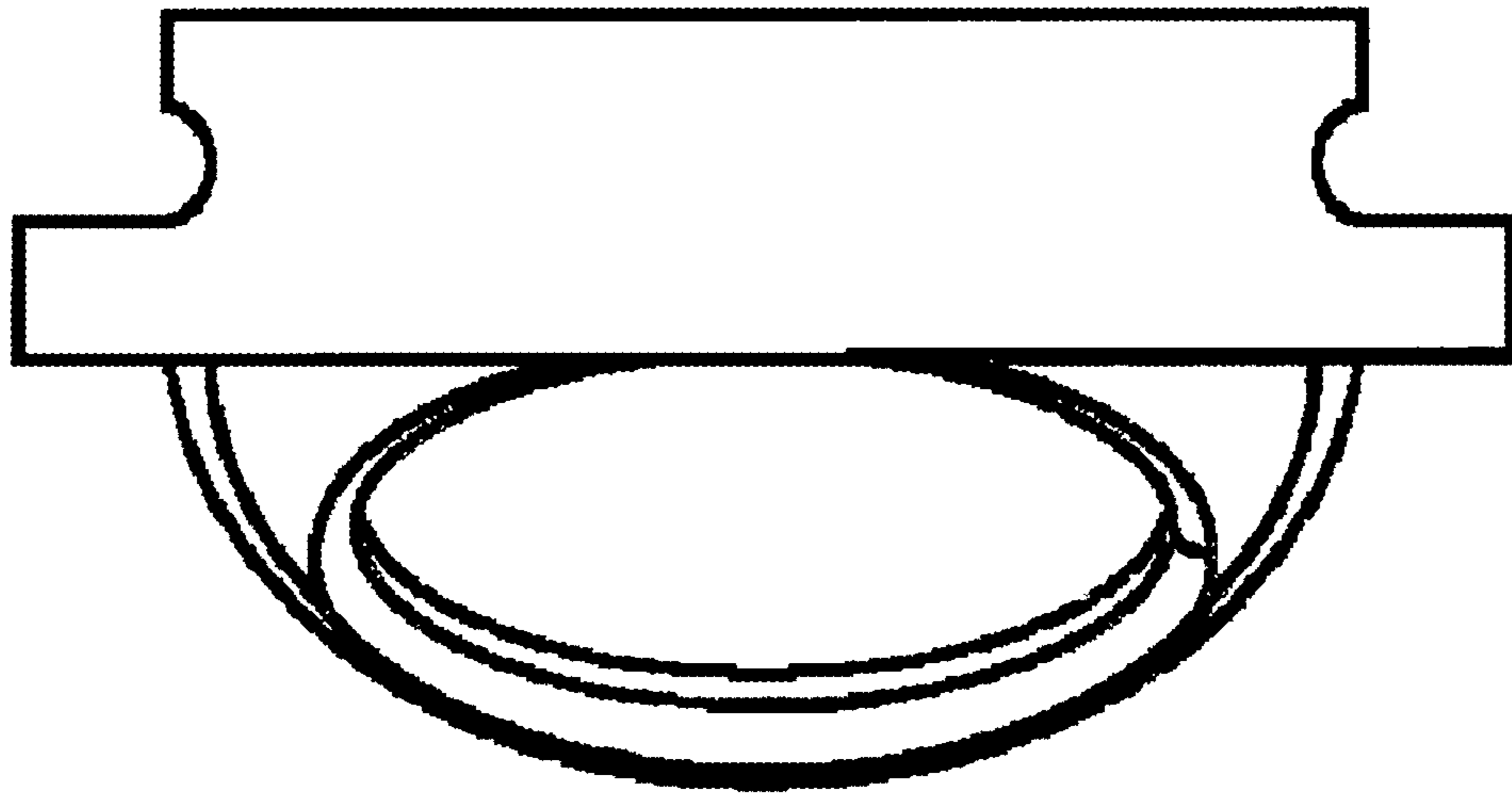

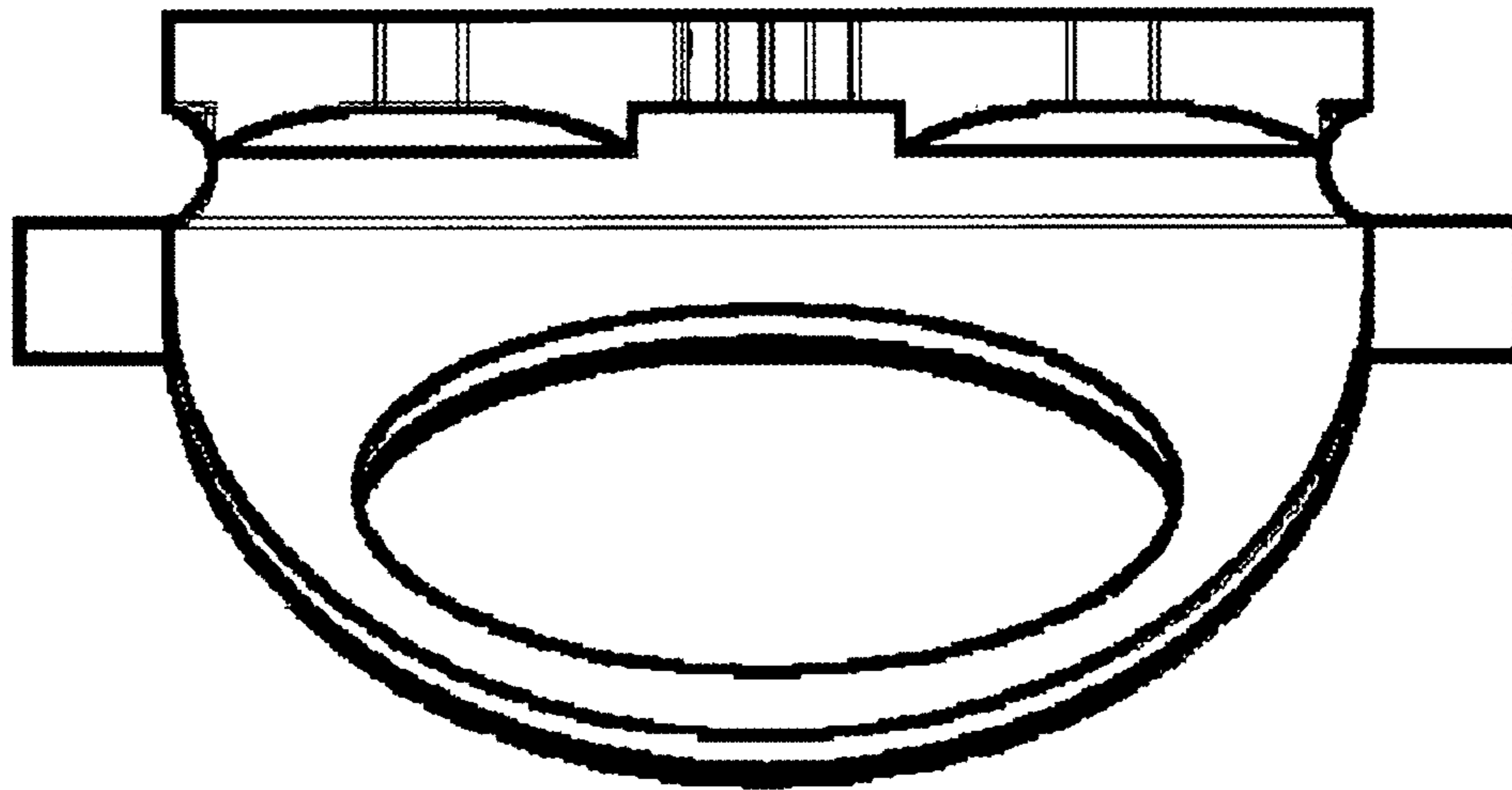

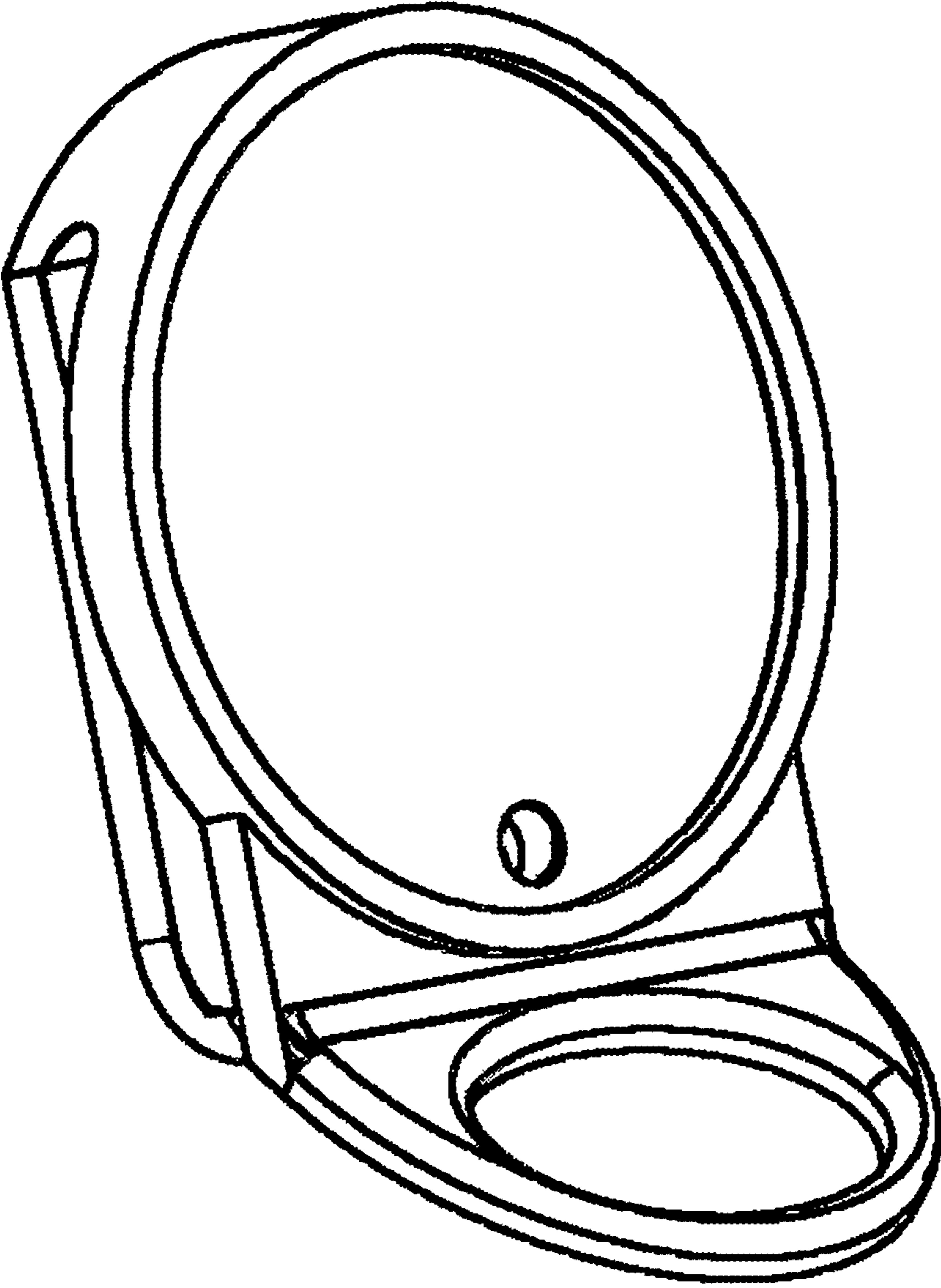

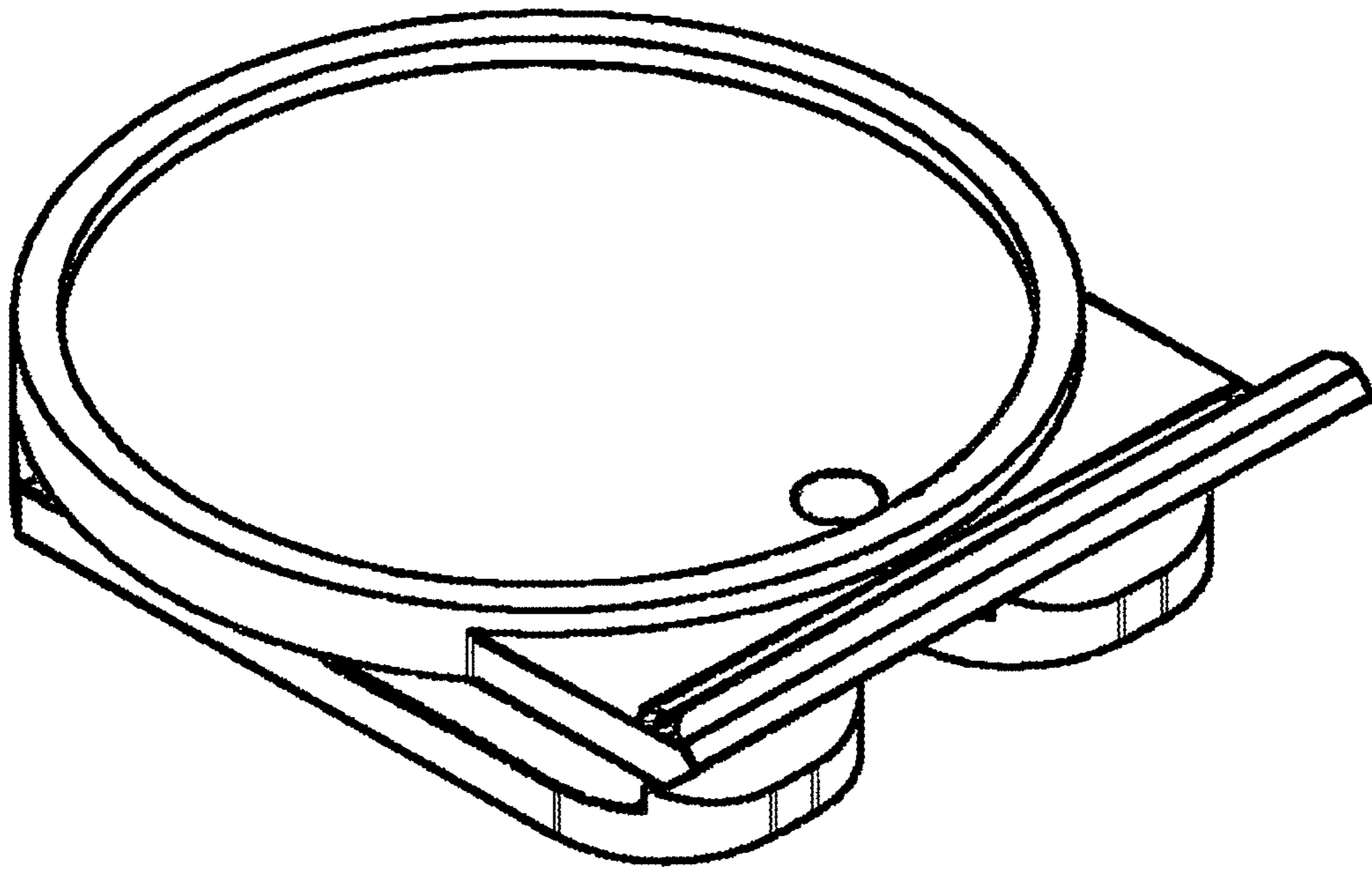

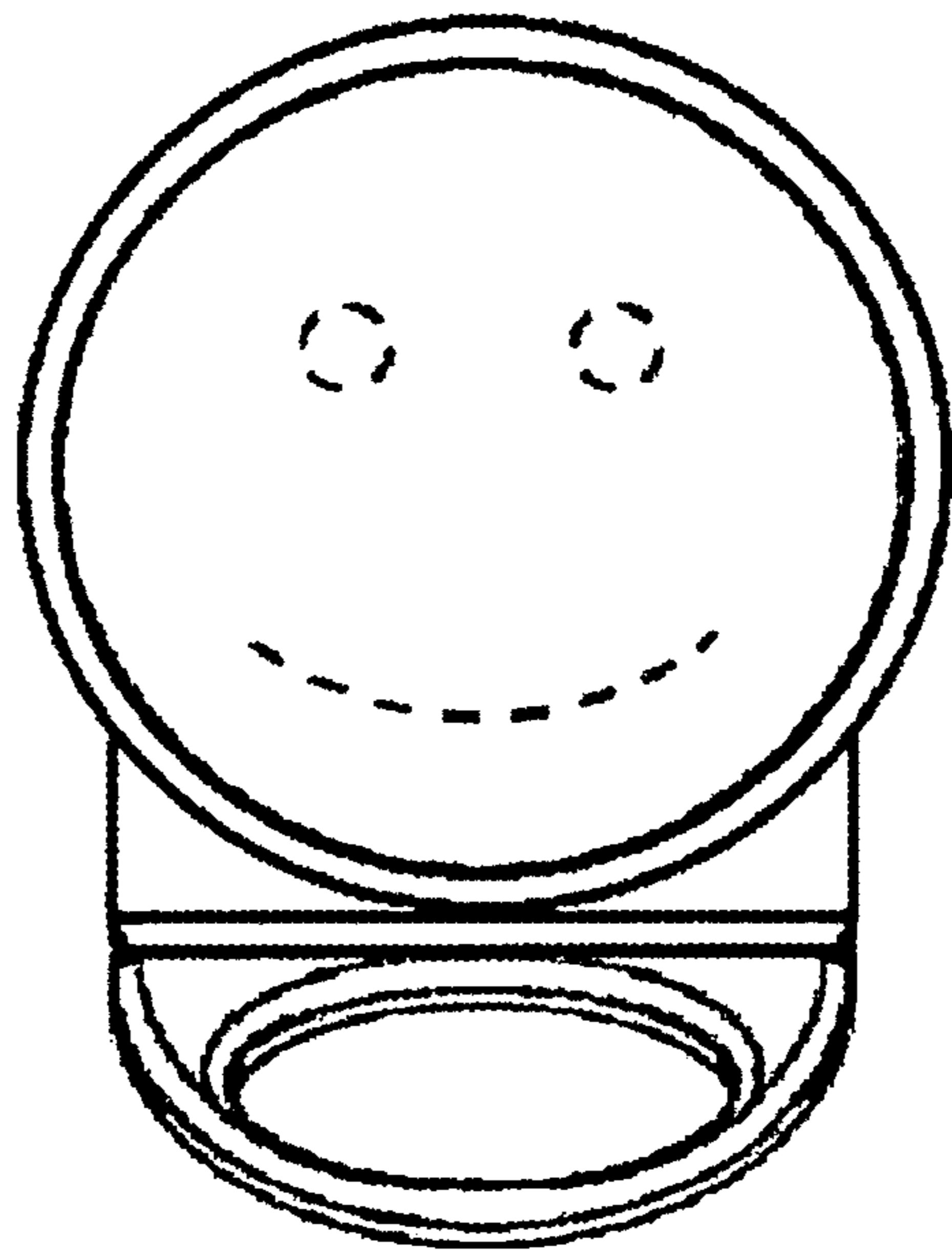

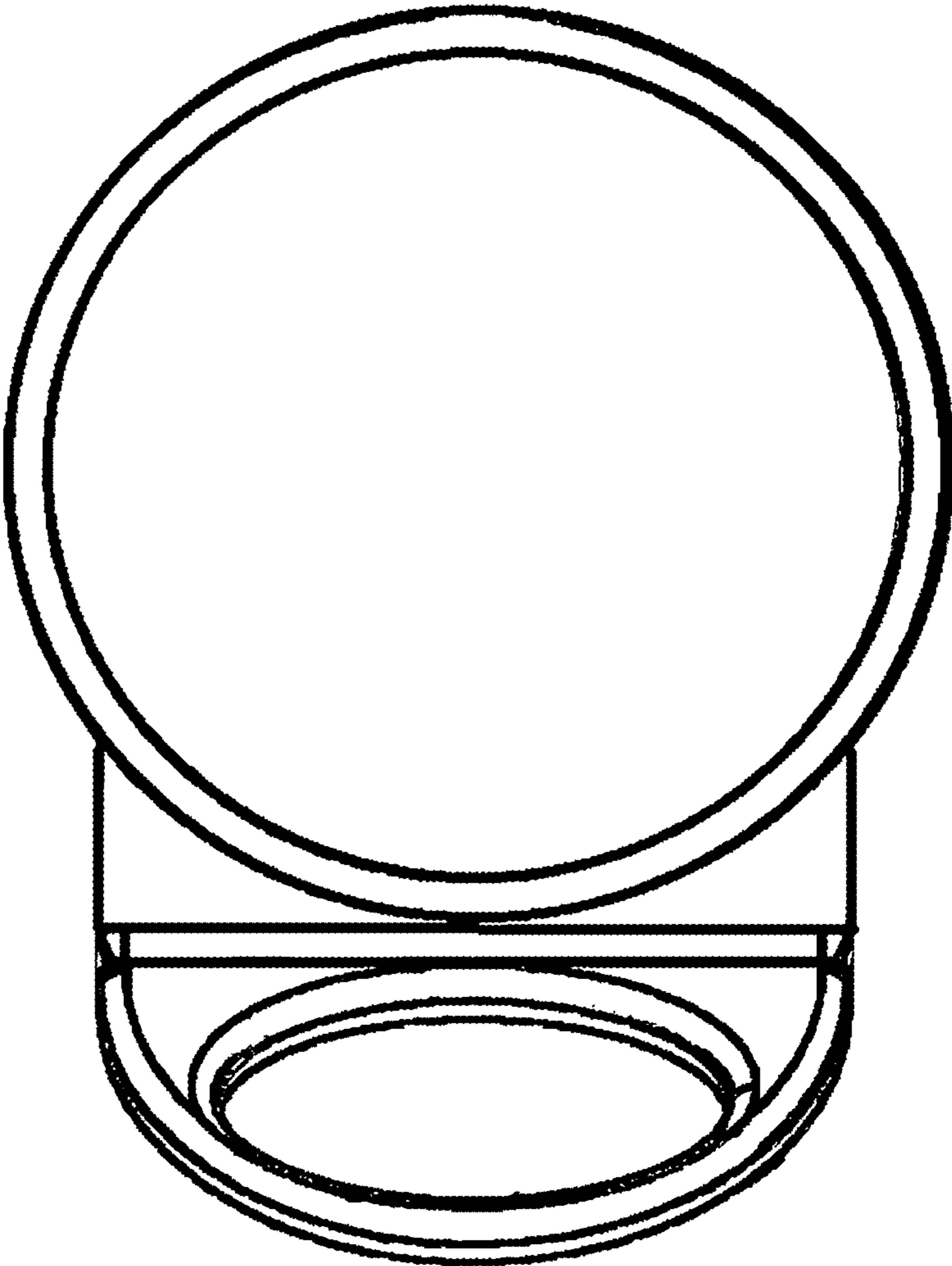

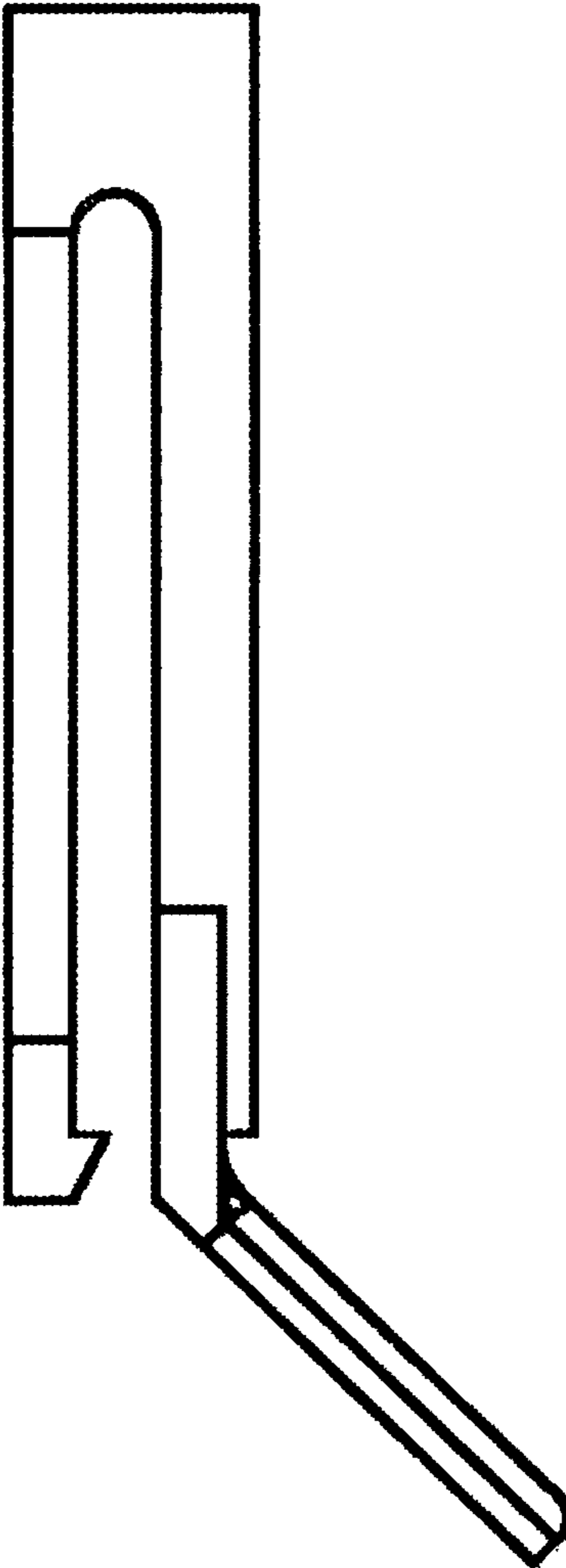

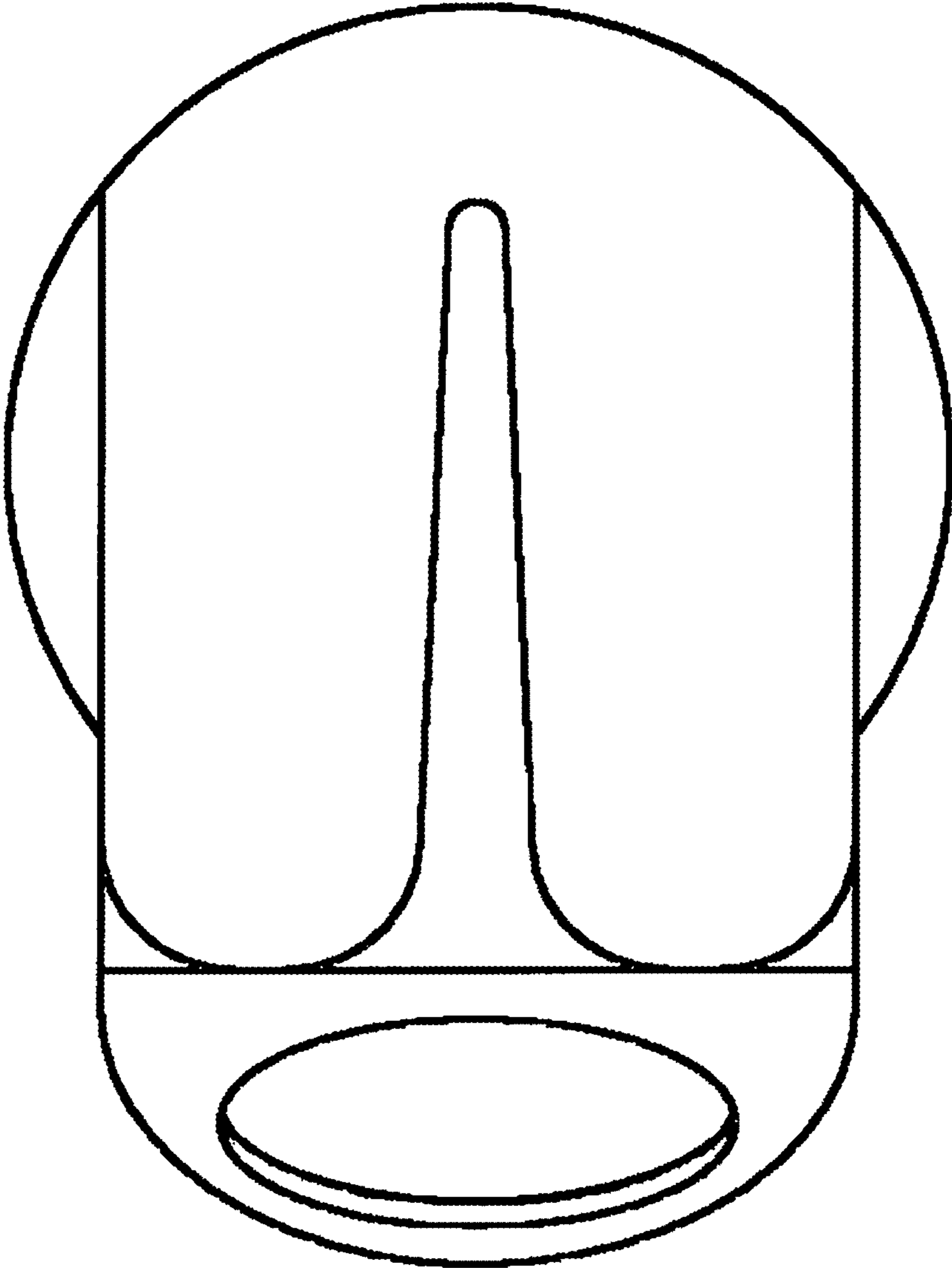

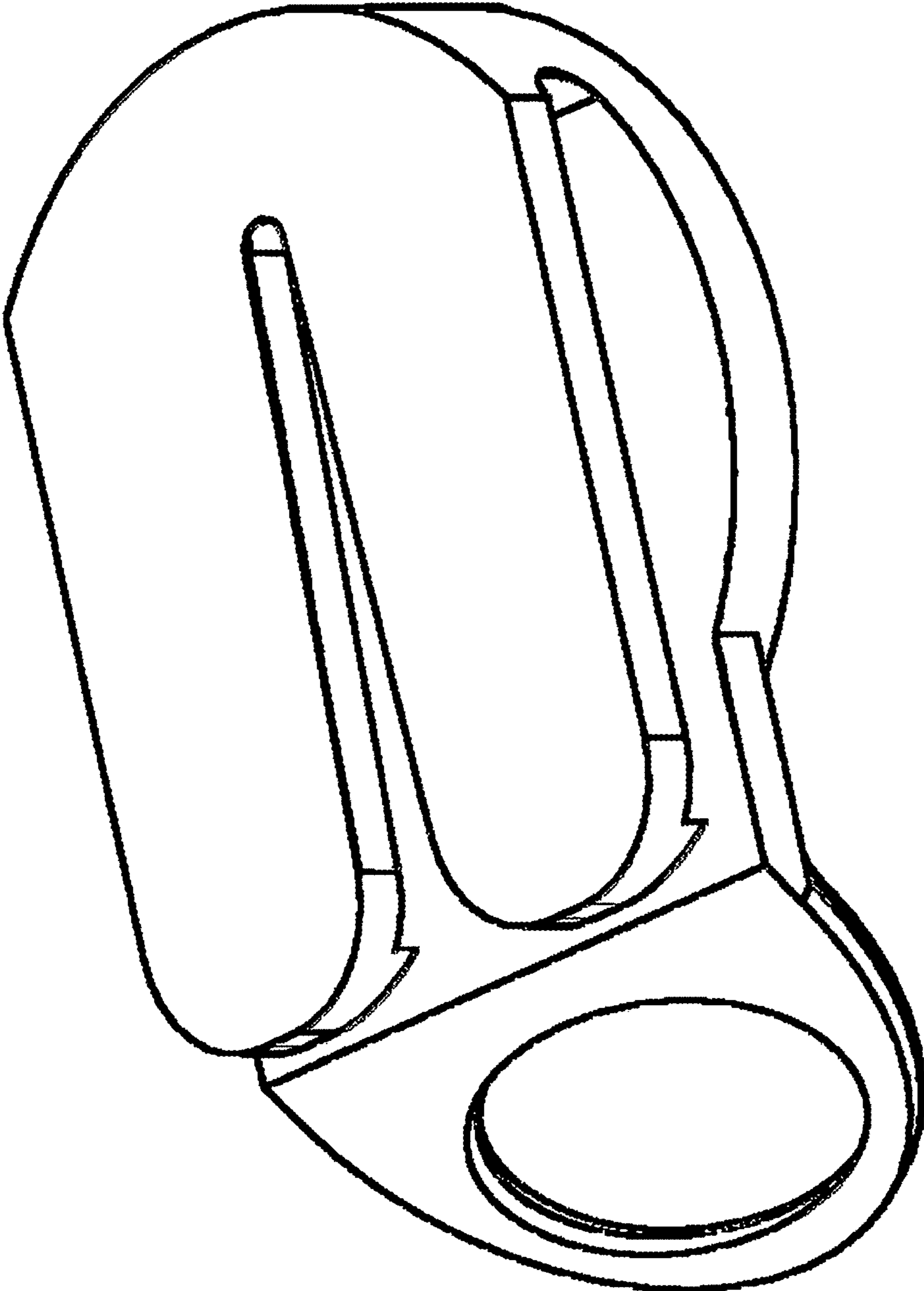

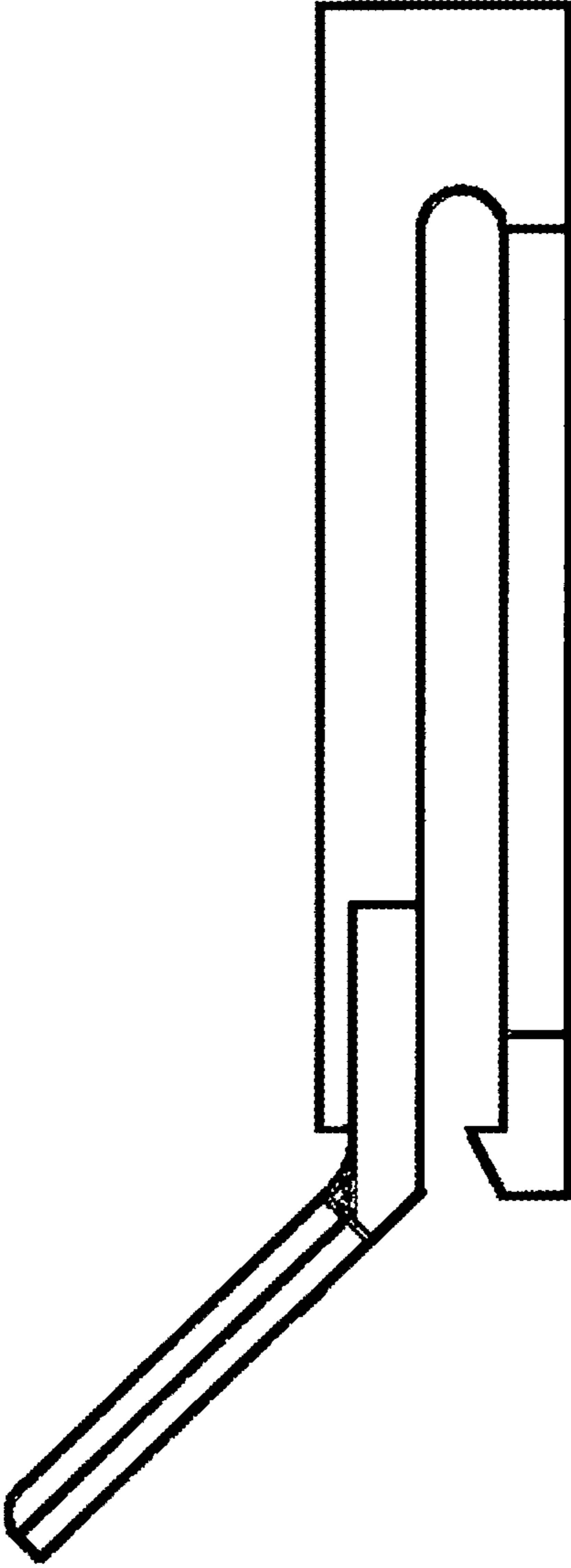

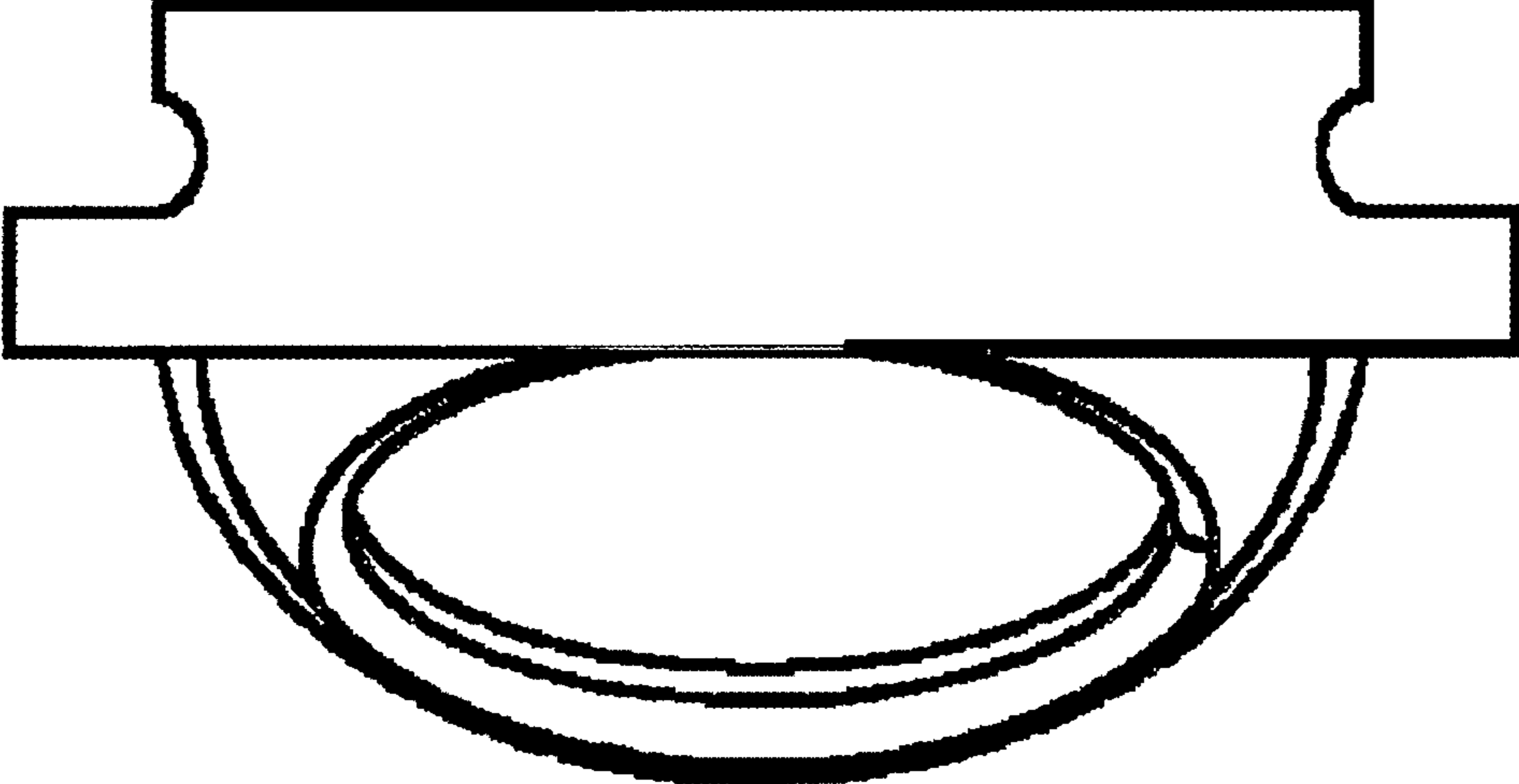

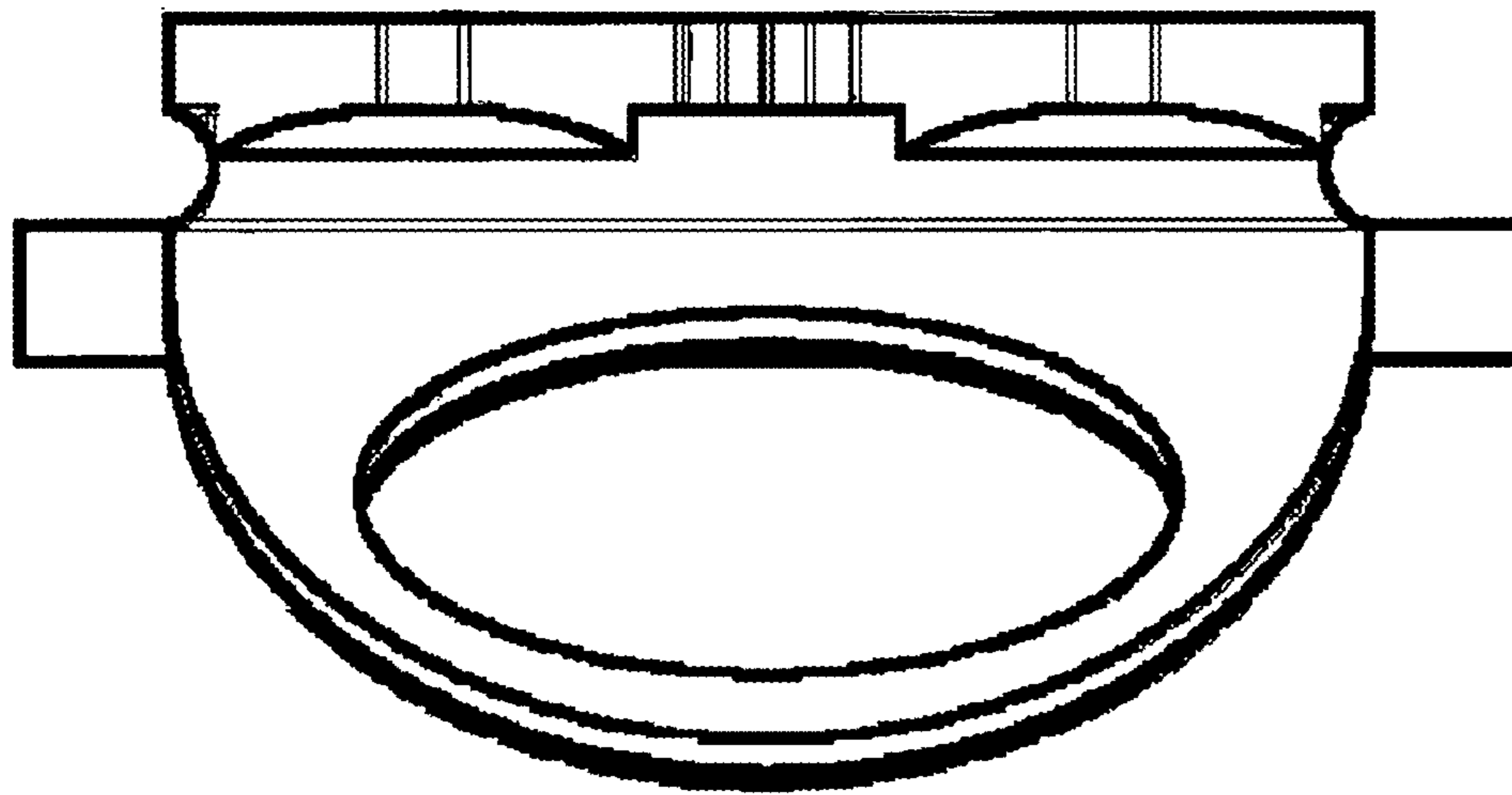

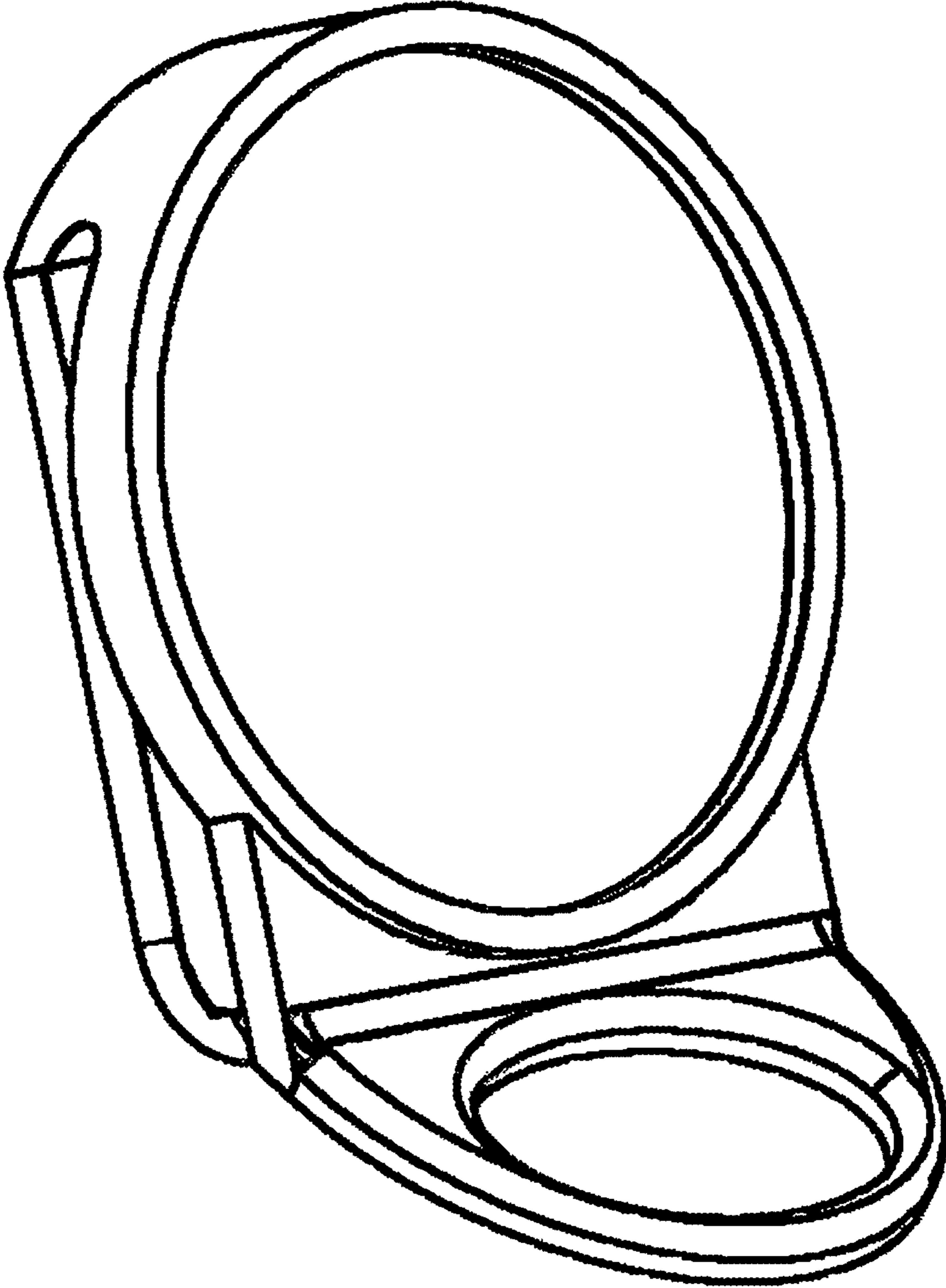

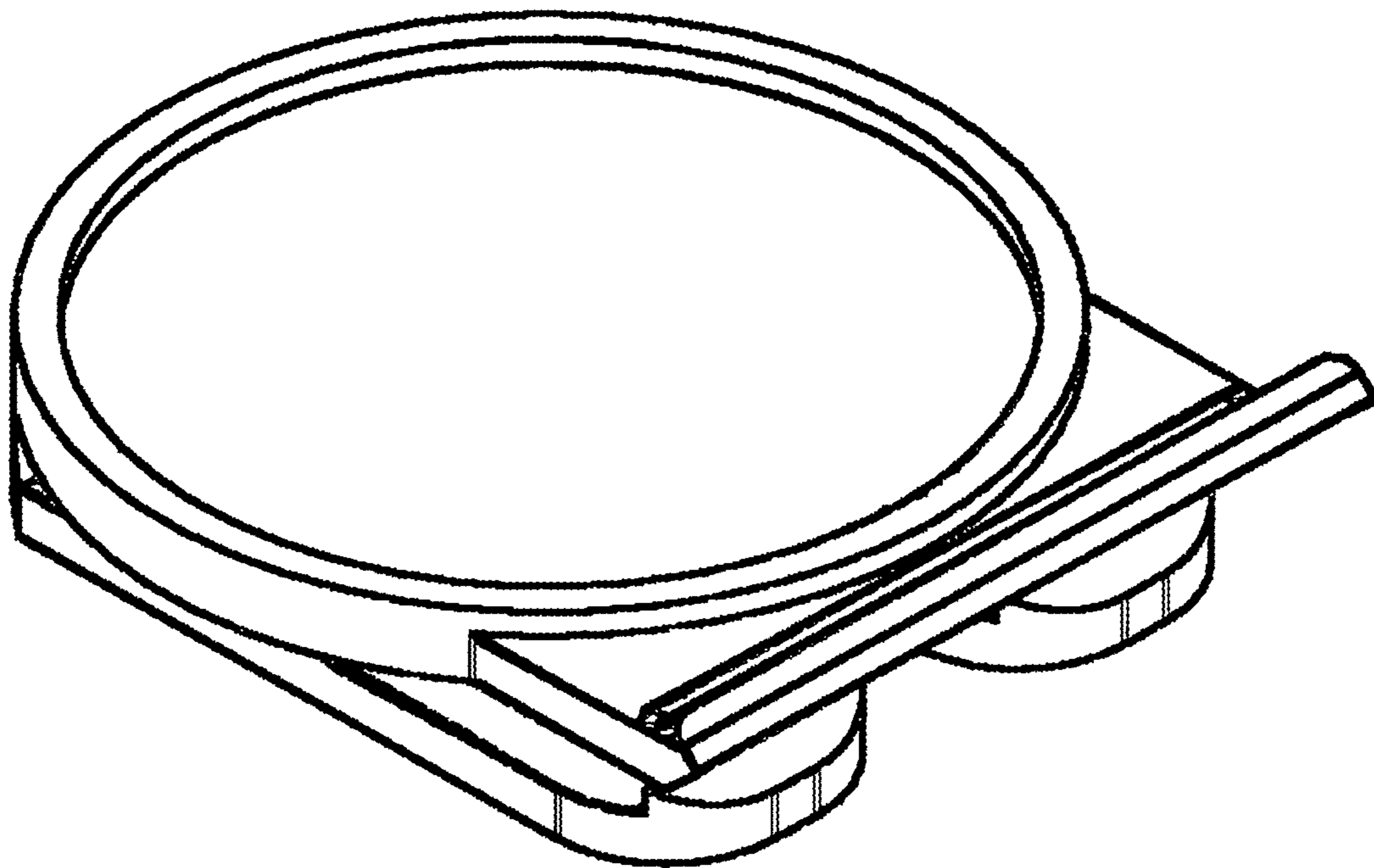

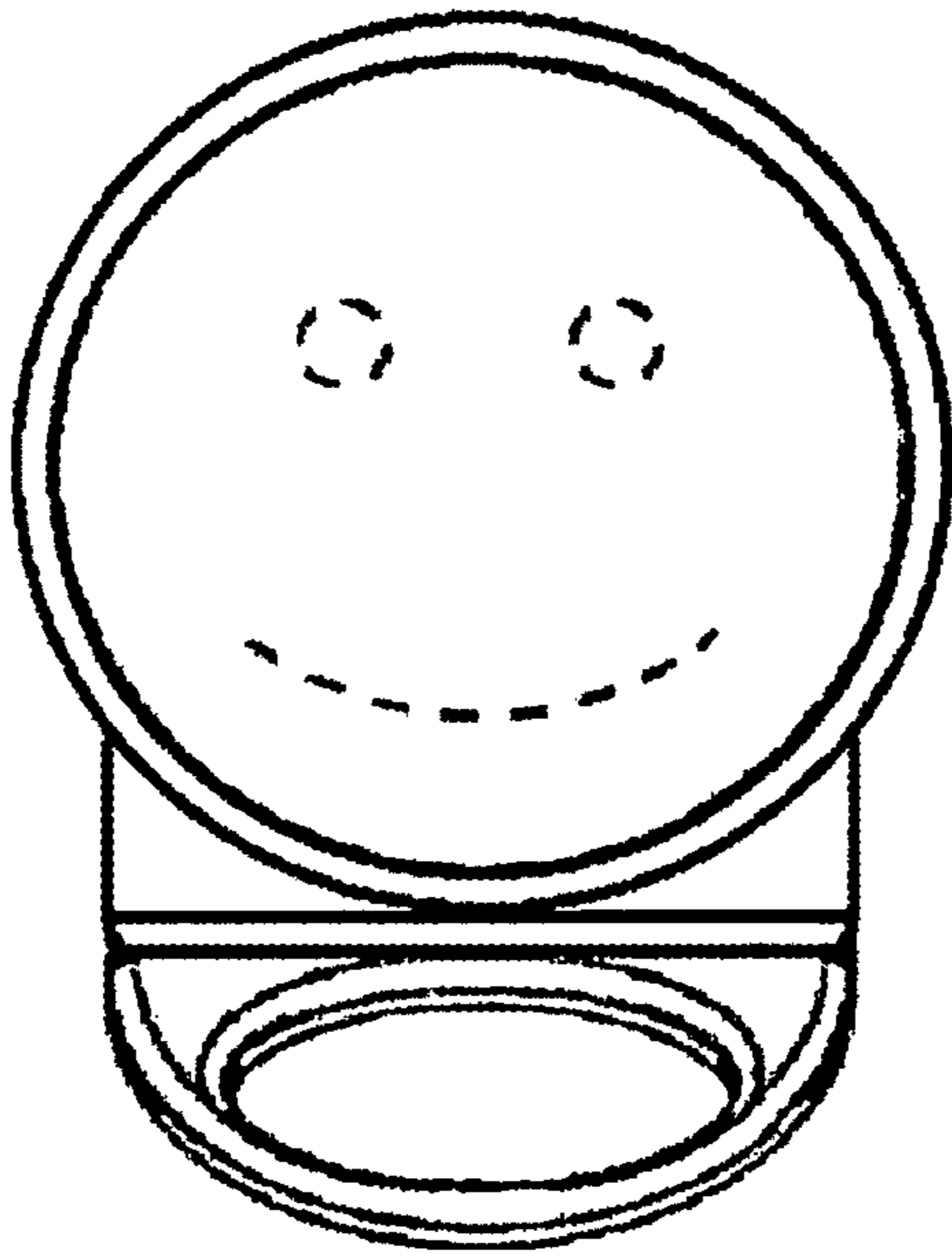
